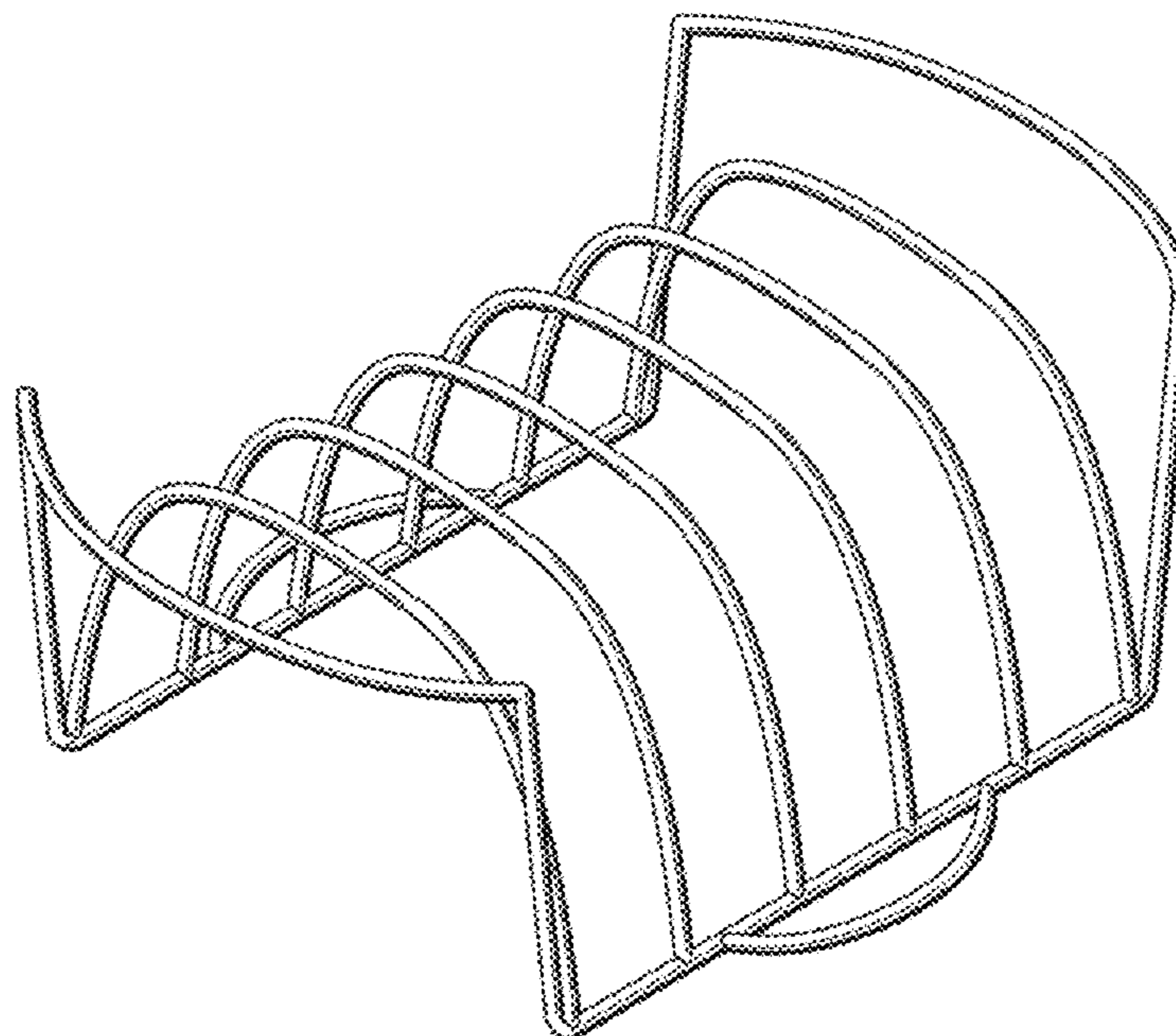
(57) **CLAIM**
The ornamental design for a rib rack, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a rib rack showing our new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a right side elevational view thereof, the left side being a mirror image;
FIG. 4 is a front end elevational view thereof, the back end being a mirror image;
FIG. 5 is top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

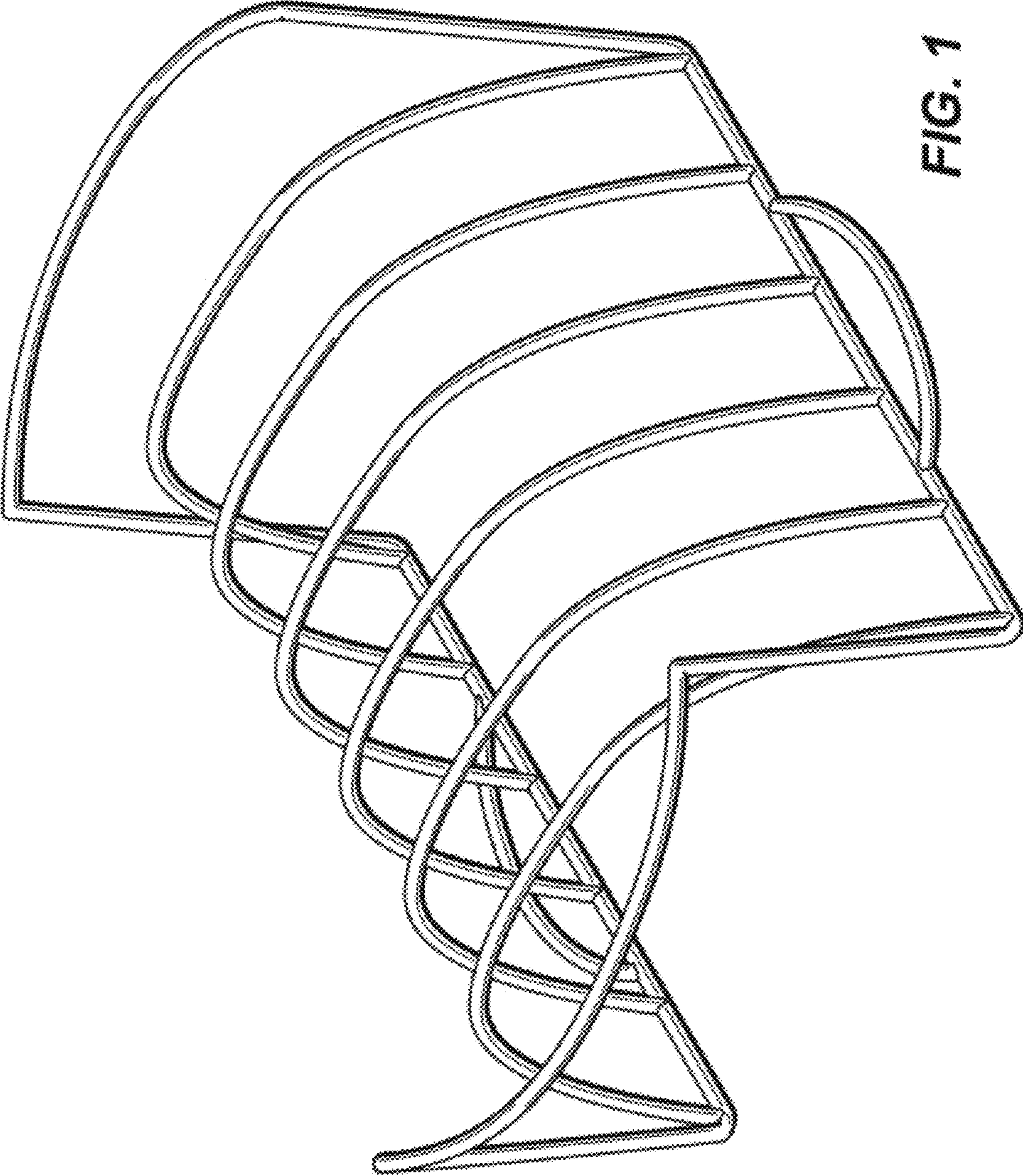

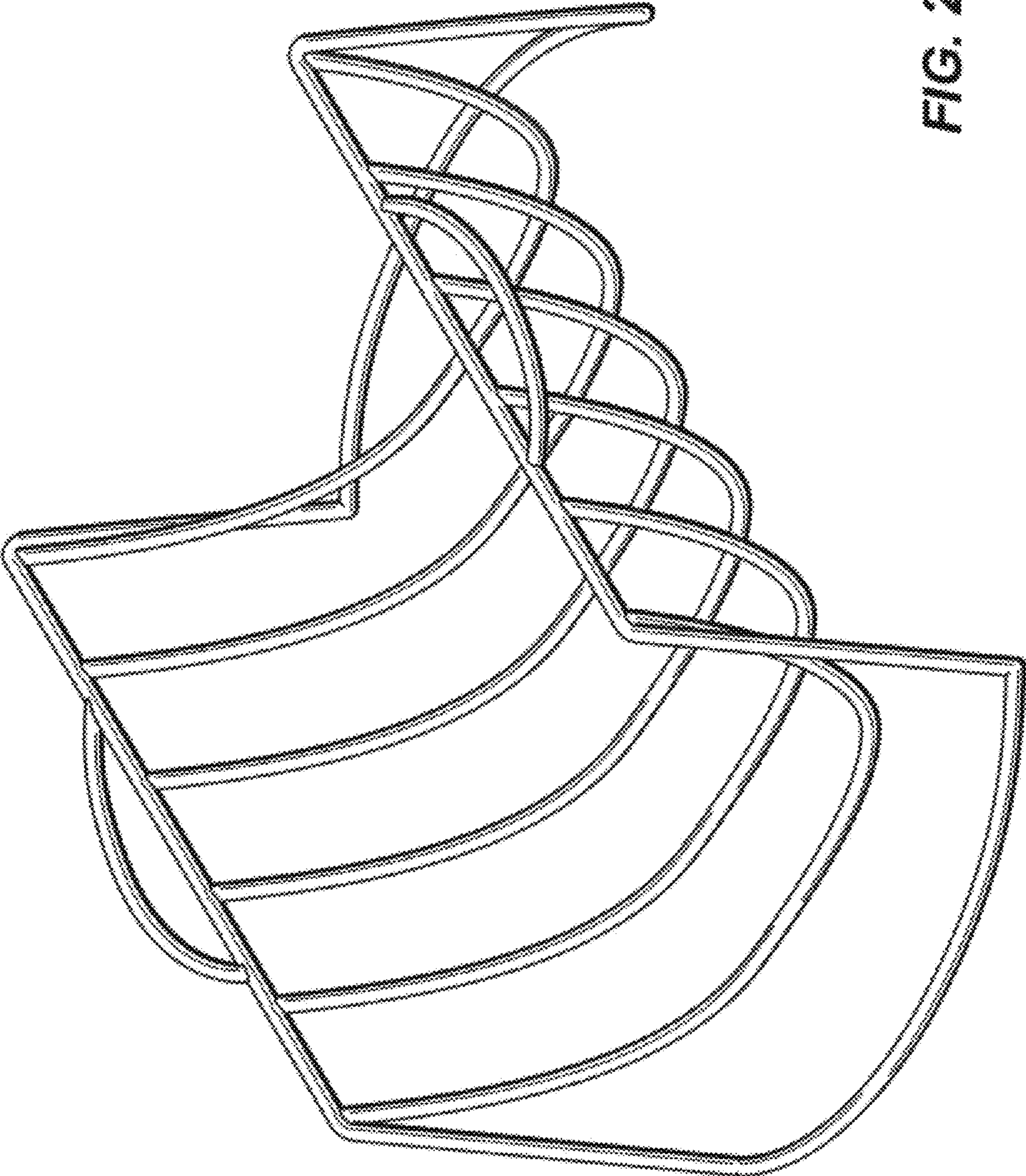

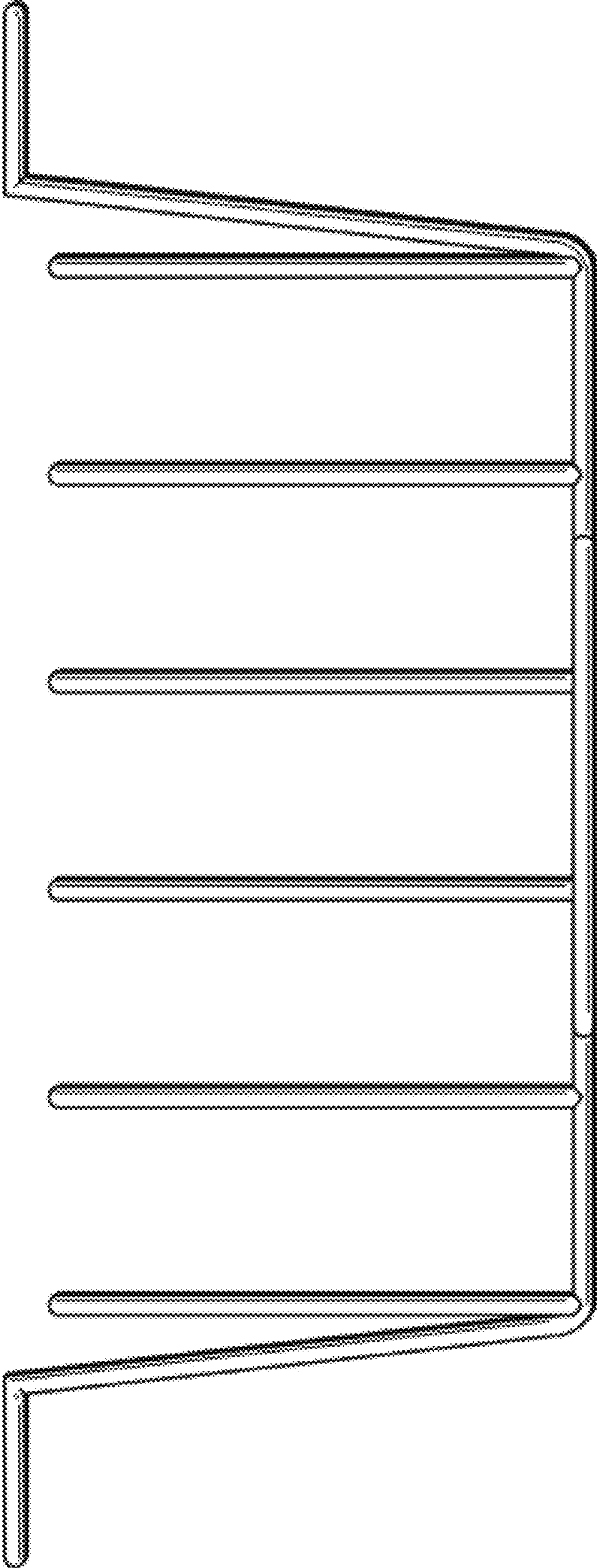

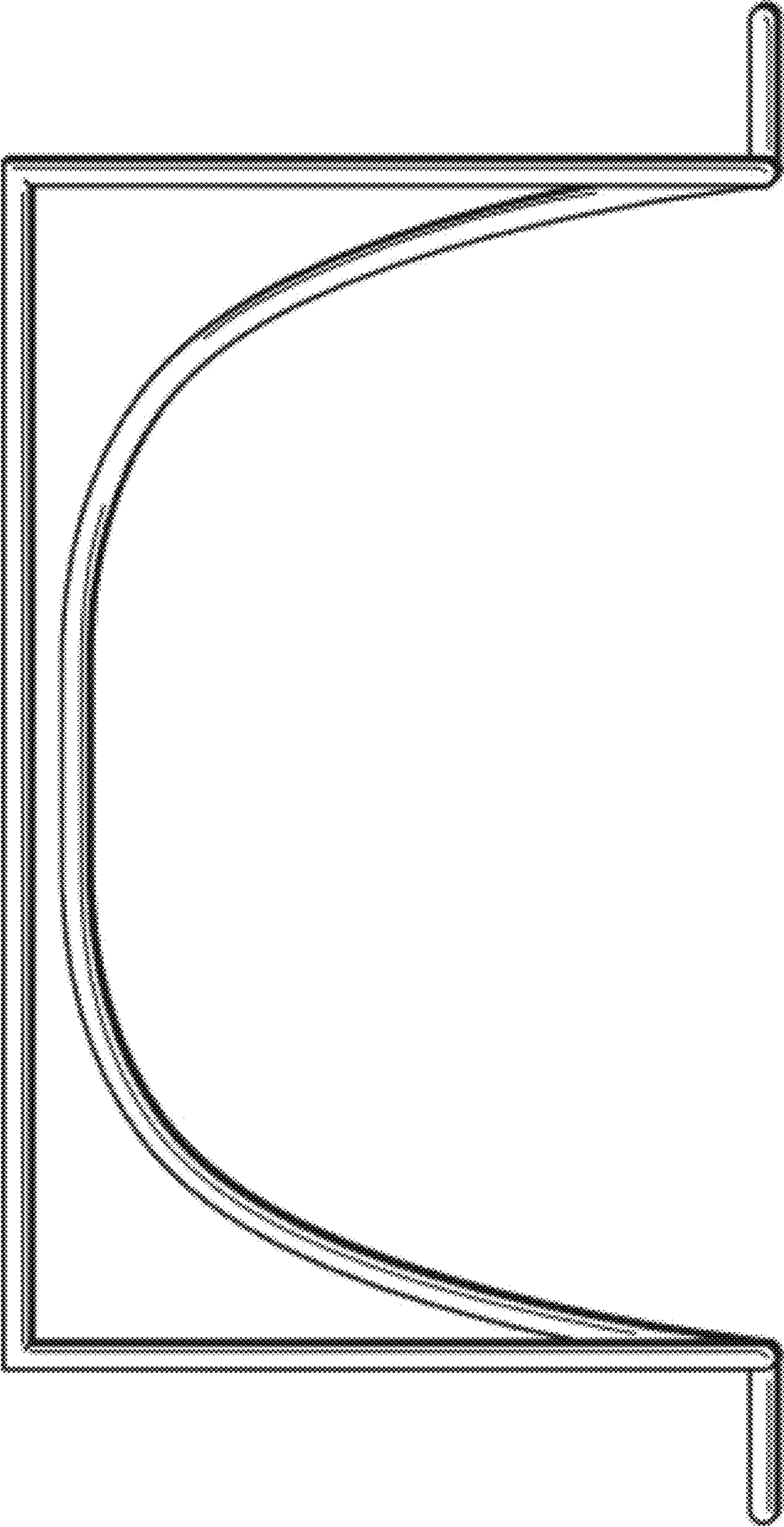

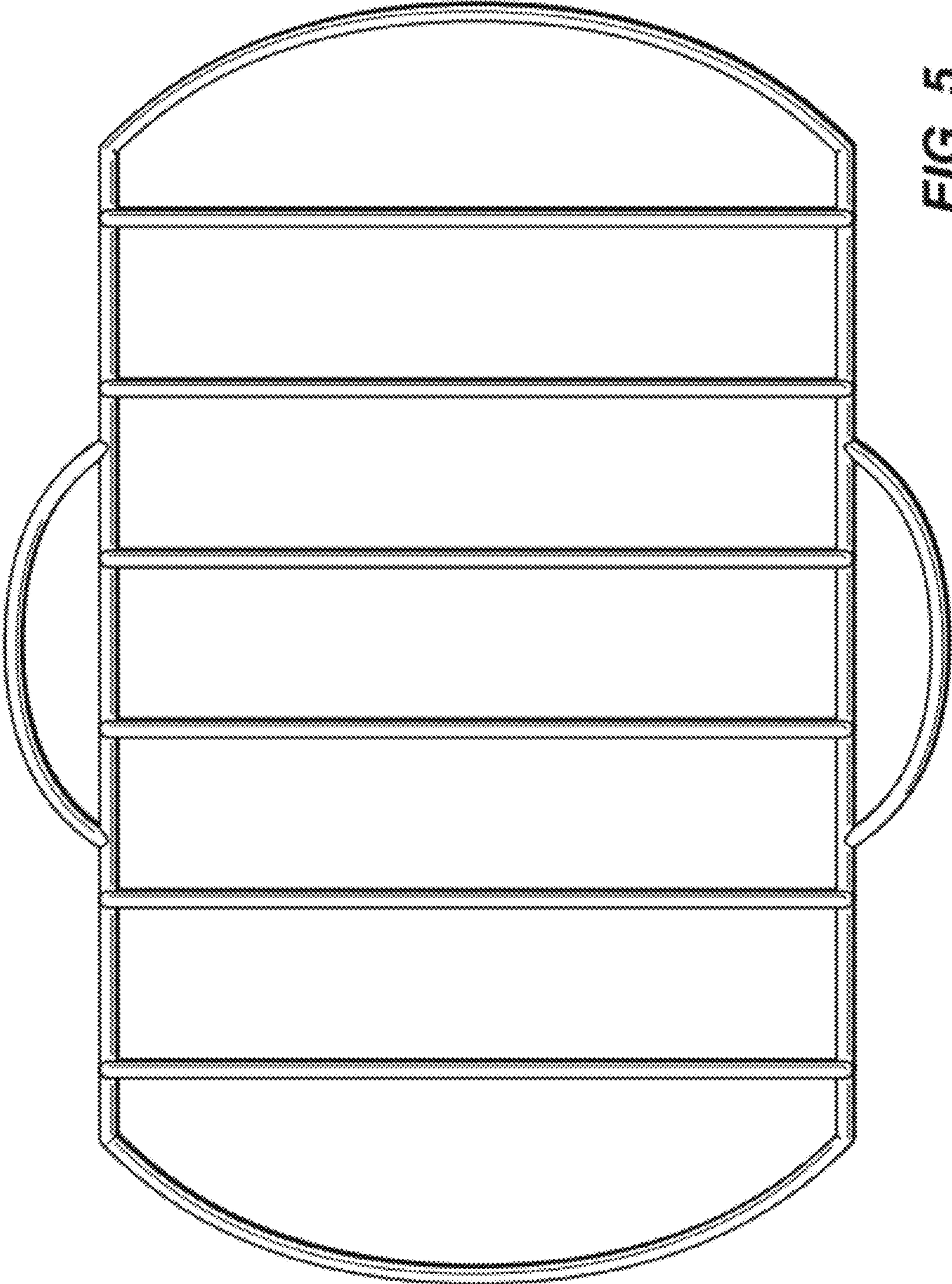

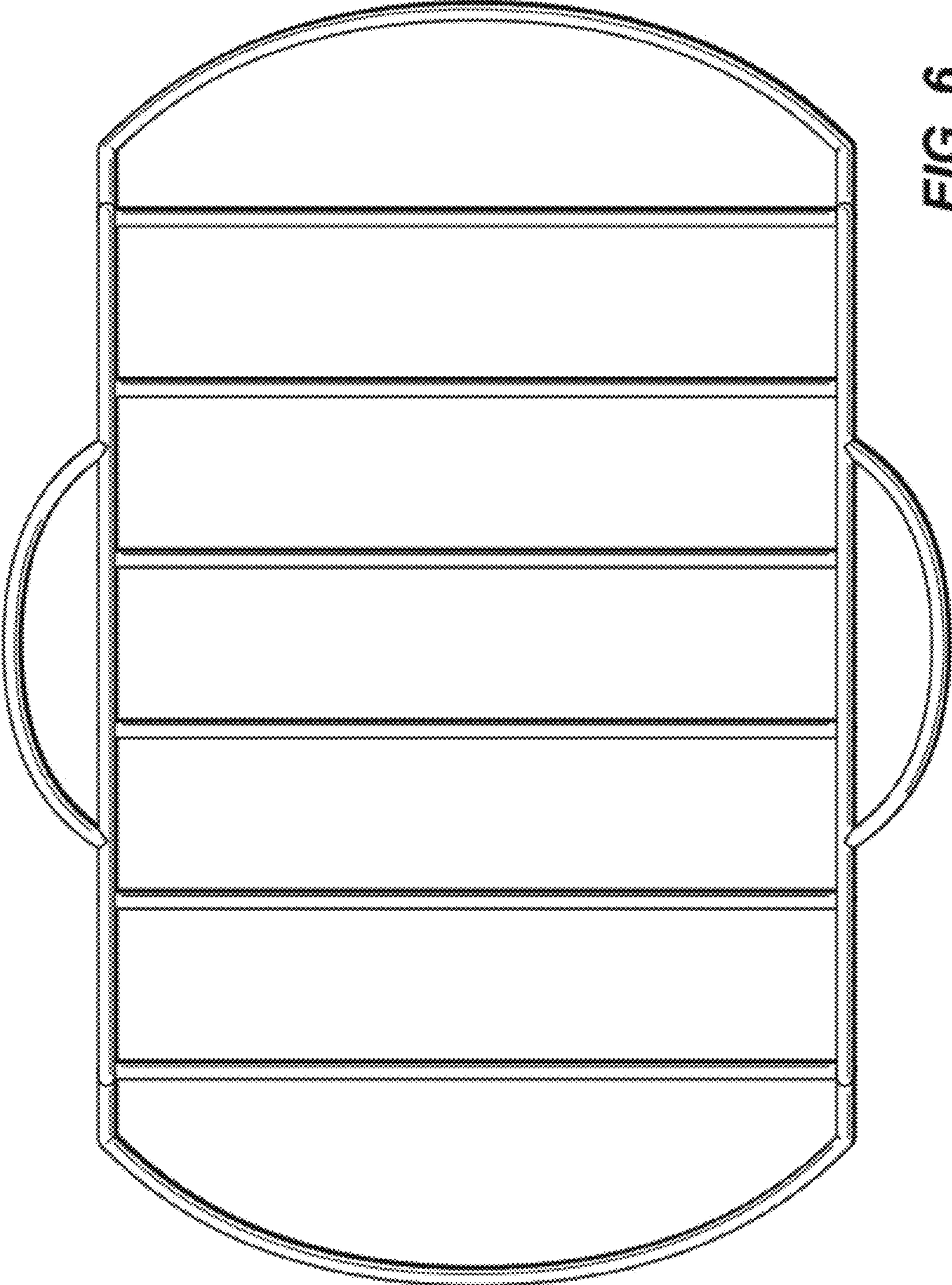
