FIG. 8 is a bottom side view of the Rastafarian head shaped bottle cap remover of FIG. 1.

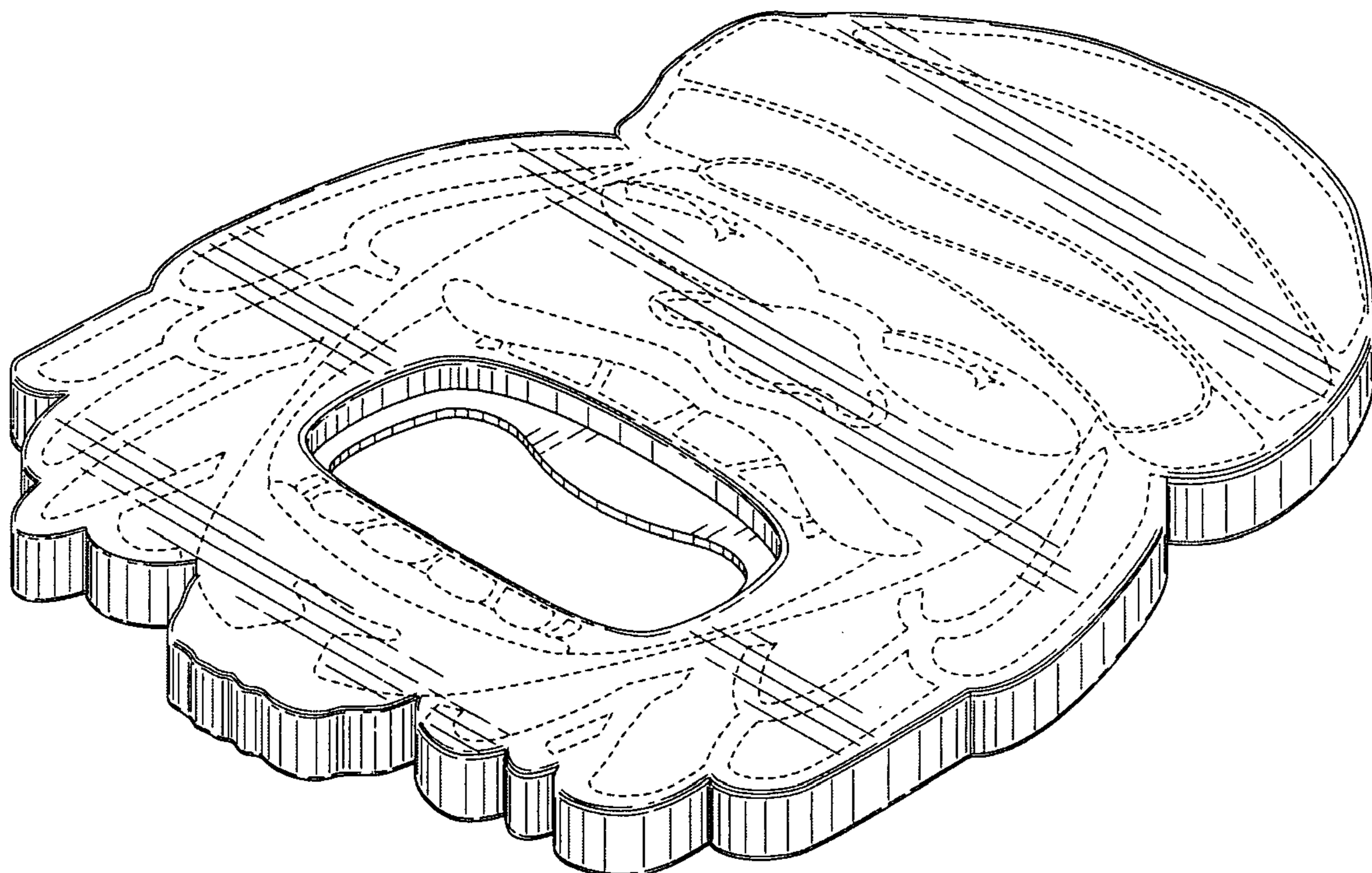

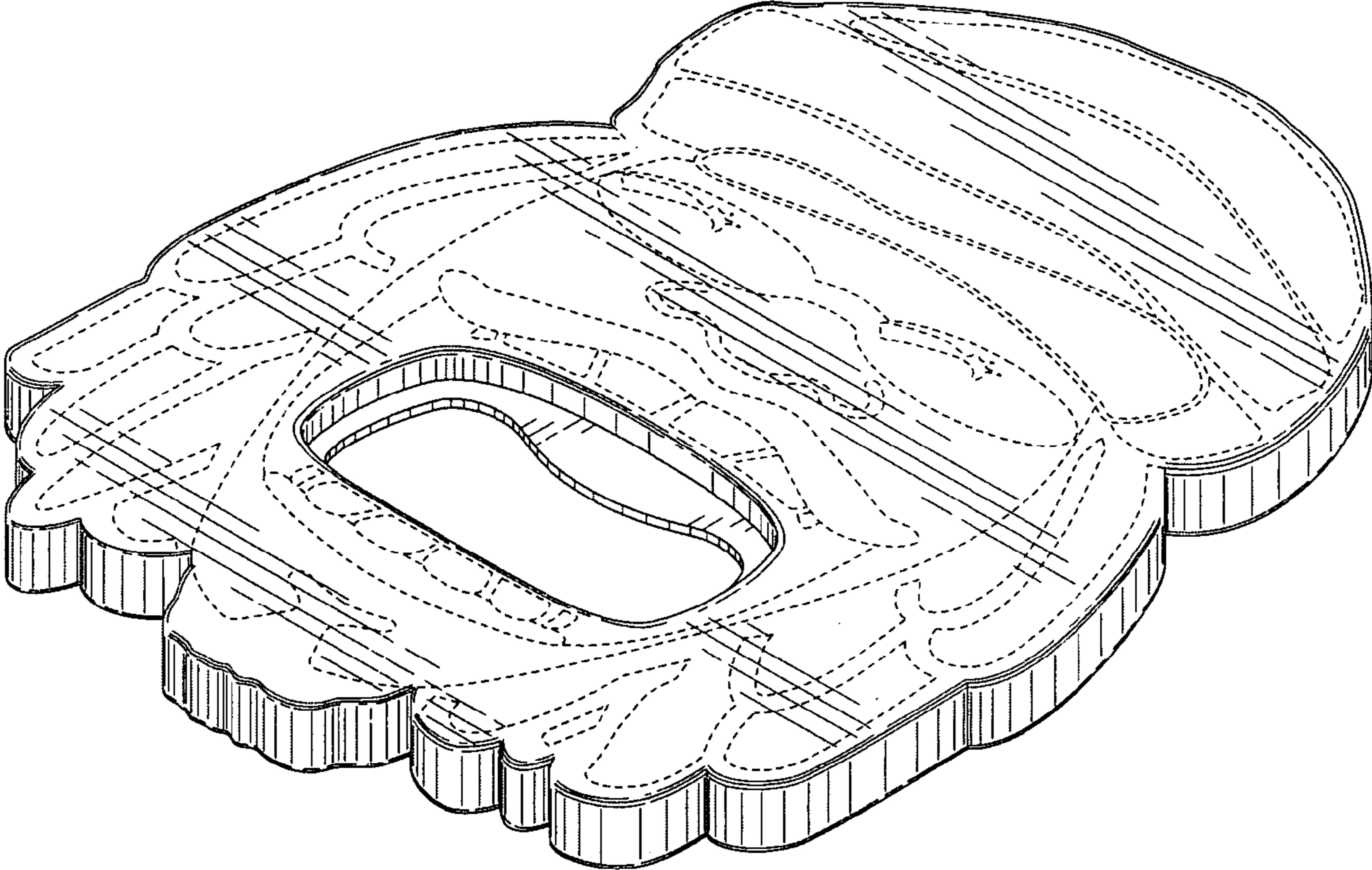

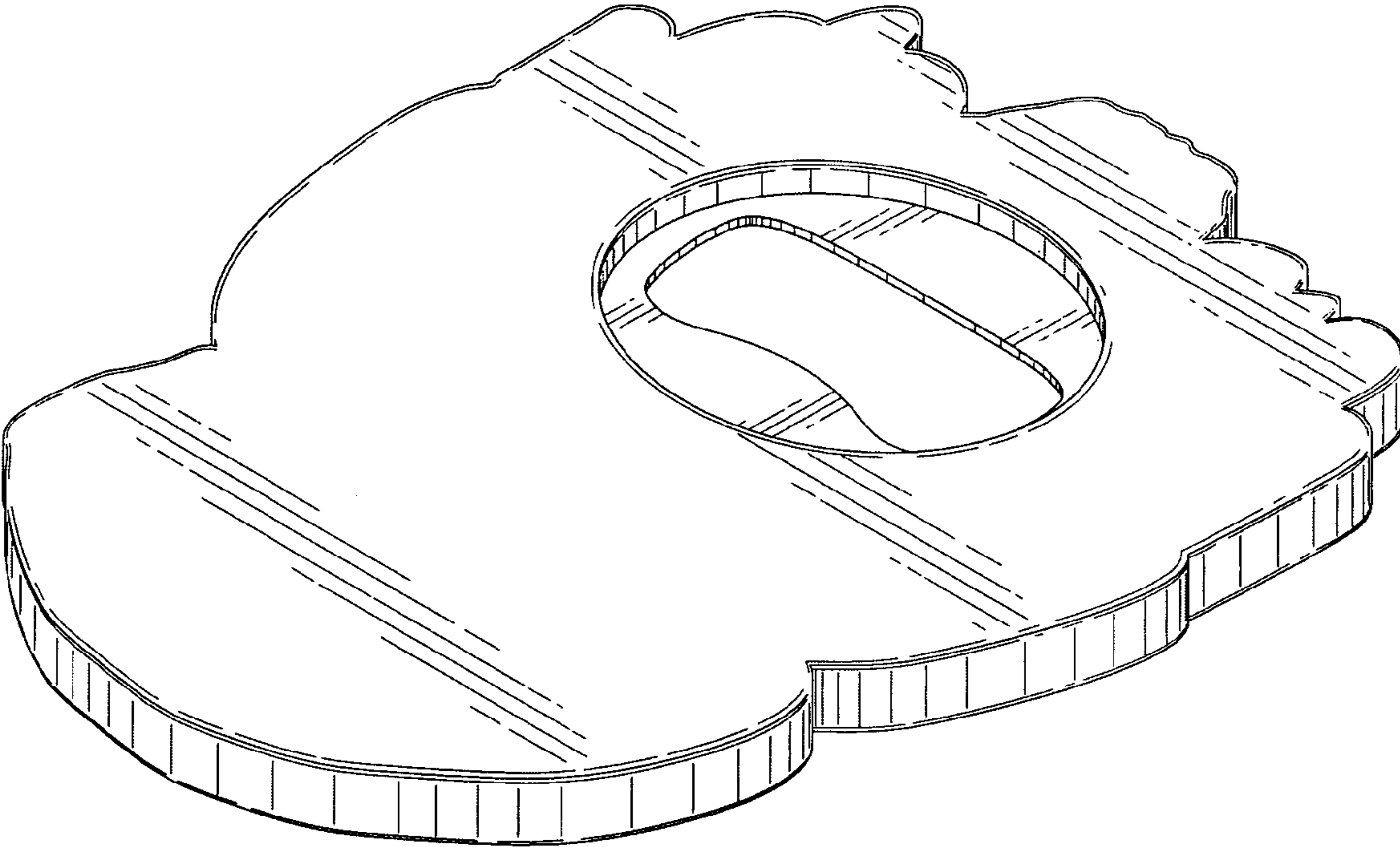

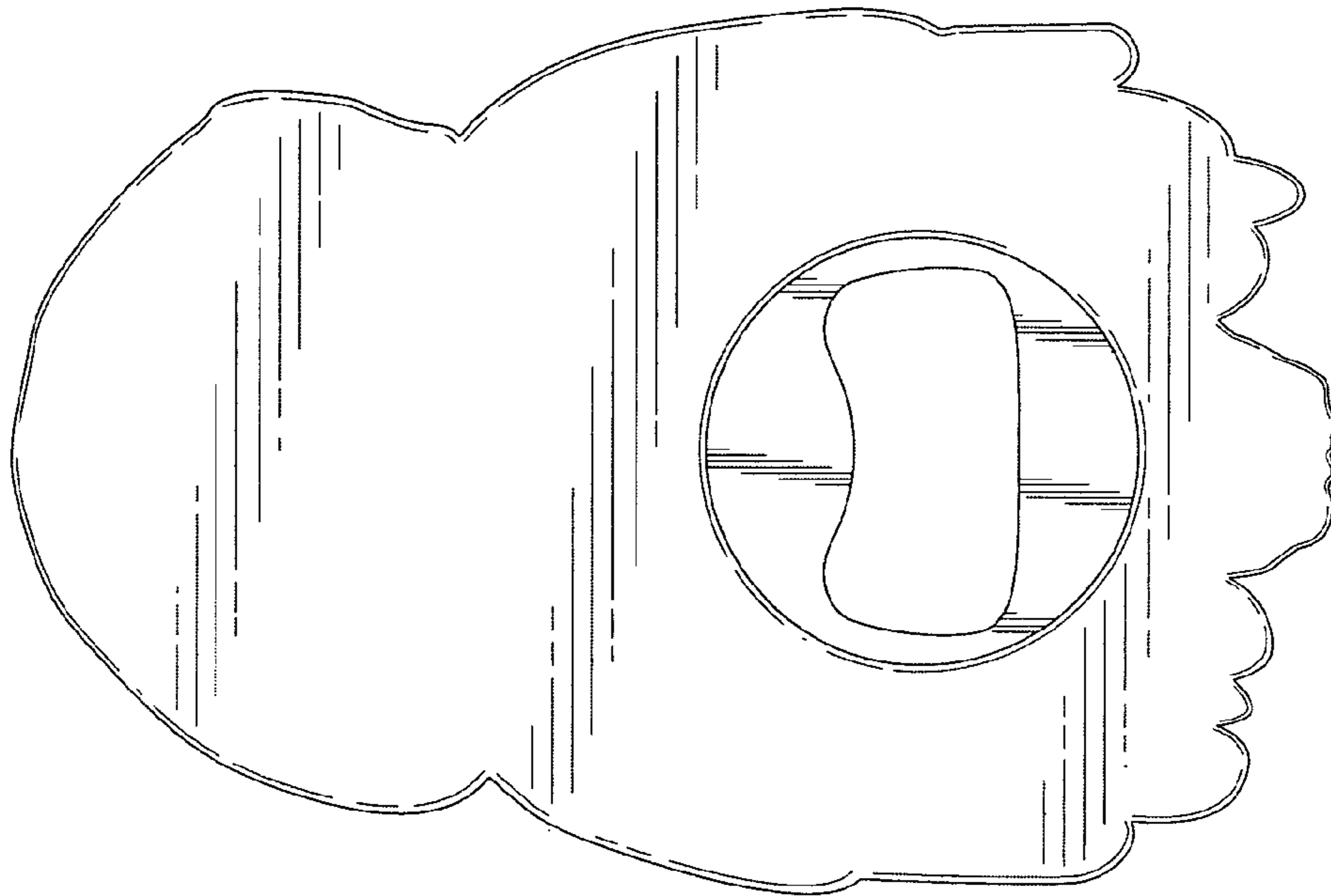

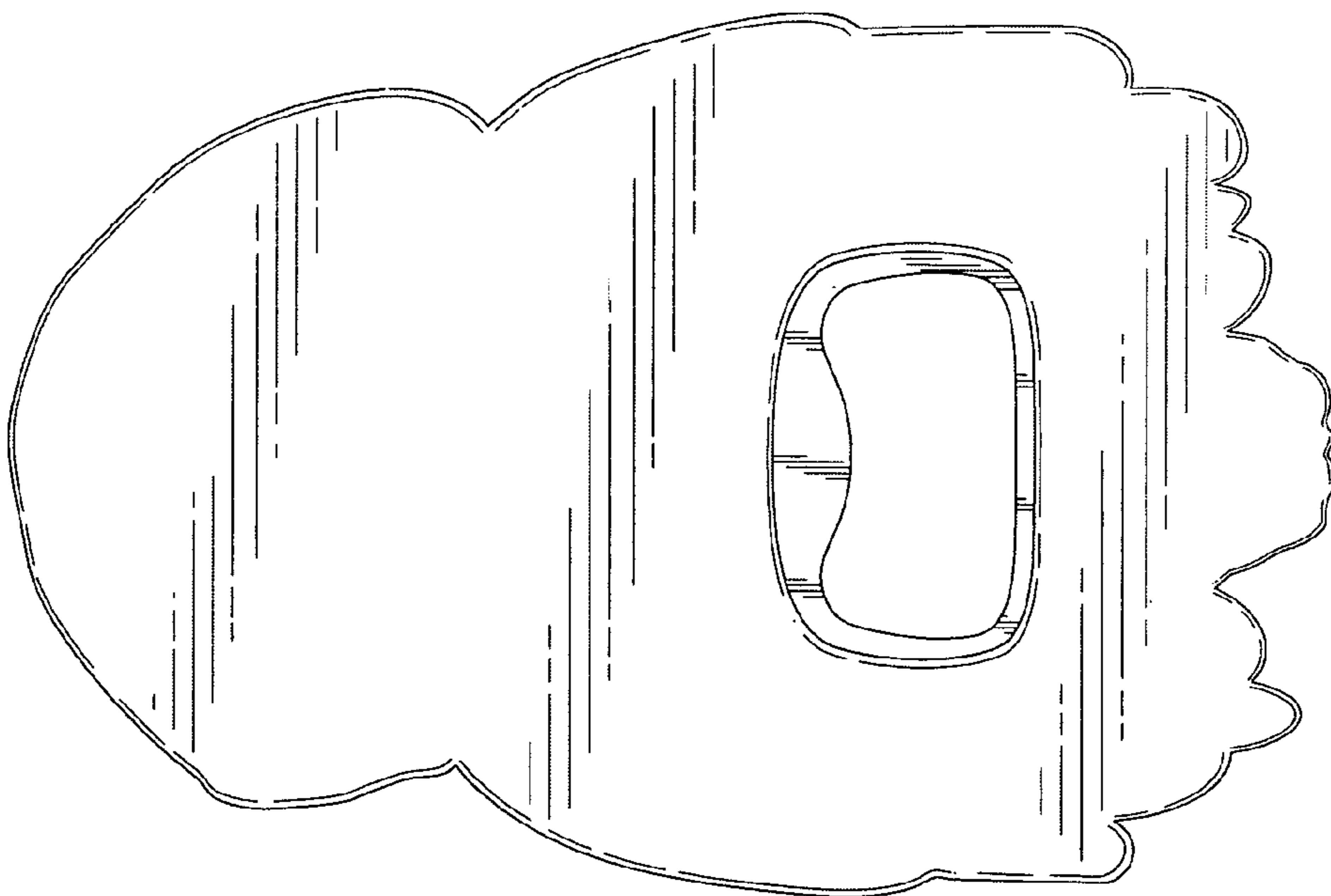

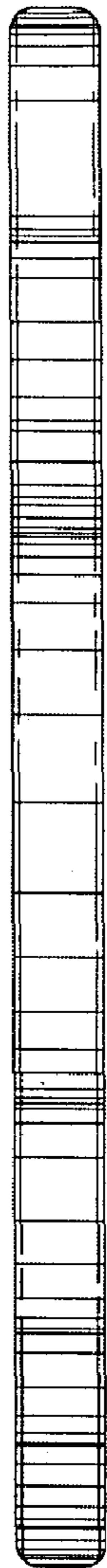




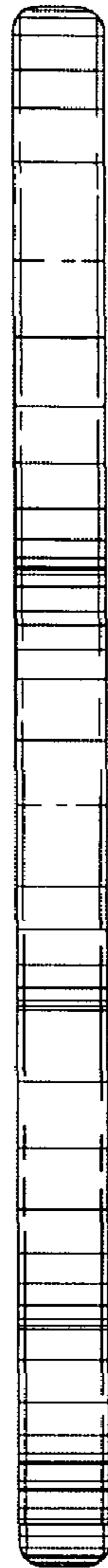
