I claim the ornamental design for a bottle, as shown and described.

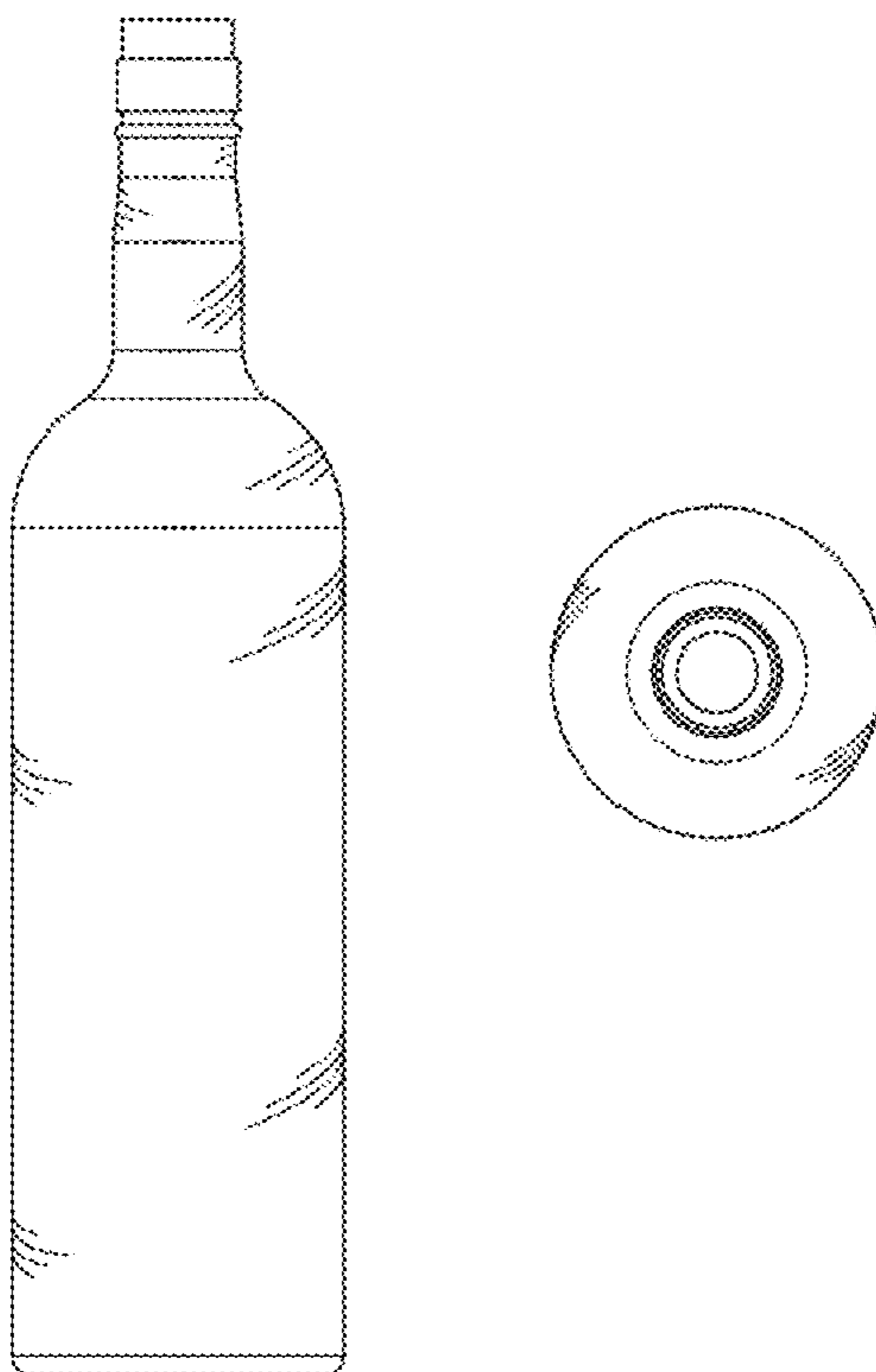
DESCRIPTION

FIG. 1 is a perspective view of a bottle in accordance with my new design.

FIG. 2 is a front elevational view of the bottle in FIG. 1, the side elevational views and the rear elevational view of the bottle in FIG. 1 being identical to FIG. 2; and,

FIG. 3 is a top plan view of the bottle in FIGS. 1 and 2, the bottom forming no part of the claimed design.

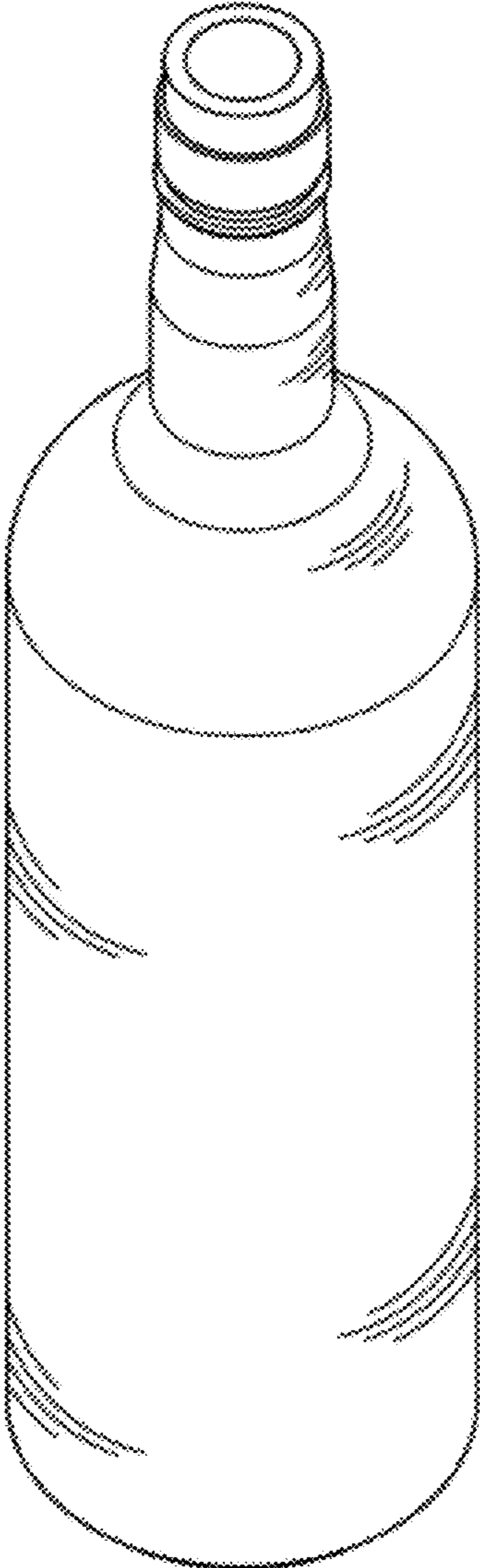

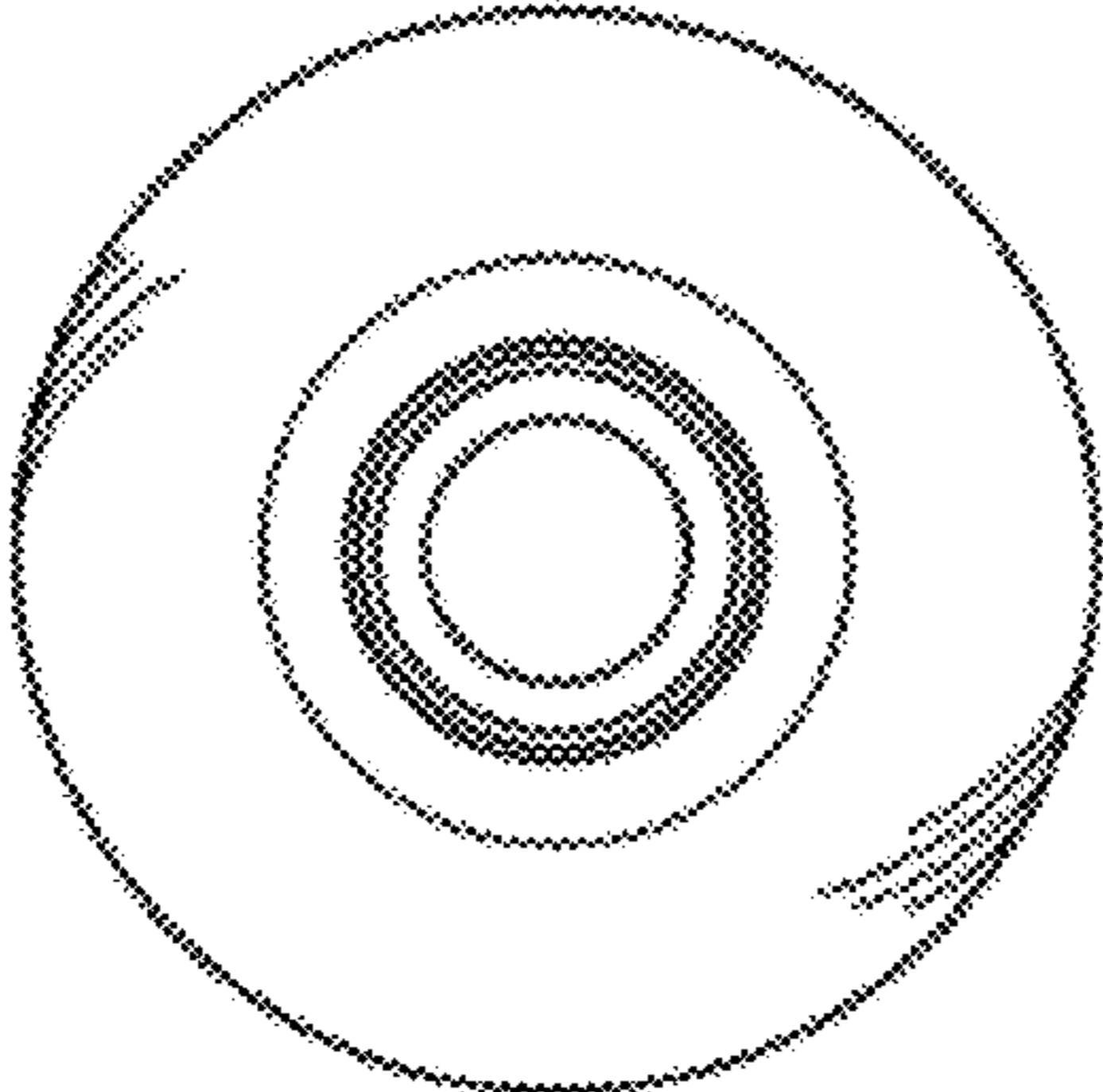

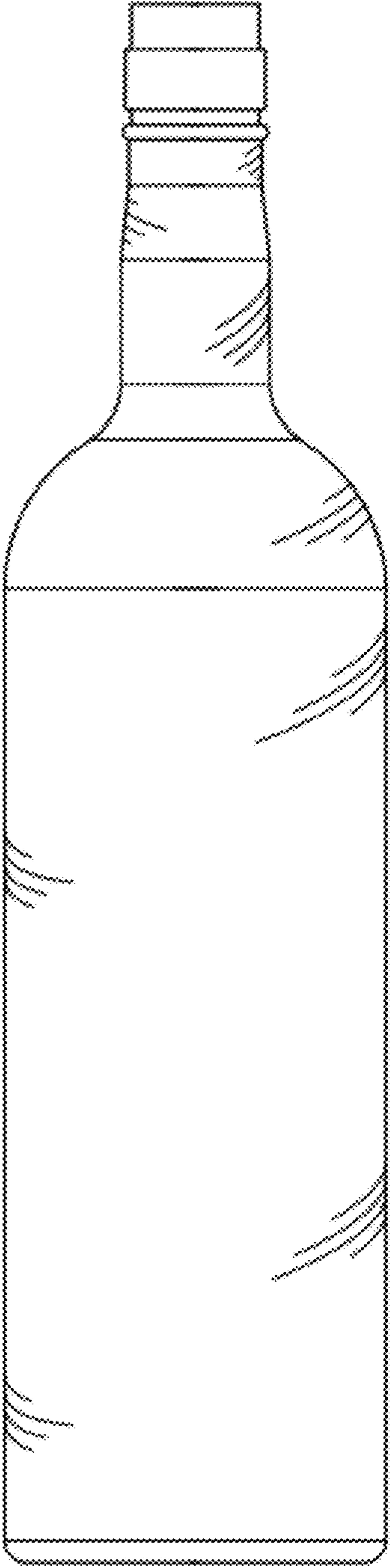


FIG. 2
