(57) **CLAIM**

The ornamental design for a blister pack for pharmaceuticals, as shown and described.

**DESCRIPTION**

FIG. 1 is a front-left-top perspective view of a blister pack for pharmaceuticals according to the present invention.

FIG. 2 is a view from the top side thereof according to the present invention;

FIG. 3 is a view from the bottom side thereof according to the present invention;

FIG. 4 is a view from the left side thereof according to the present invention;

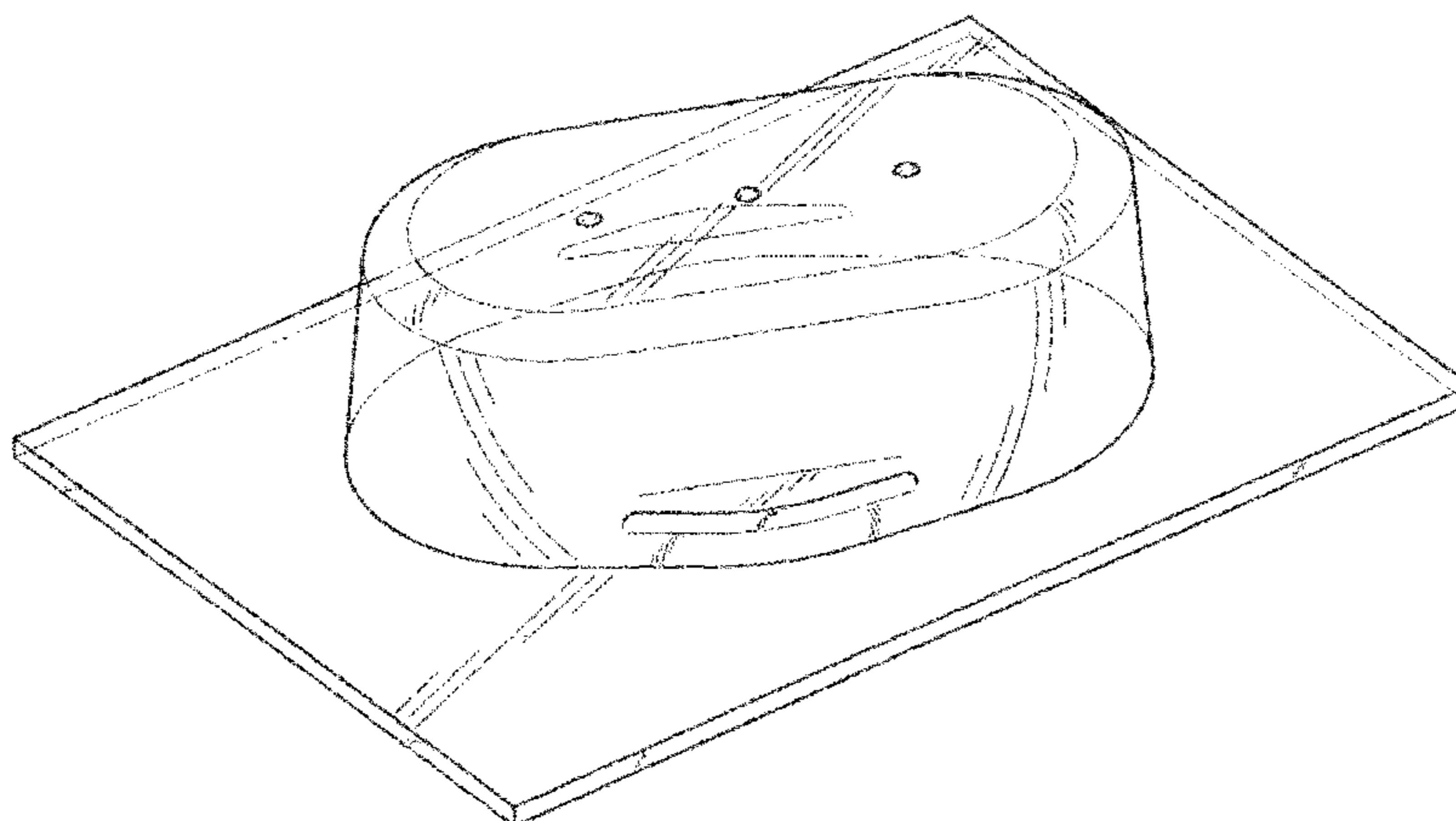
FIG. 5 is a view from the right side thereof according to the present invention;

FIG. 6 is a view from the front side thereof according to the present invention; and,

FIG. 7 is a view from the rear side thereof according to the present invention.

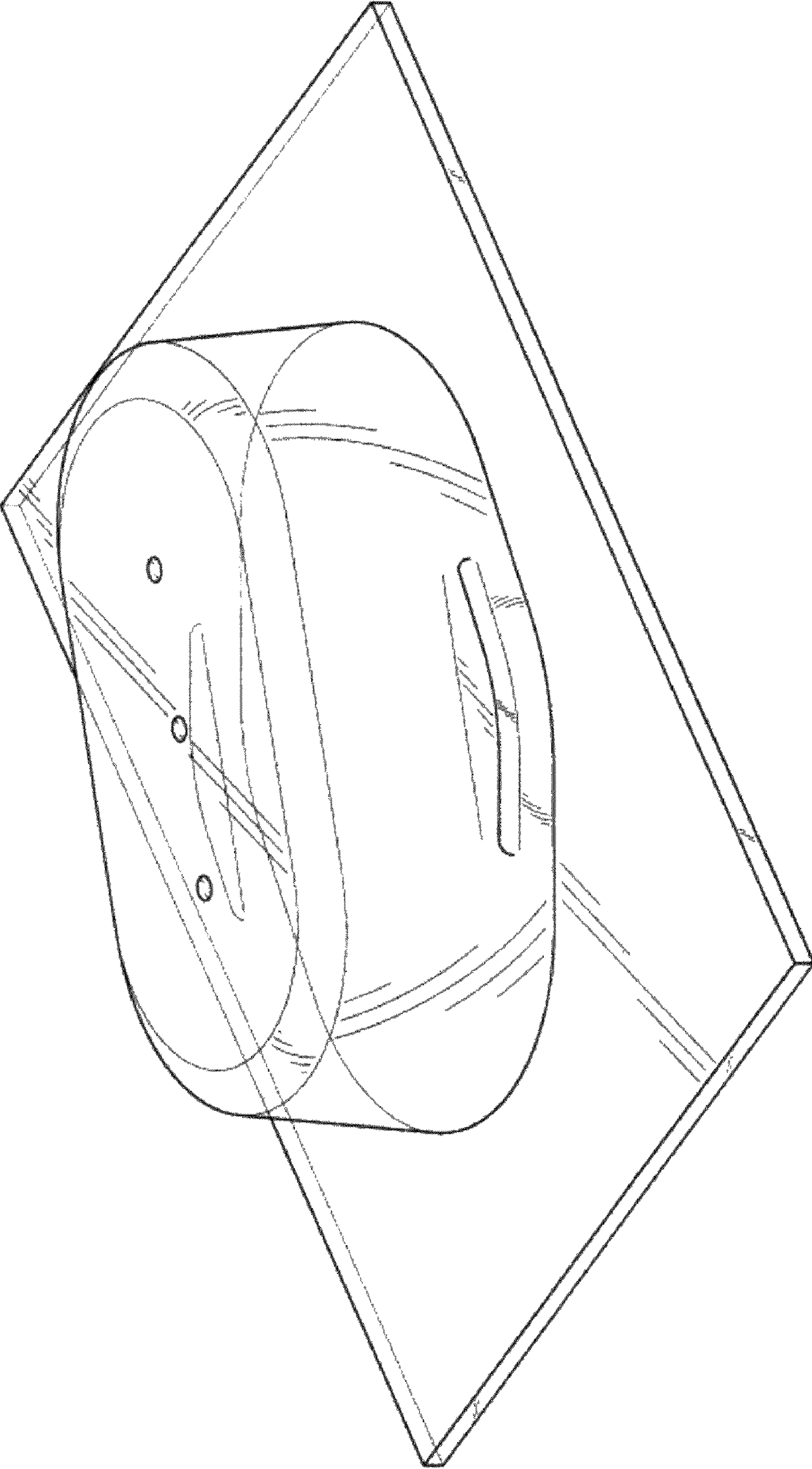

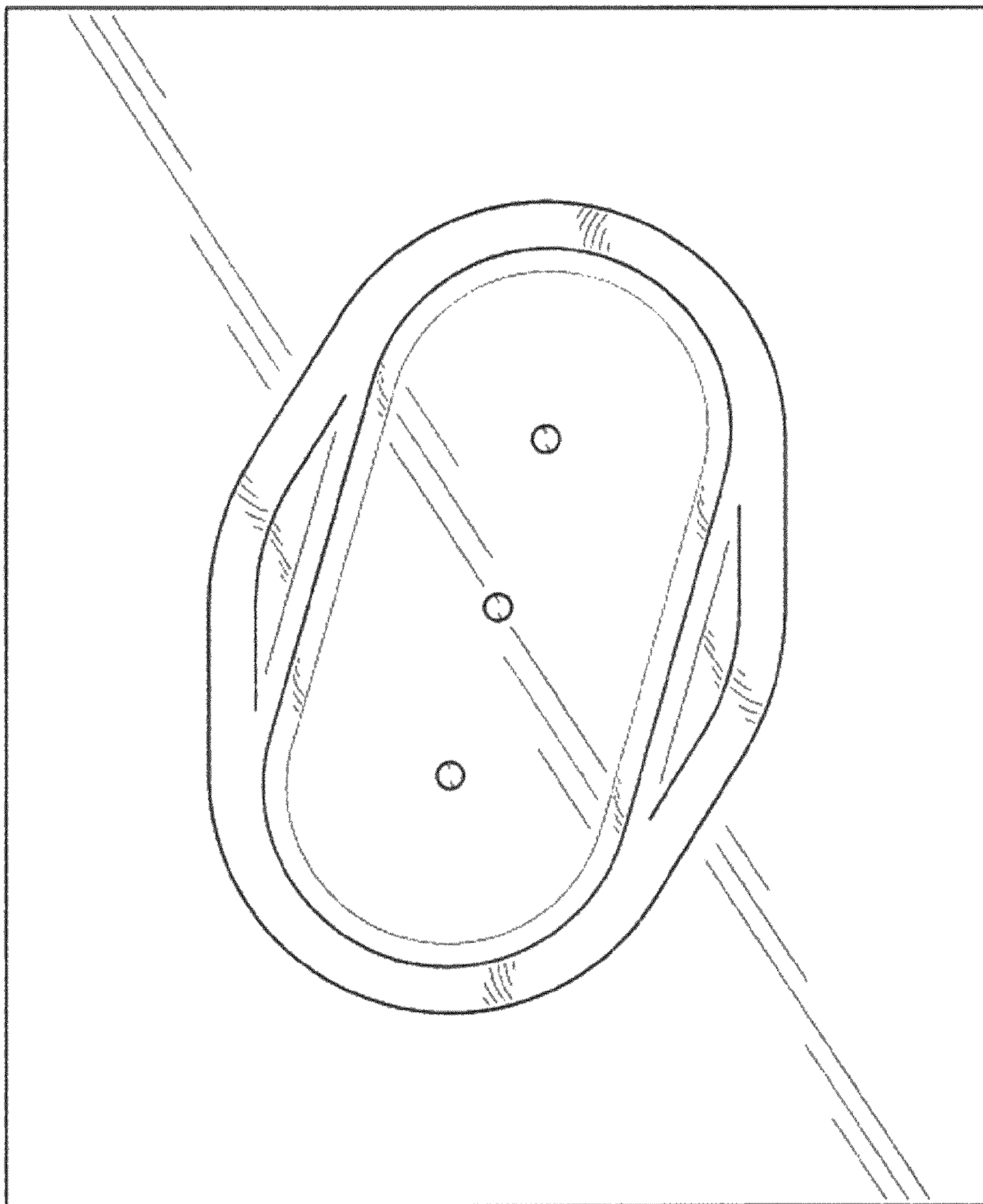

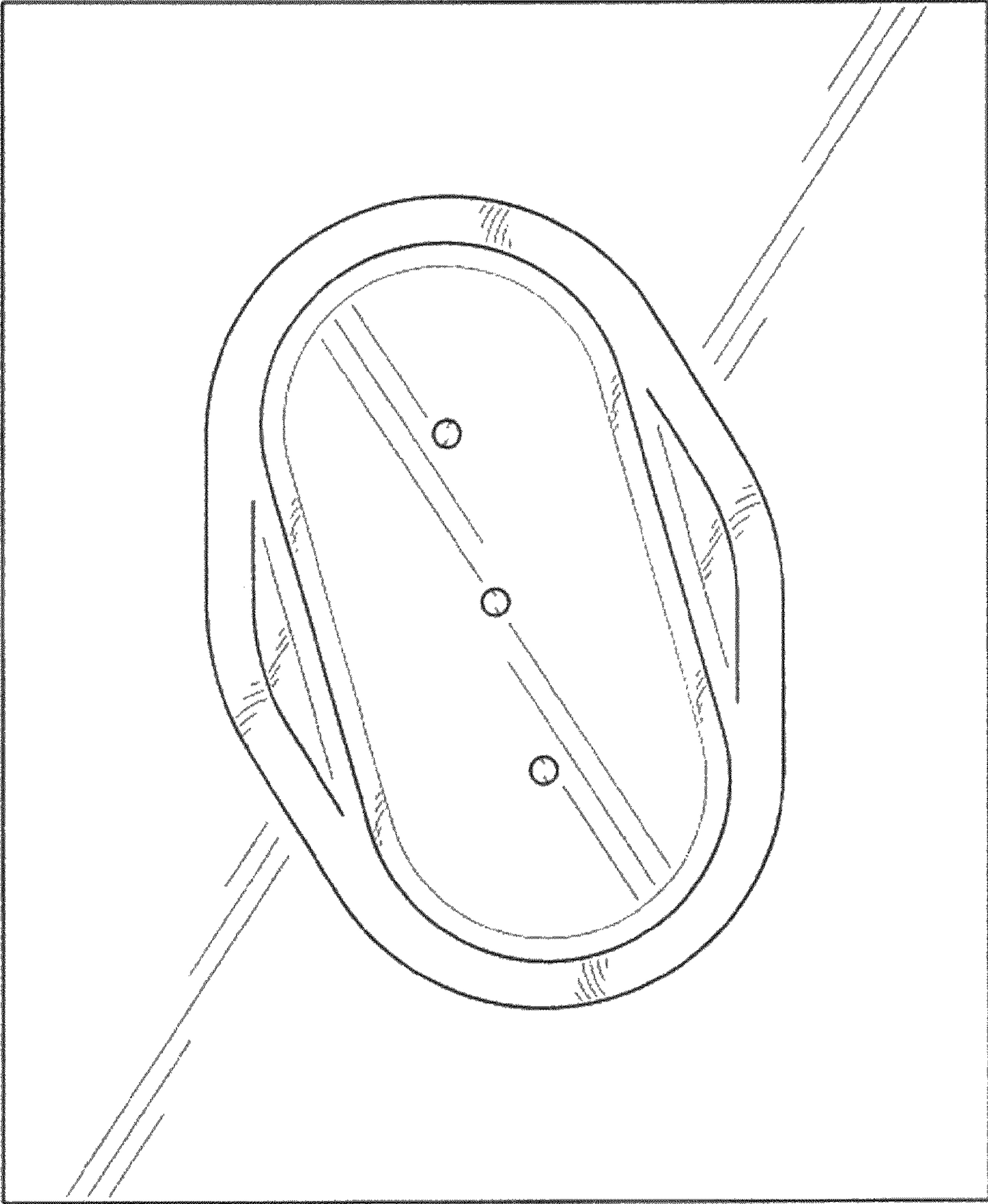

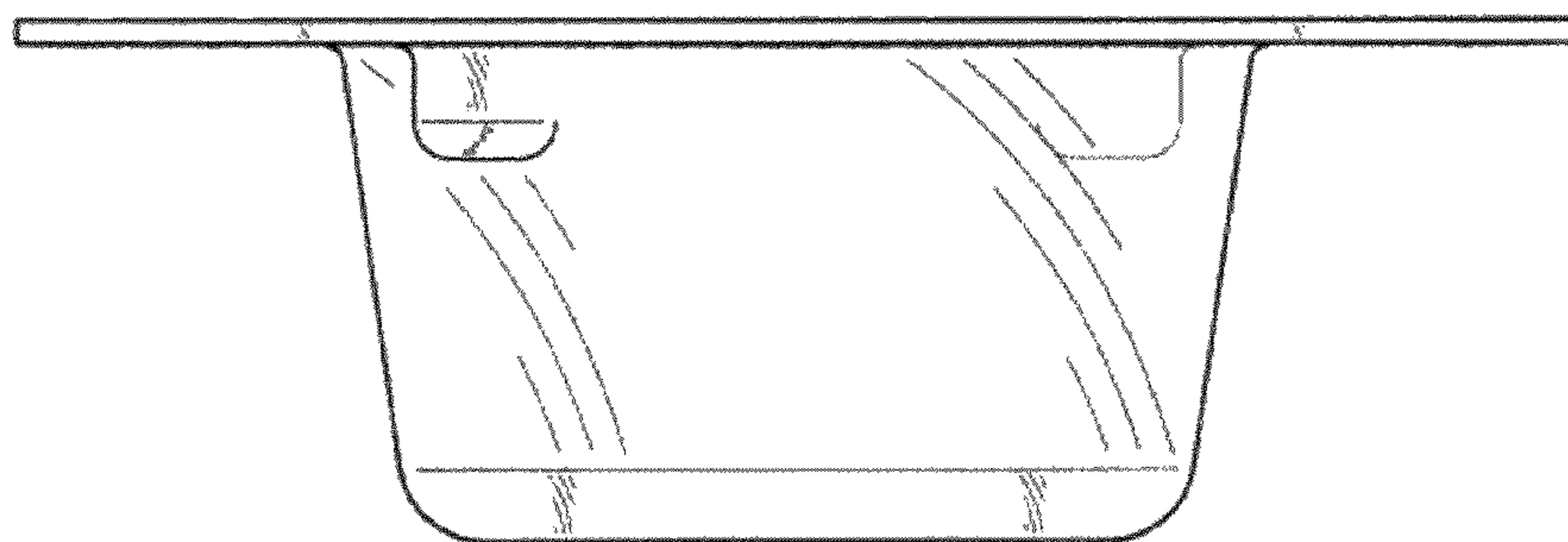

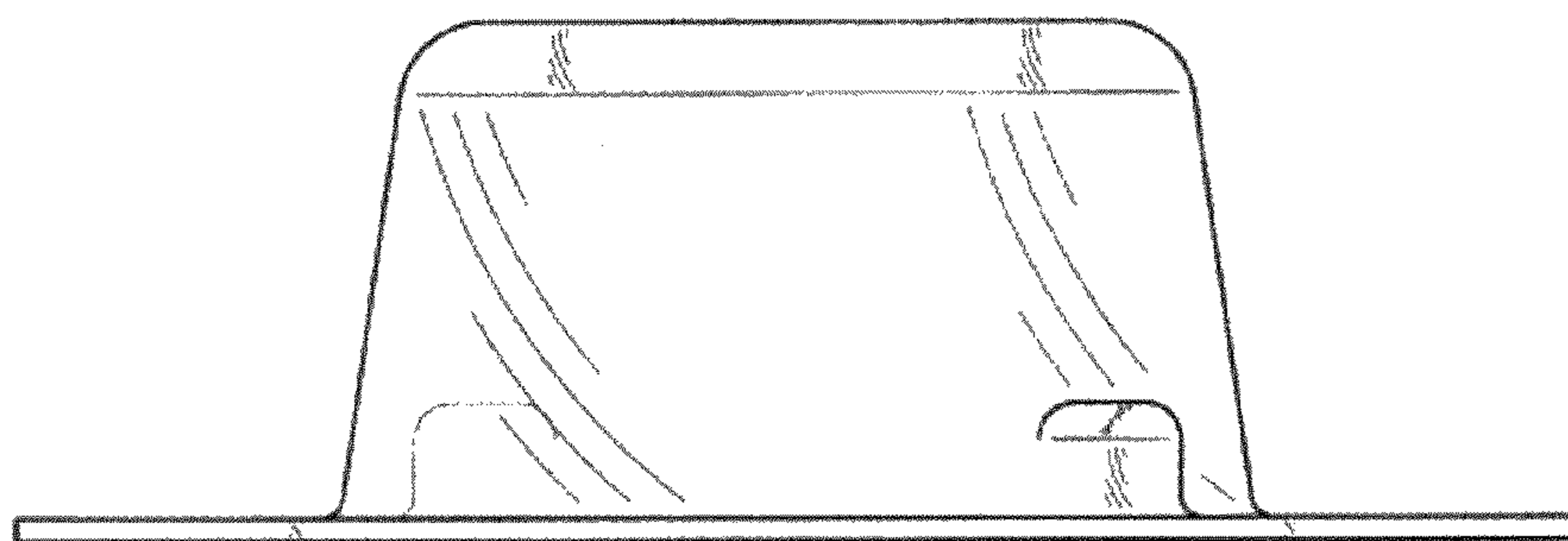

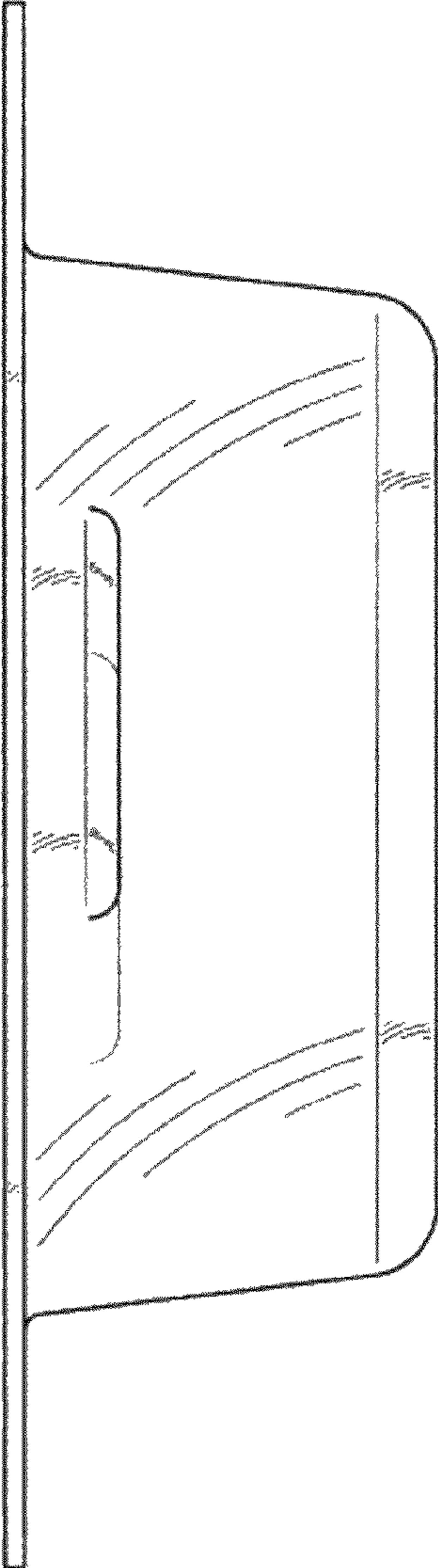

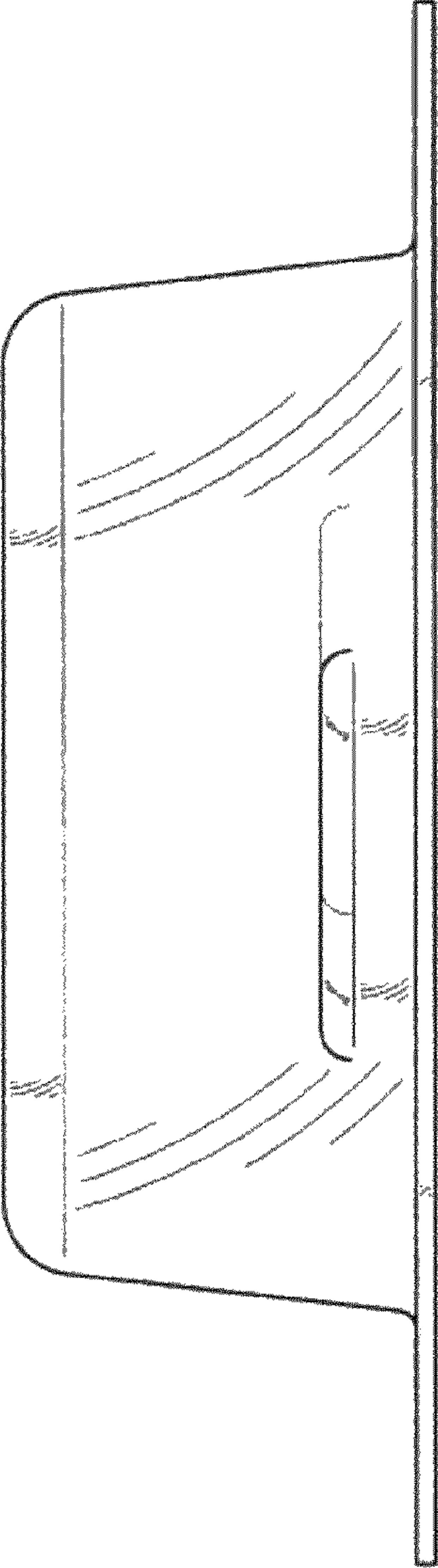
