FIG. 3 shows a bottom plan view thereof;

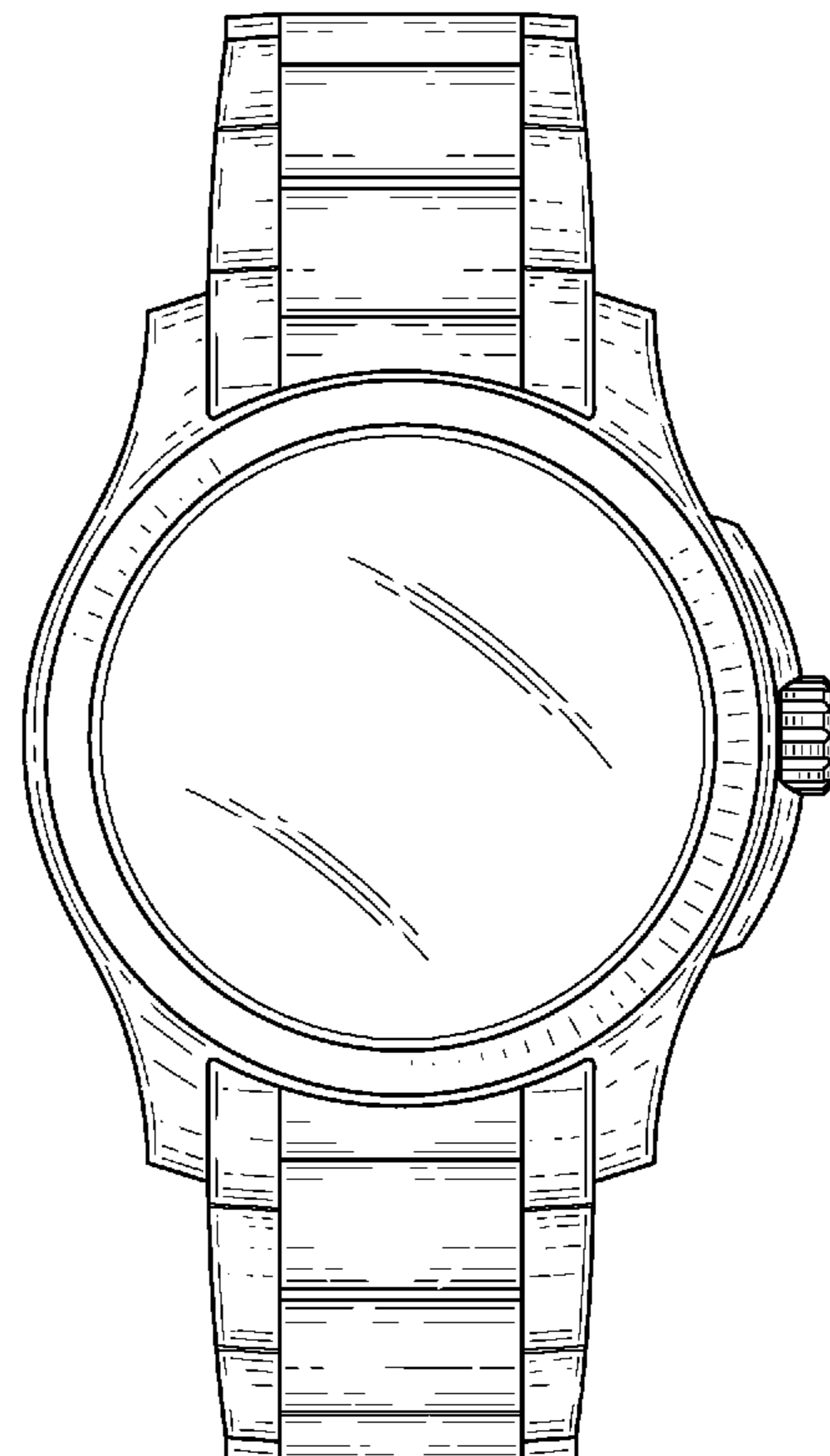
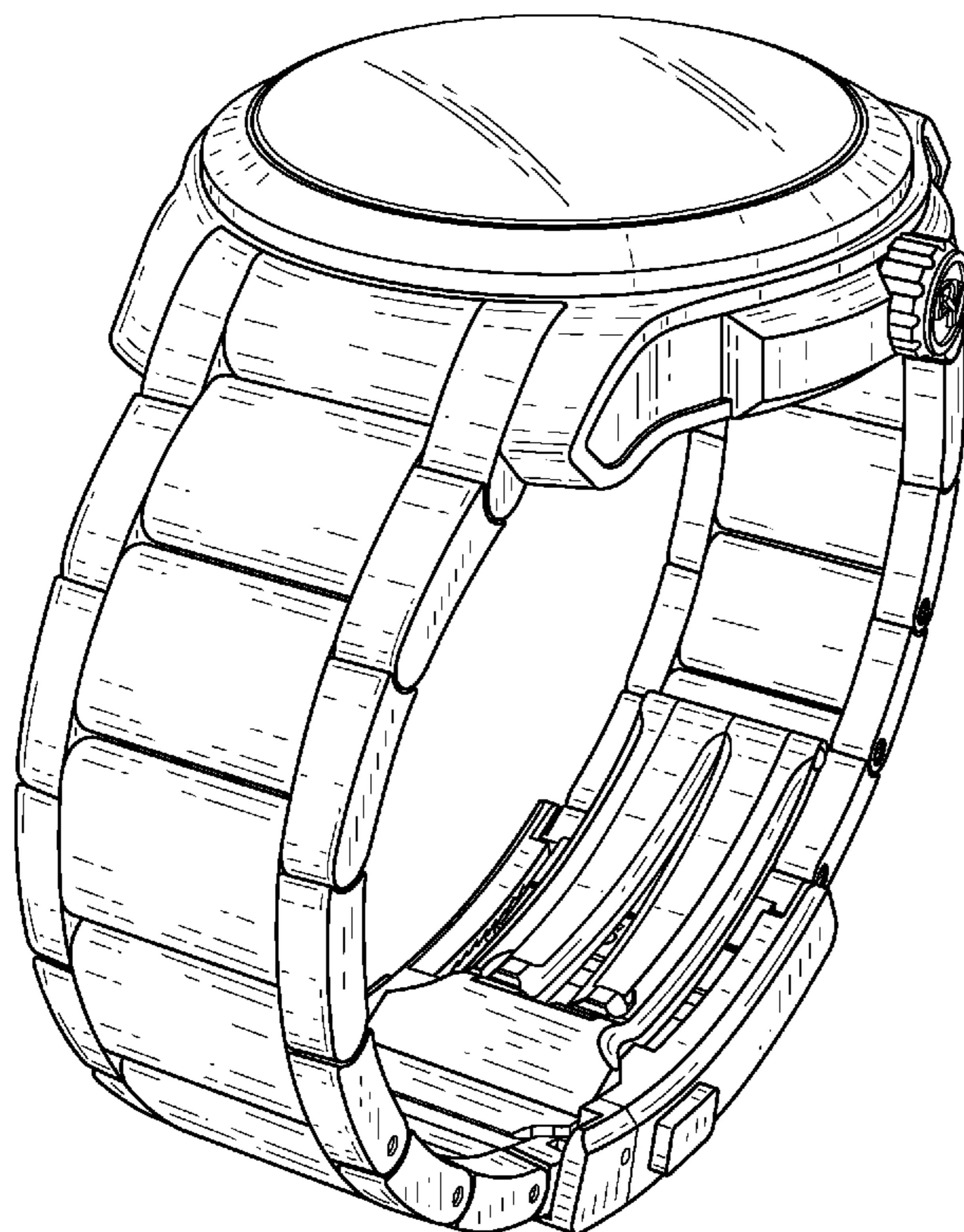
FIG. 4 shows a front elevational view thereof;

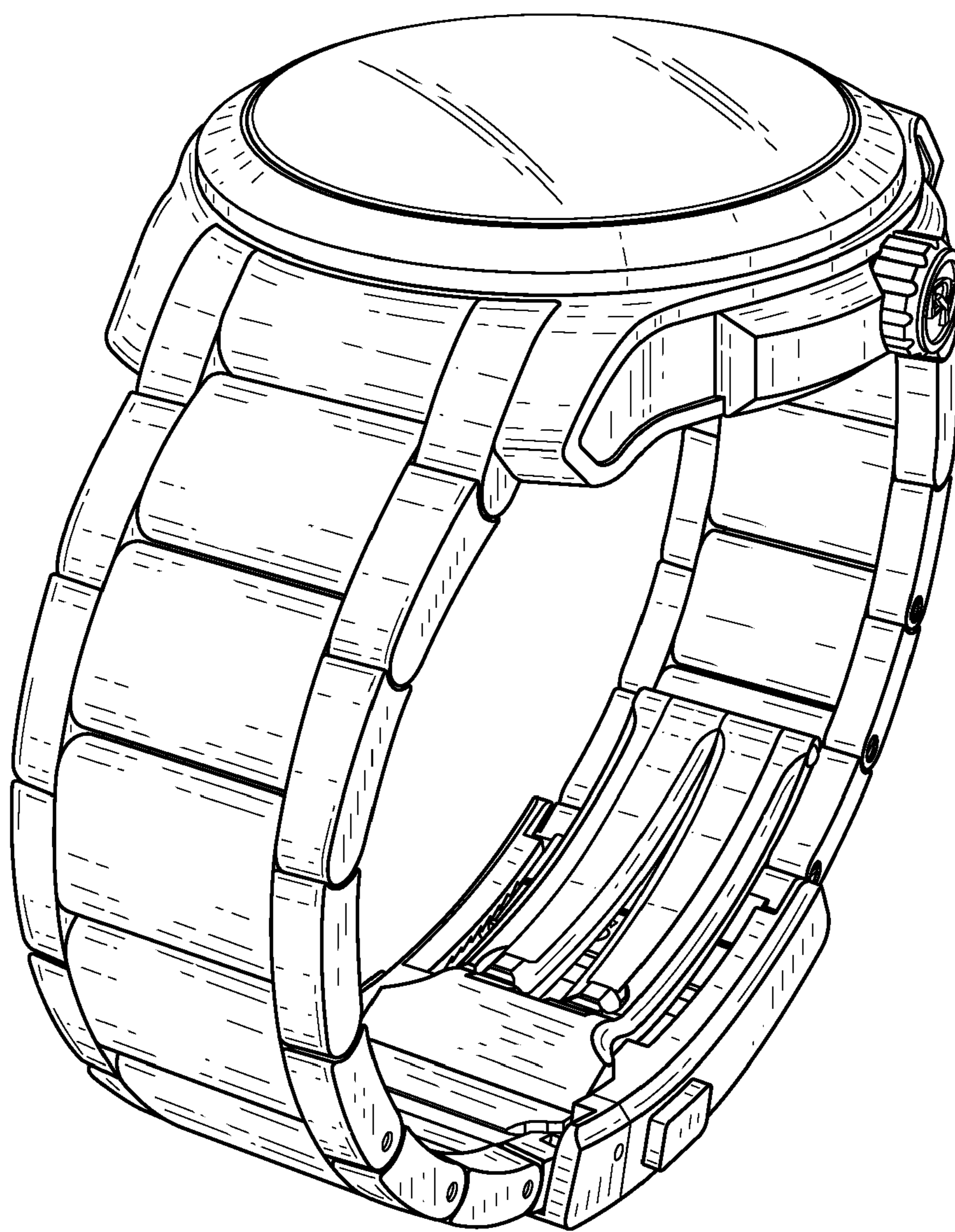

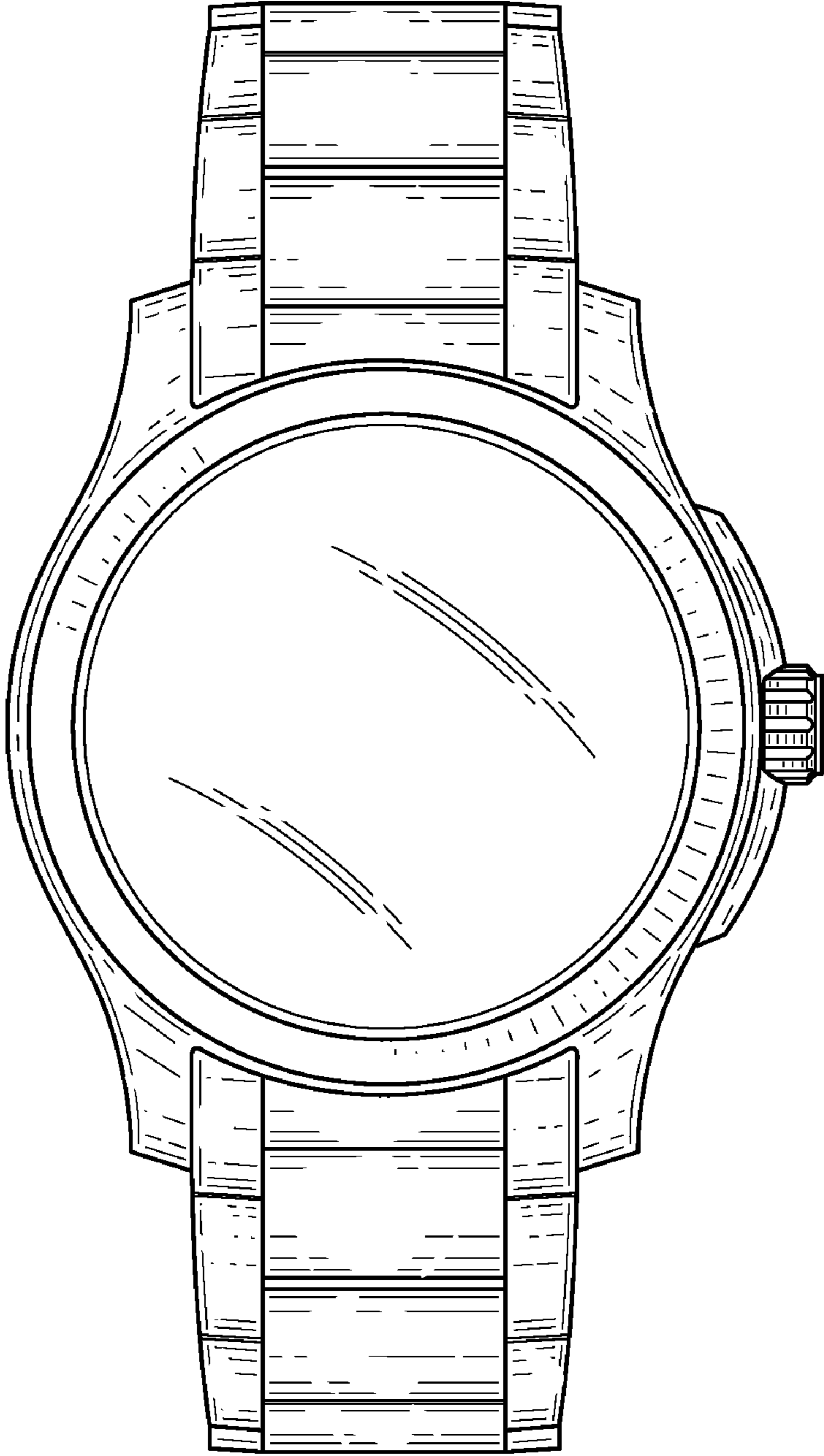

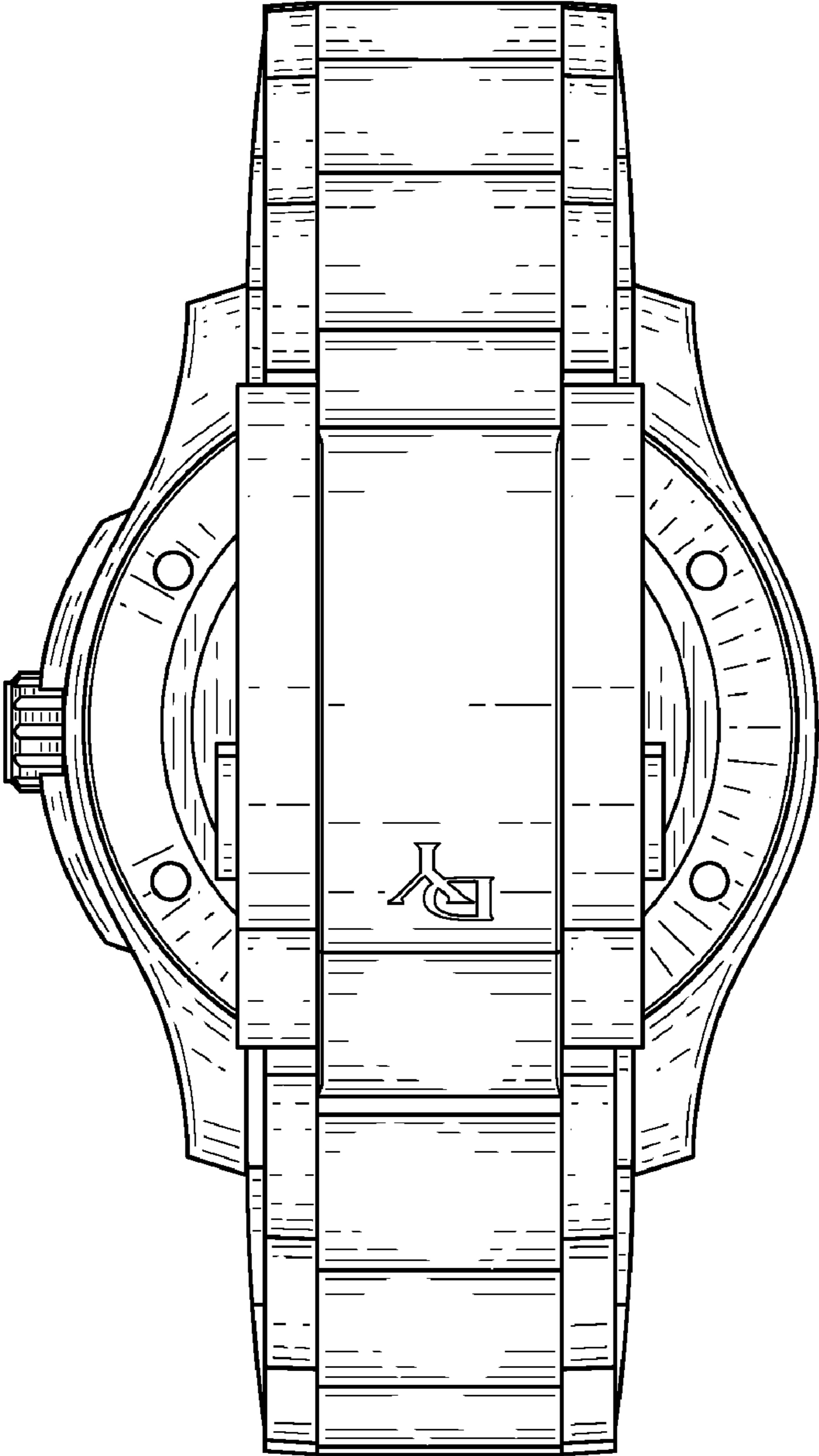

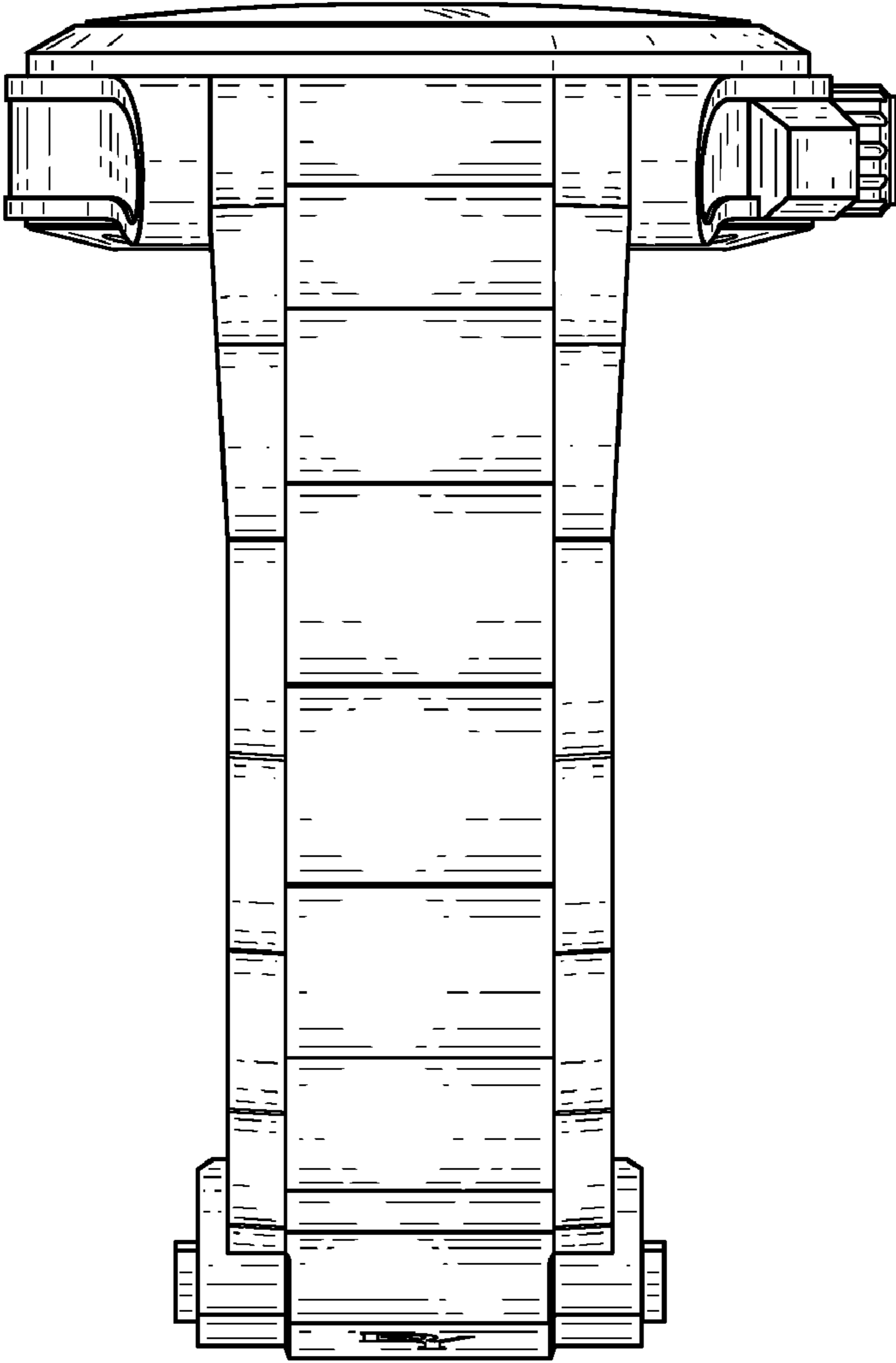

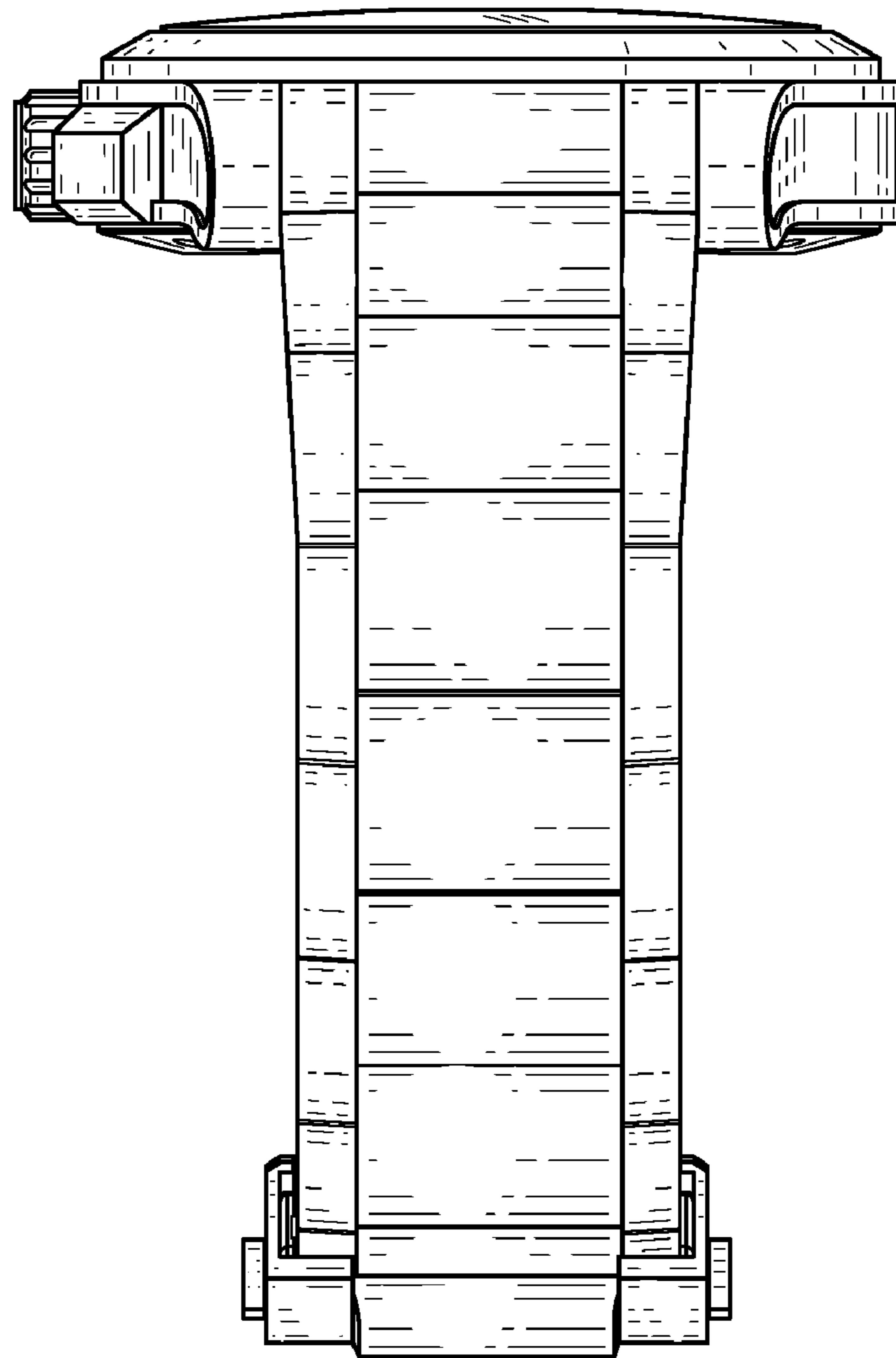

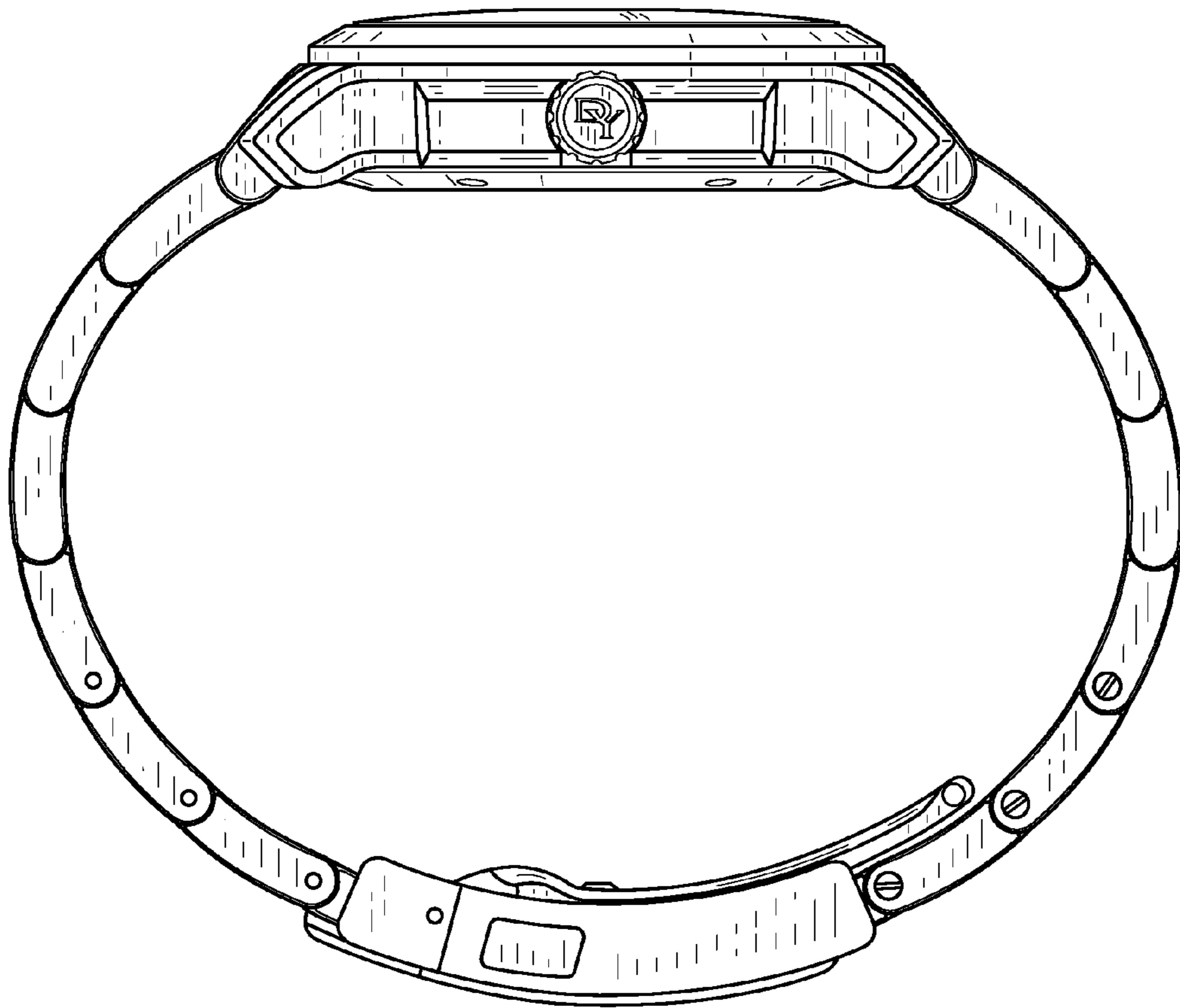

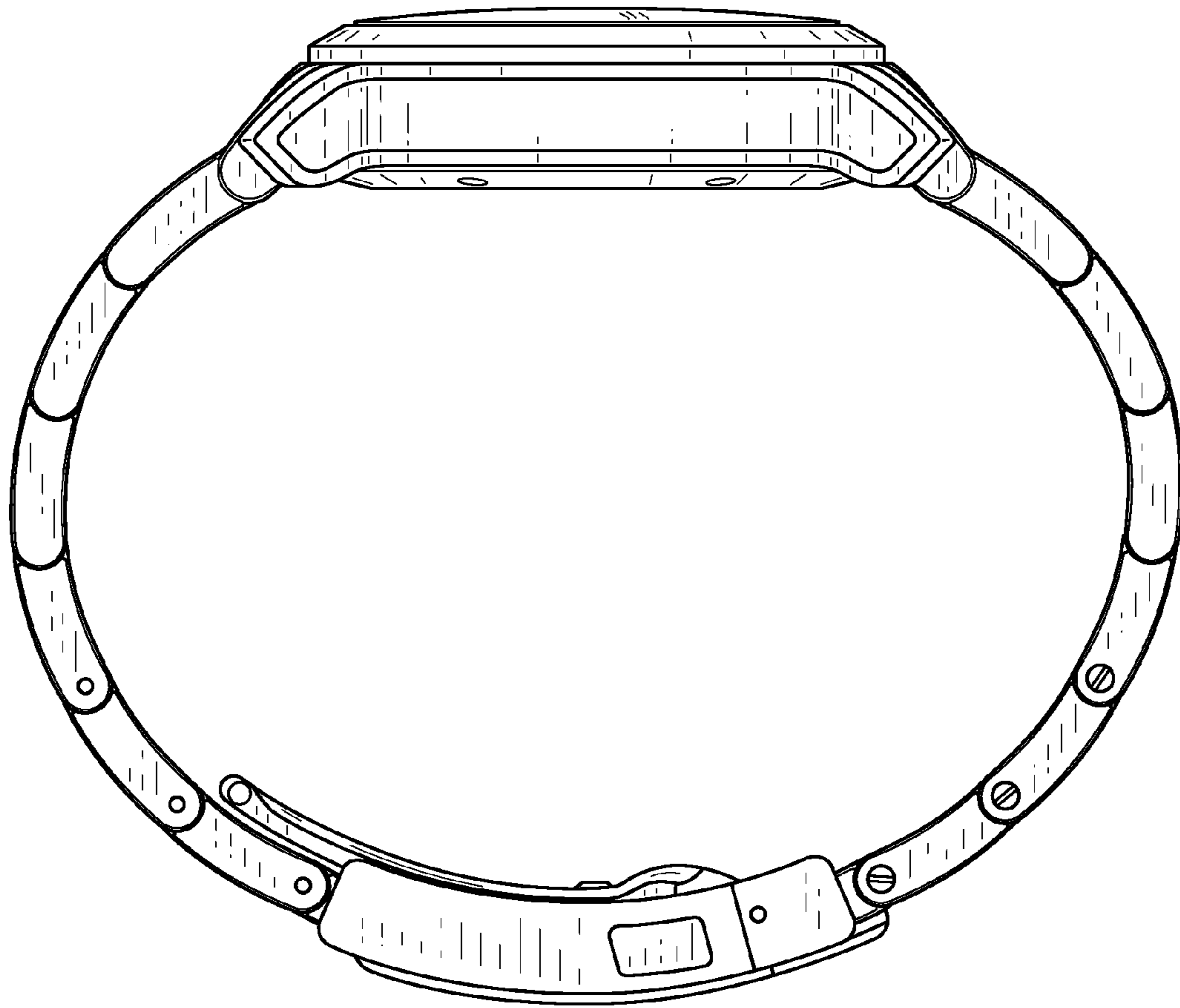
