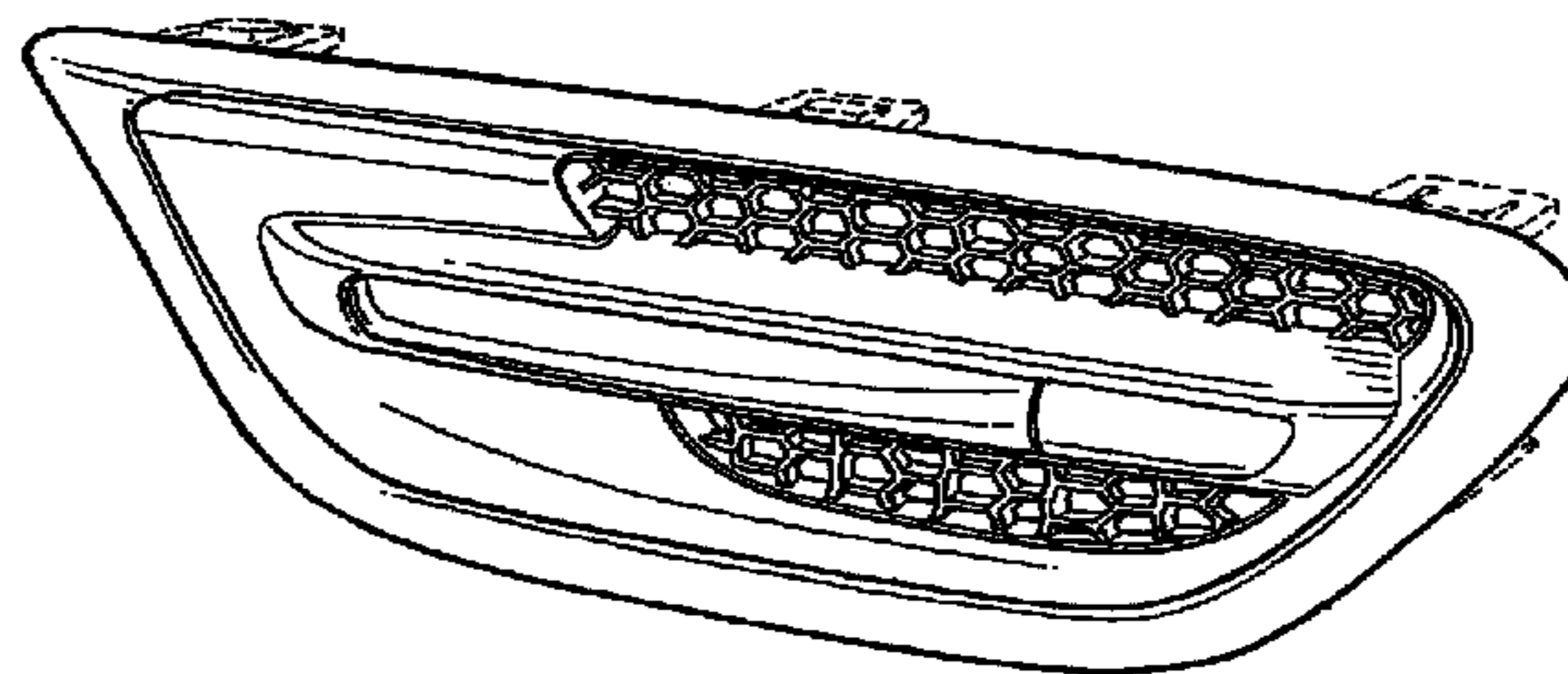
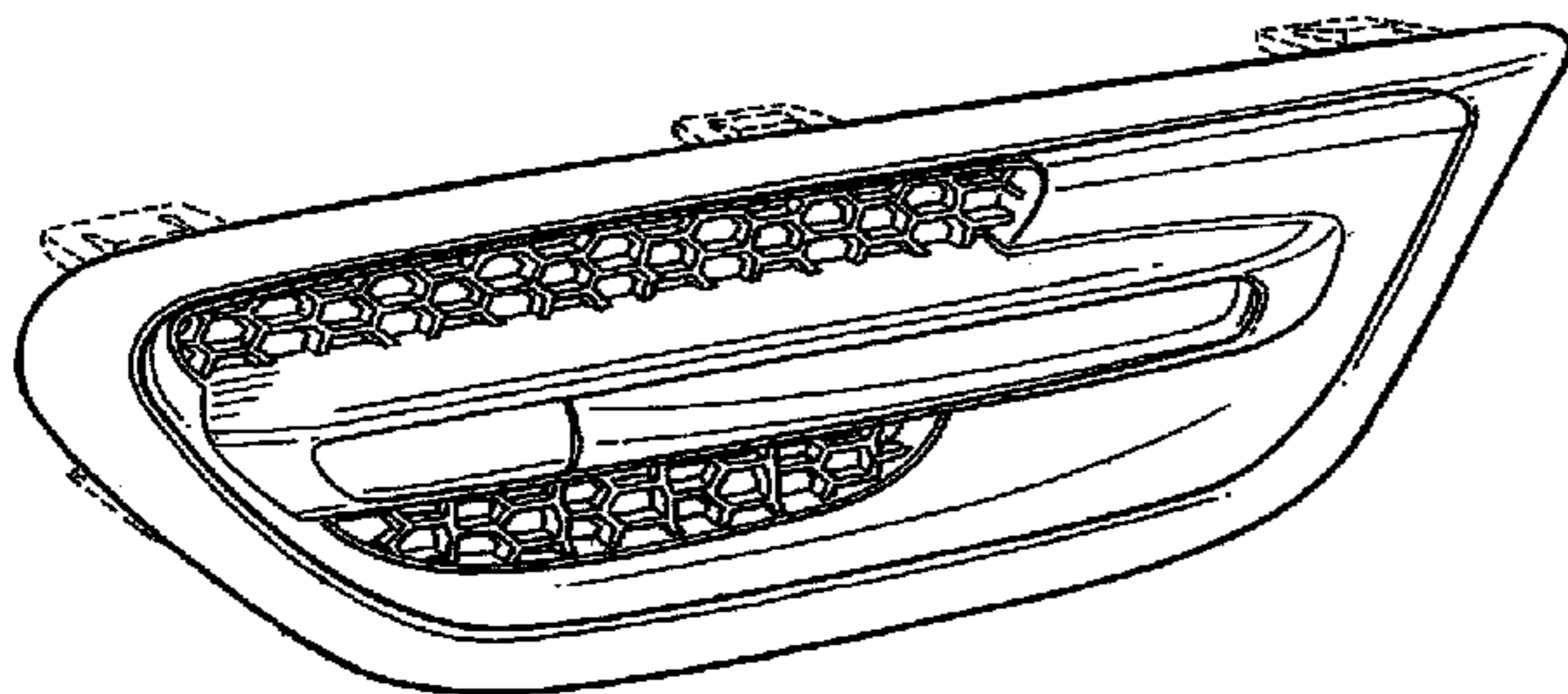
(57) **CLAIM**

The ornamental design for a decorative element for a vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a left perspective view of a first embodiment of a decorative element for a vehicle according to my design; FIG. 2 is a right perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a right side view thereof; and FIG. 7 is a left side view thereof. 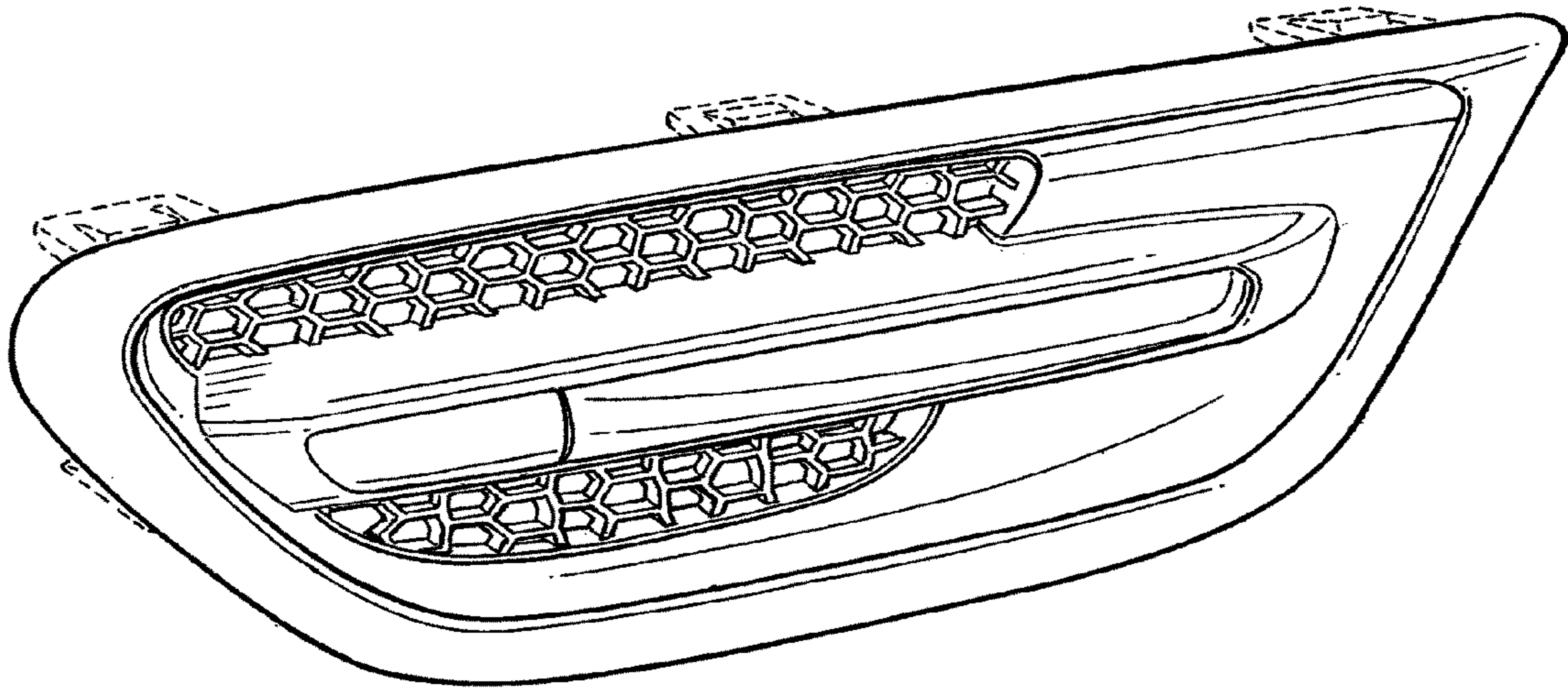

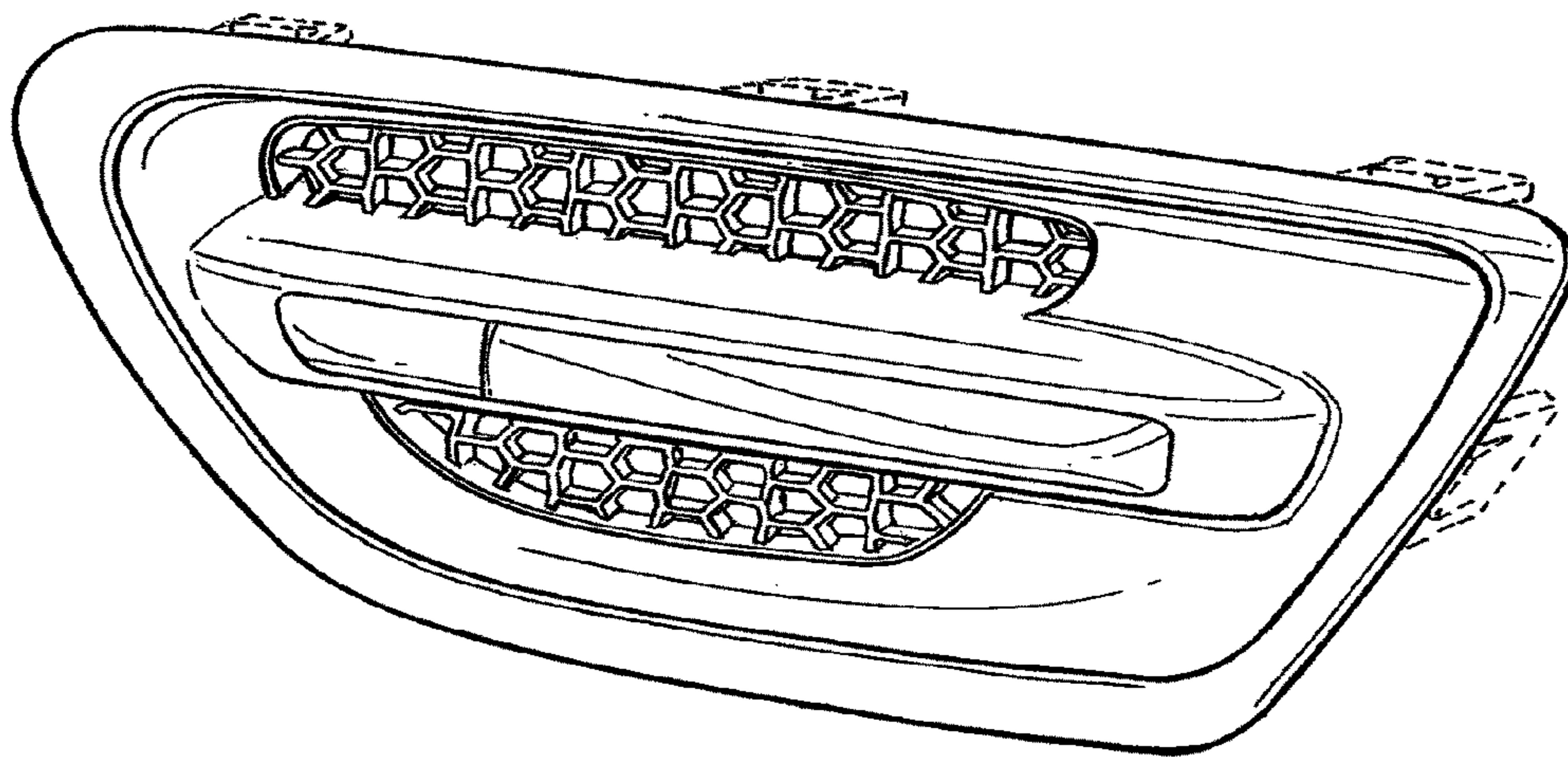

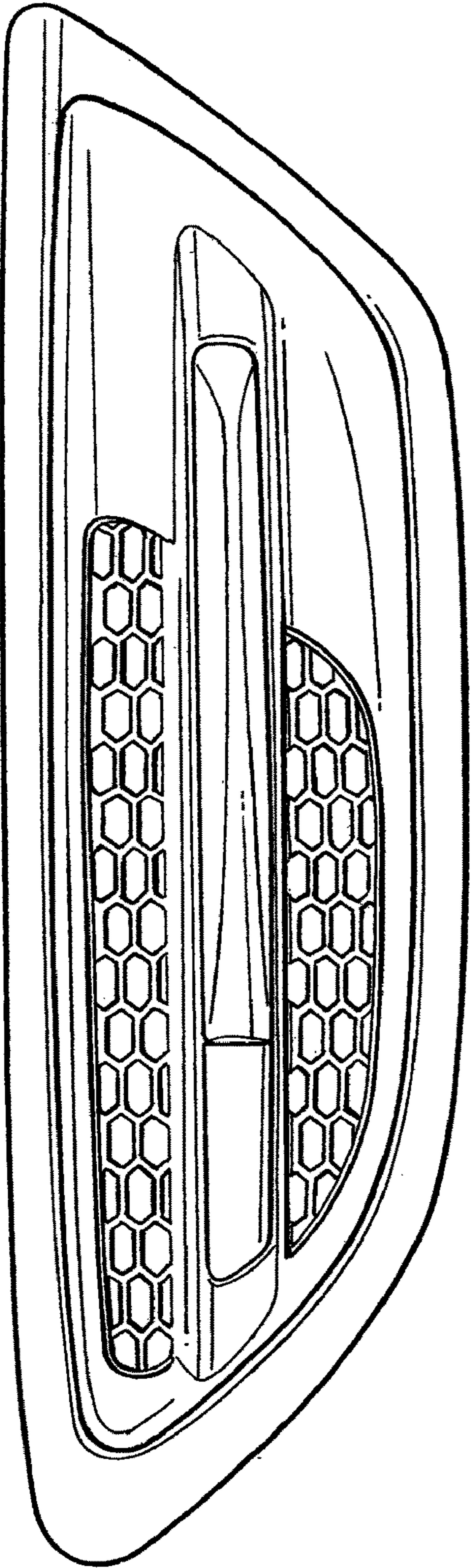

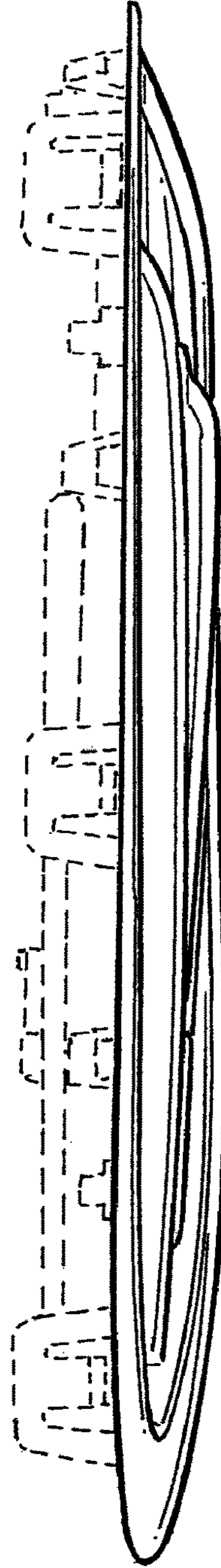

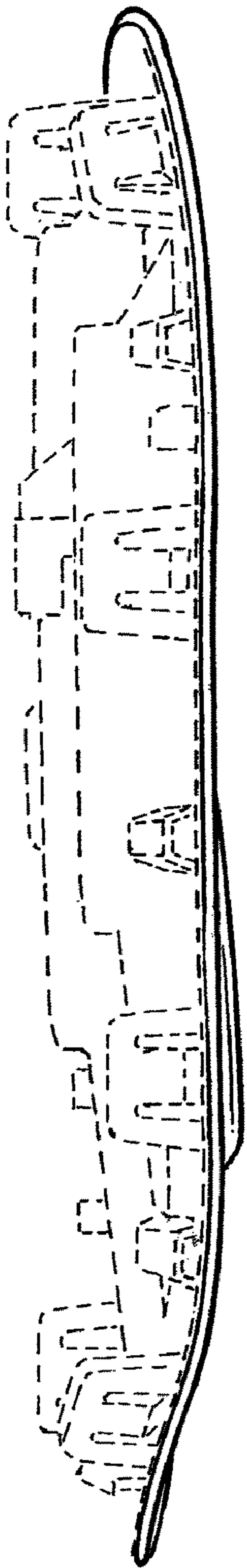

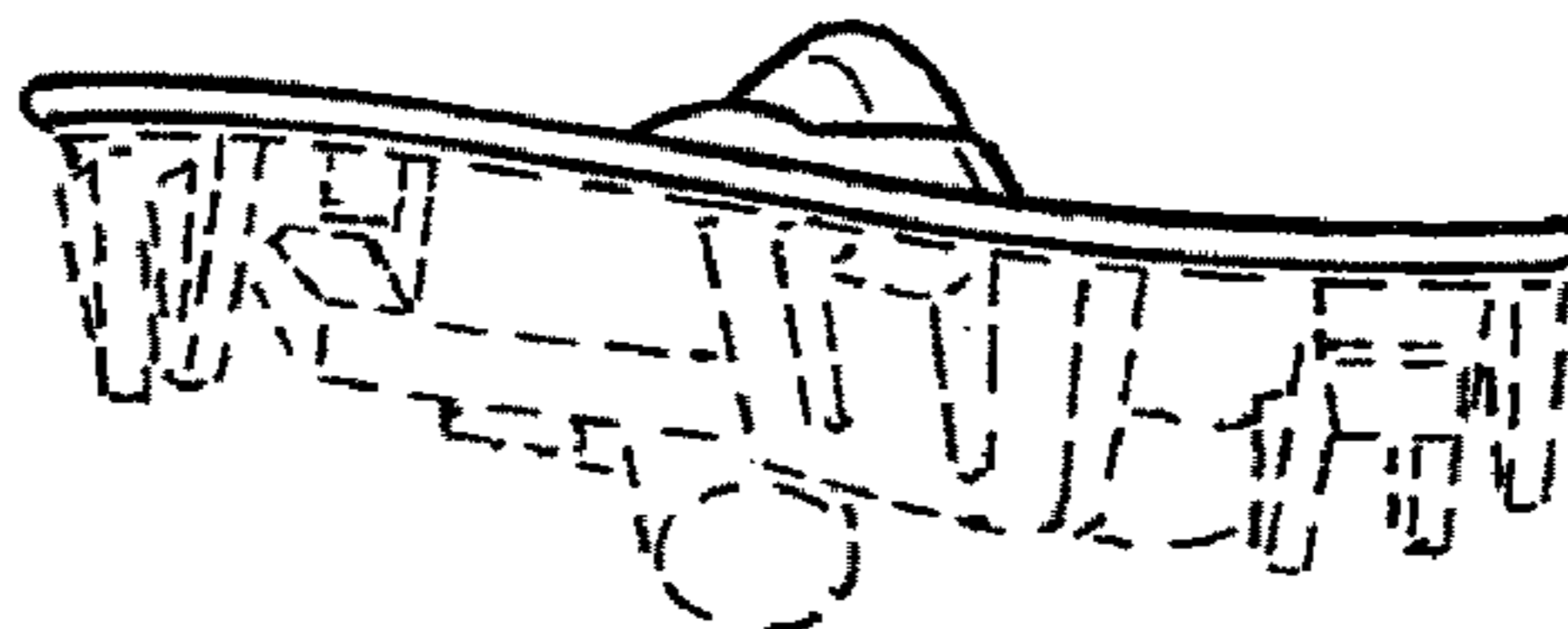

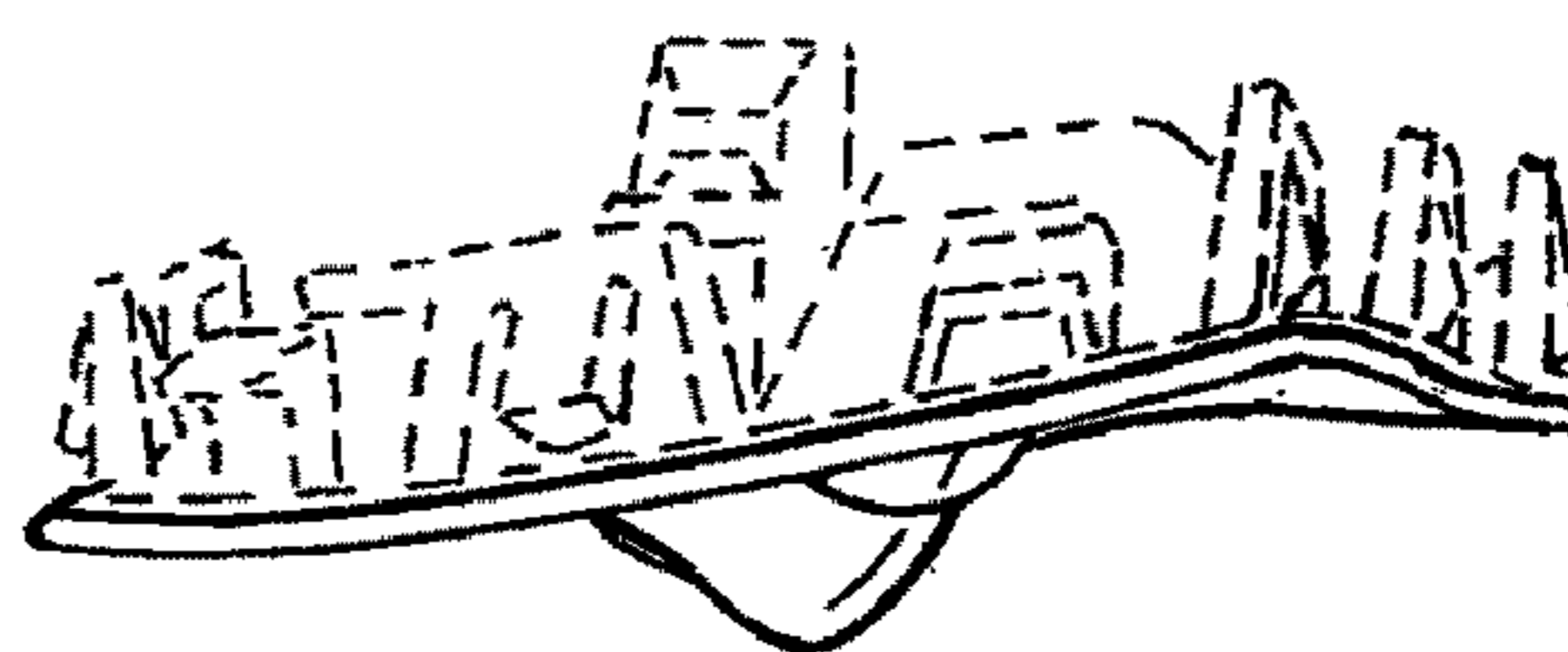

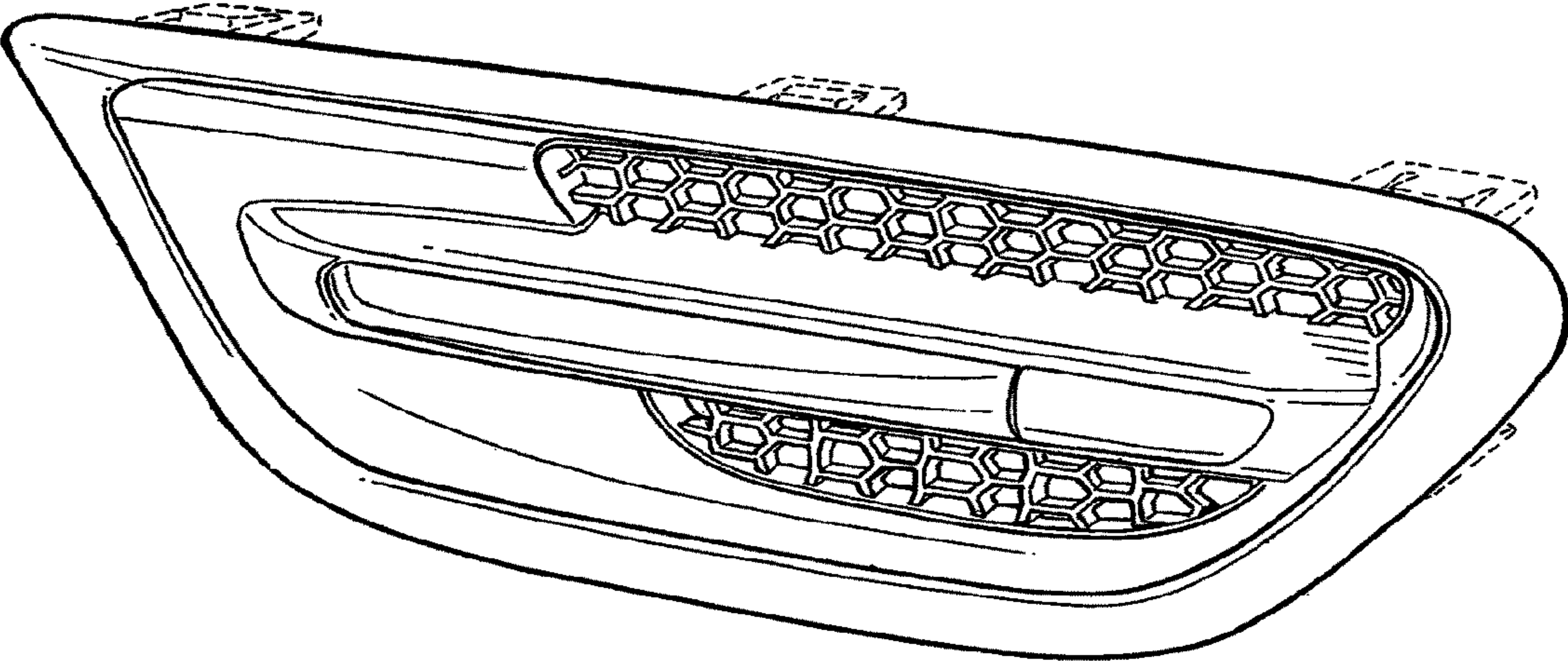

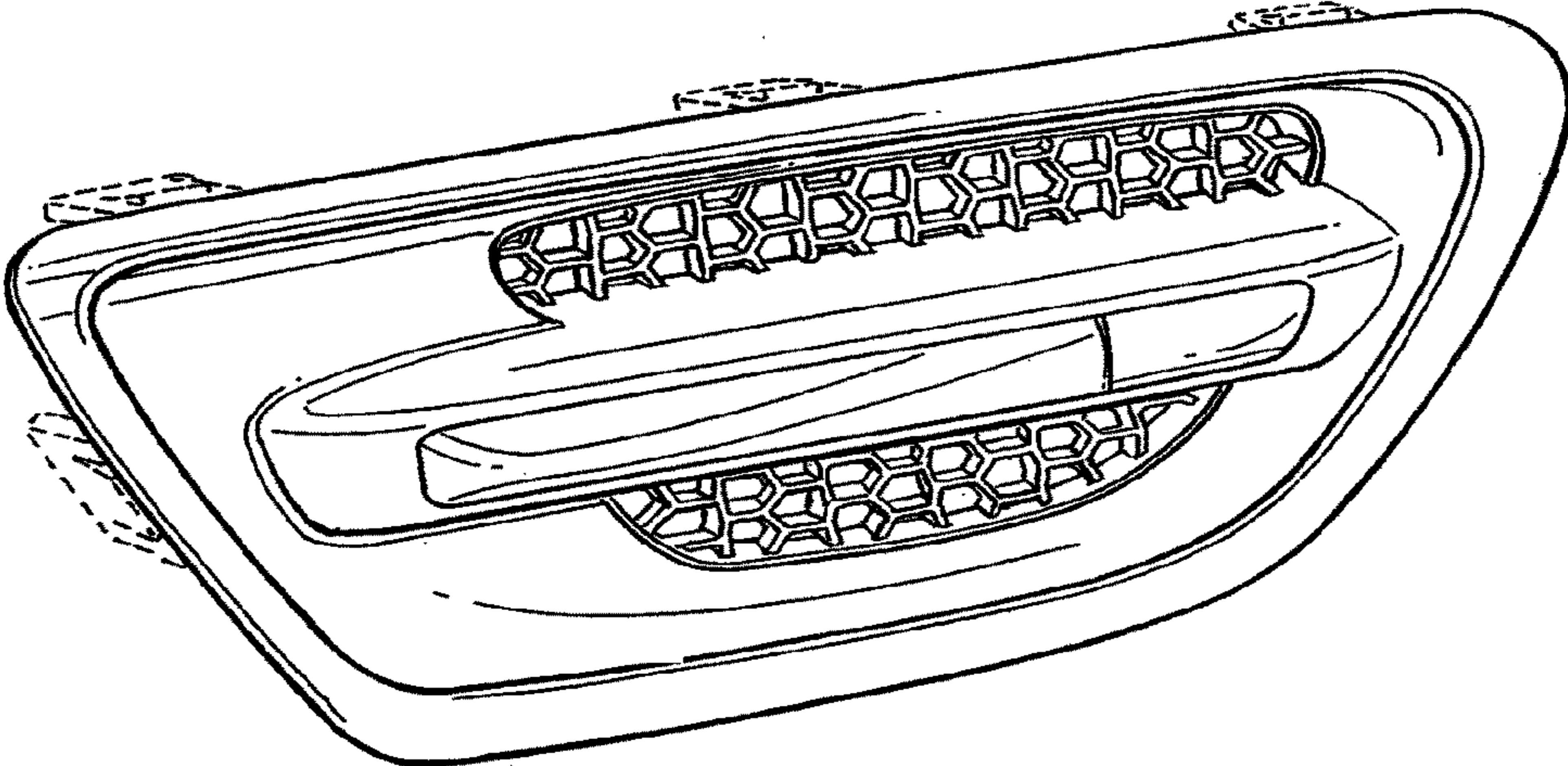

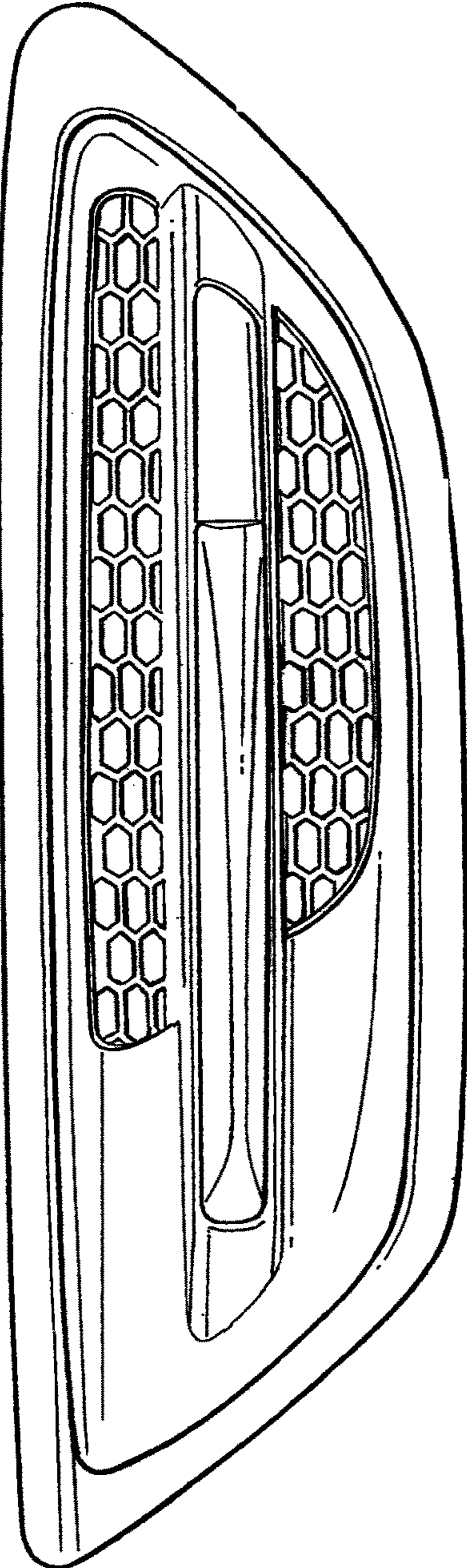

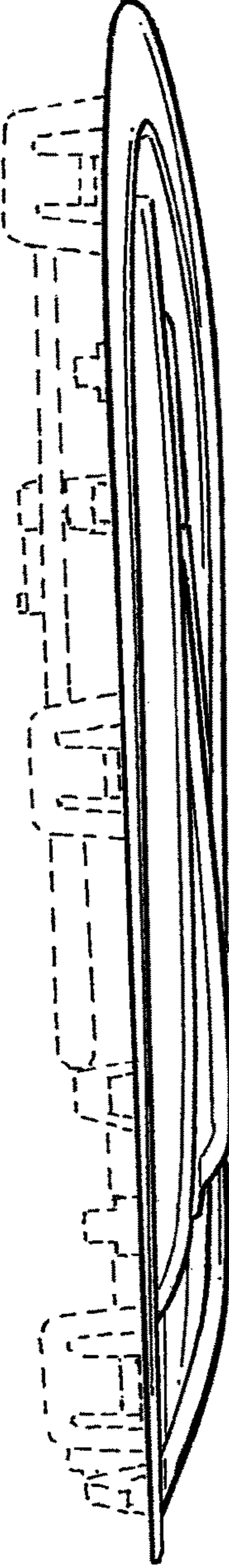

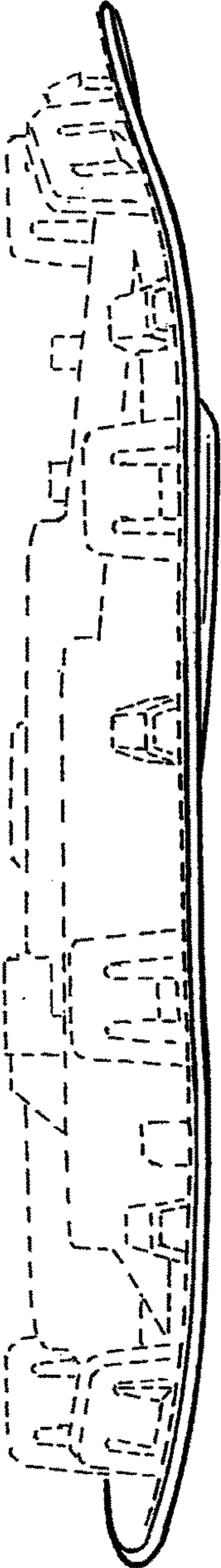

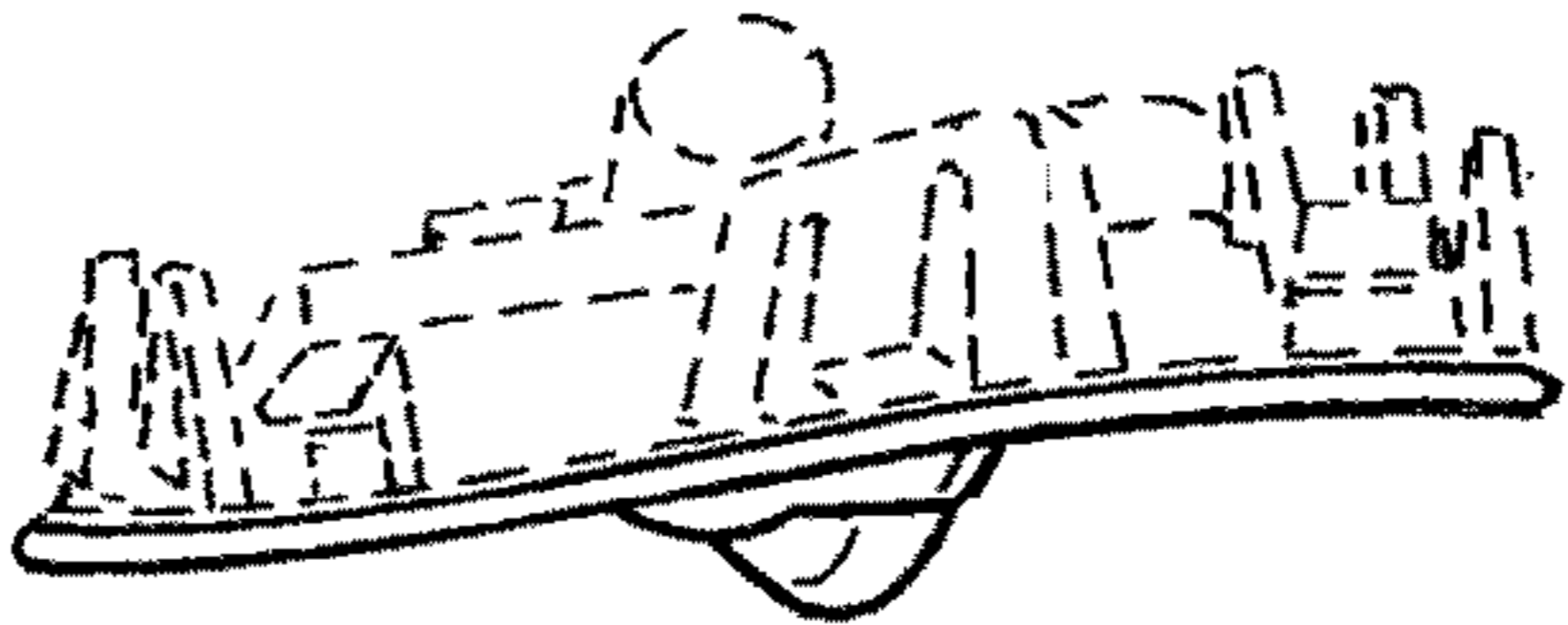

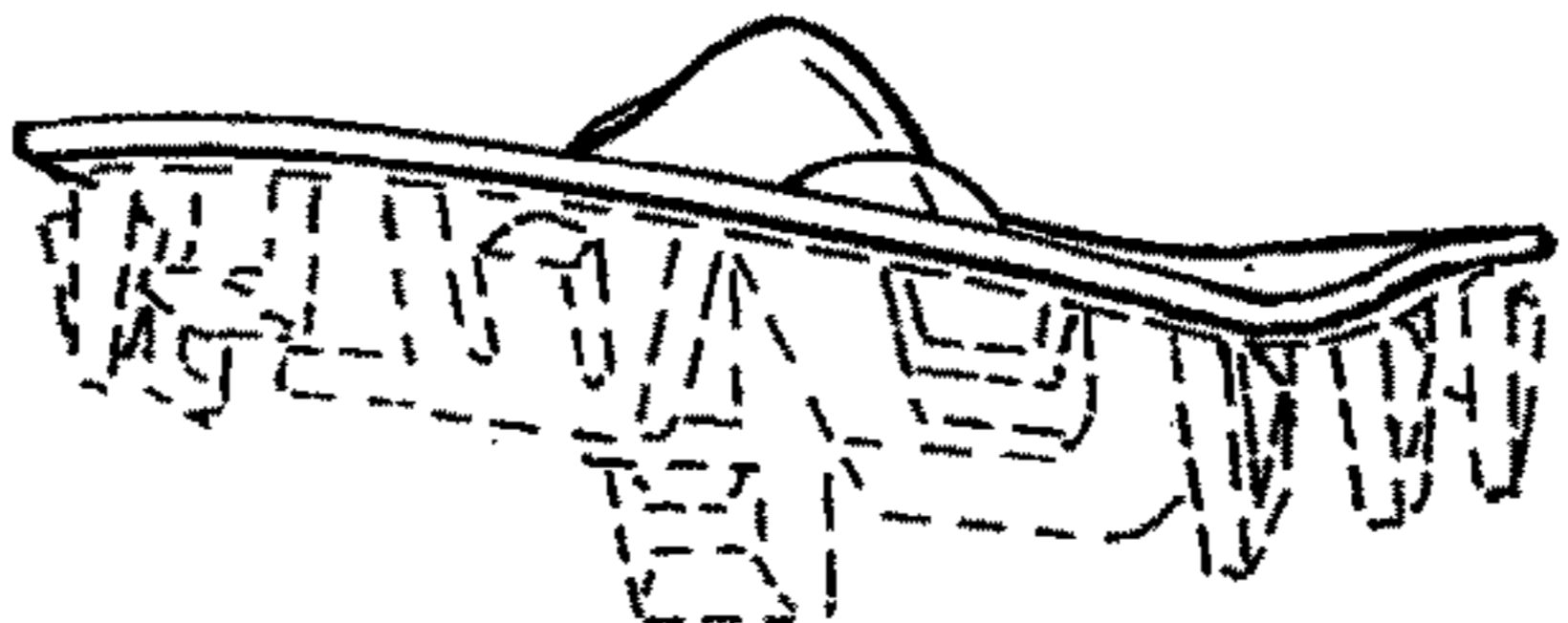
