FIG. 3 is a perspective view of the invention shown in FIG. 1 in an unfastened manner.

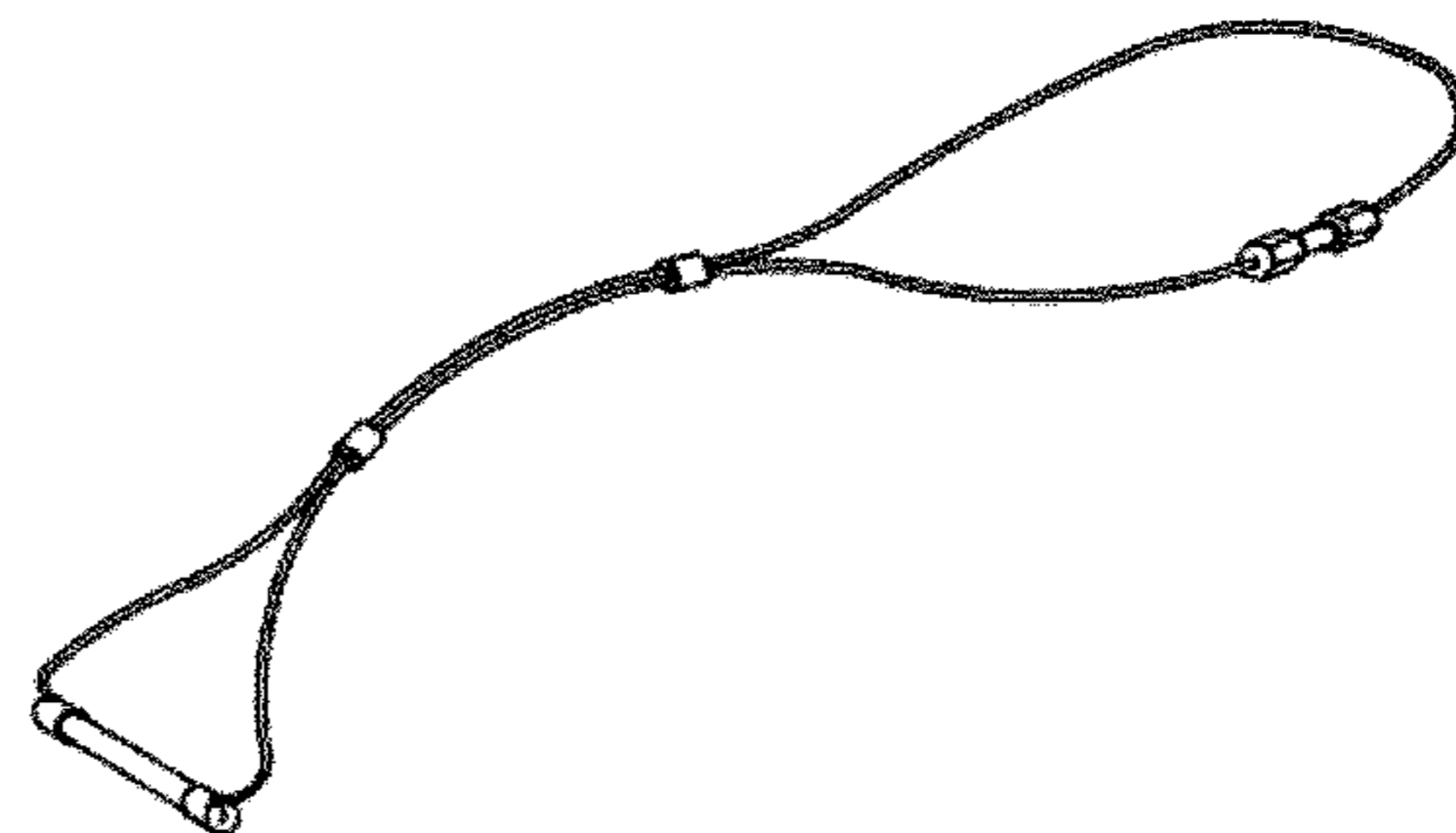
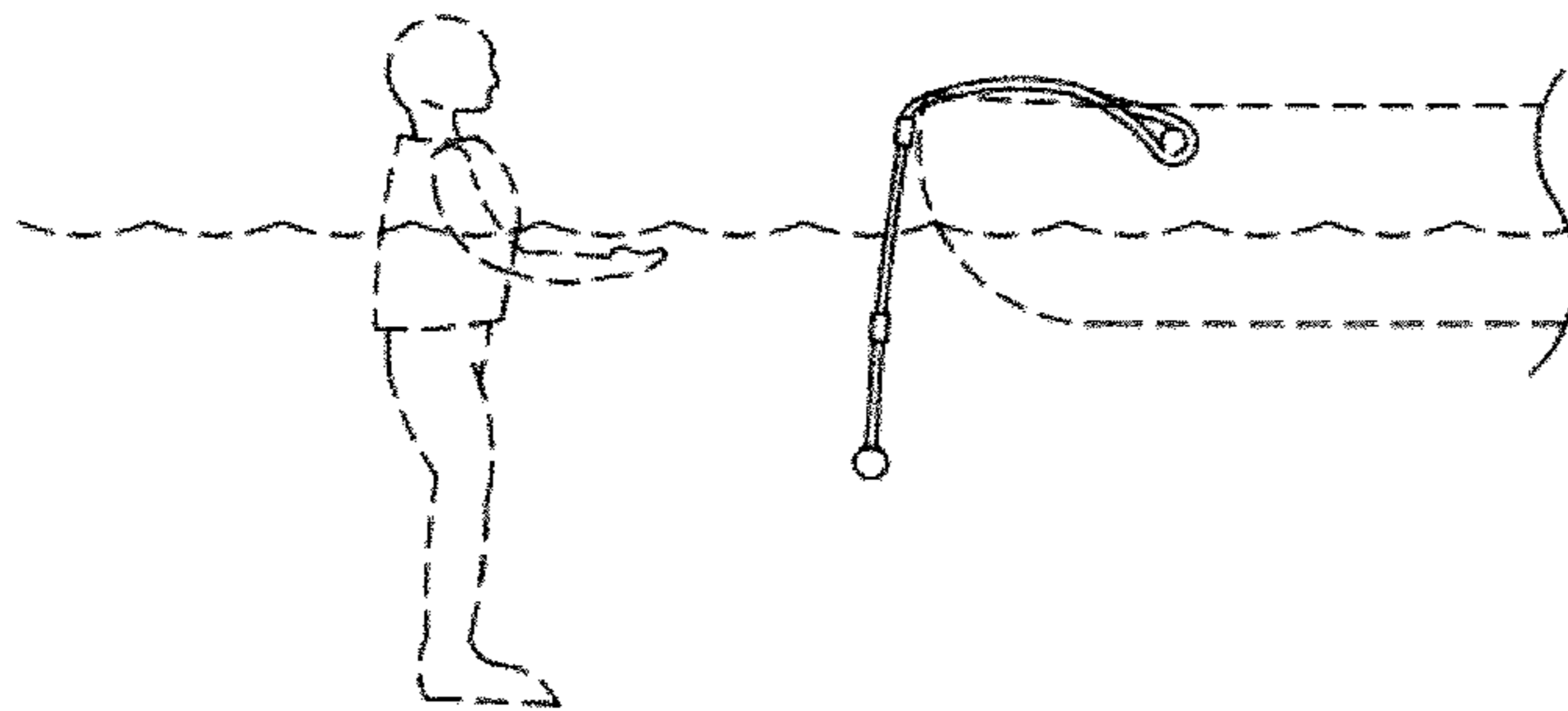
FIG. 4 is a perspective view of the invention shown in FIG. 1 in a partially fastened manner;

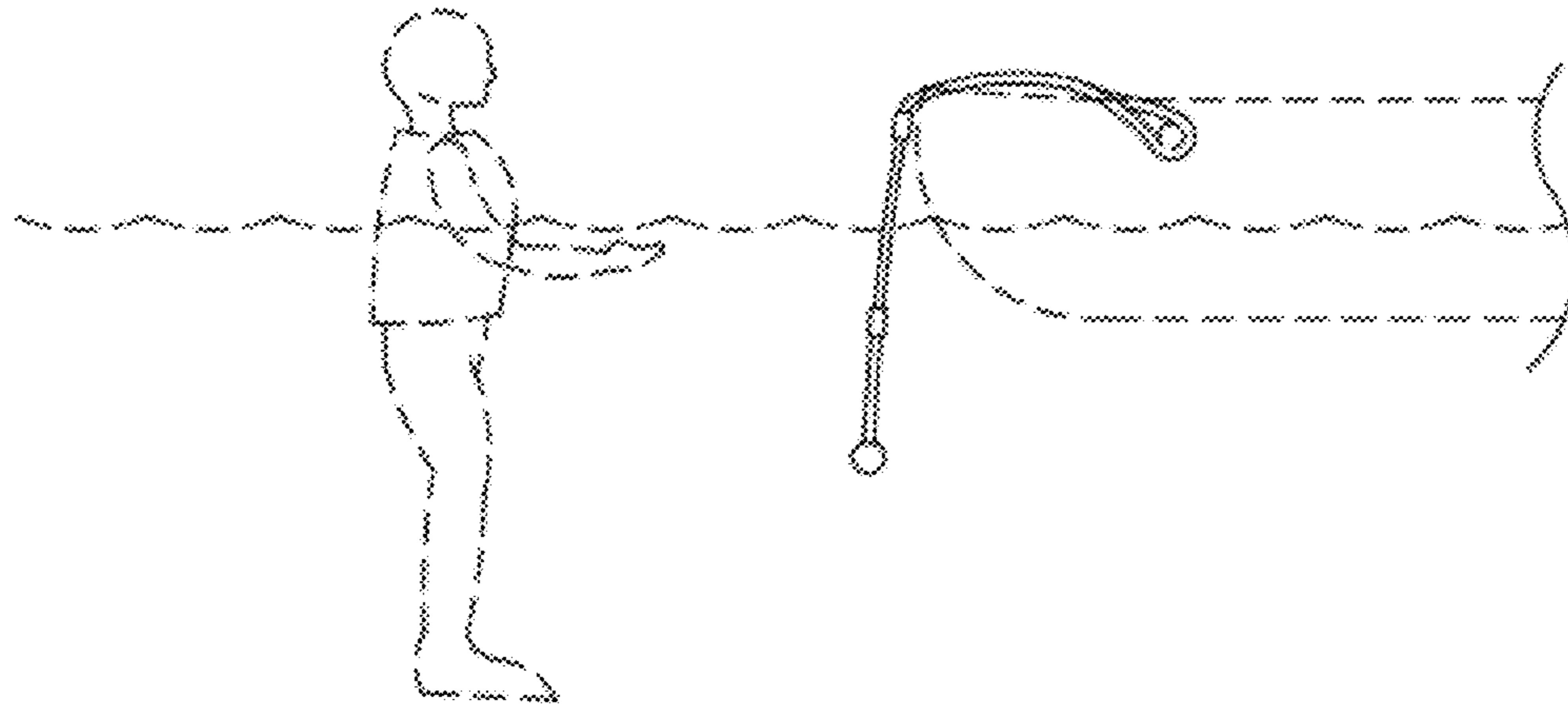

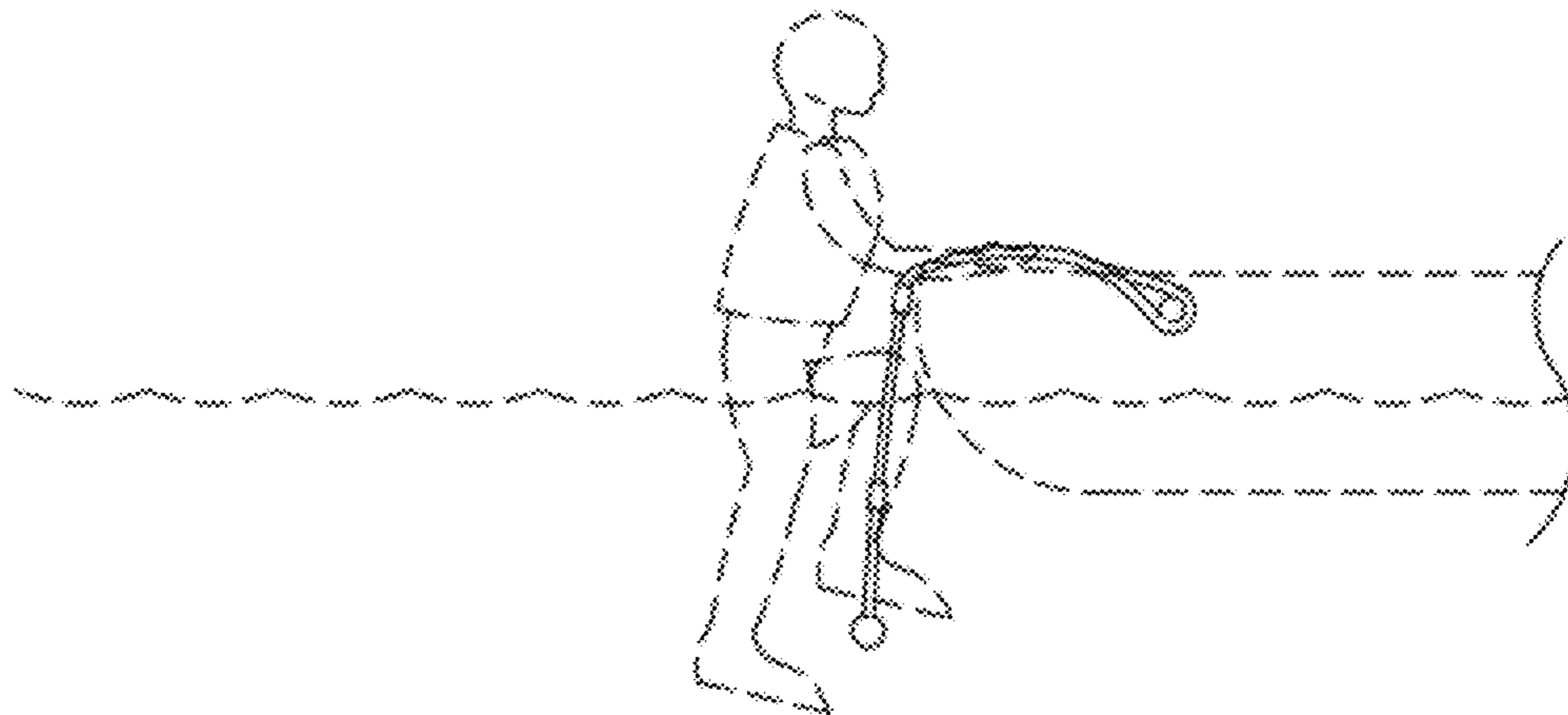

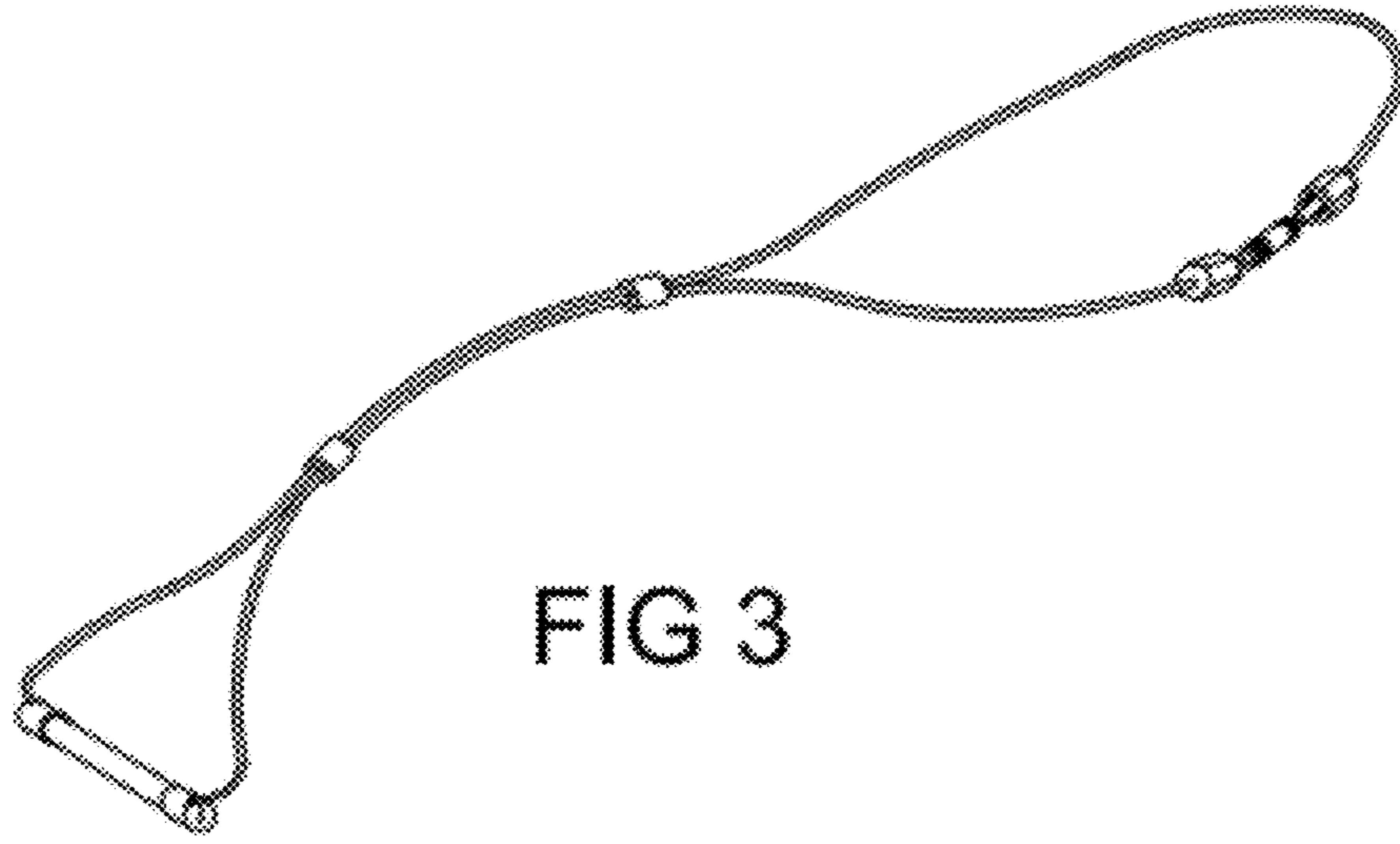

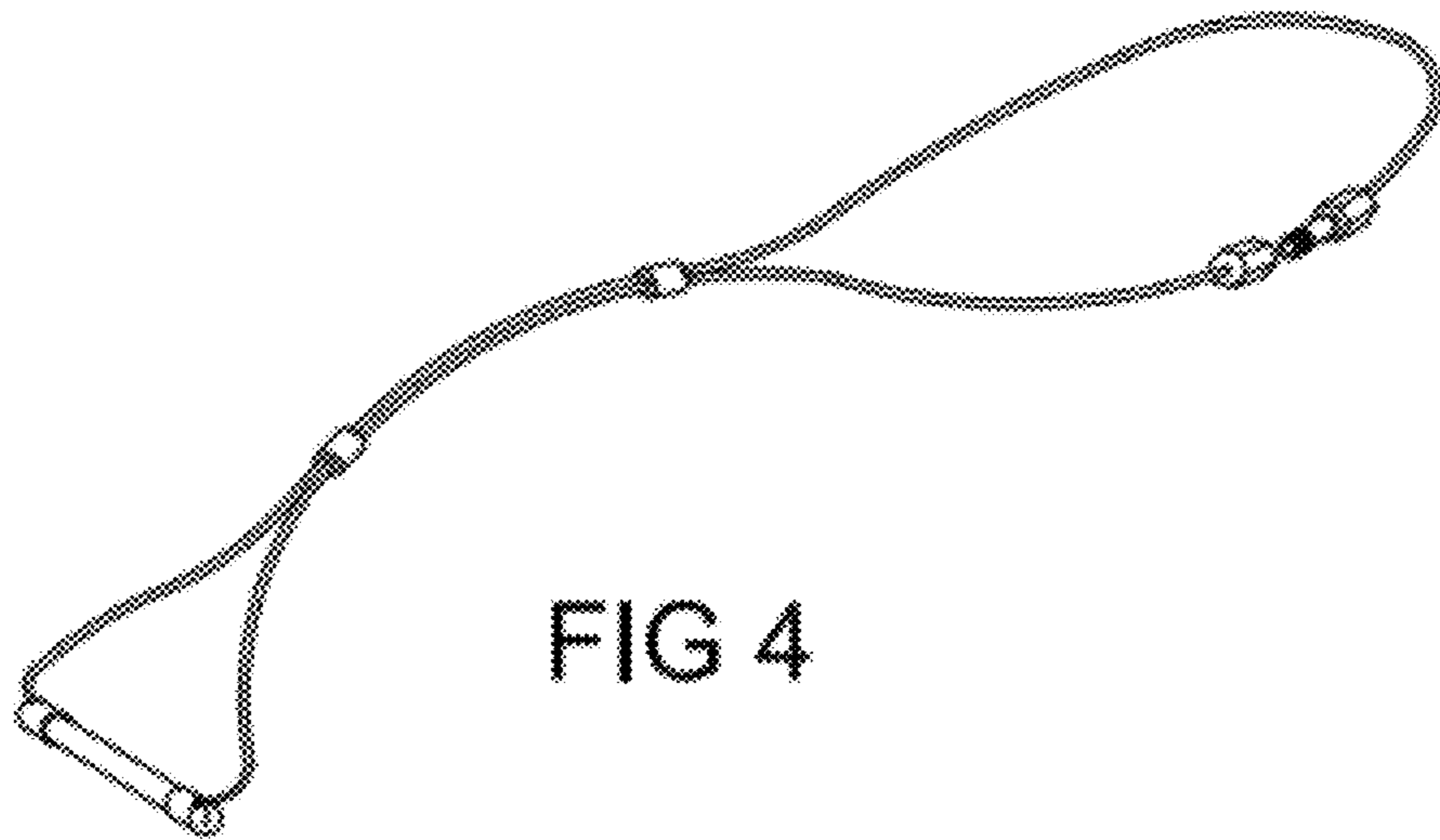

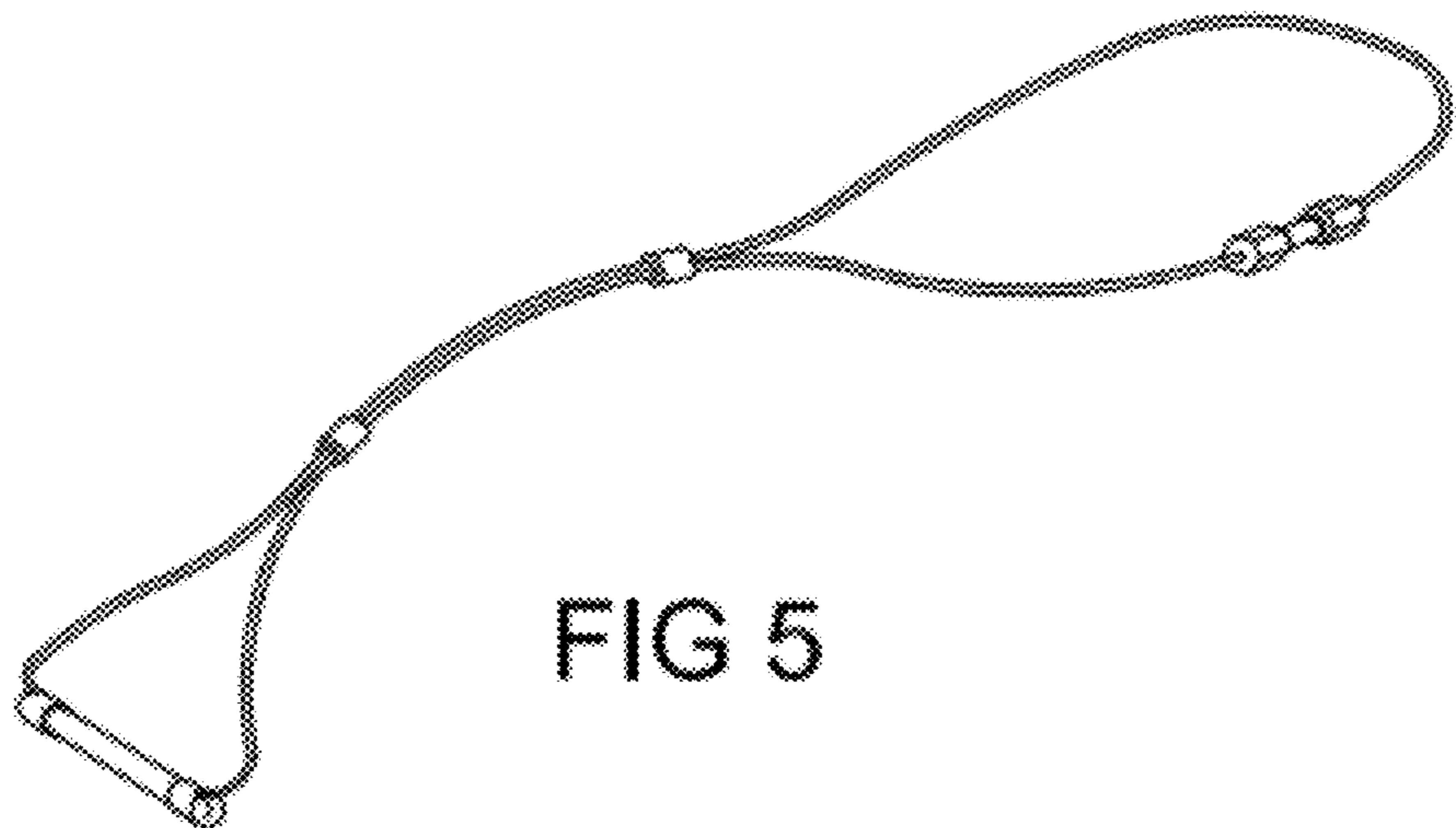

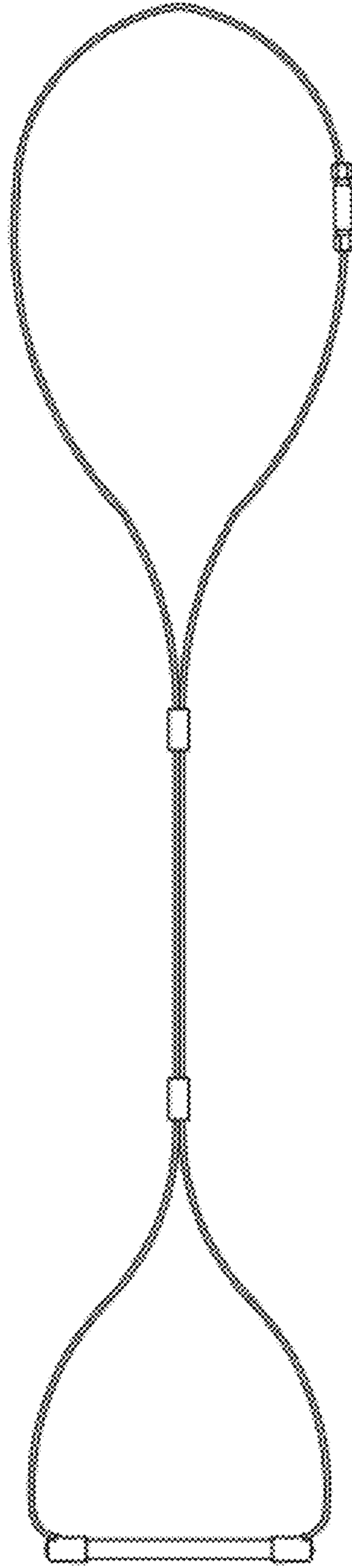
