(57) **CLAIM**

The ornamental design for a protective cover, including key-
board, for a mobile computing device, as shown and
described.

DESCRIPTION

FIG. 1 is a front perspective view of the protective cover
including keyboard for mobile computing device showing my
new design;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a top view thereof;

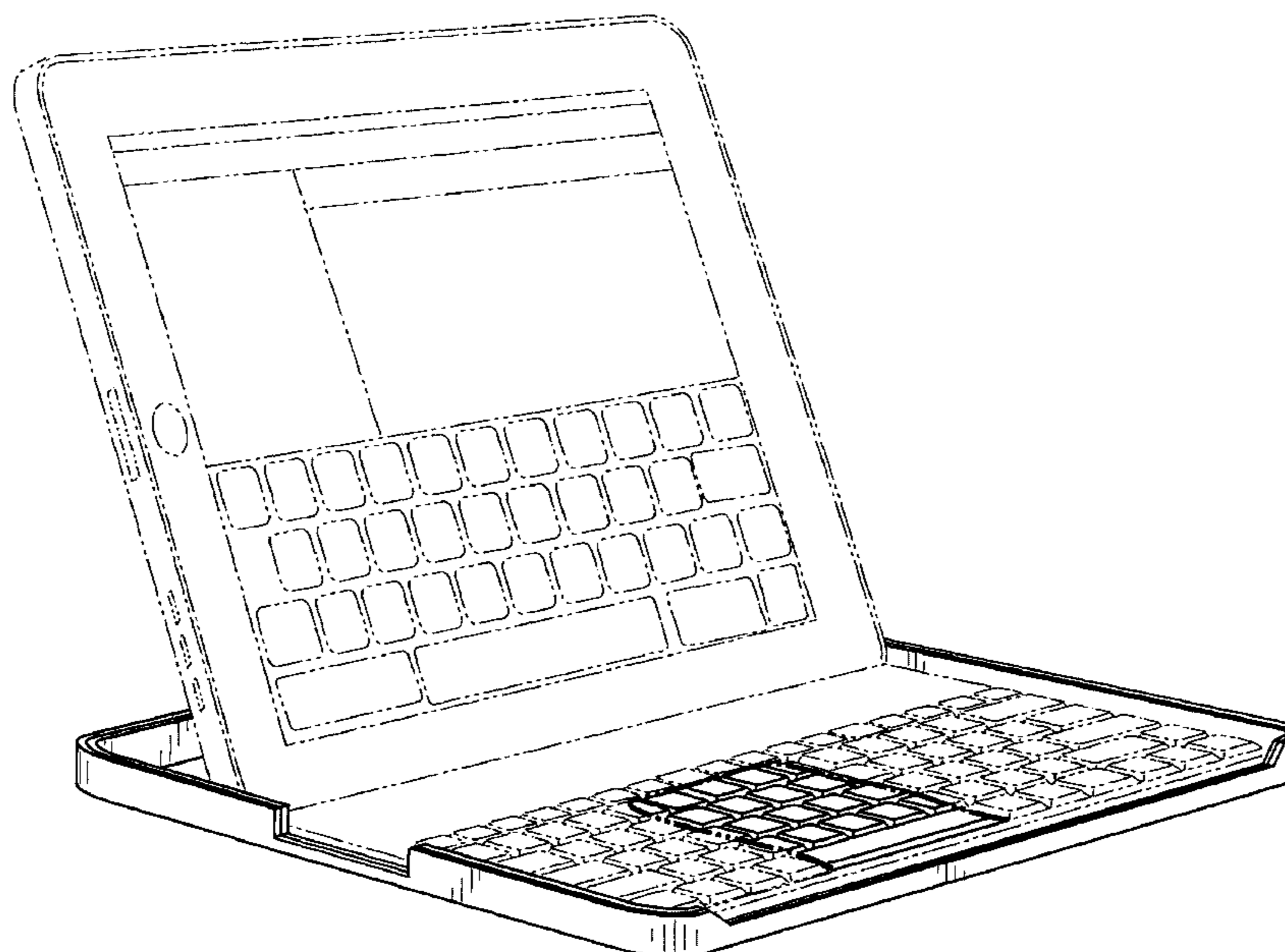
FIG. 7 is a side view thereof;

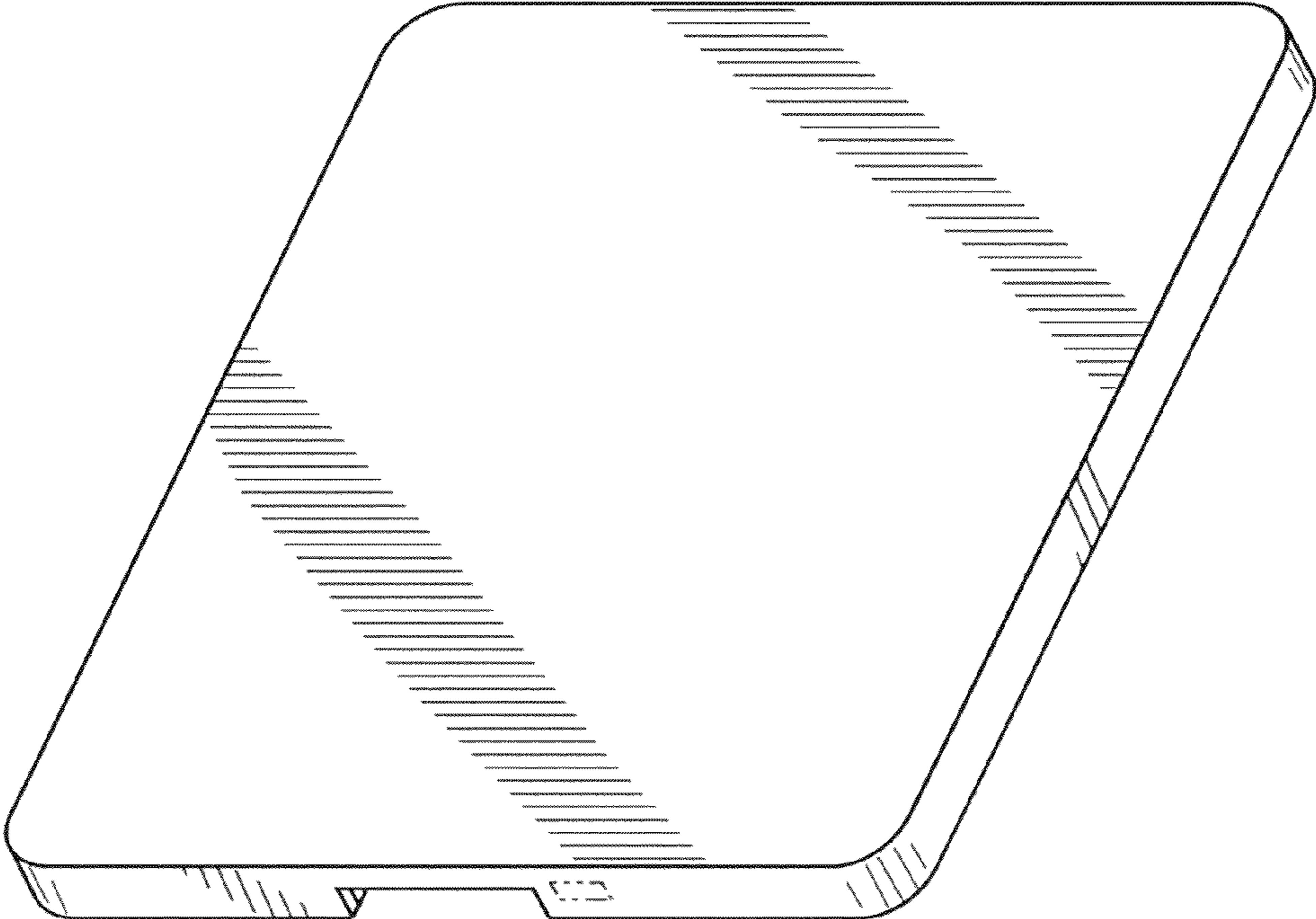

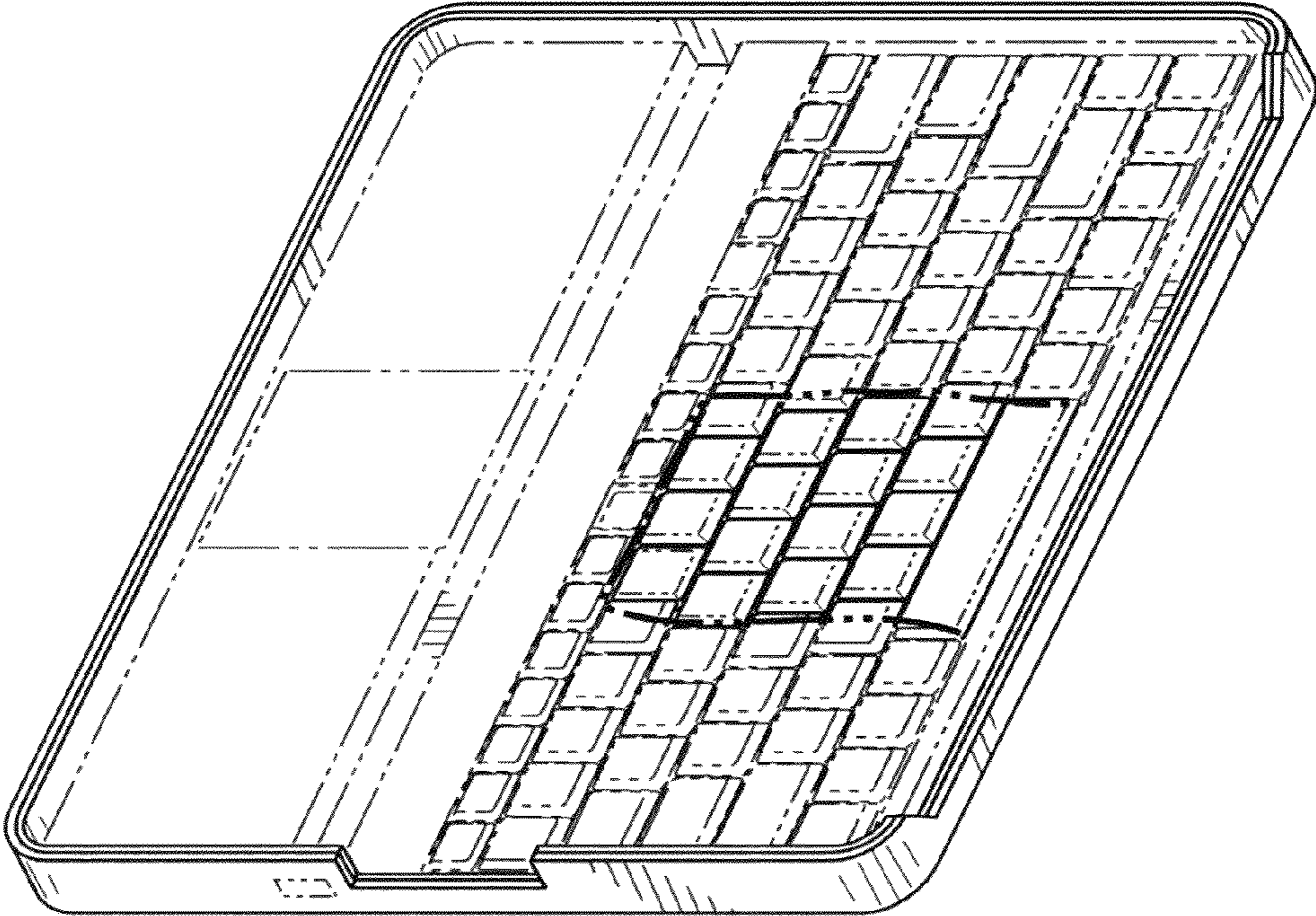

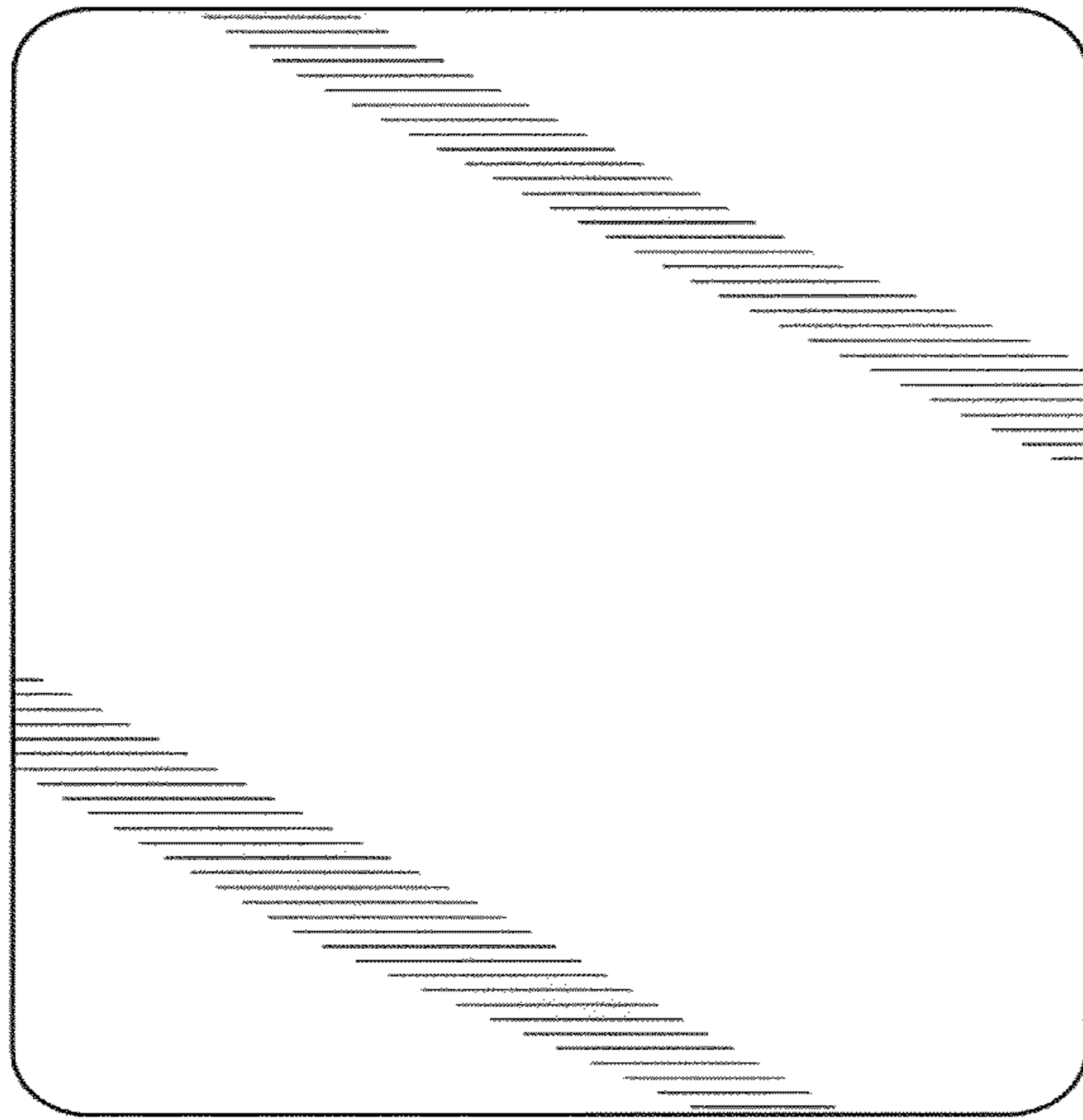

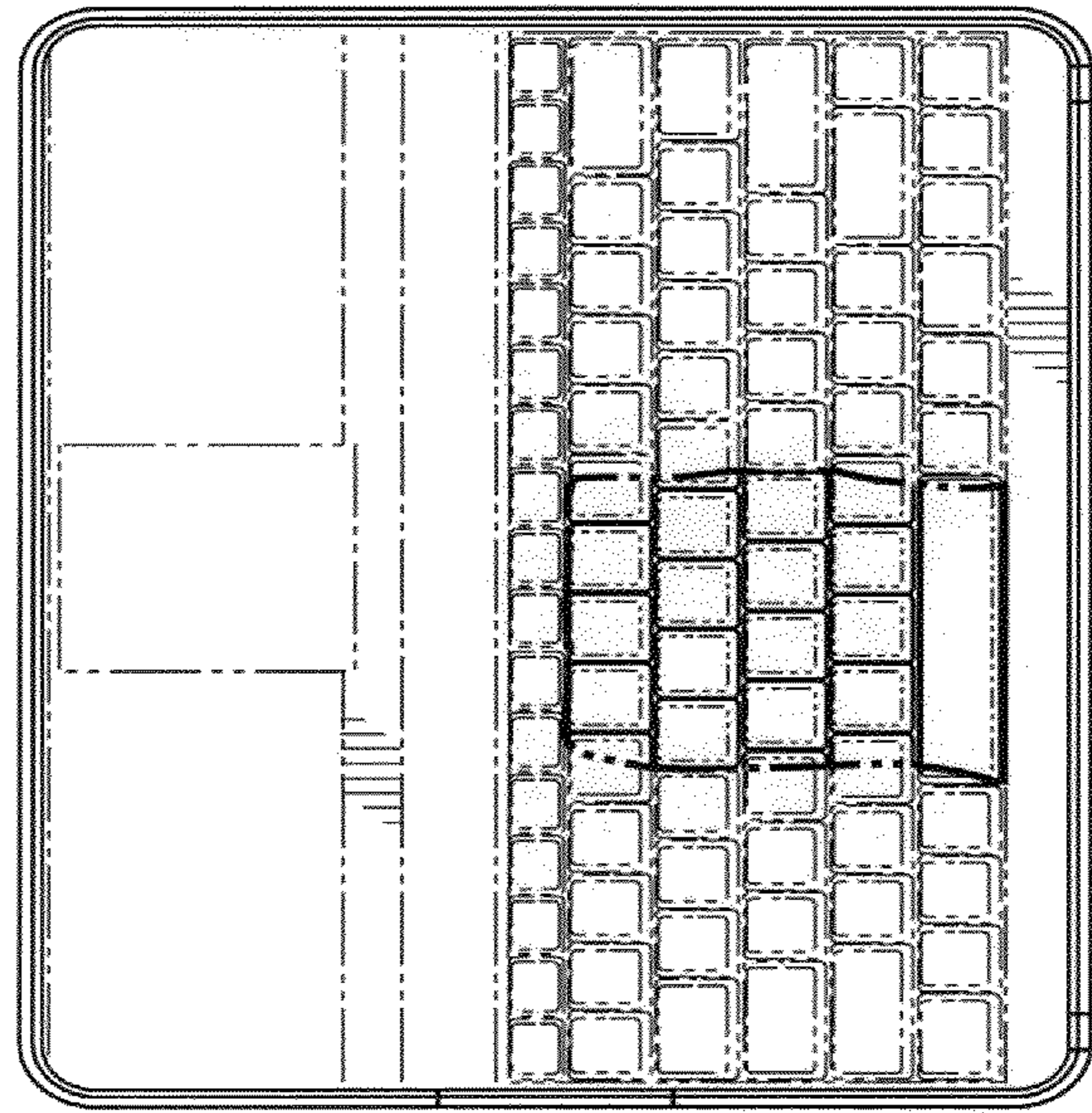

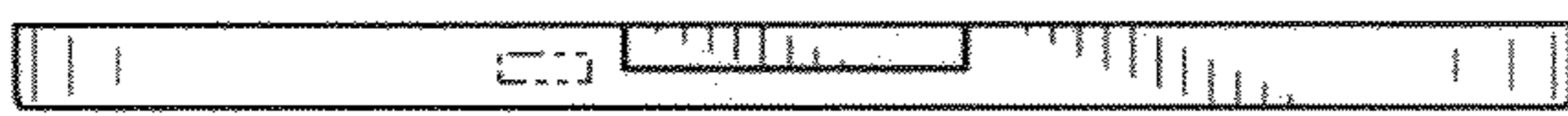

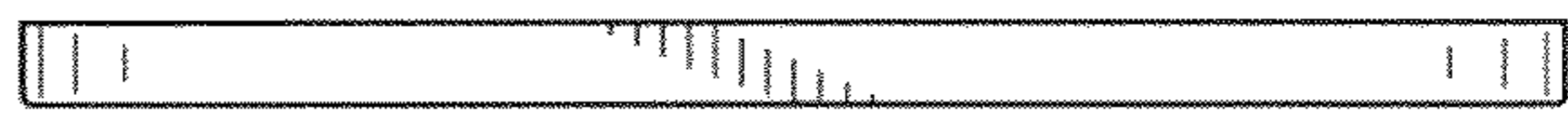

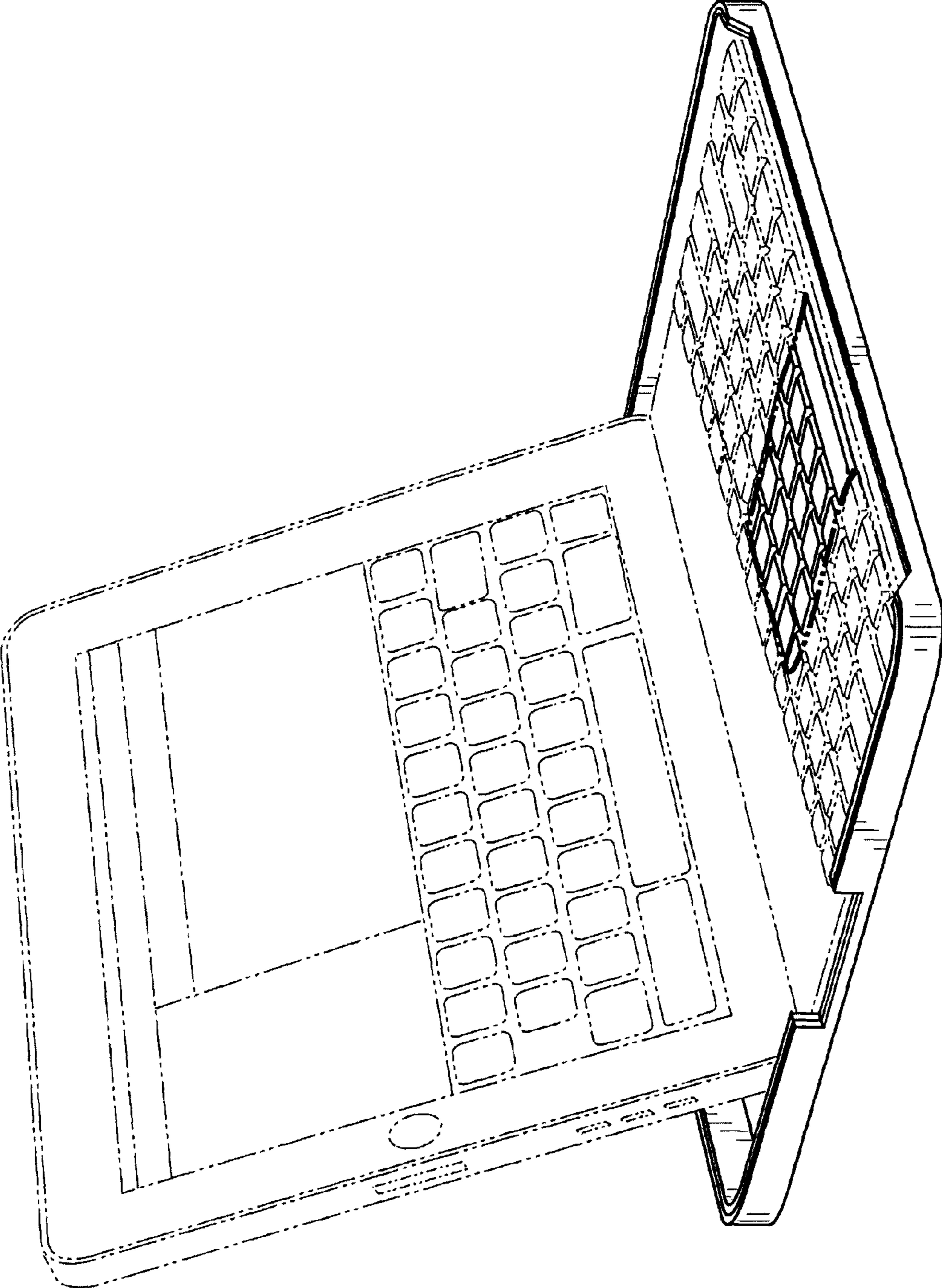
