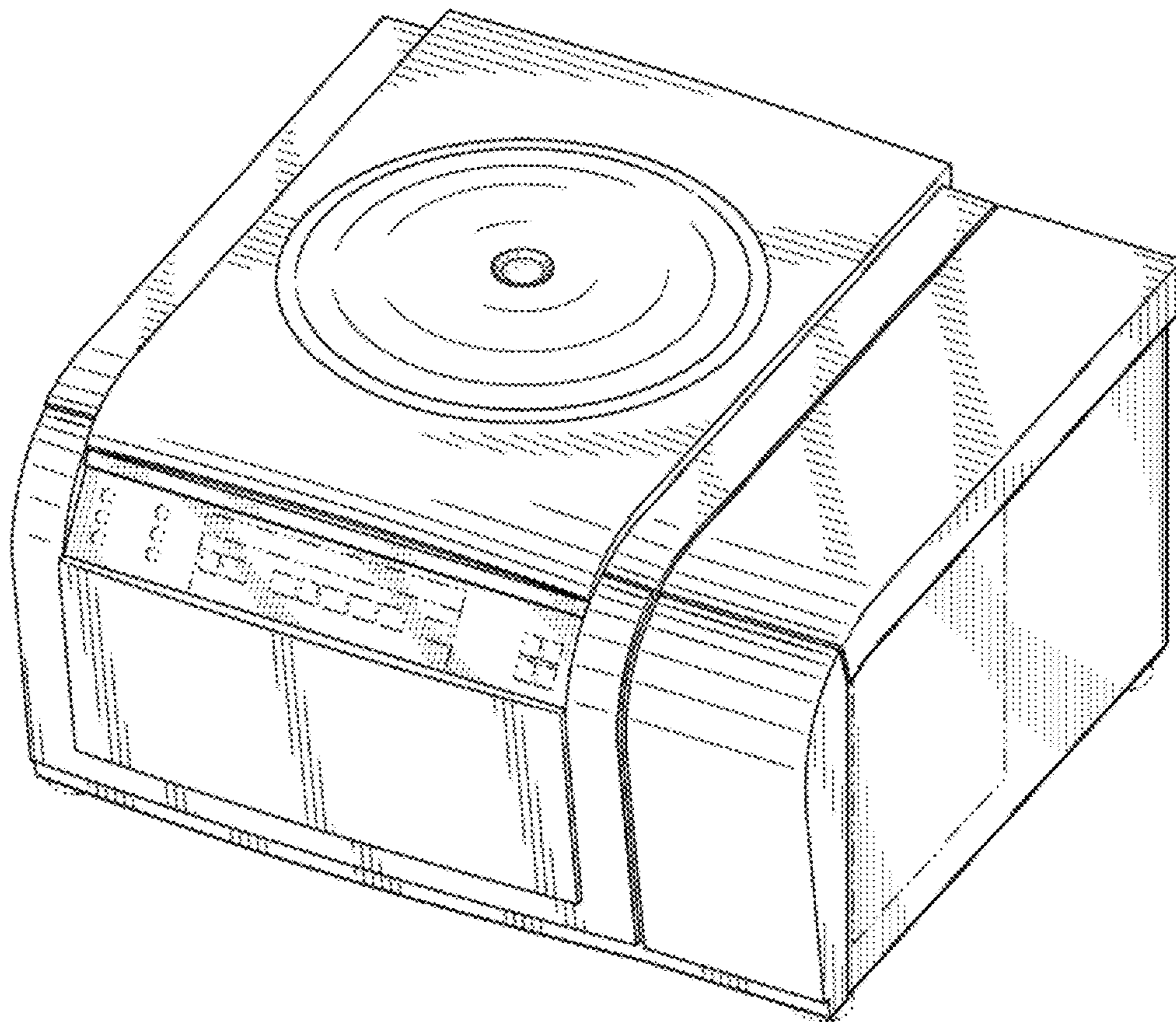
The ornamental design for a centrifuge, as shown and described.

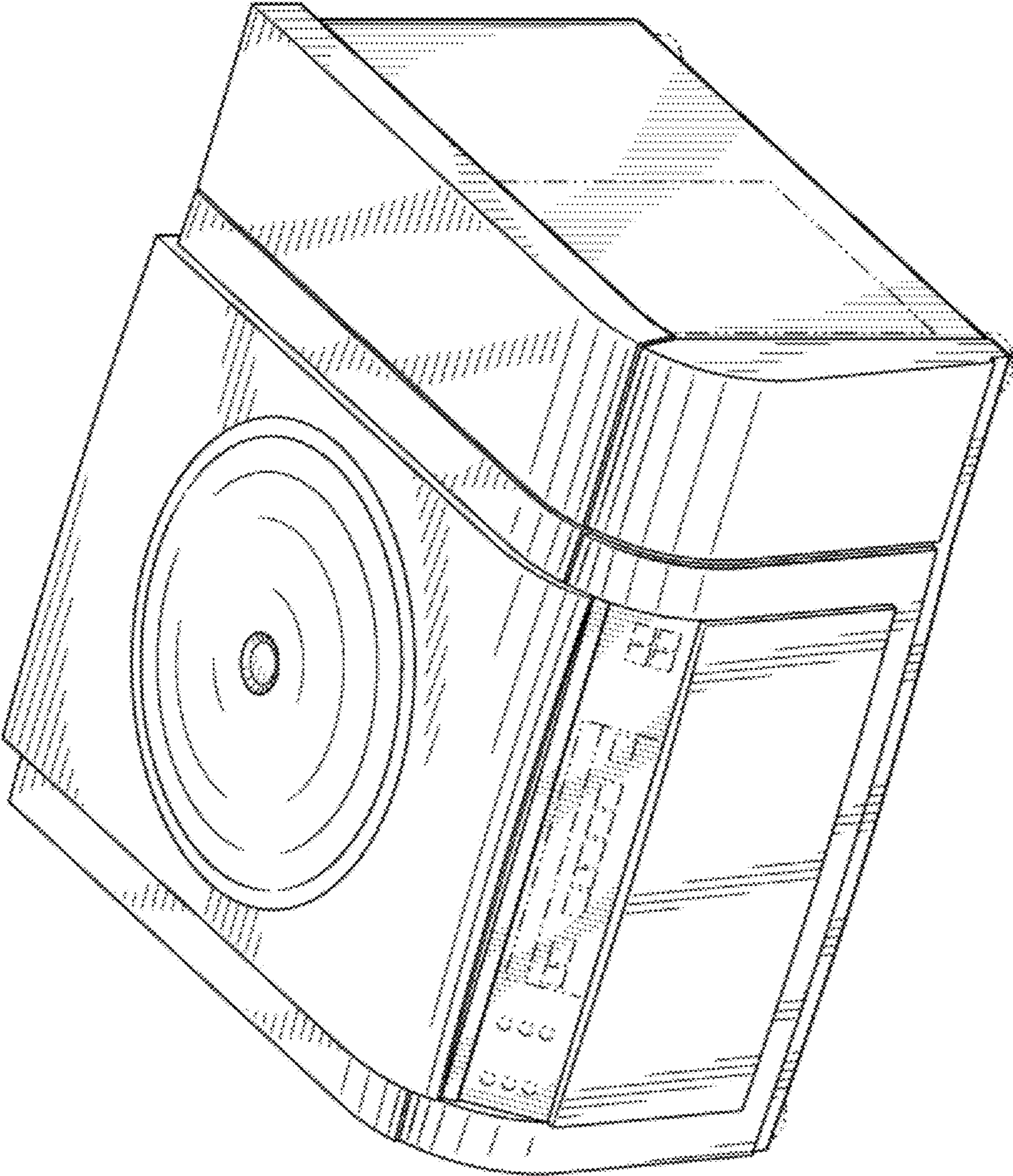

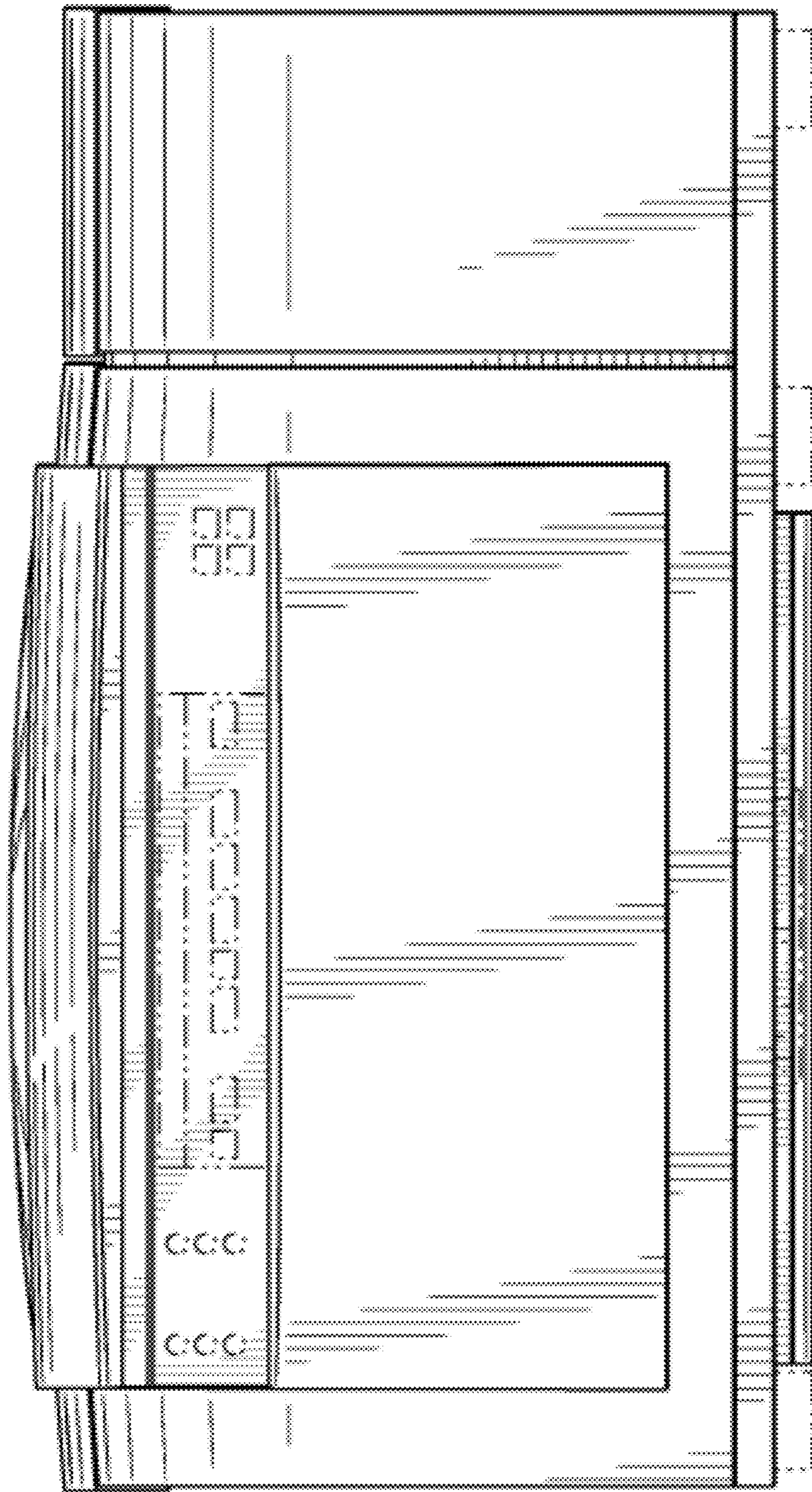

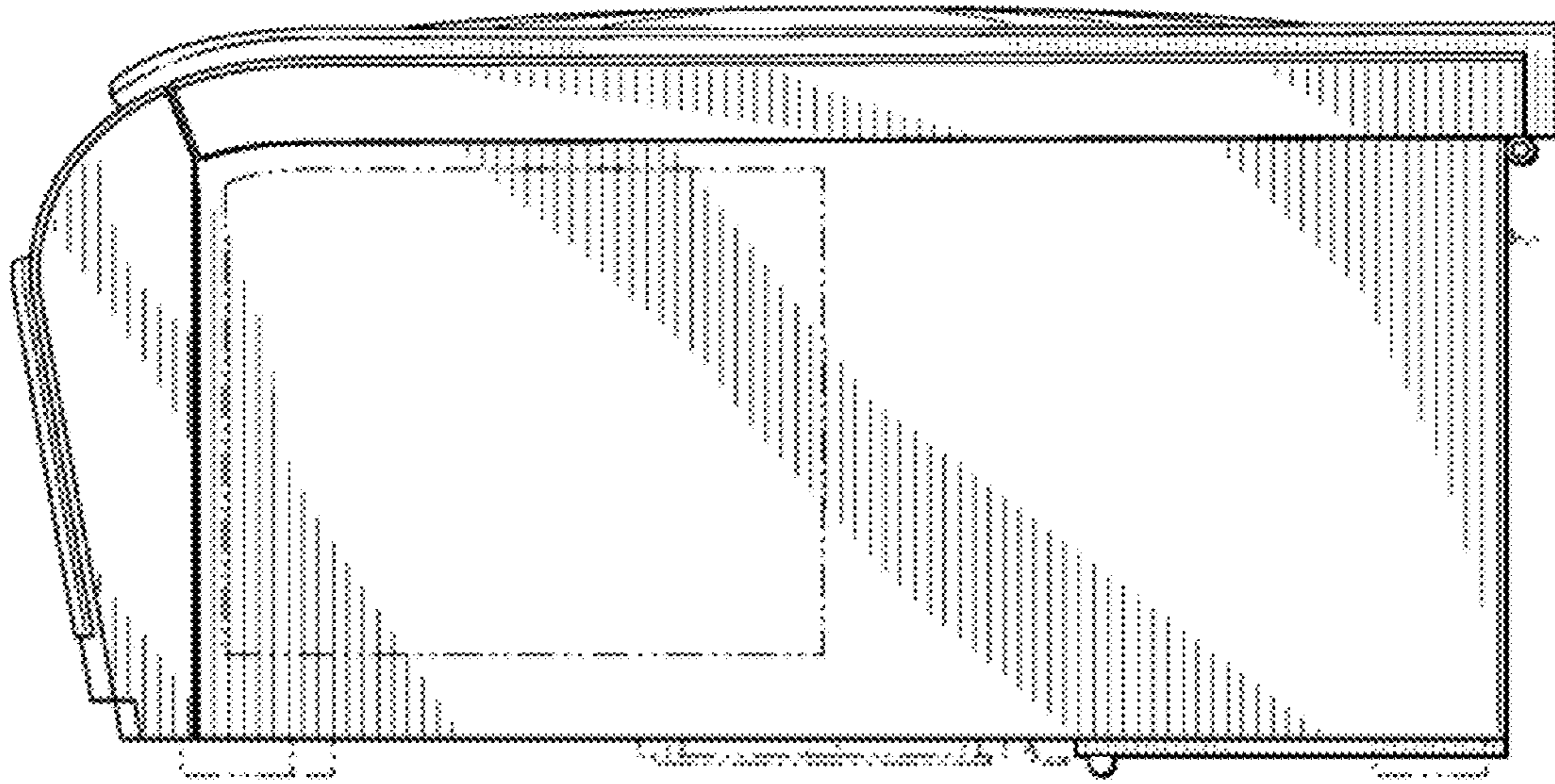

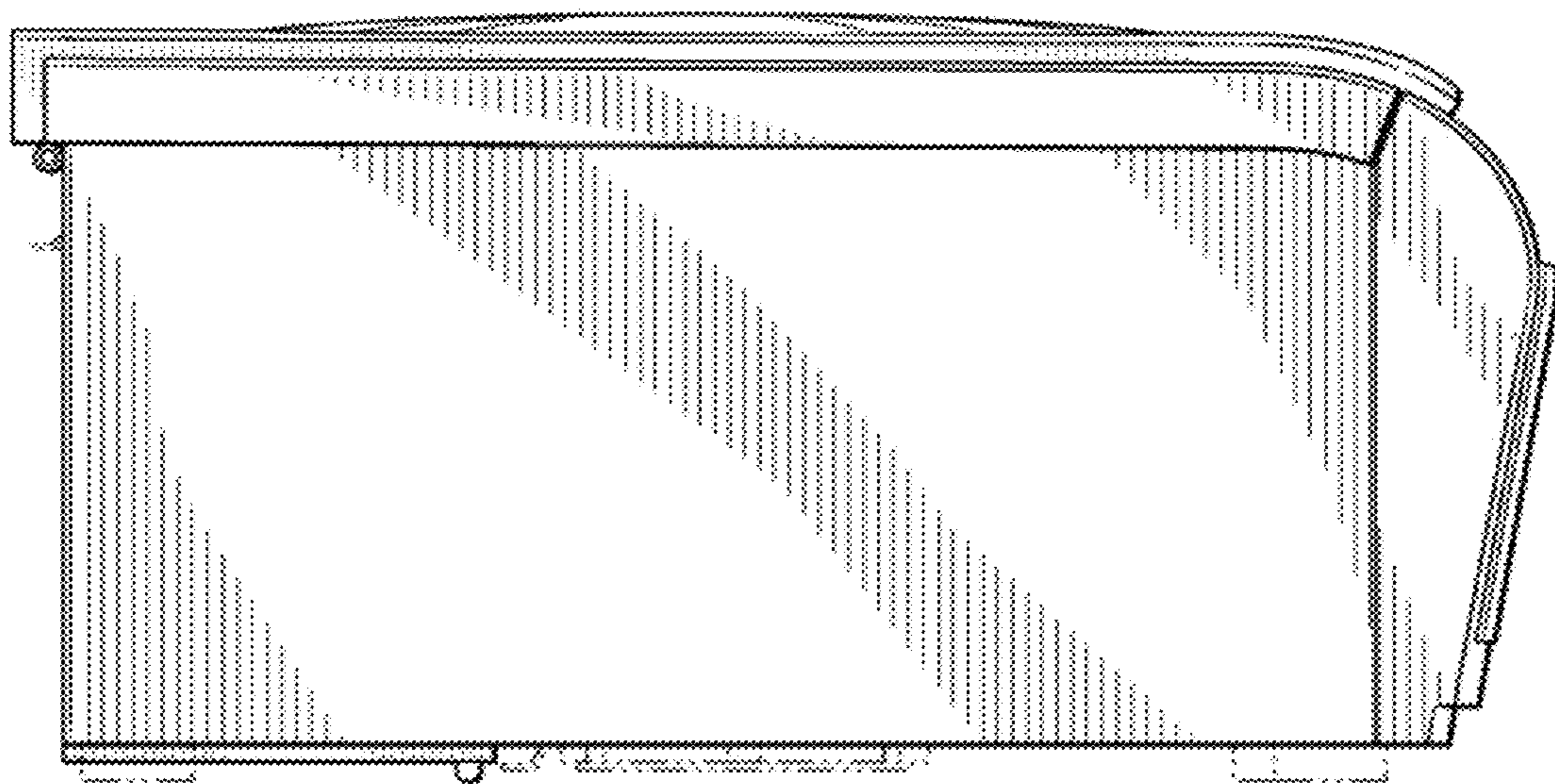

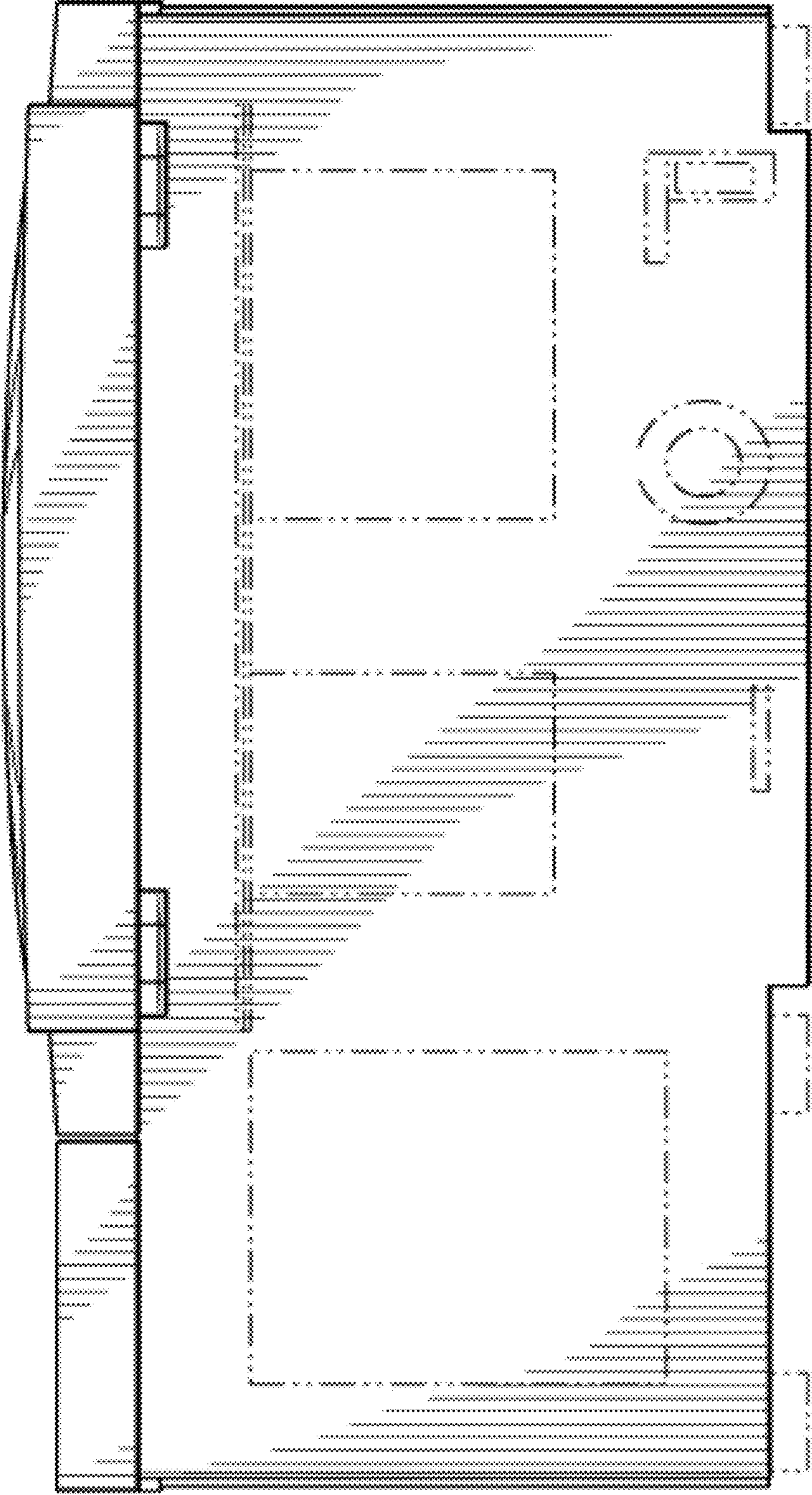

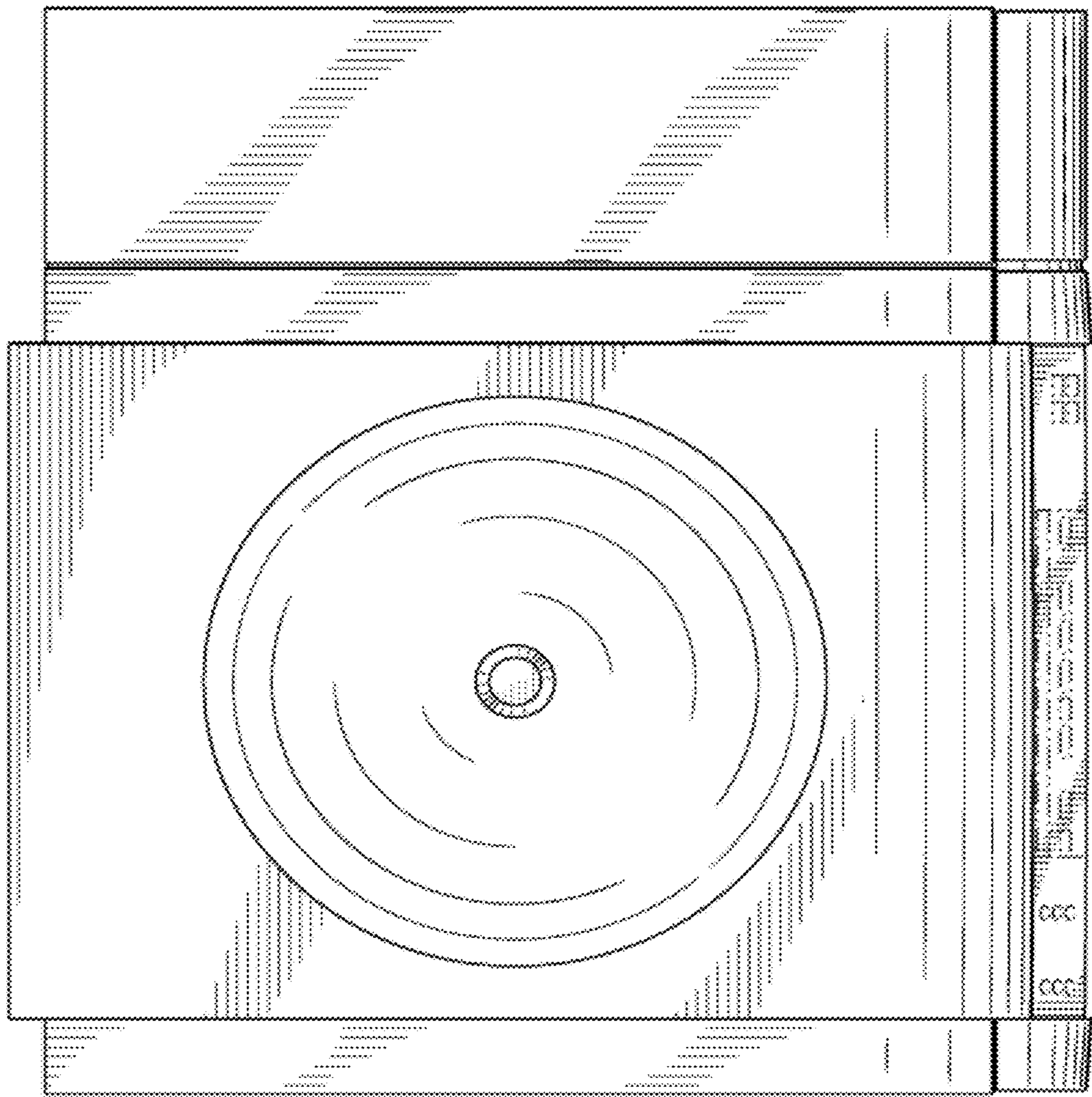

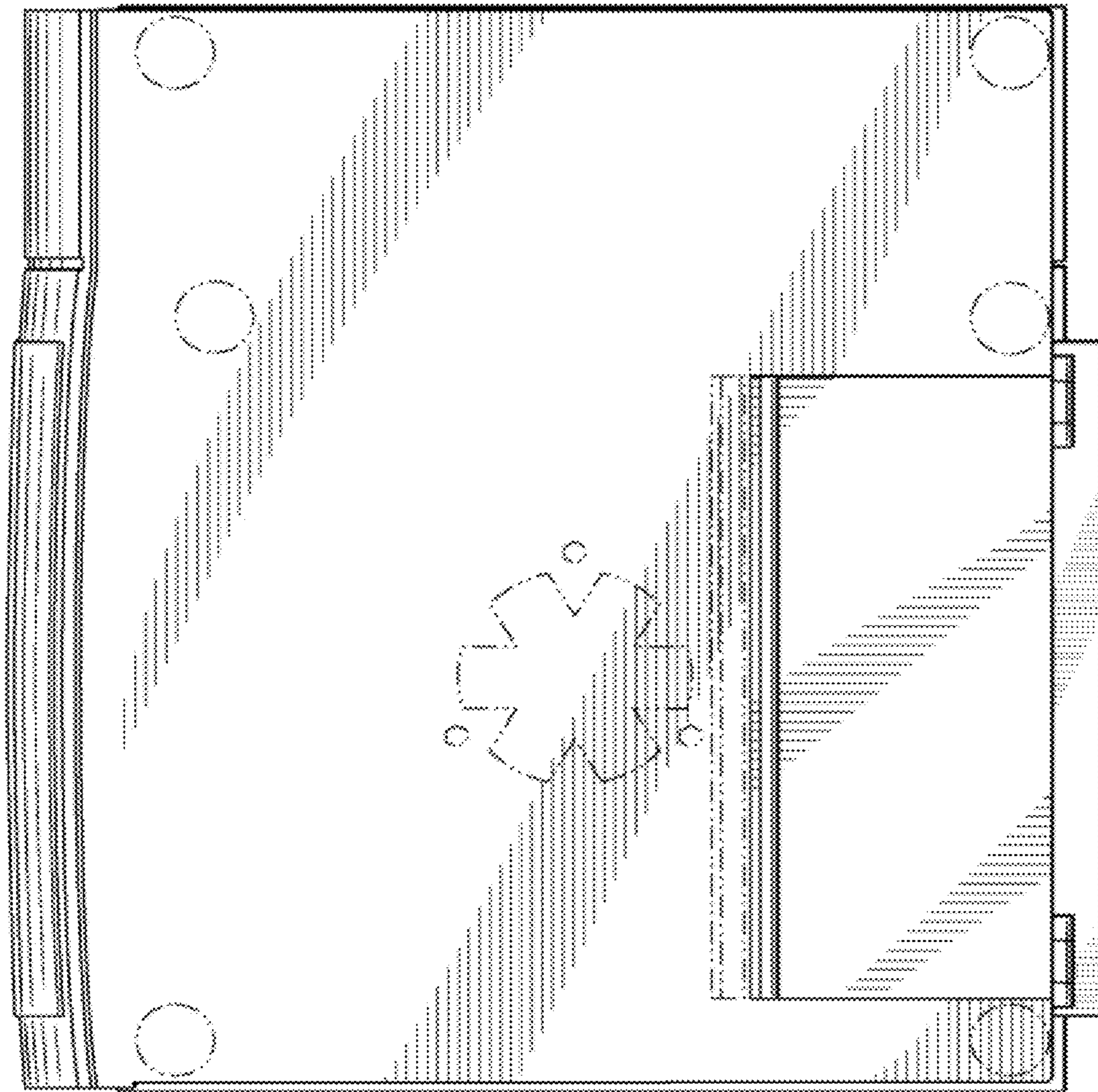
