The ornamental design for a starfish pentagon landscape light, as shown and described.

DESCRIPTION

FIG. 1 is an upper front perspective view of the novel starfish pentagon landscape light.

FIG. 5 is a right side view of the novel landscape light of FIG. 1.

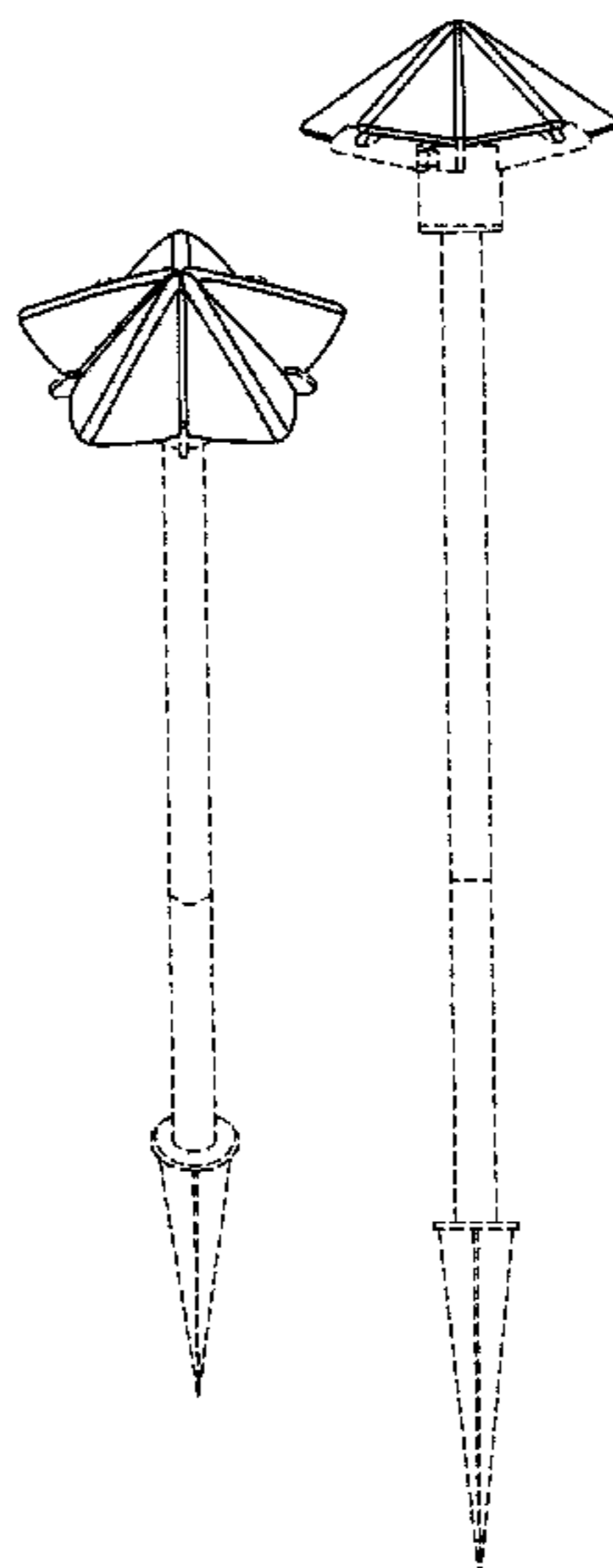
FIG. 6 is a rear side view of the novel landscape light of FIG. 1; and,

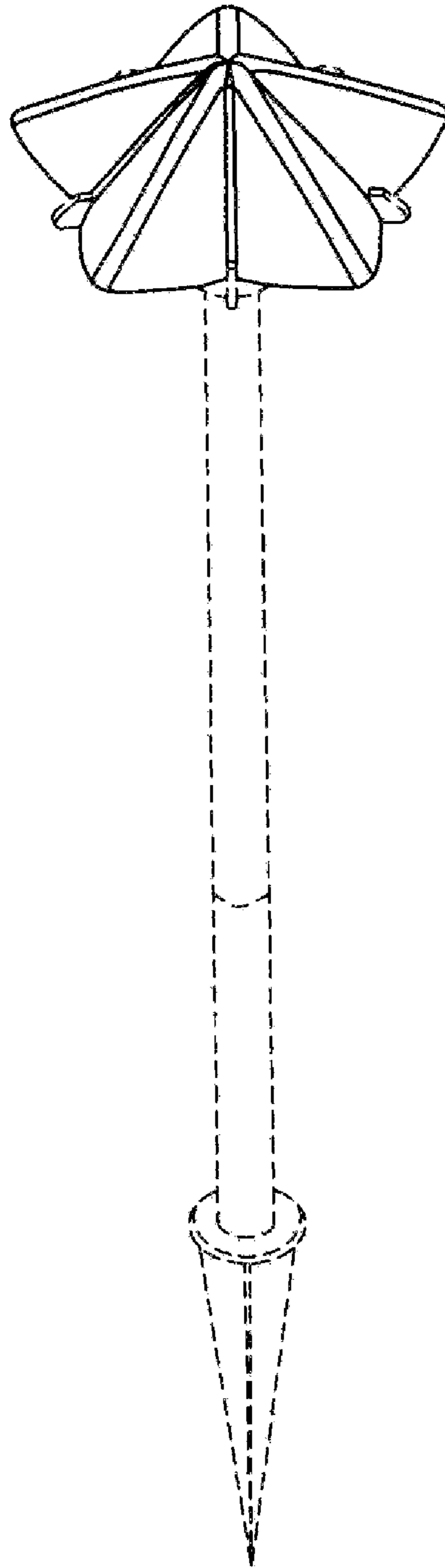

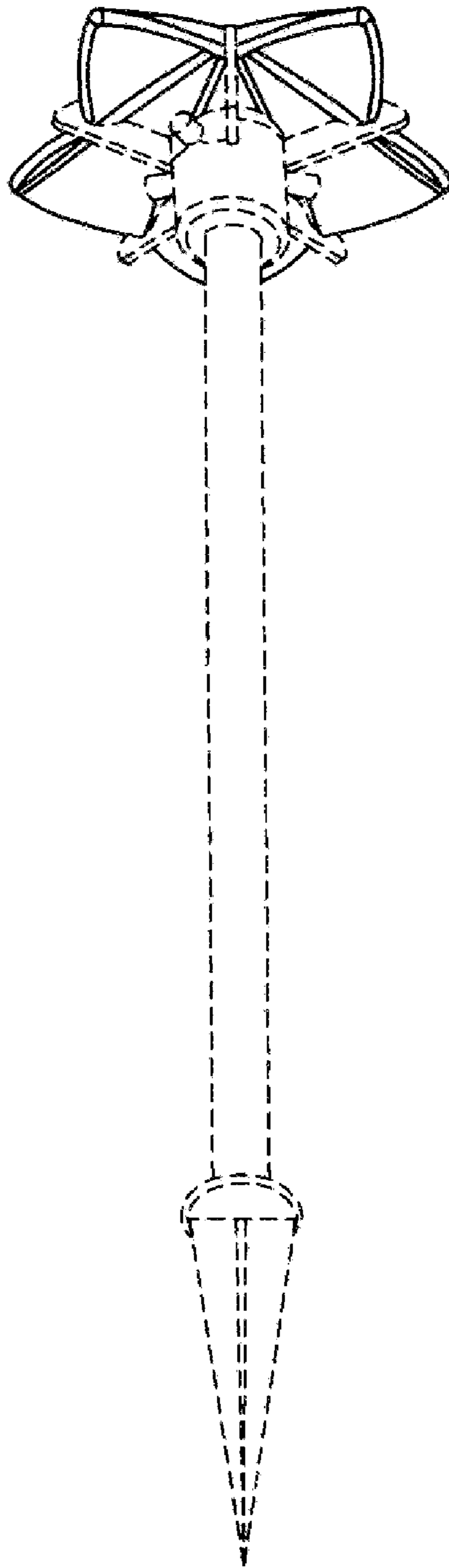

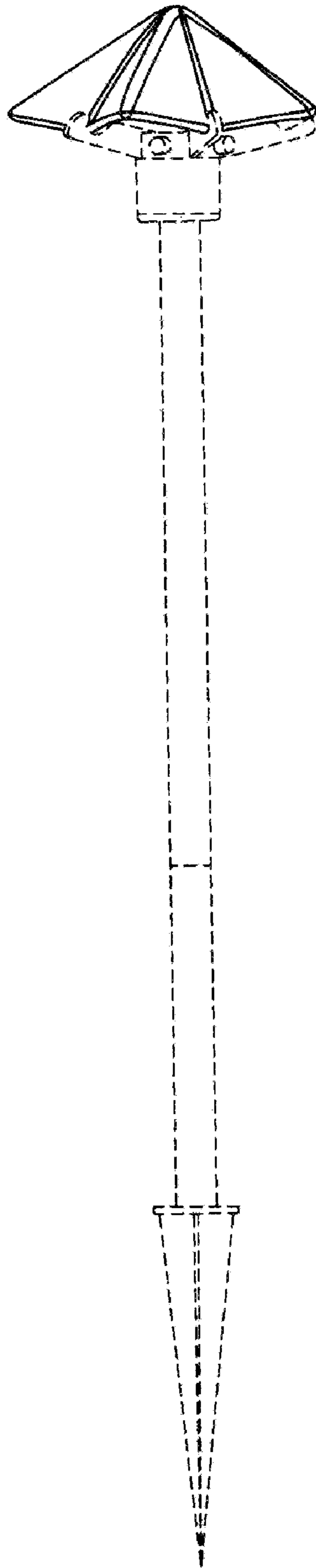

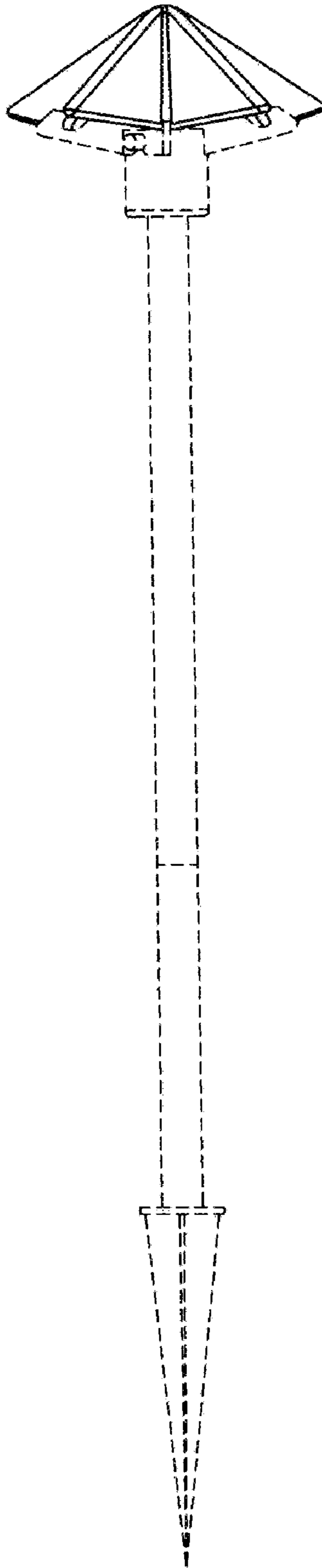

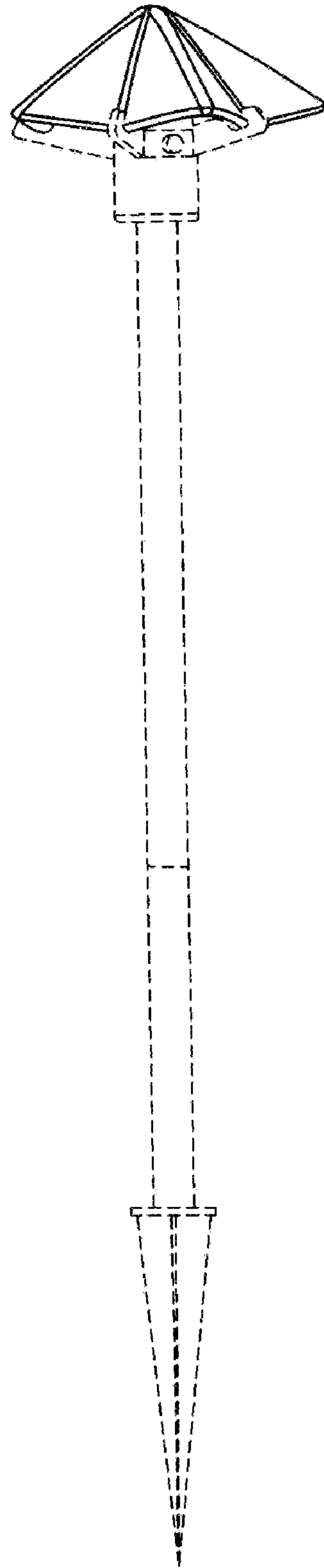

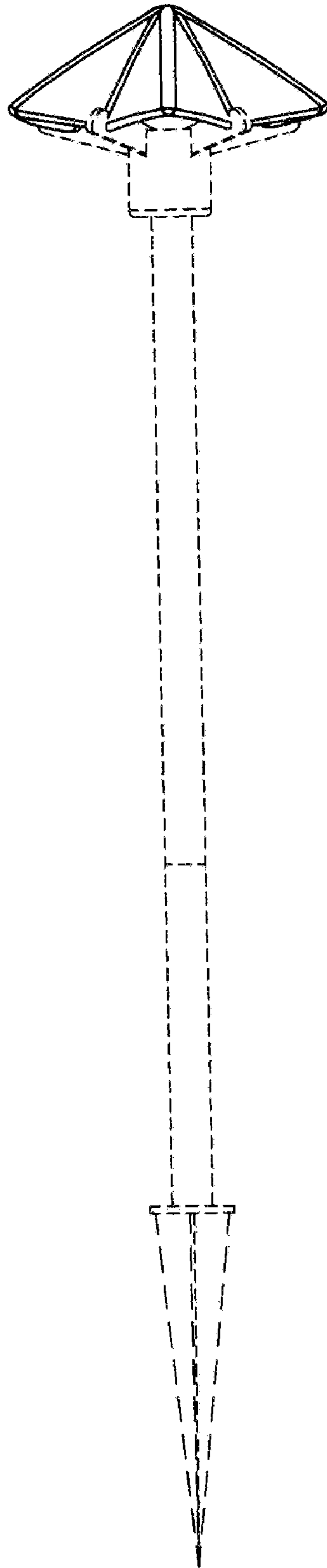

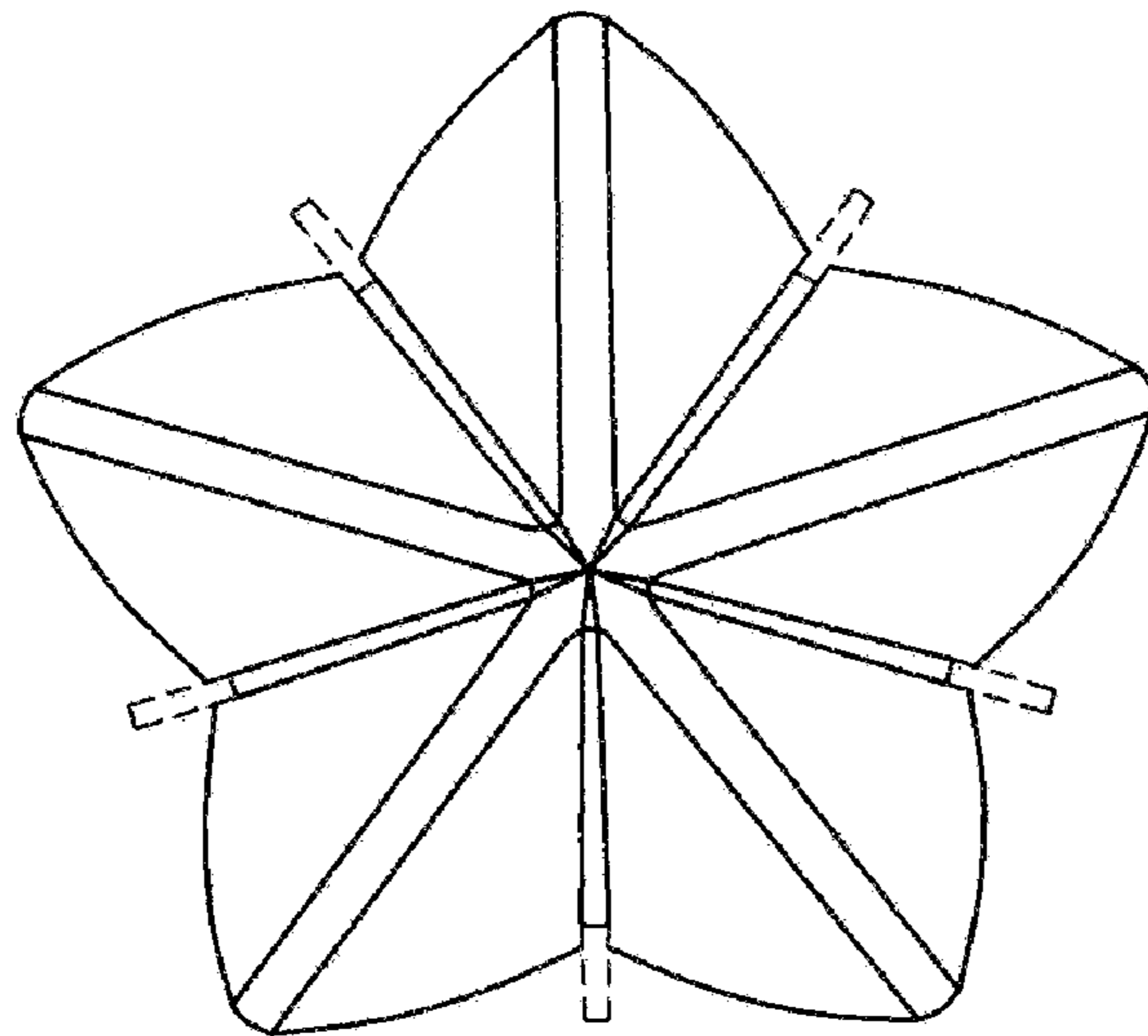
