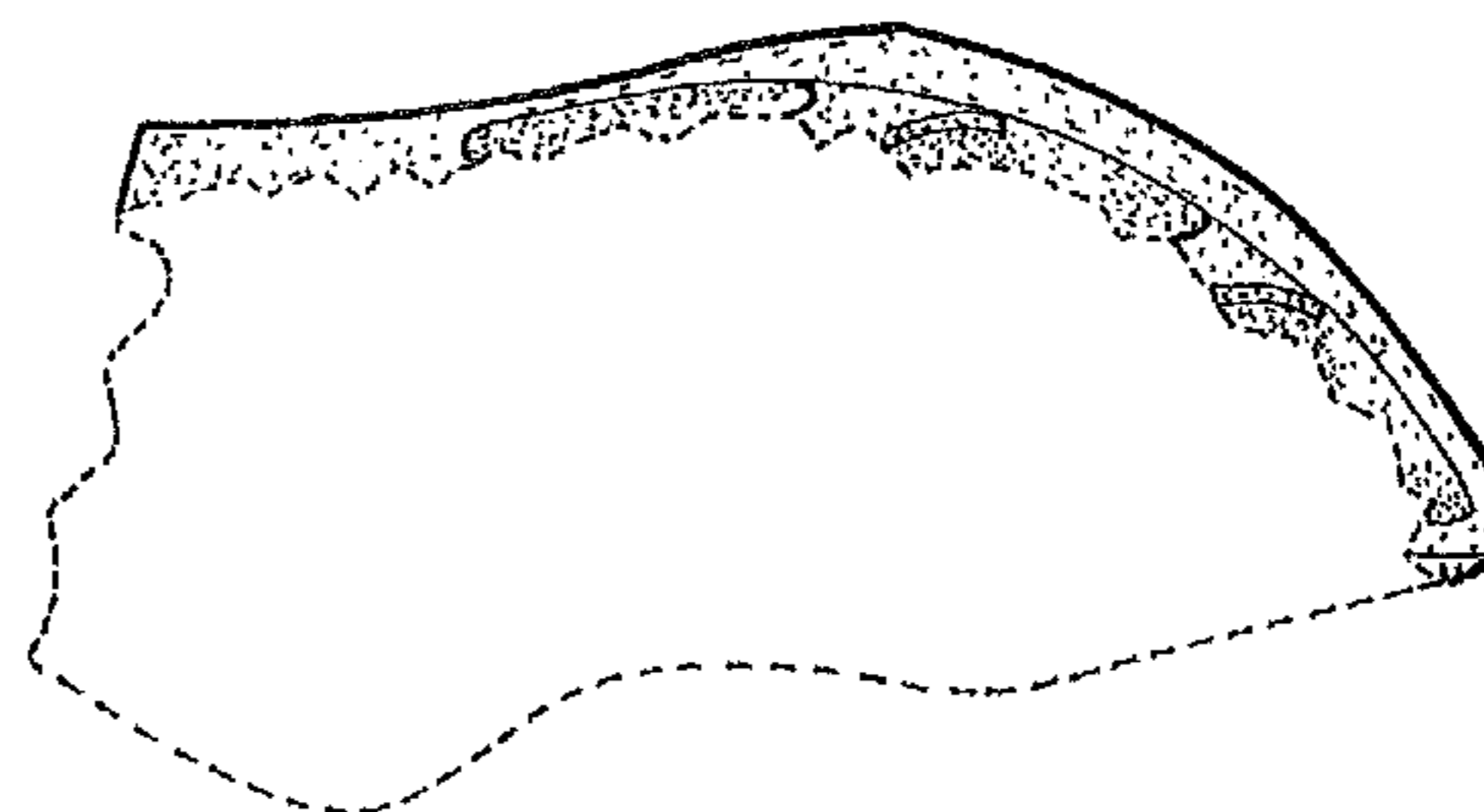
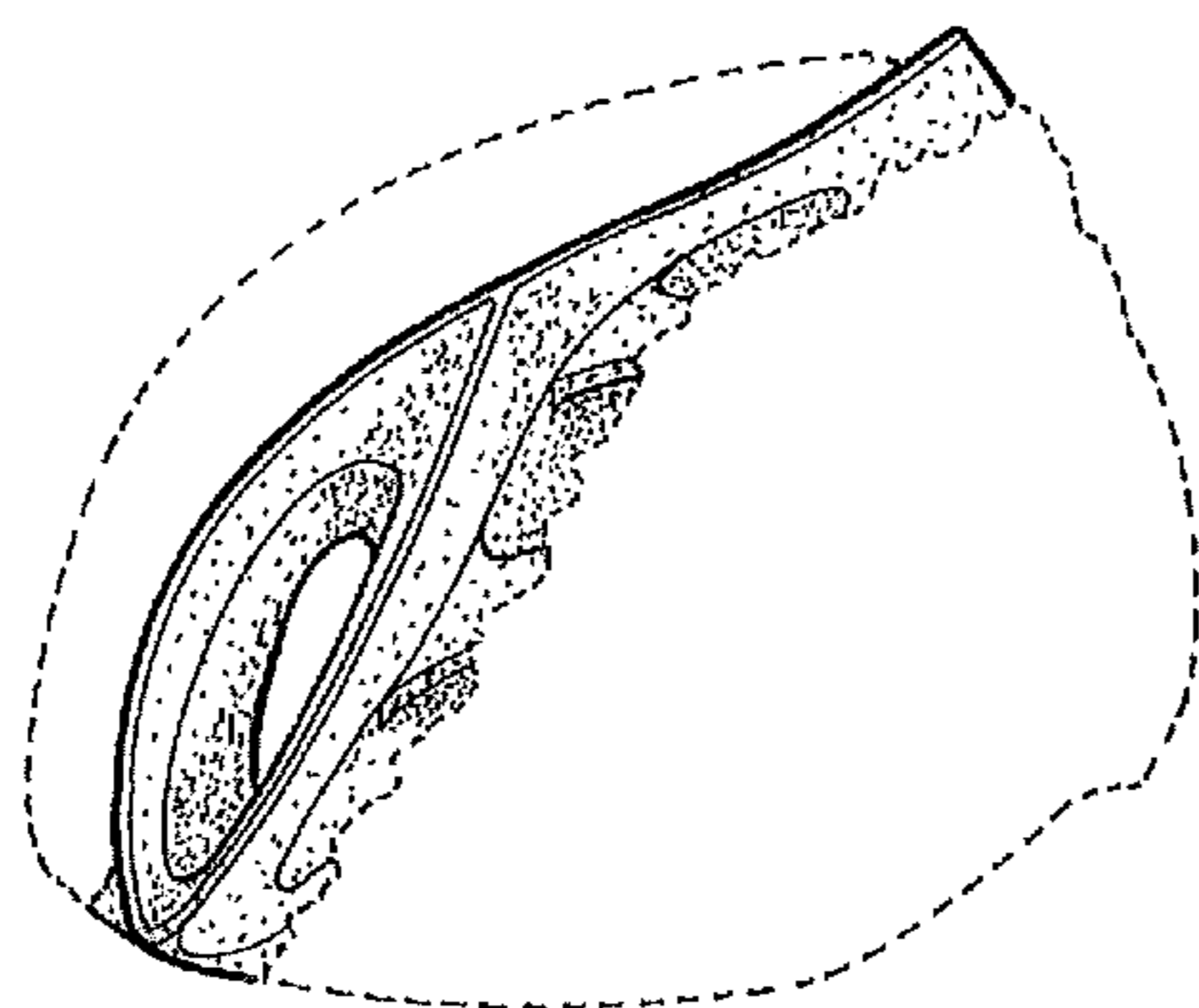
(57) **CLAIM**

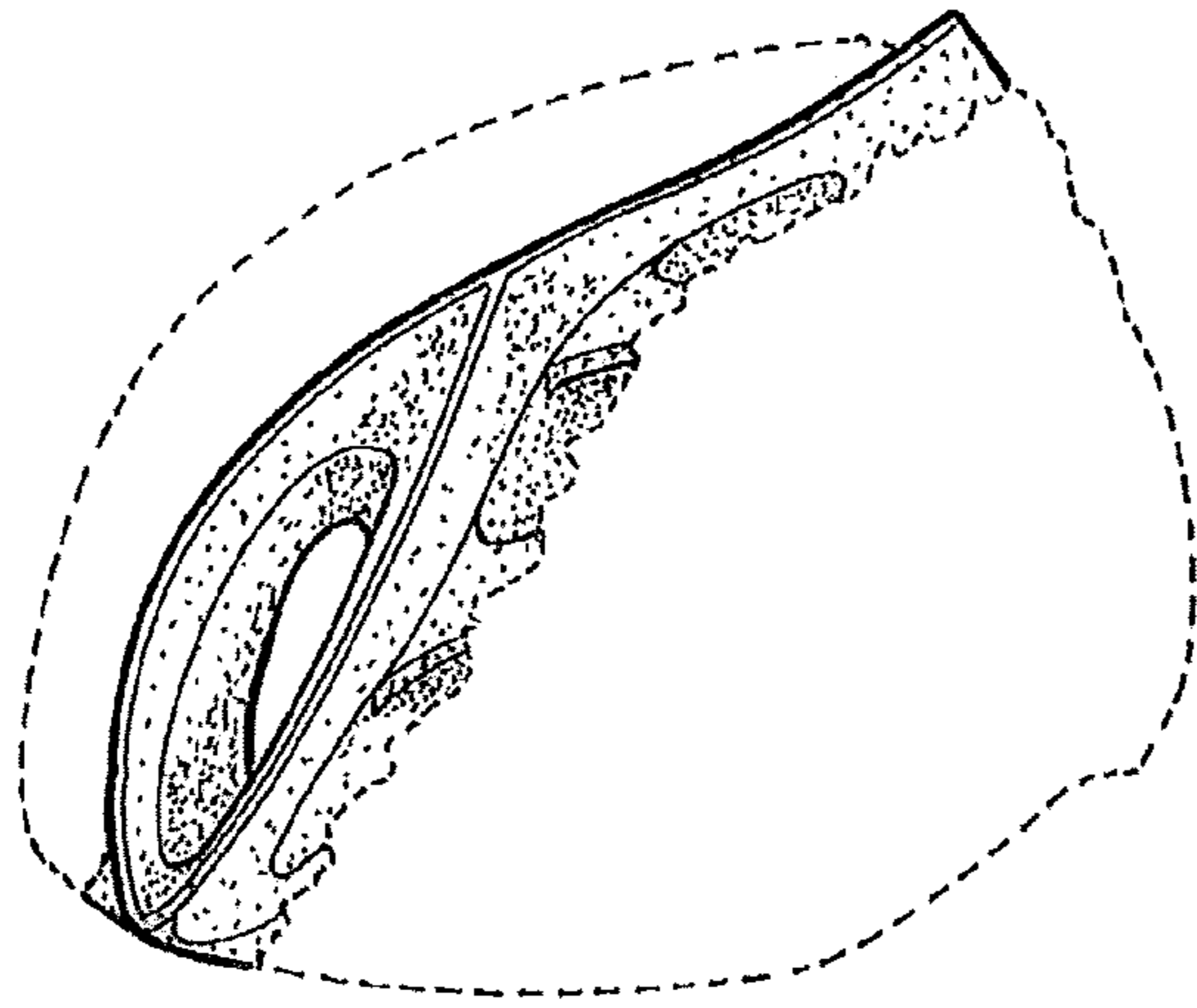
I claim the ornamental design for a portion of a shell of a sports helmet, as shown and described.

**DESCRIPTION**

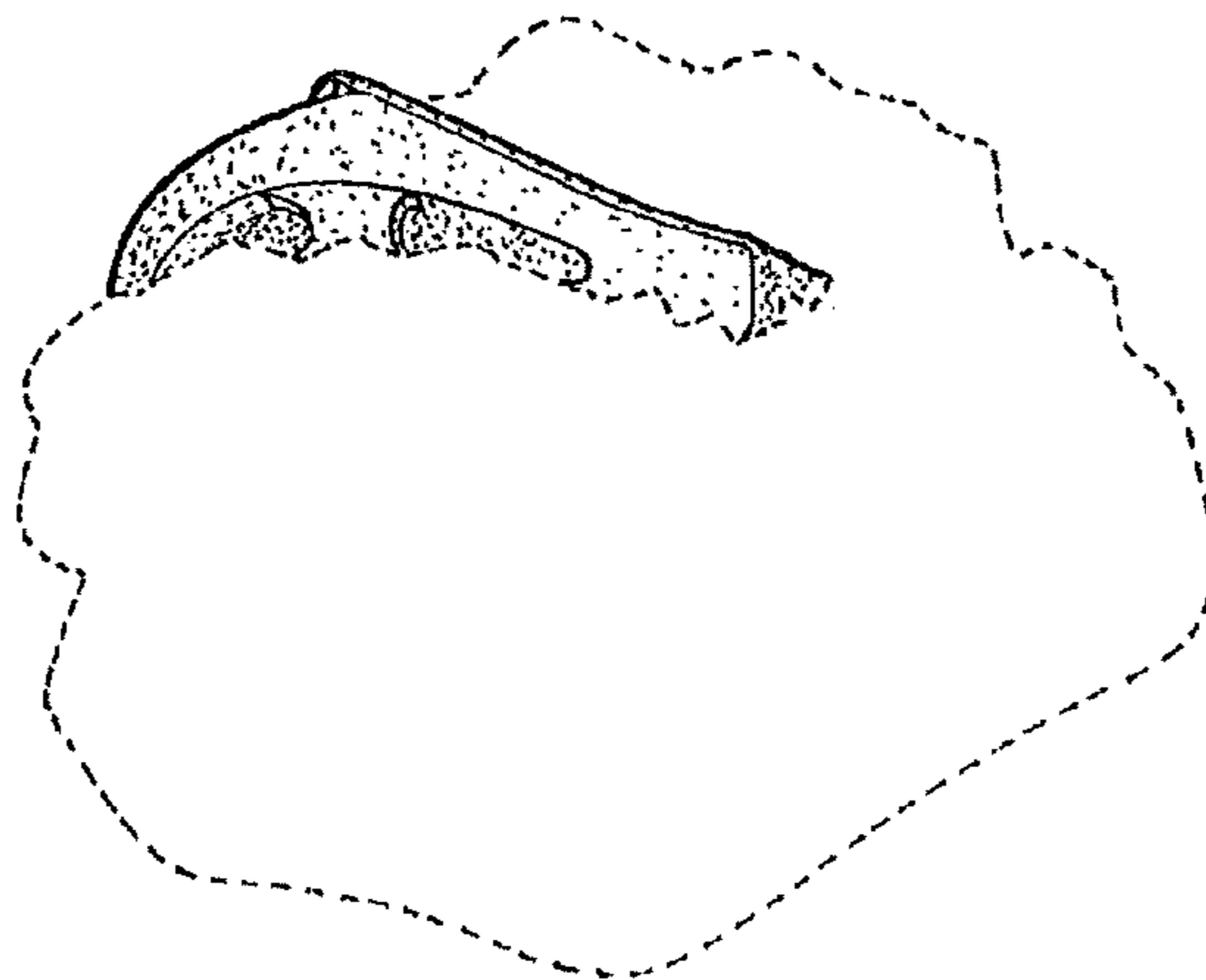

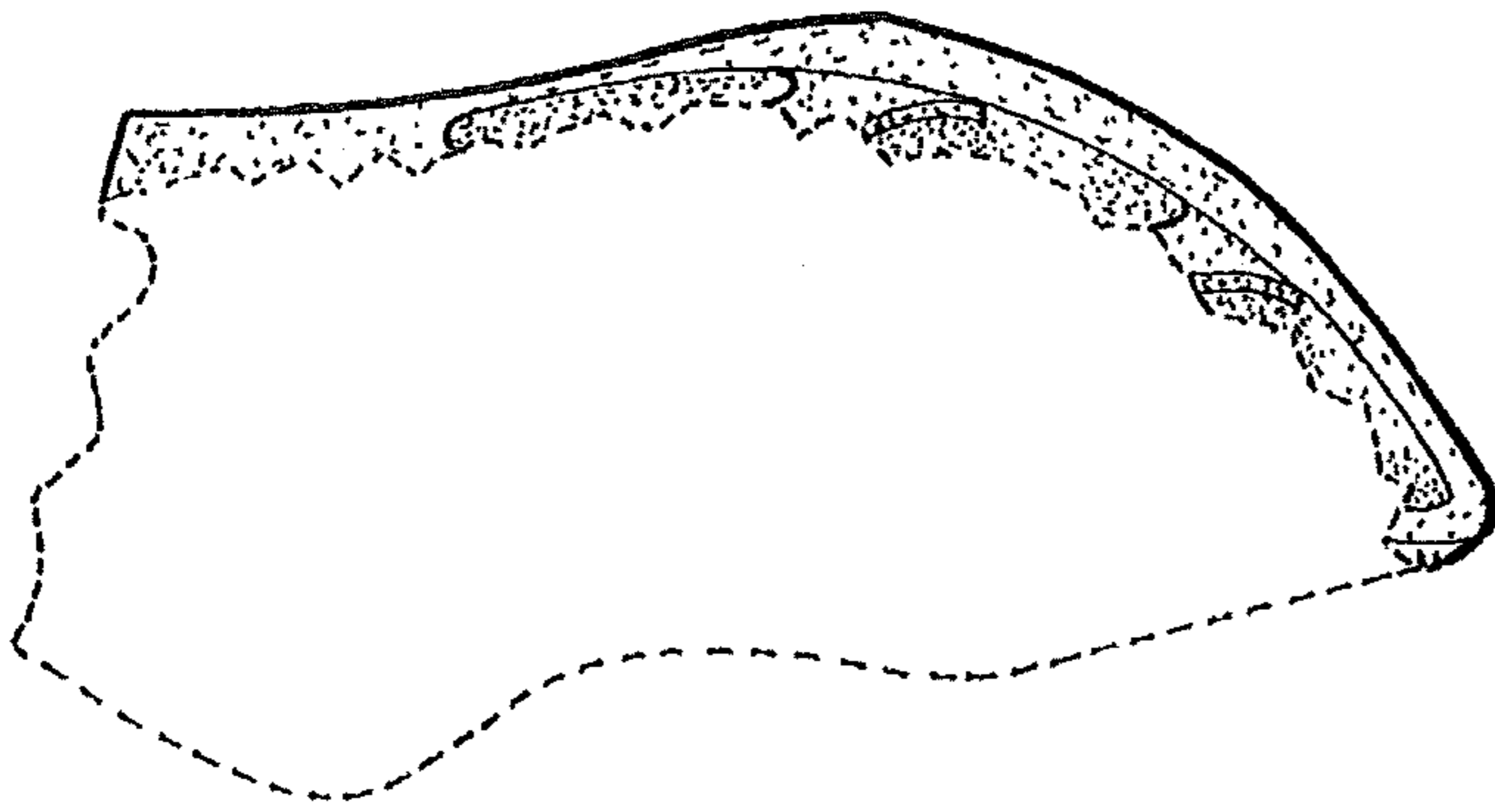
