DESCRIPTION

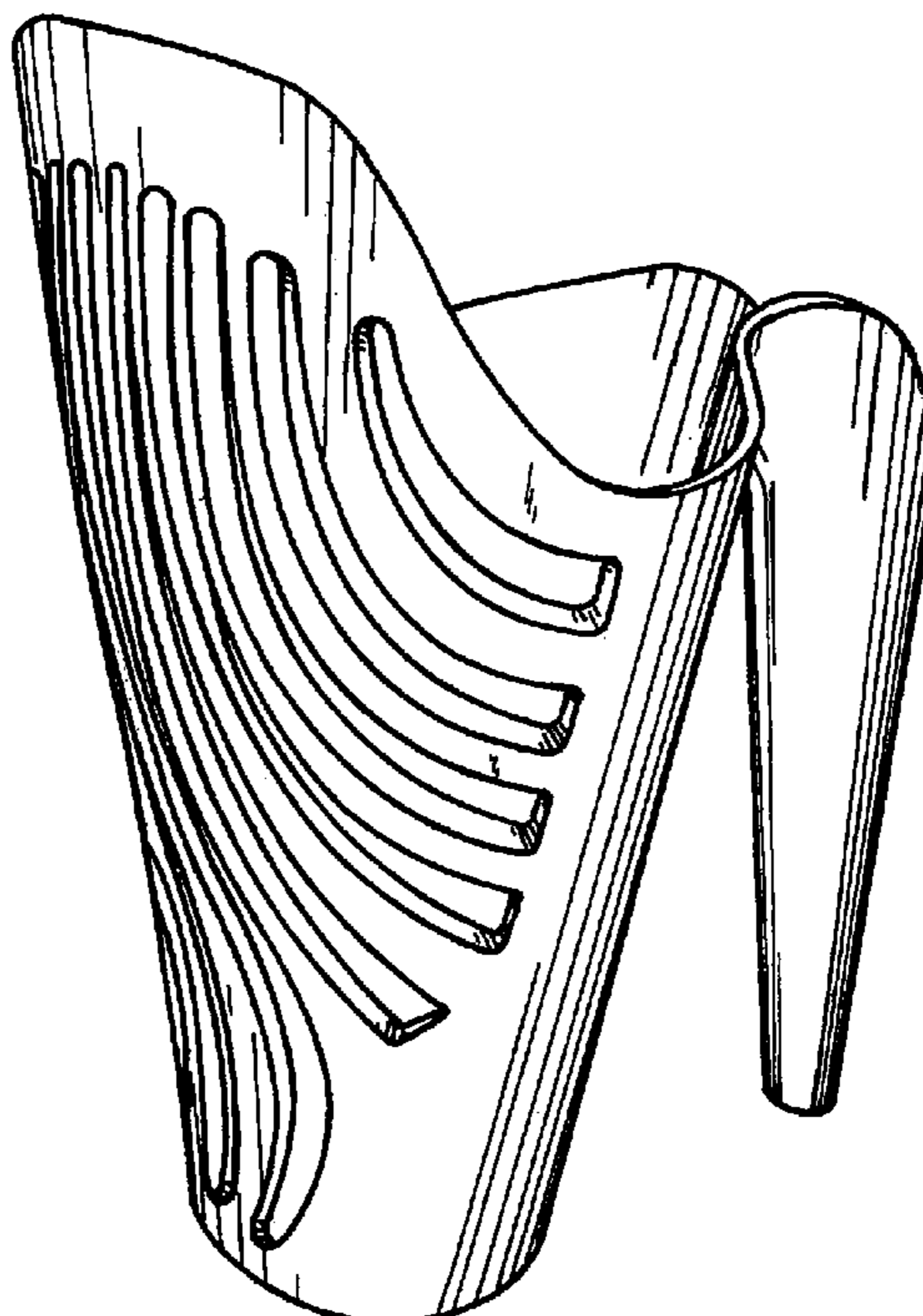
FIG. 1 is a perspective view of a sifting scoop incorporating our new design, viewed from in front of, above, and from the right side thereof;

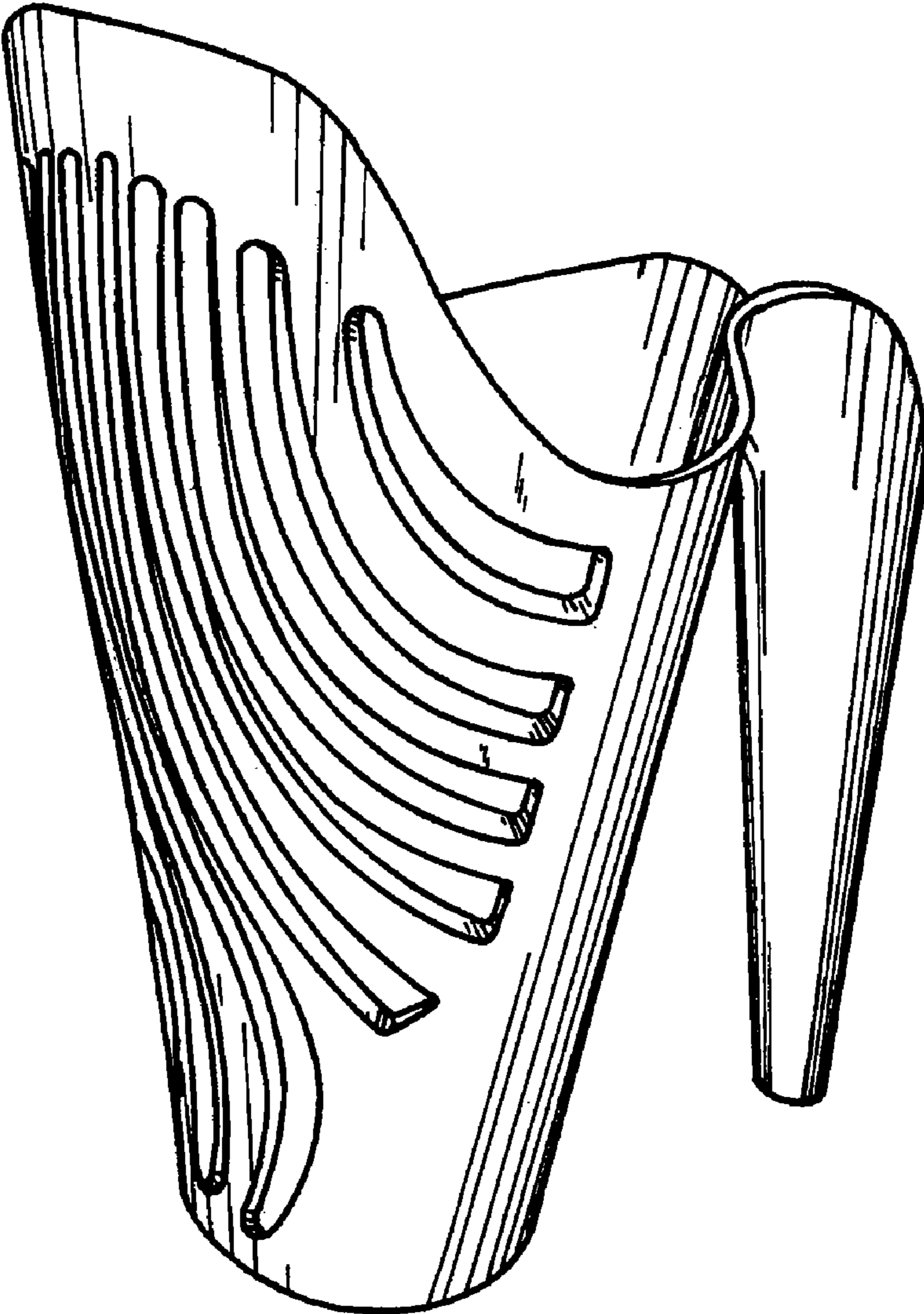

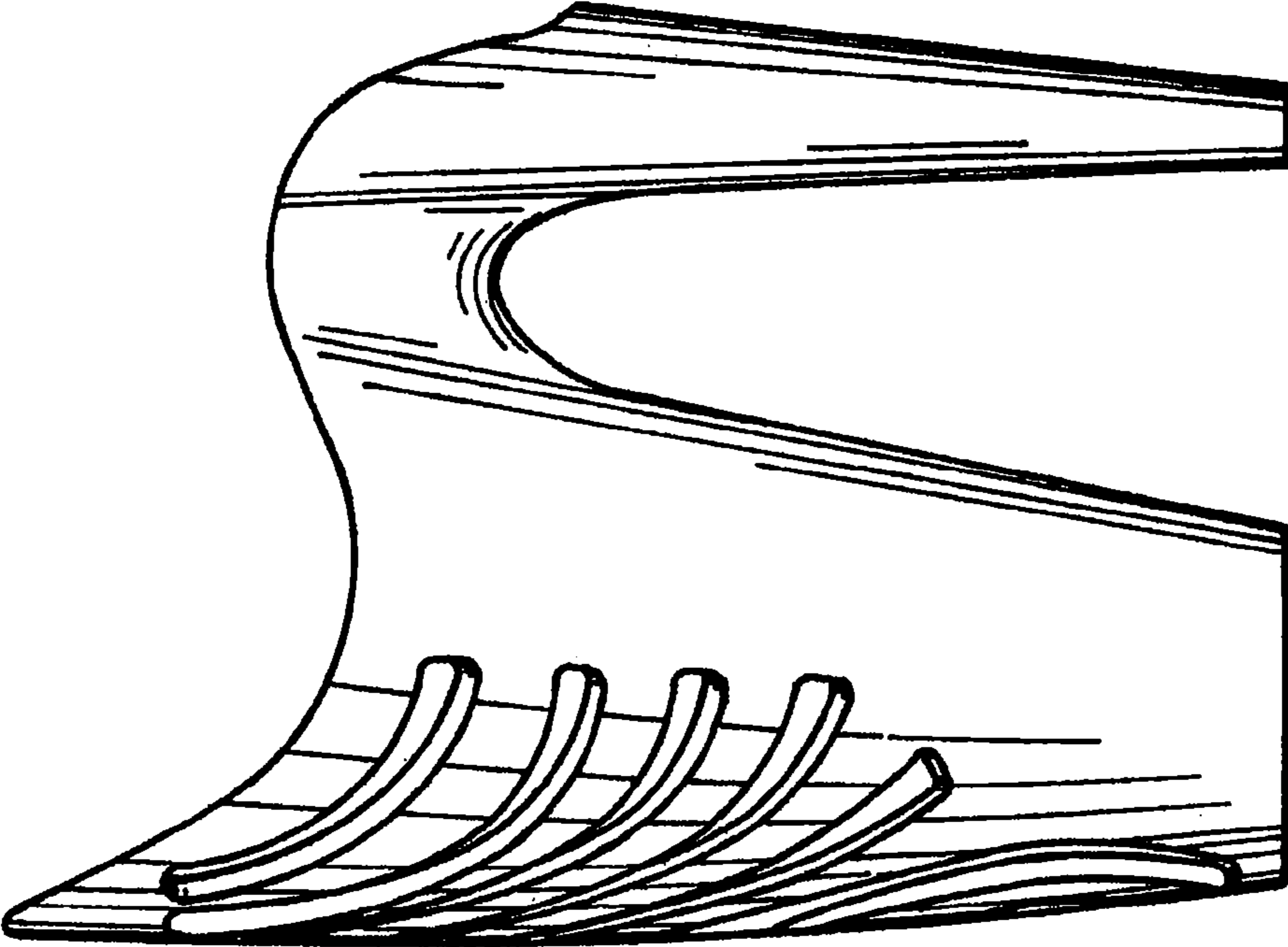

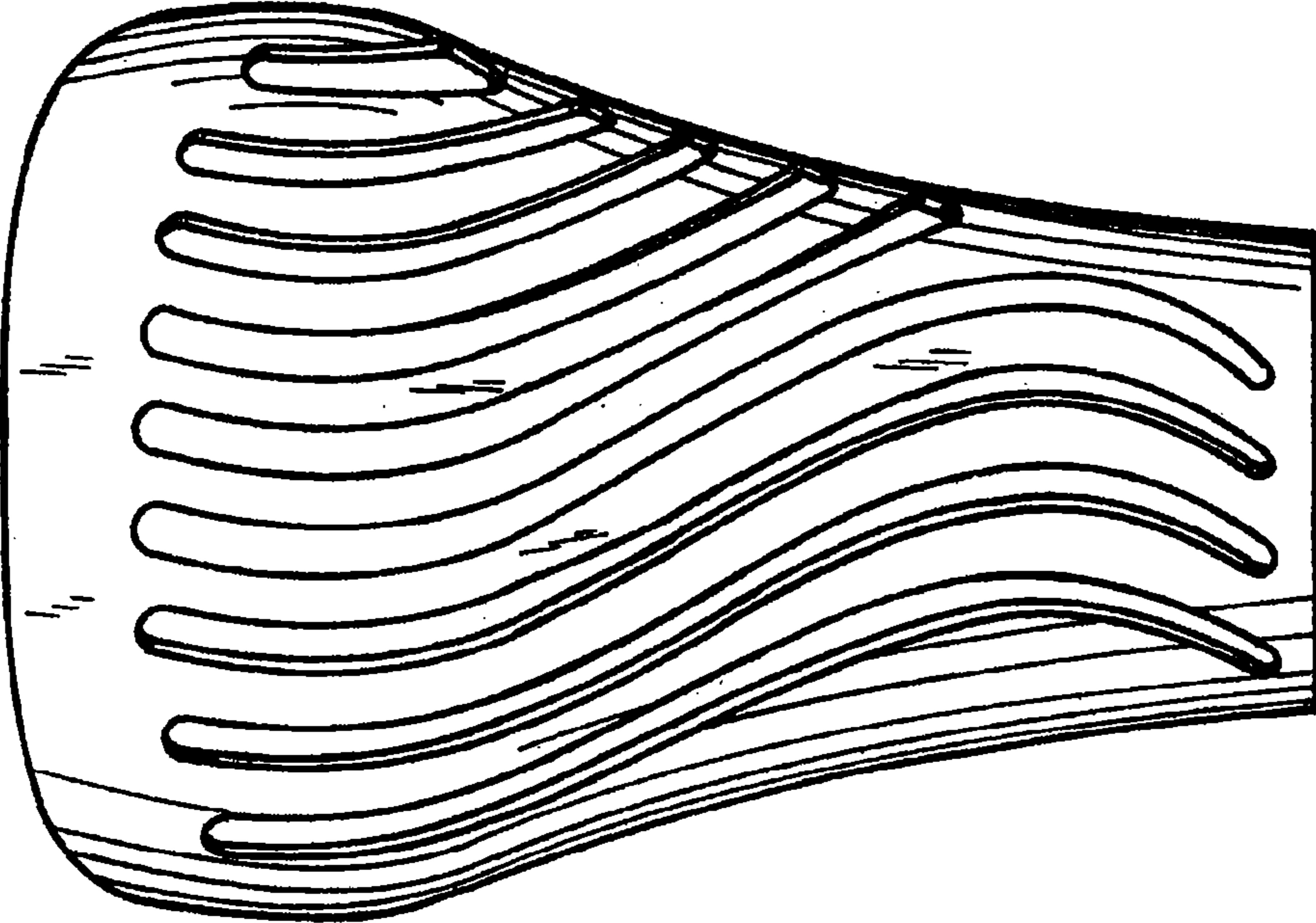

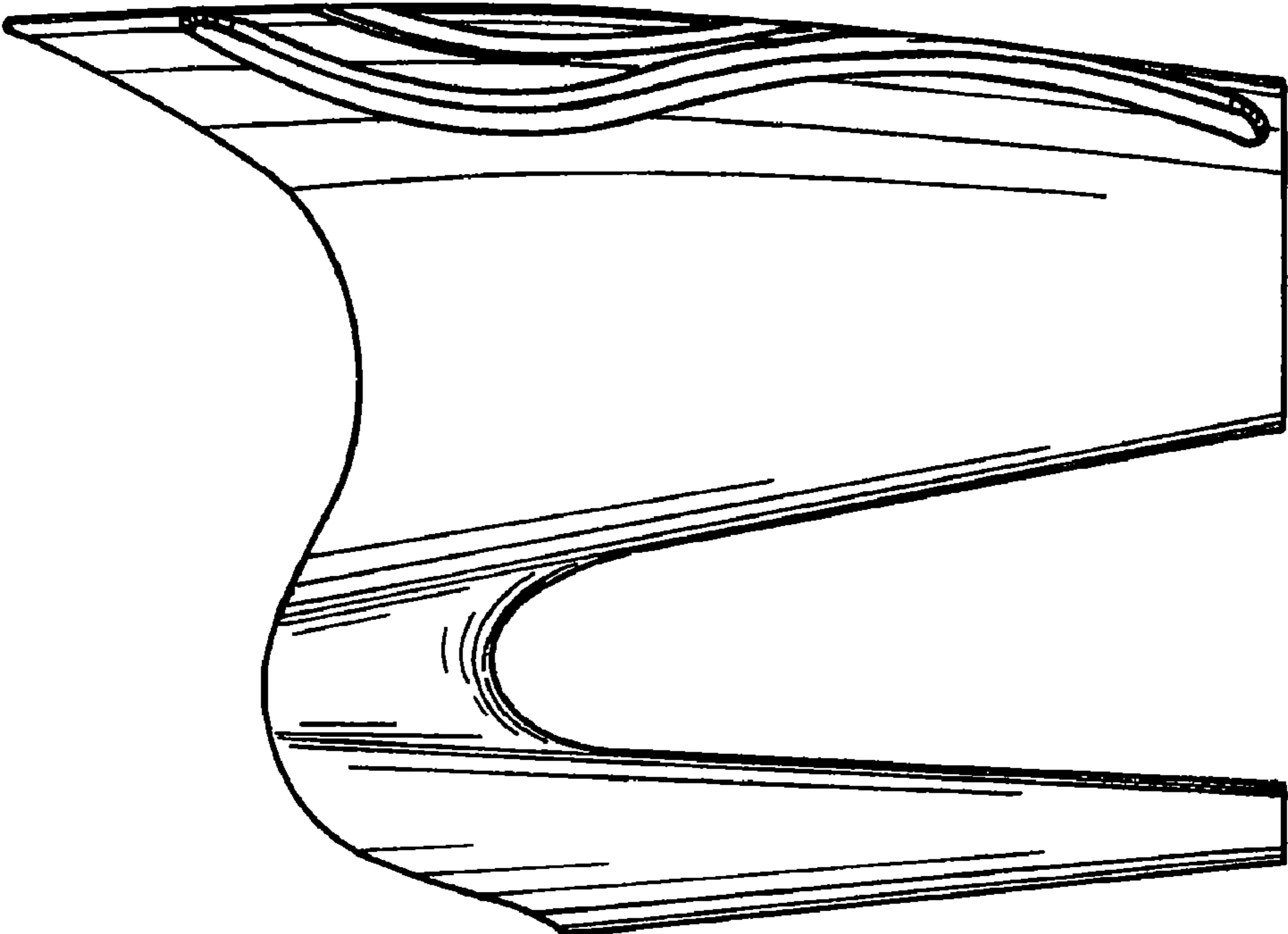

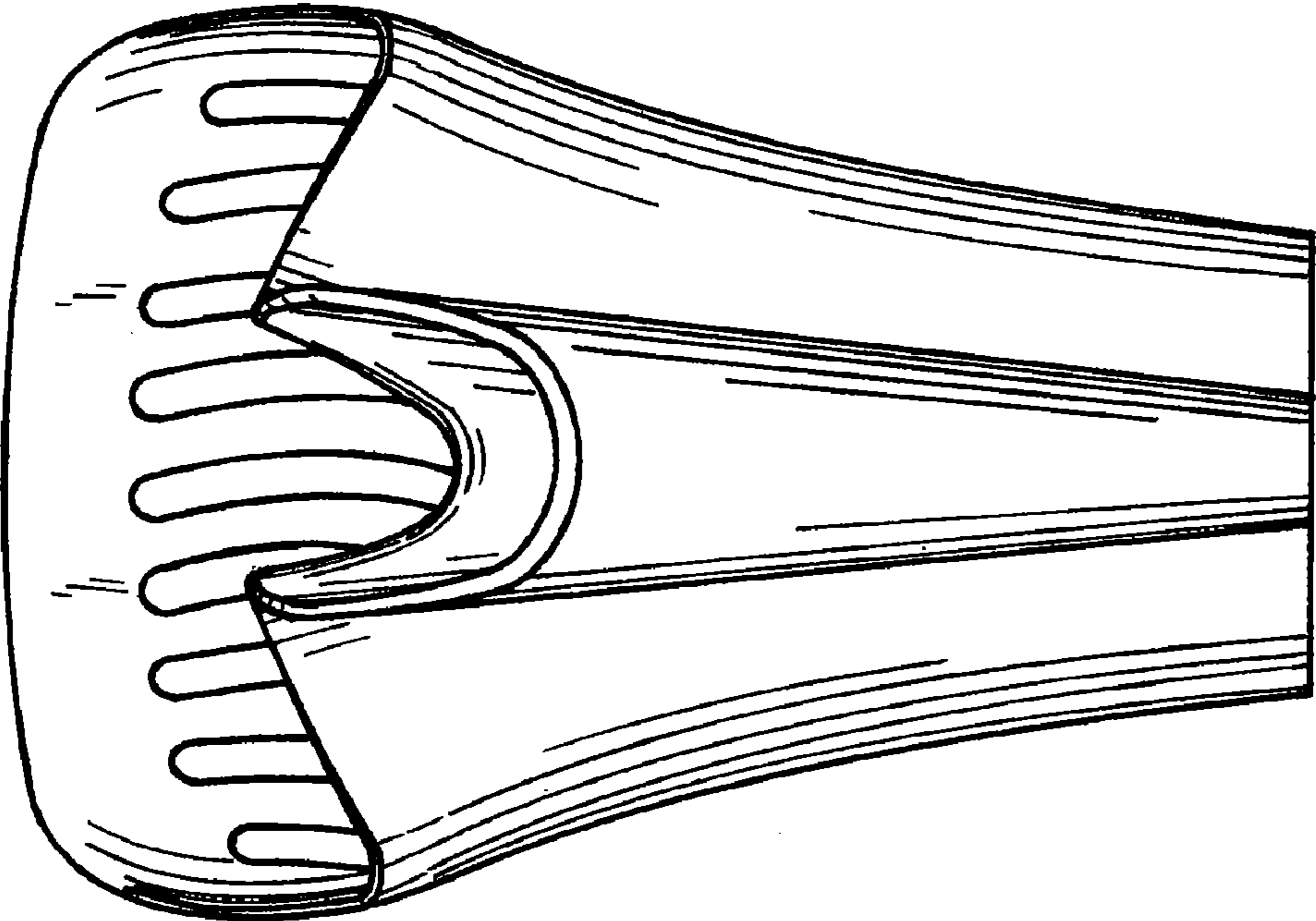

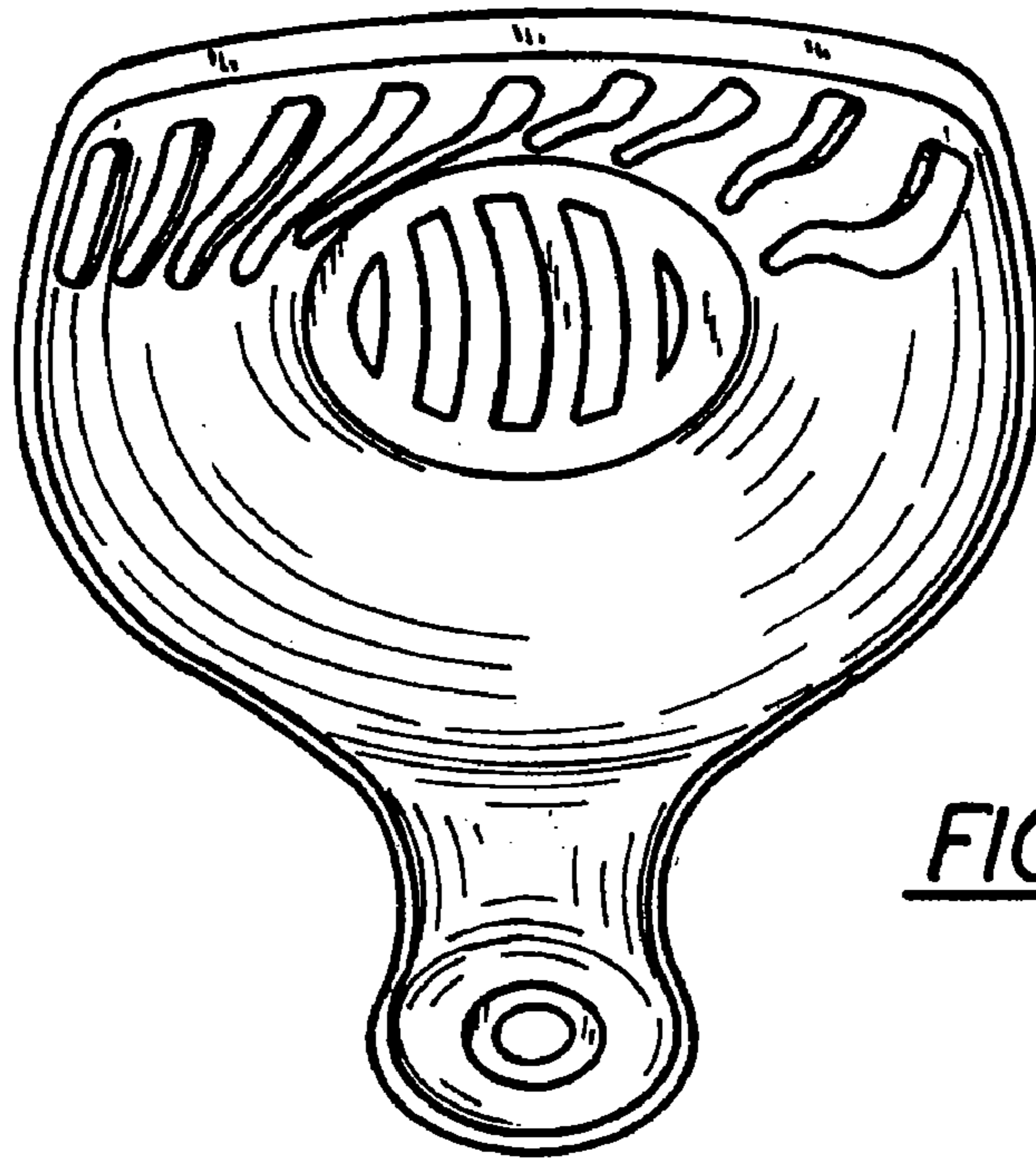

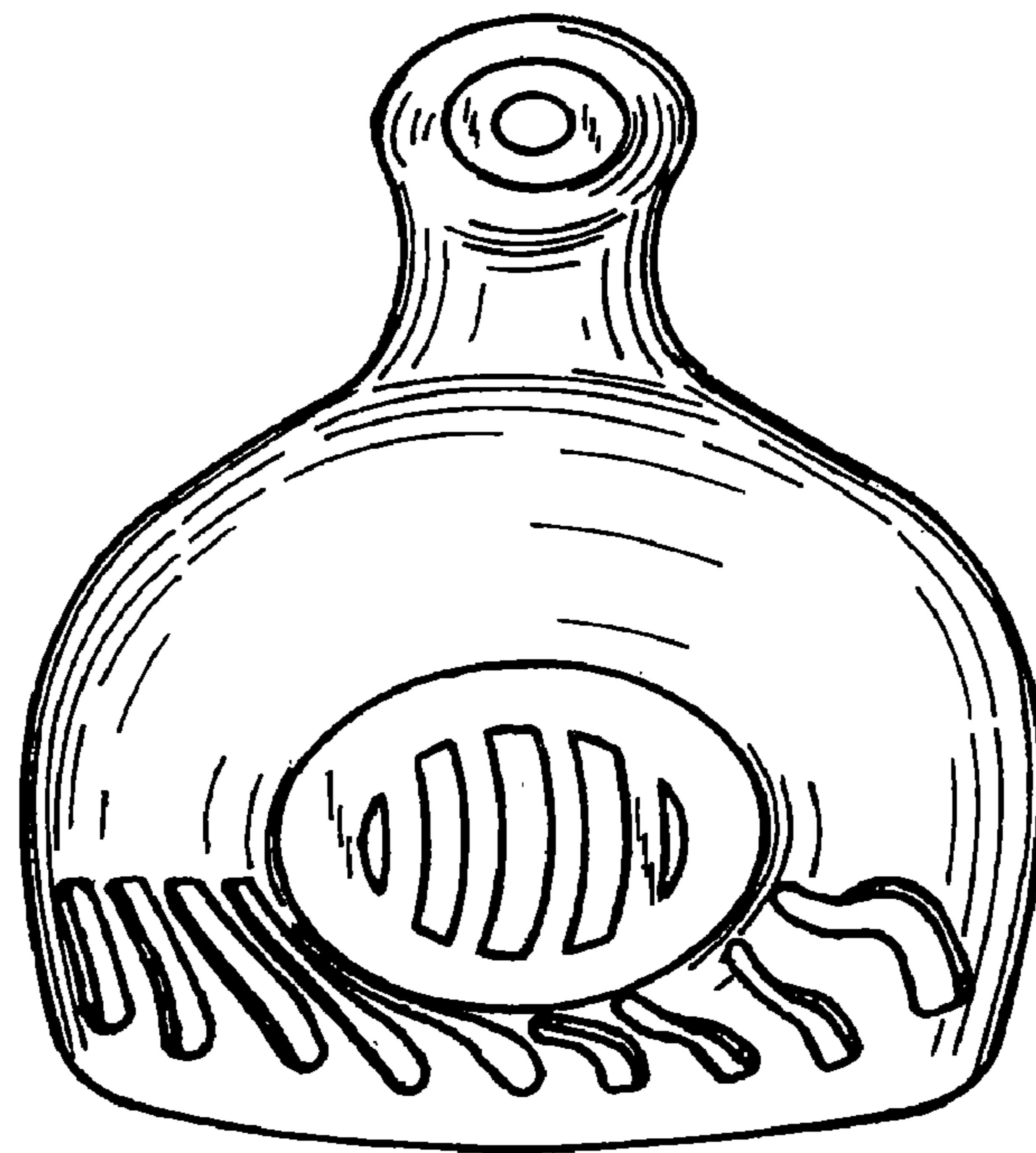
