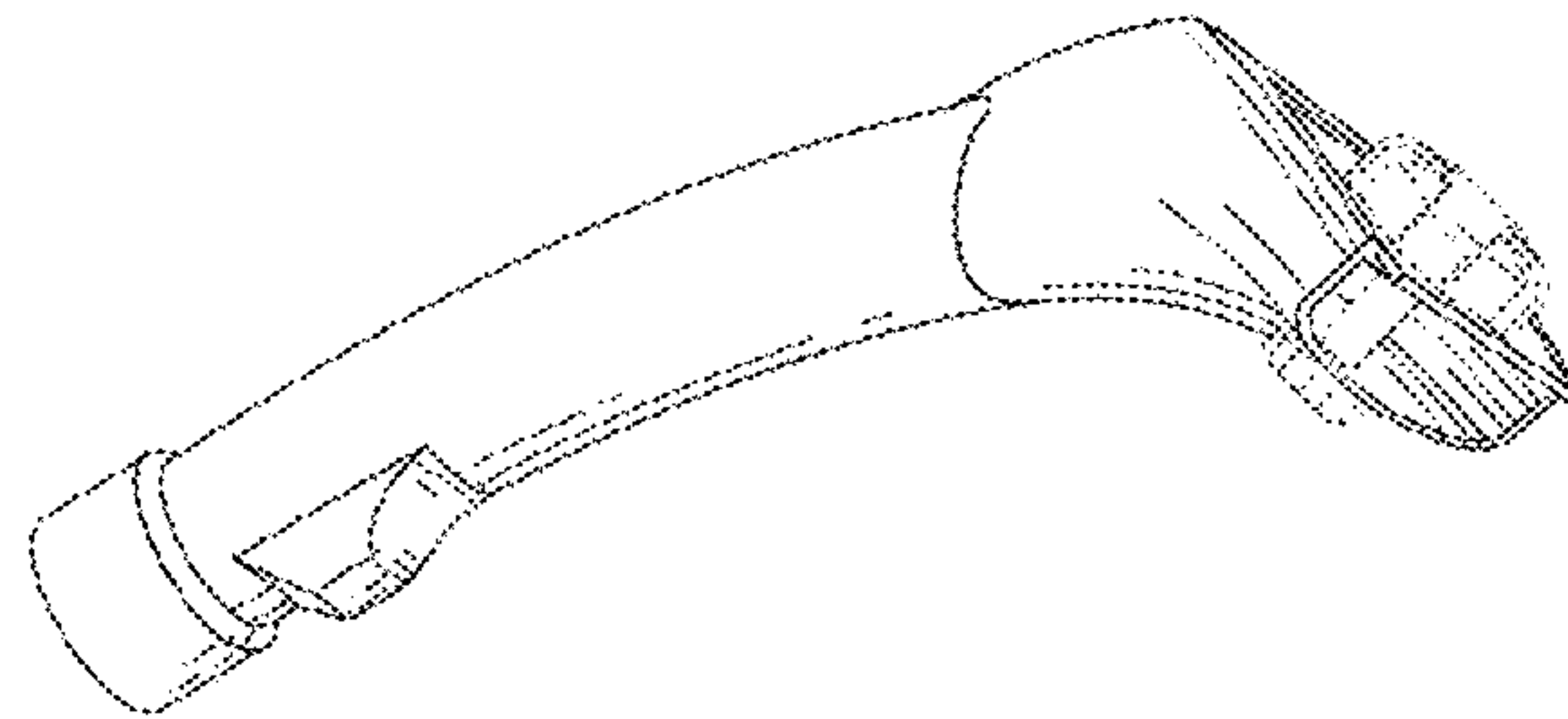
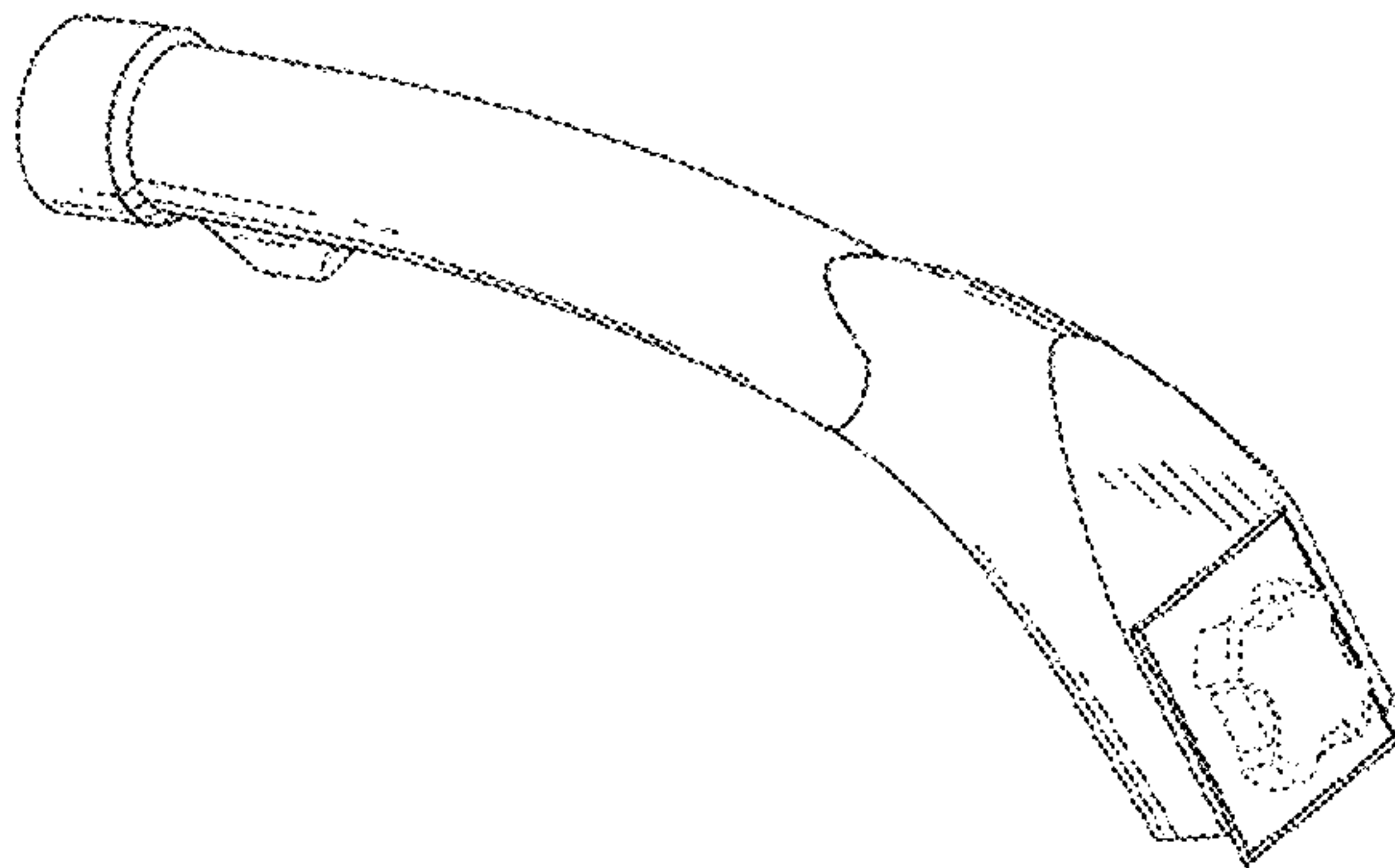
(57) **CLAIM**

The ornamental design for a scraper vacuum accessory tool, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric front perspective view of the front and upper surface of the scraper vacuum accessory tool; FIG. 2 is a perspective bottom view of the underside thereof; FIG. 3 is a top view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a front view thereof; and, FIG. 6 is a side view thereof. The broken lines in the Figures are for the purpose of illustrating exemplary environmental structure and form no part of the claimed design.

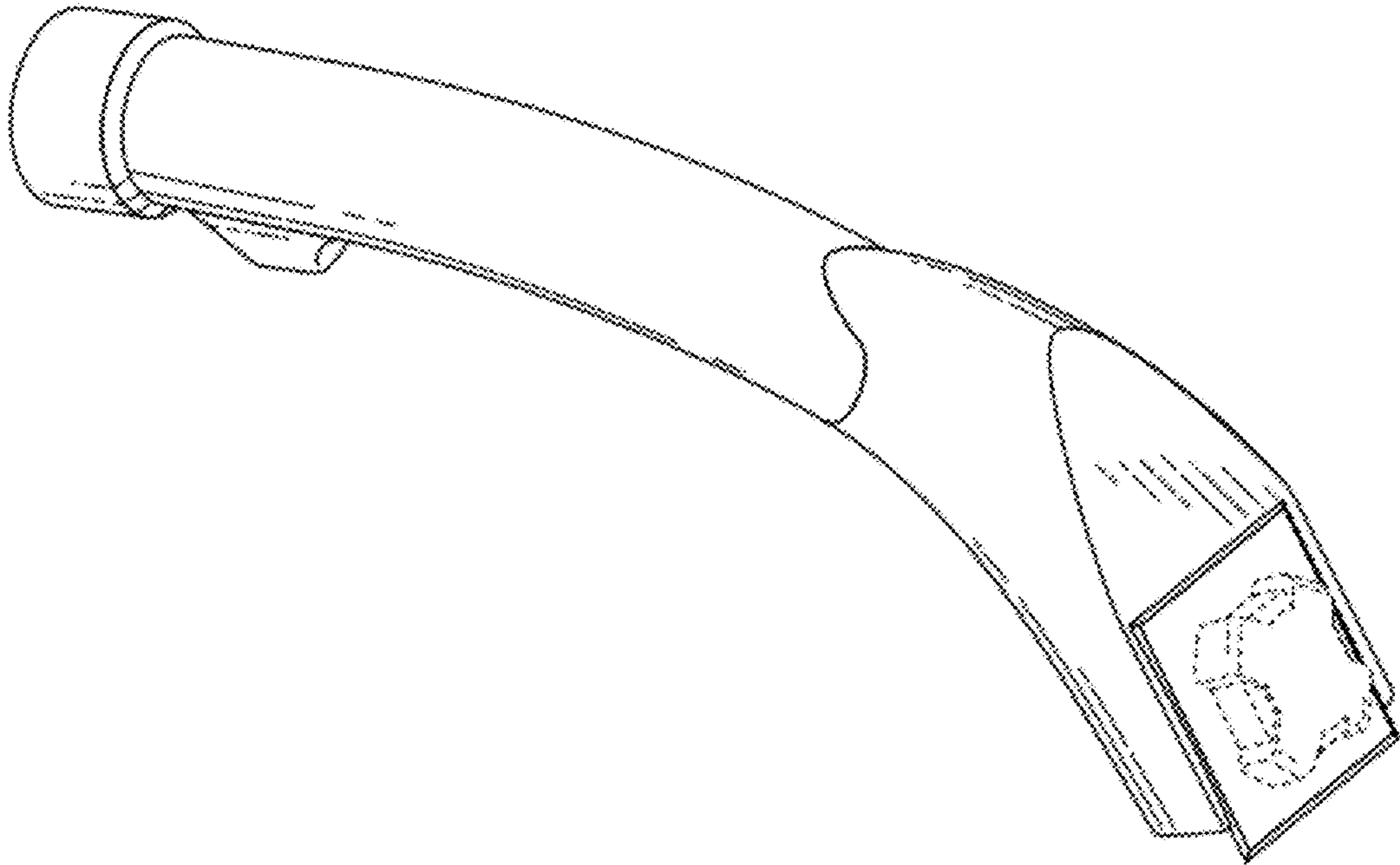

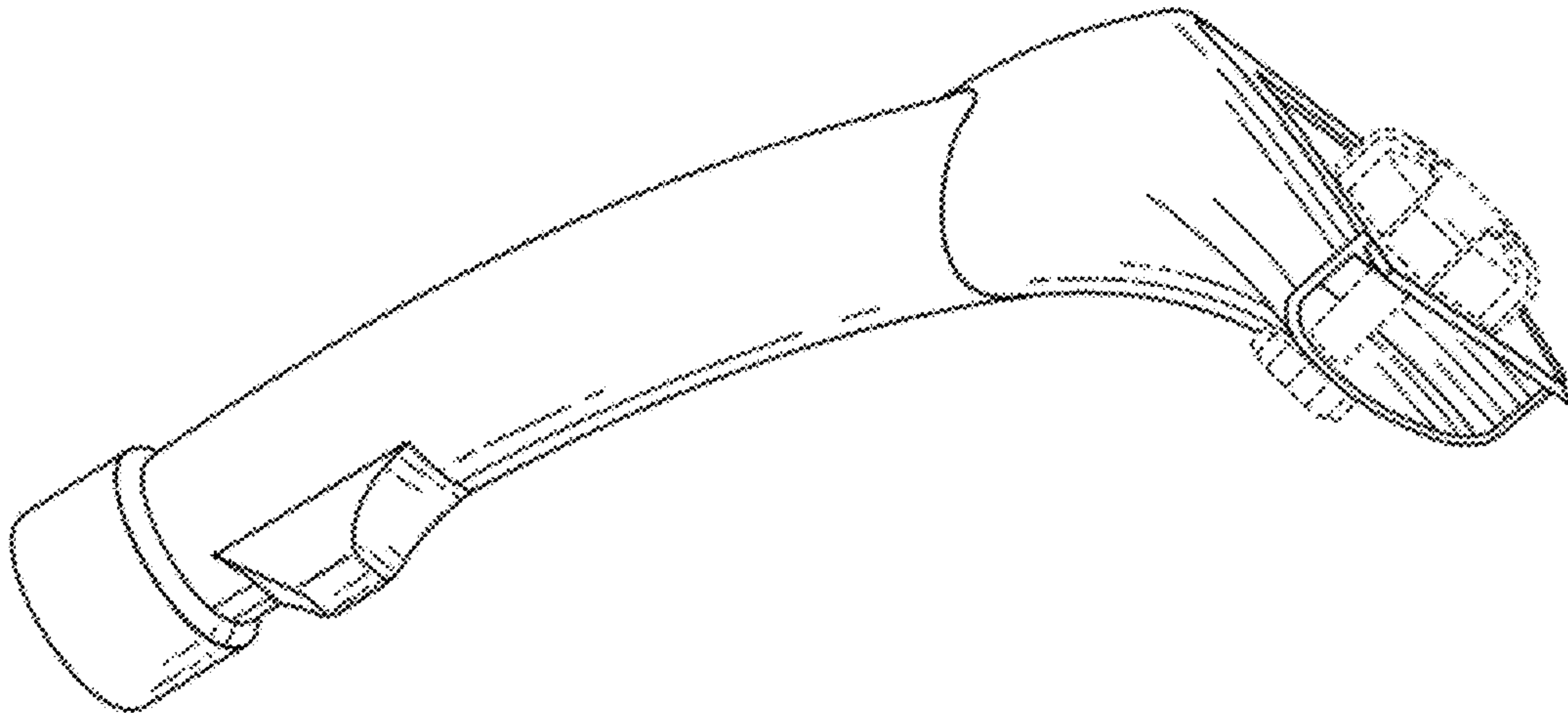

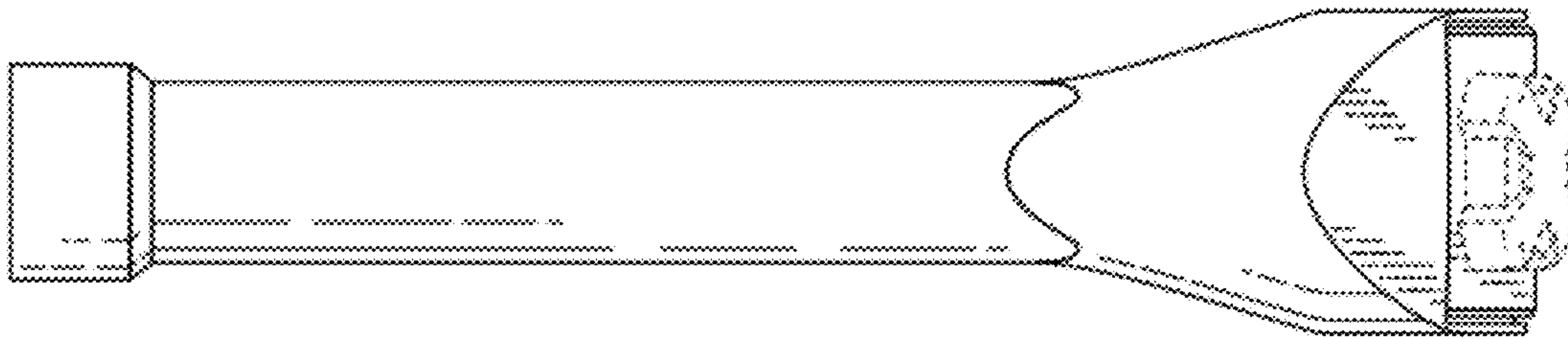

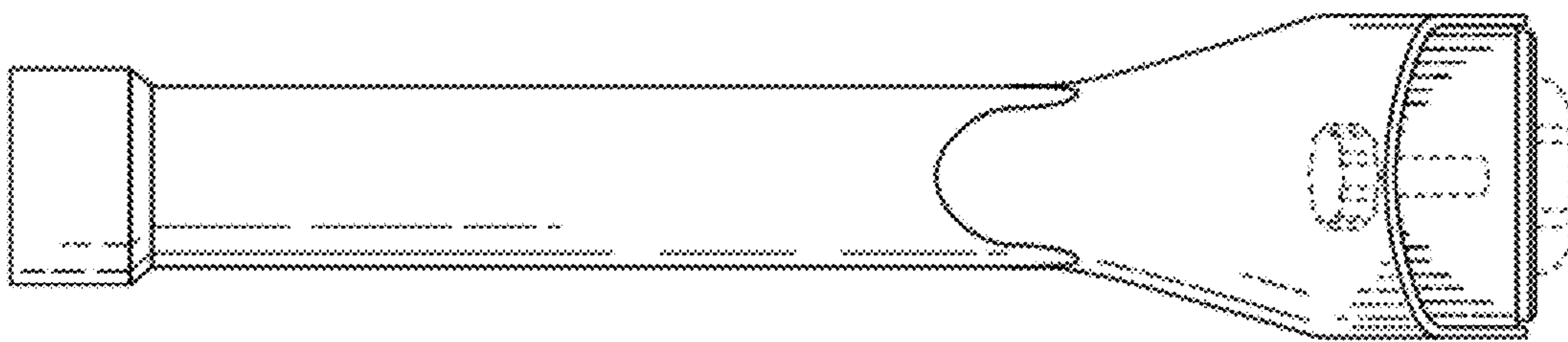

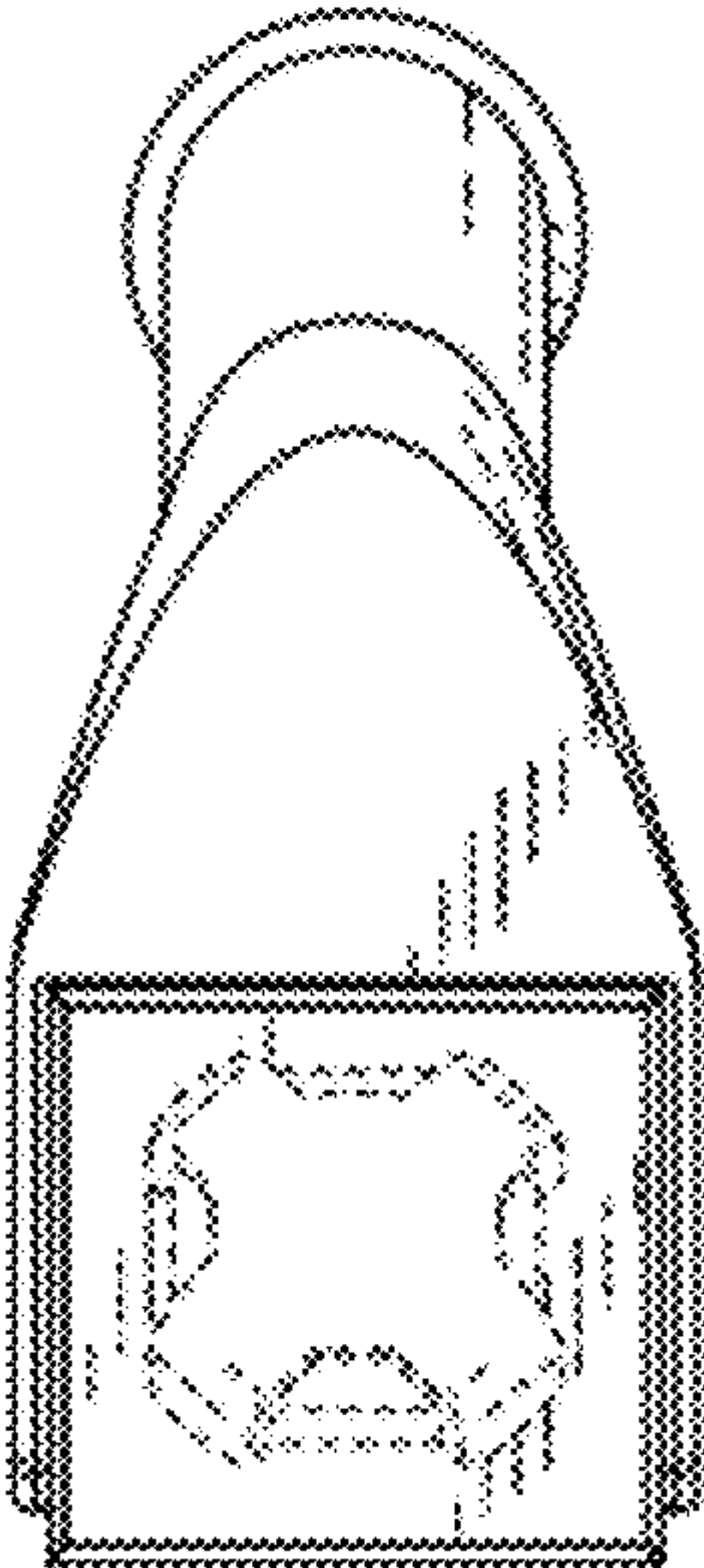

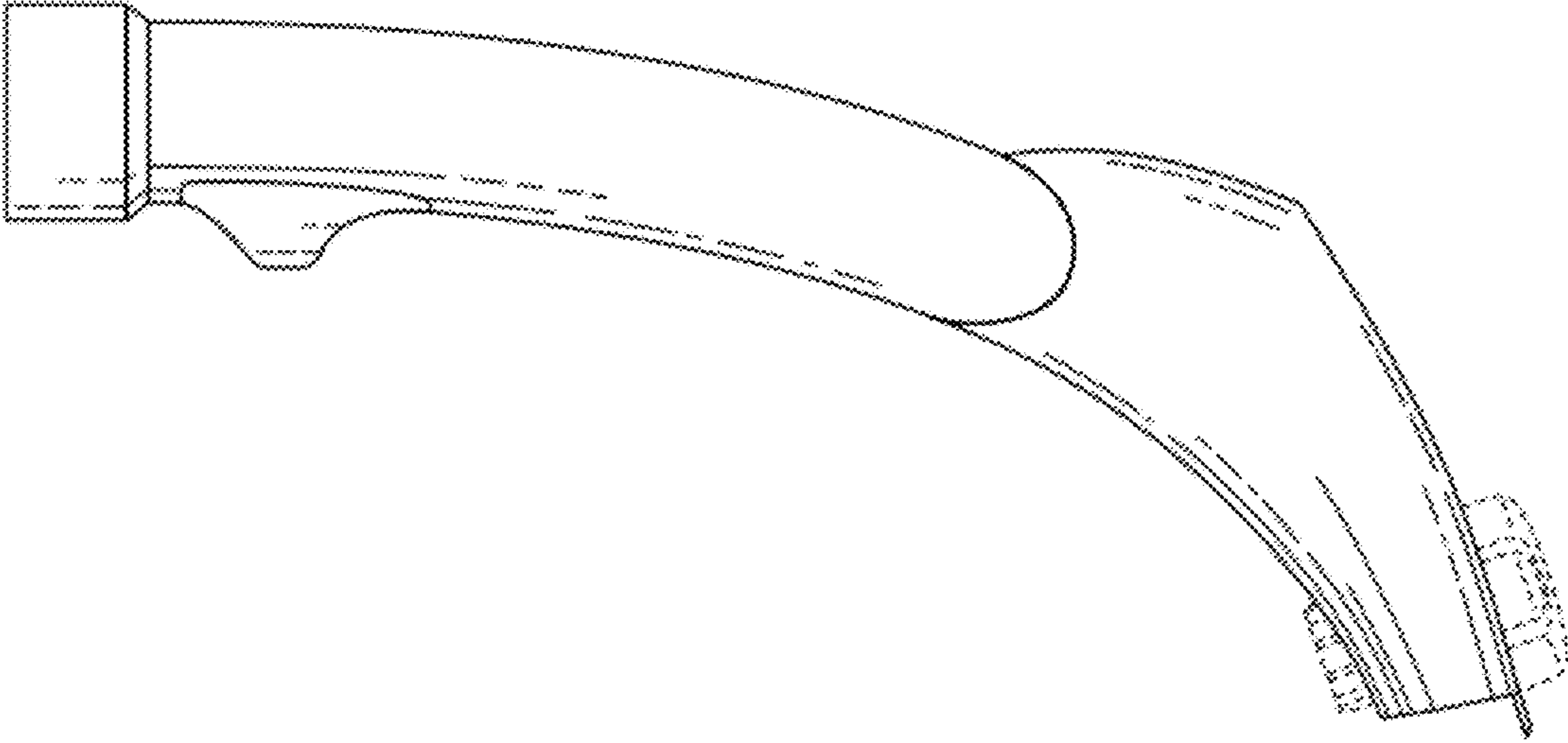
