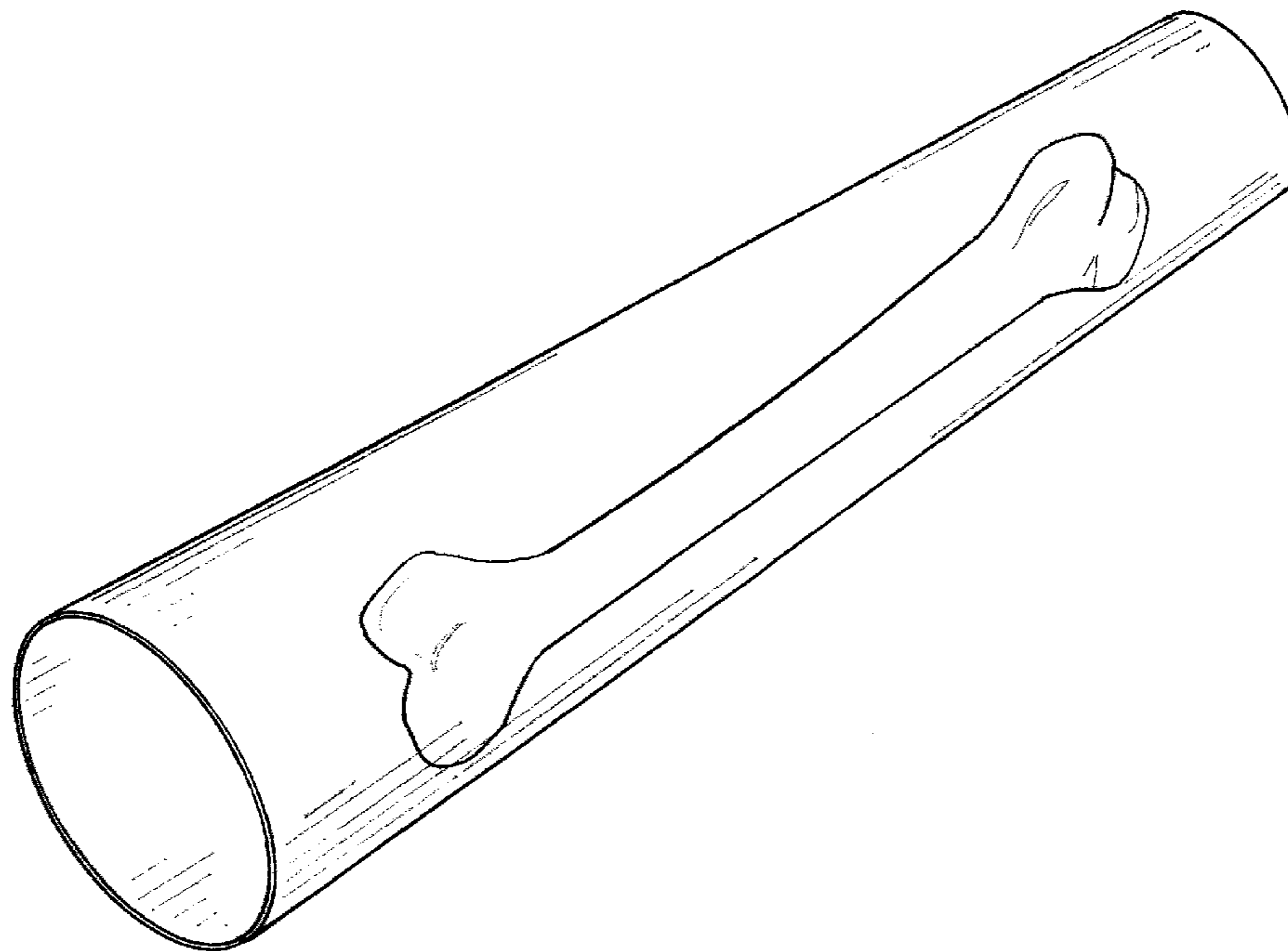
(57) **CLAIM**

The ornamental design for a garment to be worn on an arm of a person, as shown and described.

DESCRIPTION

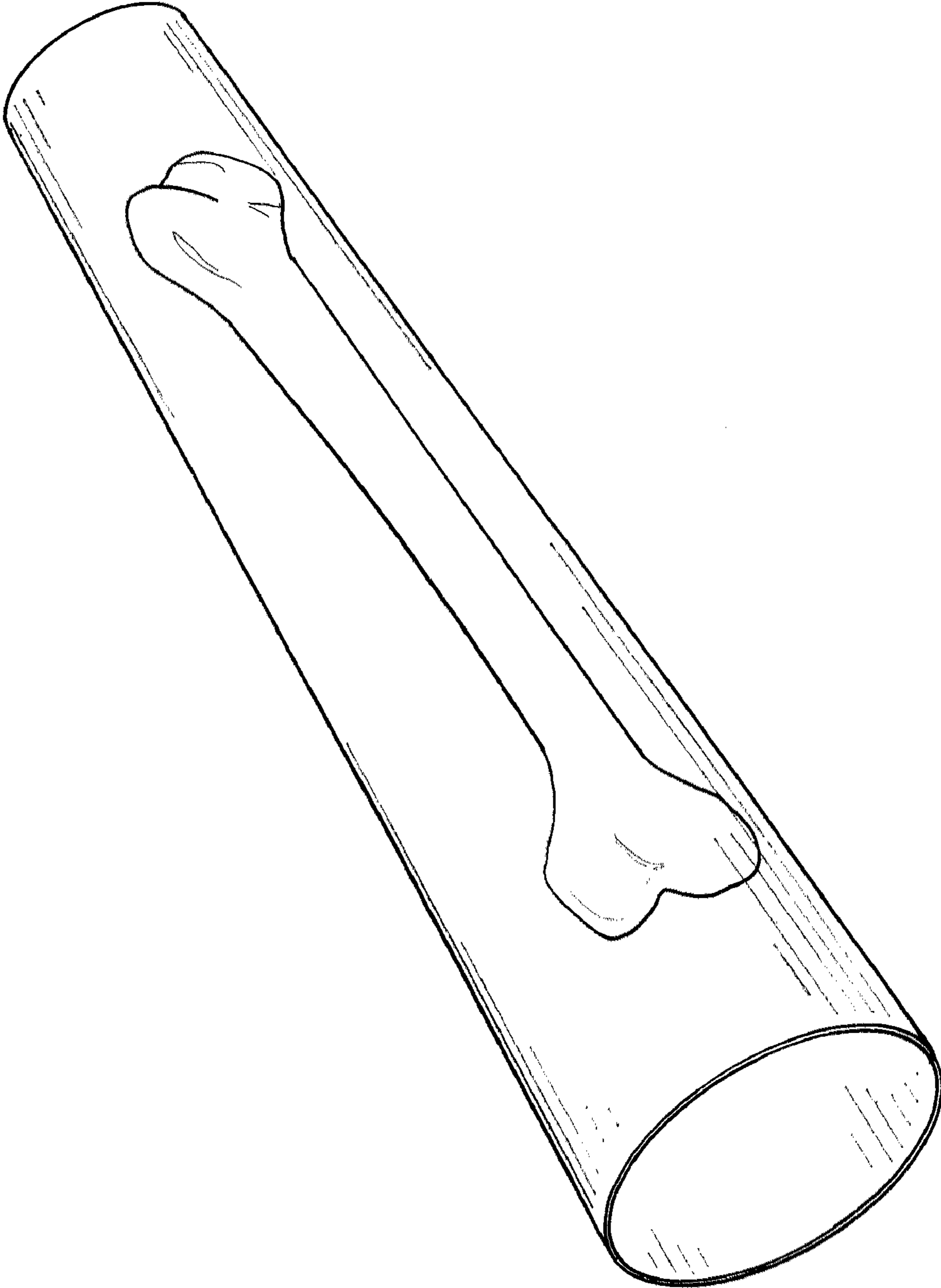

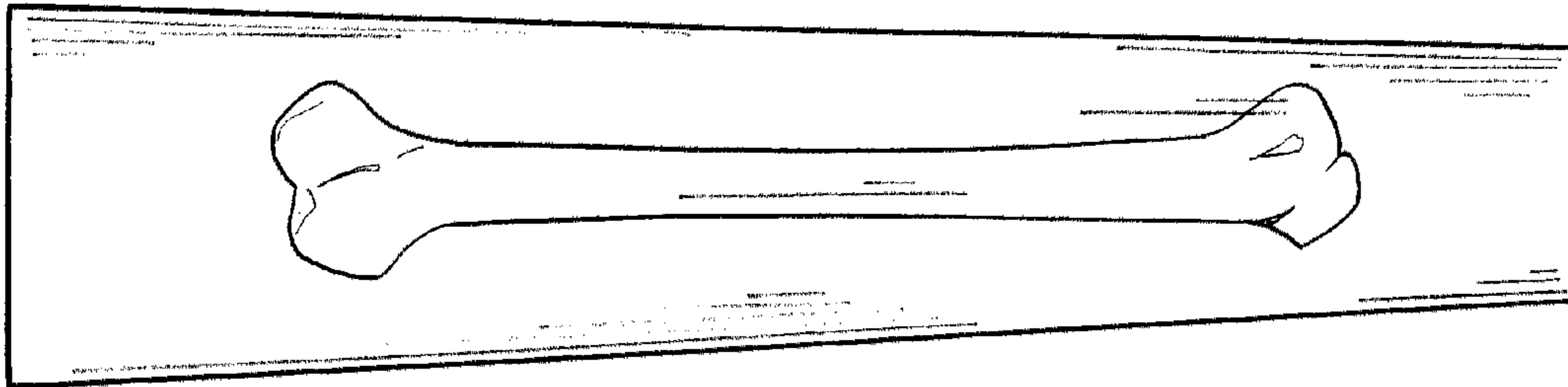

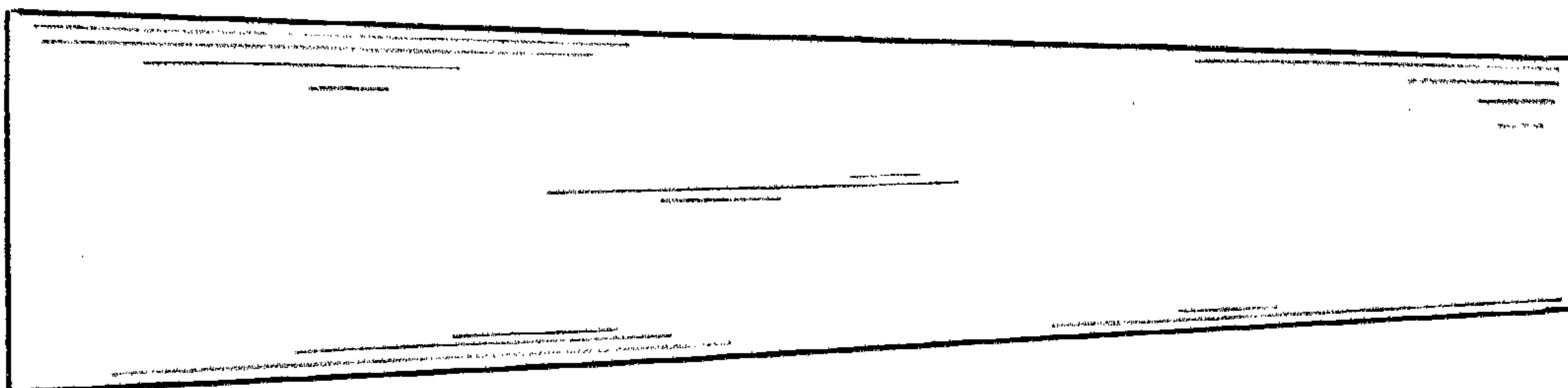

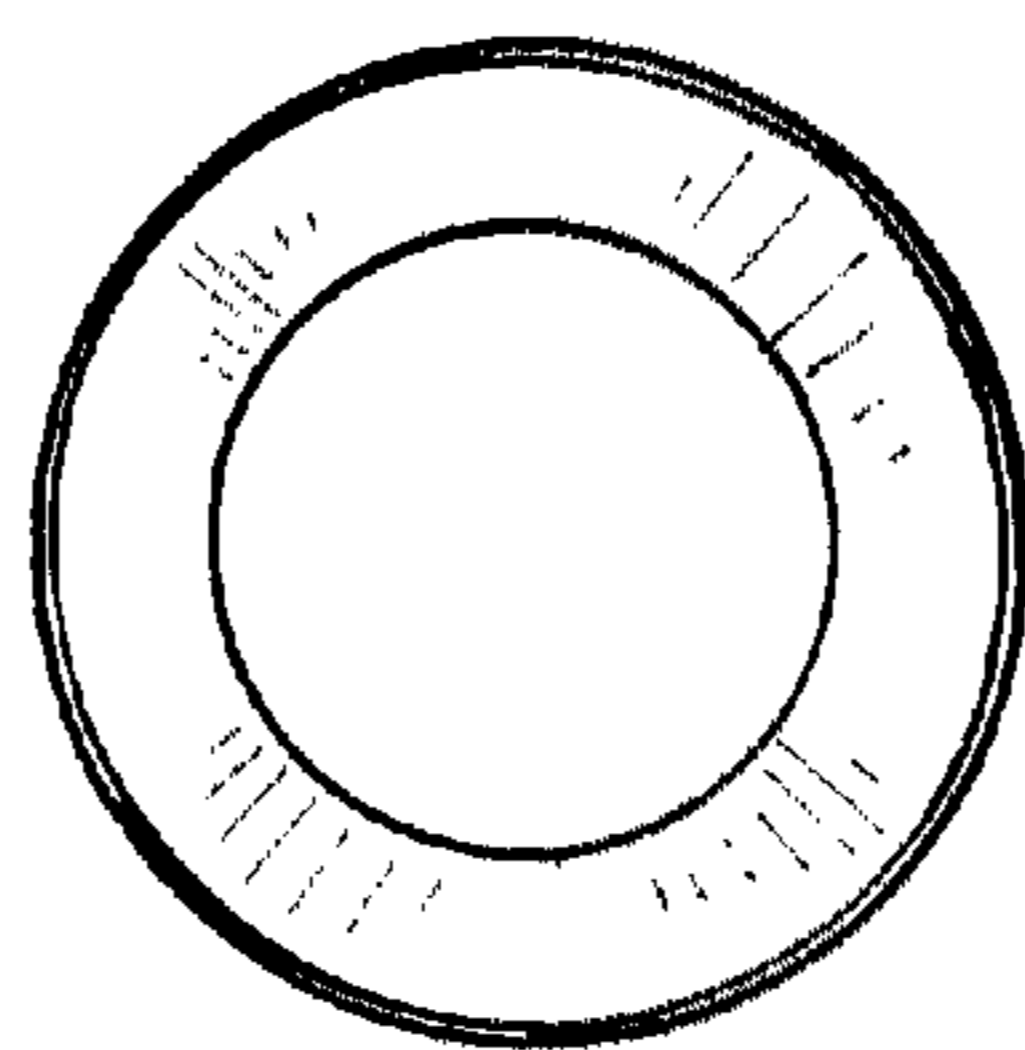

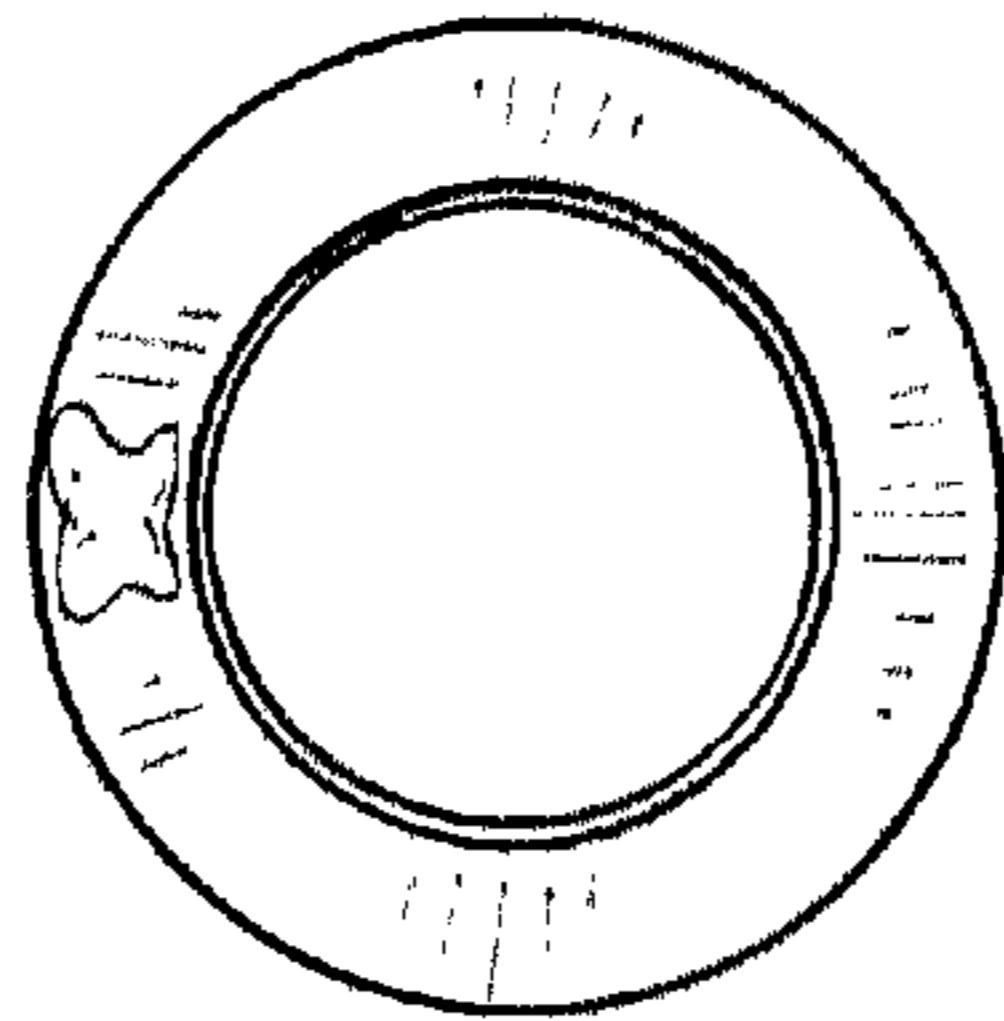

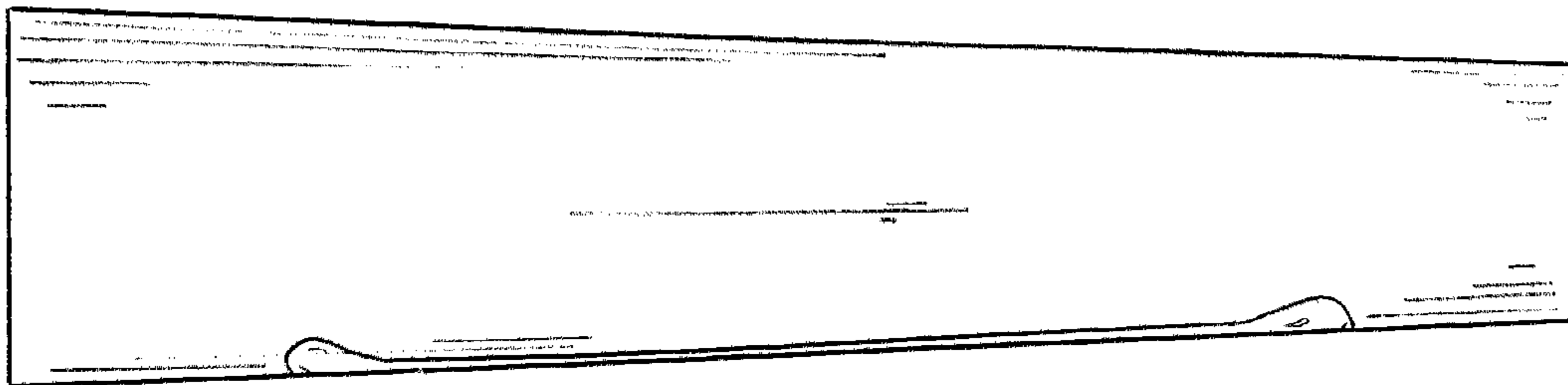

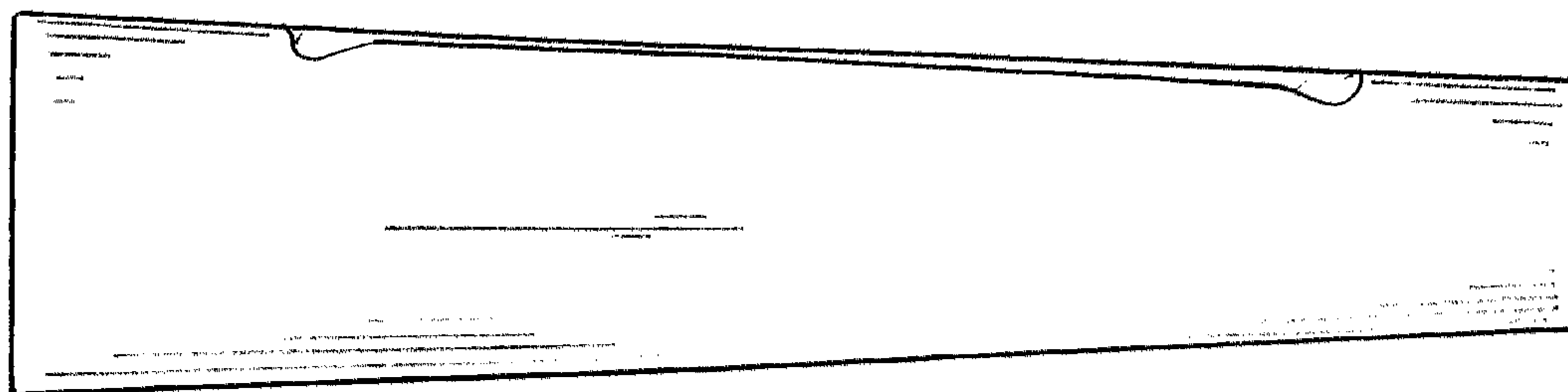
