(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shoe sole, showing the design; and,
FIG. 2 is a bottom view of the shoe sole shown in FIG. 1.

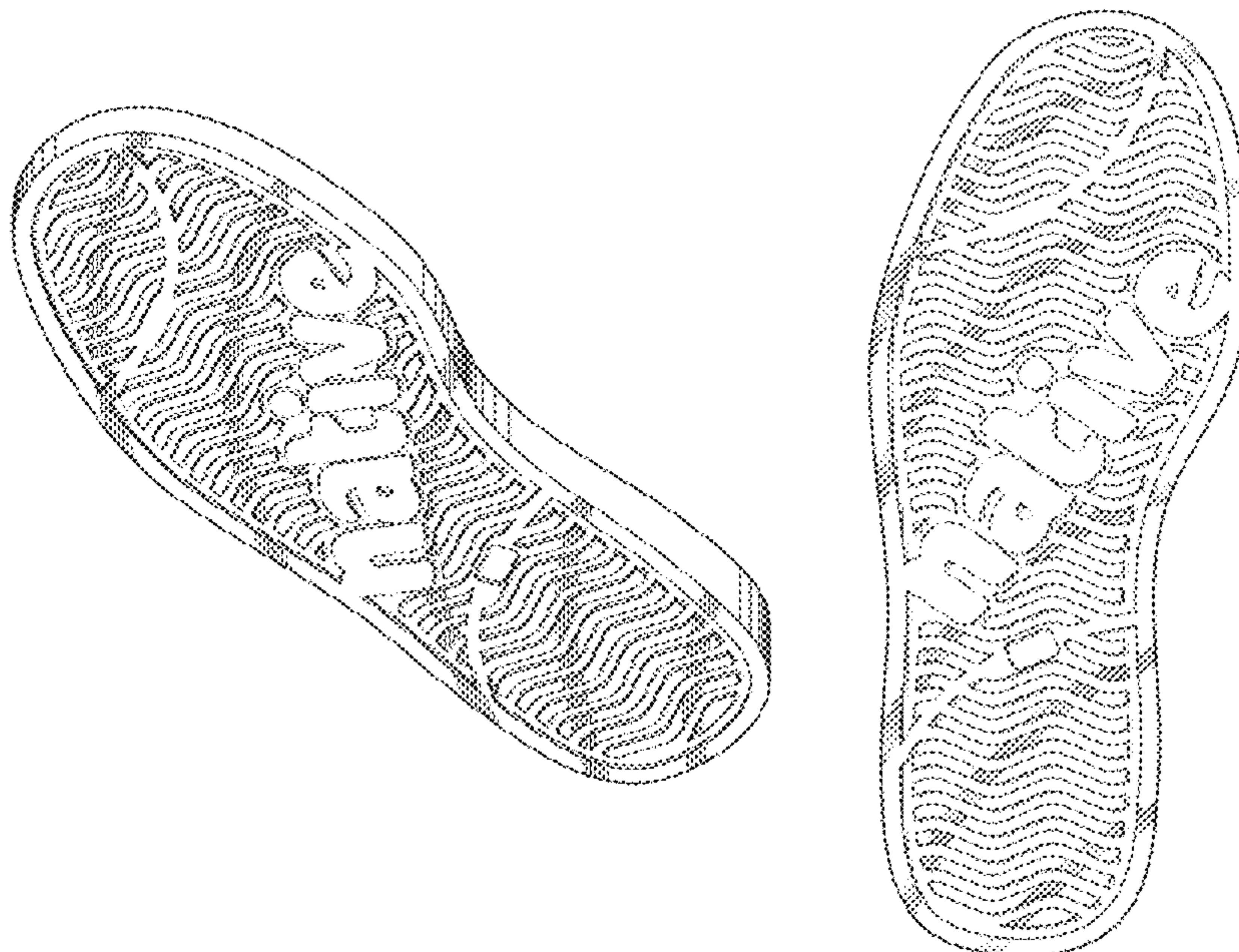

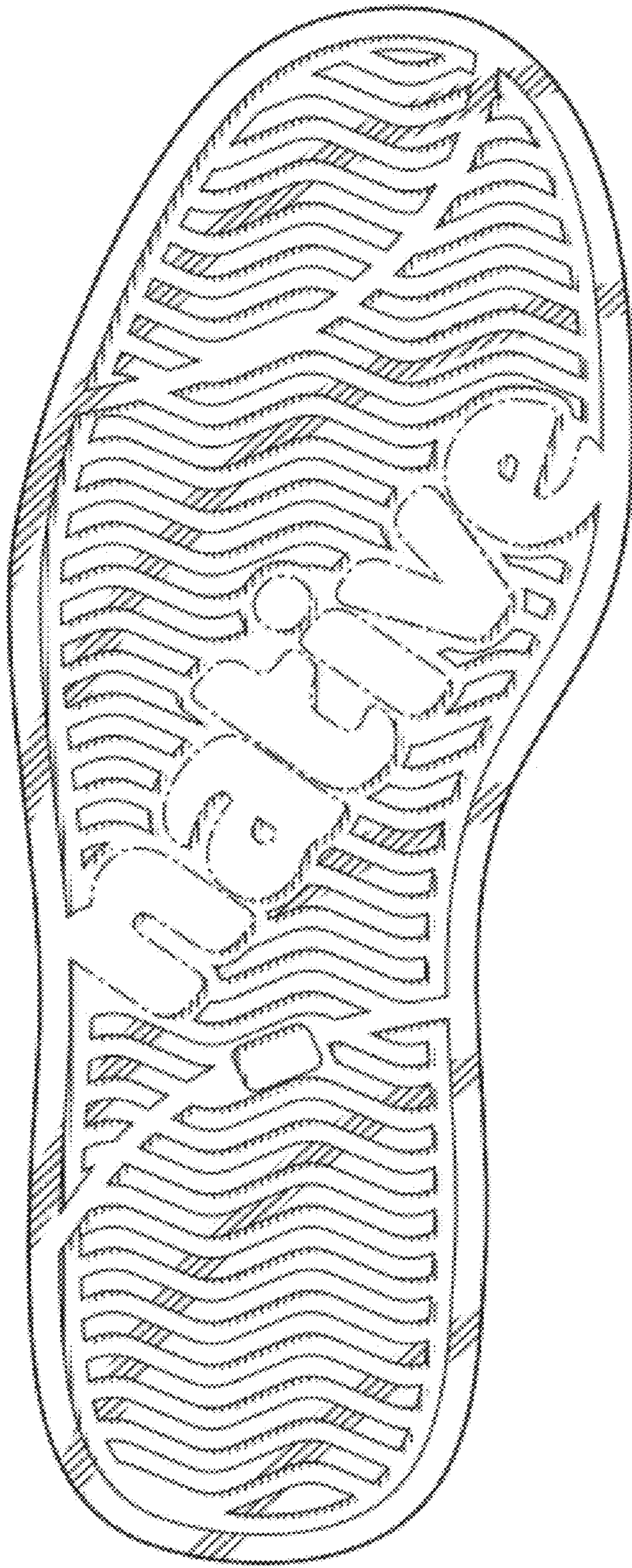
