**DESCRIPTION**

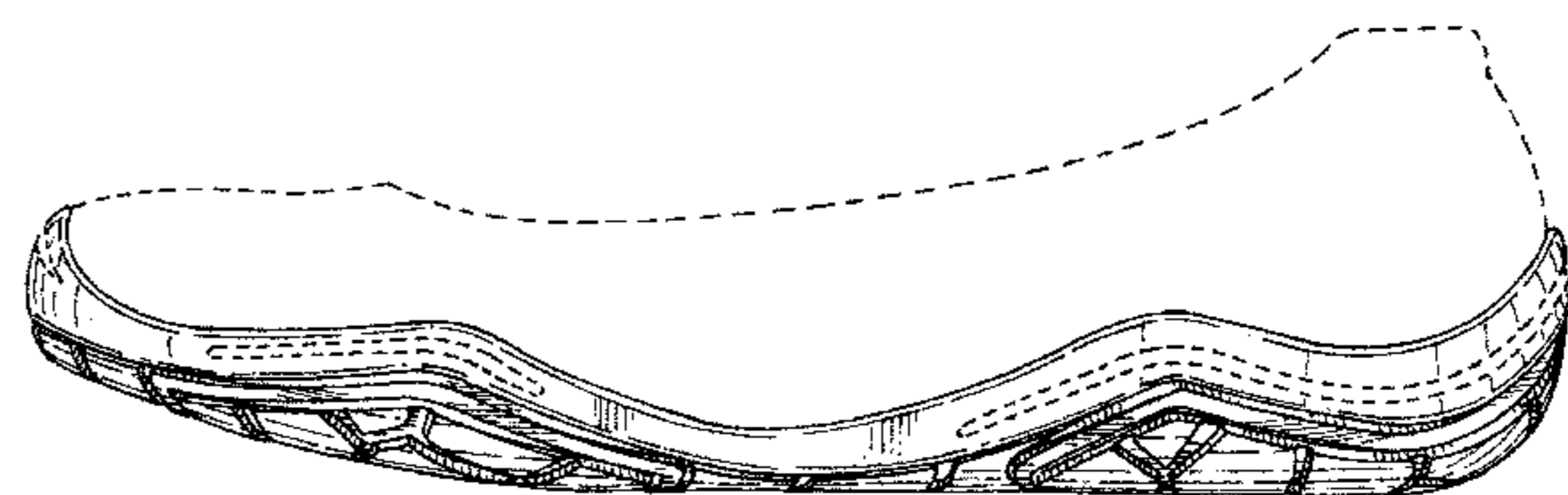
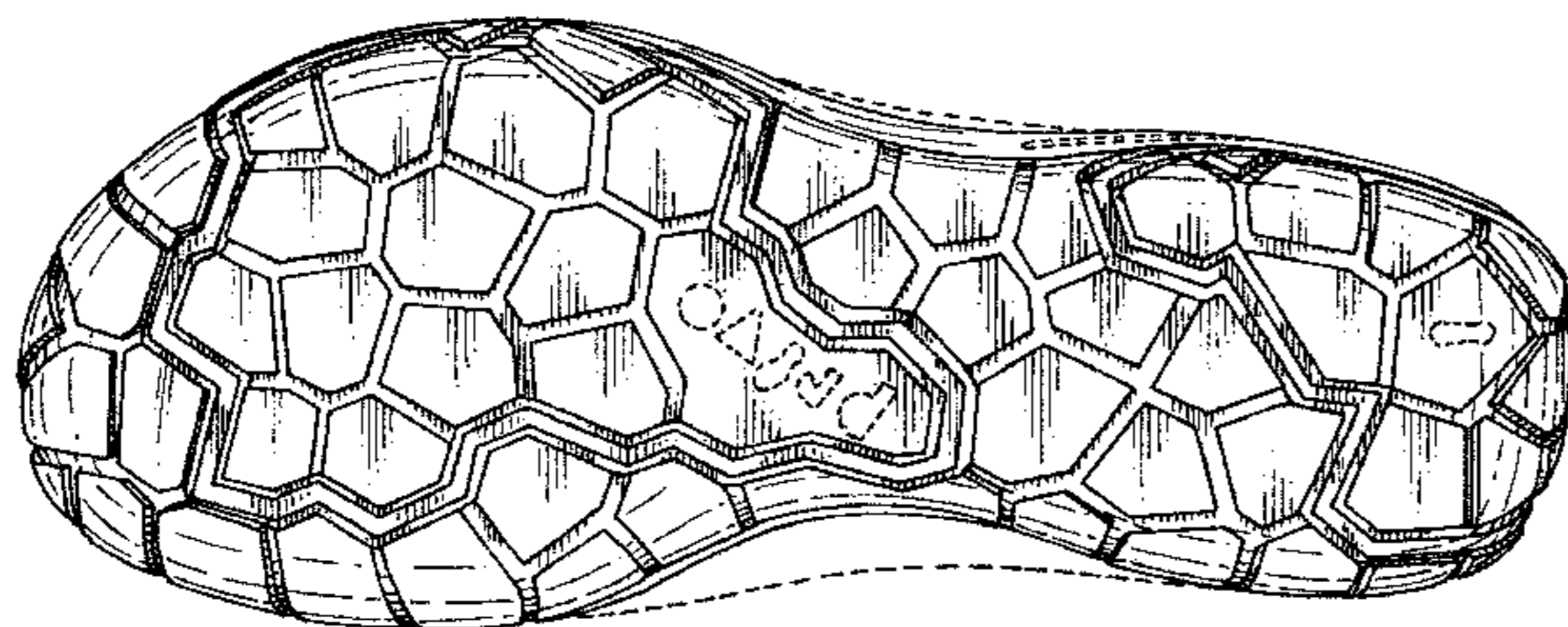
FIG. 1 is a bottom, left side and rear perspective view of a shoe sole in accordance with the new design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a left side elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a front view elevation thereof; and, FIG. 6 is a rear elevation view thereof.

The shoe upper shown in broken lines in FIGS. 1-6 is an illustration of environmental structure only and forms no part of the claimed design.

The trademark and logo elements shown in the shoe sole in broken lines in FIGS. 1-2 are an illustration of environmental structure only and form no part of the claimed design.

The channels along the left and right sides of the shoe sole in broken lines in FIGS. 1-6 are an illustration of environmental structure only and form no part of the claimed design.

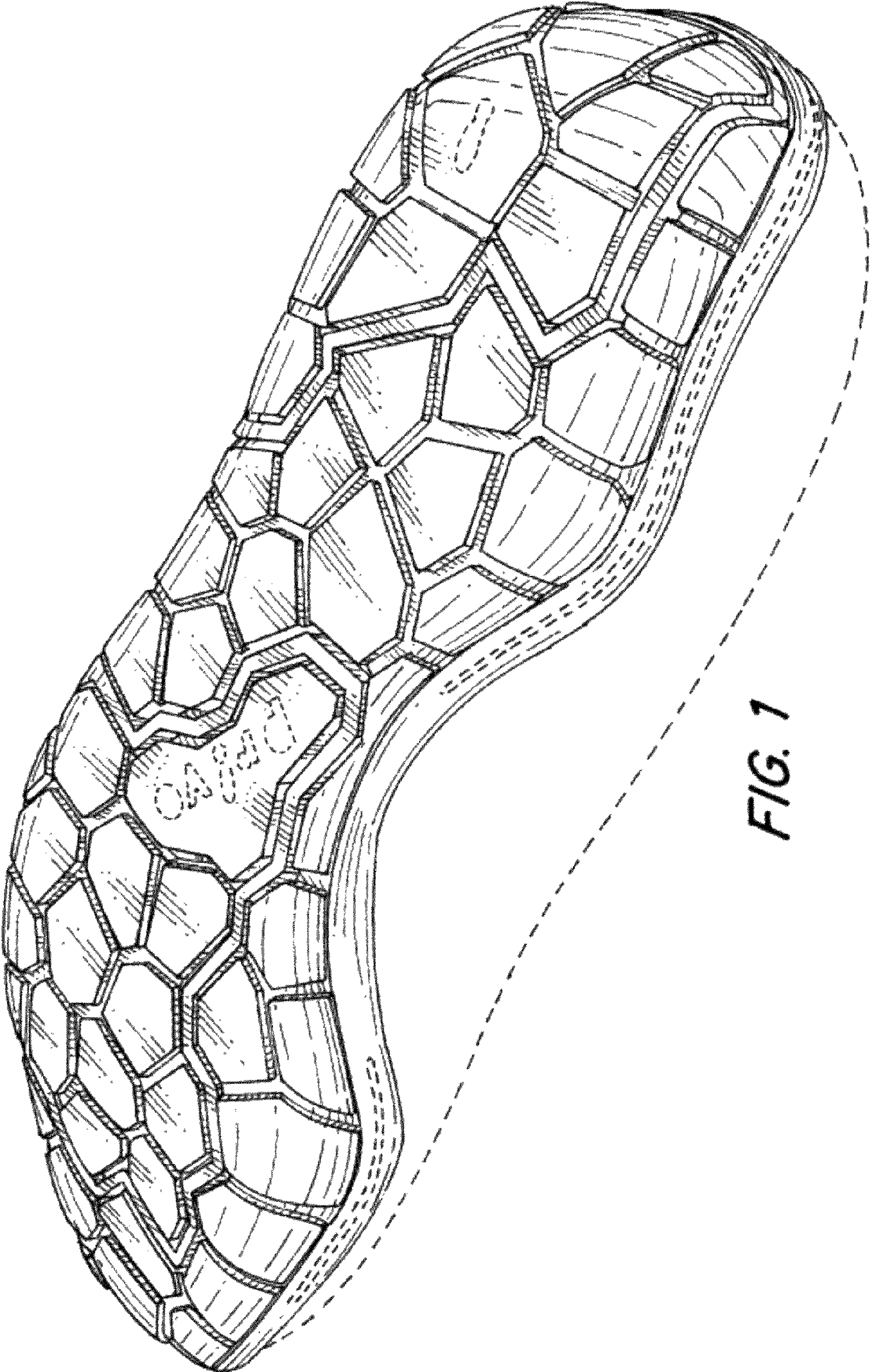

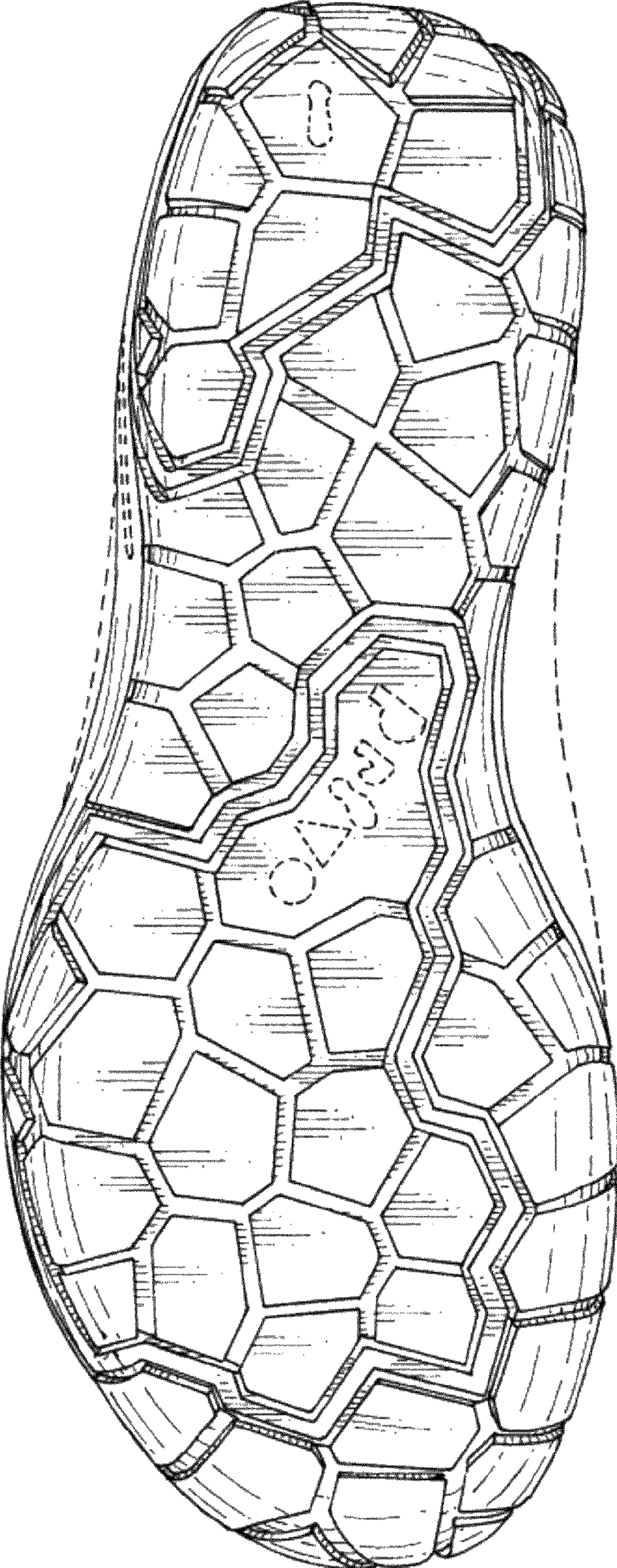
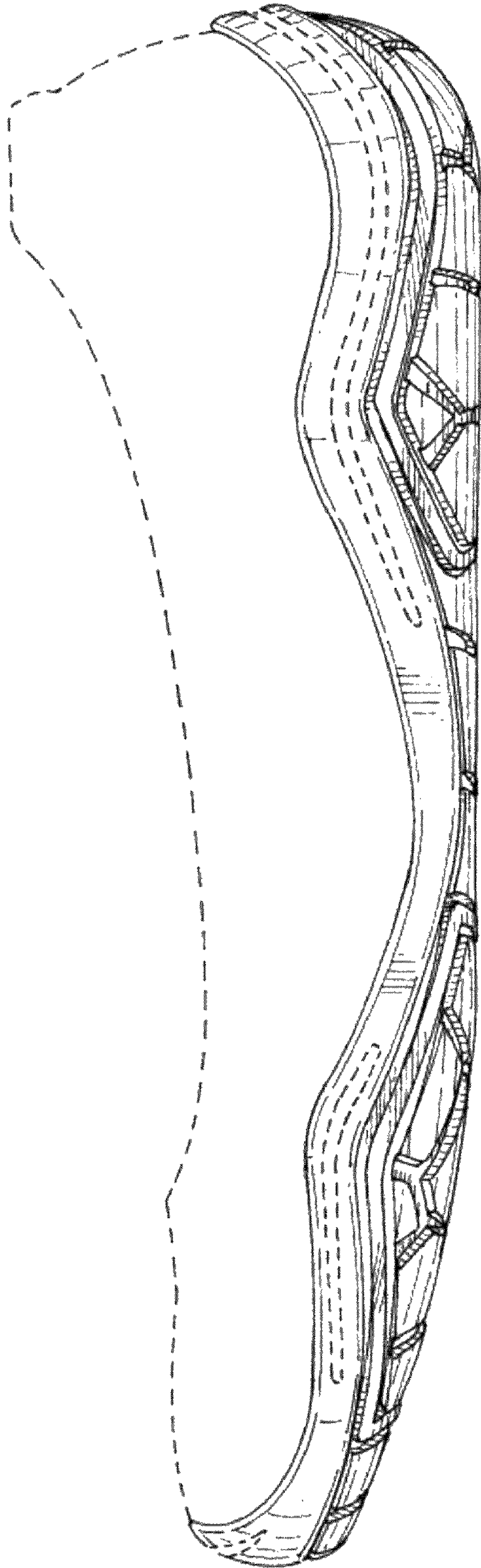
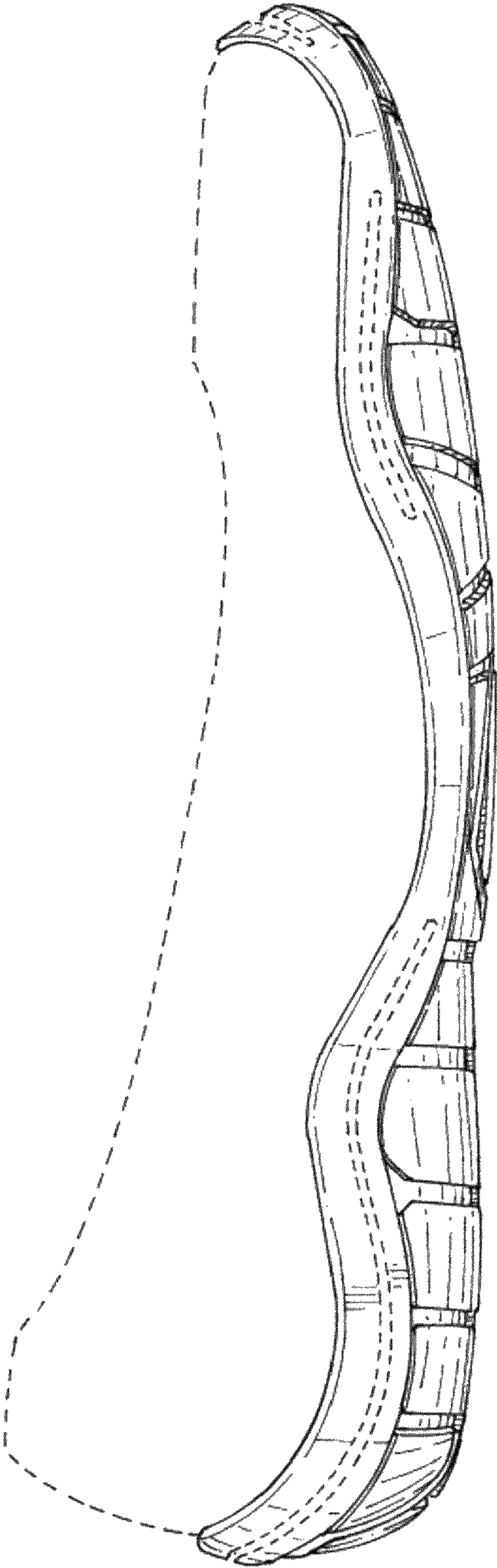

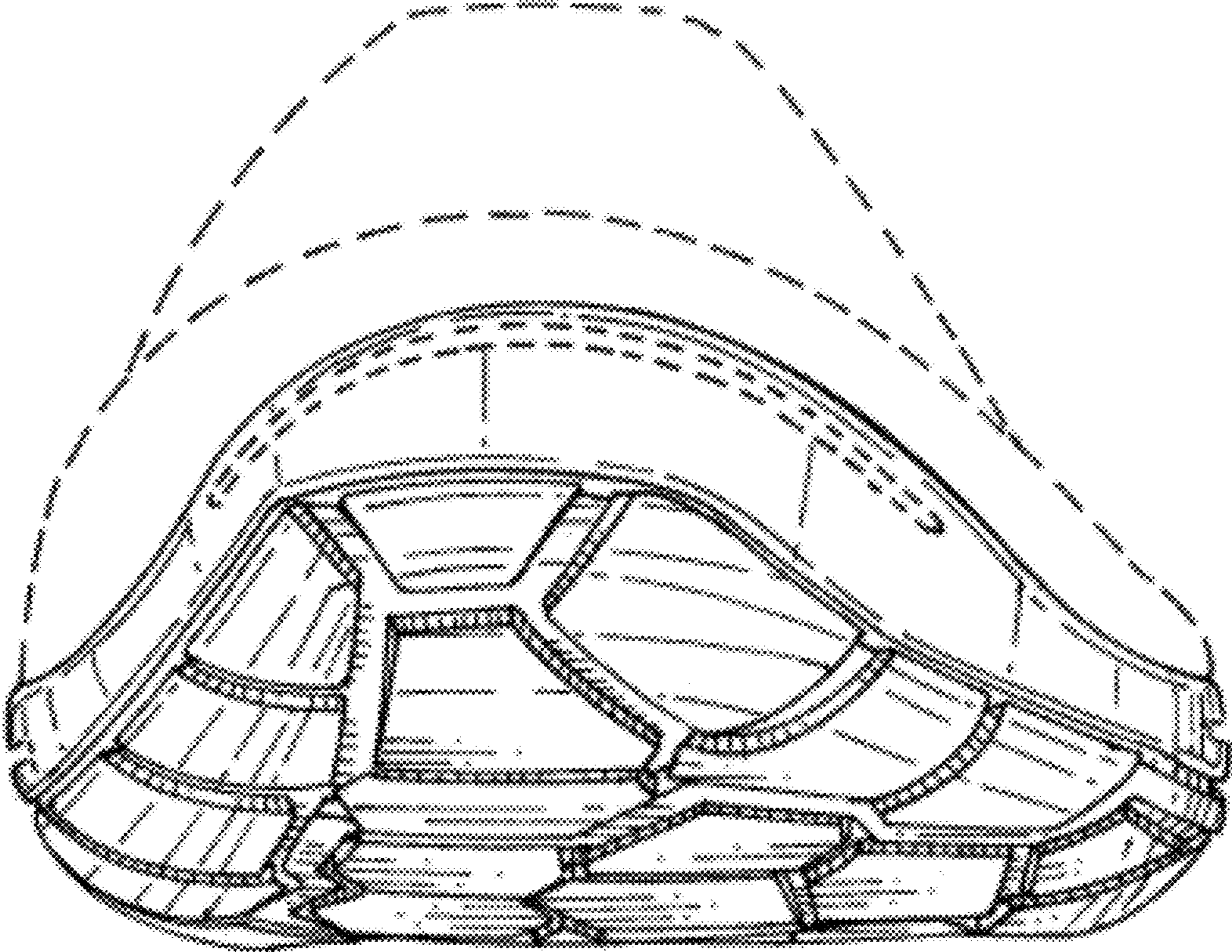

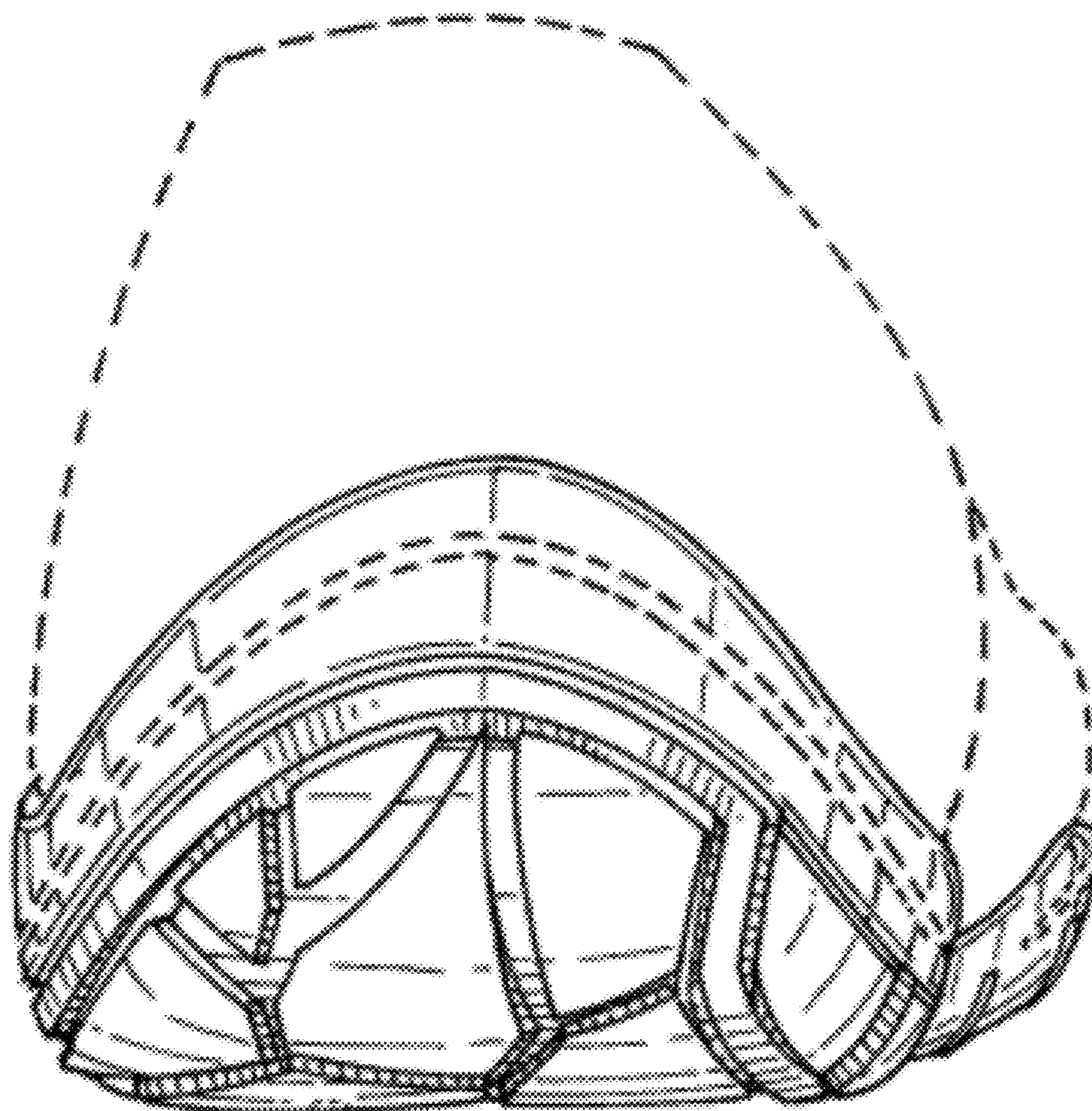
