(57) **CLAIM**

The ornamental design for a seat plate with a foldable leg rest, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a seat plate with a foldable leg rest, illustrated in an expanded configuration, showing my new design;

FIG. 2 is a front elevational view thereof, illustrated in the expanded configuration;

FIG. 3 is a rear elevational view thereof, illustrated in the expanded configuration;

FIG. 4 is a left side elevational view thereof, illustrated in the expanded configuration;

FIG. 5 is a right side elevational view thereof, illustrated in the expanded configuration;

FIG. 6 is a top plan view thereof, illustrated in the expanded configuration;

FIG. 7 is a bottom plan view thereof, illustrated in the expanded configuration;

FIG. 8 is a perspective view thereof, illustrated in a collapsed configuration; and,

FIG. 9 is a perspective view thereof, illustrated in another collapsed configuration.

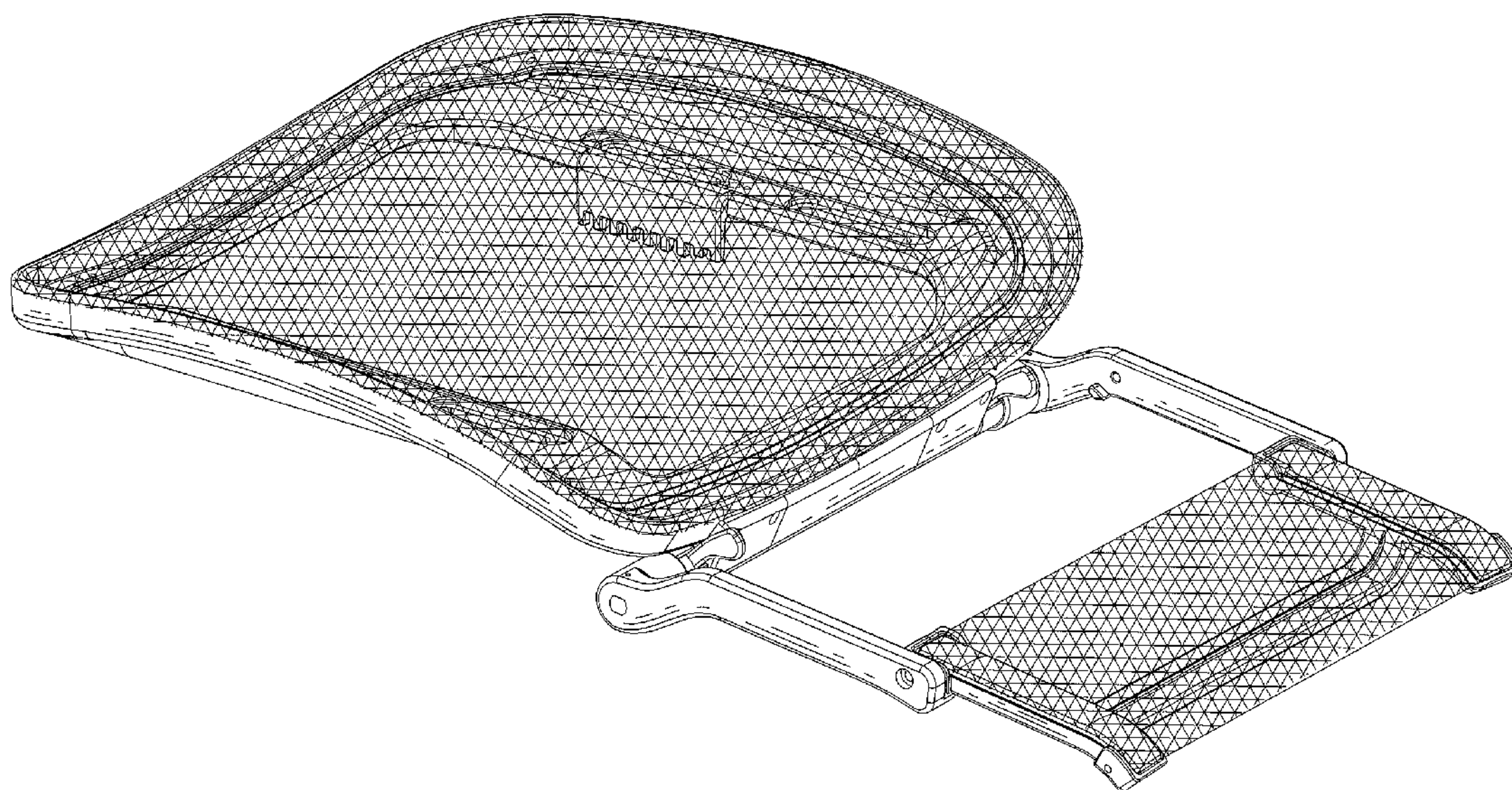

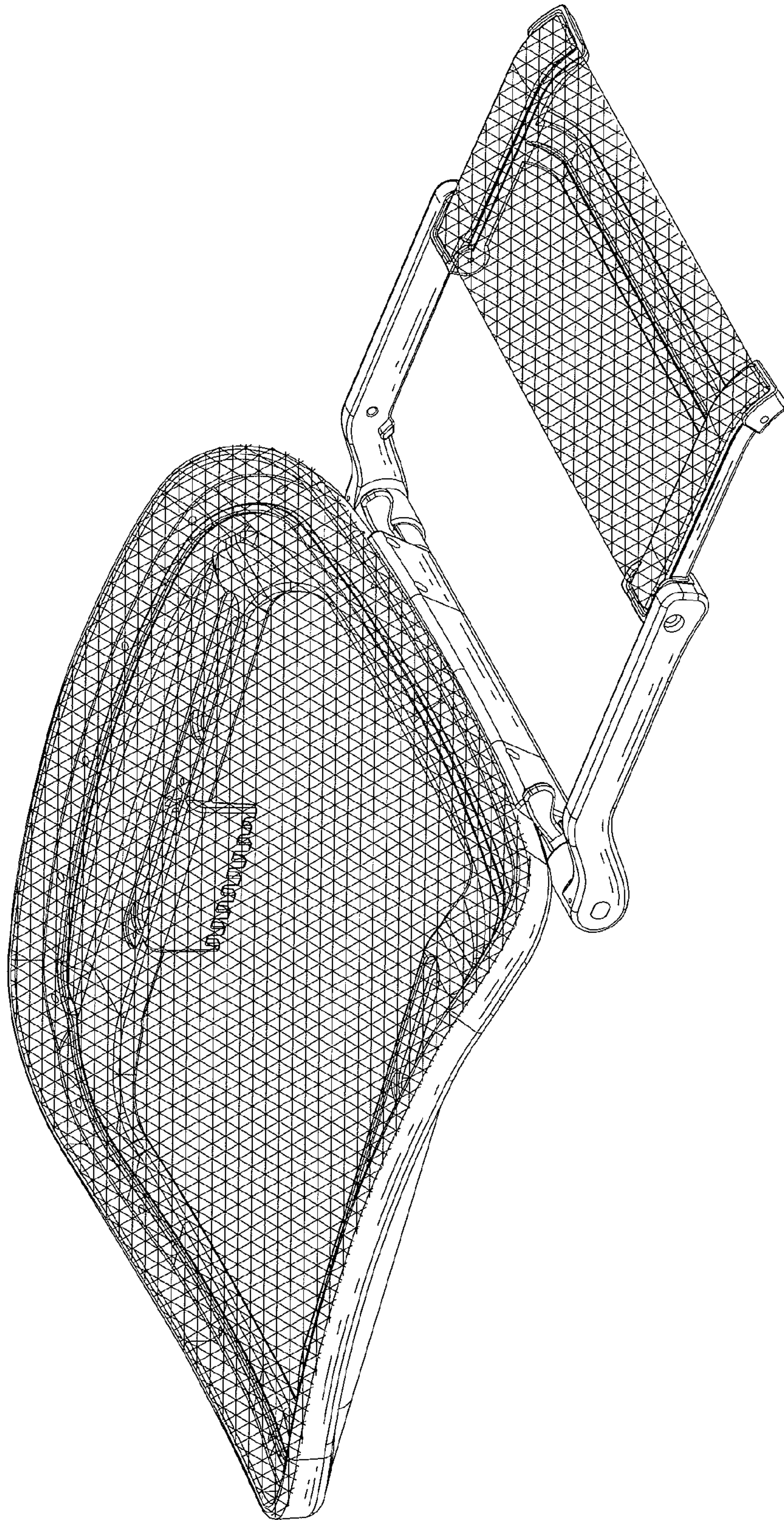

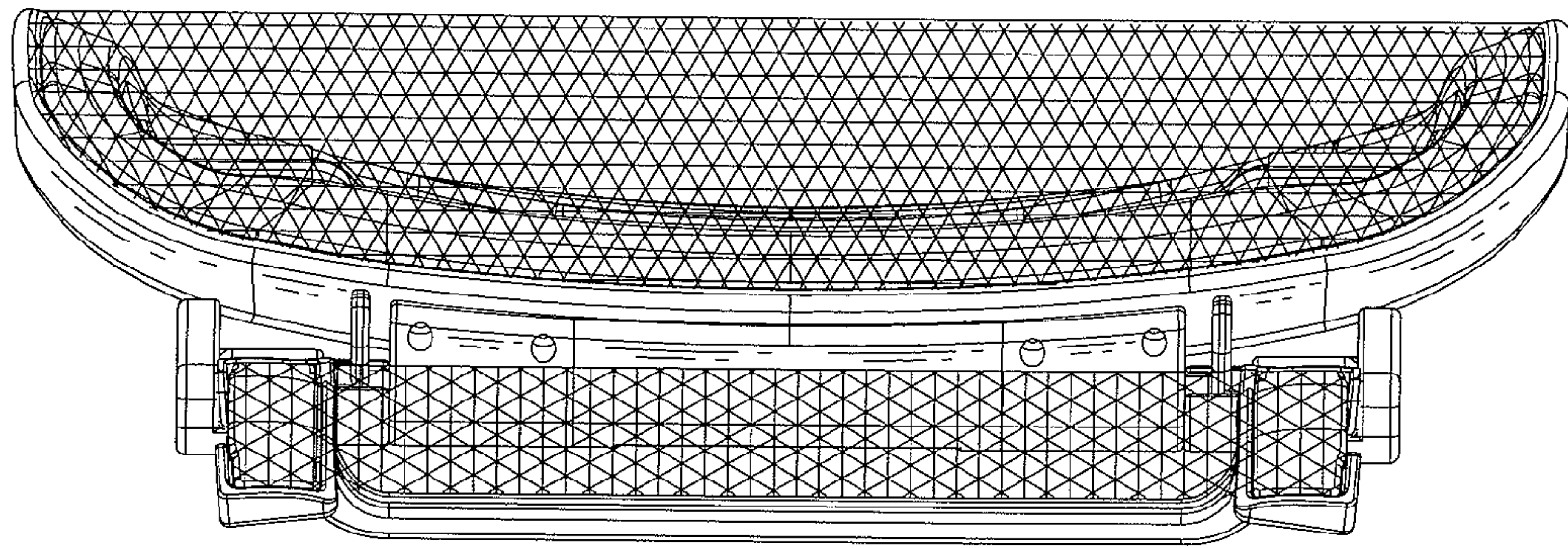

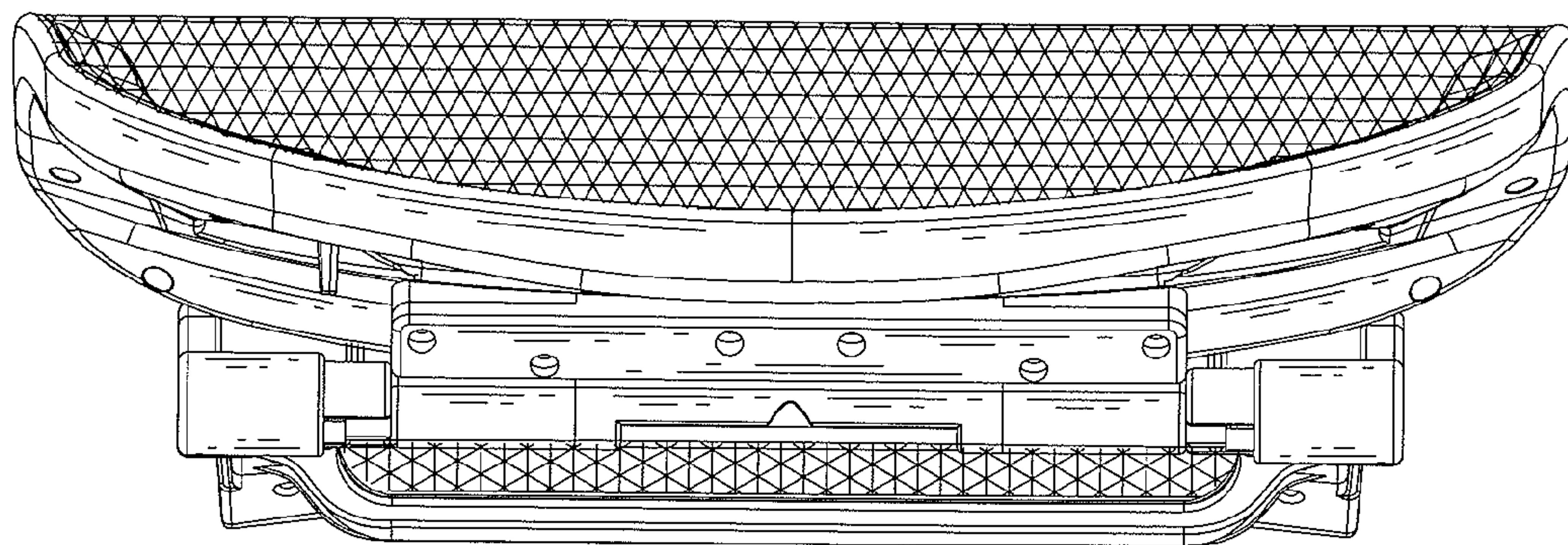

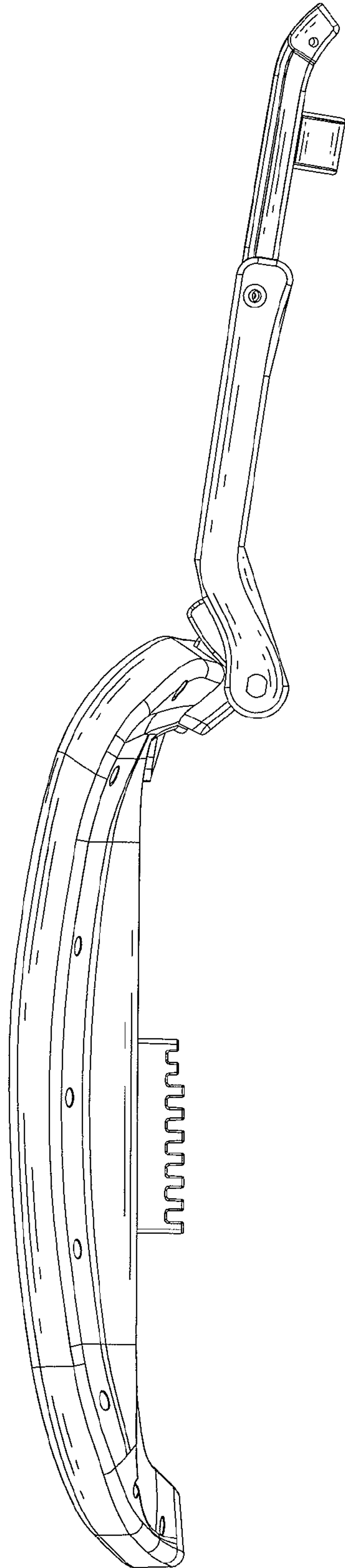

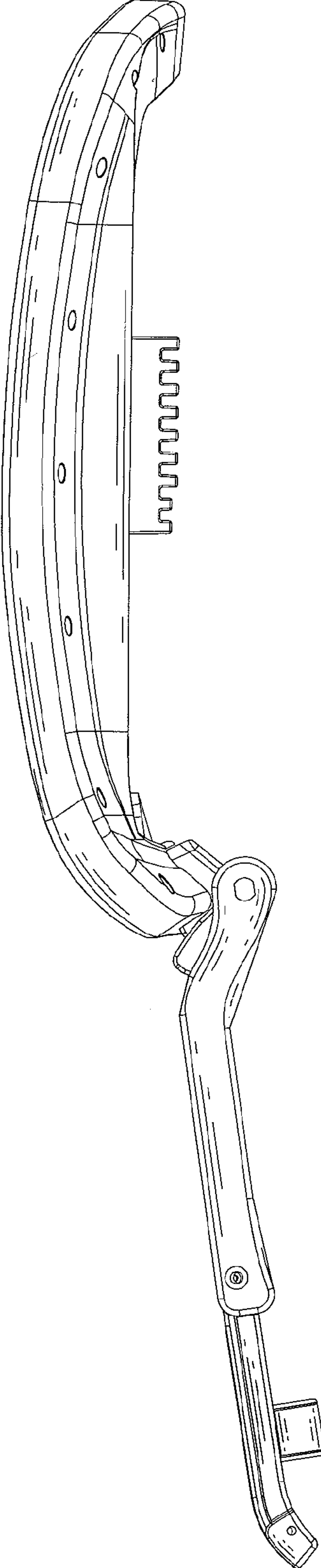

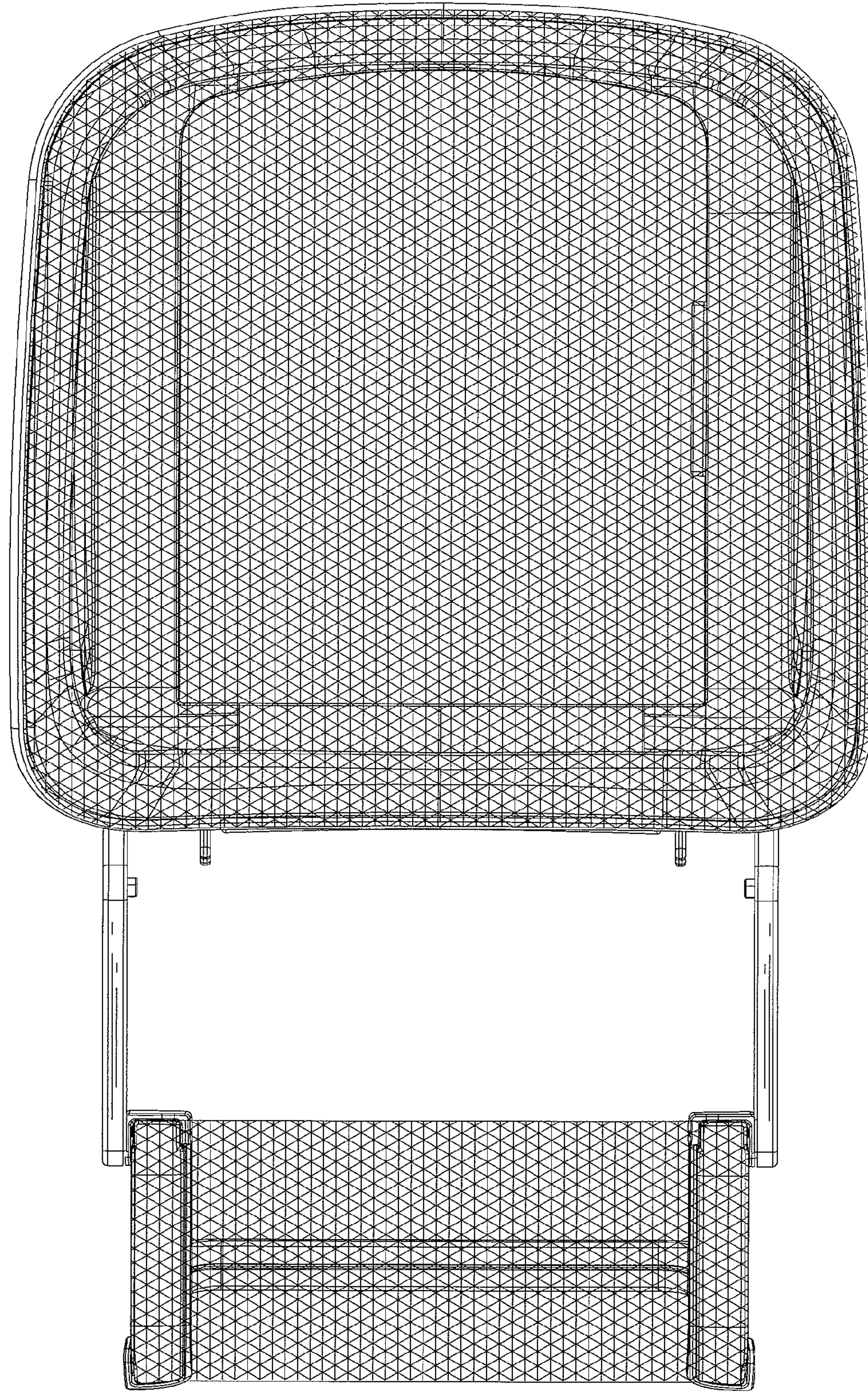

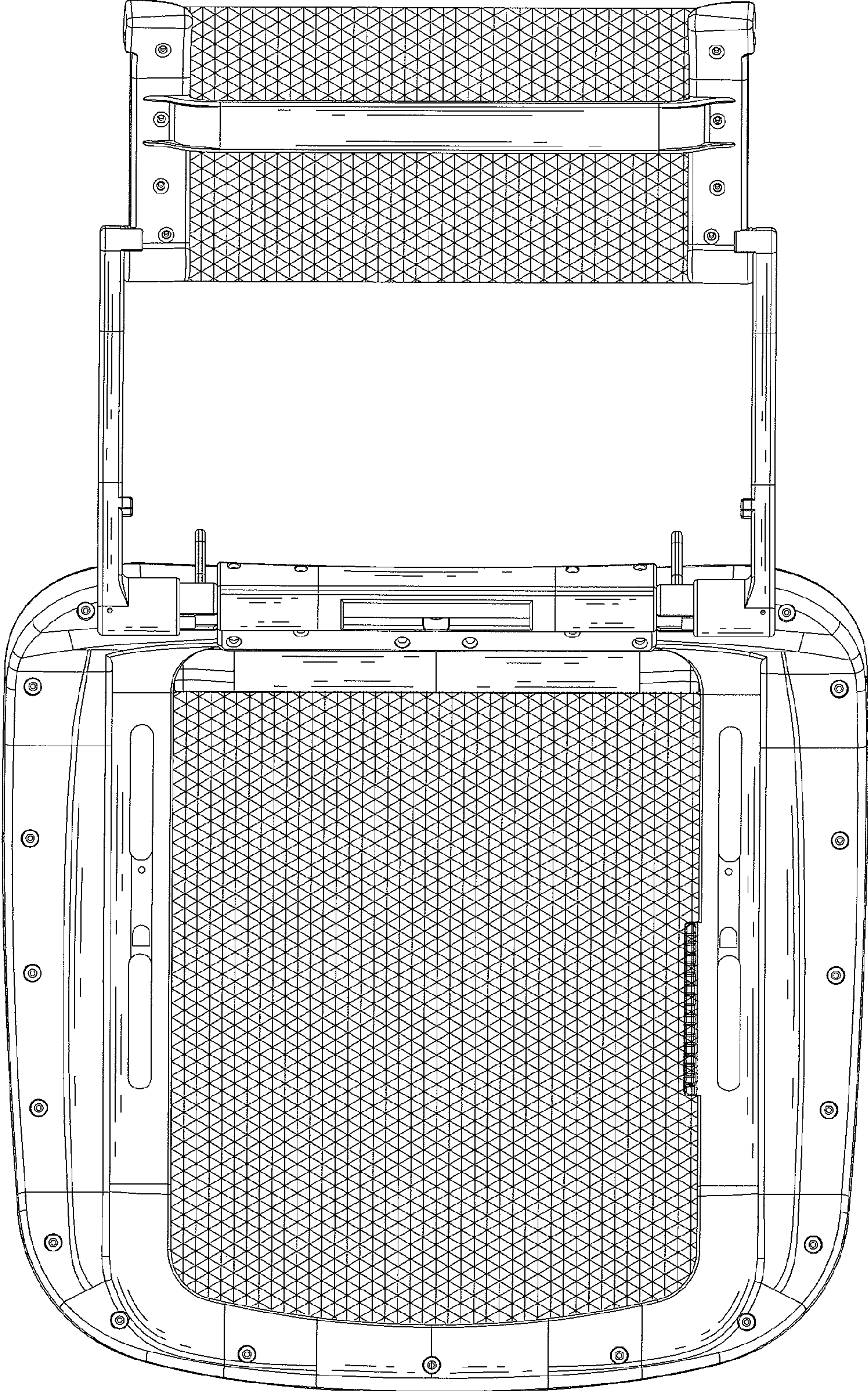

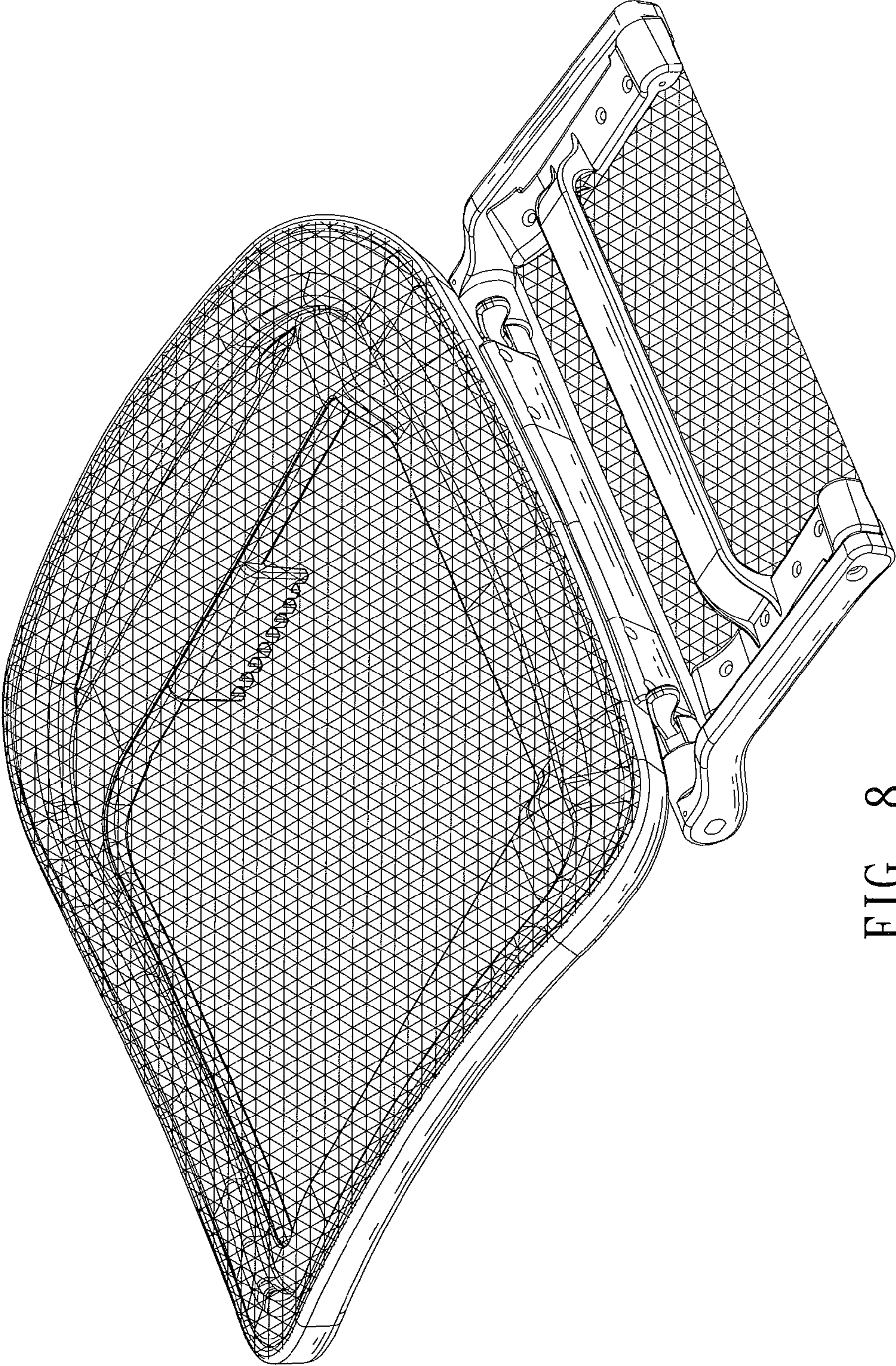

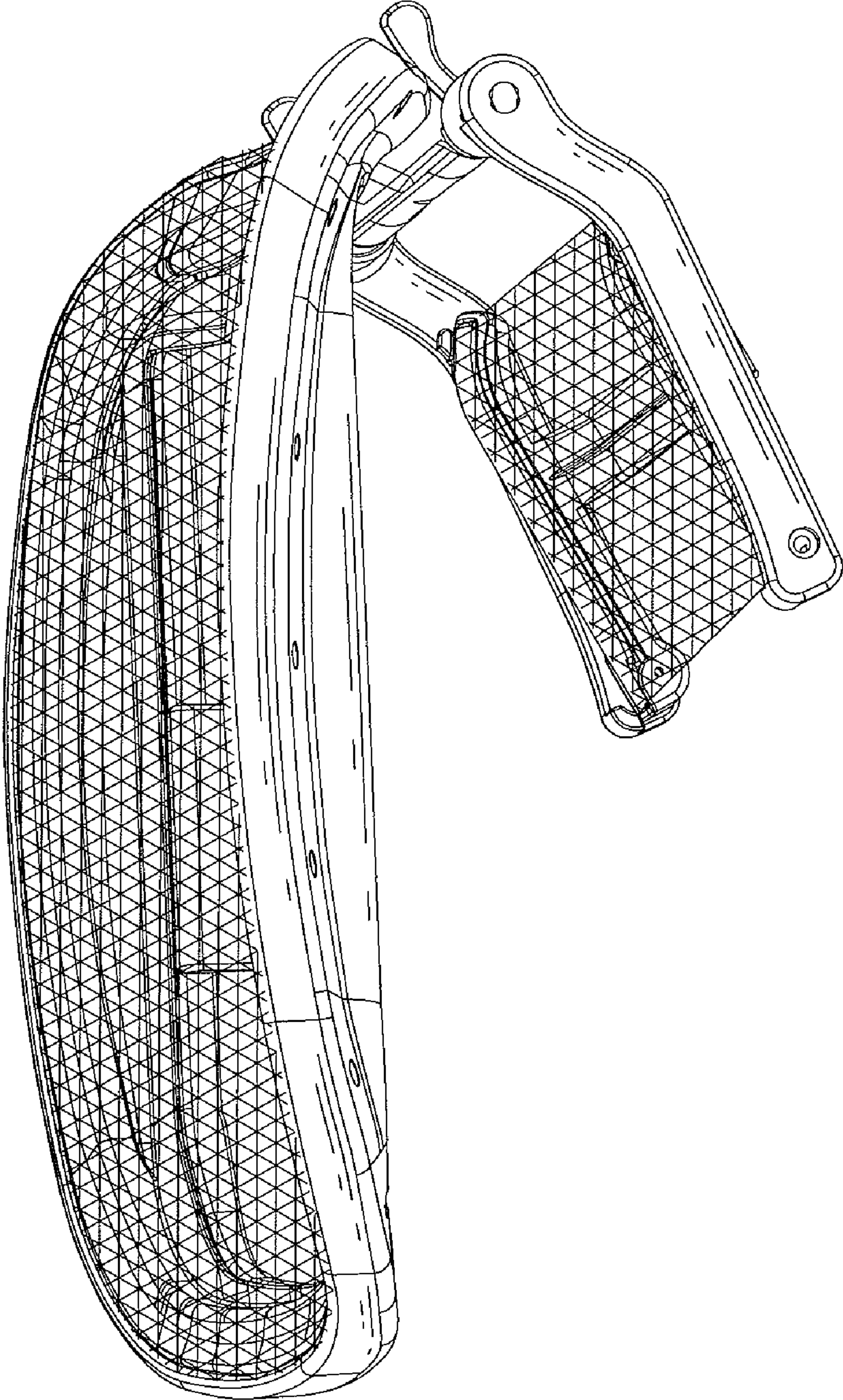
