(57) **CLAIM**

The ornamental designs for a mattress with horizontal handles, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the mattress with horizontal handles.

FIG. 2 is a side view of the mattress with horizontal handles of FIG. 1, which is identical to the opposite side view thereof.

FIG. 3 is an end view of the mattress with horizontal handles of FIG. 1, which is identical to the opposite end view thereof.

FIG. 4 is a top view of the mattress with horizontal handles of FIG. 1.

FIG. 5 is a bottom view of the mattress with horizontal handles of FIG. 1.

FIG. 6 is a perspective view of a second embodiment of the mattress with horizontal handles.

FIG. 7 is a side view of the mattress with horizontal handles of FIG. 6, which is identical to the opposite side view thereof.

FIG. 8 is an end view of the mattress with horizontal handles of FIG. 6, which is identical to the opposite end view thereof.

FIG. 9 is a top view of the mattress with horizontal handles of FIG. 6.

FIG. 10 is a bottom view of the mattress with horizontal handles of FIG. 6.

FIG. 11 is a perspective view of a third embodiment of the mattress with horizontal handles.

FIG. 12 is a side view of the mattress with horizontal handles of FIG. 11, which is identical to the opposite side view thereof.

FIG. 13 is an end view of the mattress with horizontal handles of FIG. 11, which is identical to the opposite end view thereof.

FIG. 14 is a top view of the mattress with horizontal handles of FIG. 11.

FIG. 15 is a bottom view of the mattress with horizontal handles of FIG. 11.

FIG. 16 is a perspective view of a fourth embodiment of the mattress with horizontal handles.

FIG. 17 is a side view of the mattress with horizontal handles of FIG. 16.

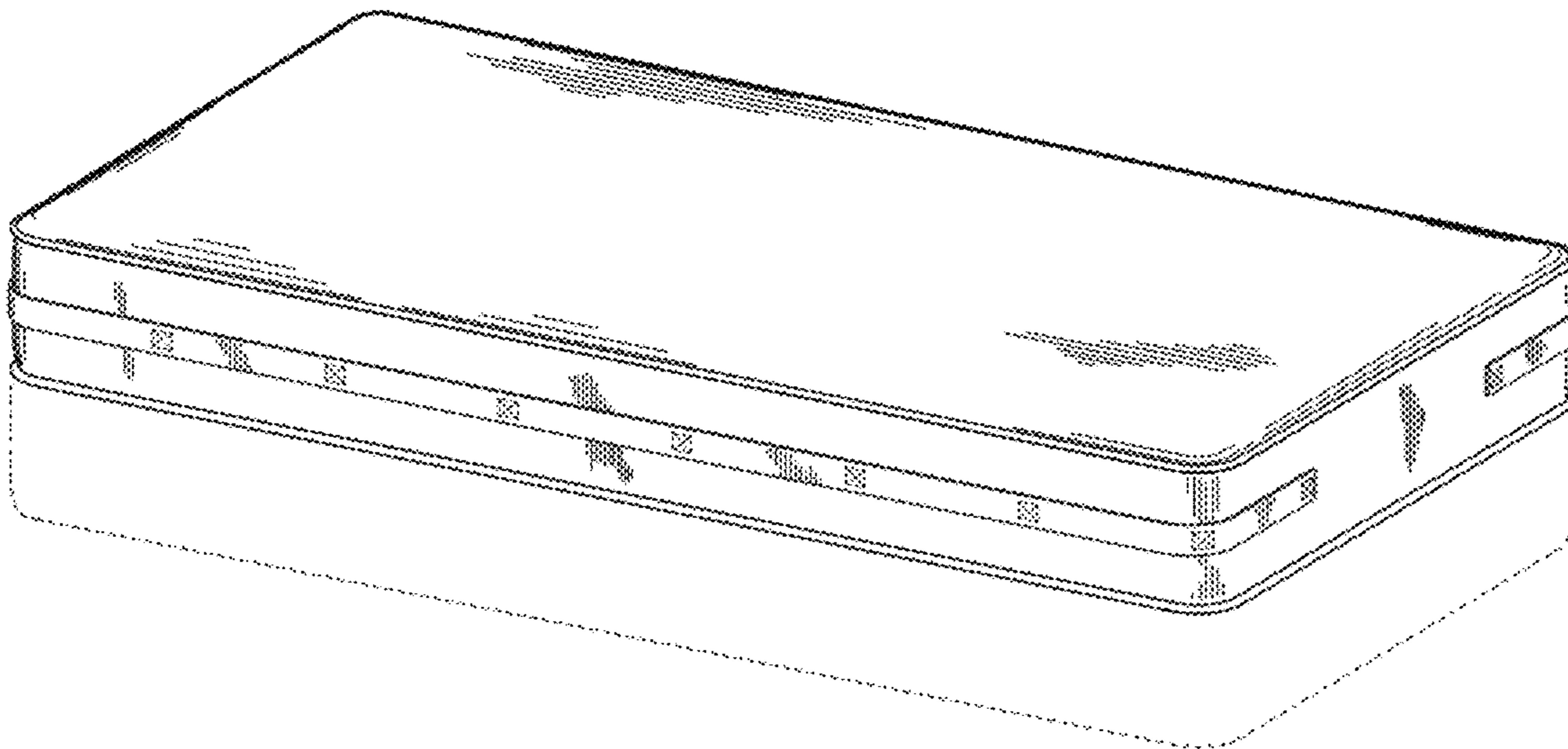
FIG. 18 is an end view of the mattress with horizontal handles of FIG. 16.

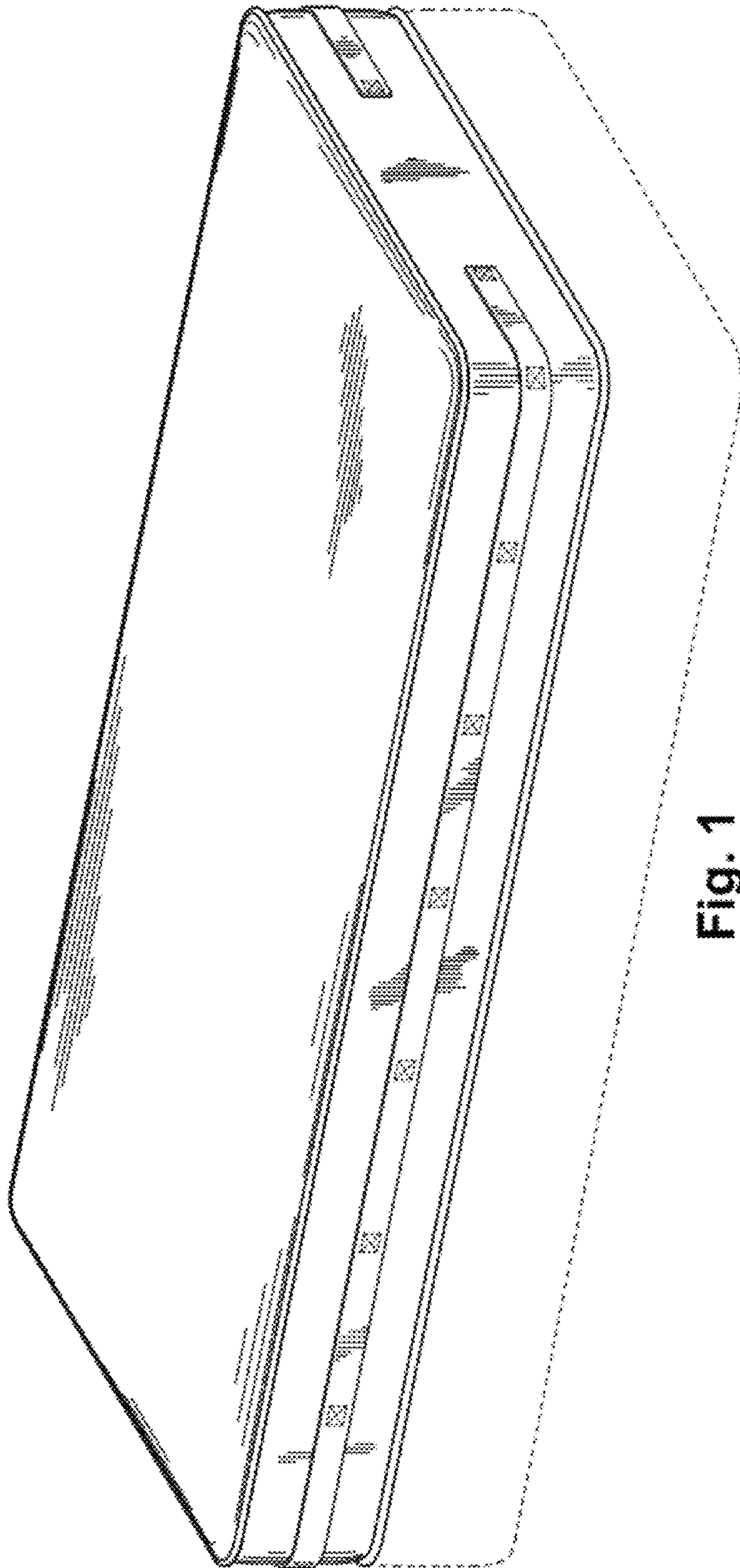

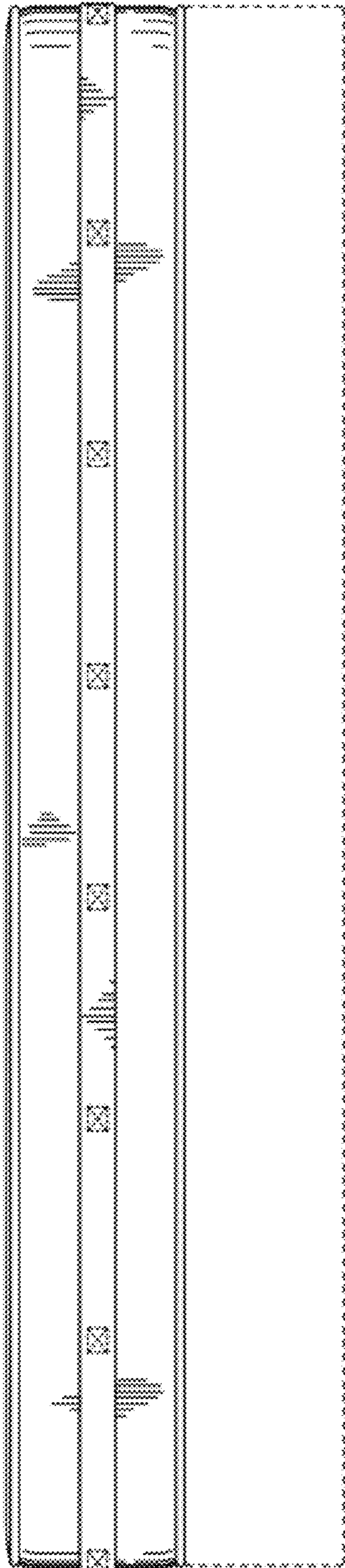

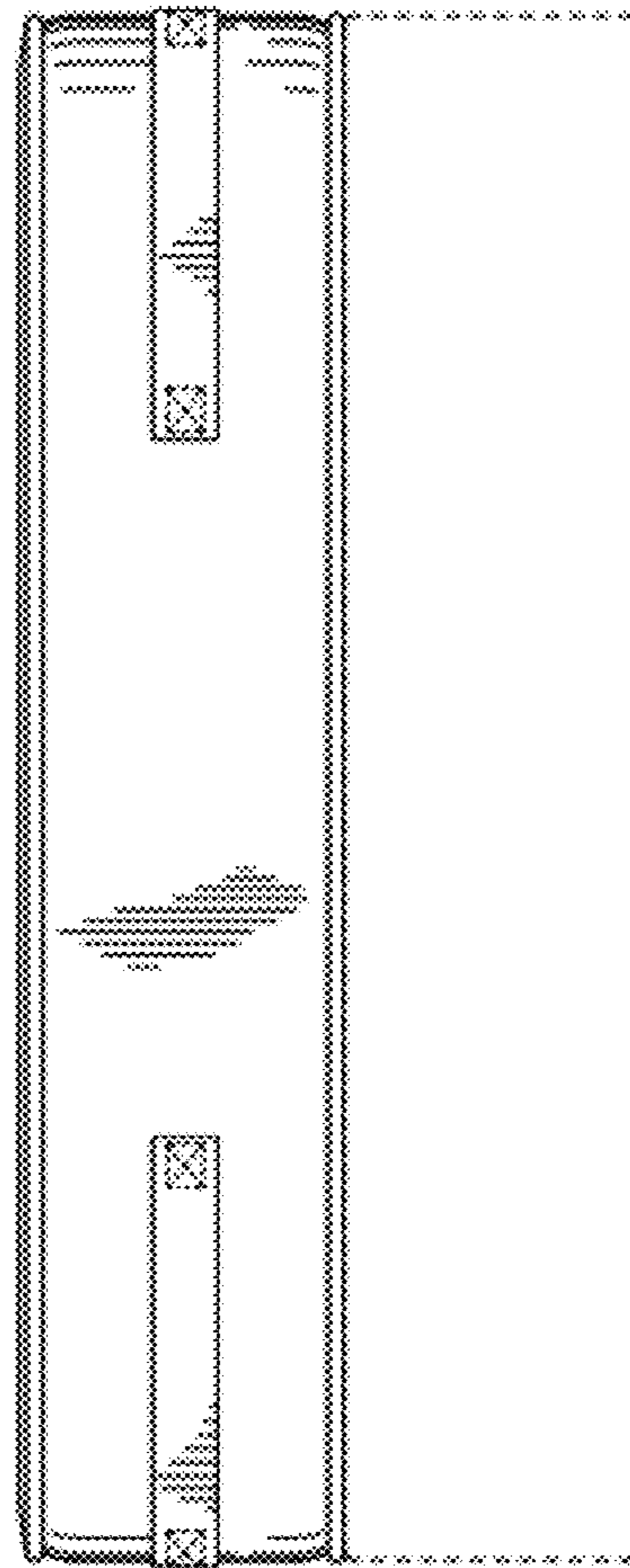

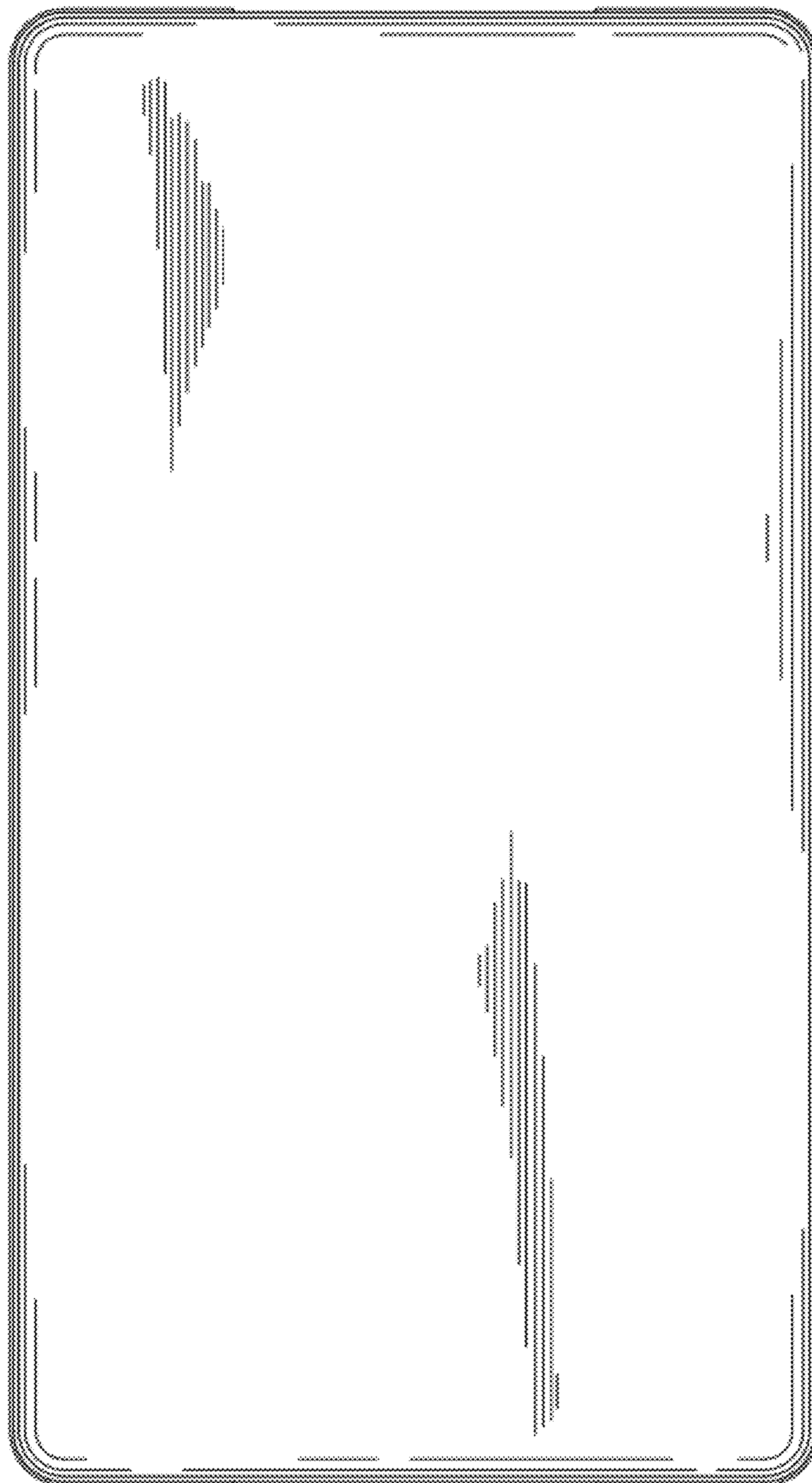

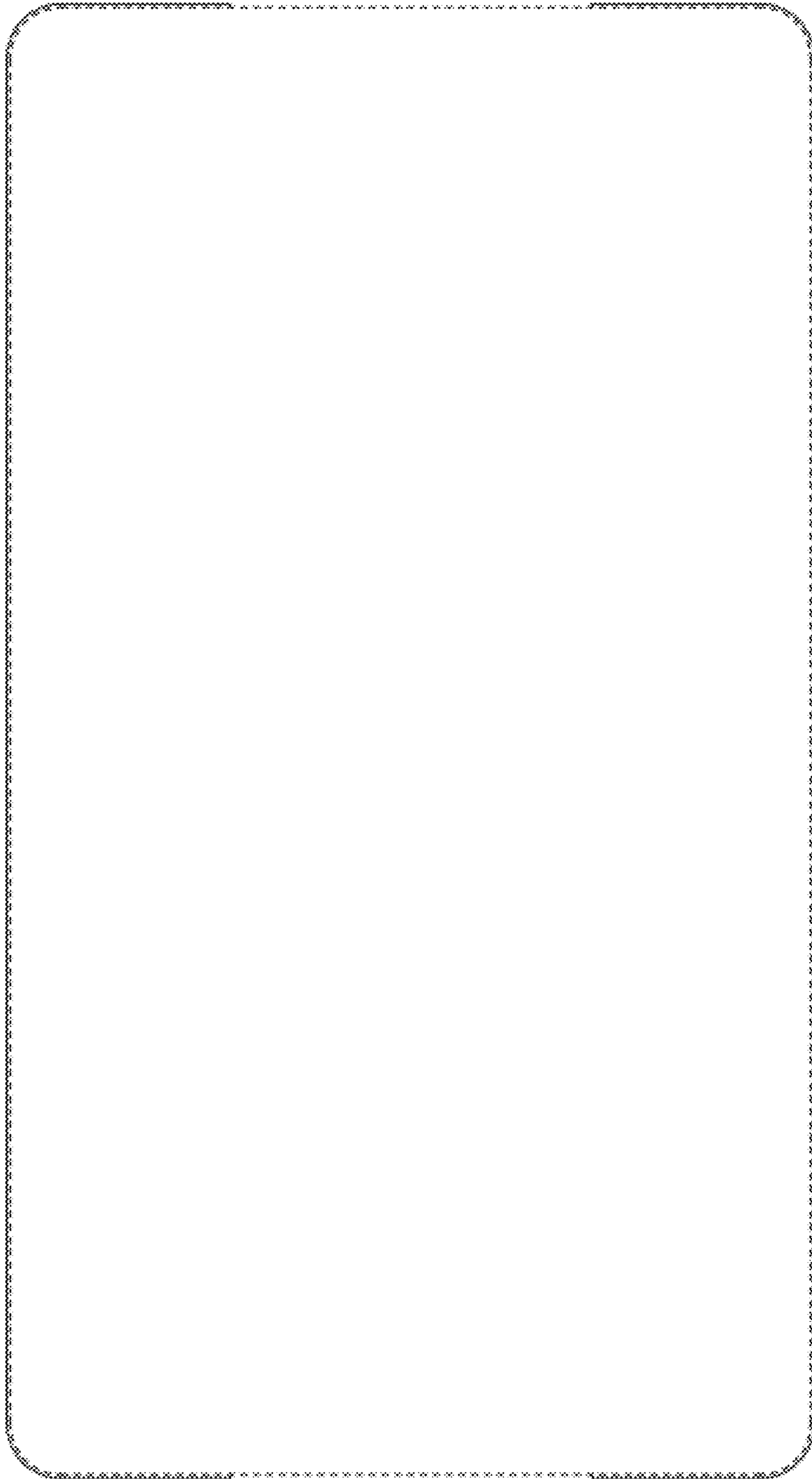

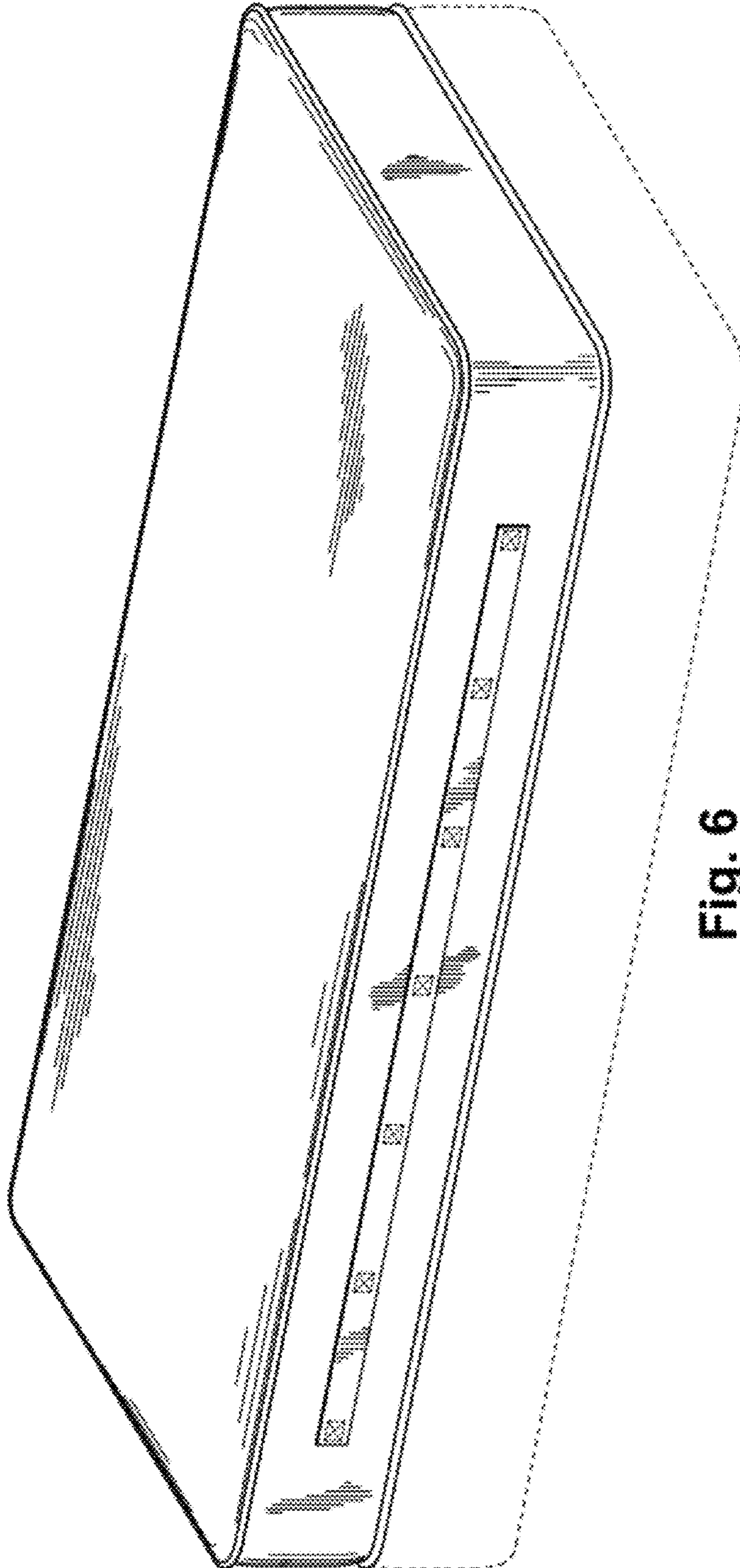

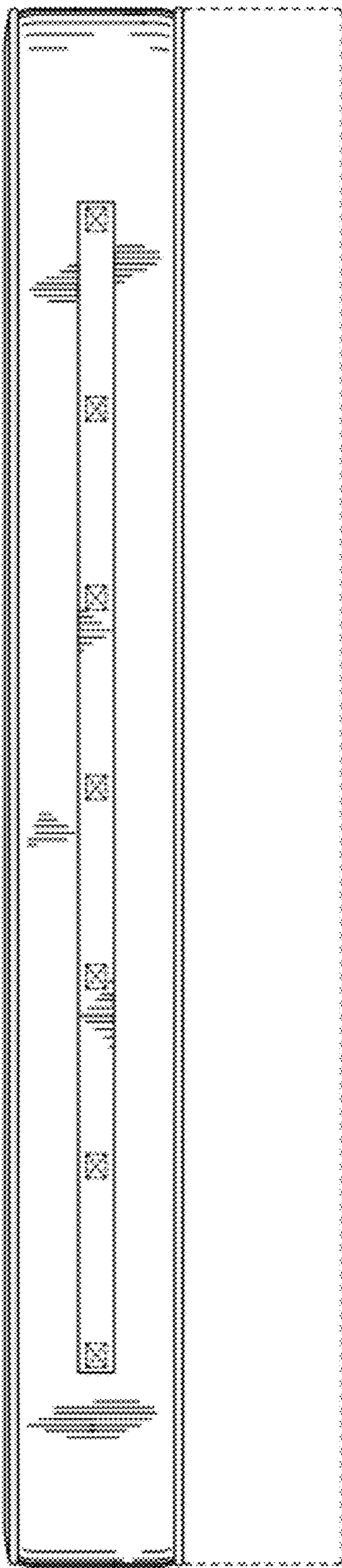

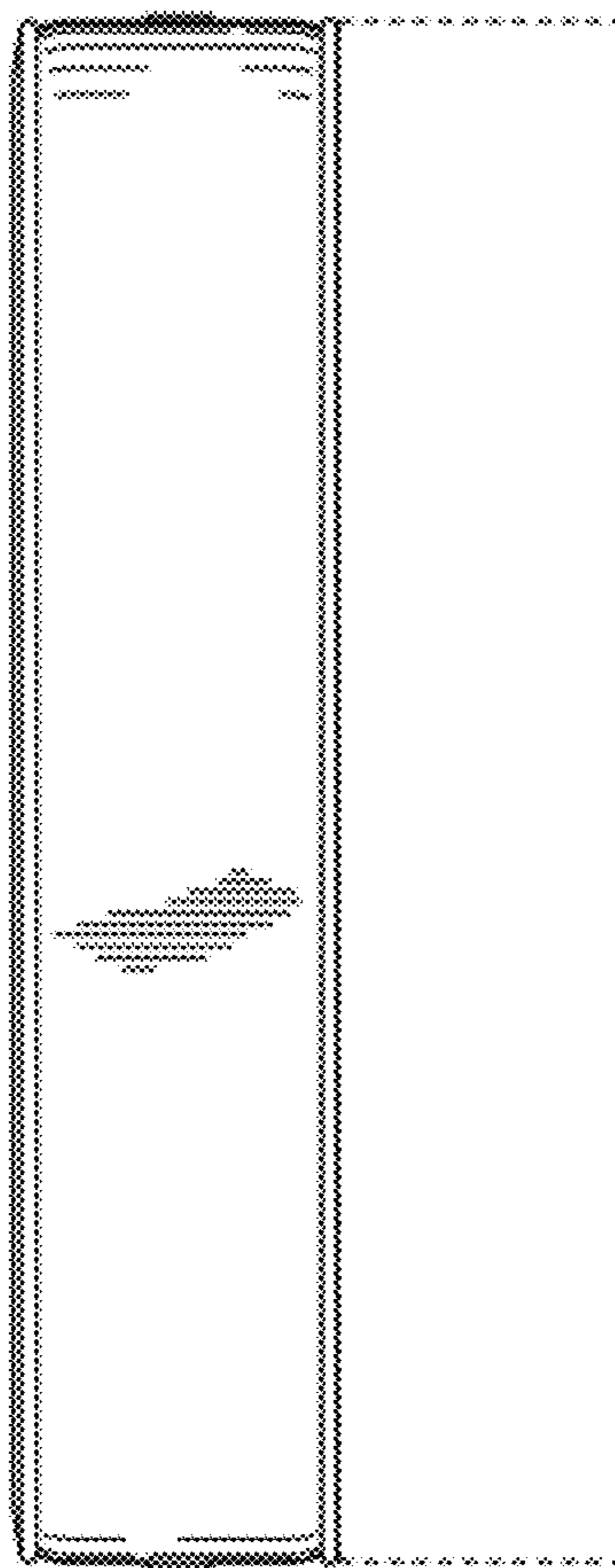

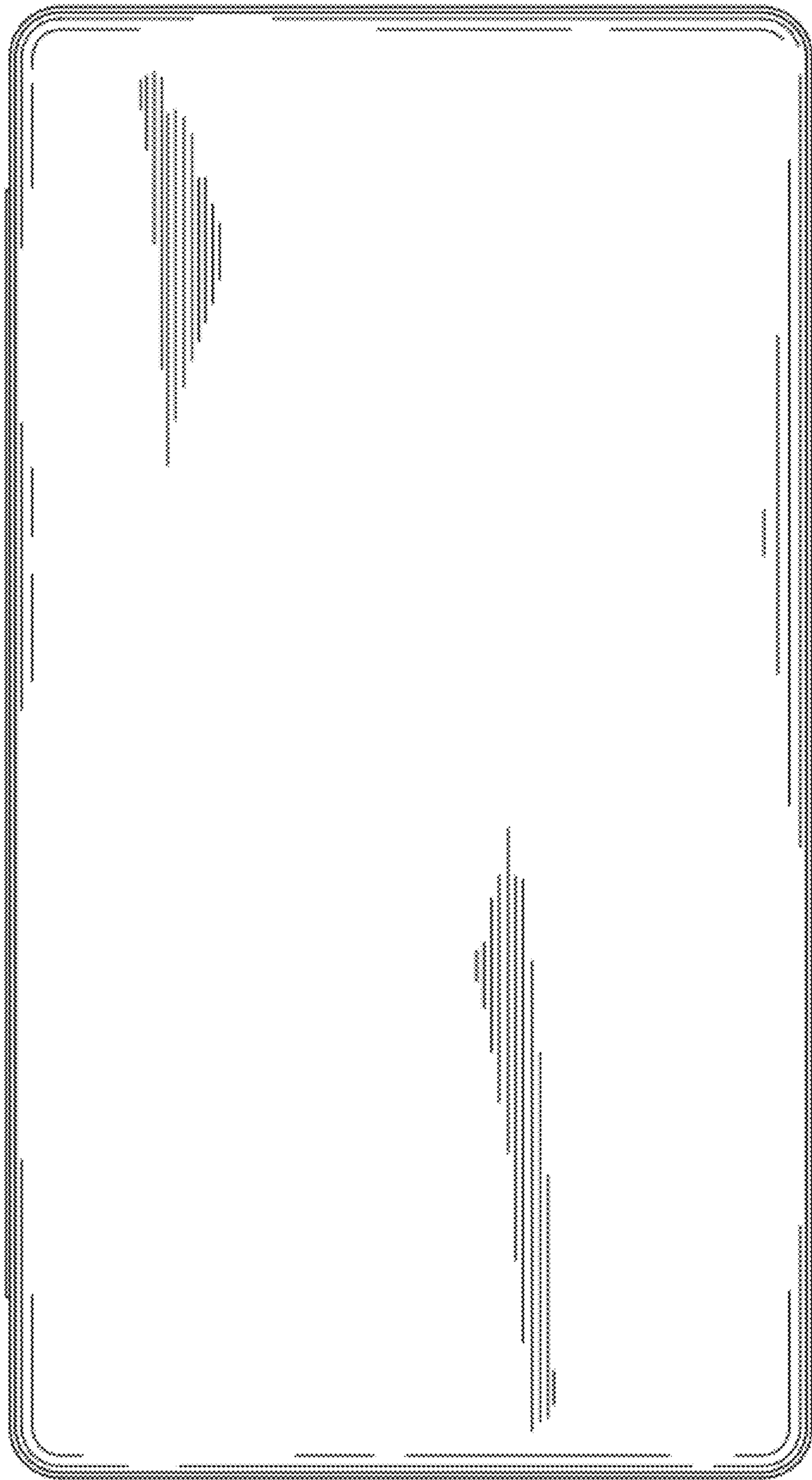

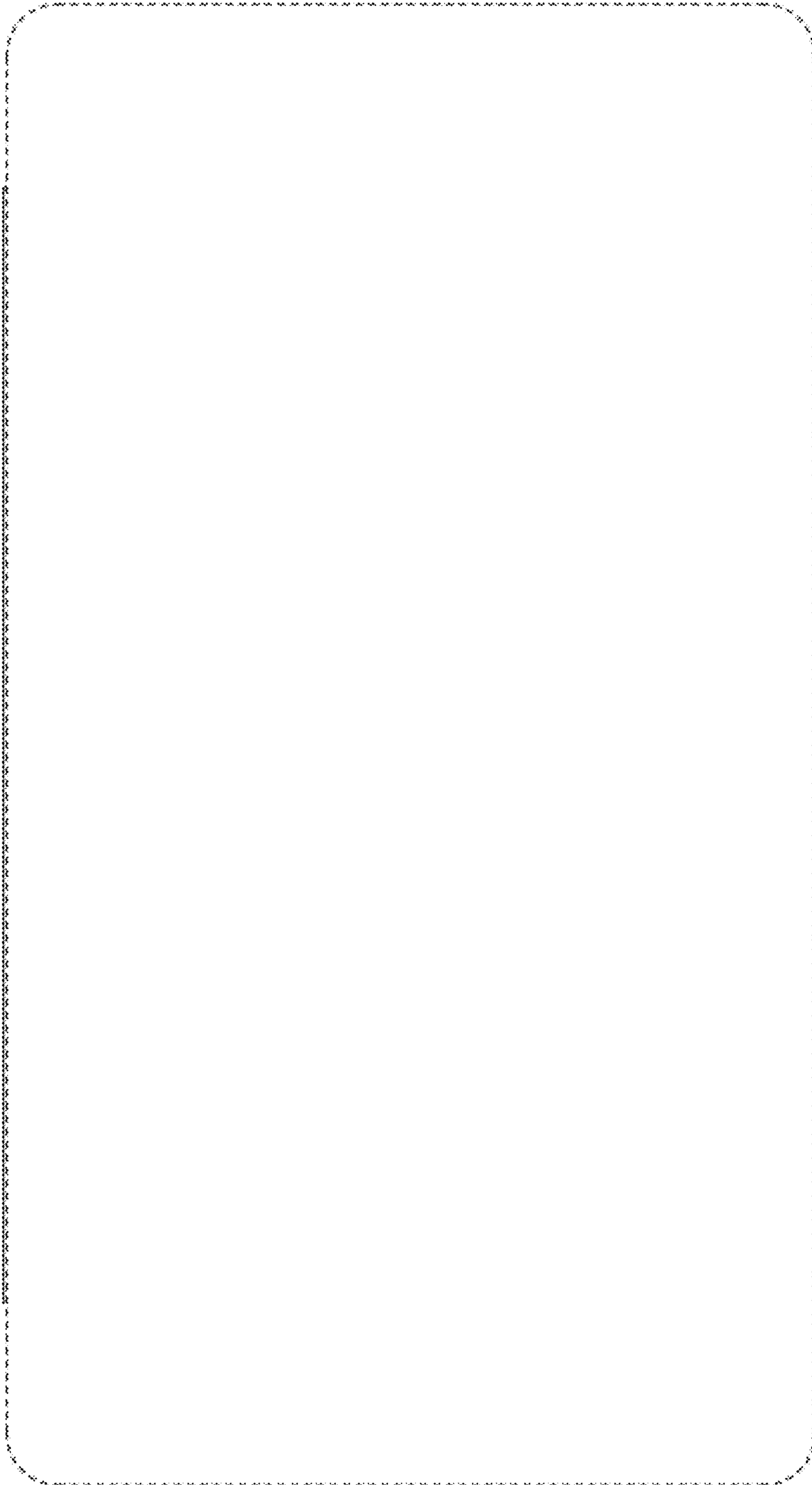

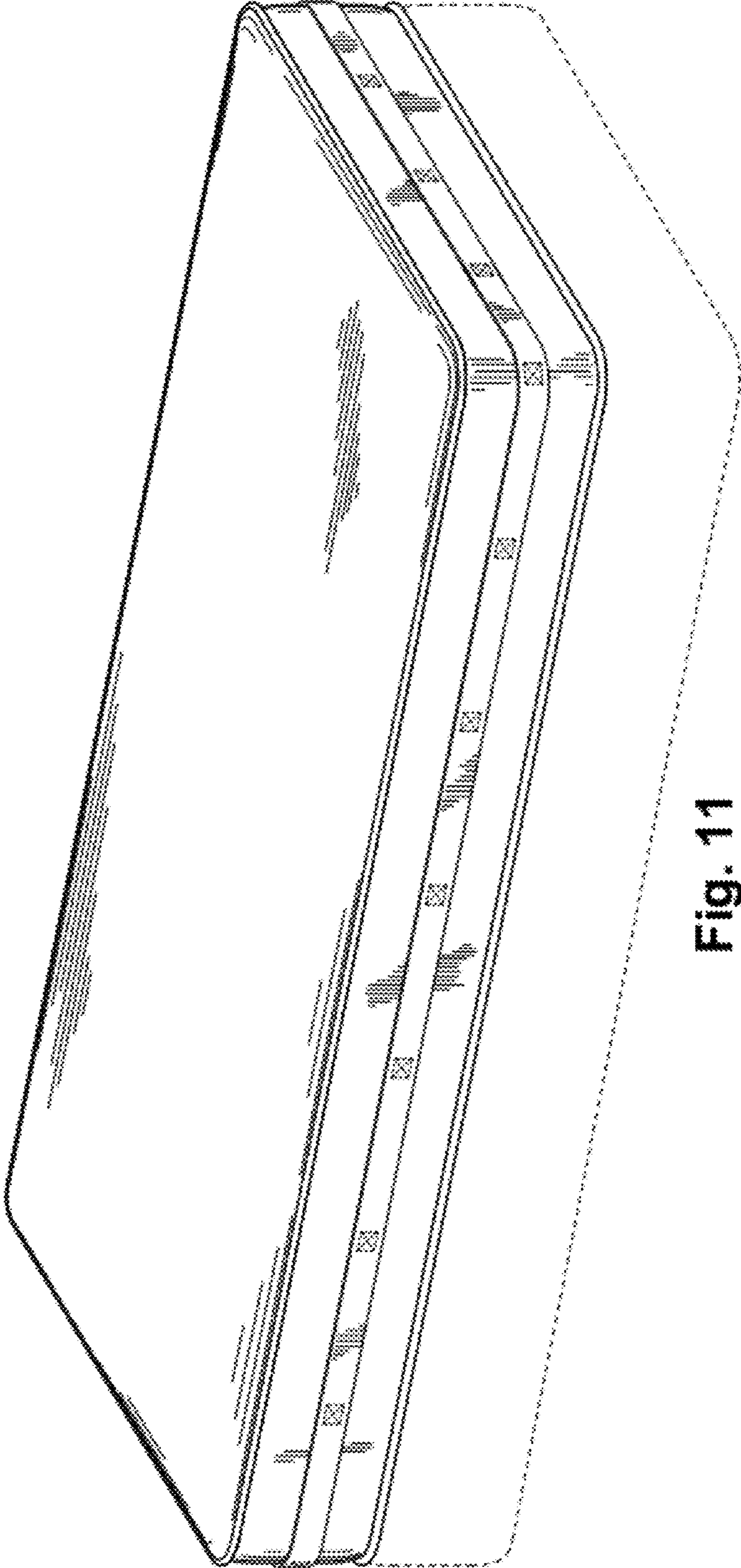

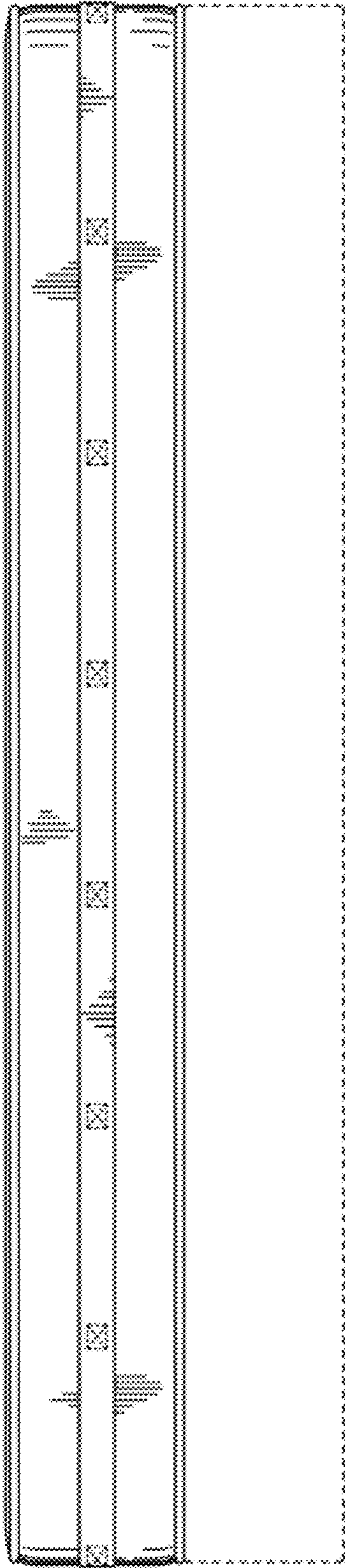

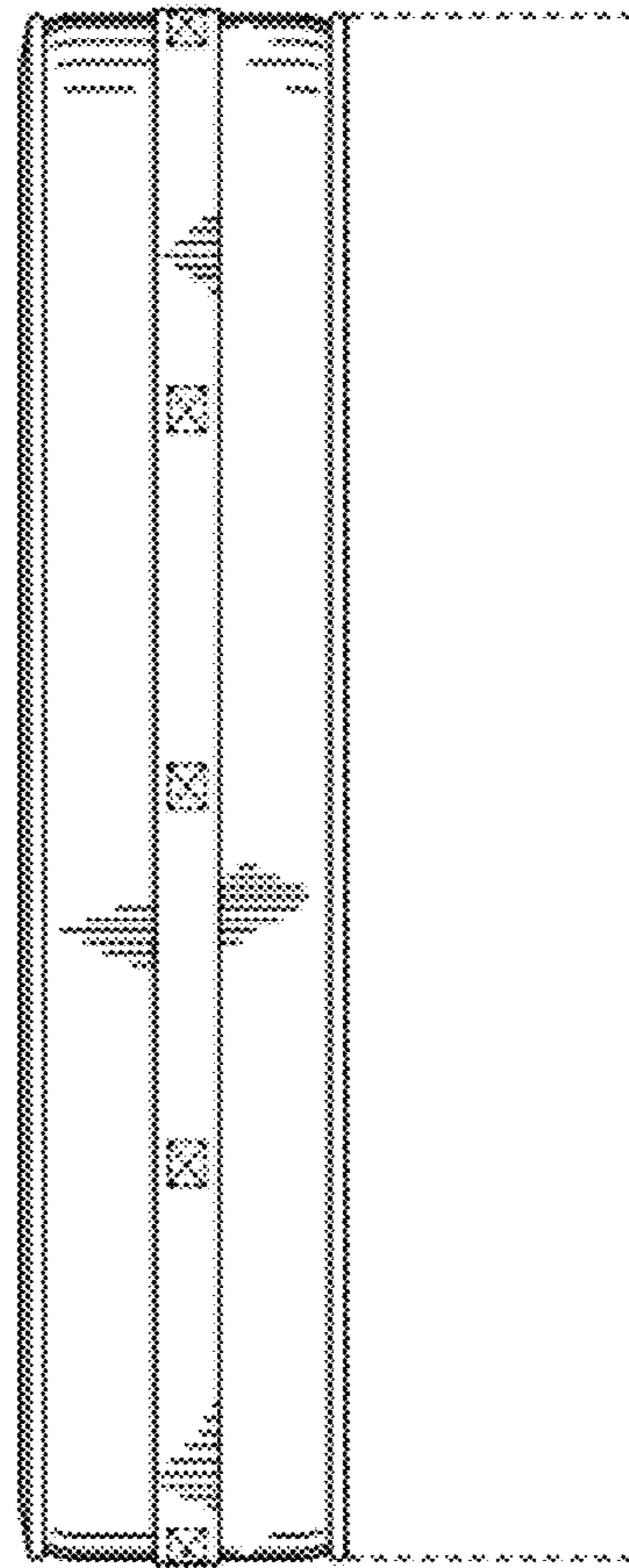

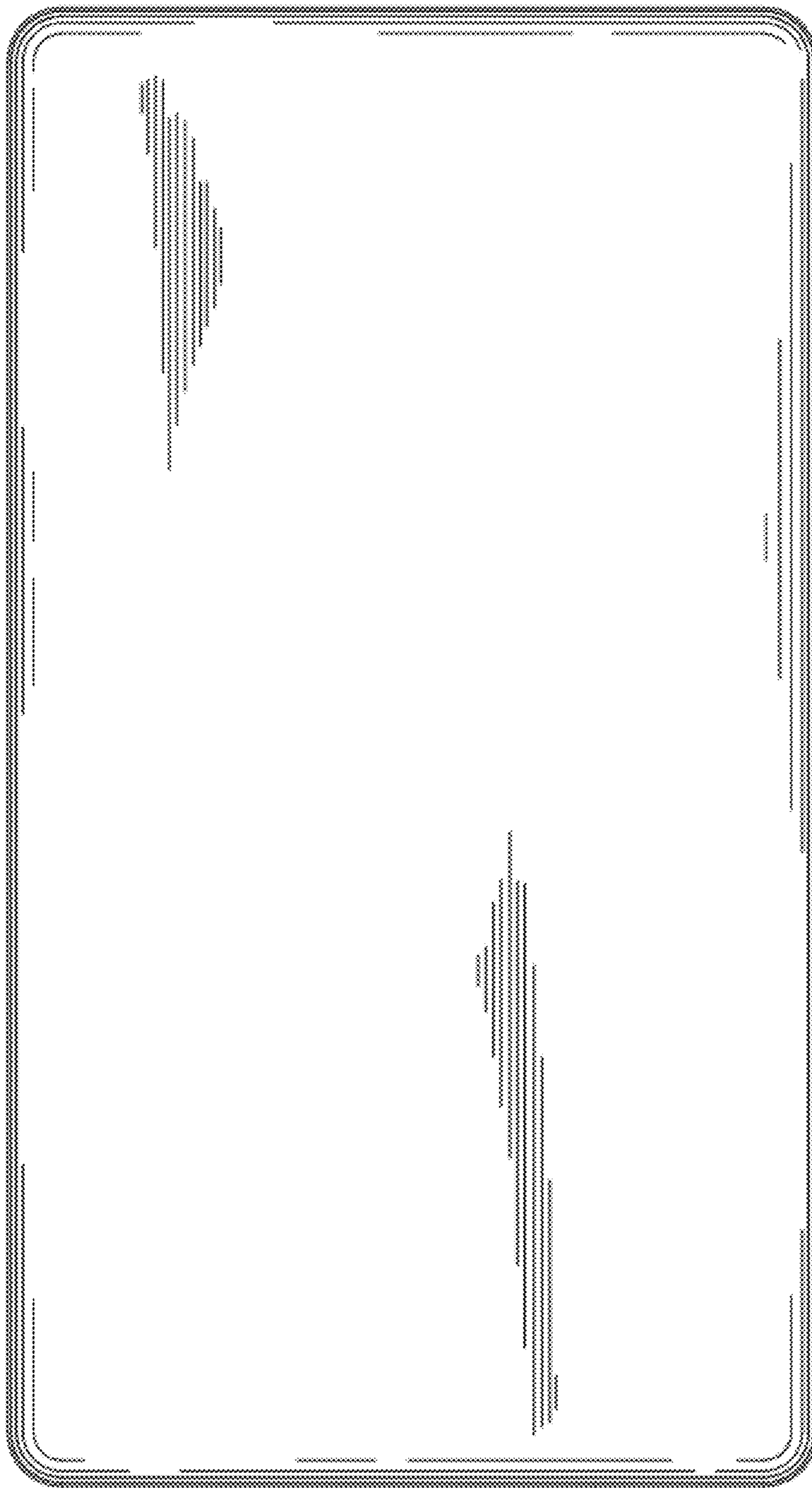

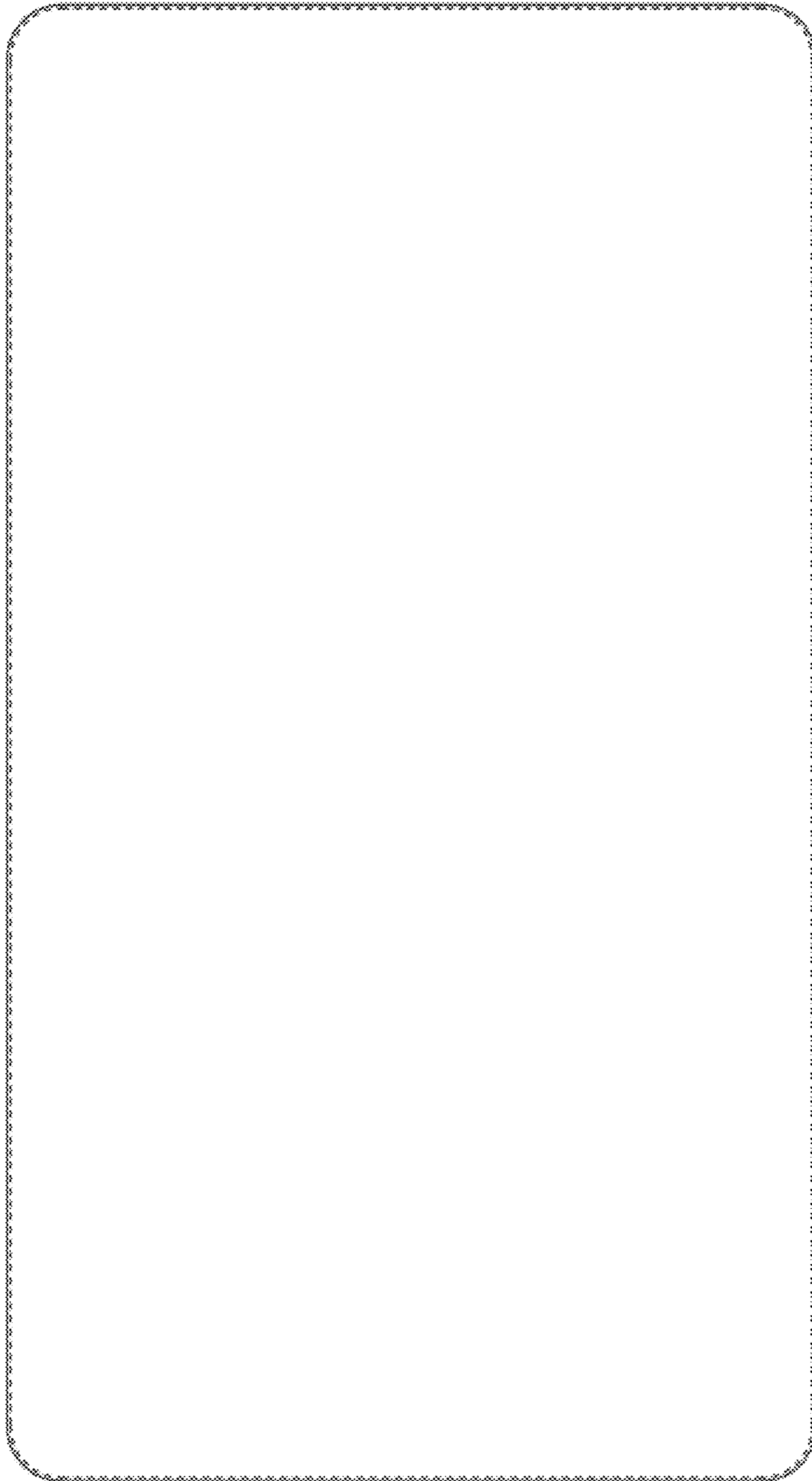

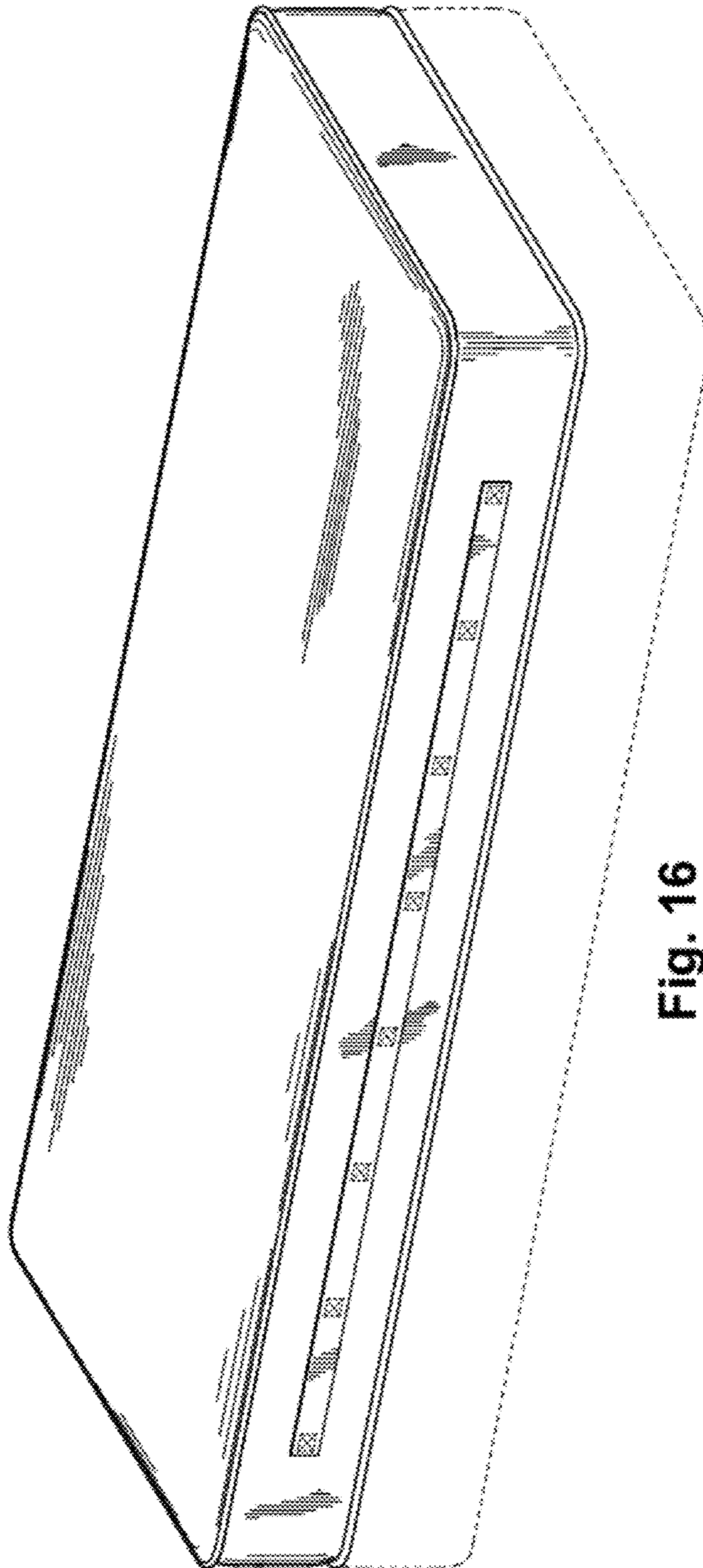

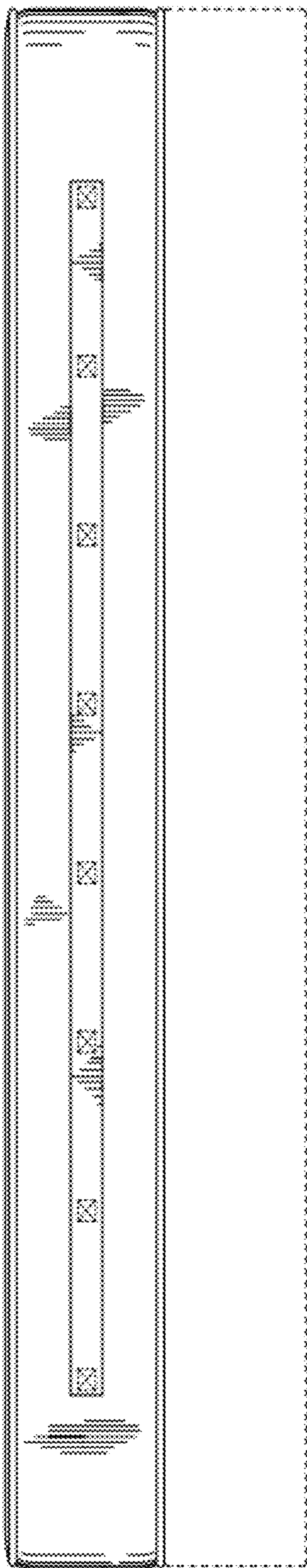

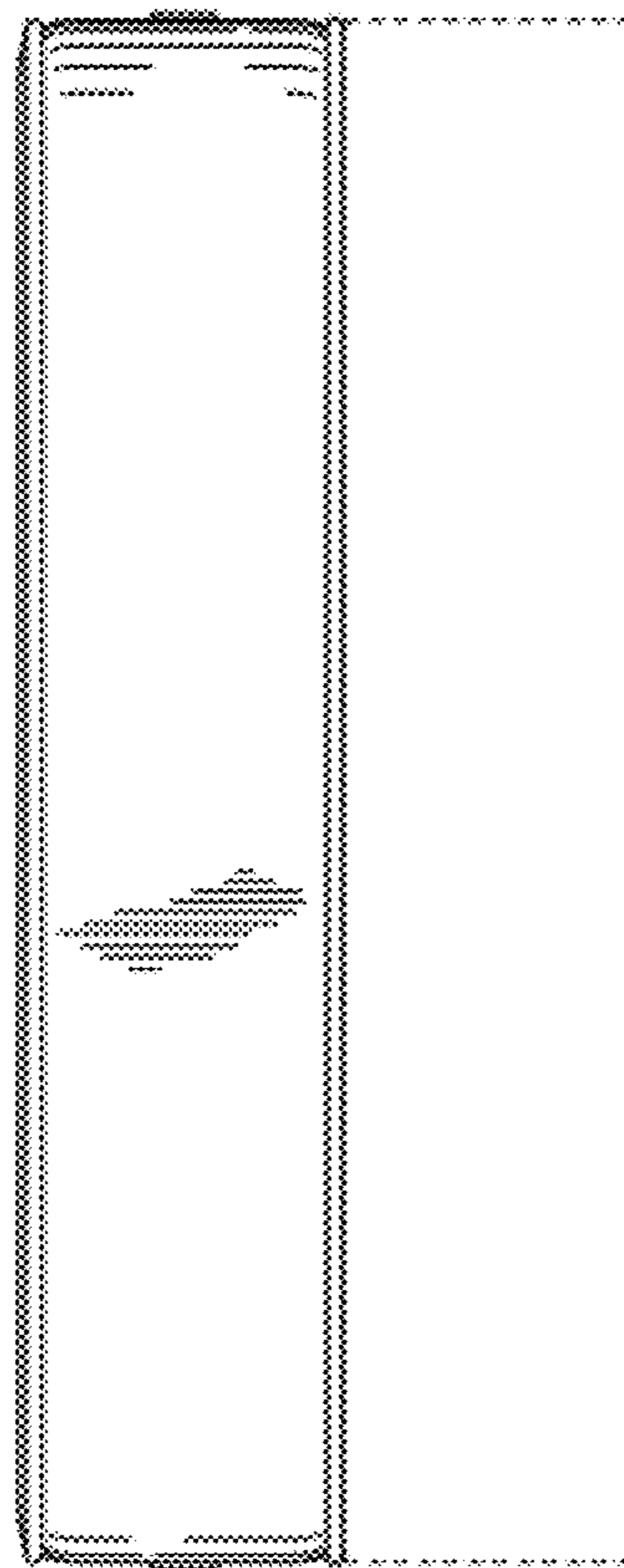

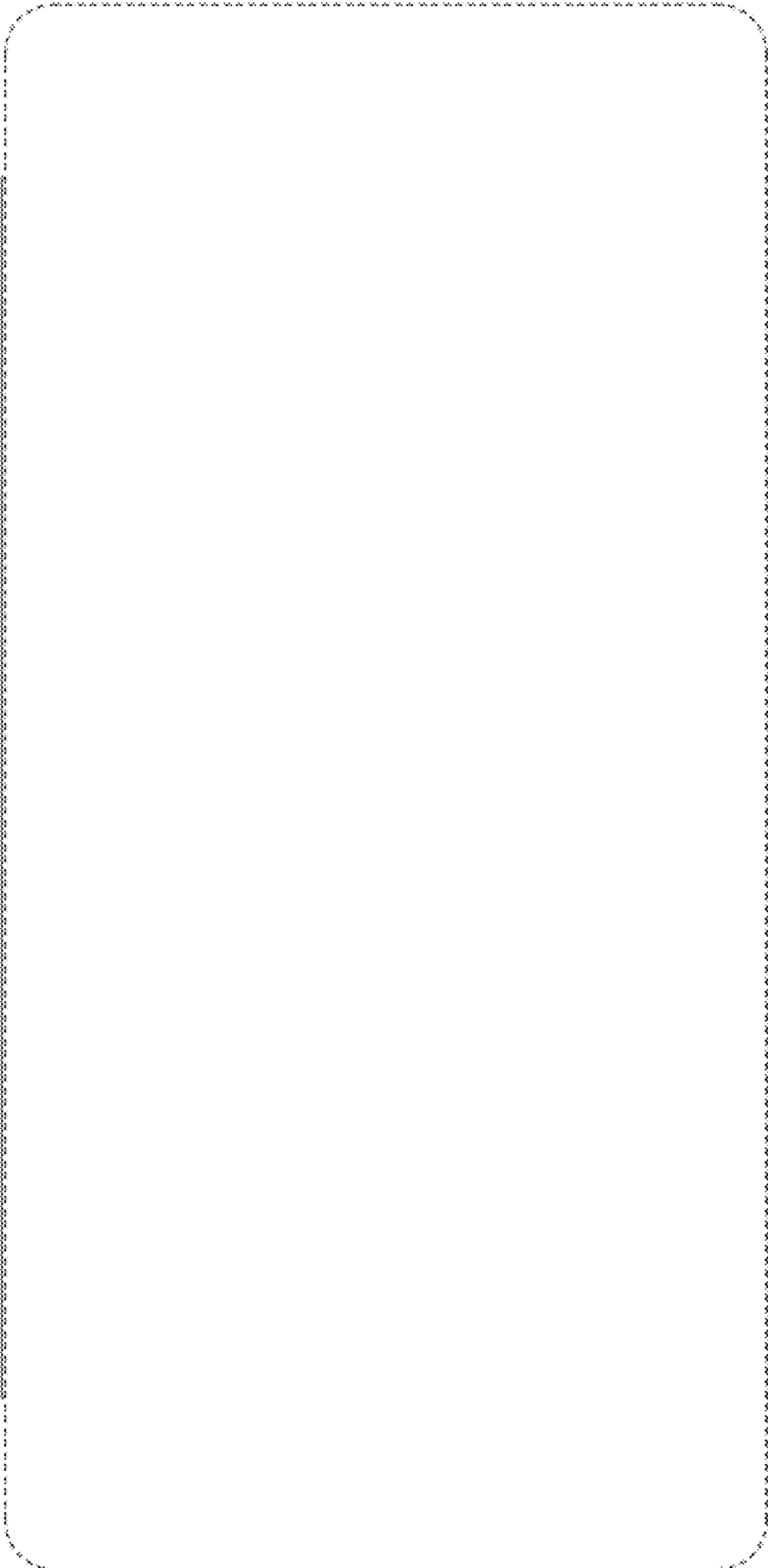
