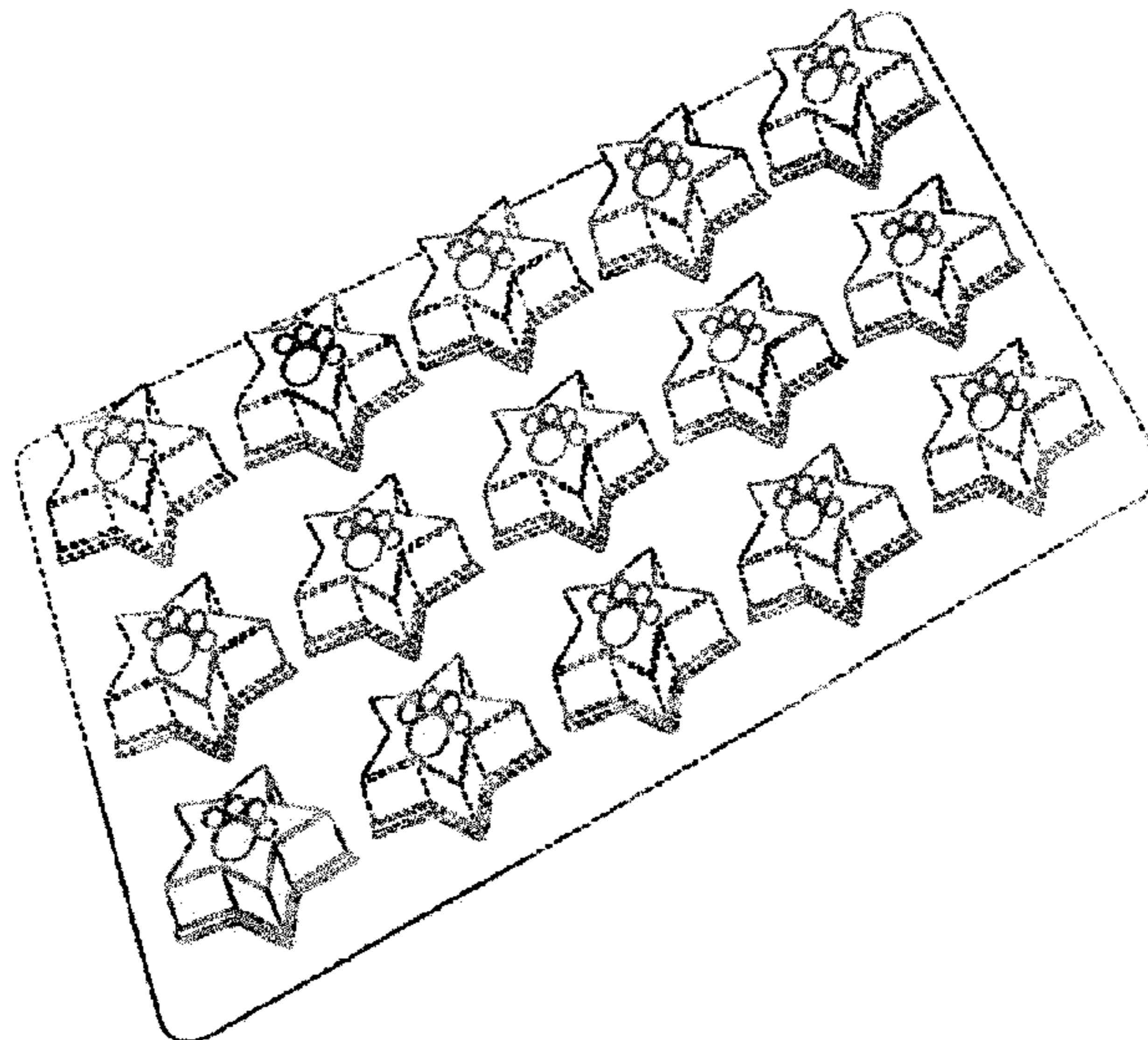
CLAIM
