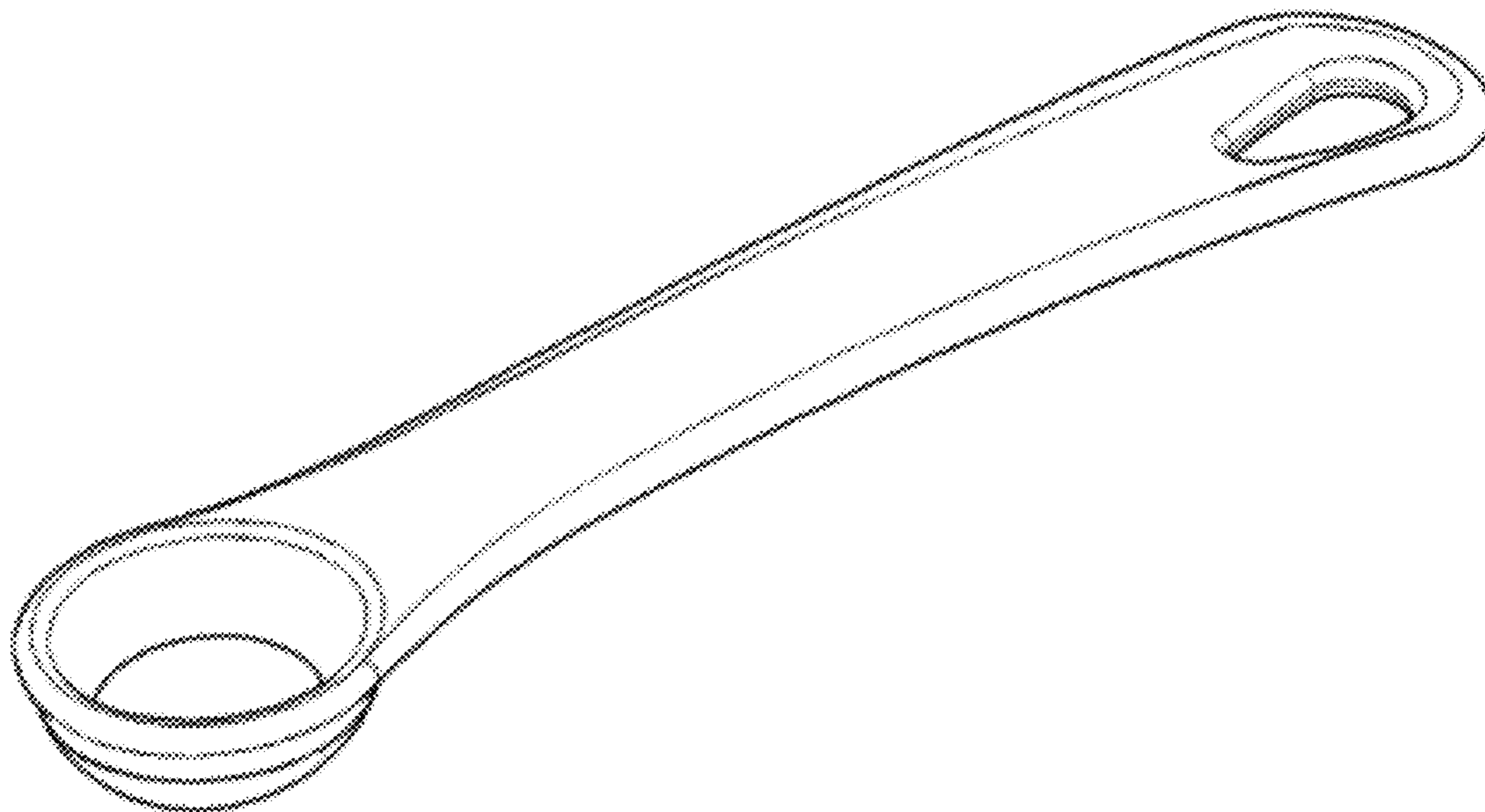
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a measuring spoon.
FIG. 2 is a top plan view of the measuring spoon of FIG. 1.

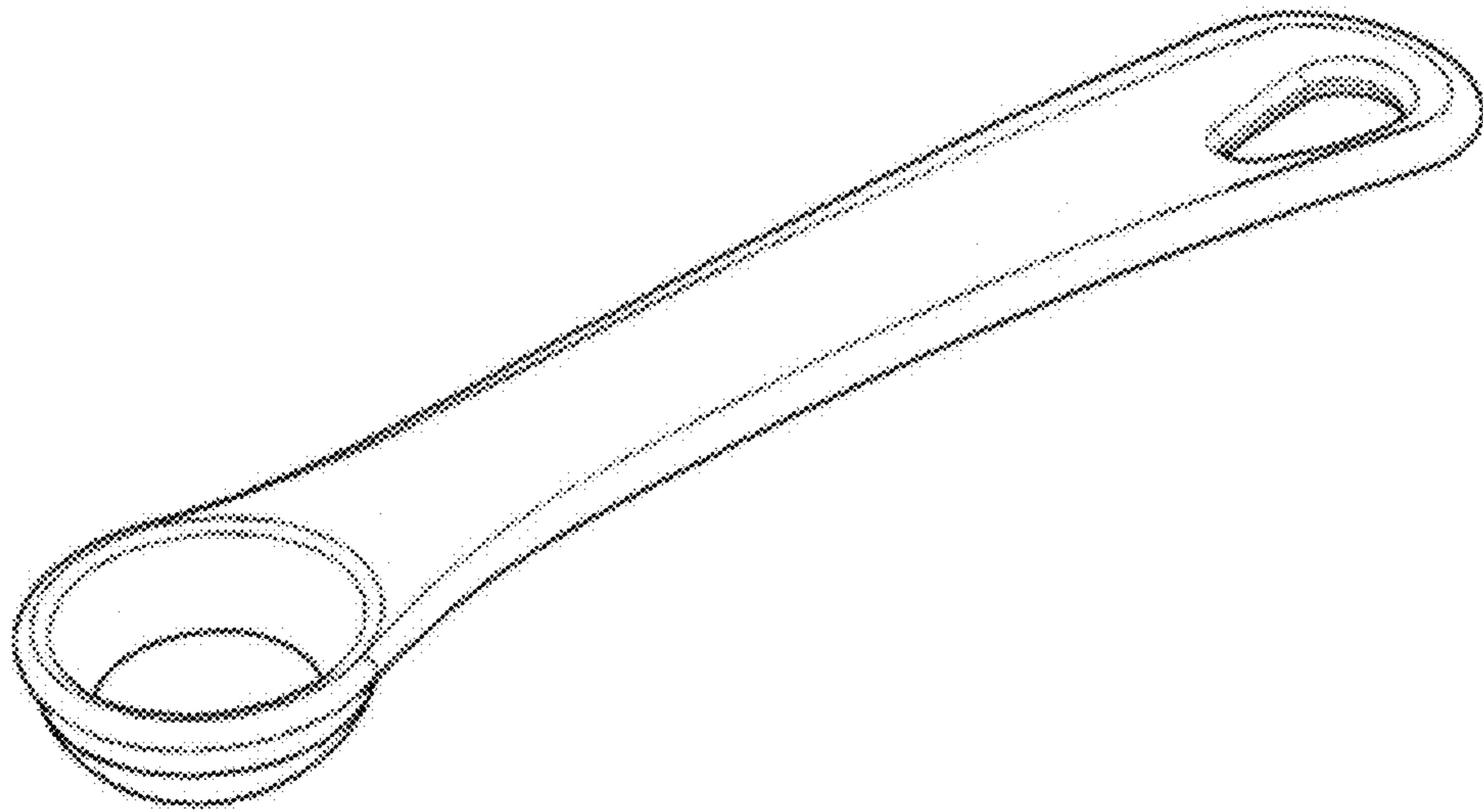

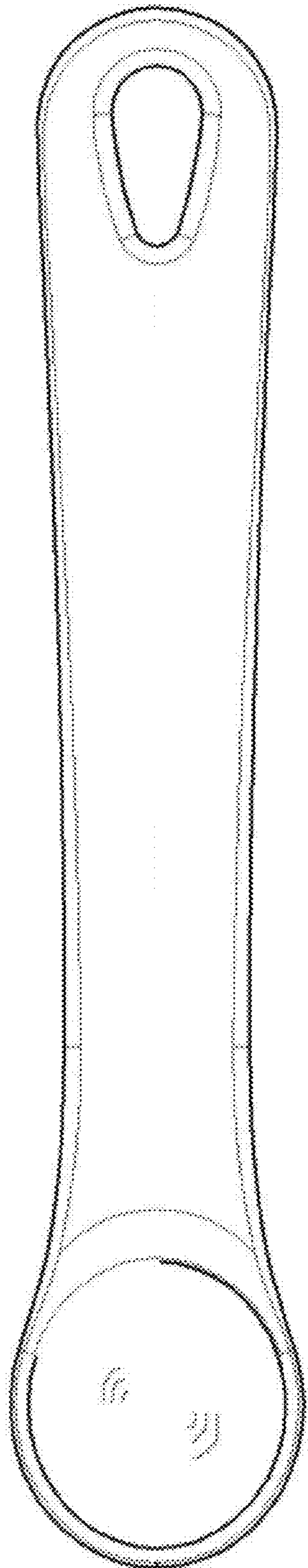

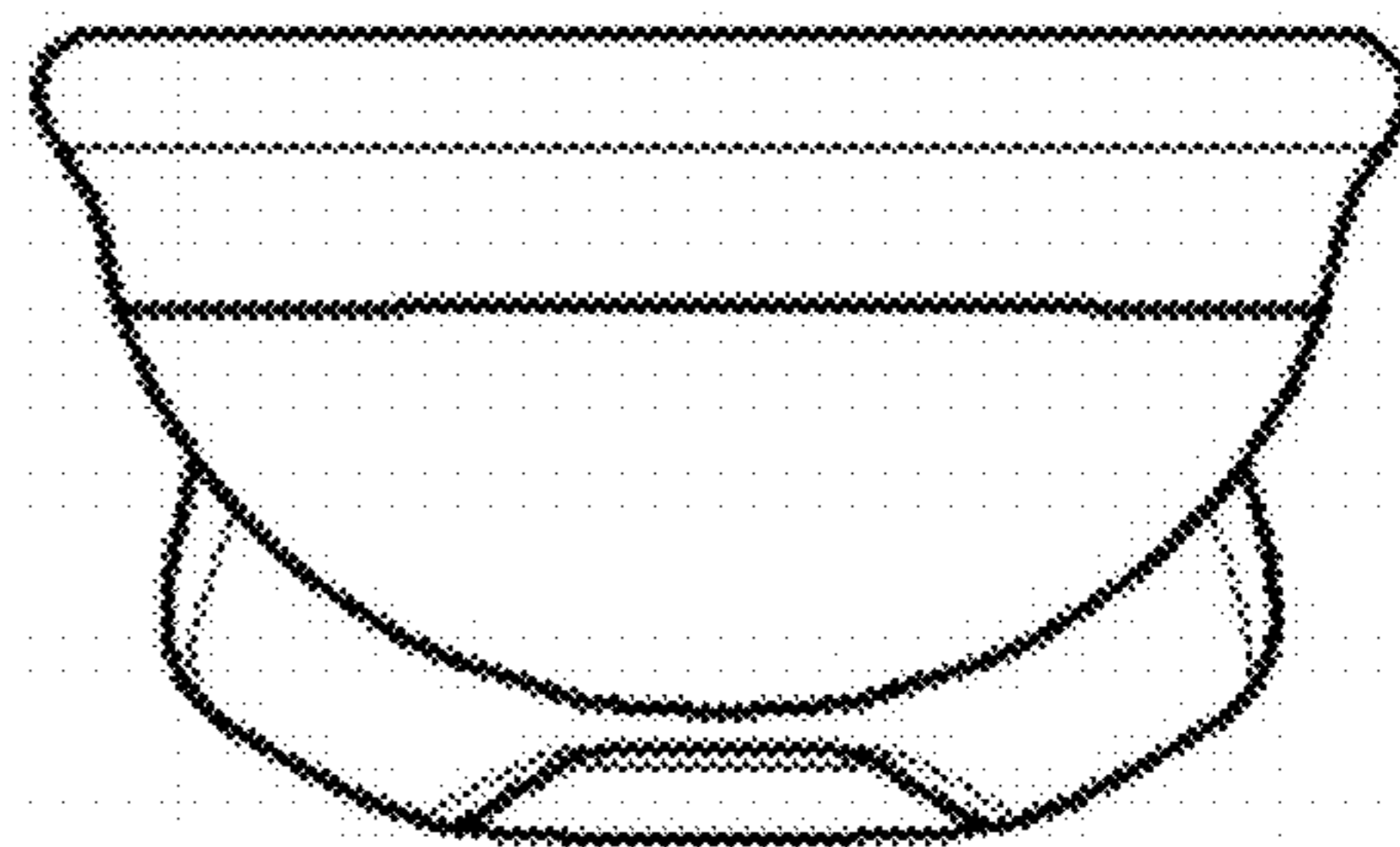

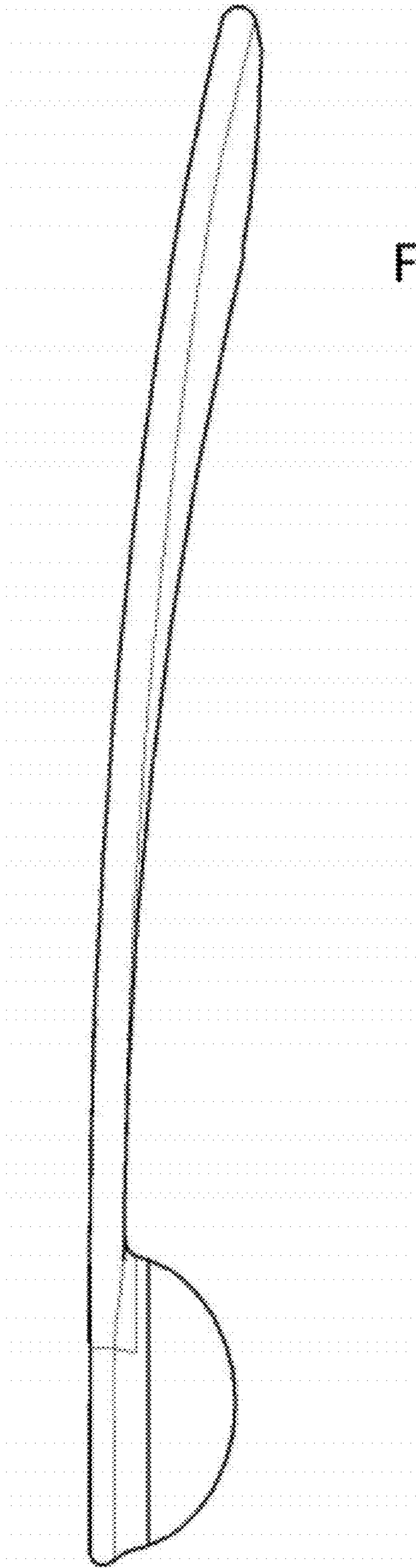

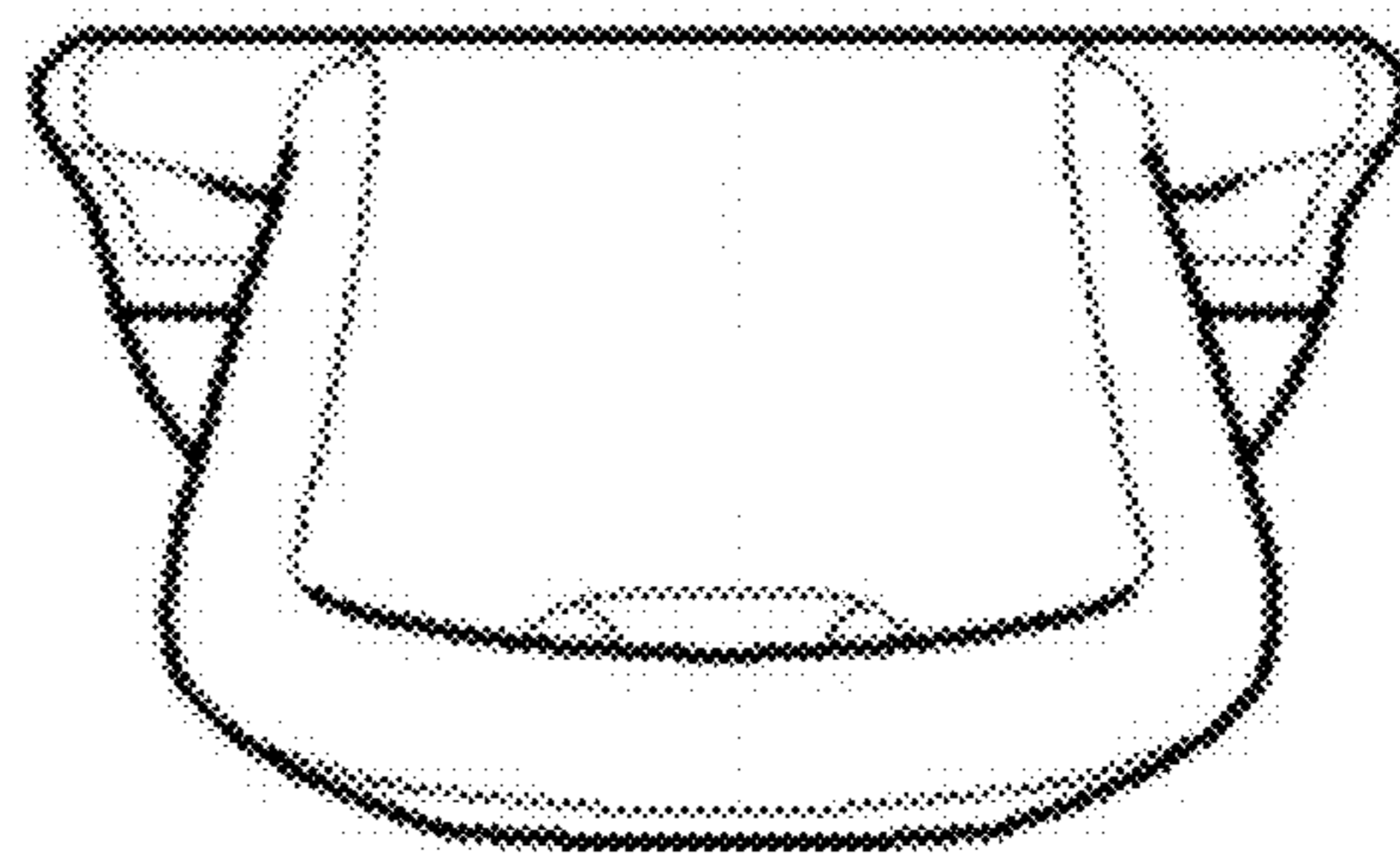

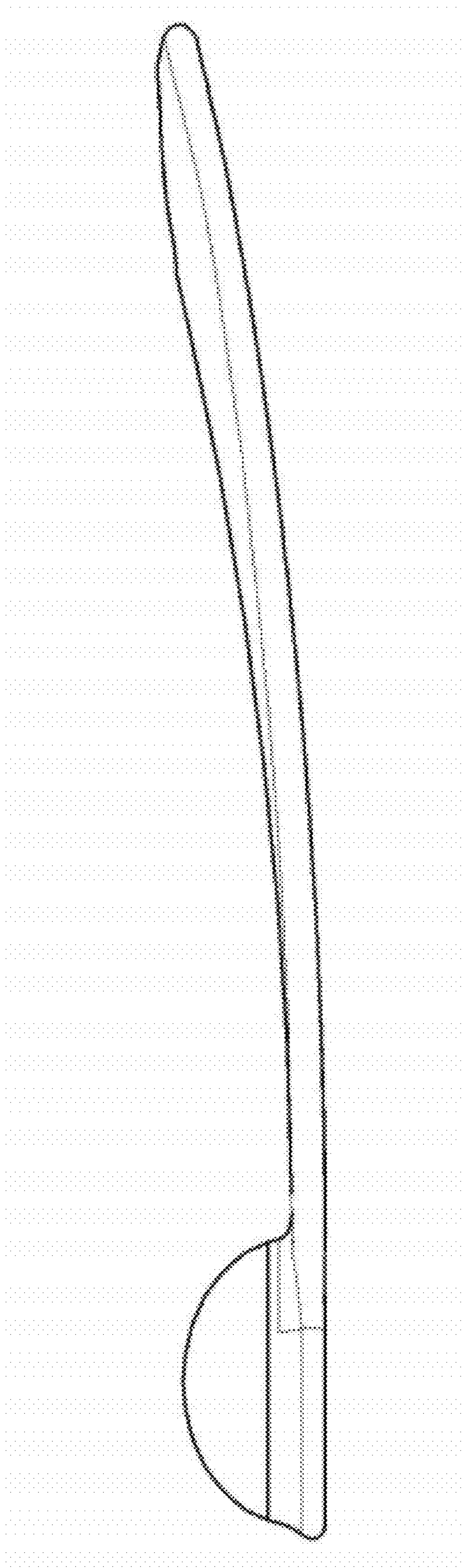

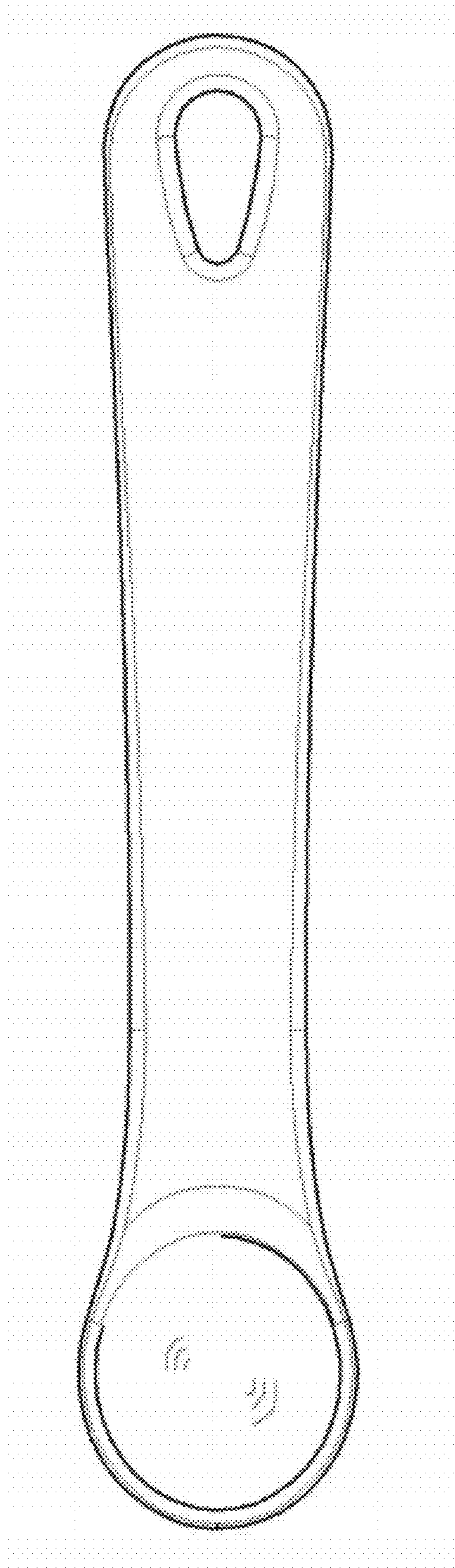
