The ornamental design for a plant pot, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a plant pot, showing my new design;

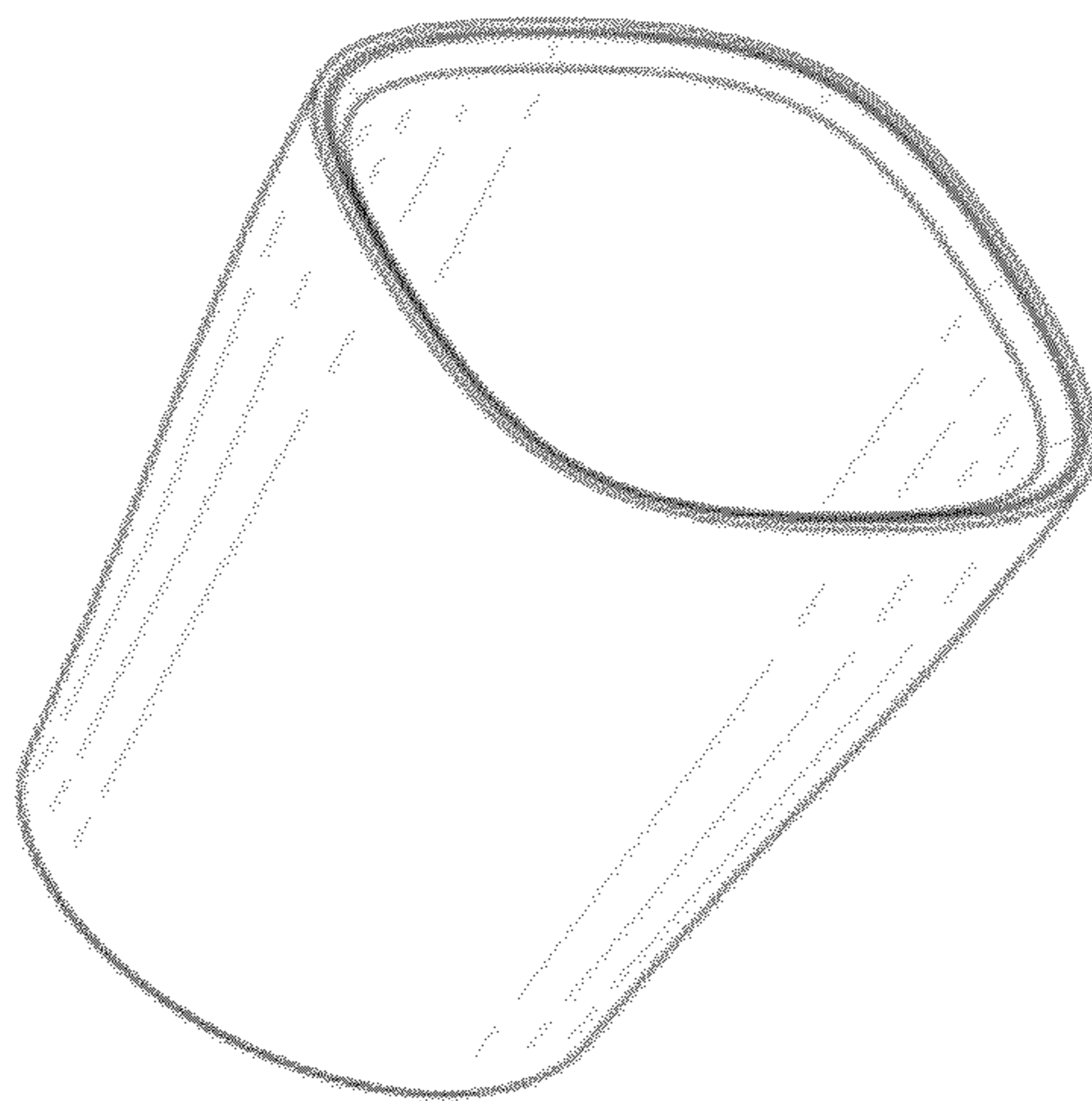

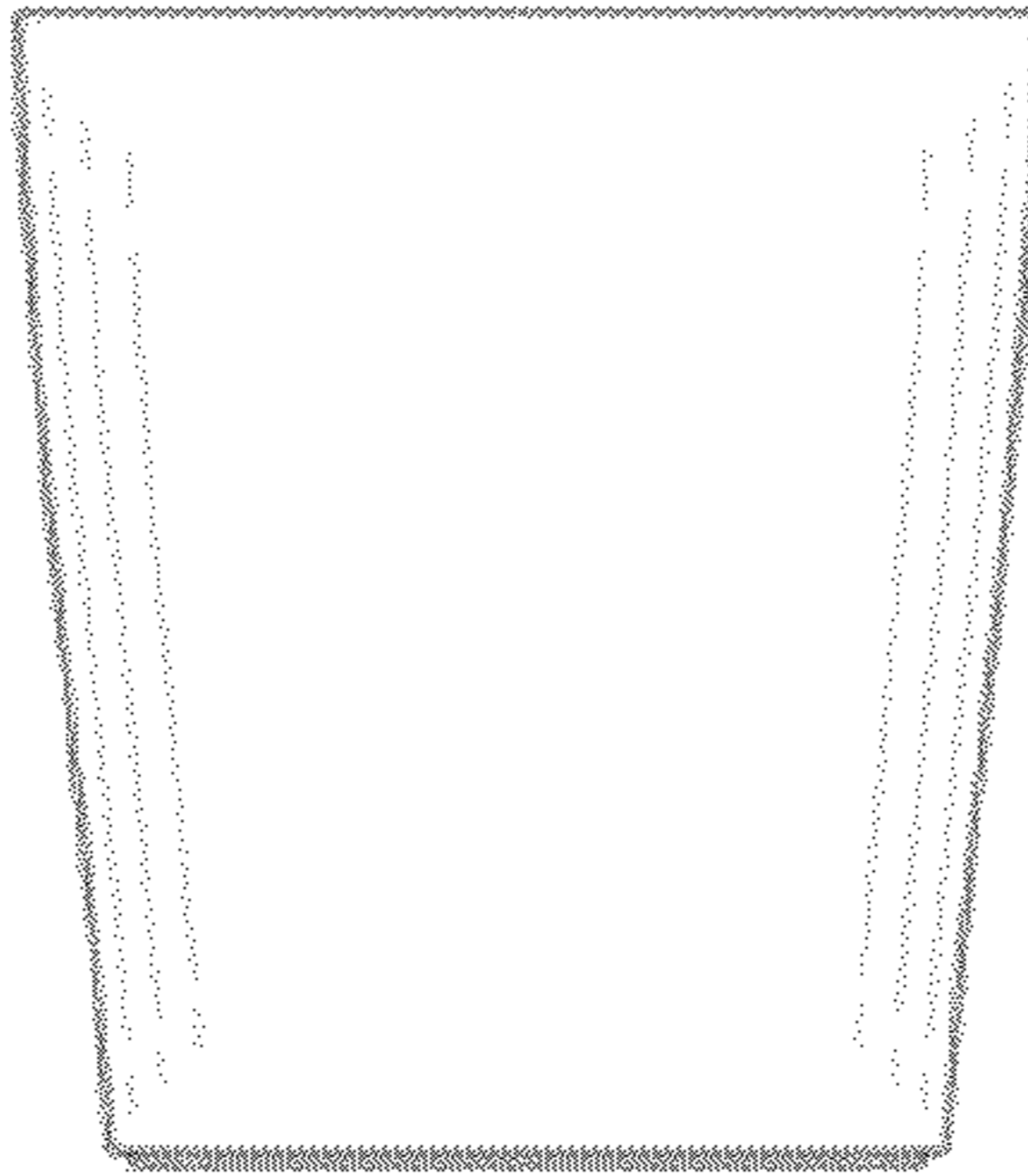

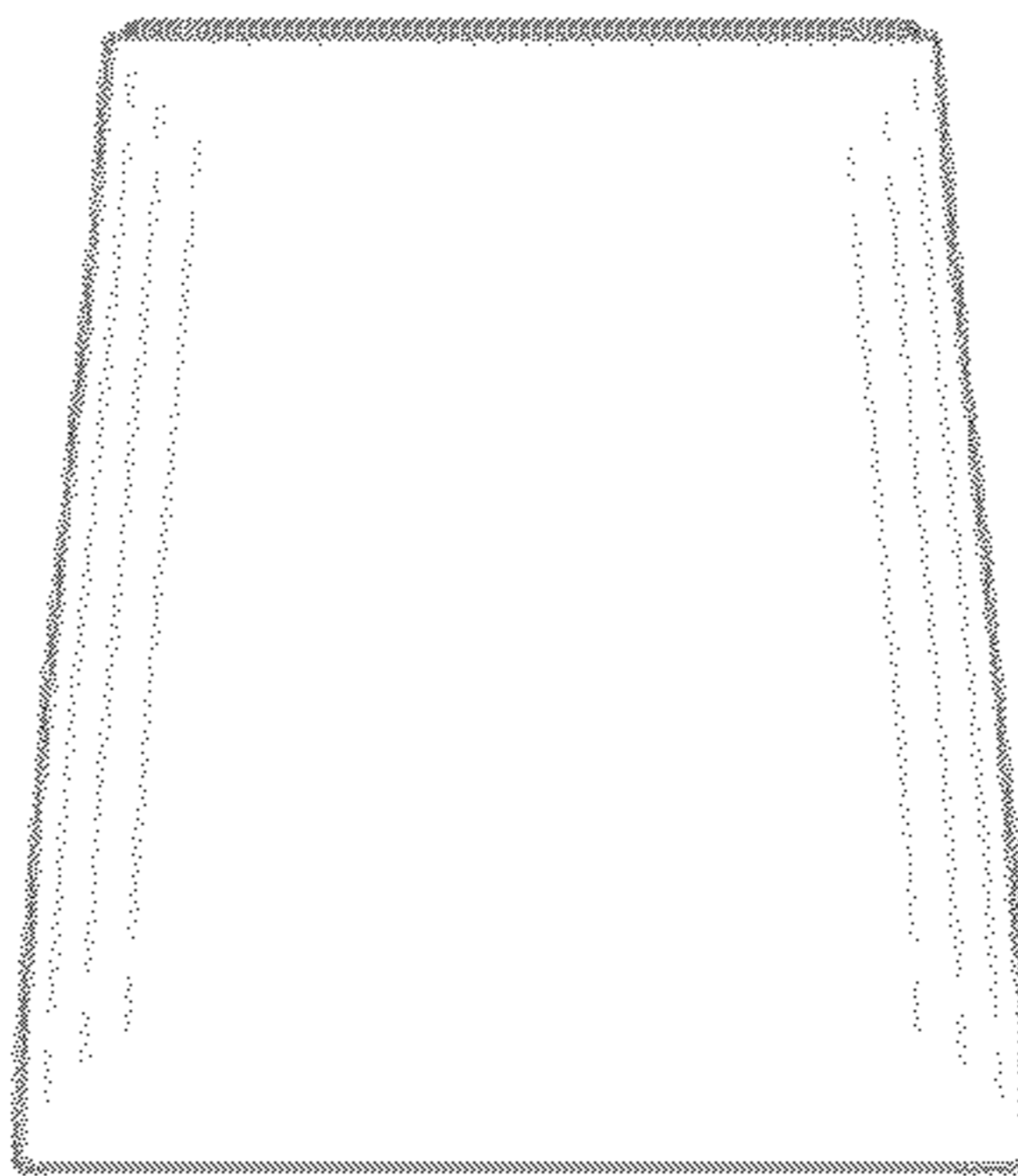

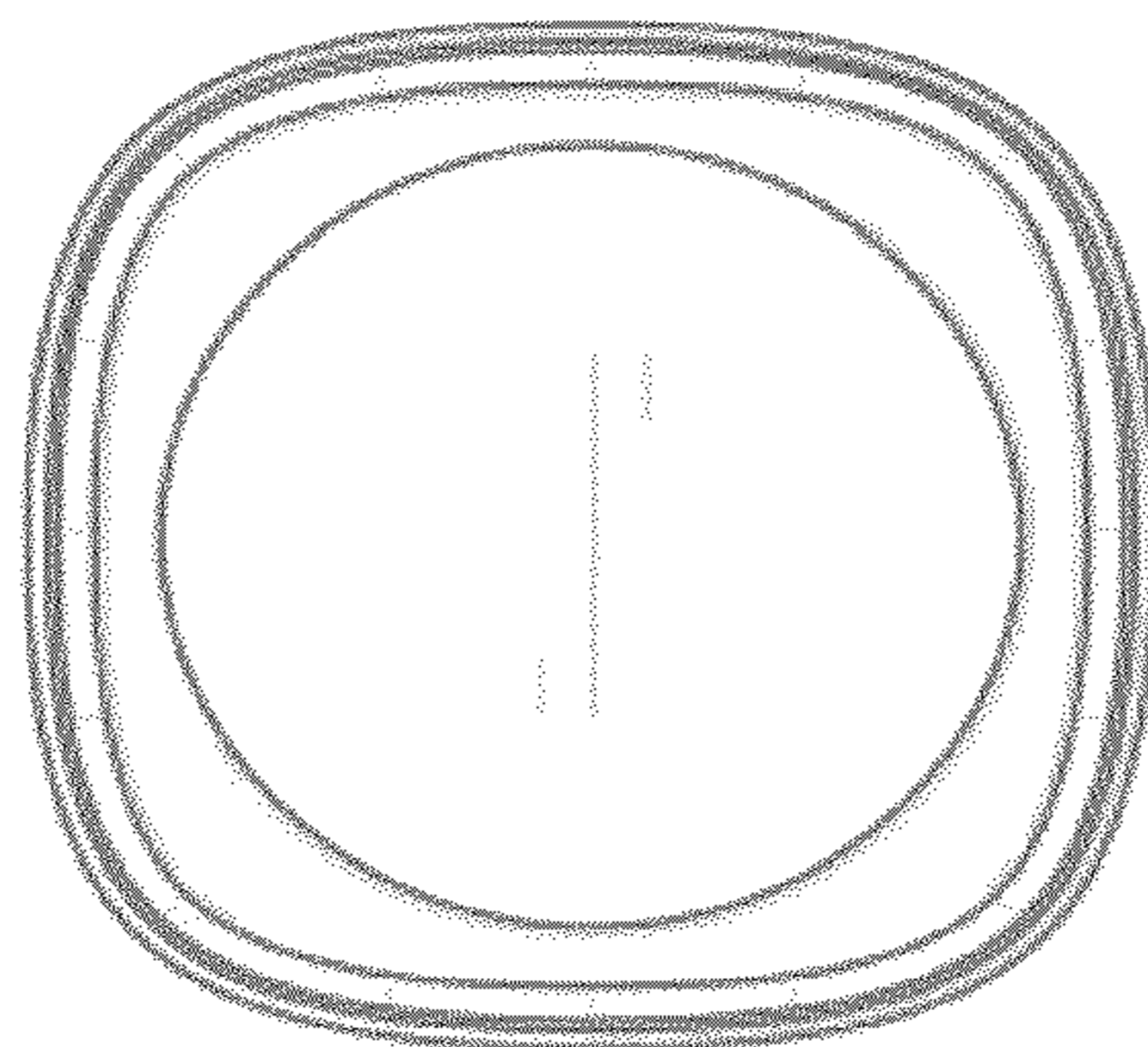

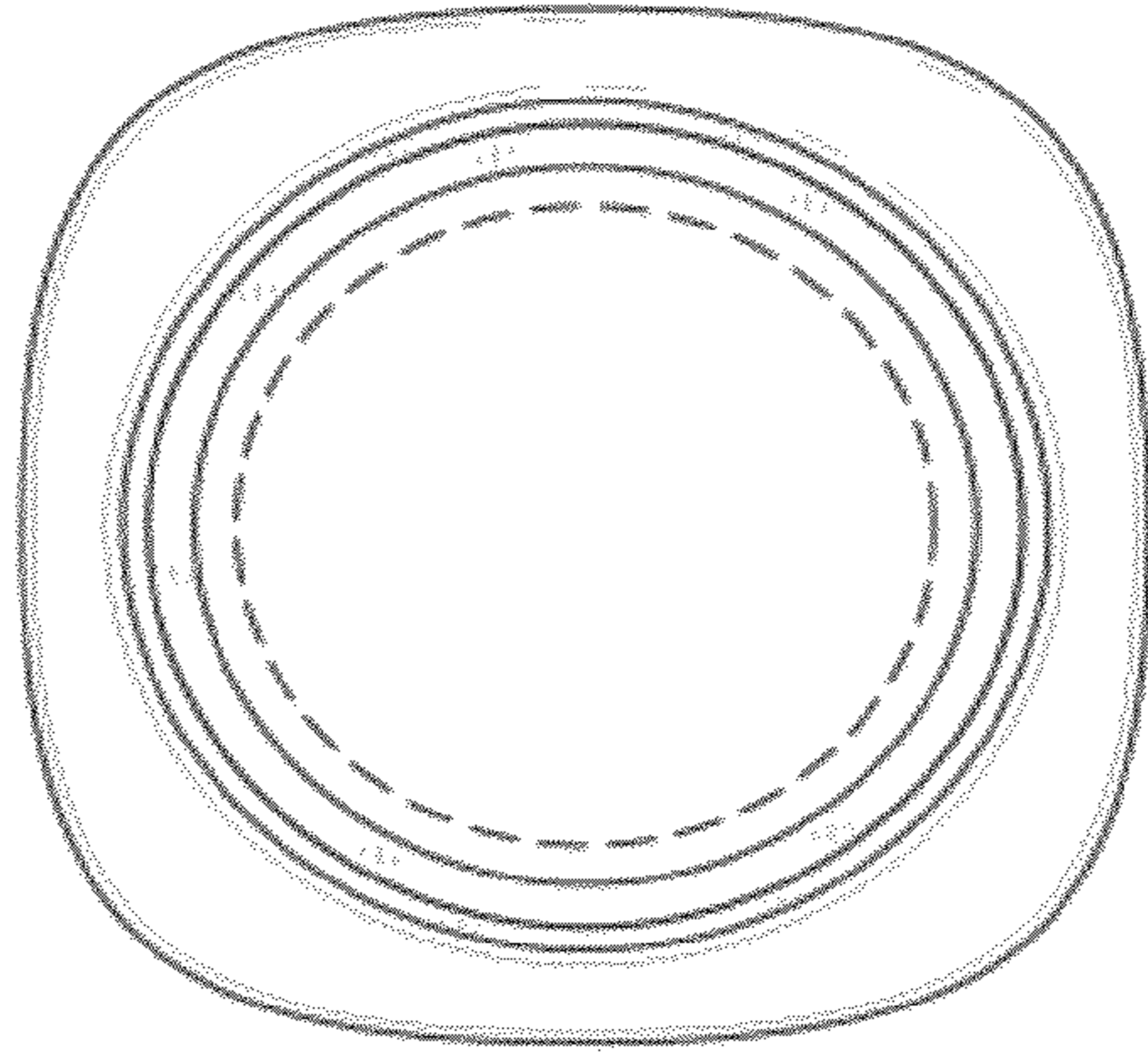

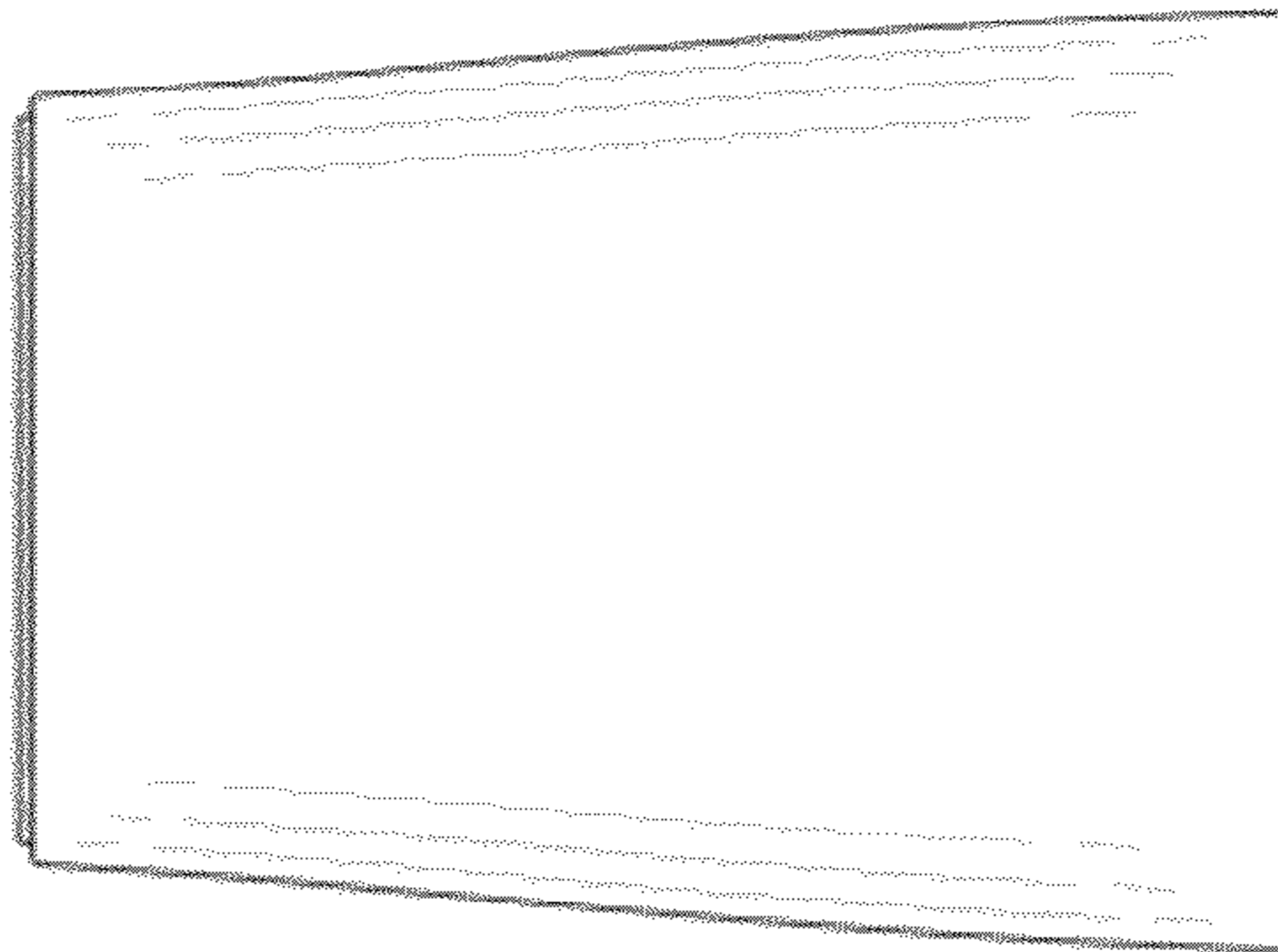

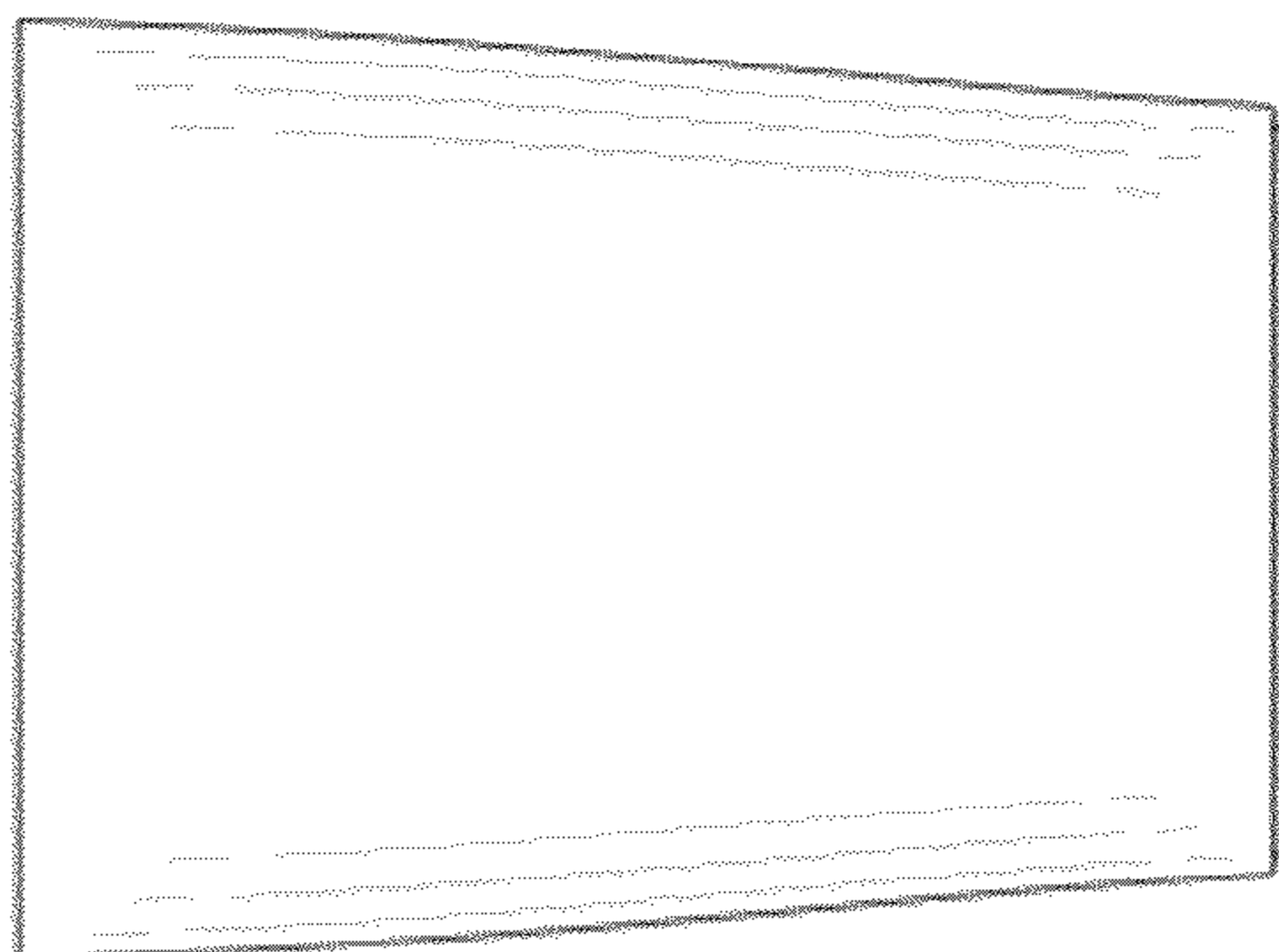
