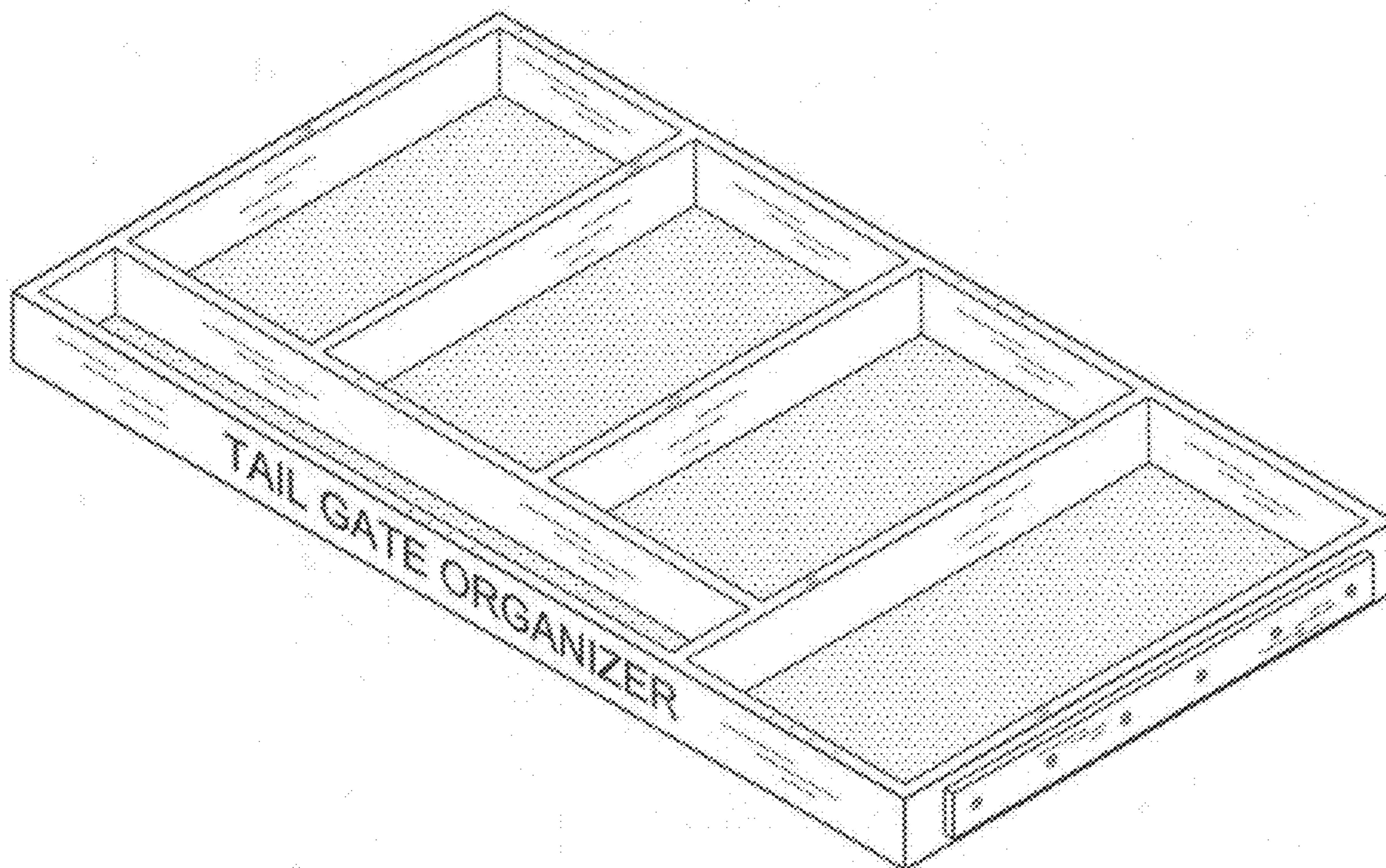
(57) **CLAIM**

The ornamental design for a sliding storage and organizer drawer for truck bed, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sliding storage and organizer drawer for truck bed showing my new design;

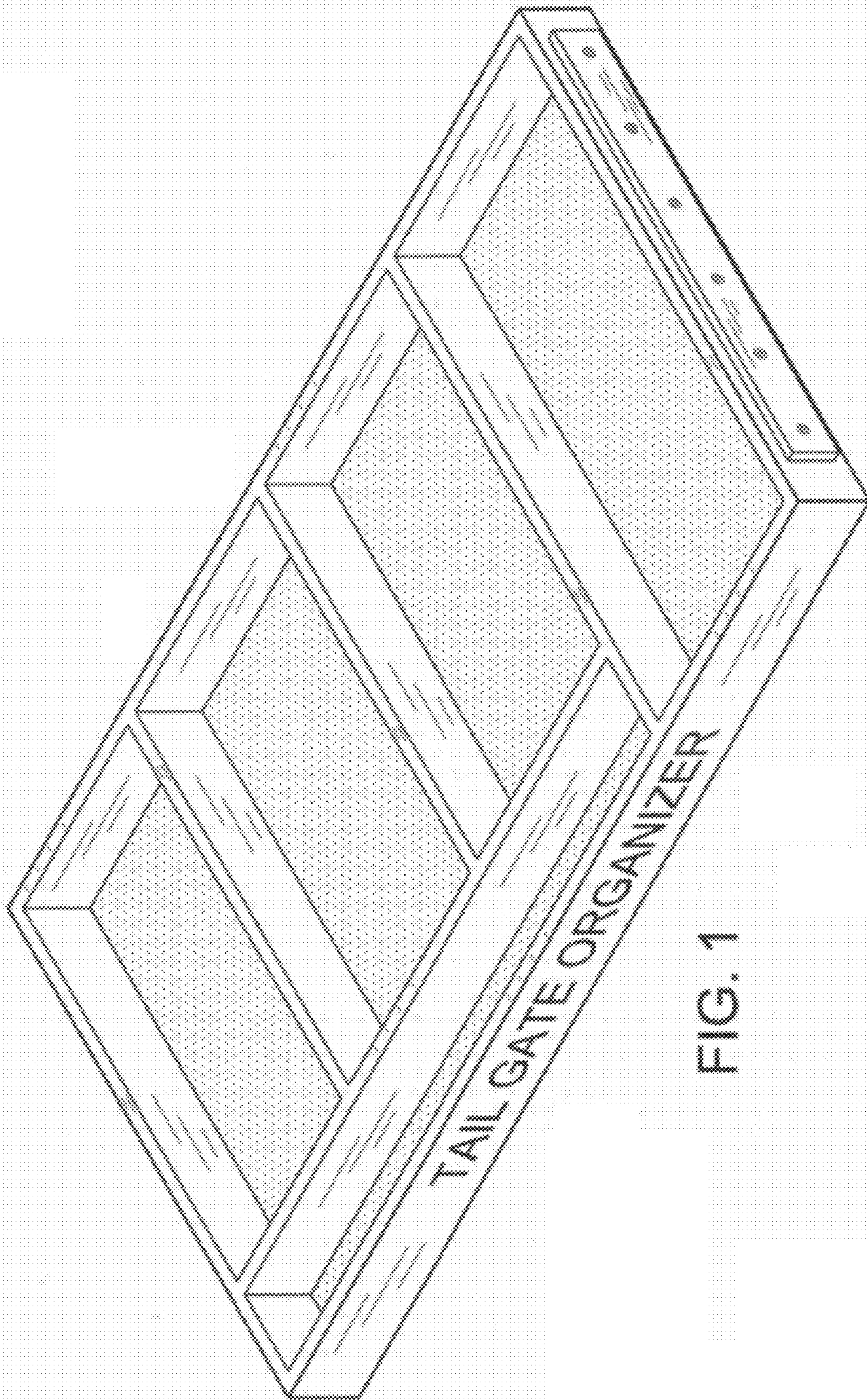

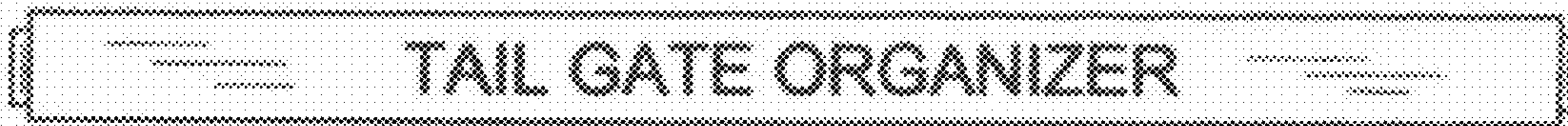

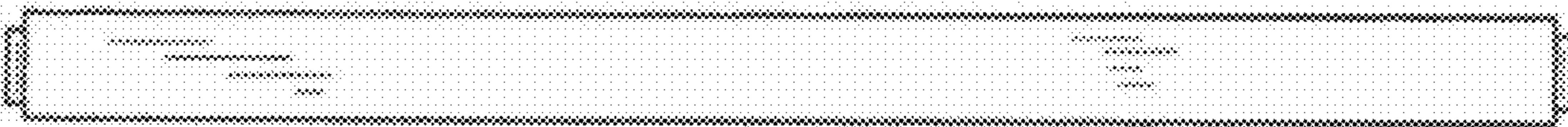

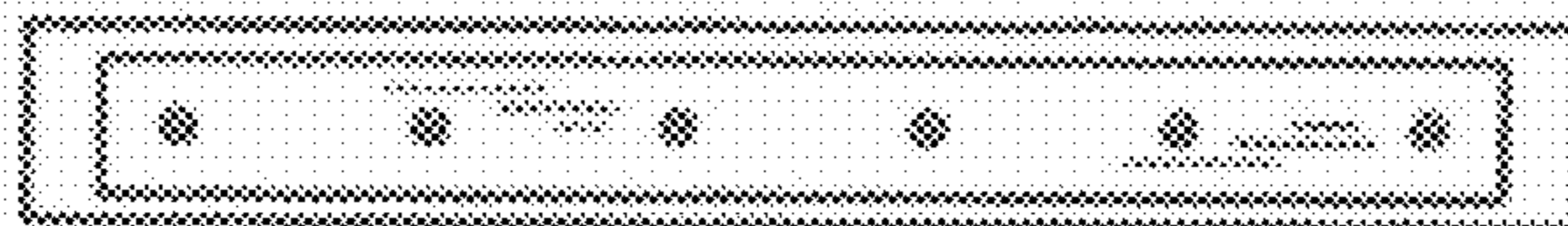

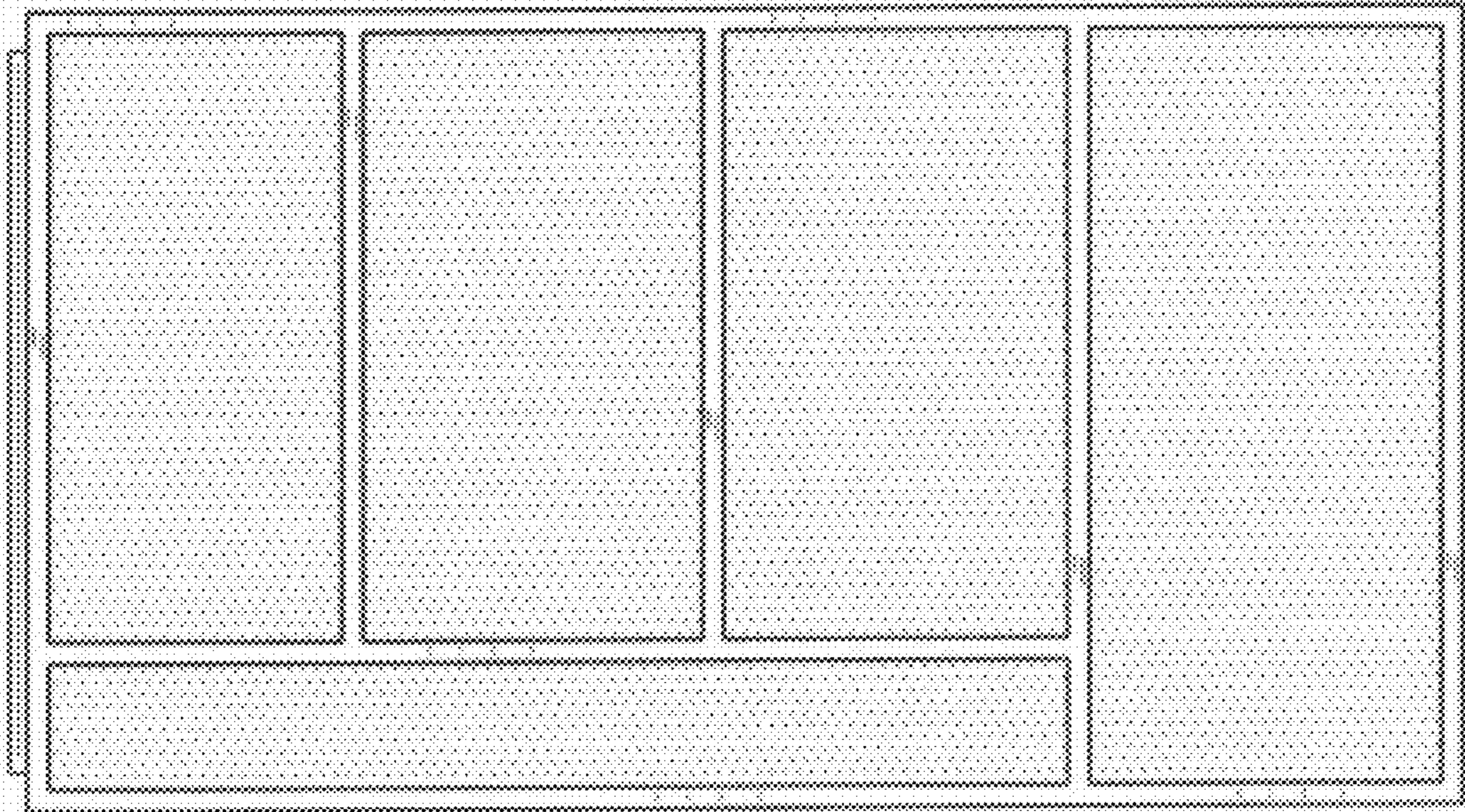

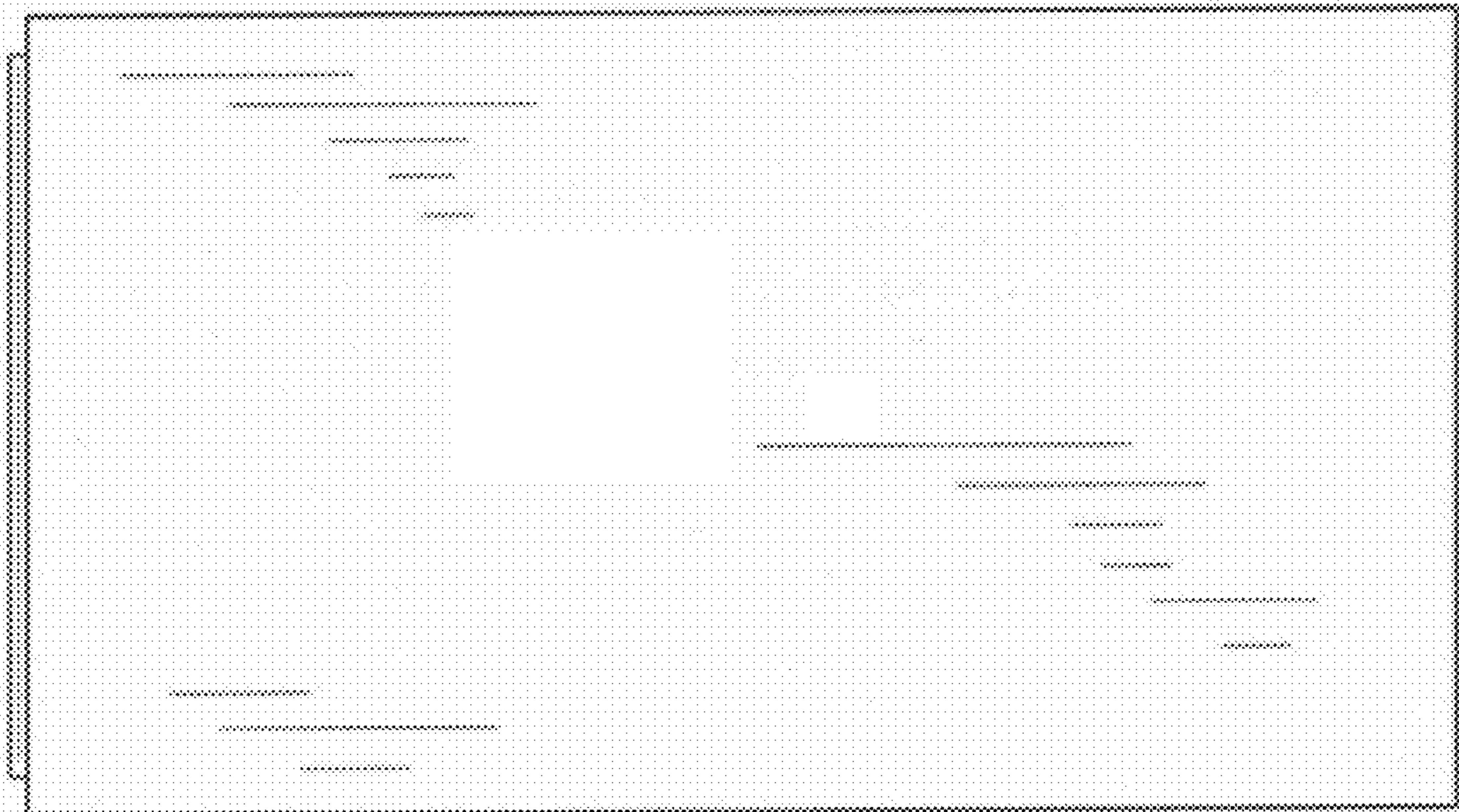
