(57) **CLAIM**

I claim the ornamental design for a toy register, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the right side of a toy register. FIG. 2 is a top view of the toy register illustrated in FIG. 1. FIG. 3 is a bottom view of the toy register illustrated in FIG. 1.

FIG. 4 is a front elevation view of the toy register illustrated in FIG. 1.

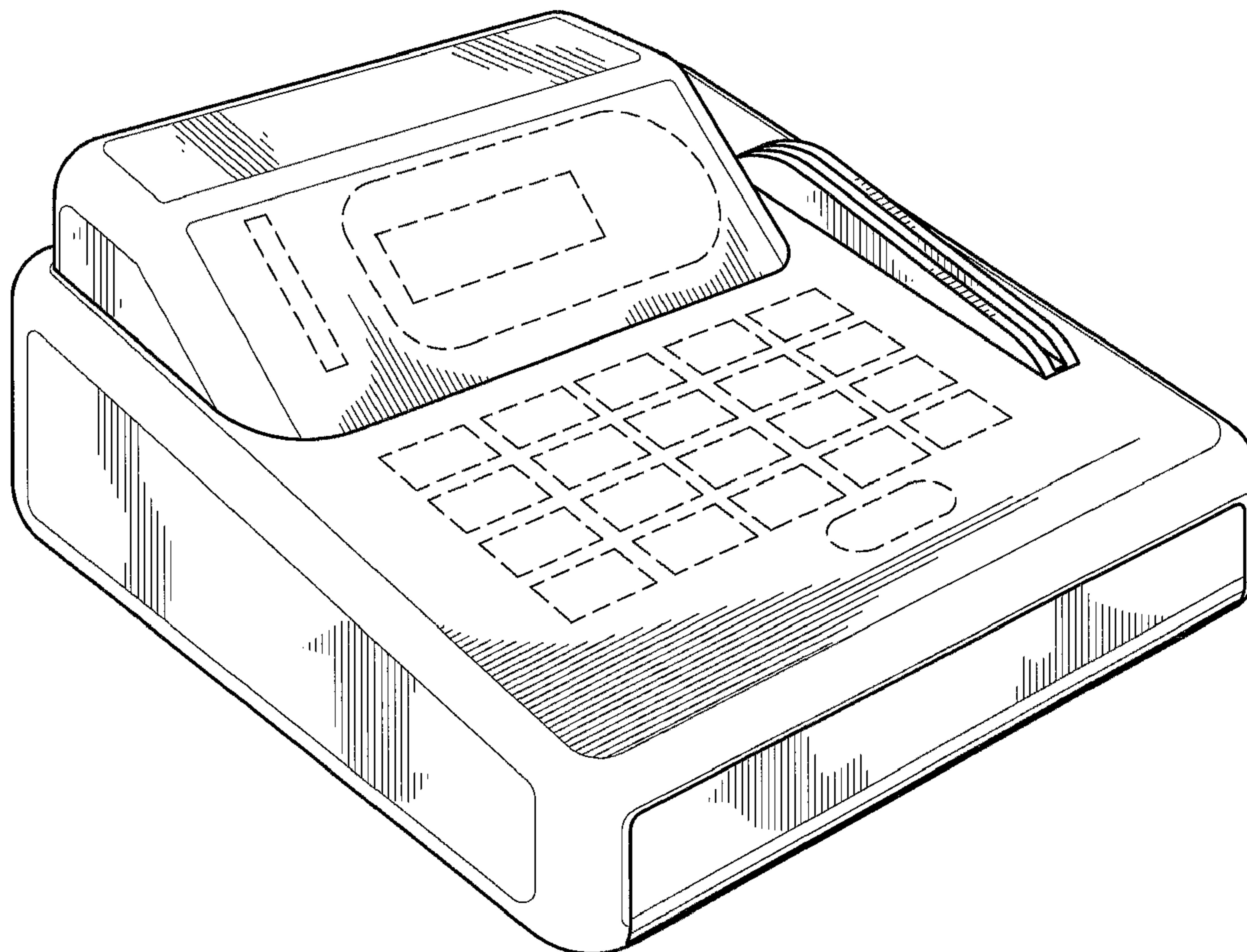
FIG. 5 is a rear elevation view of the toy register illustrated in FIG. 1.

FIG. 6 is an elevation view of the right side of the toy register illustrated in FIG. 1; and,

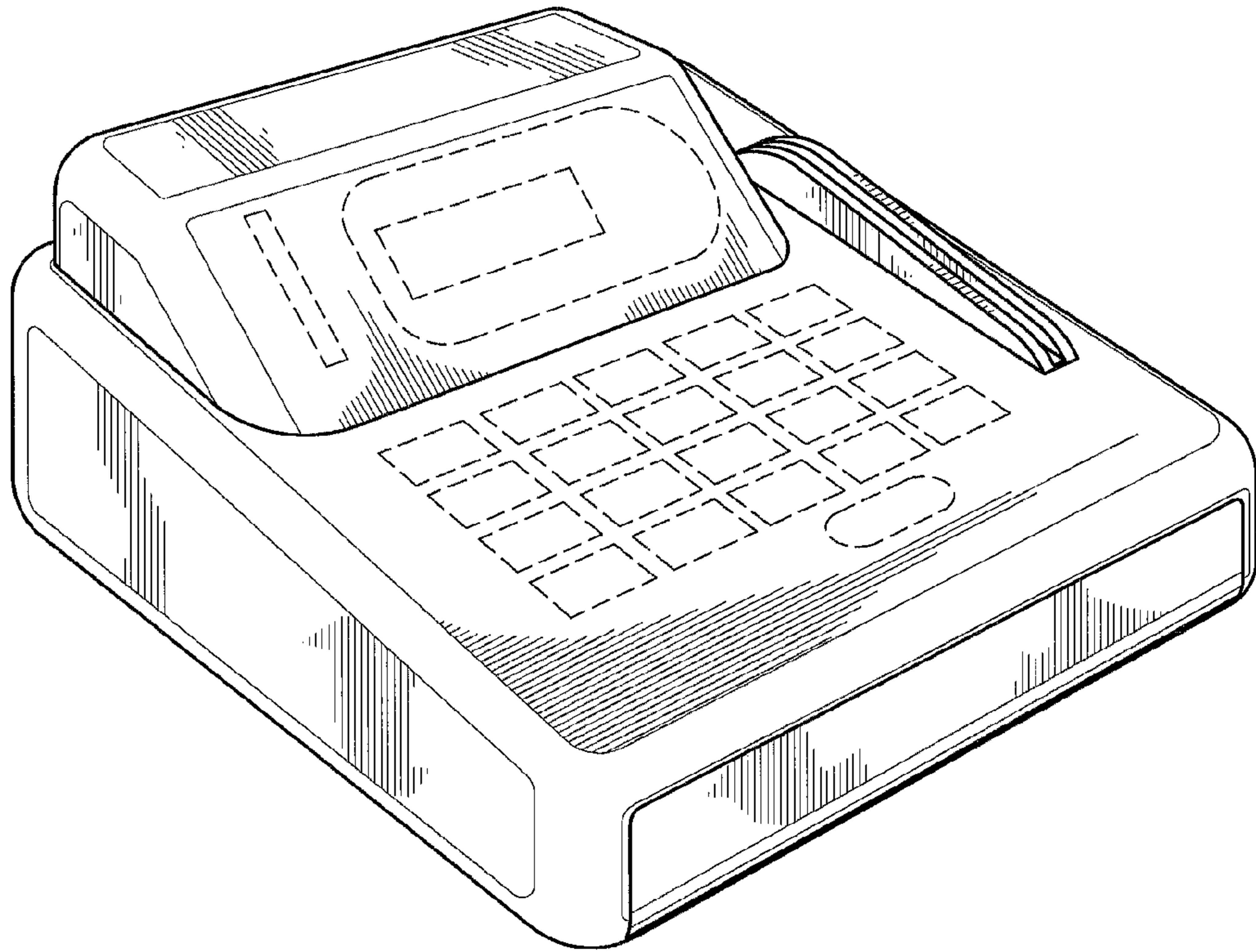
FIG. 7 is an elevation view of the left side of the toy register illustrated in FIG. 1.

The broken lines shown are included for the purpose of illustrating the unclaimed portions of the toy register that form no part of the claimed design.

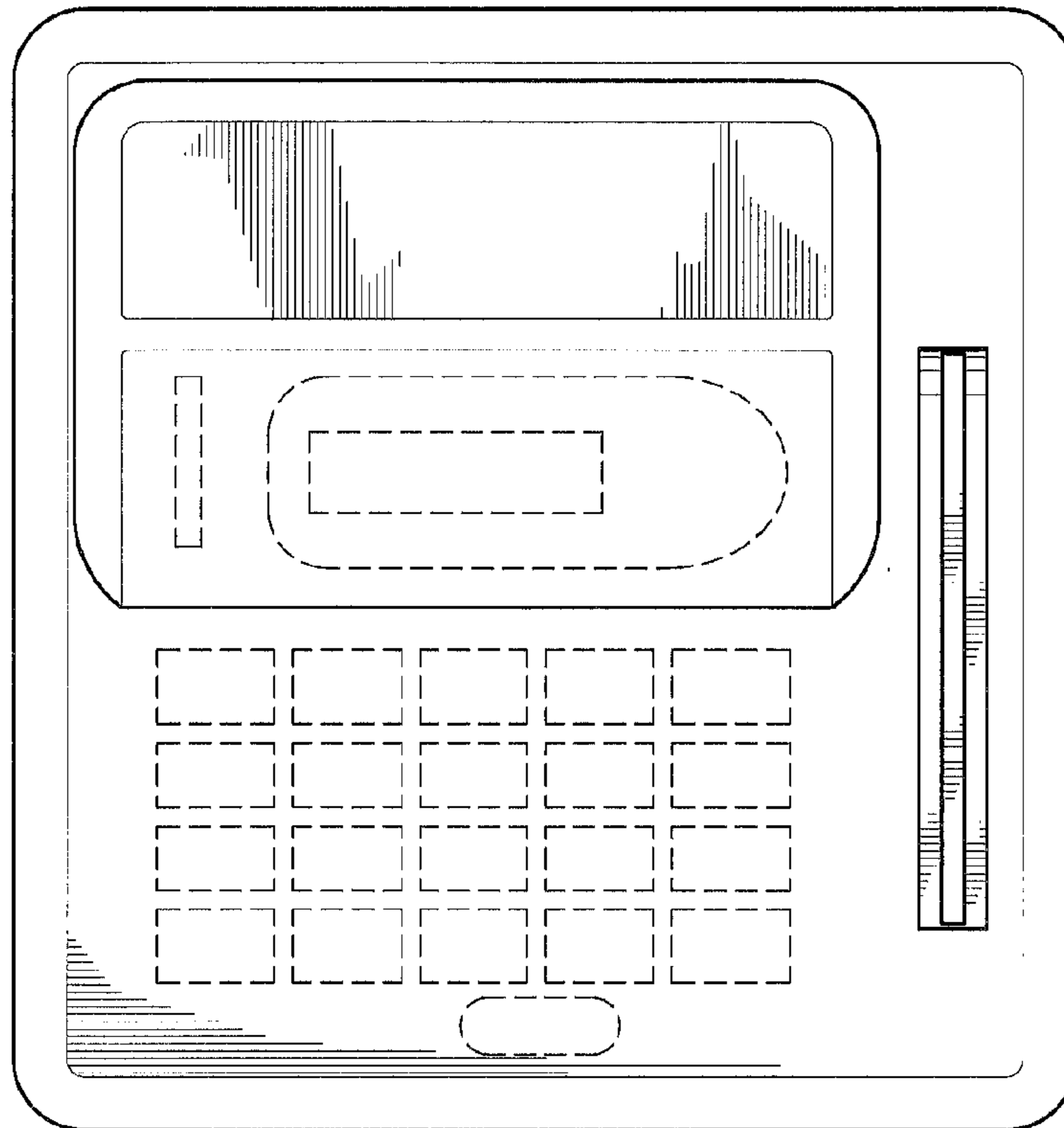

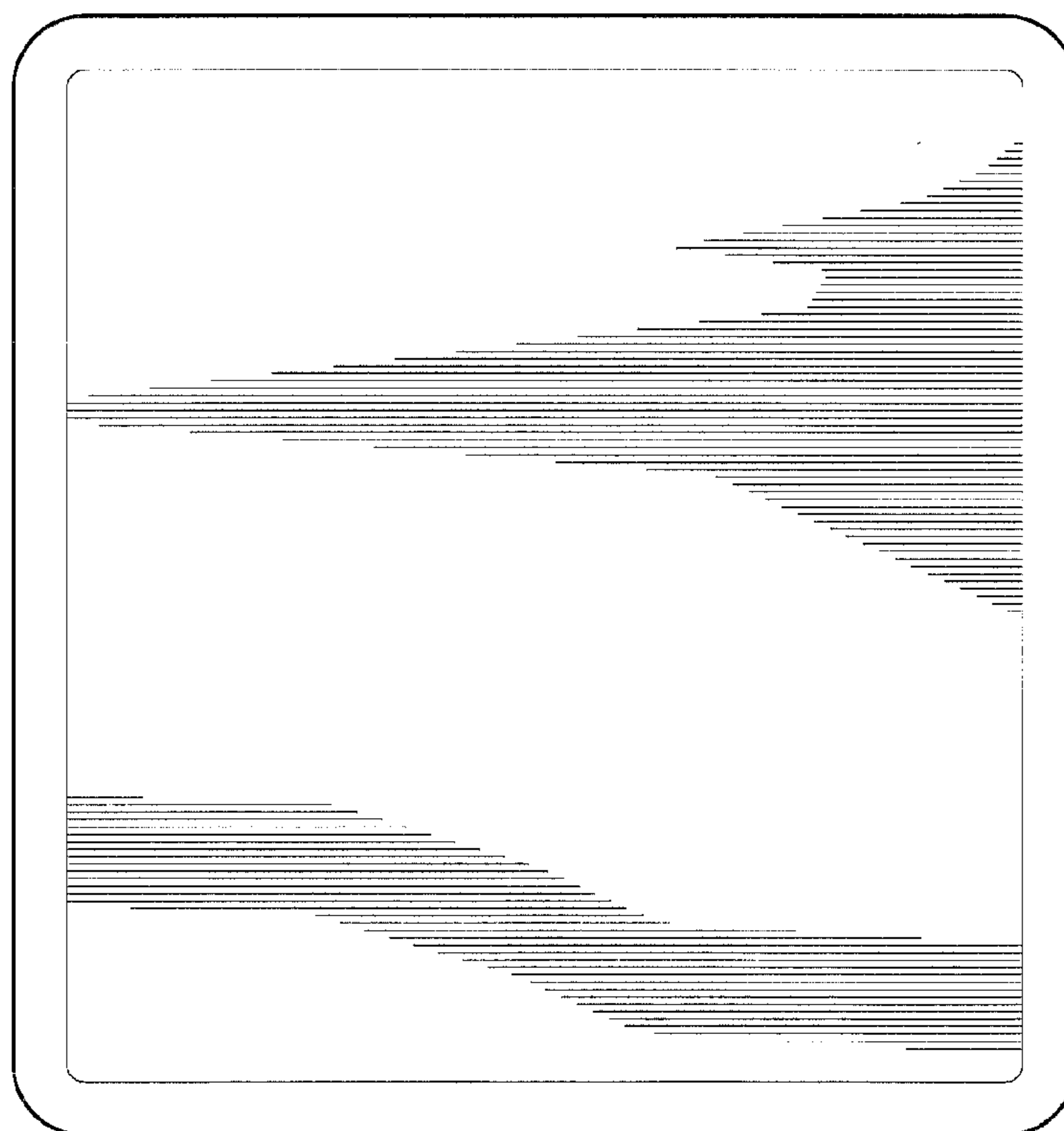

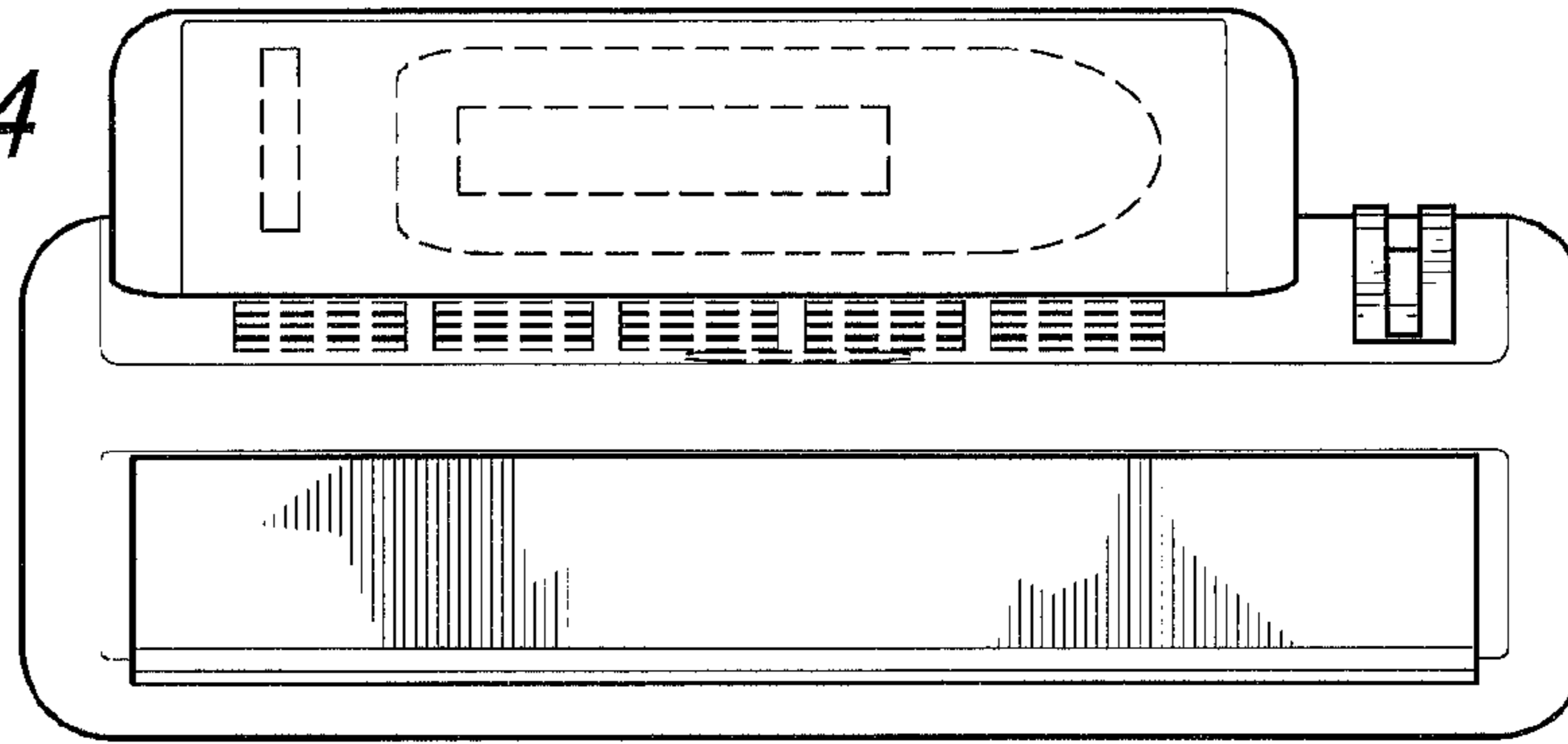

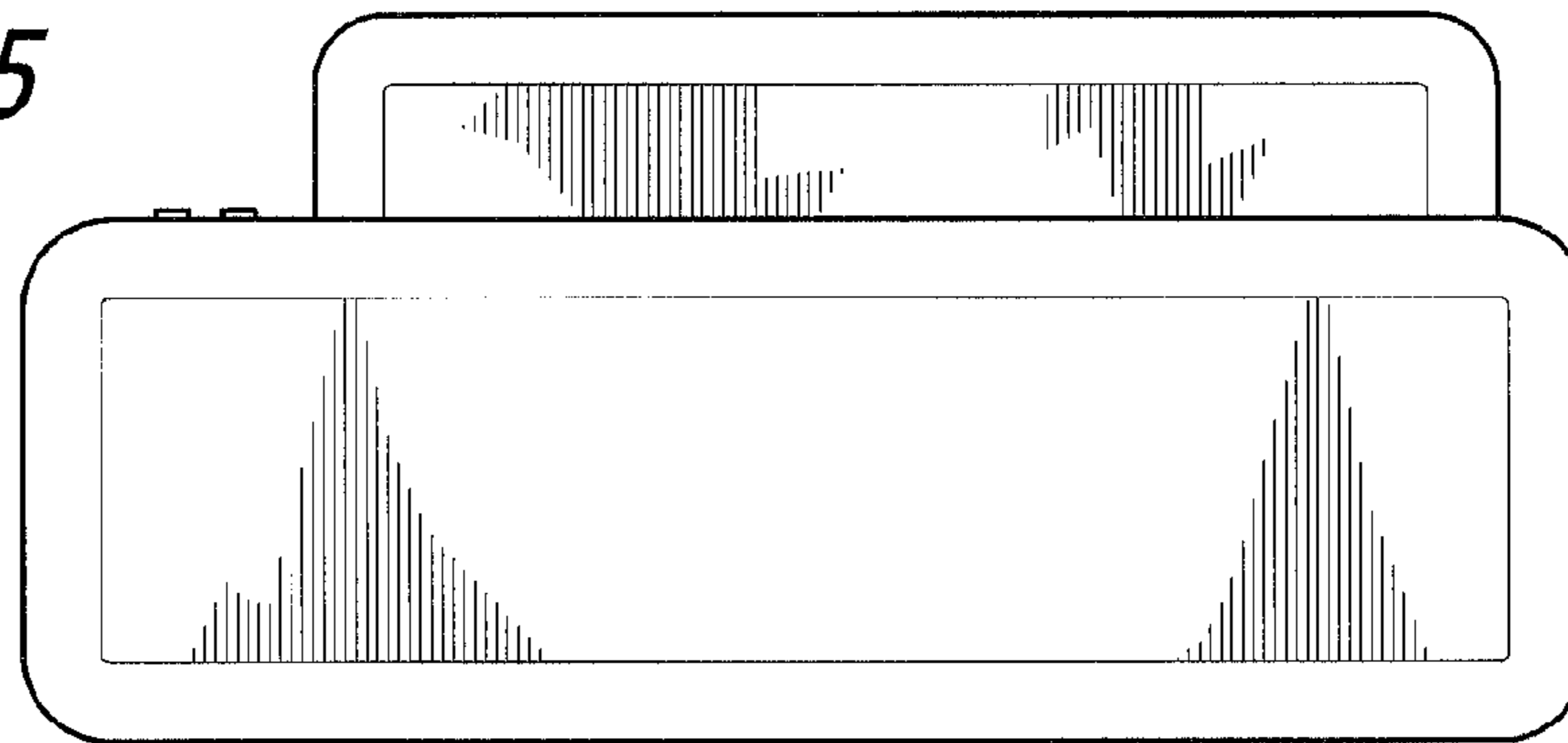

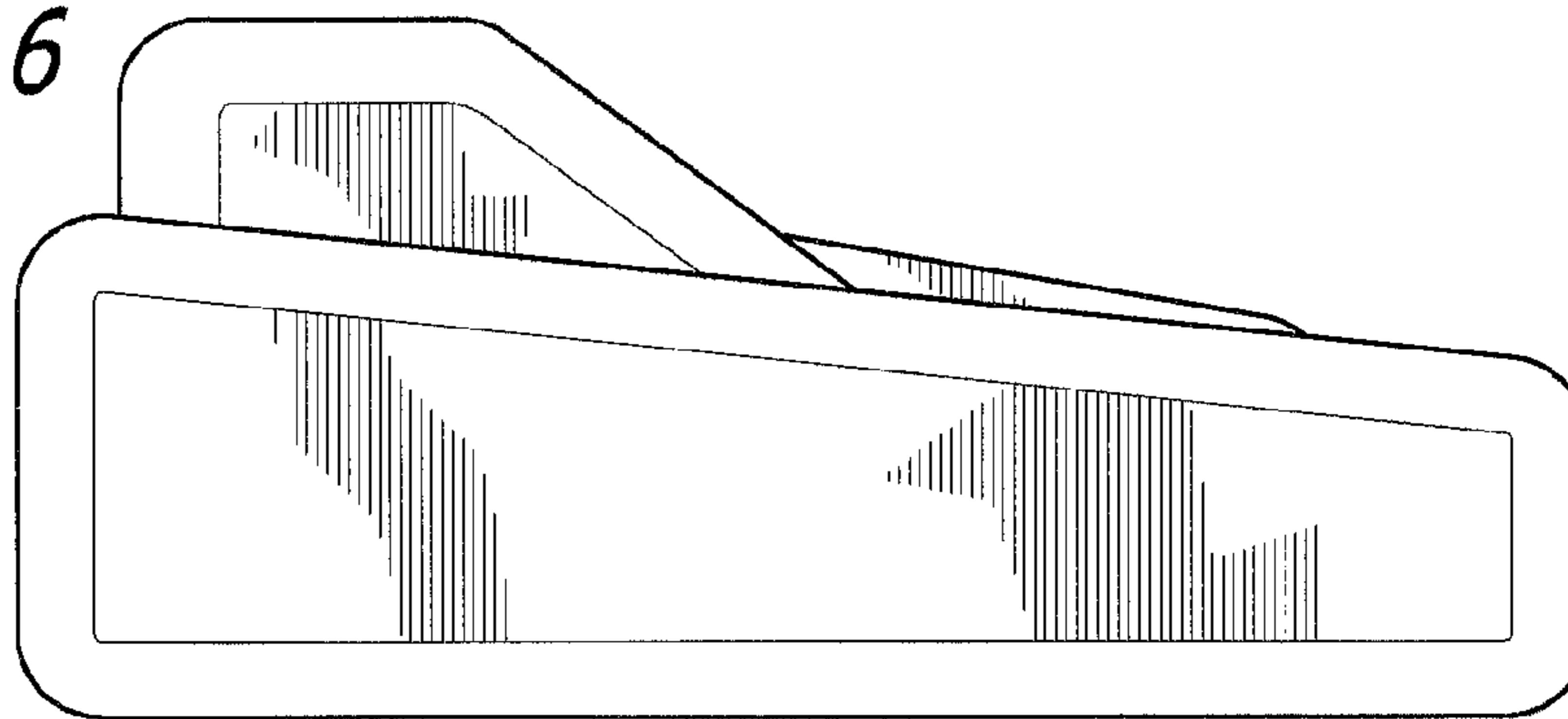
