The ornamental design for a hand shower, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a hand shower according to the invention.

FIG. 2 is a right side elevational view of the hand shower of FIG. 1.

FIG. 3 is a front elevational view of the hand shower of FIG. 1.

FIG. 4 is a rear elevational view of the hand shower of FIG. 1.

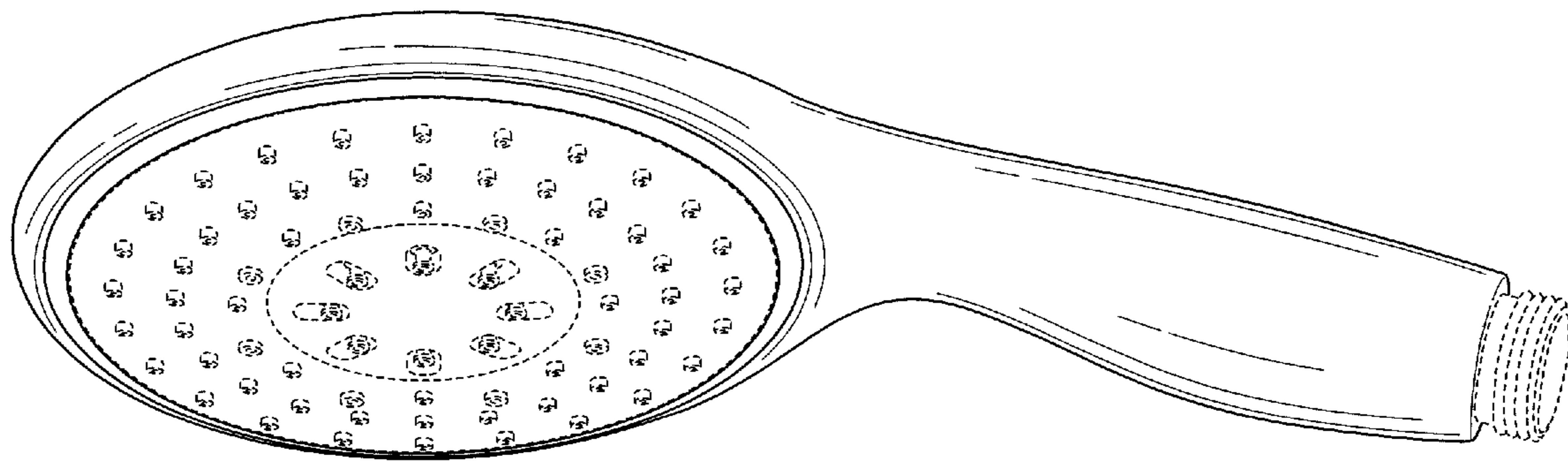
FIG. 5 is a top plan view of the hand shower of FIG. 1.

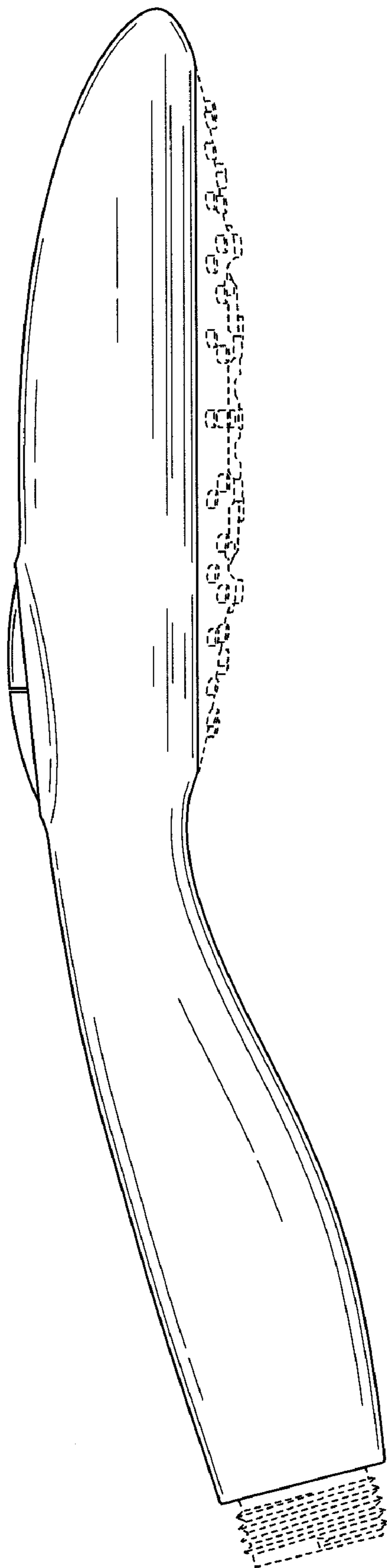

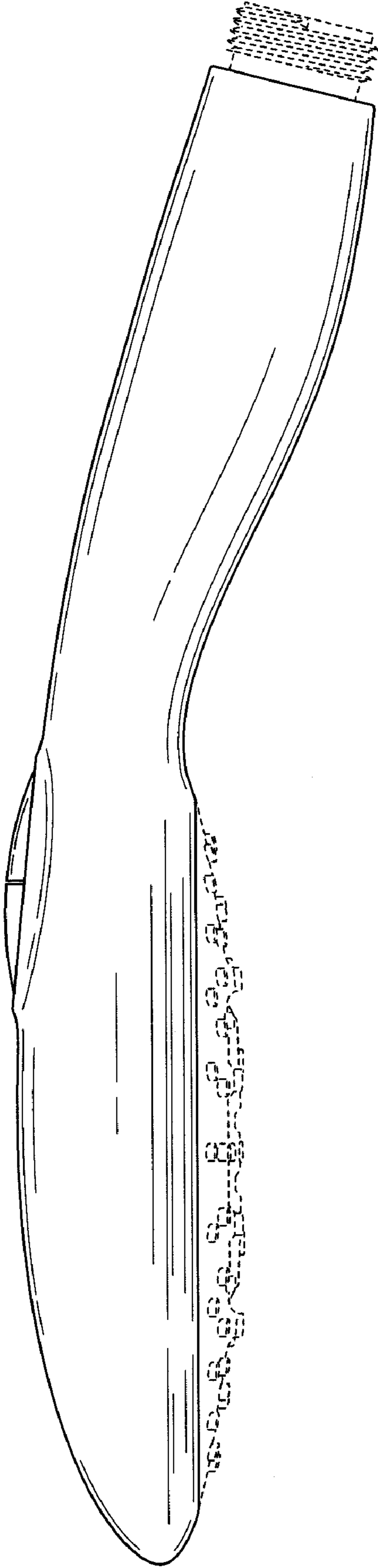

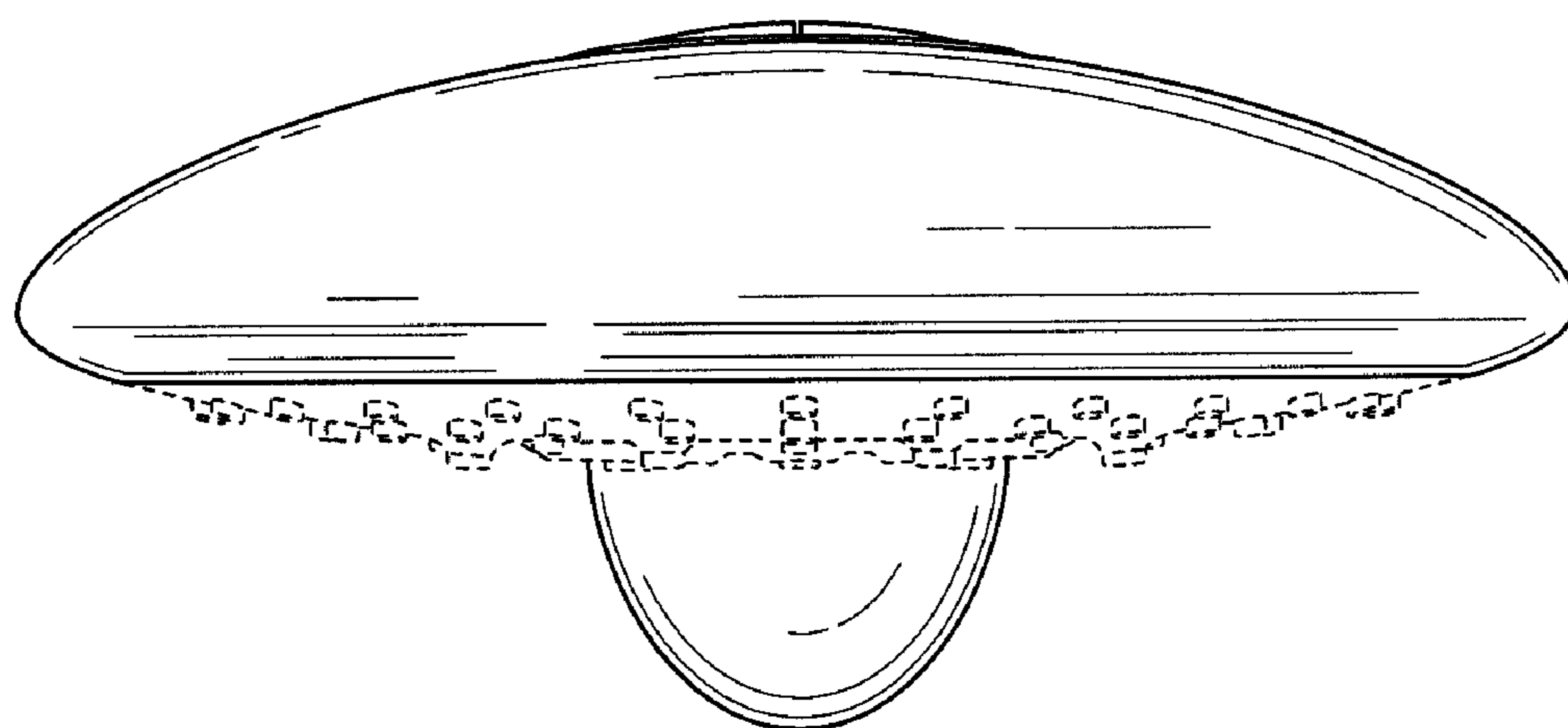

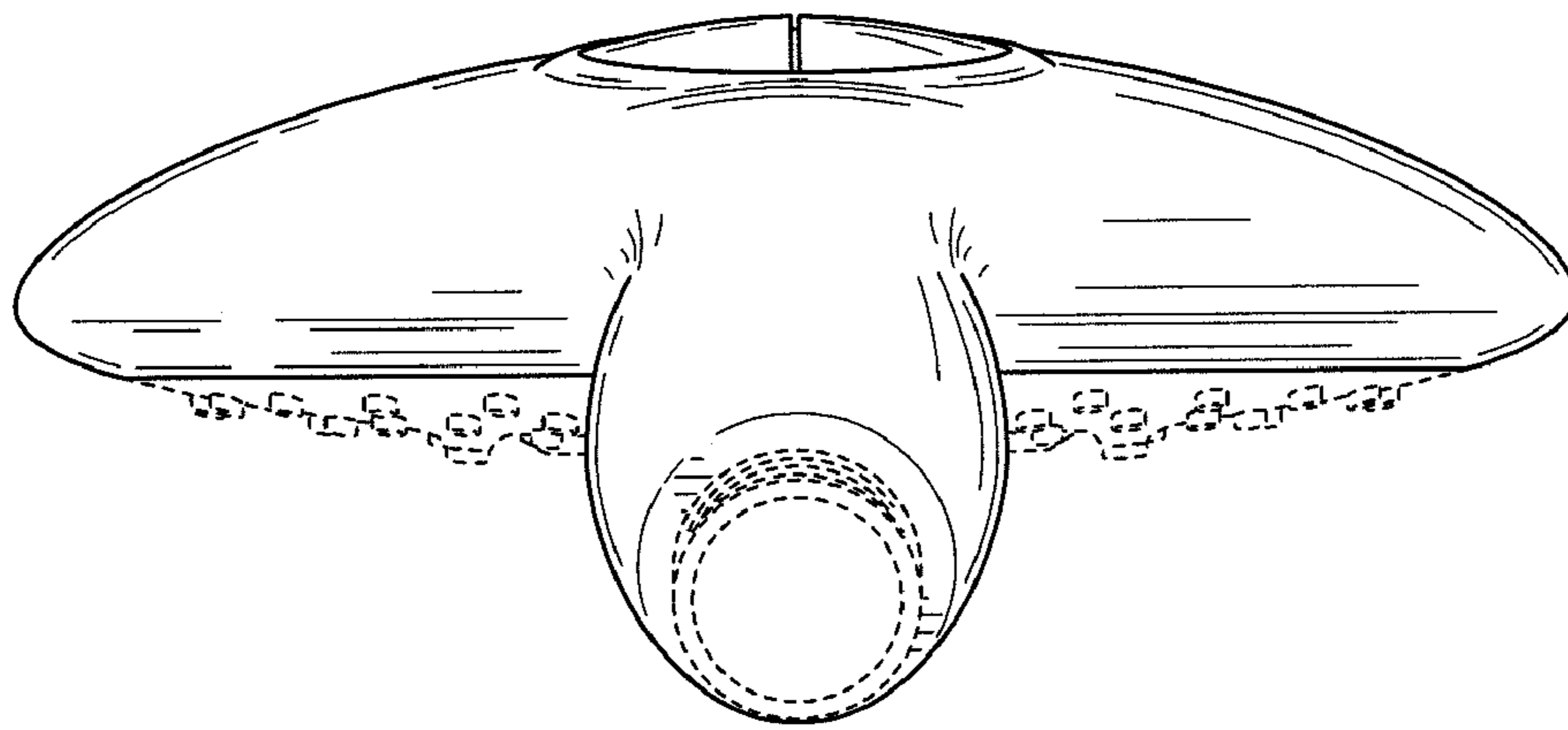

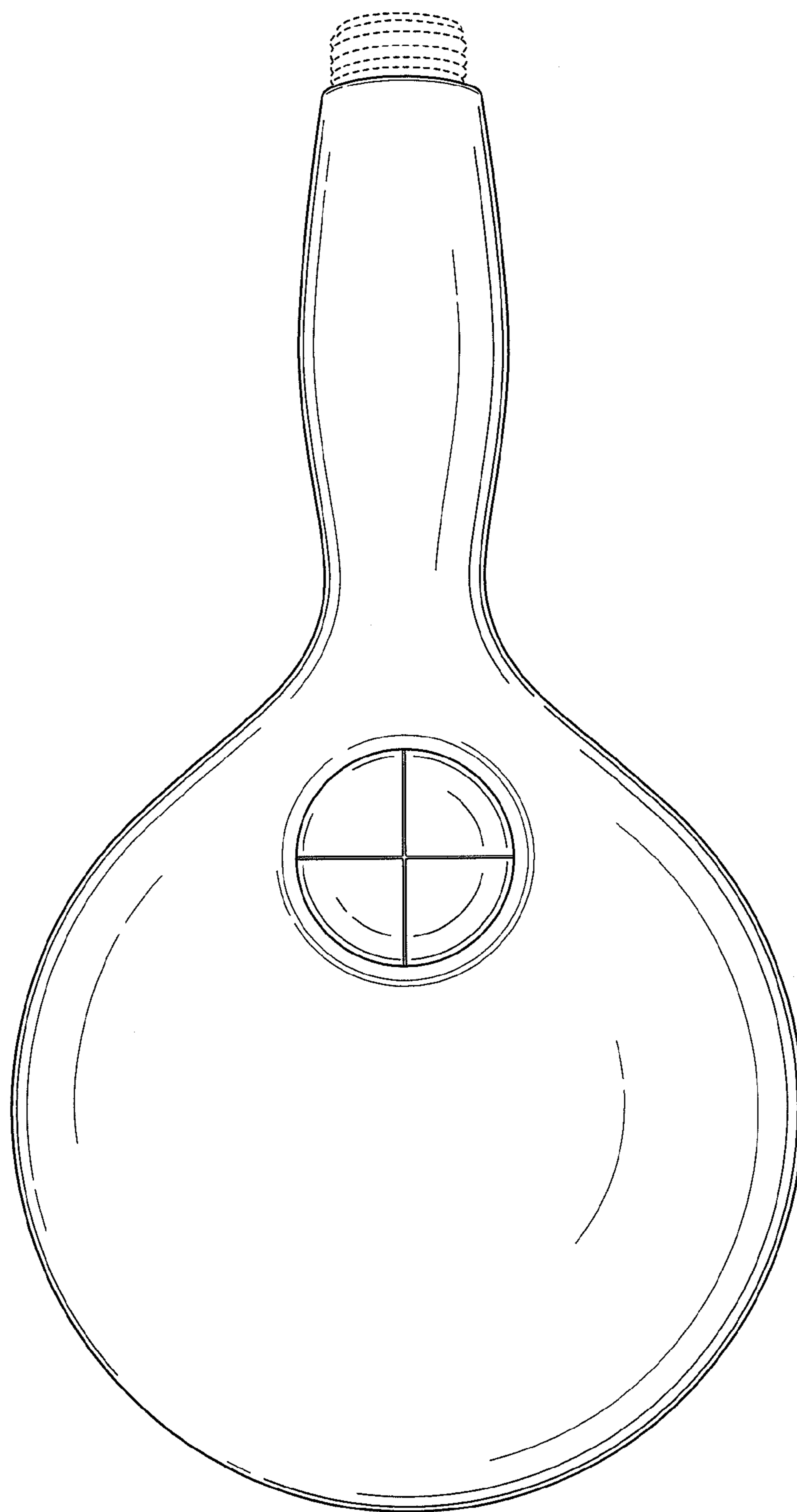

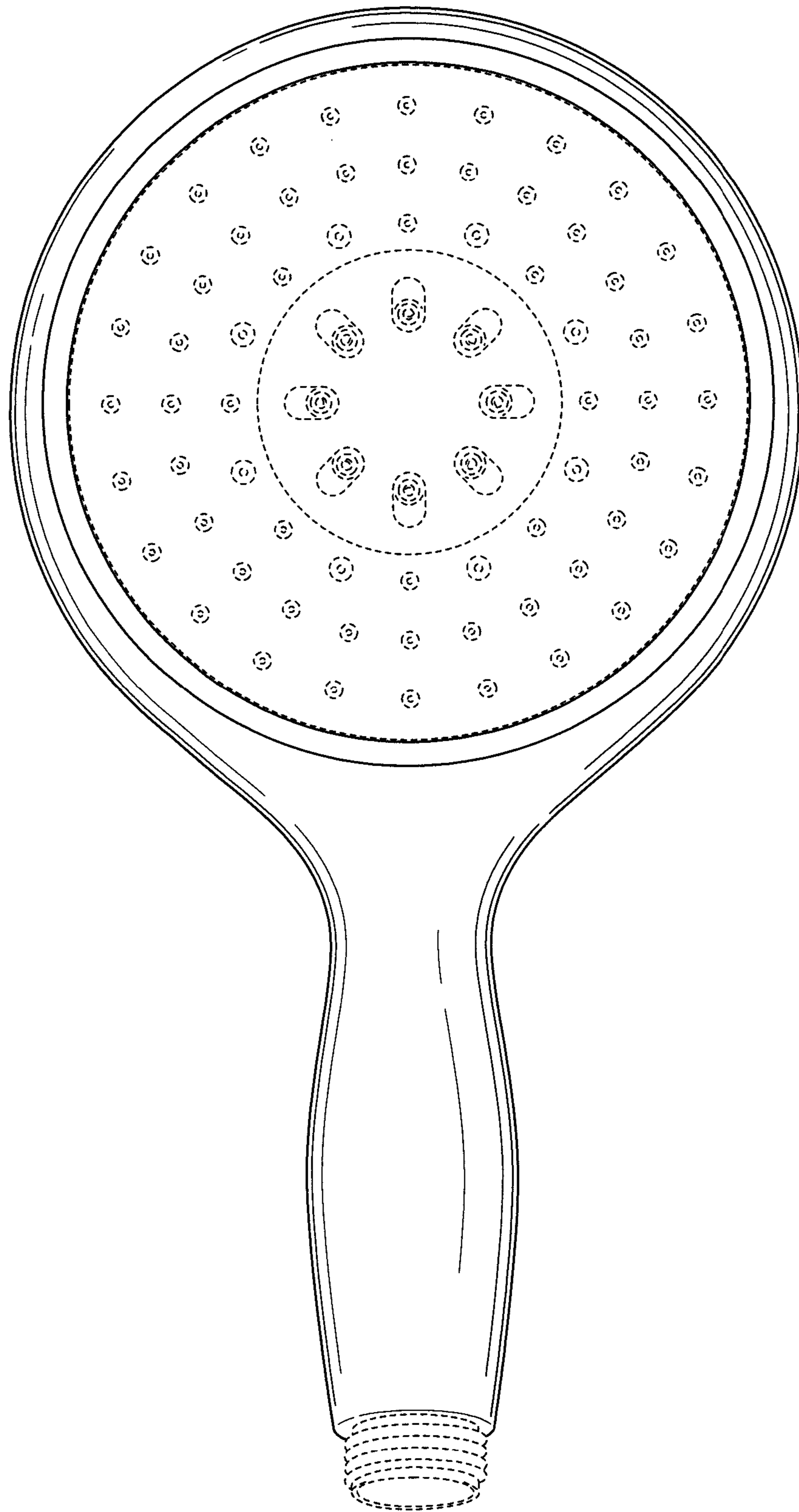

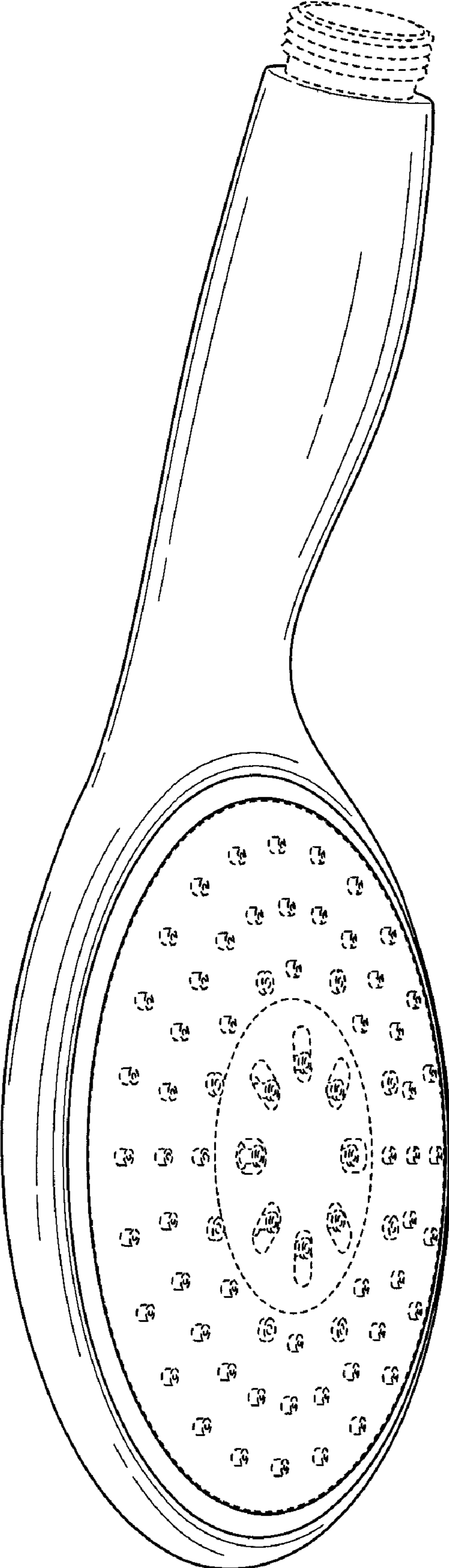
