(57) **CLAIM**

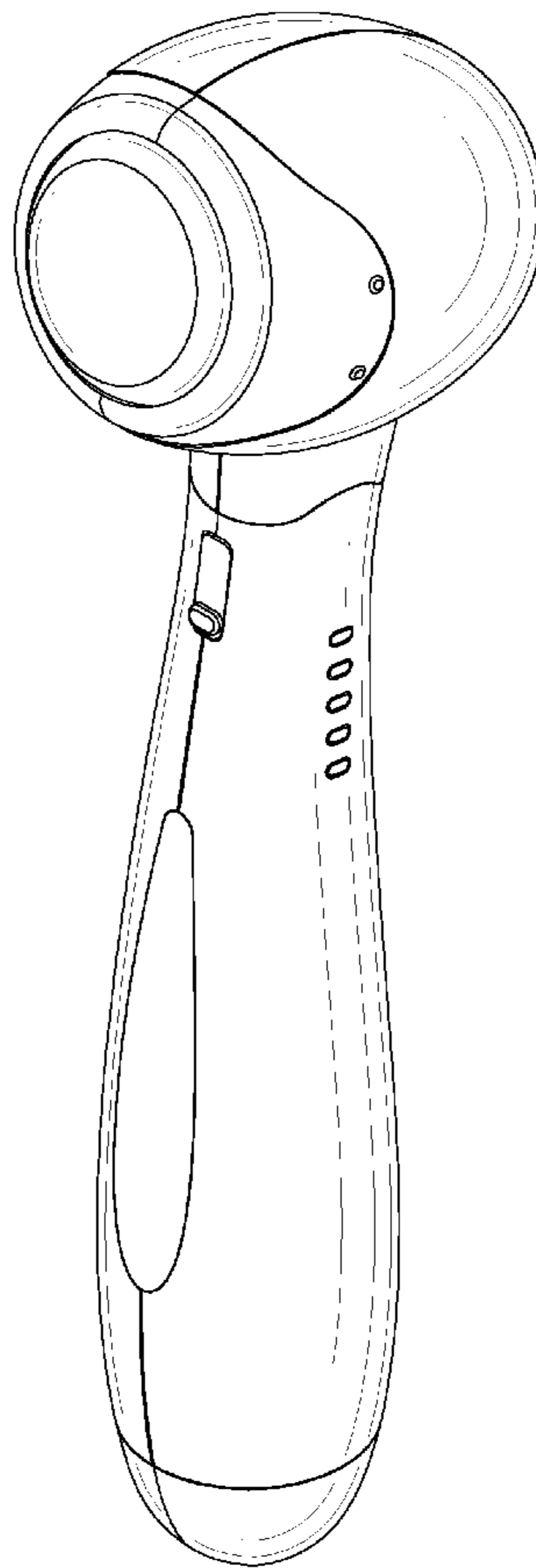
I claim the ornamental design for a facial massage tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a facial massage tool showing the design;

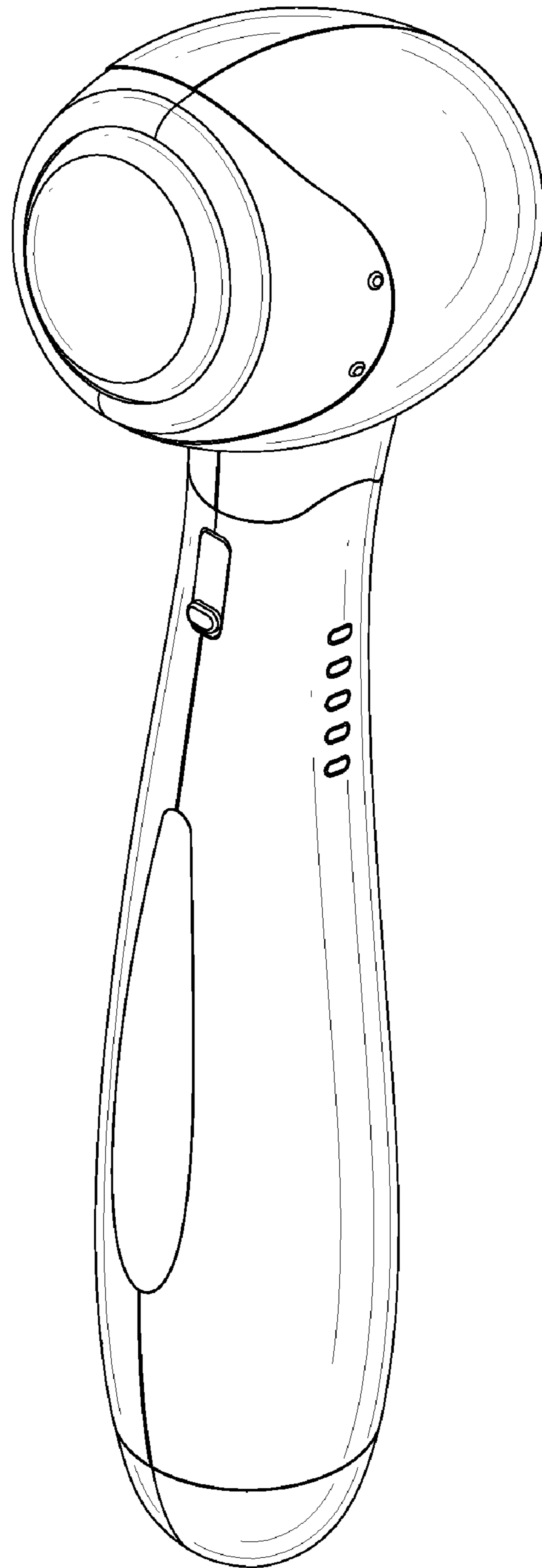

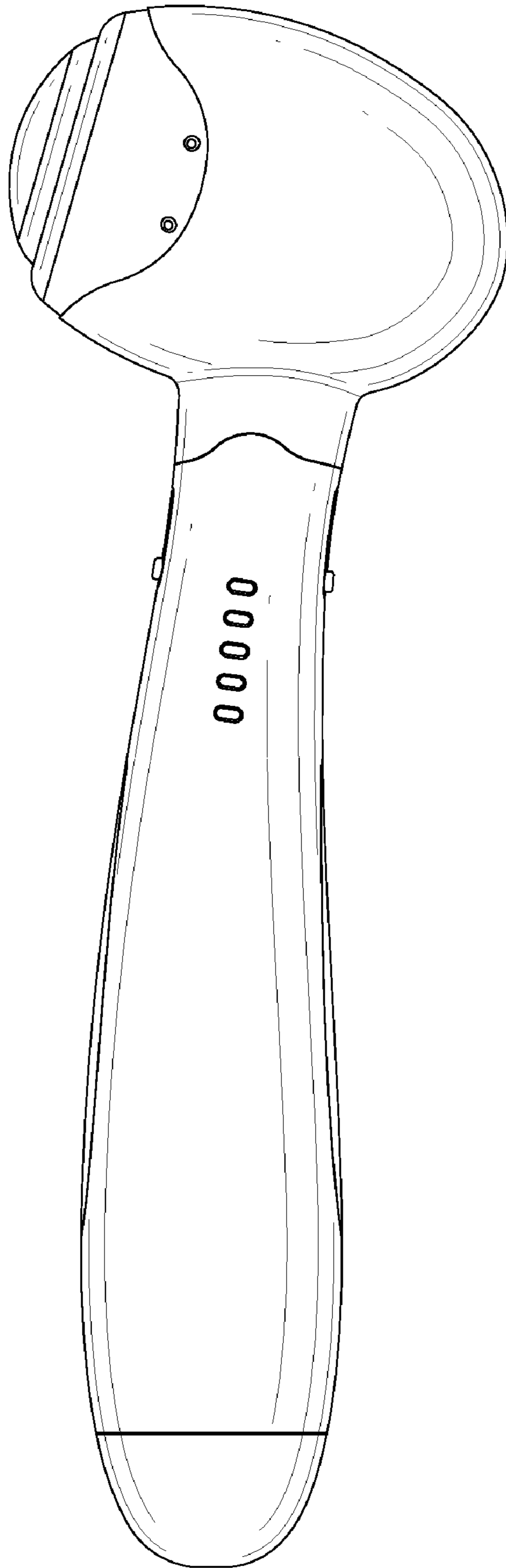

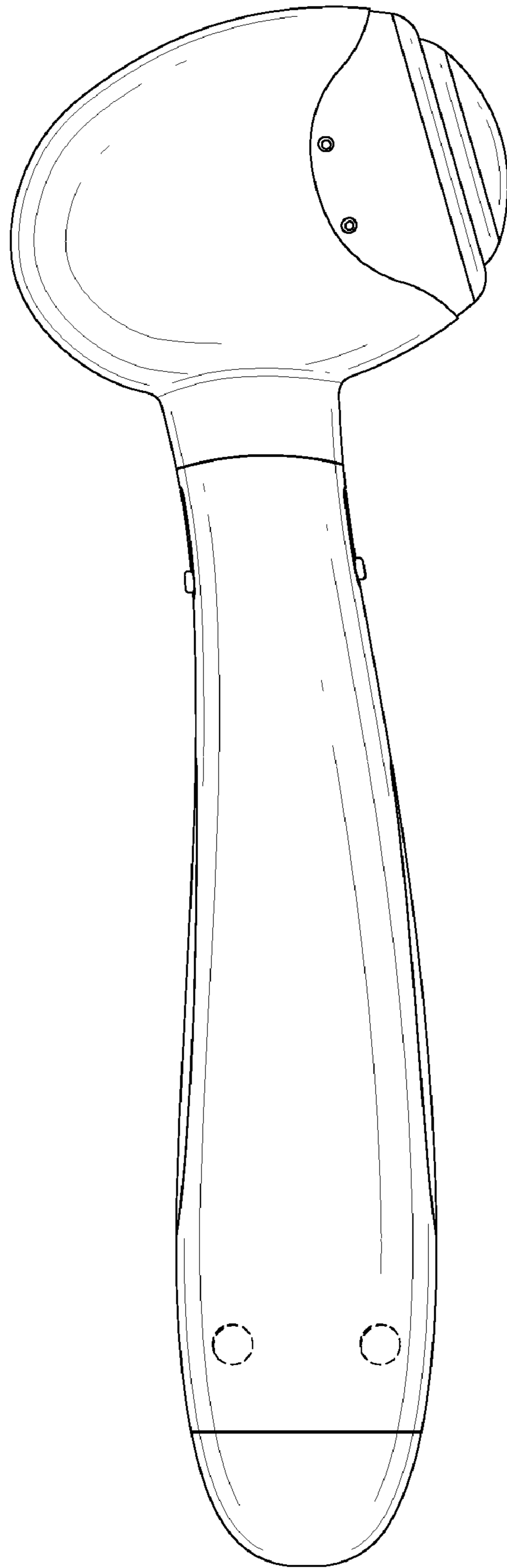

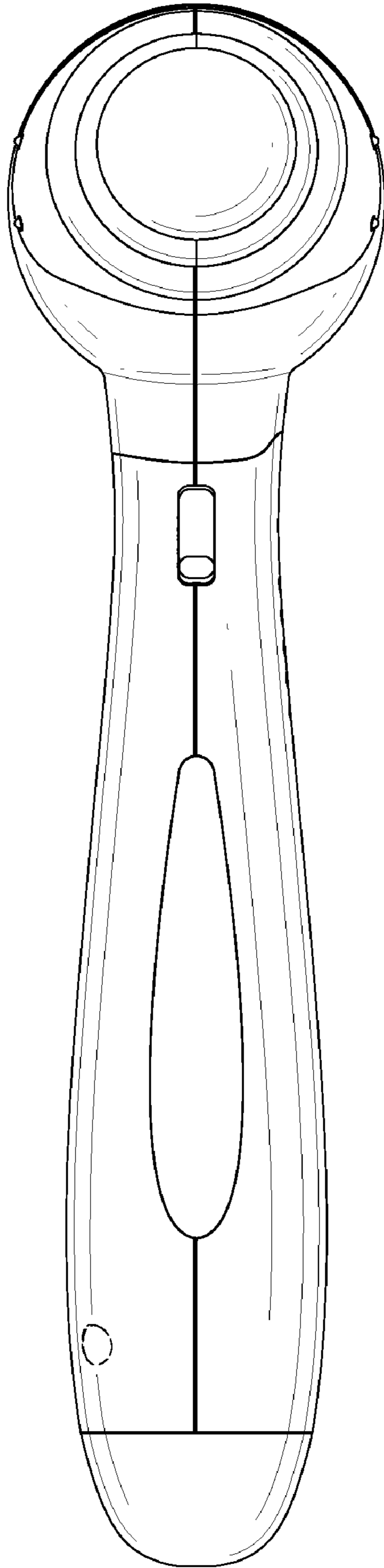

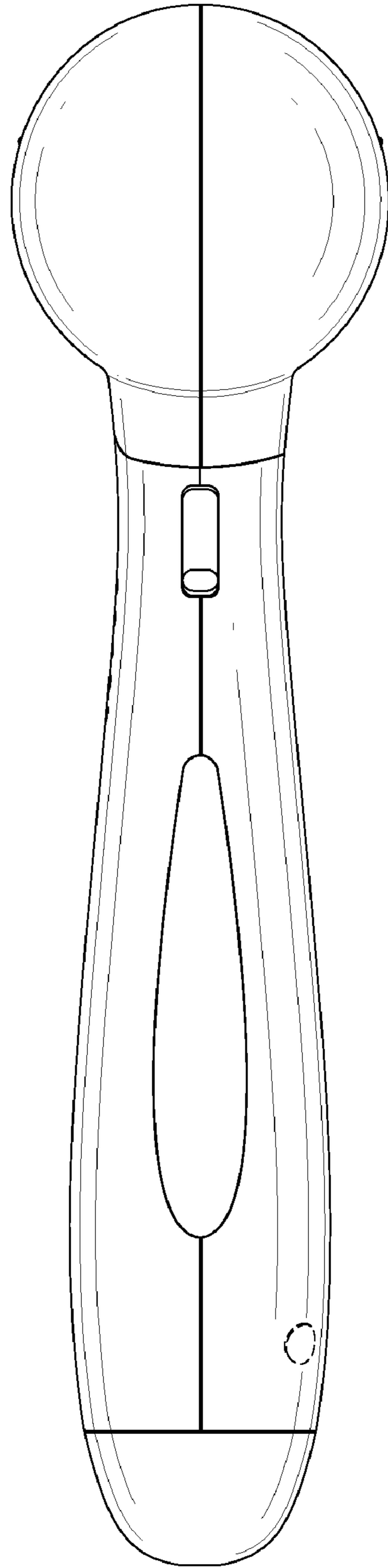

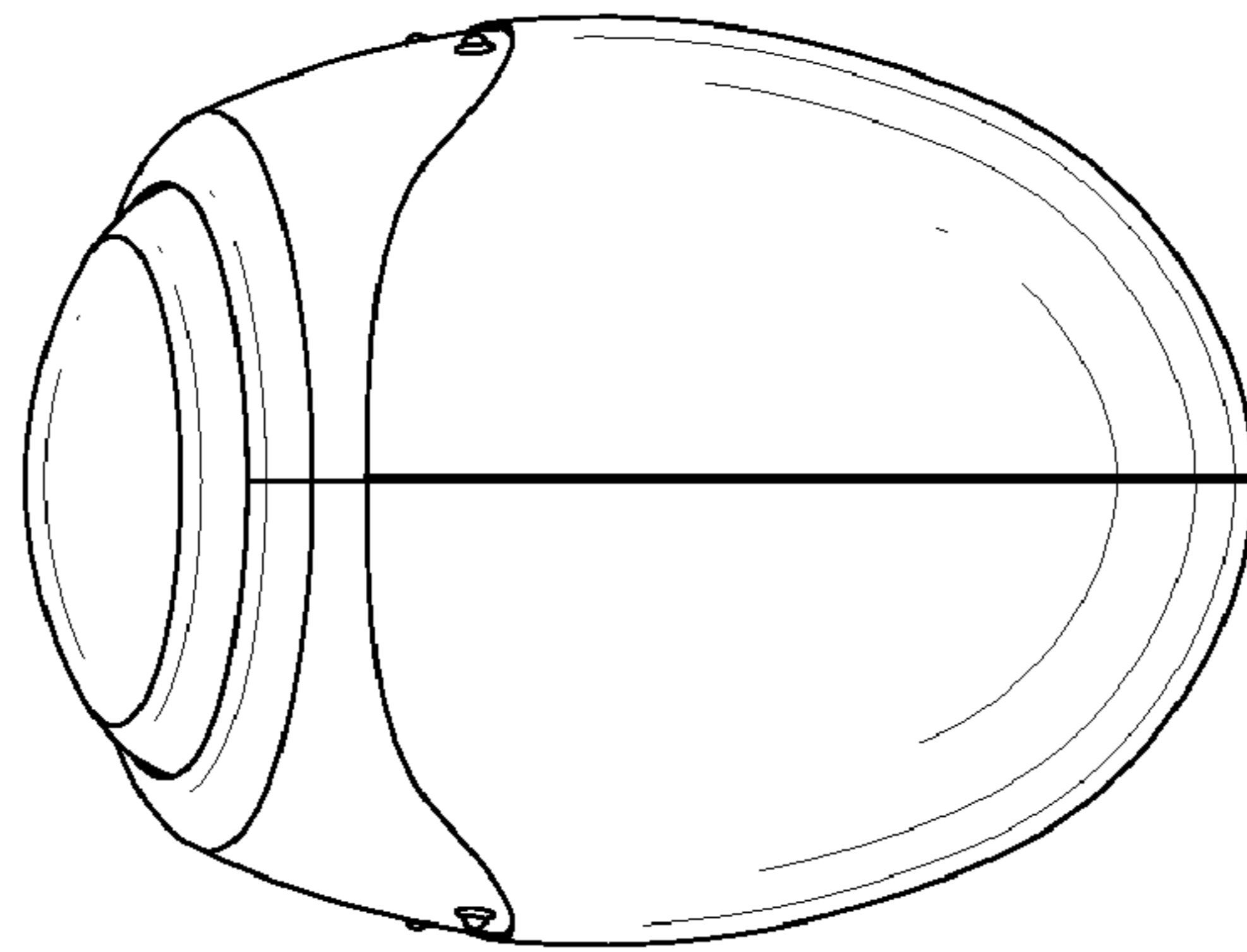

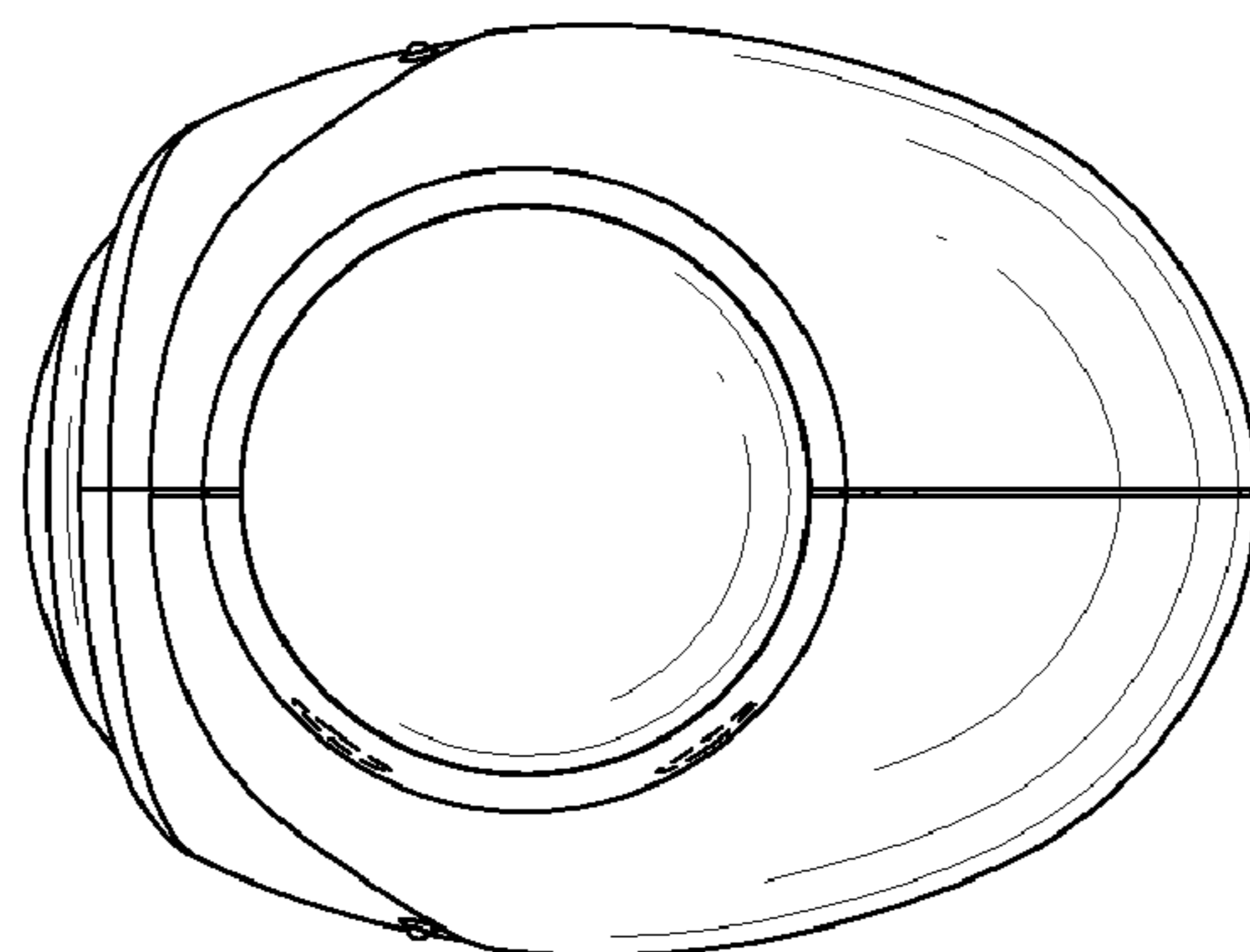
