DESCRIPTION

FIG. 1 is a perspective view of a front side of a laser medical instrument.
FIG. 2 is a perspective view of the opposite side of FIG. 1;
FIG. 3 is a front view of FIG. 1;

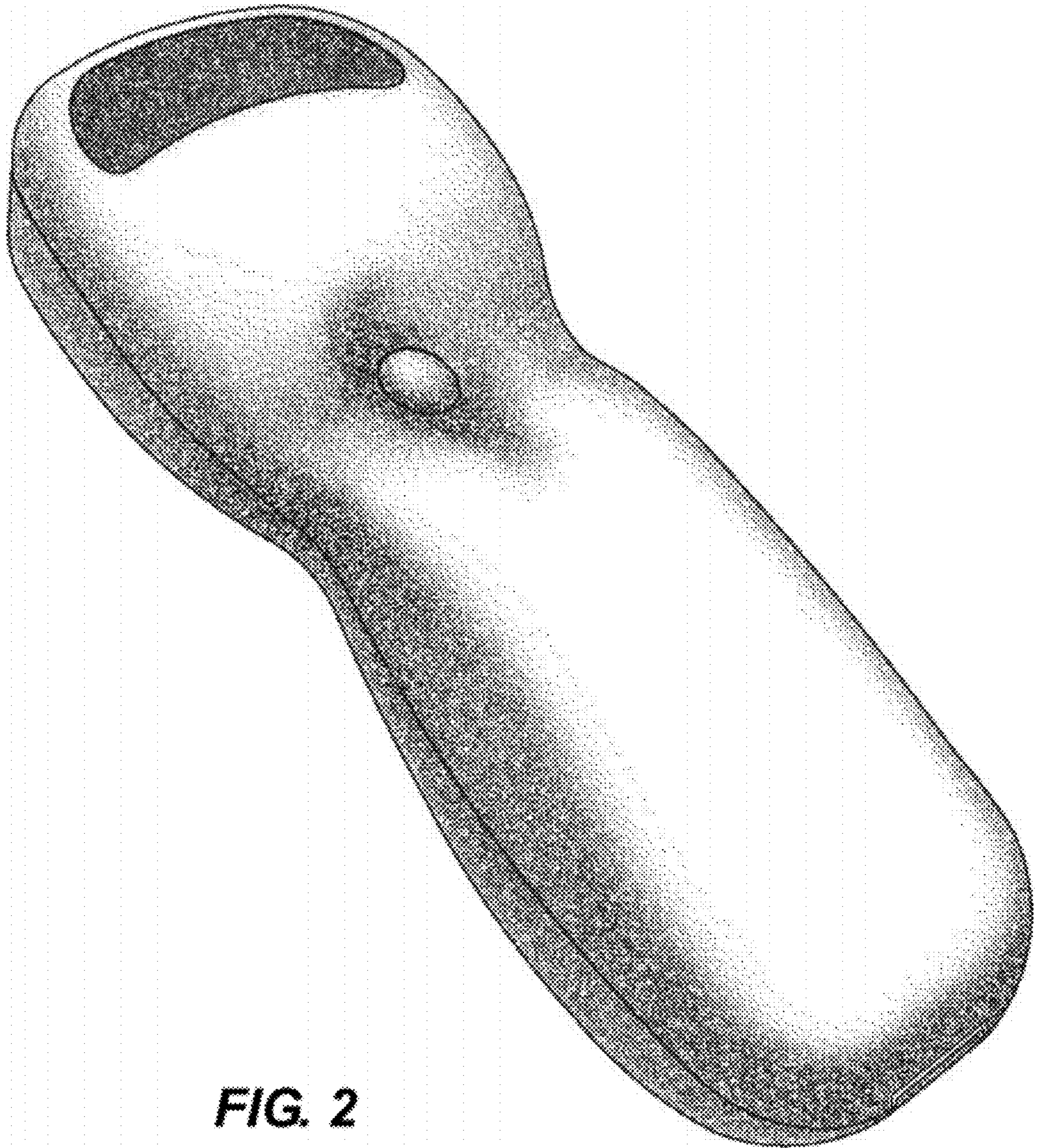

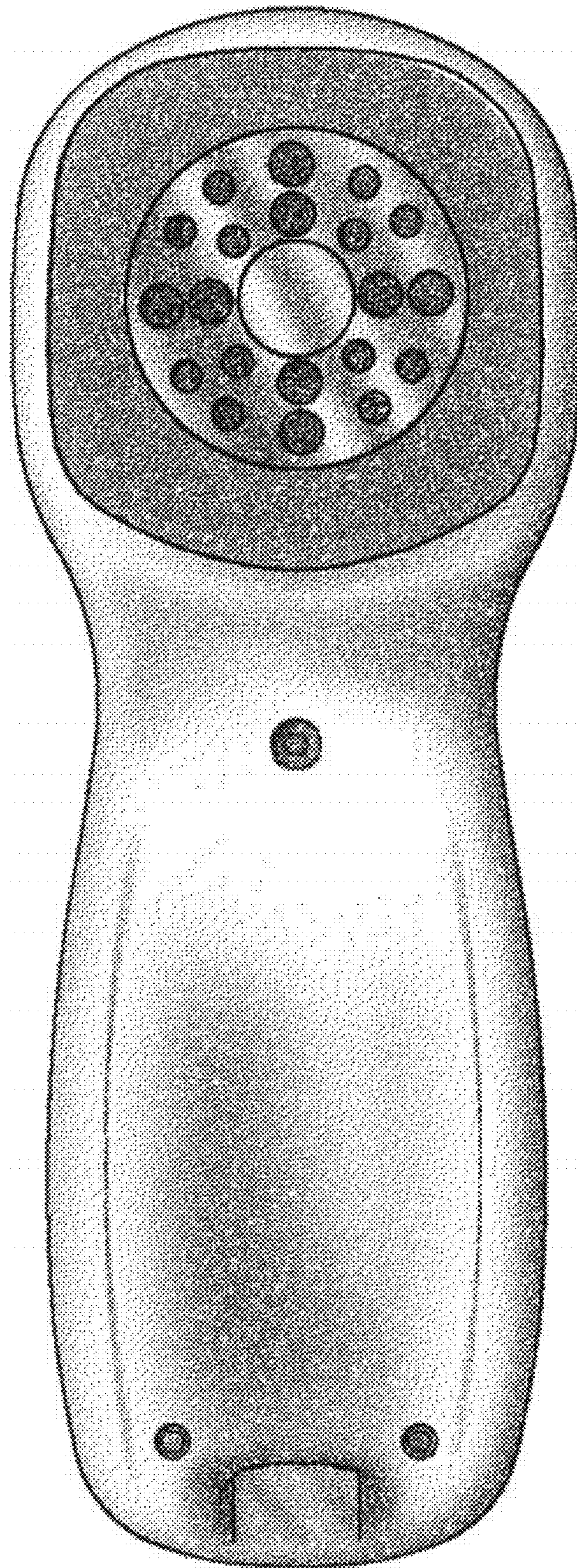

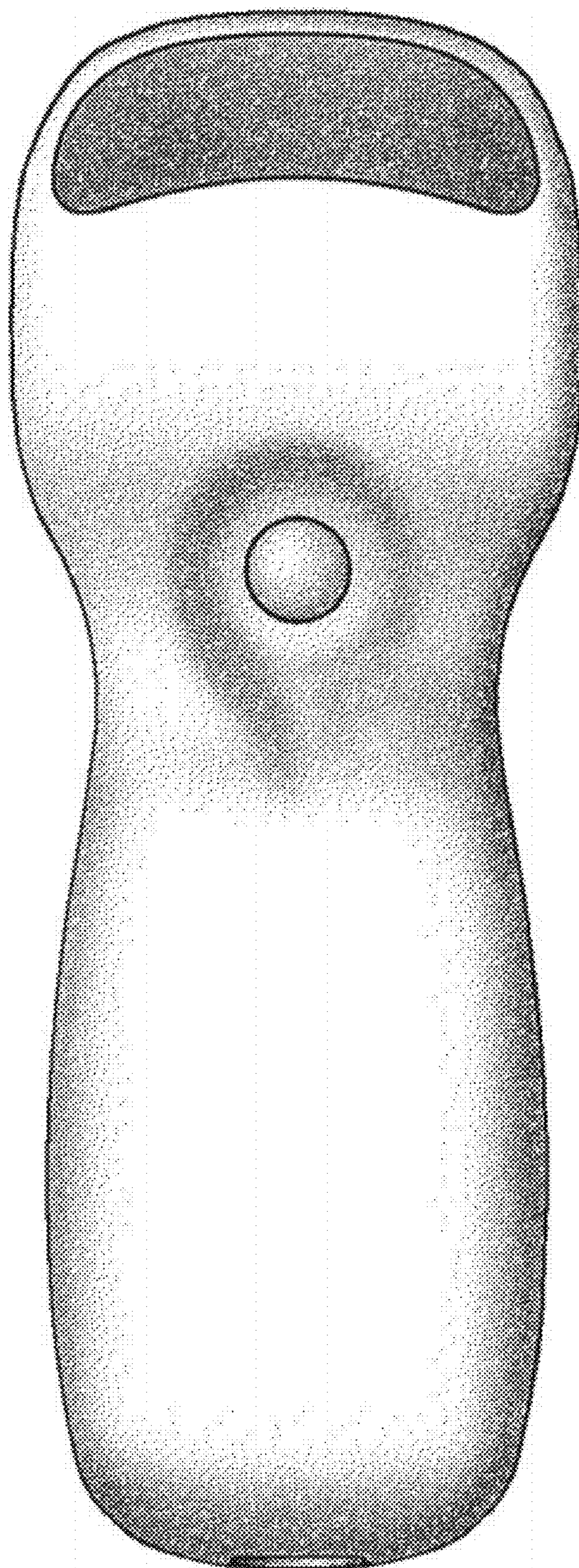

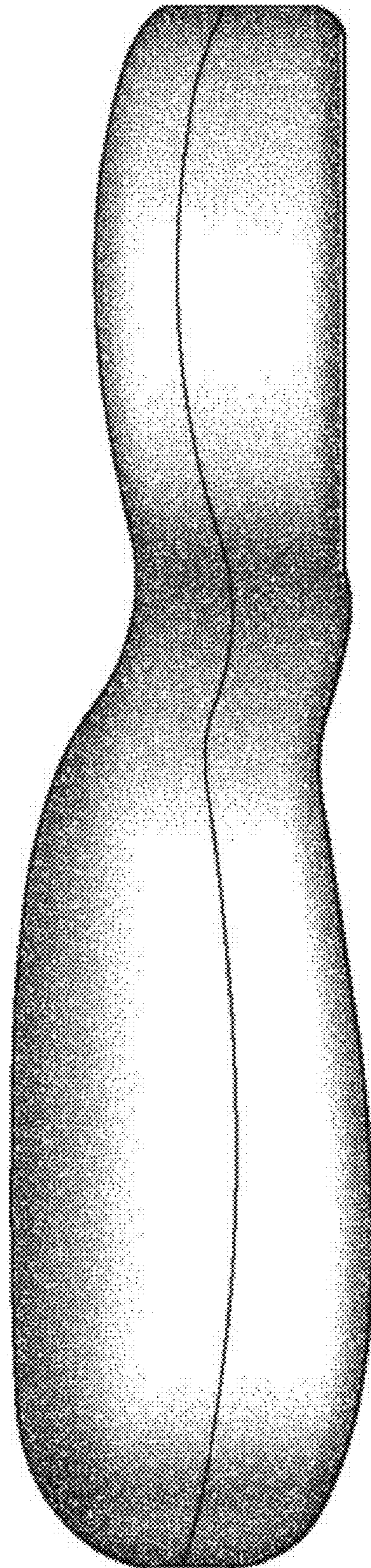

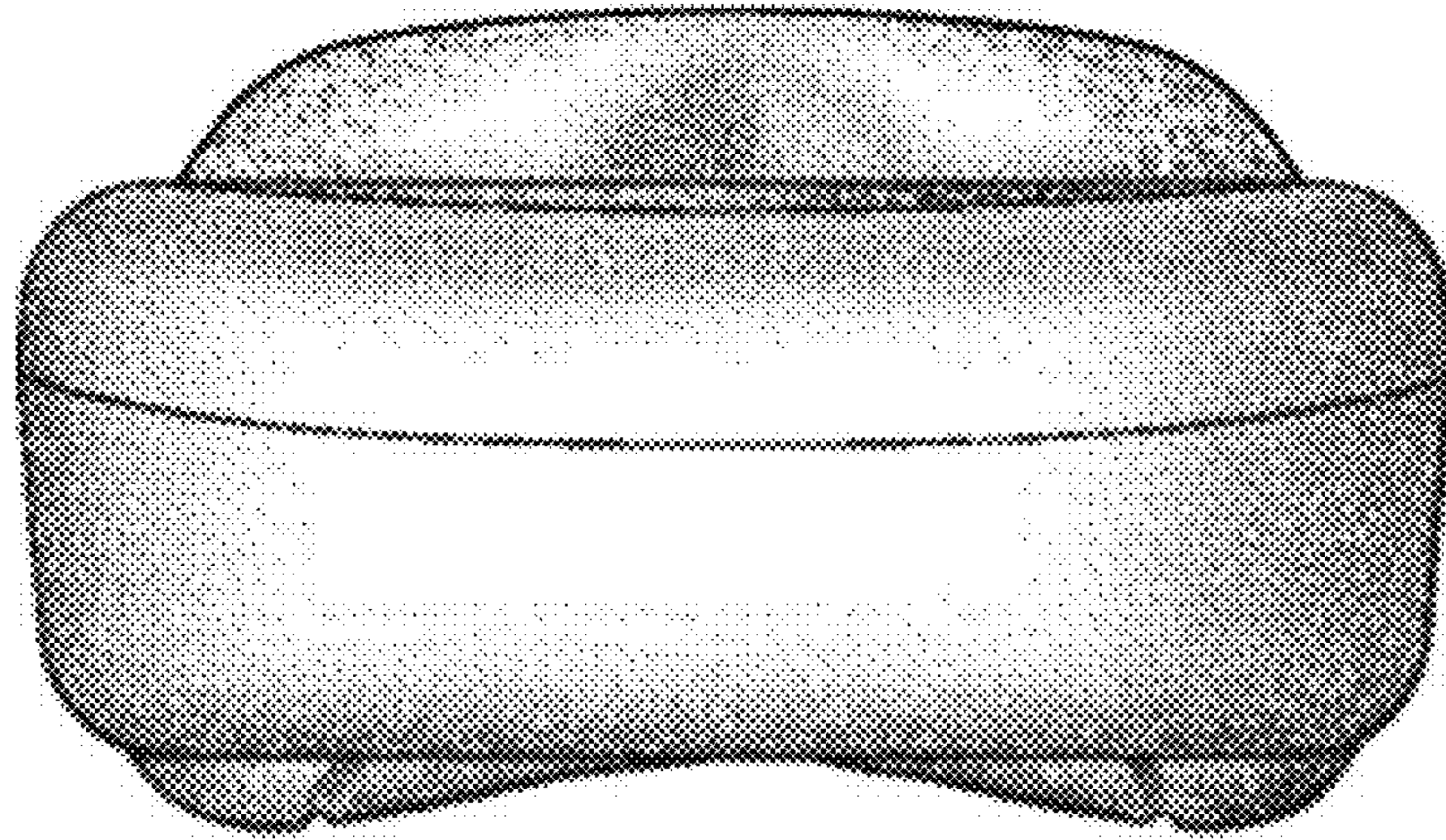

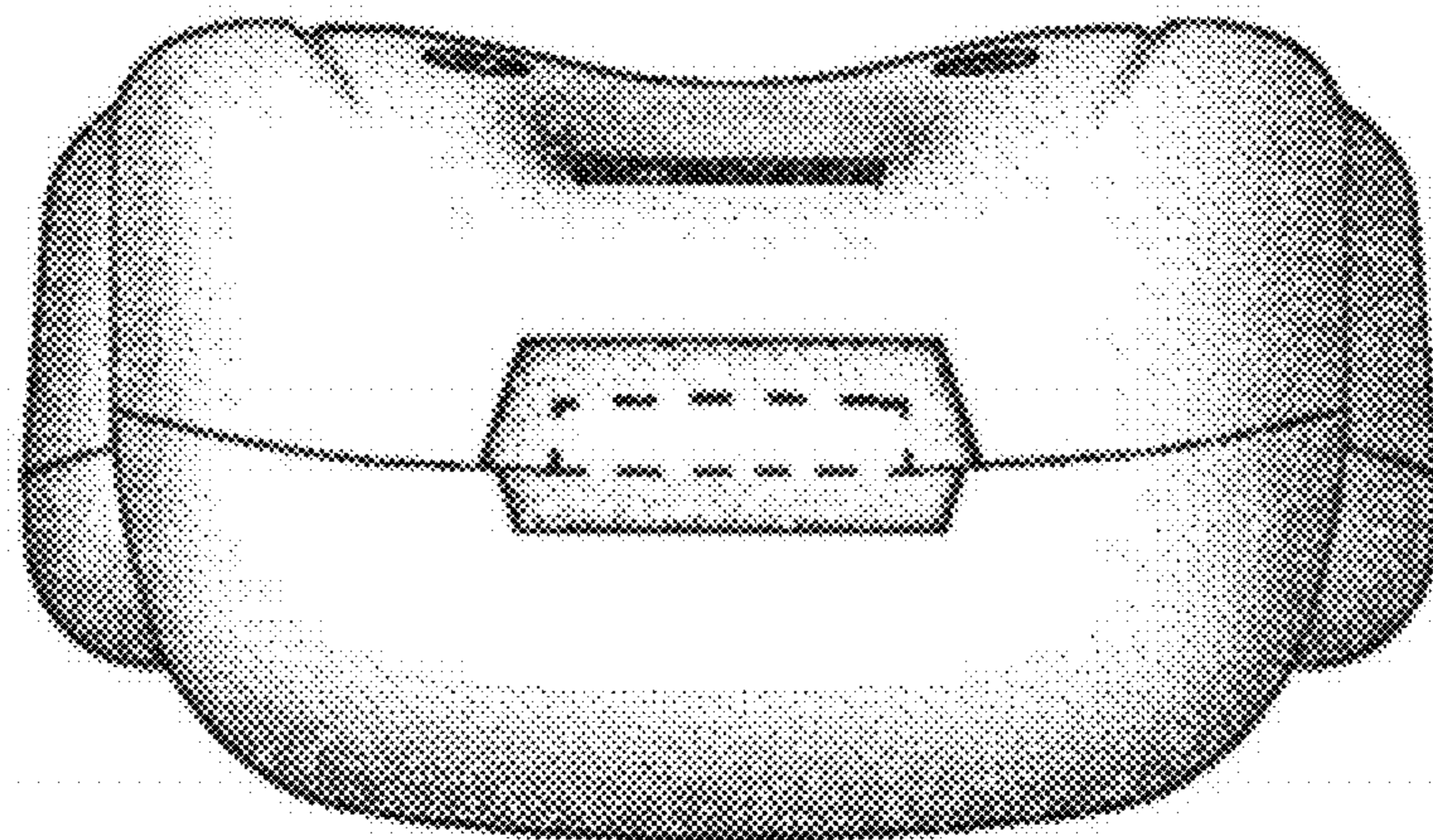
