The ornamental design for a test tube rack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a test tube rack showing my new design;

FIG. 2 is a perspective view of the top portion of the test tube rack seen in FIG. 1 shown separately for clarity of illustration;

FIG. 3 is a side view of FIG. 2;

FIG. 4 is a front or rear view of FIG. 2;

FIG. 5 is a top plan view of FIG. 2;

FIG. 6 is a bottom plan view of FIG. 2;

FIG. 7 is a perspective view of the center portion of the test tube rack seen in FIG. 1 shown separately for clarity of illustration;

FIG. 8 is a front or rear view of FIG. 7;

FIG. 9 is a side view of FIG. 7;

FIG. 10 is a top plan view of FIG. 7;

FIG. 11 is a bottom plan view of FIG. 7;

FIG. 12 is a perspective view of the bottom portion of the test tube rack seen in FIG. 1 shown separately for clarity of illustration;

FIG. 14 is a front or rear view of FIG. 12;

FIG. 15 is a top plan view of FIG. 12;

FIG. 16 is a bottom plan view of FIG. 12;

FIG. 17 is a perspective view of the detachable portion of the top and center portions of the test tube rack seen in FIG. 1 shown separately for clarity of illustration;

FIG. 18 is a front or rear view of FIG. 17;

FIG. 19 is a right side view of FIG. 17;

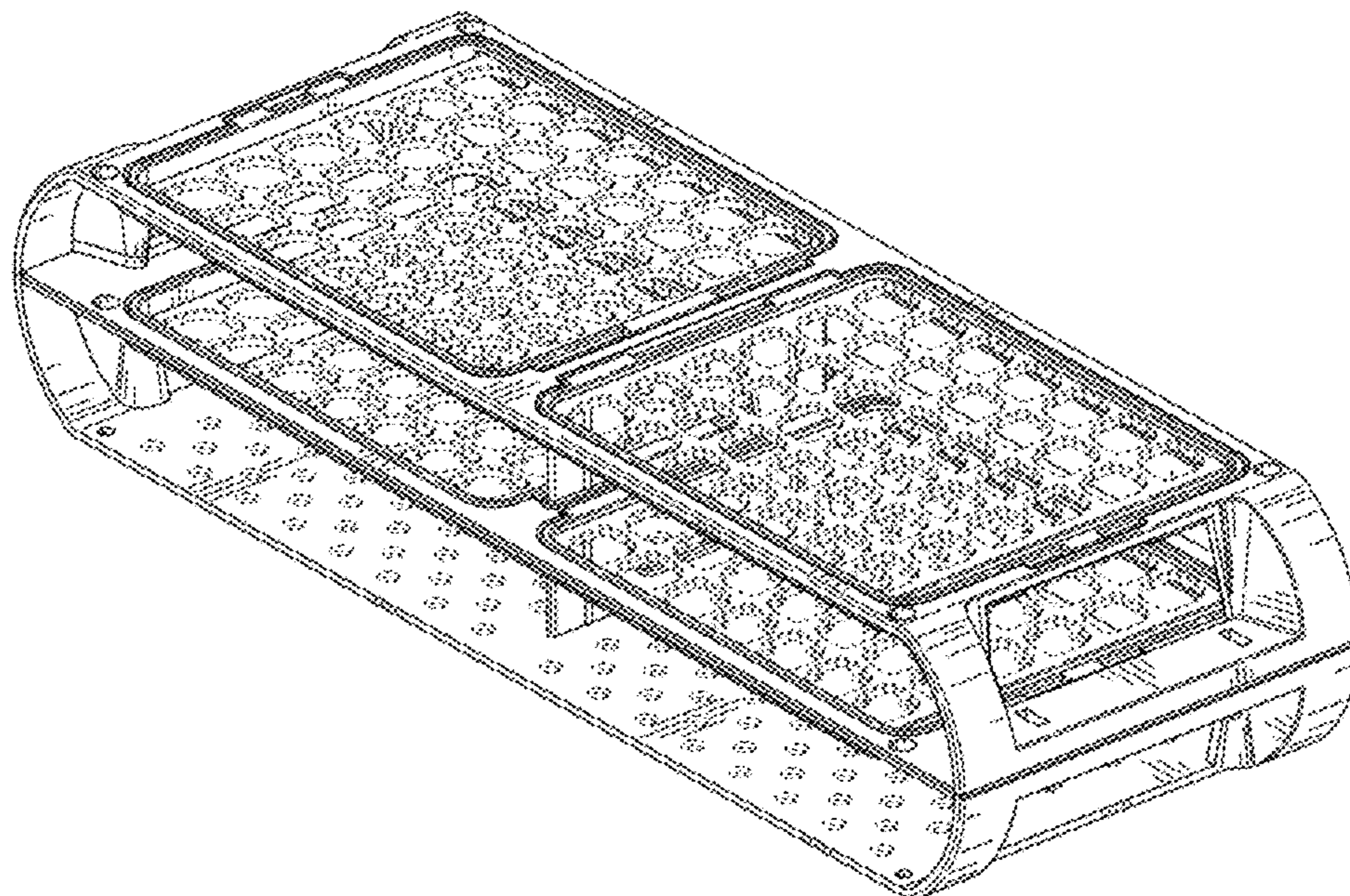
FIG. 20 is a left side view of FIG. 17;

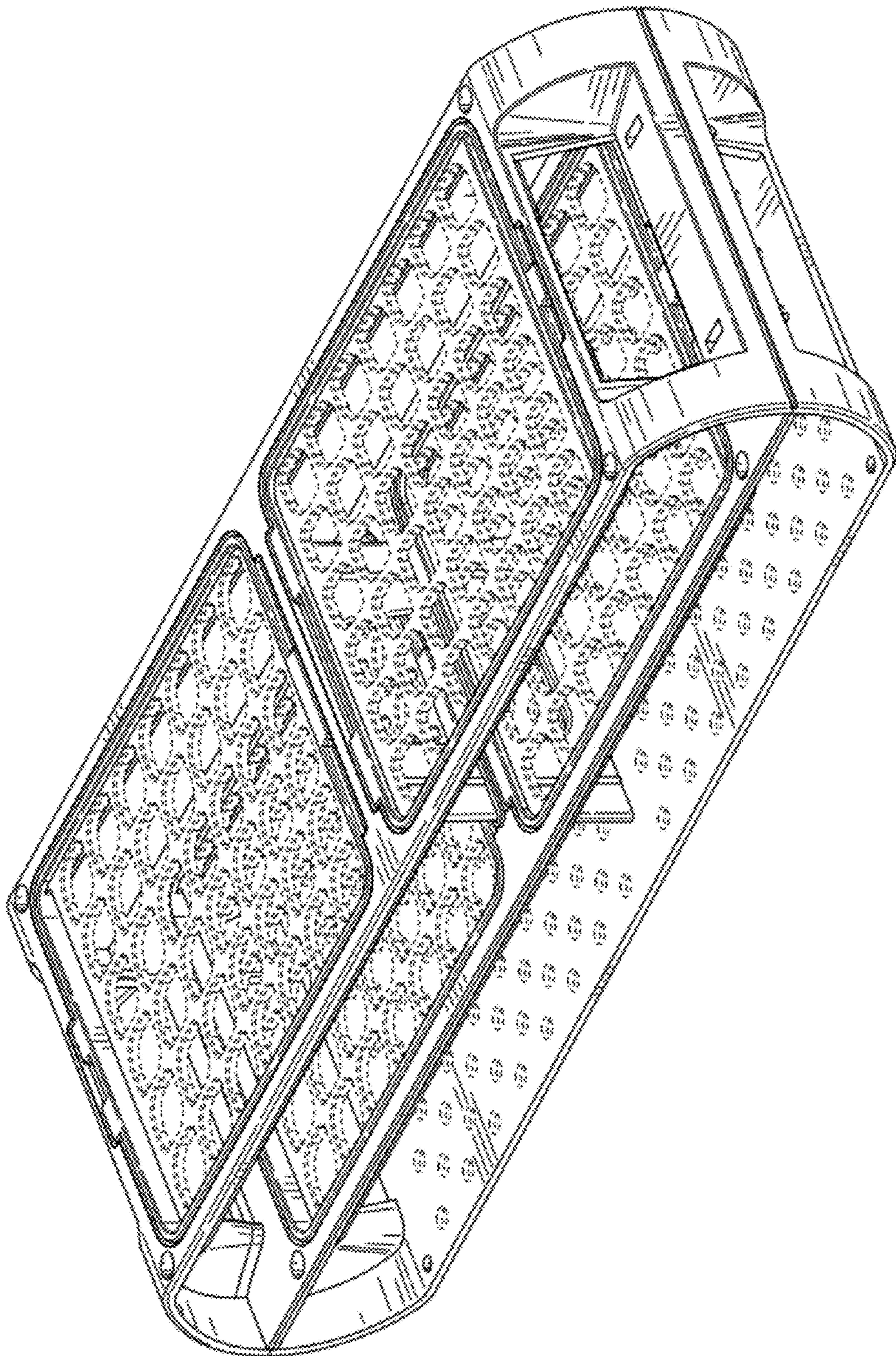

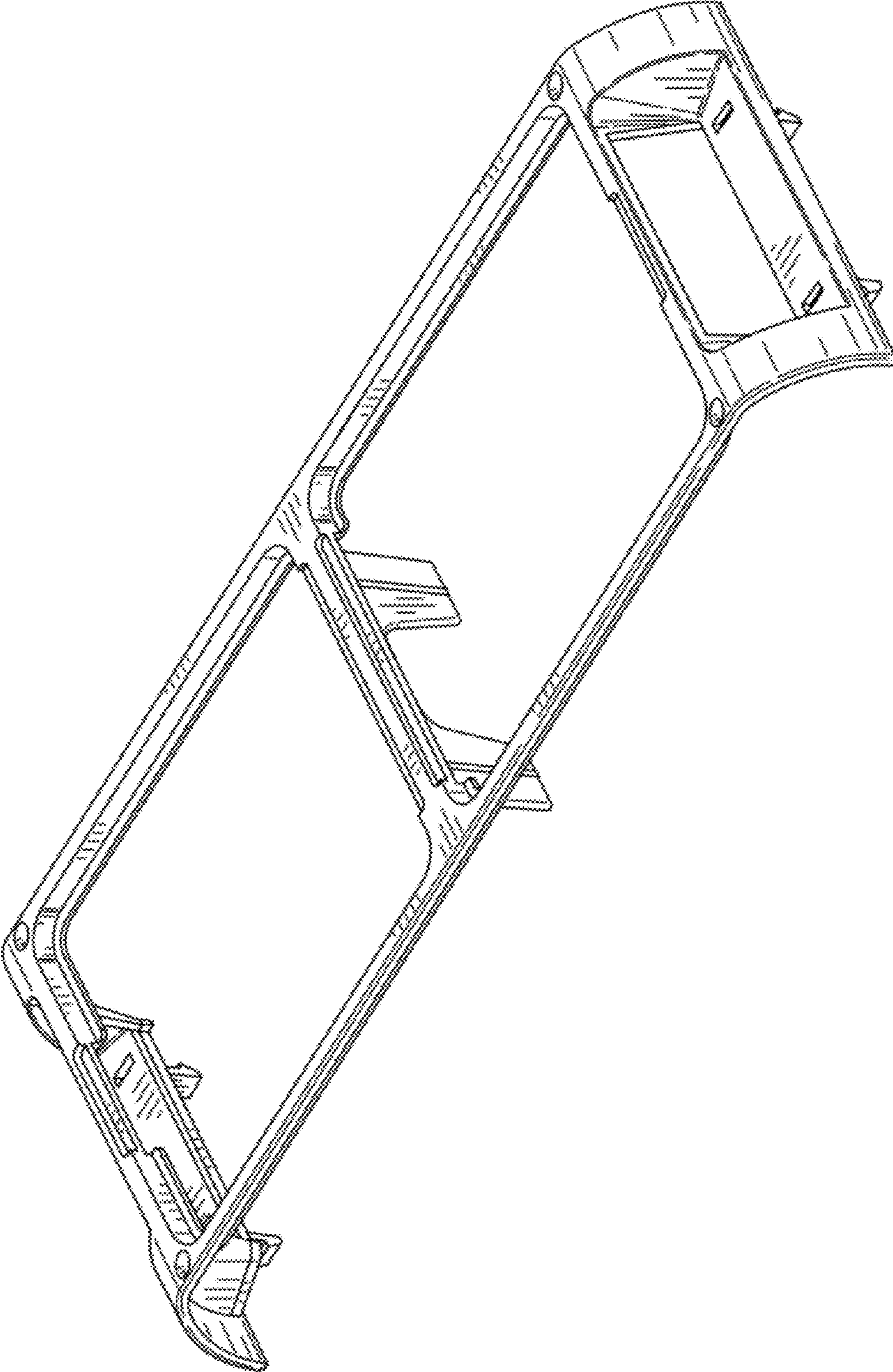

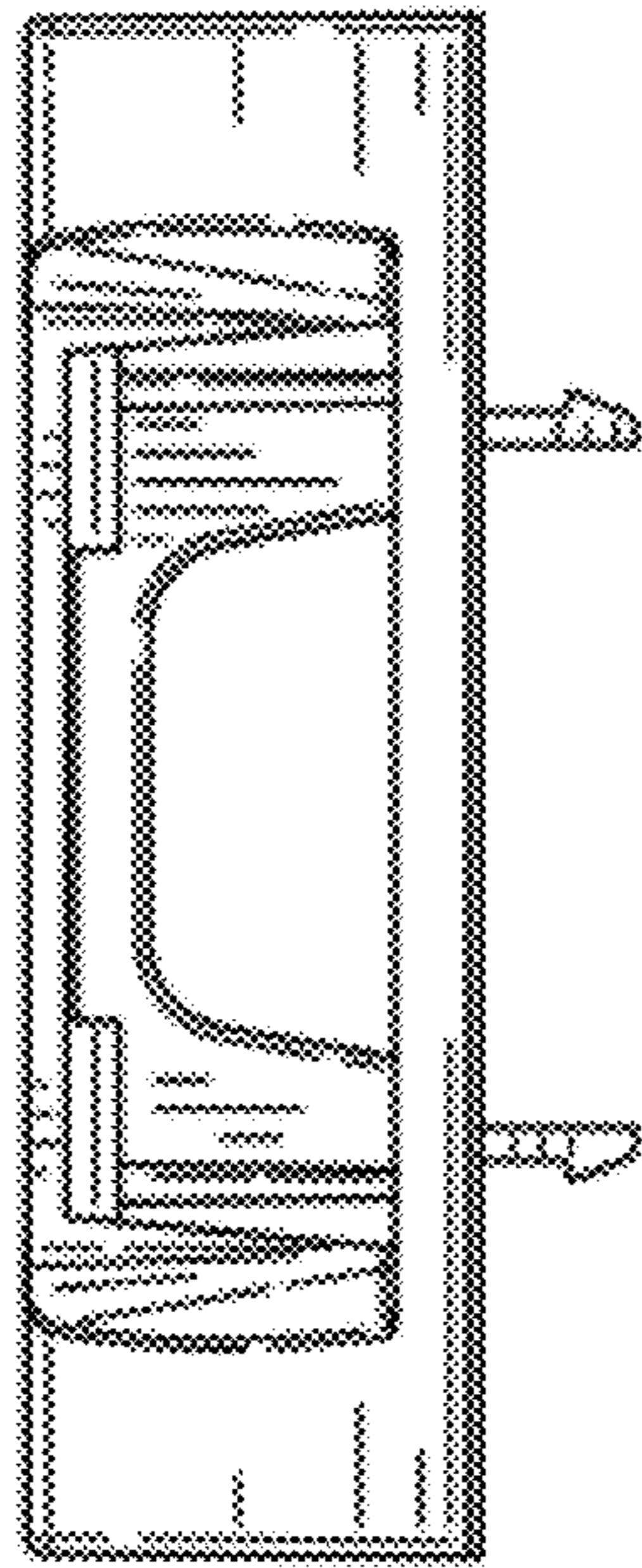

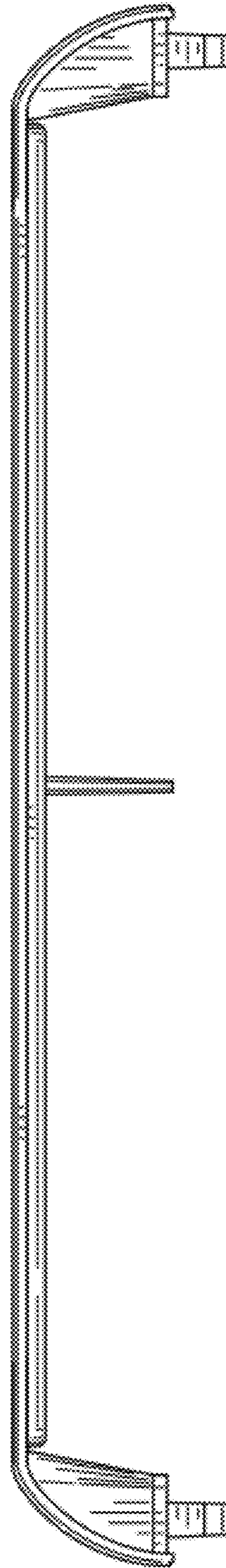

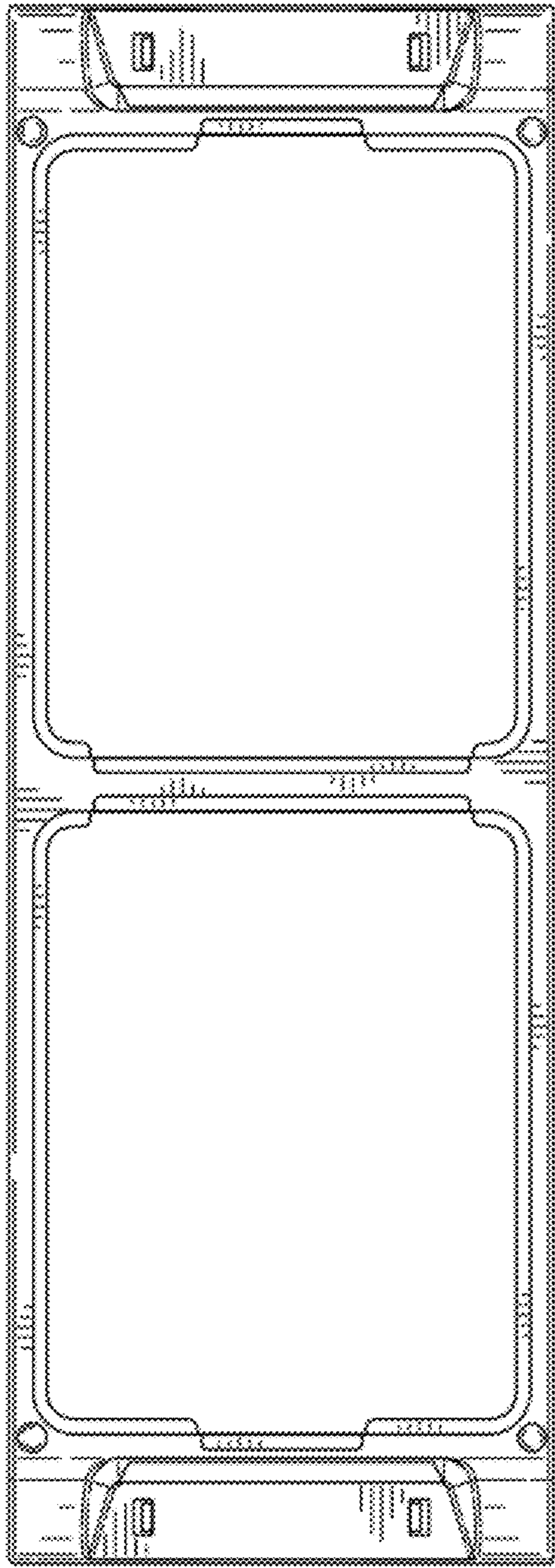

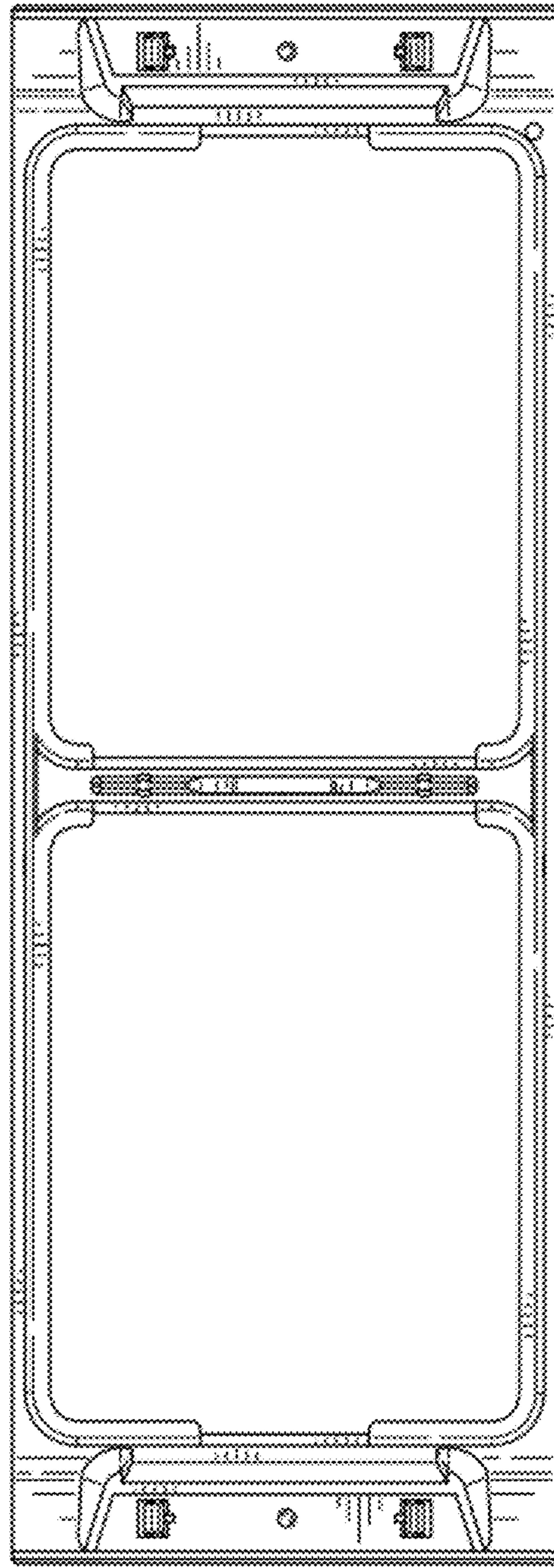

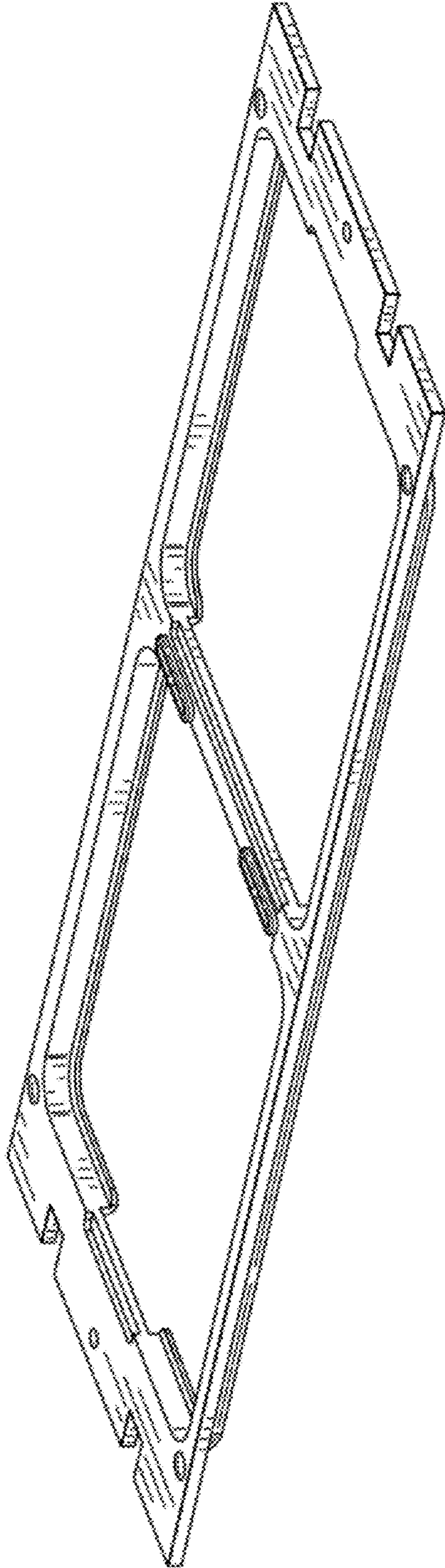

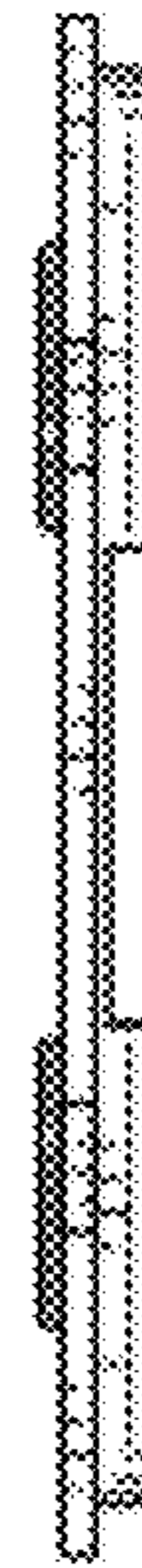

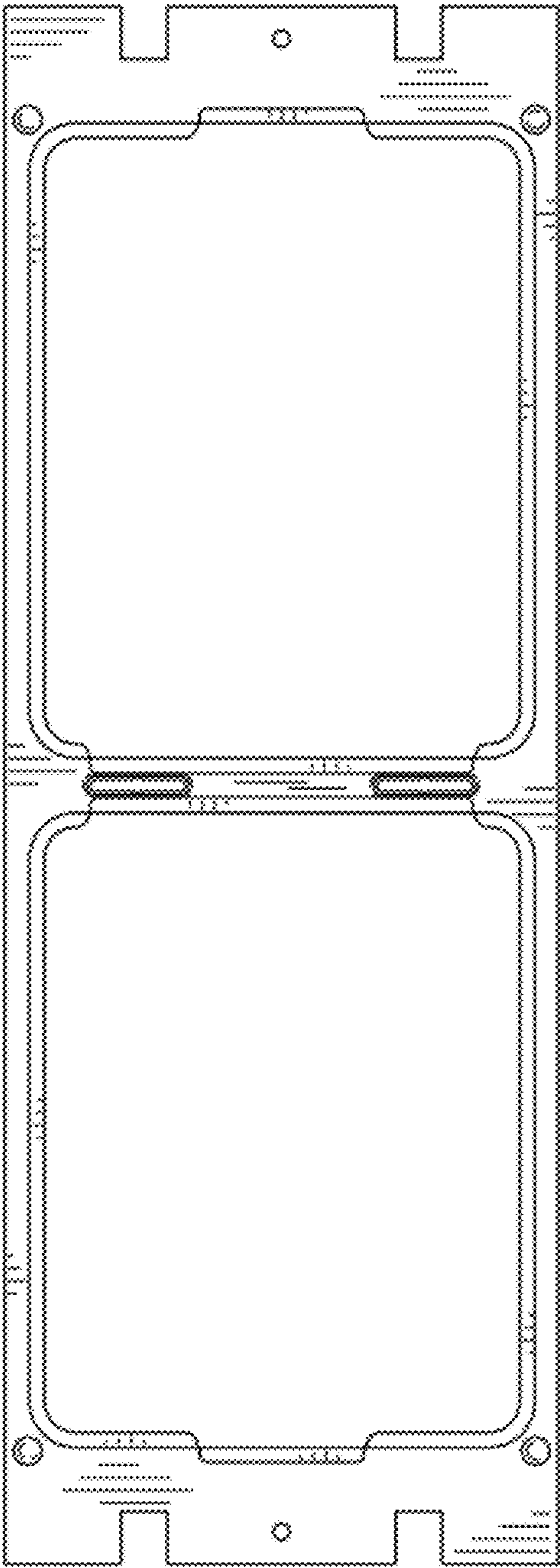

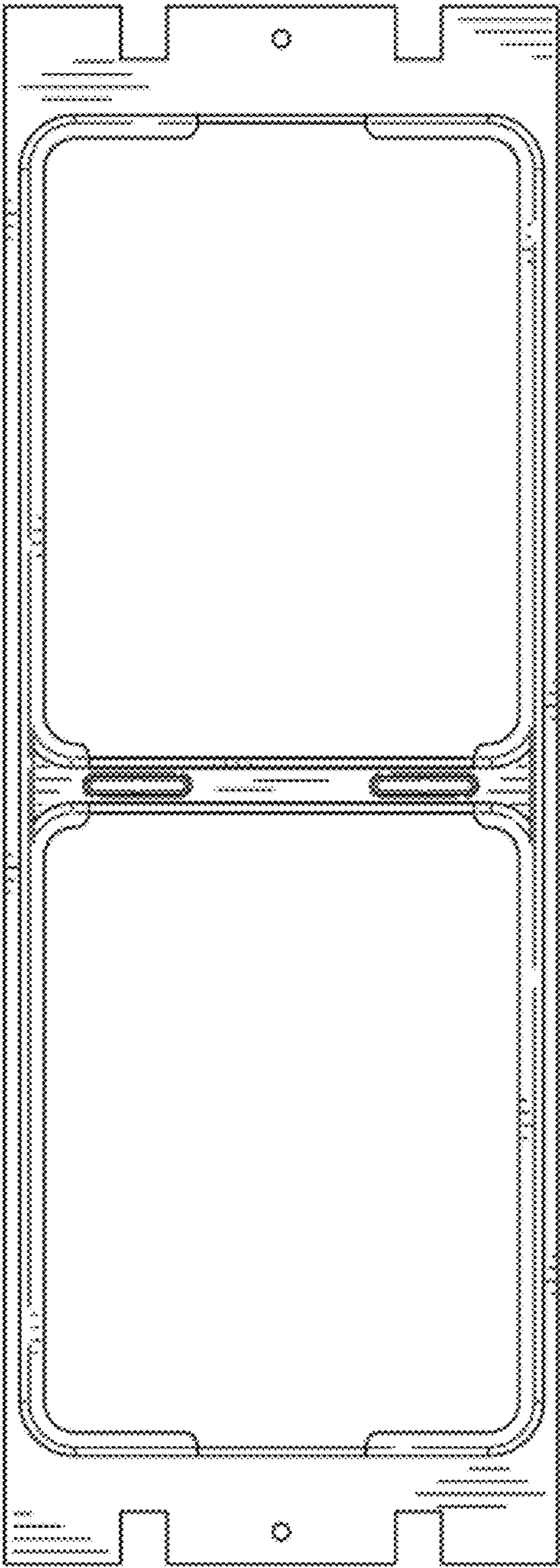

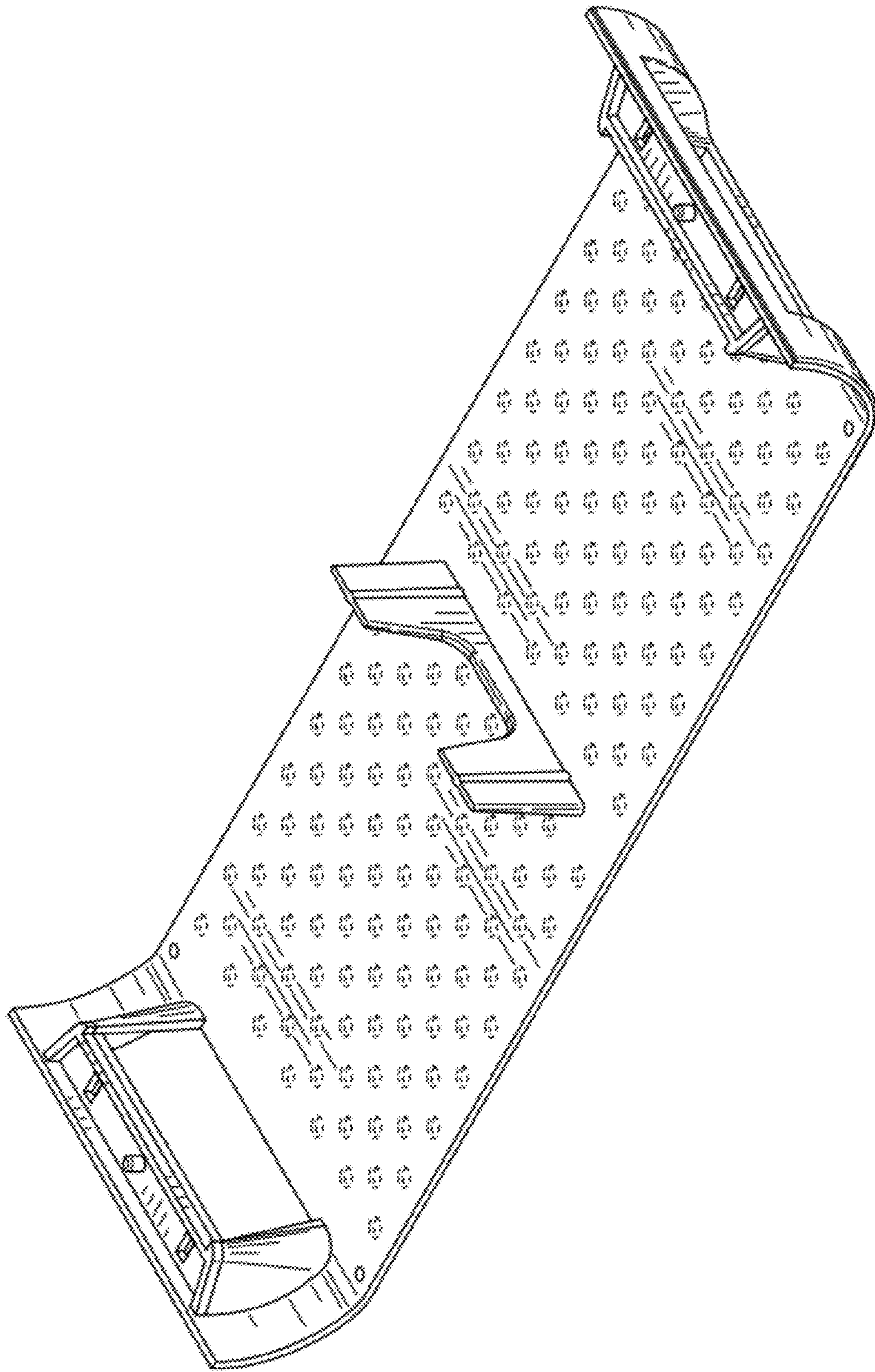

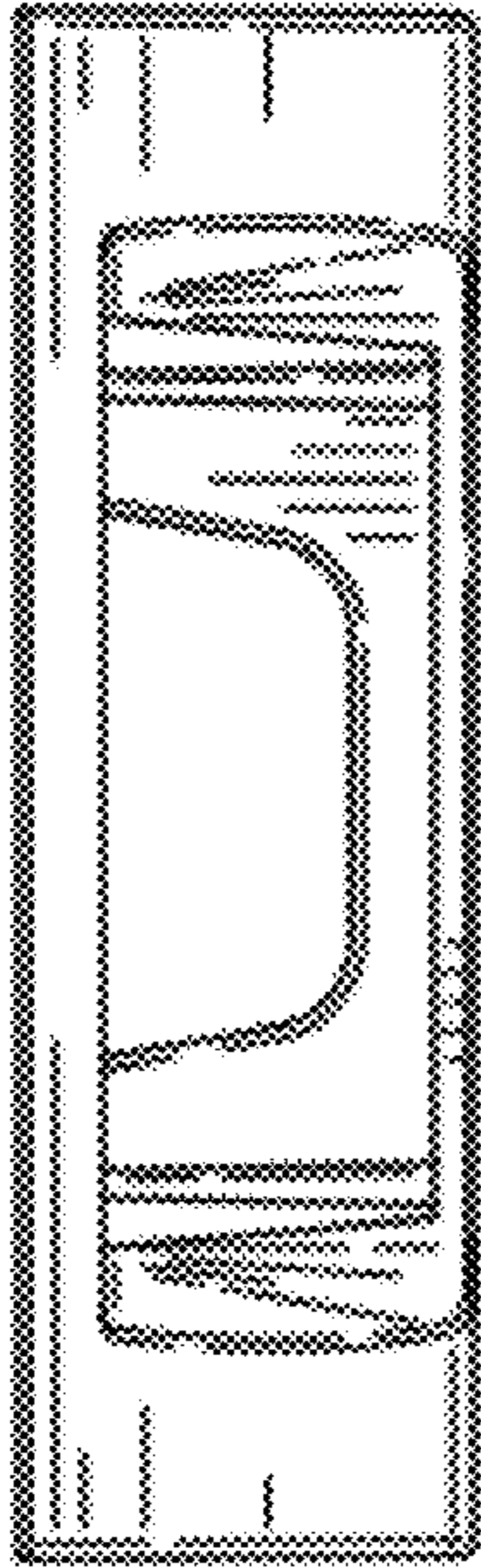

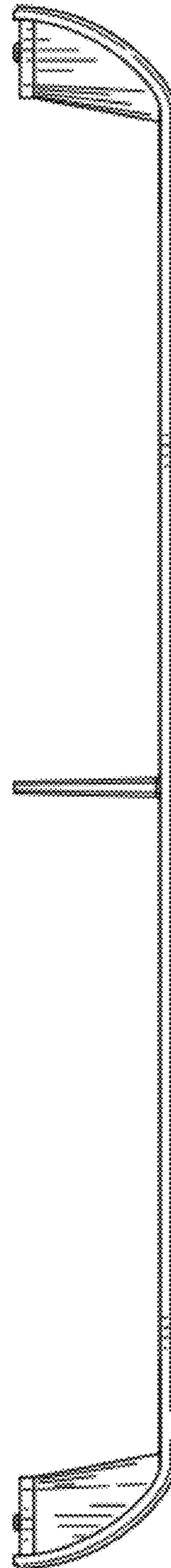

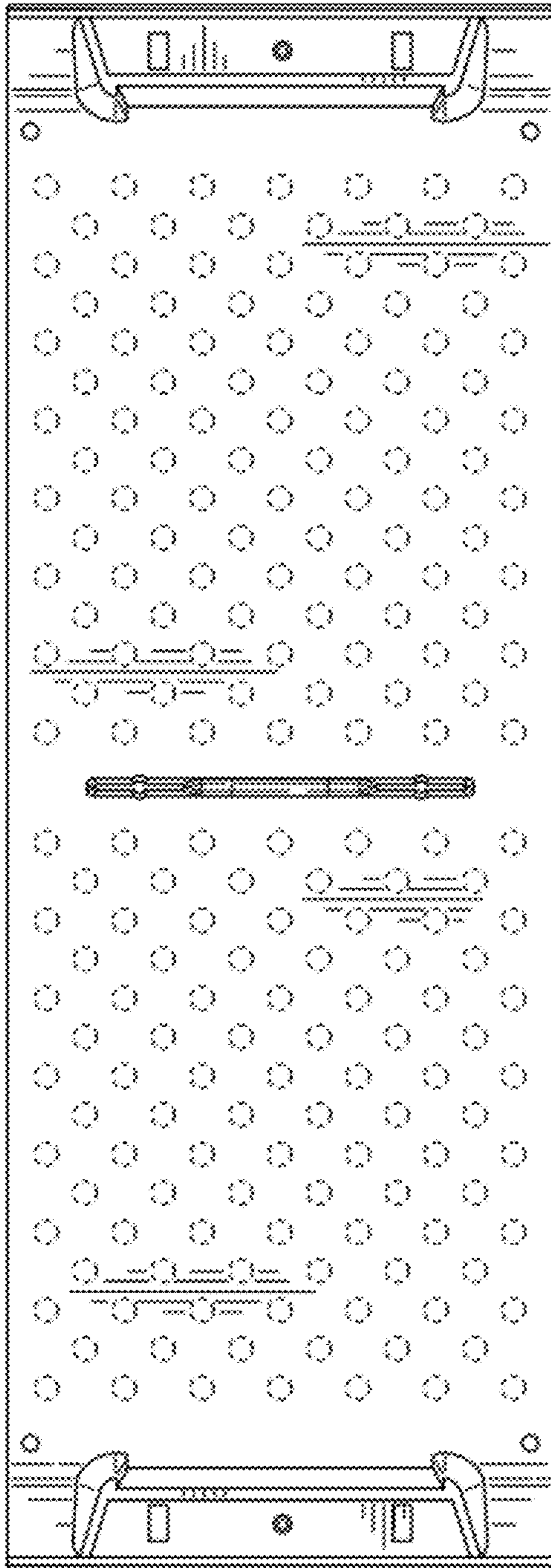
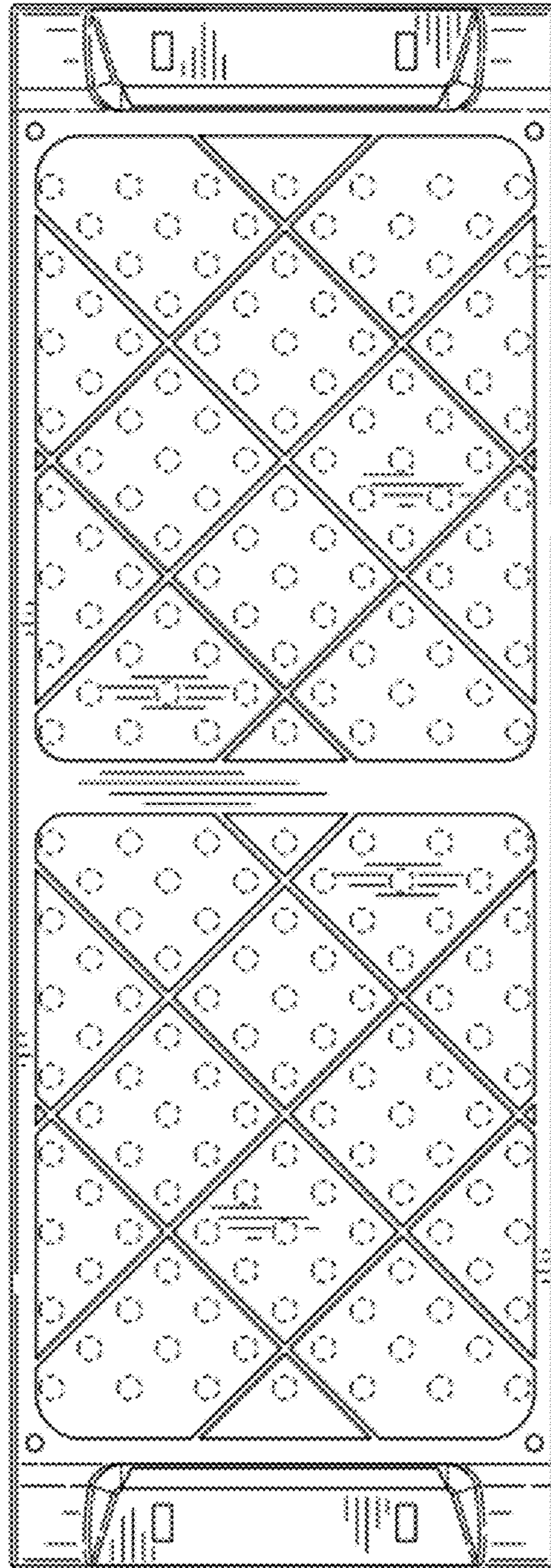

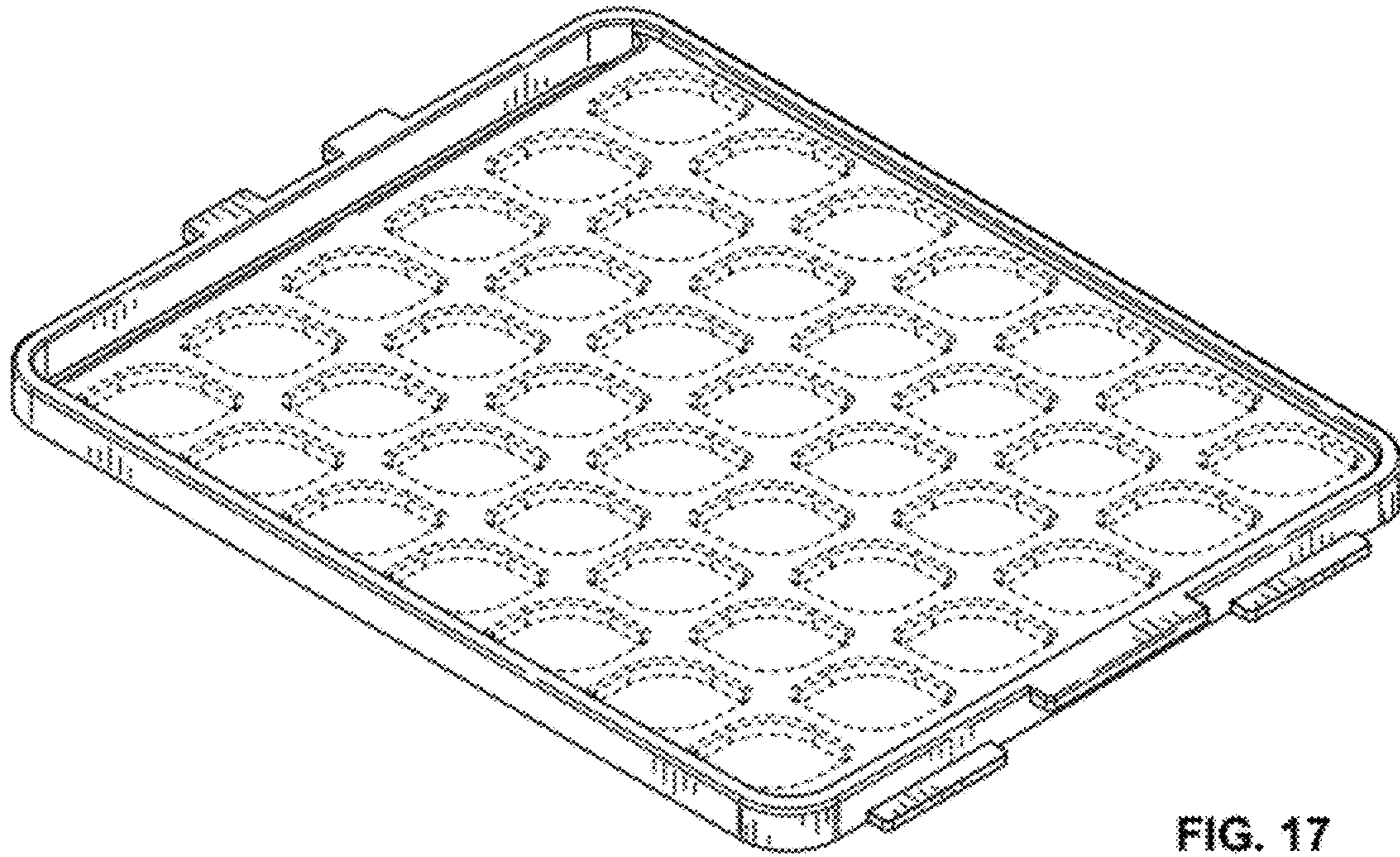

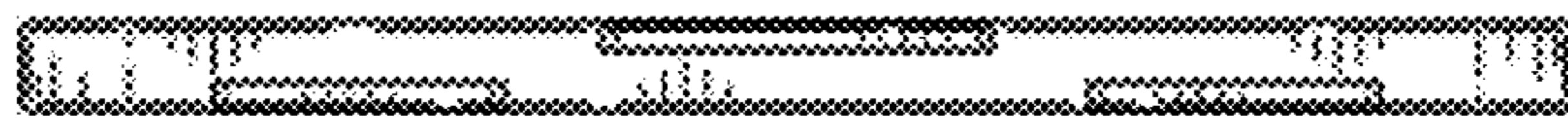

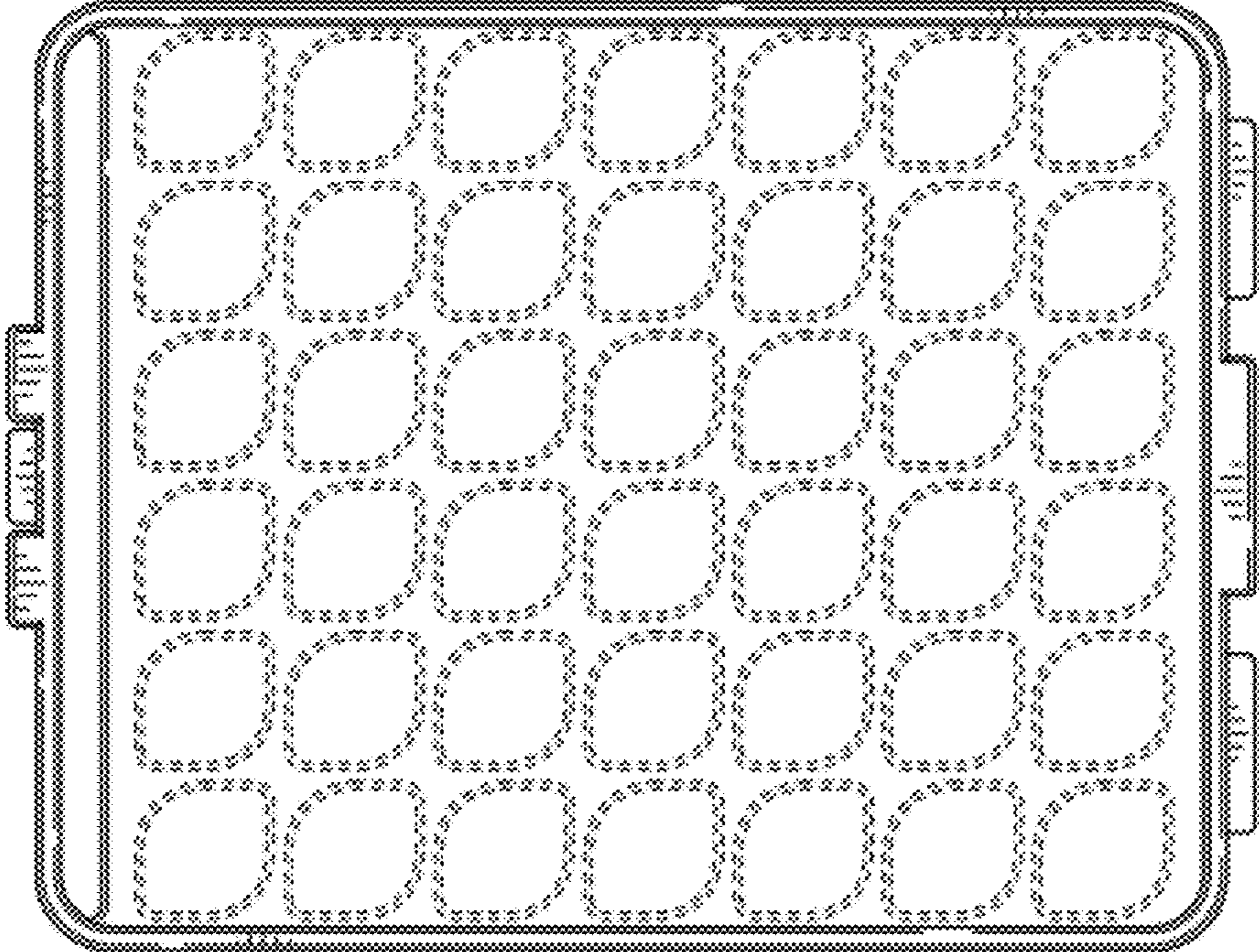

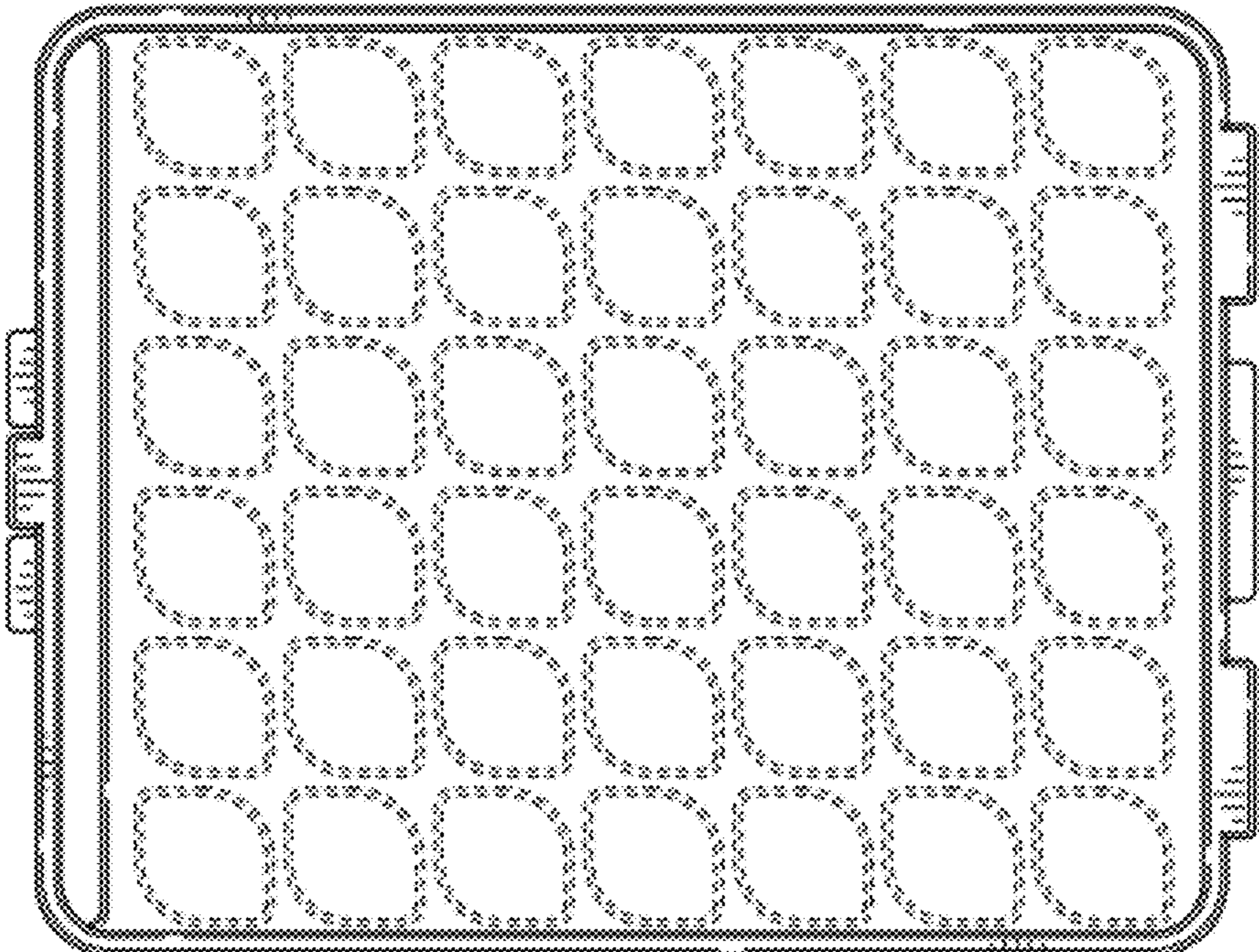
