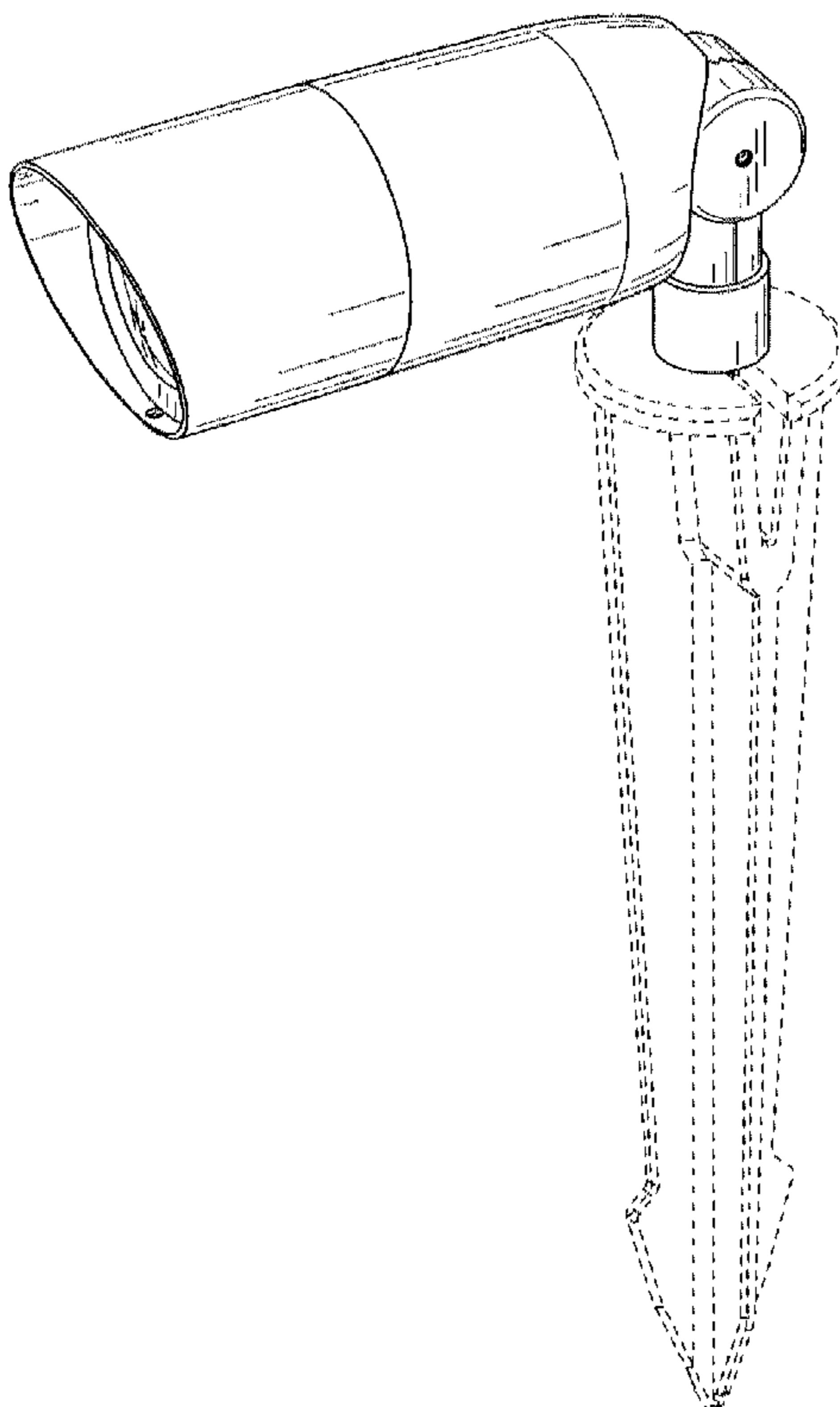
(57) **CLAIM**

We claim the ornamental design for an outdoor light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the outdoor light fixture showing the new design;

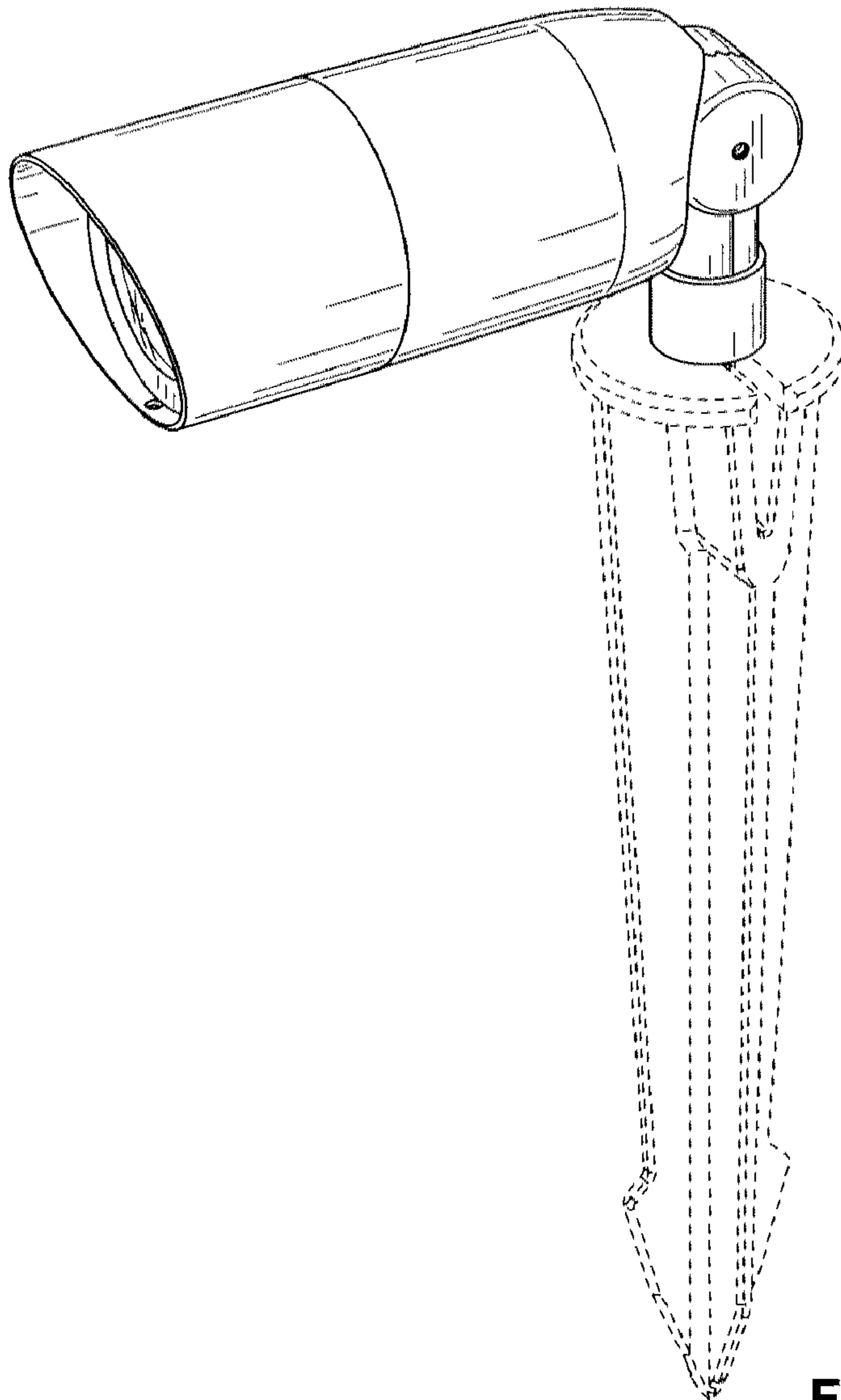

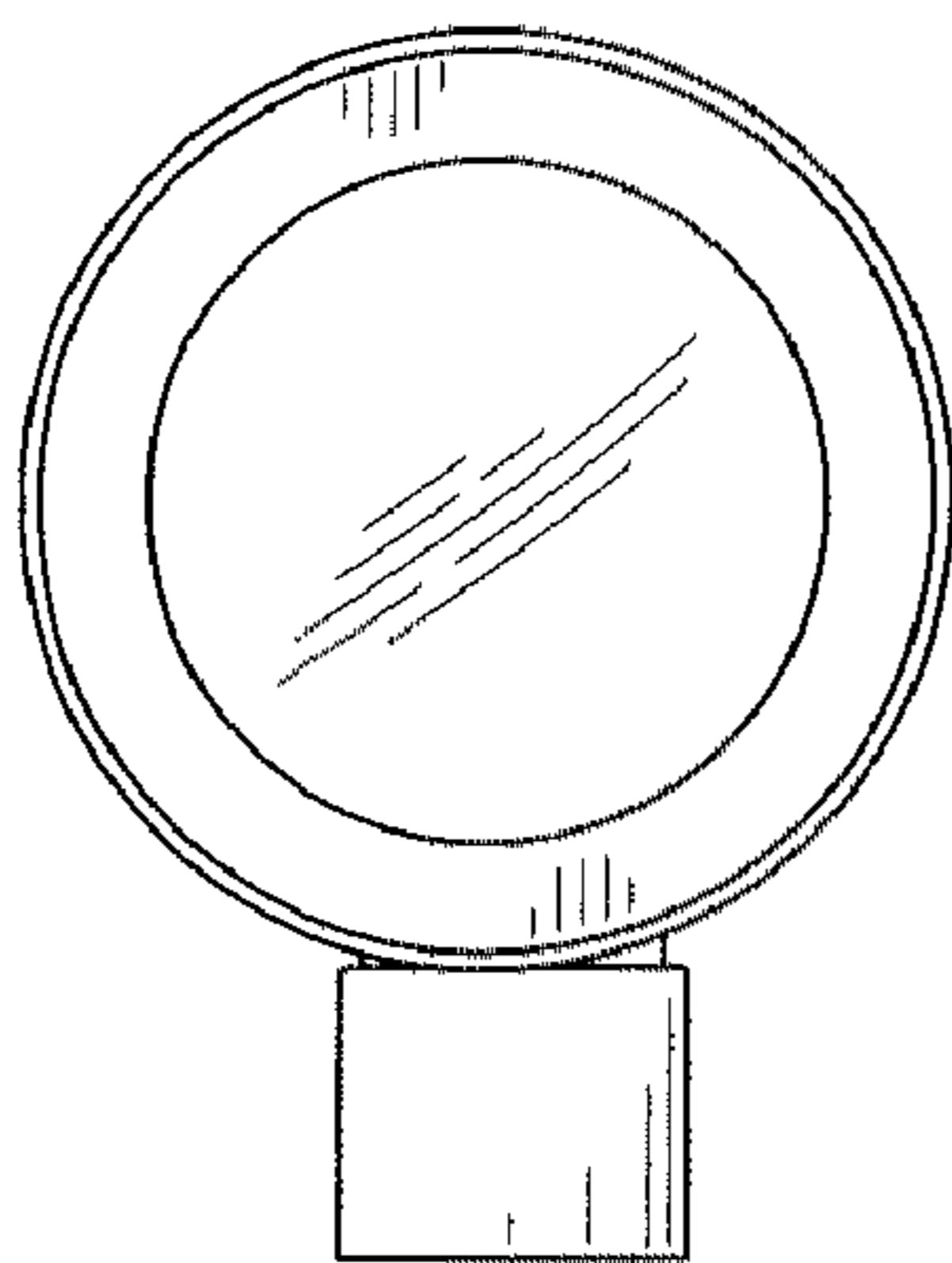

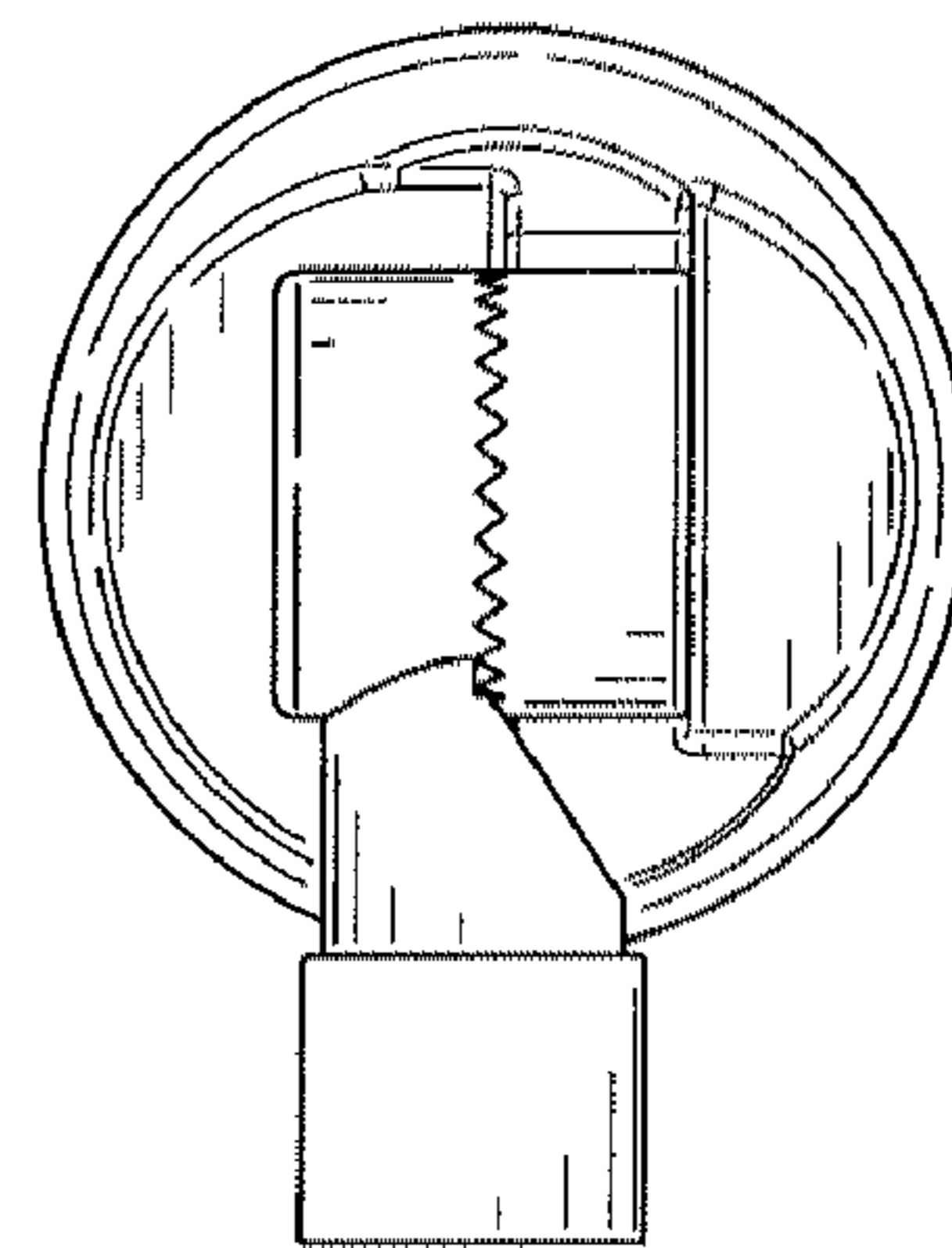

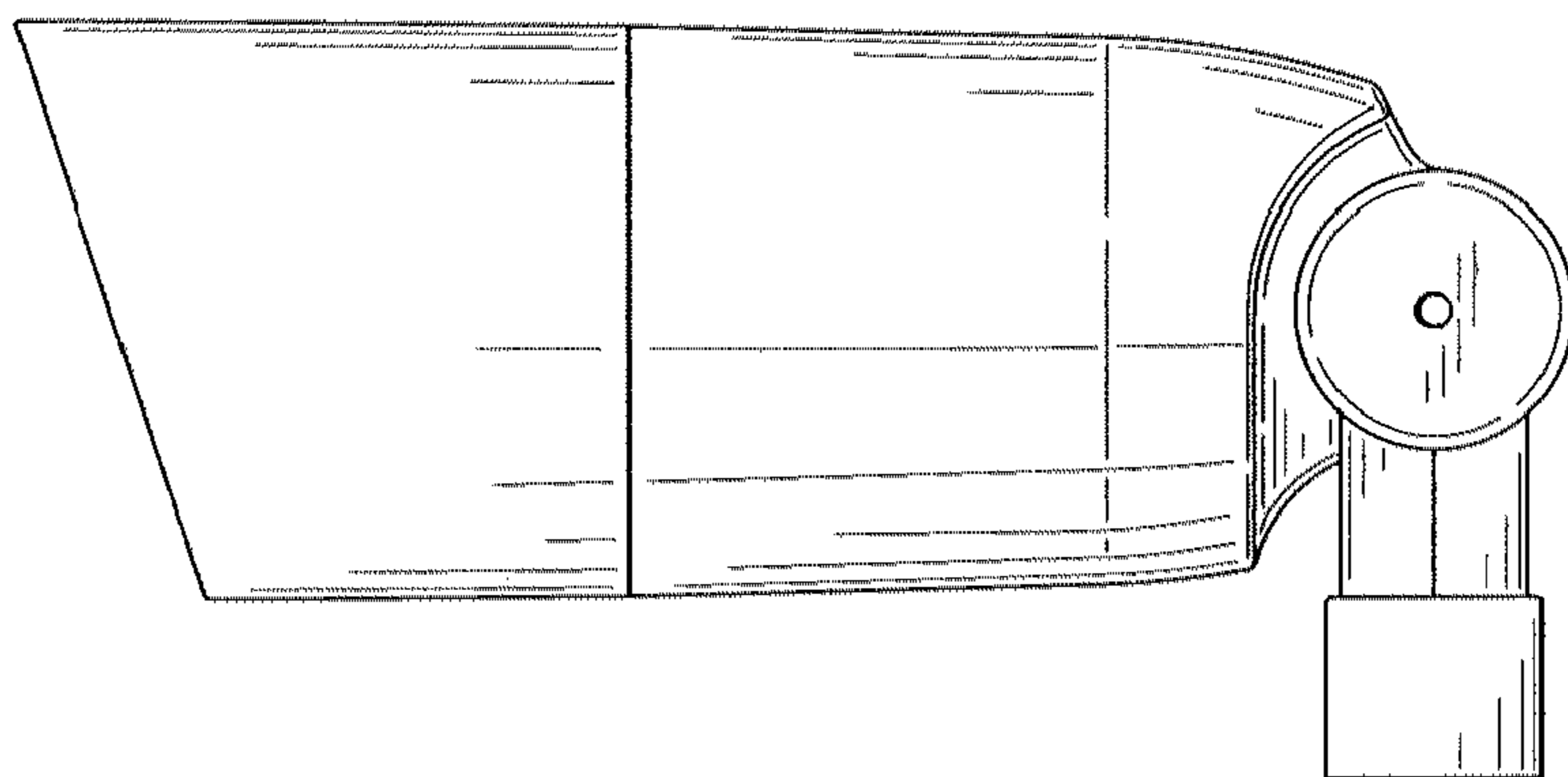

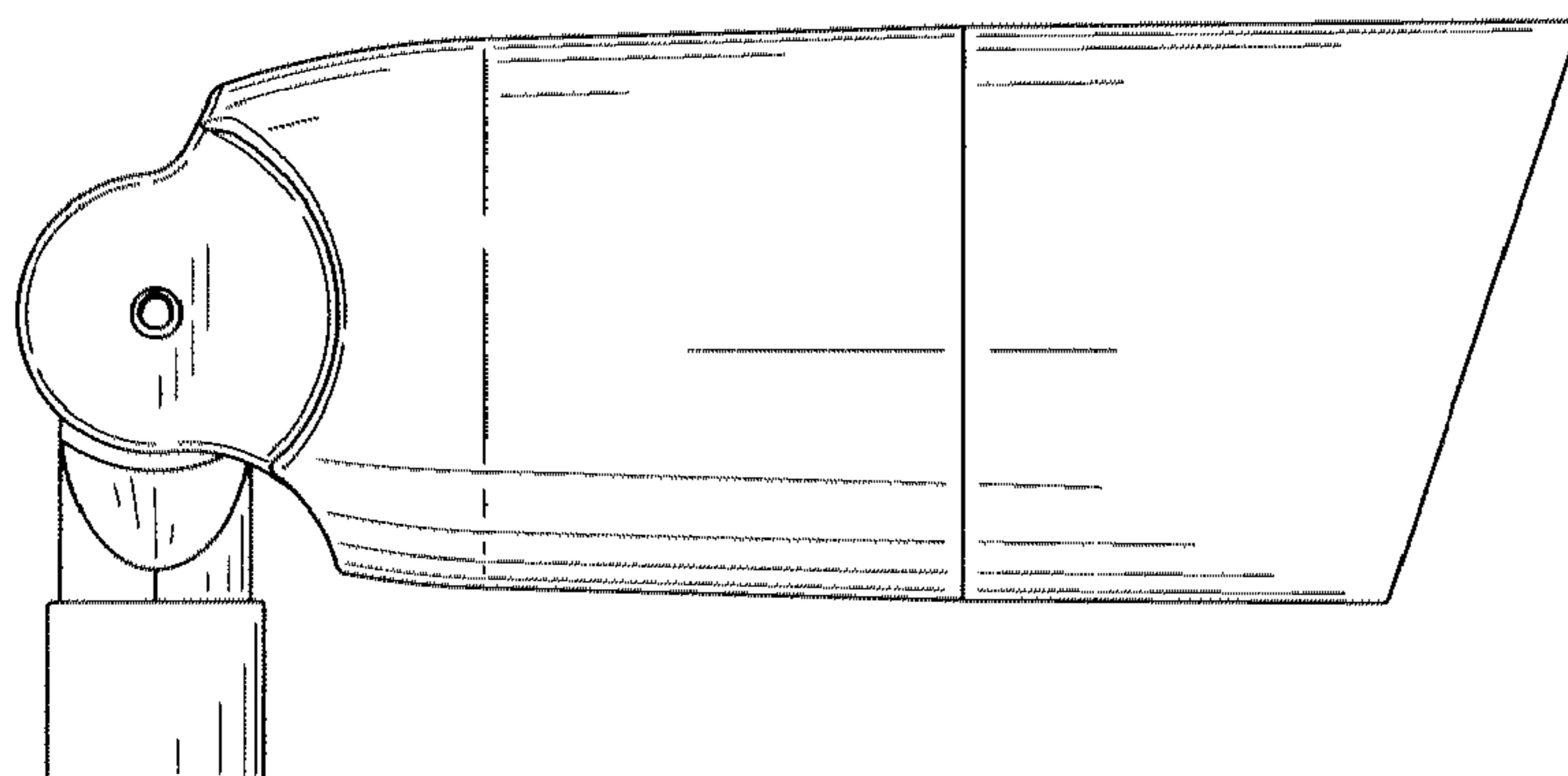

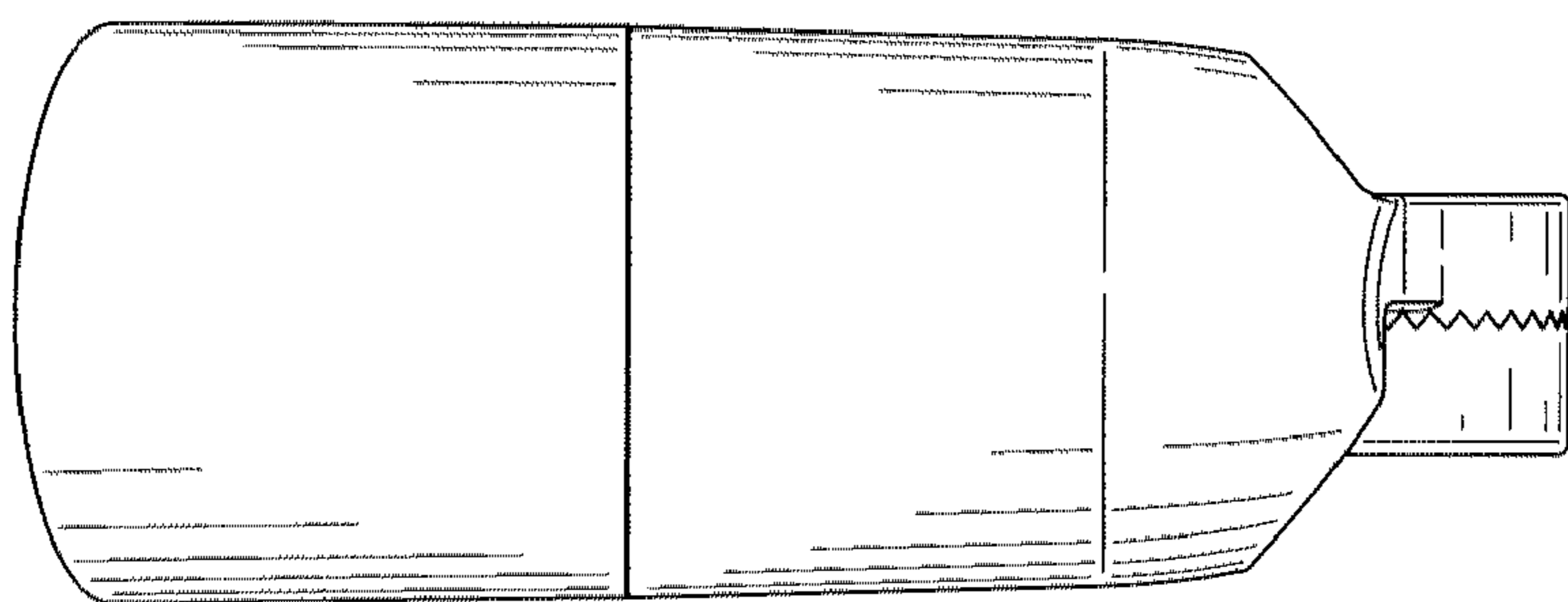

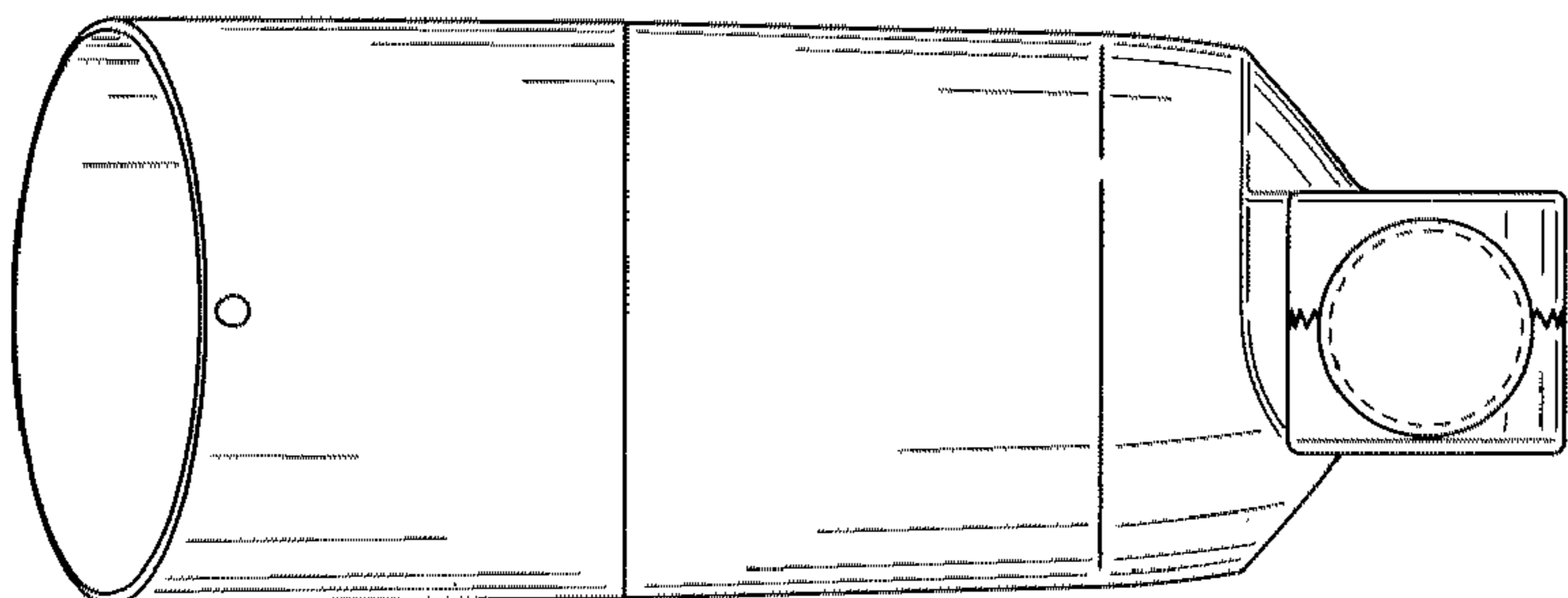
