The ornamental design for a street light, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a new and ornamental design for a street light with portions shown in phantom for environment only and forming no part of the claimed invention; FIG. 2 is a left side elevation view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is a back elevation view thereof; and, FIG. 6 is a bottom plan view thereof.

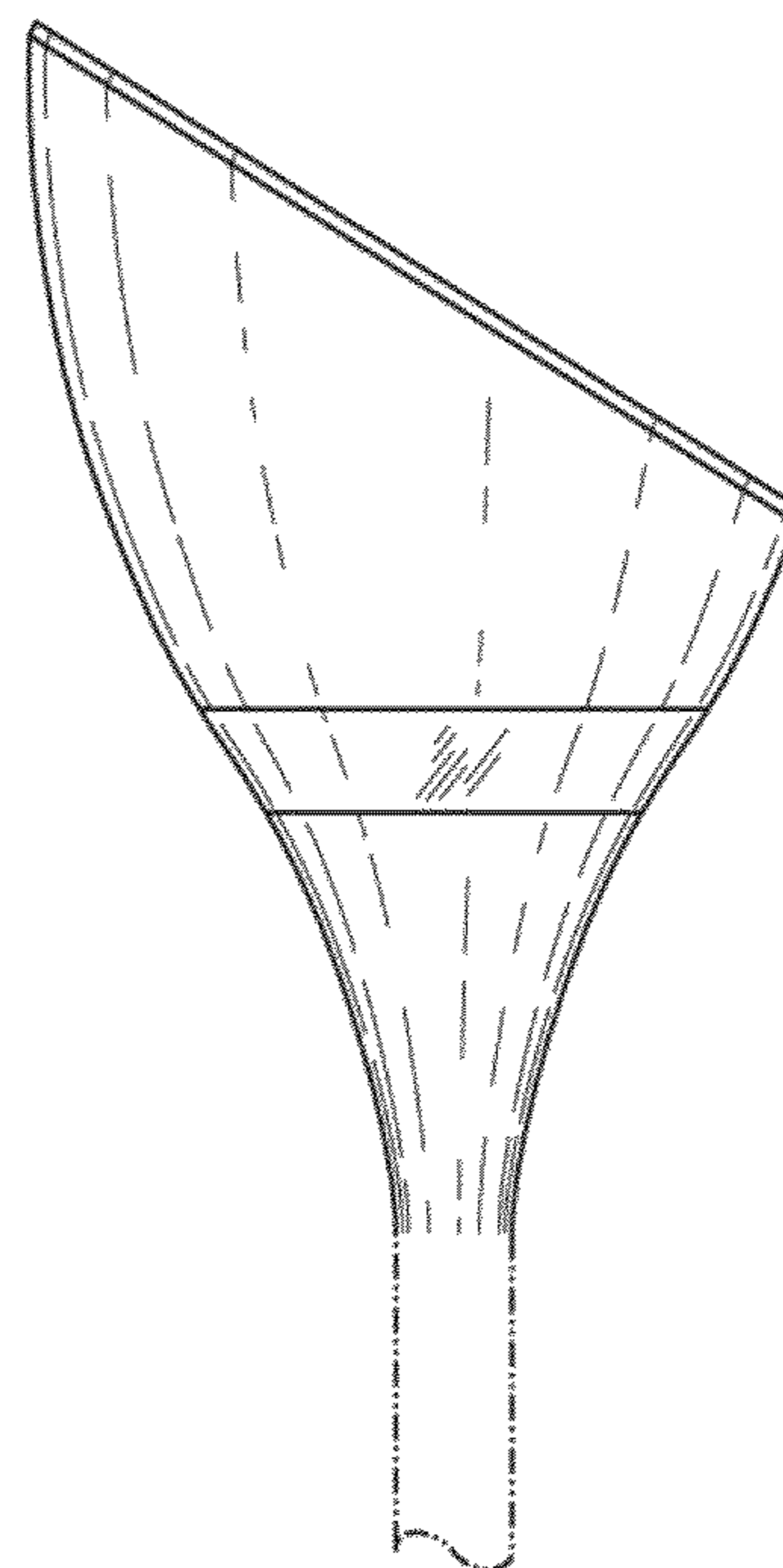
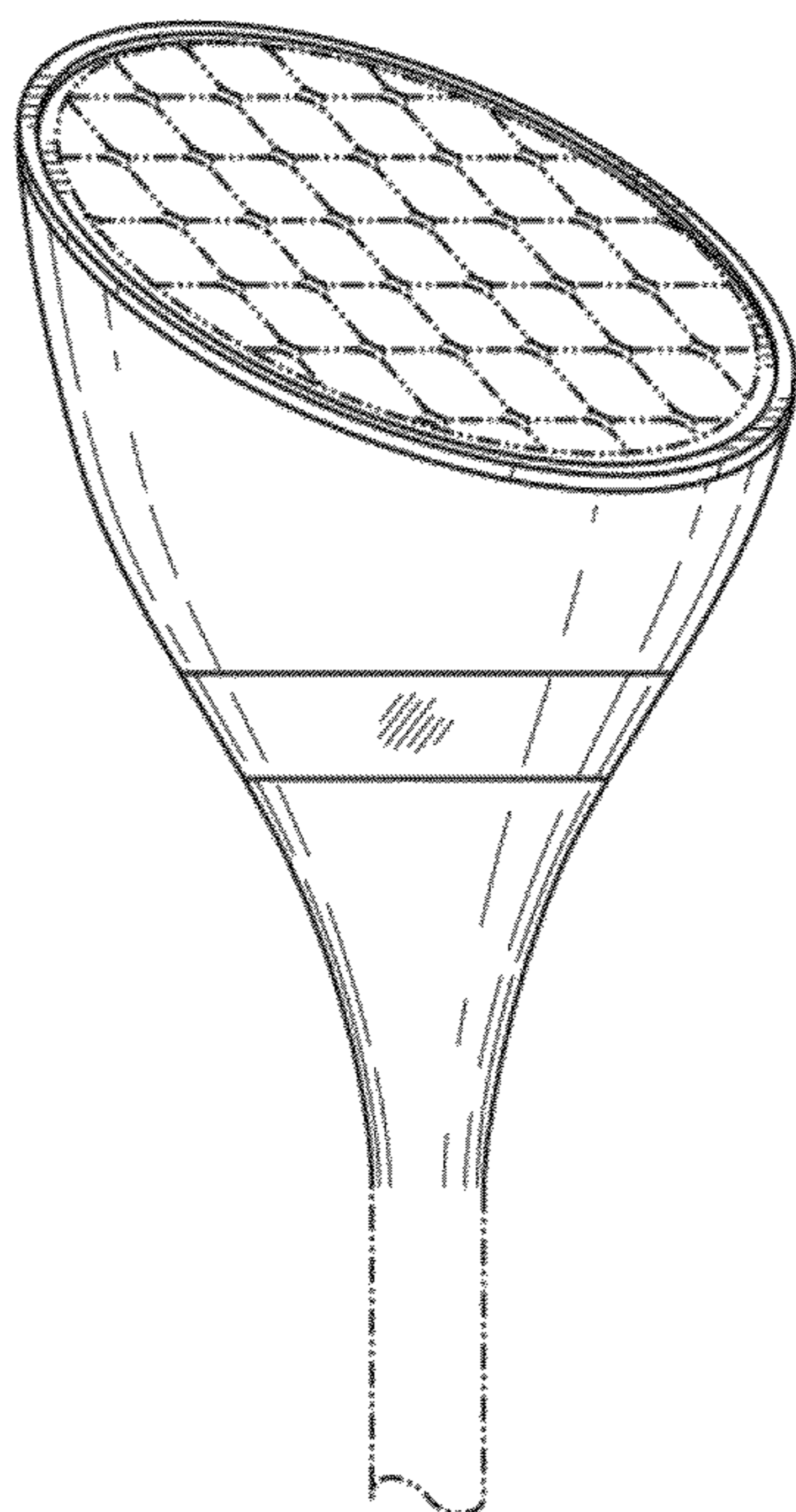

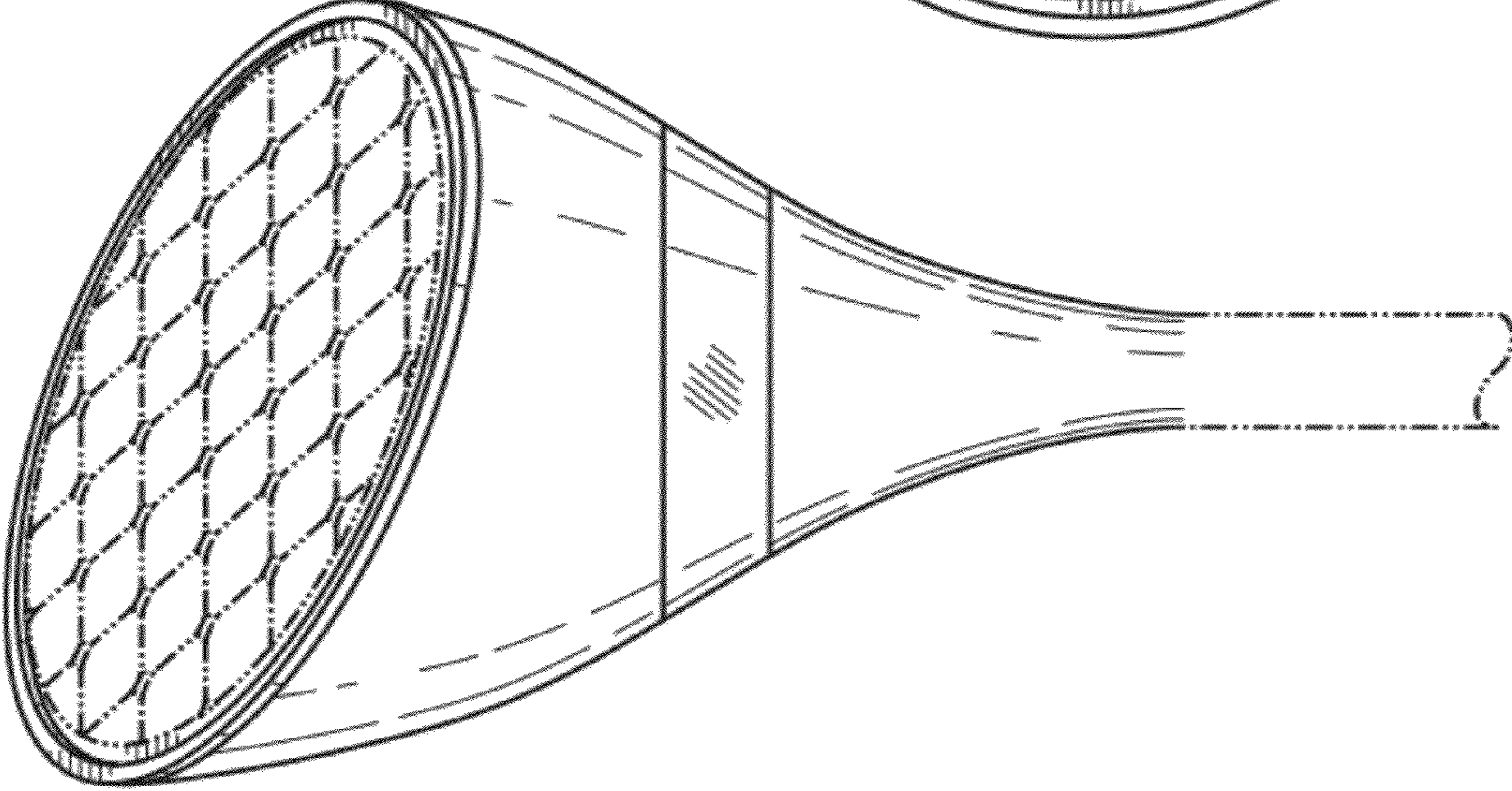

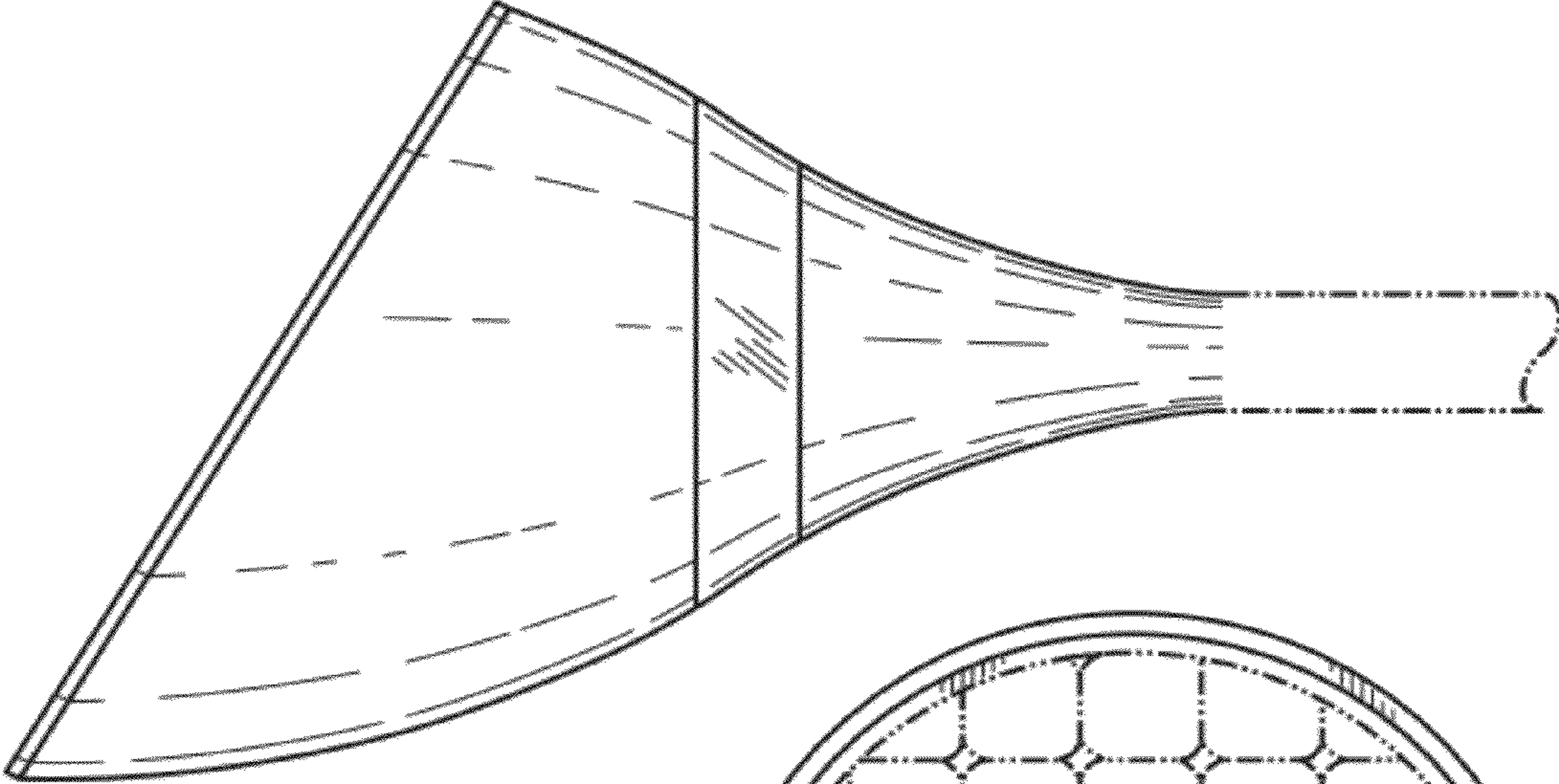
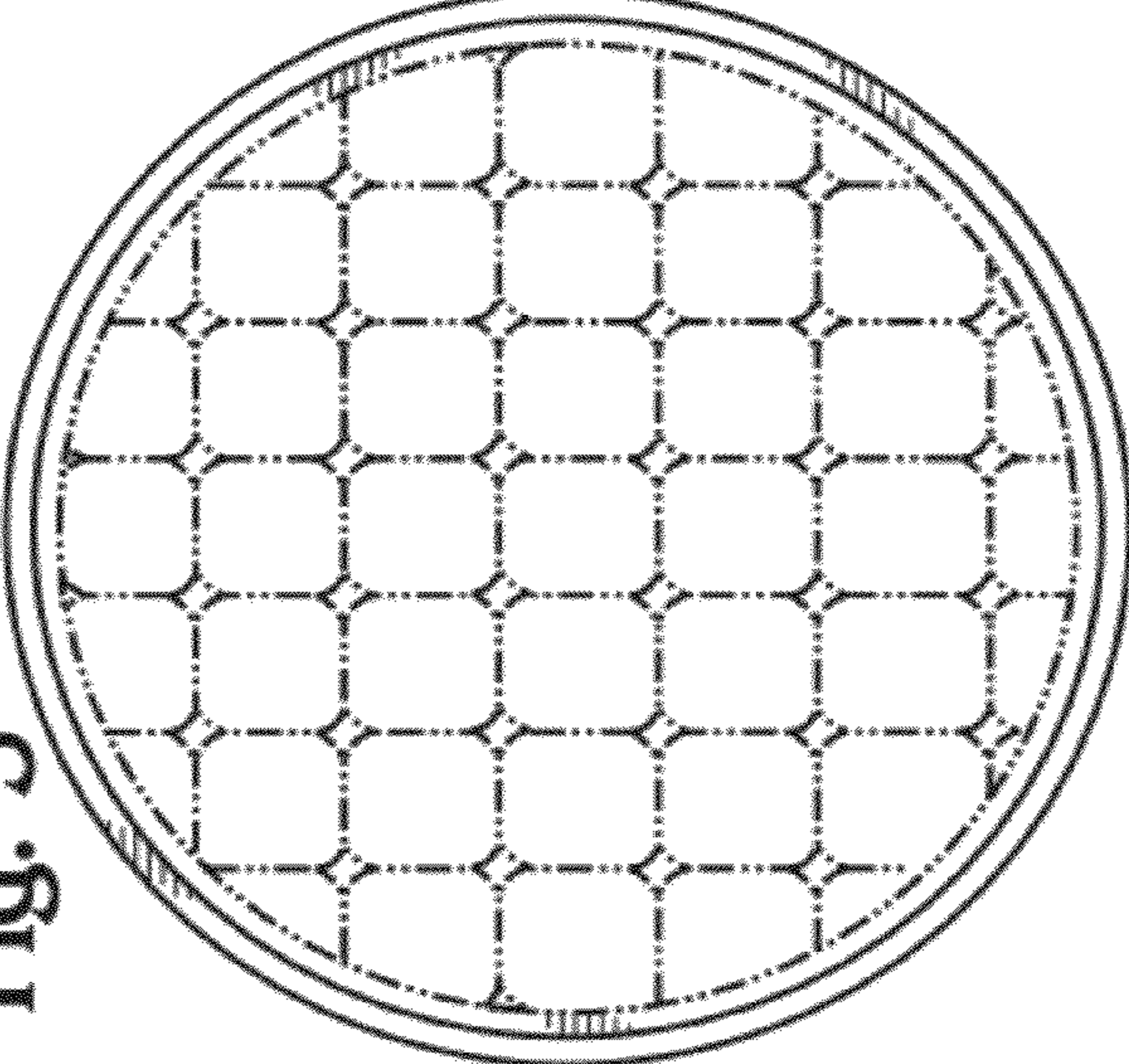

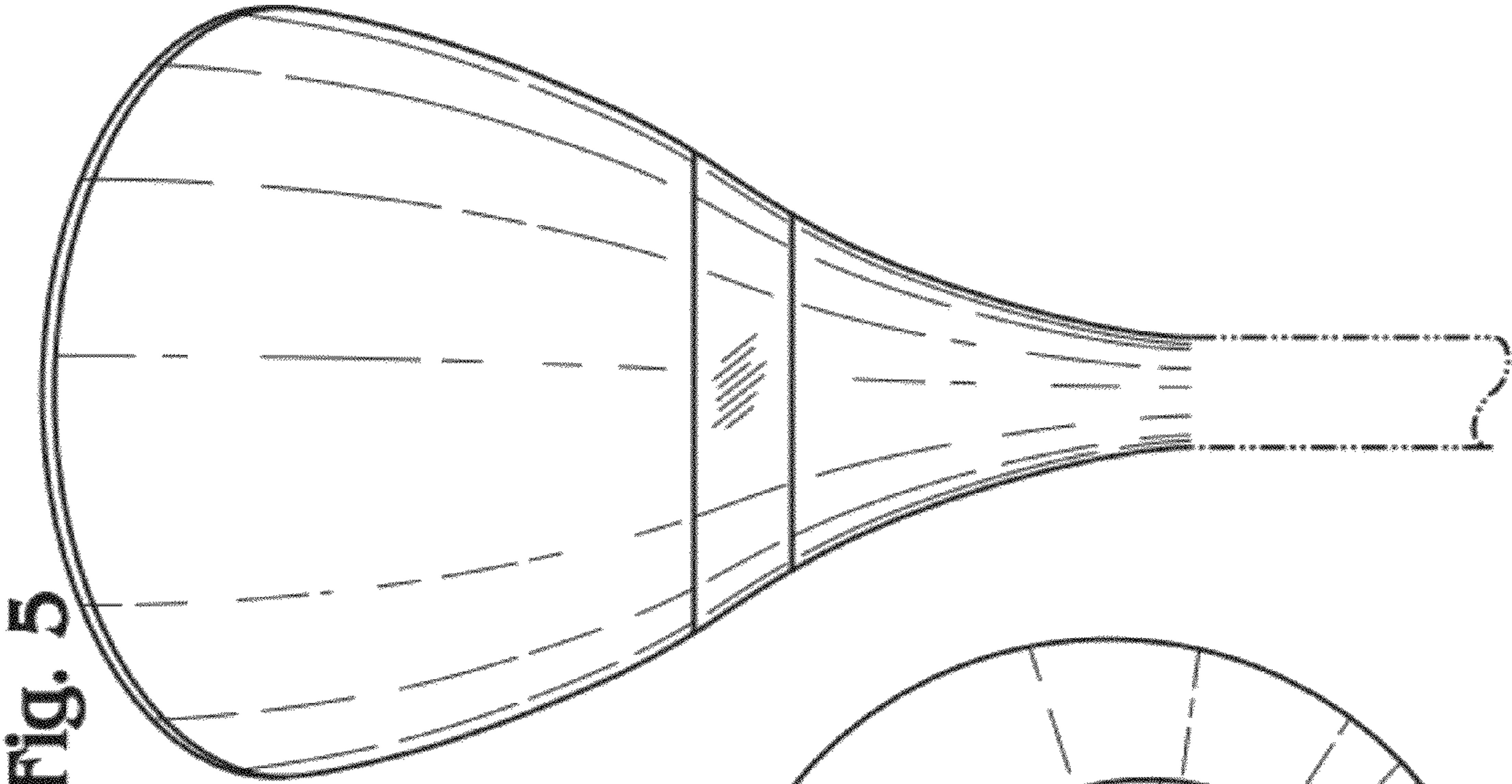

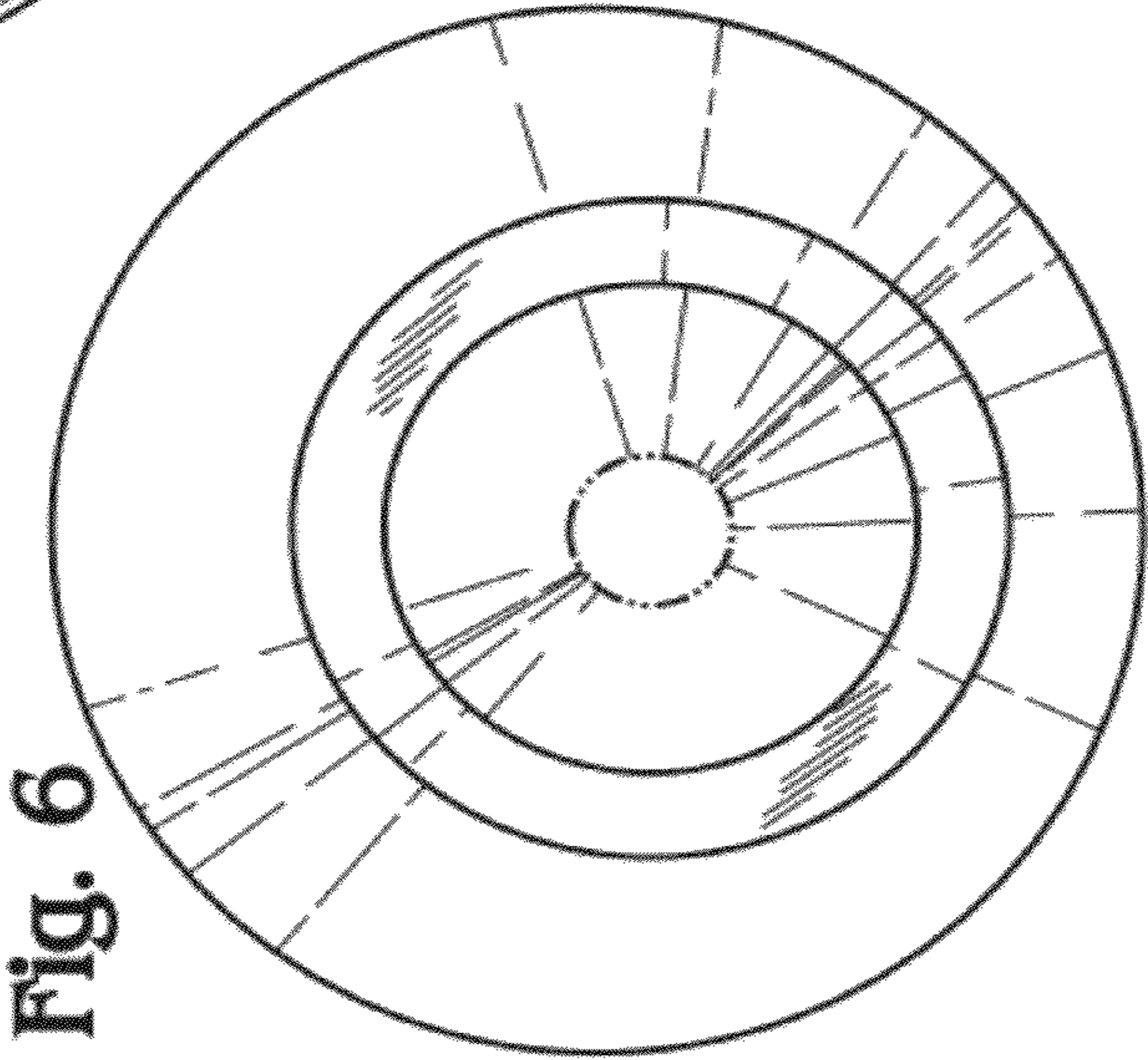

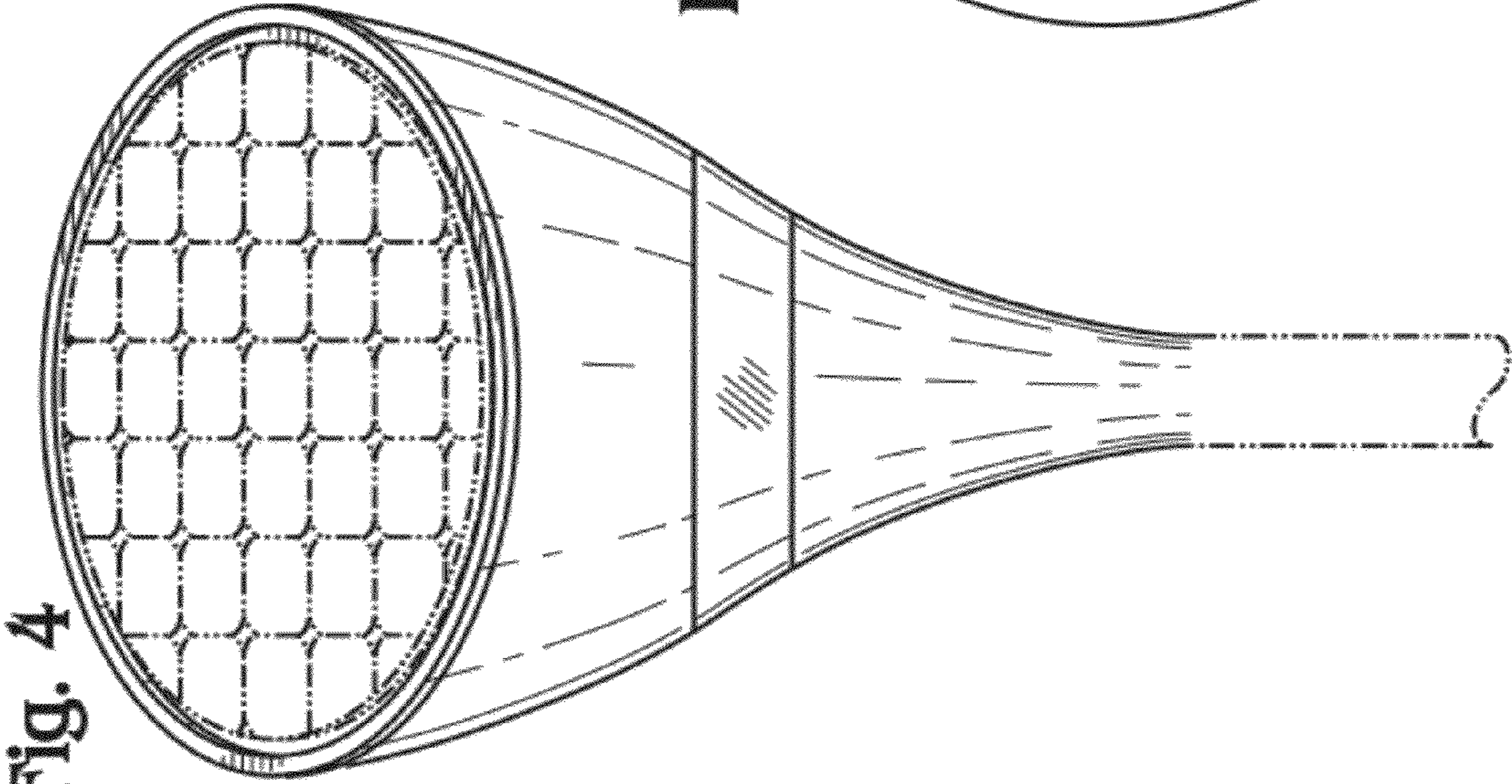
