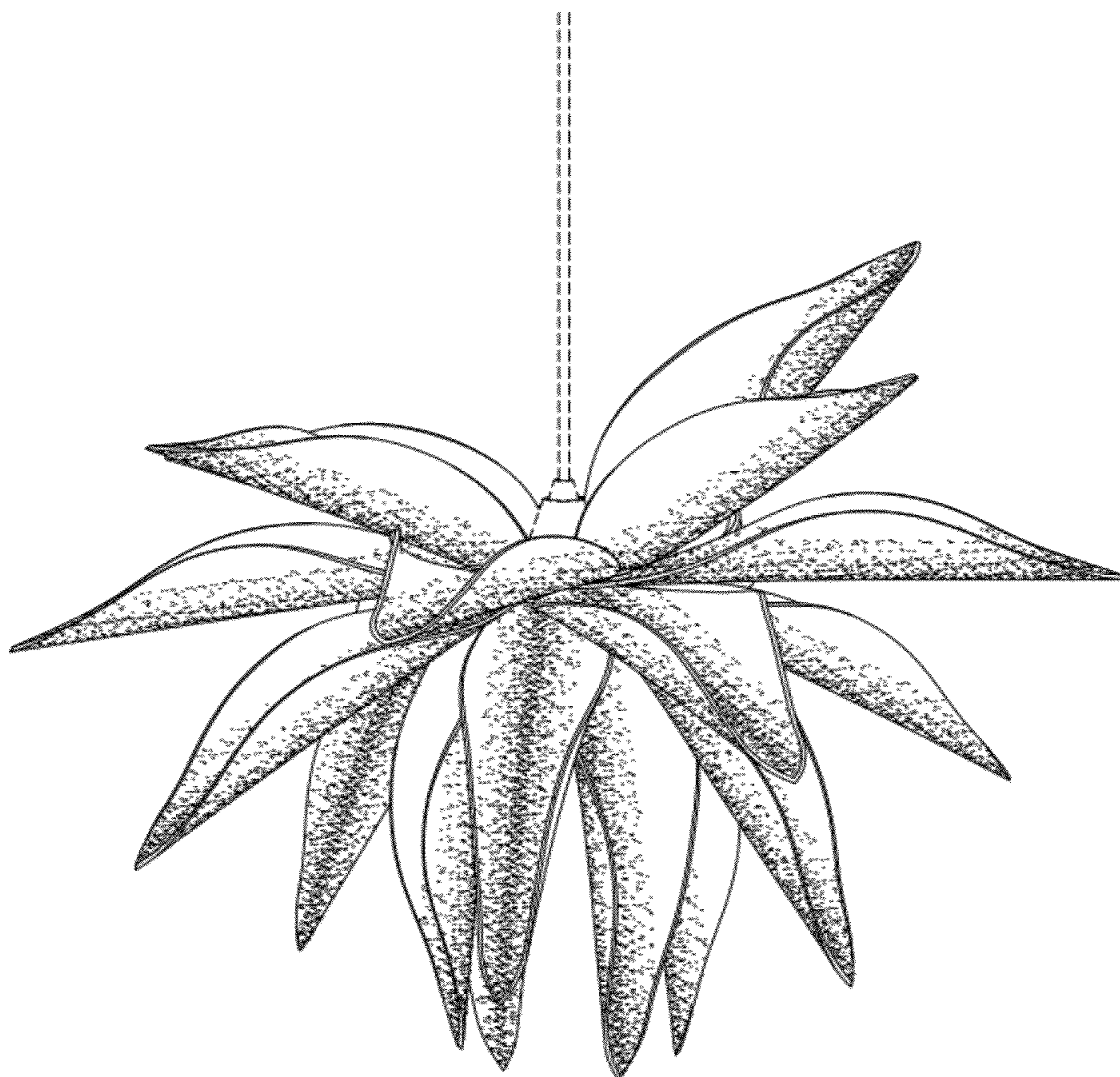
(57) **CLAIM**

The ornamental design for a dandelion lighting fixture, as shown and described.

DESCRIPTION

FIG. 1 is an elevated top, front perspective view of a lighting fixture including my design;
 FIG. 2 is a front, facing view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a rear view thereof;
 FIG. 6 is top plan view thereof;
 FIG. 7 is a bottom plan view thereof; and,
 FIG. 8 is an exploded, perspective view thereof.

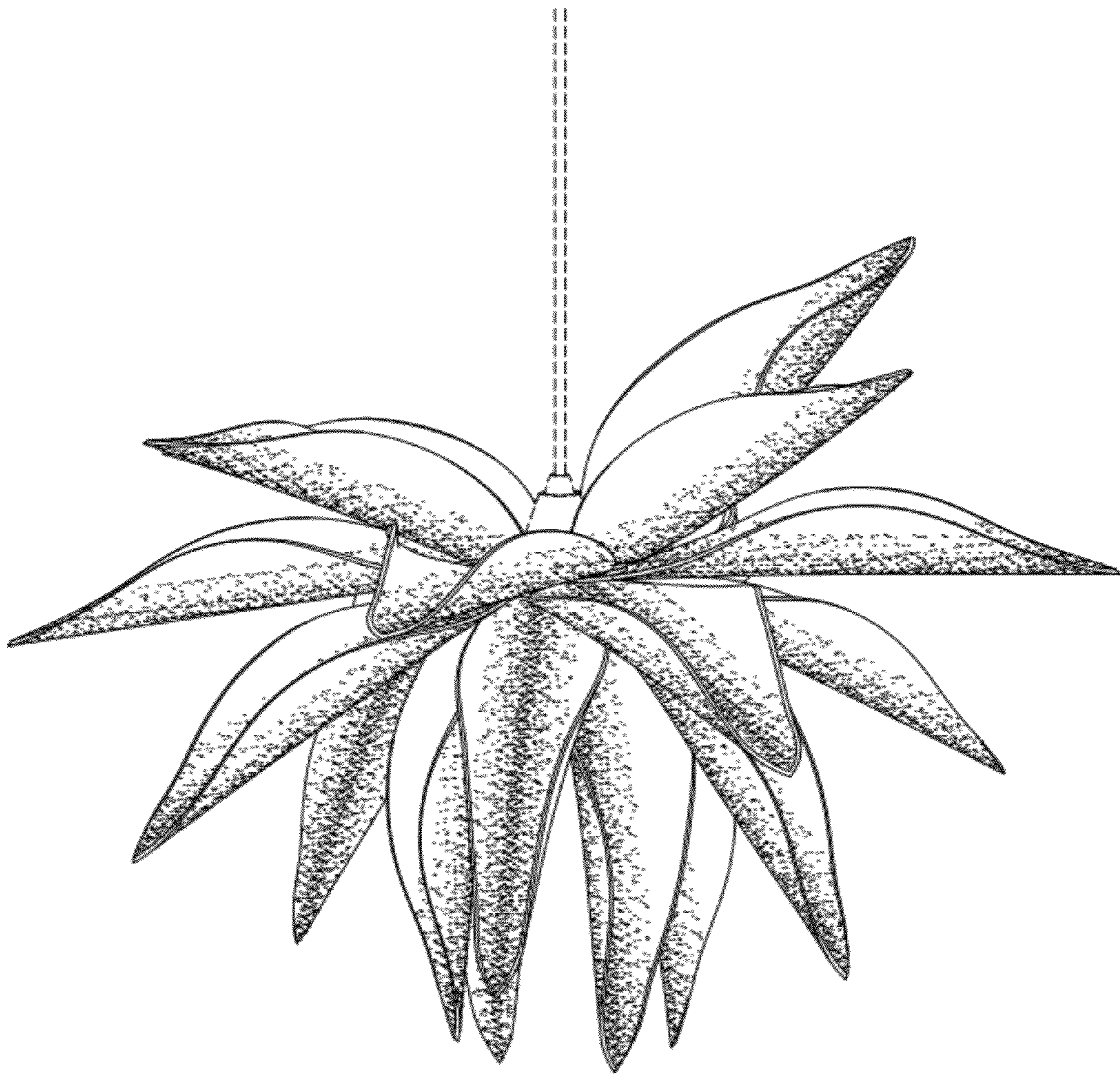

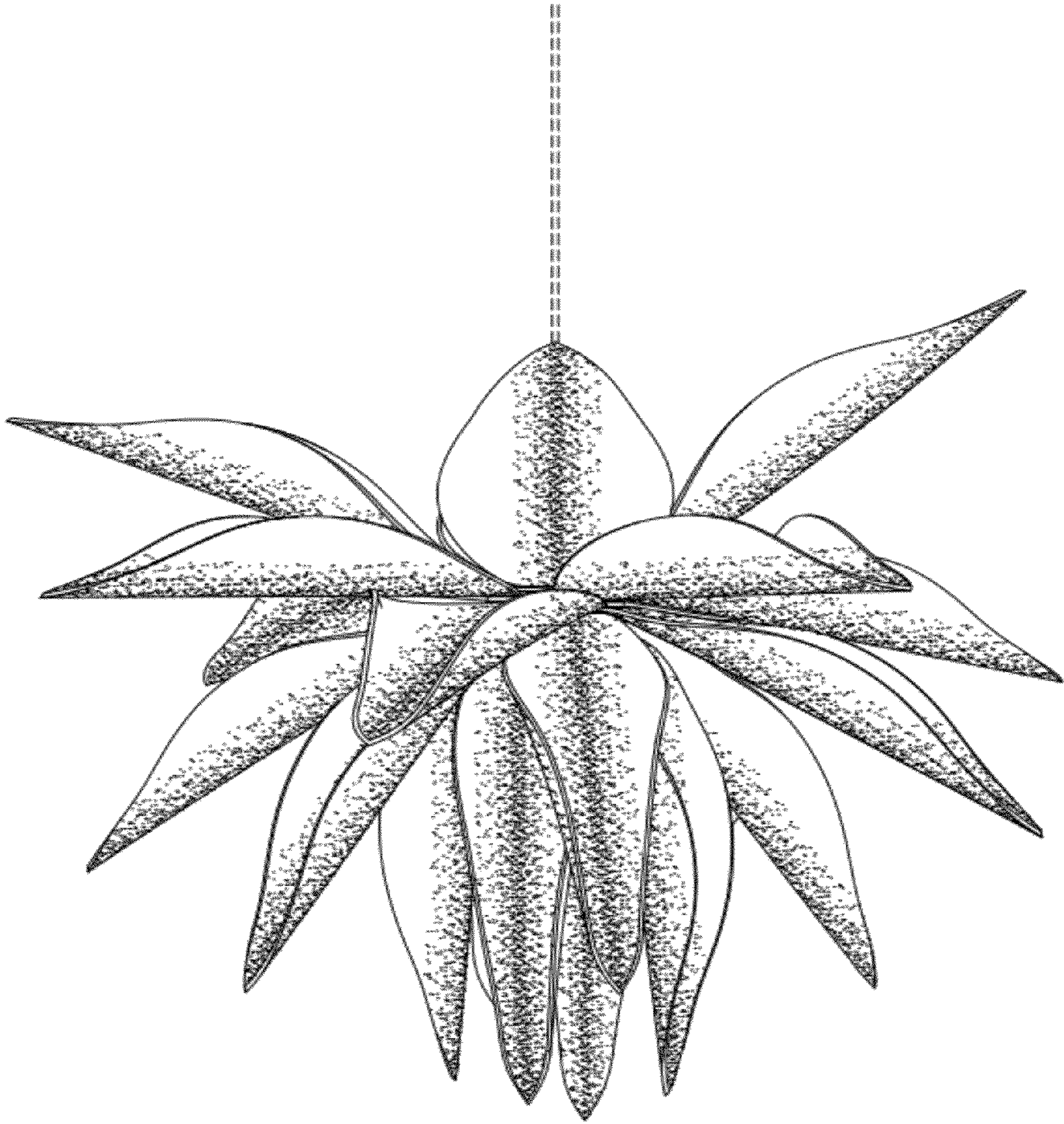

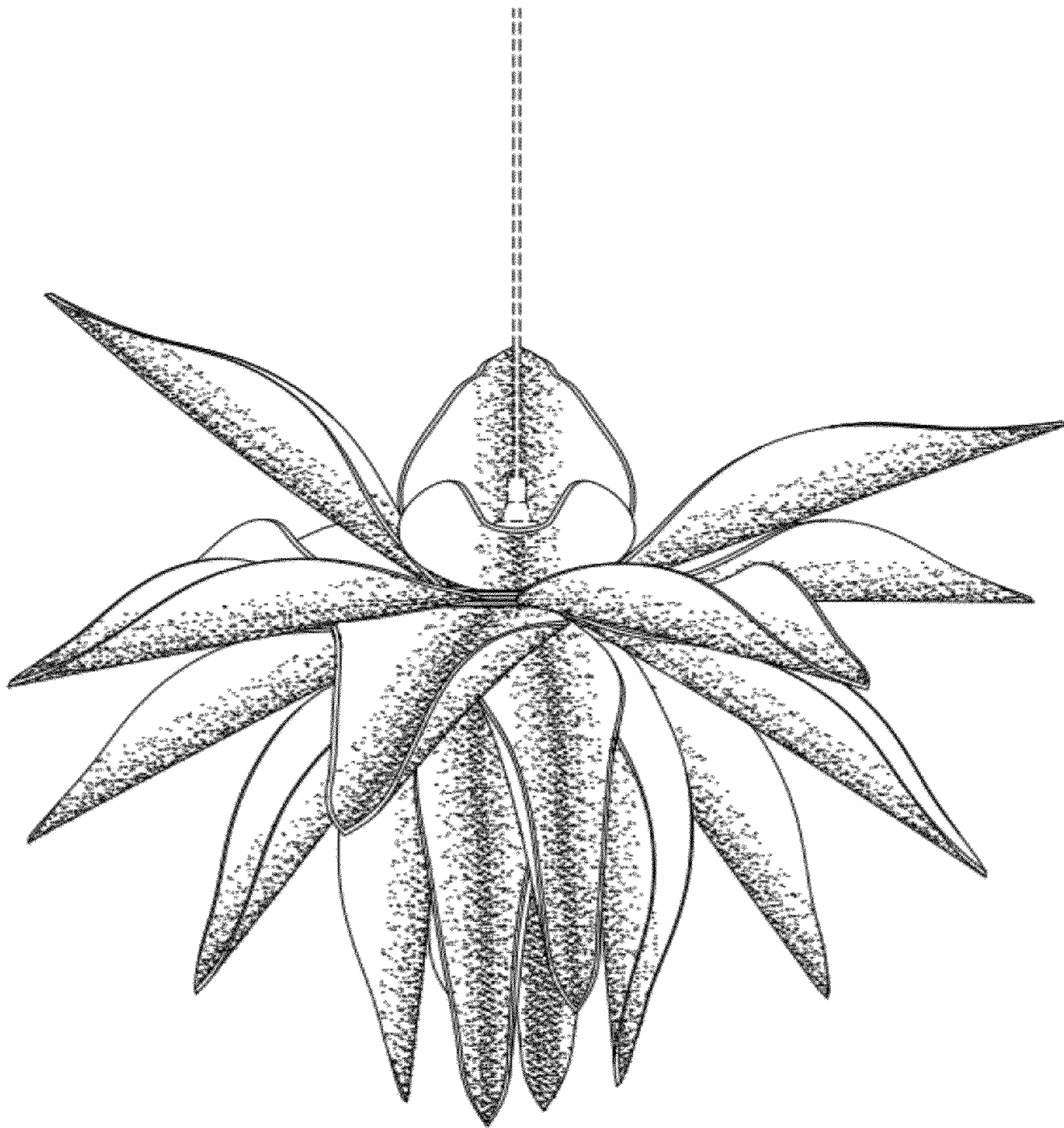

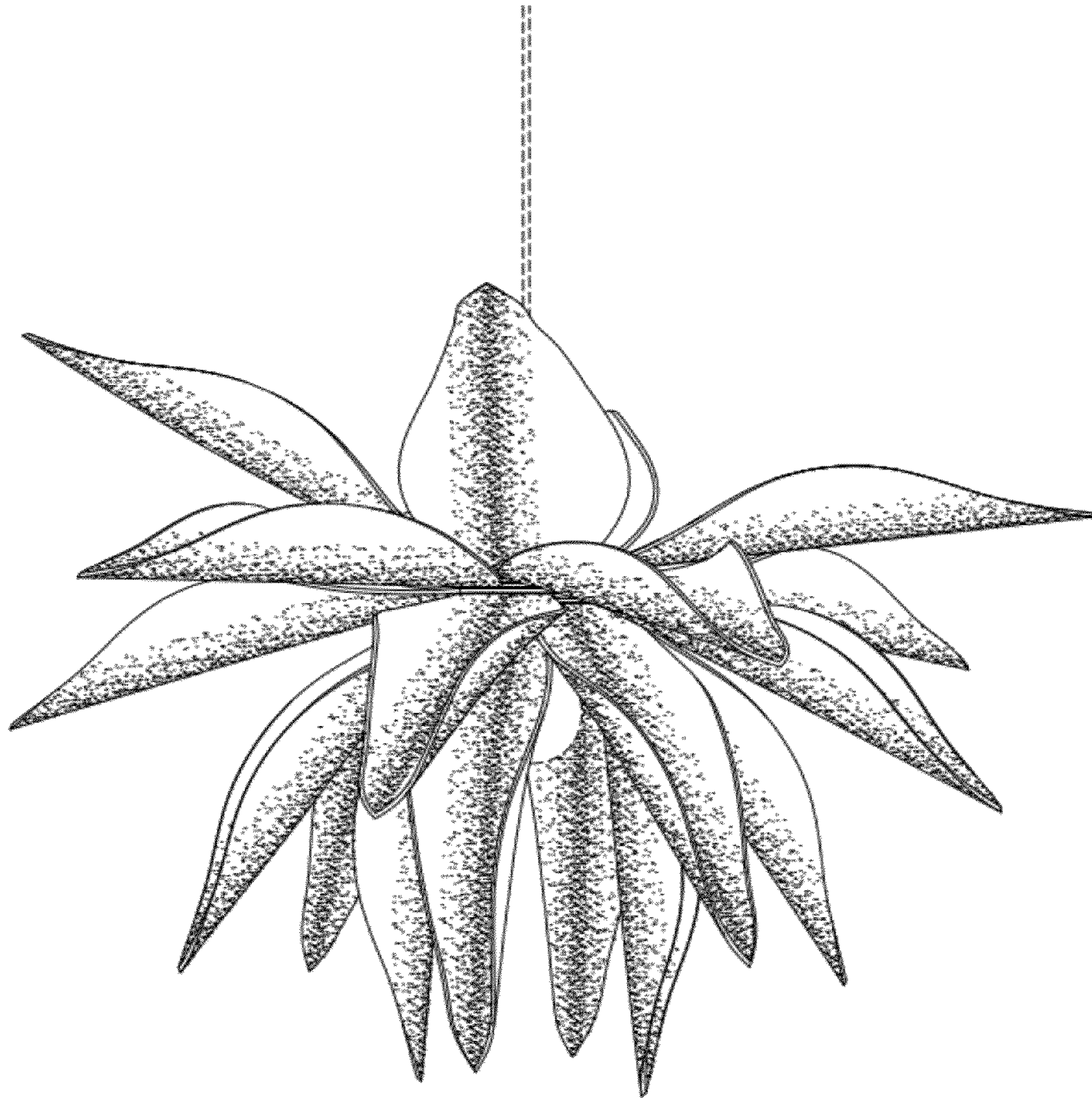

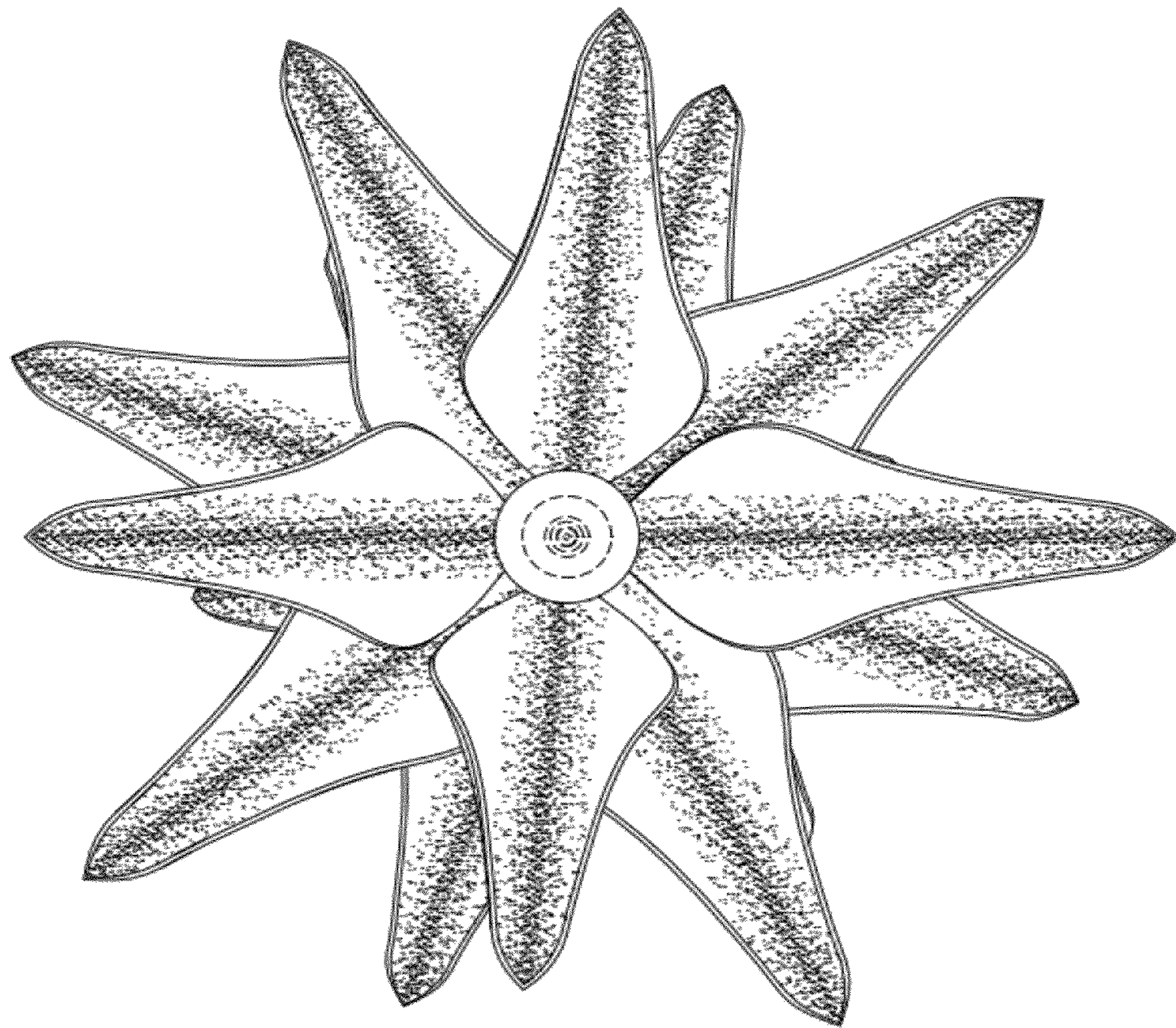

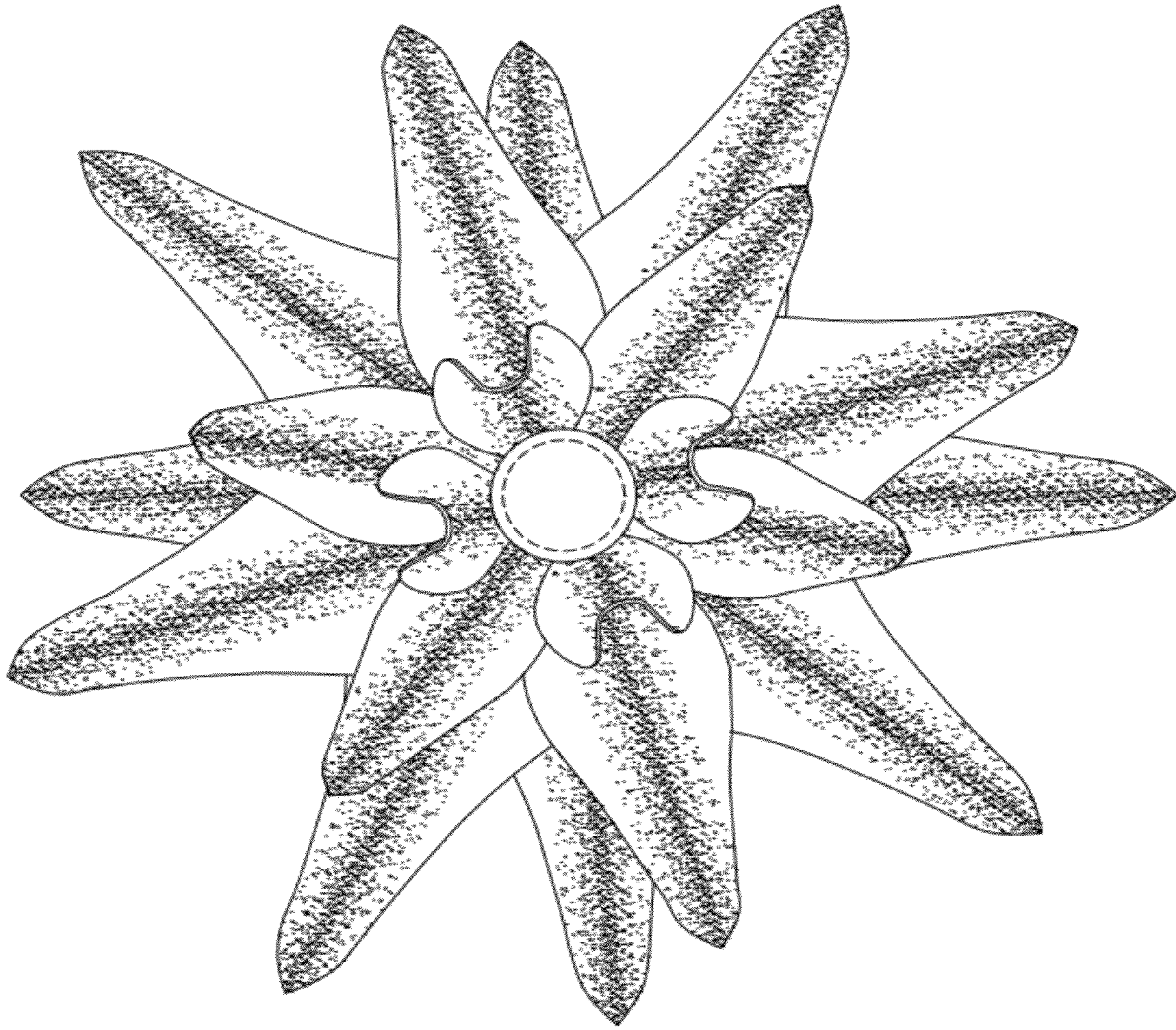
