FIG. 1 is a side view of the decorative wood panel trash bin of the present invention with the side door in the open position. FIG. 2 is a front view of the decorative wood panel trash bin of the present invention with the front door in the open position.

FIG. 3 is a front view of the decorative wood panel trash bin of the present invention with the front and side doors in the closed position.

FIG. 4 is a side perspective view of the decorative wood panel trash bin of the present invention with the front and side doors in the closed position.

FIG. 5 is a side view of the decorative wood panel trash bin of the present invention with the side door in the closed position.

FIG. 6 is a back view of the decorative framed wood panel trash bin of the present invention with the side door in the closed position; and,

FIG. 7 is a top view of the decorative framed wood panel trash bin of the present invention with the top hatches in the closed position.

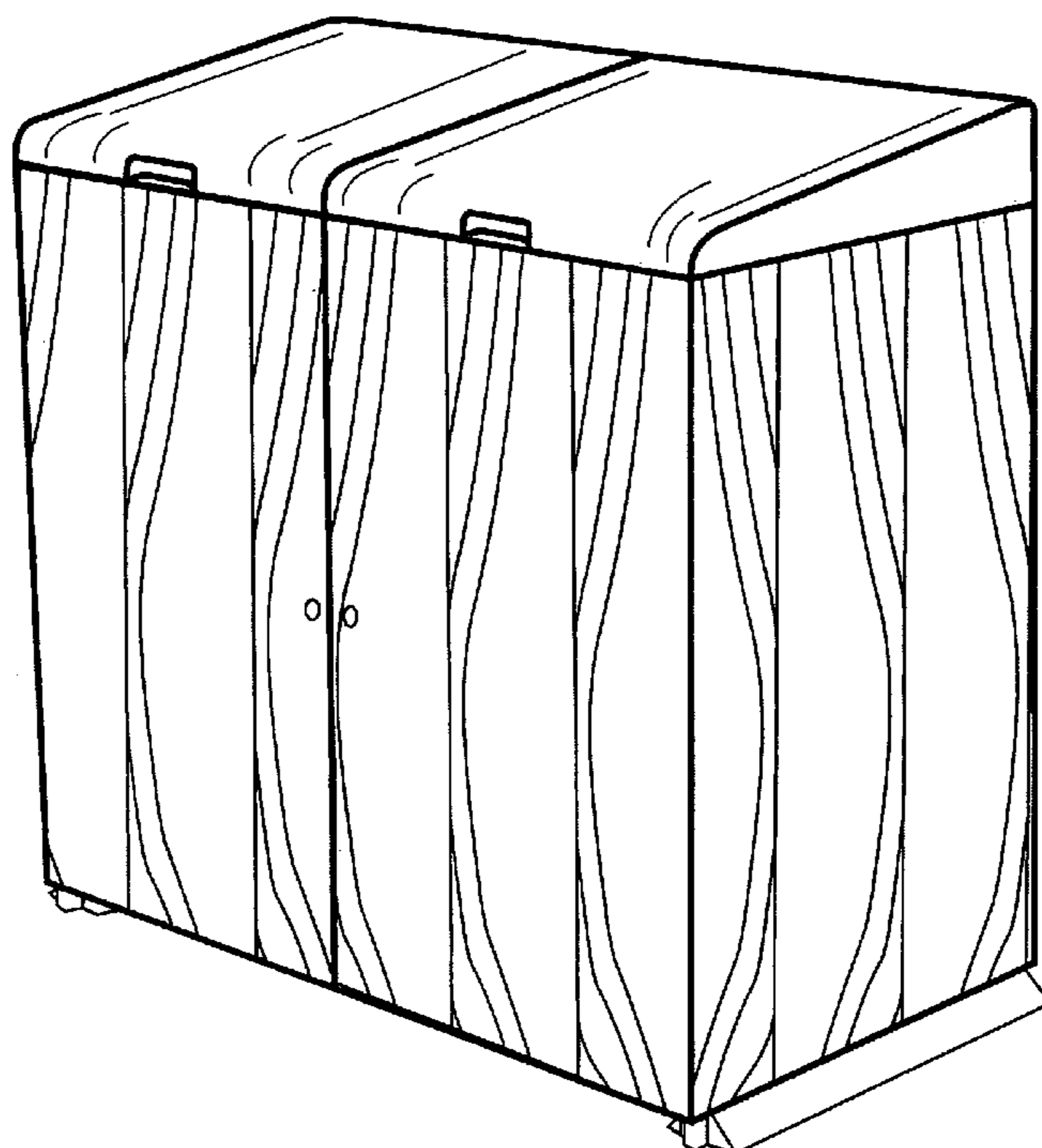

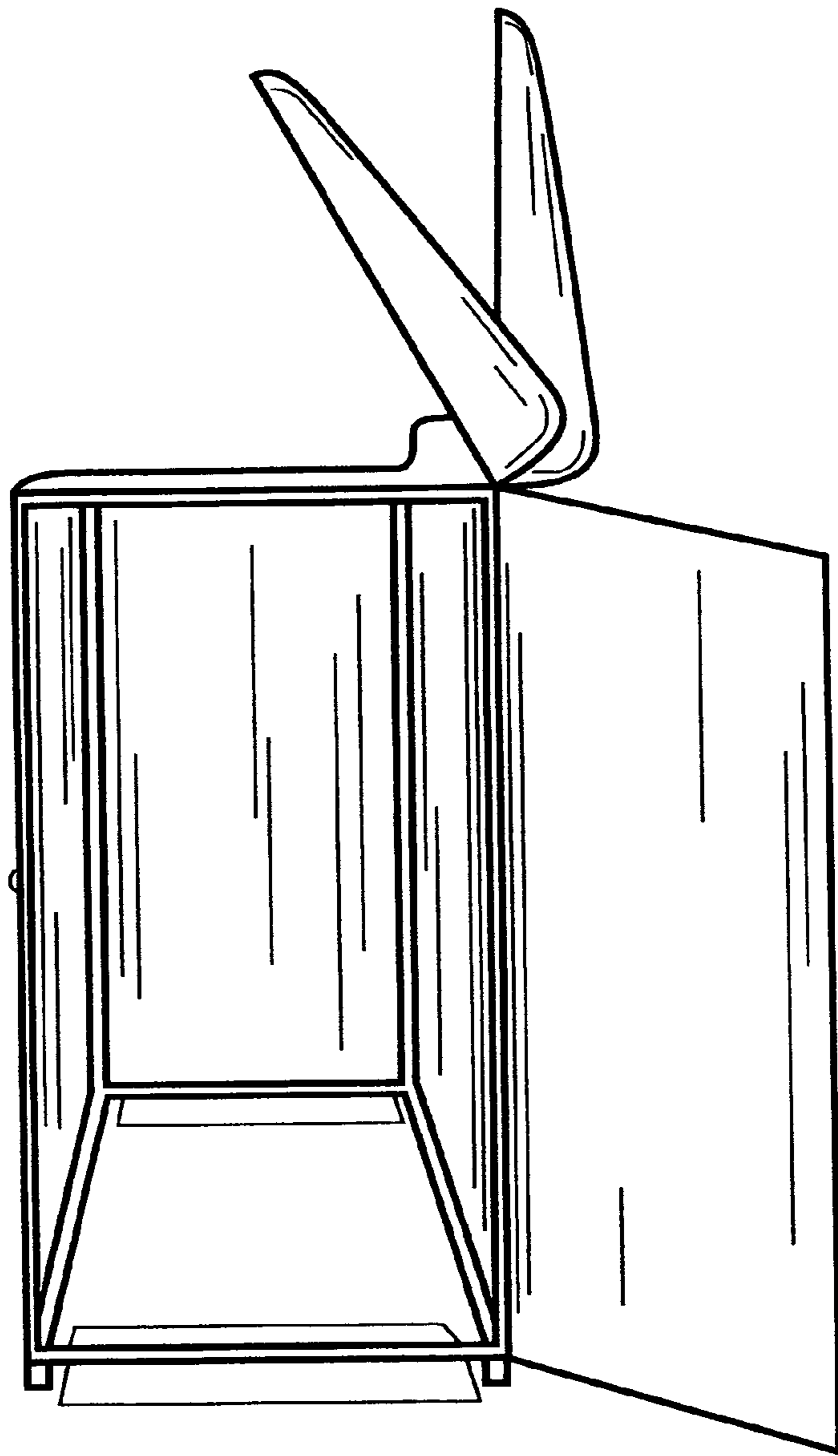

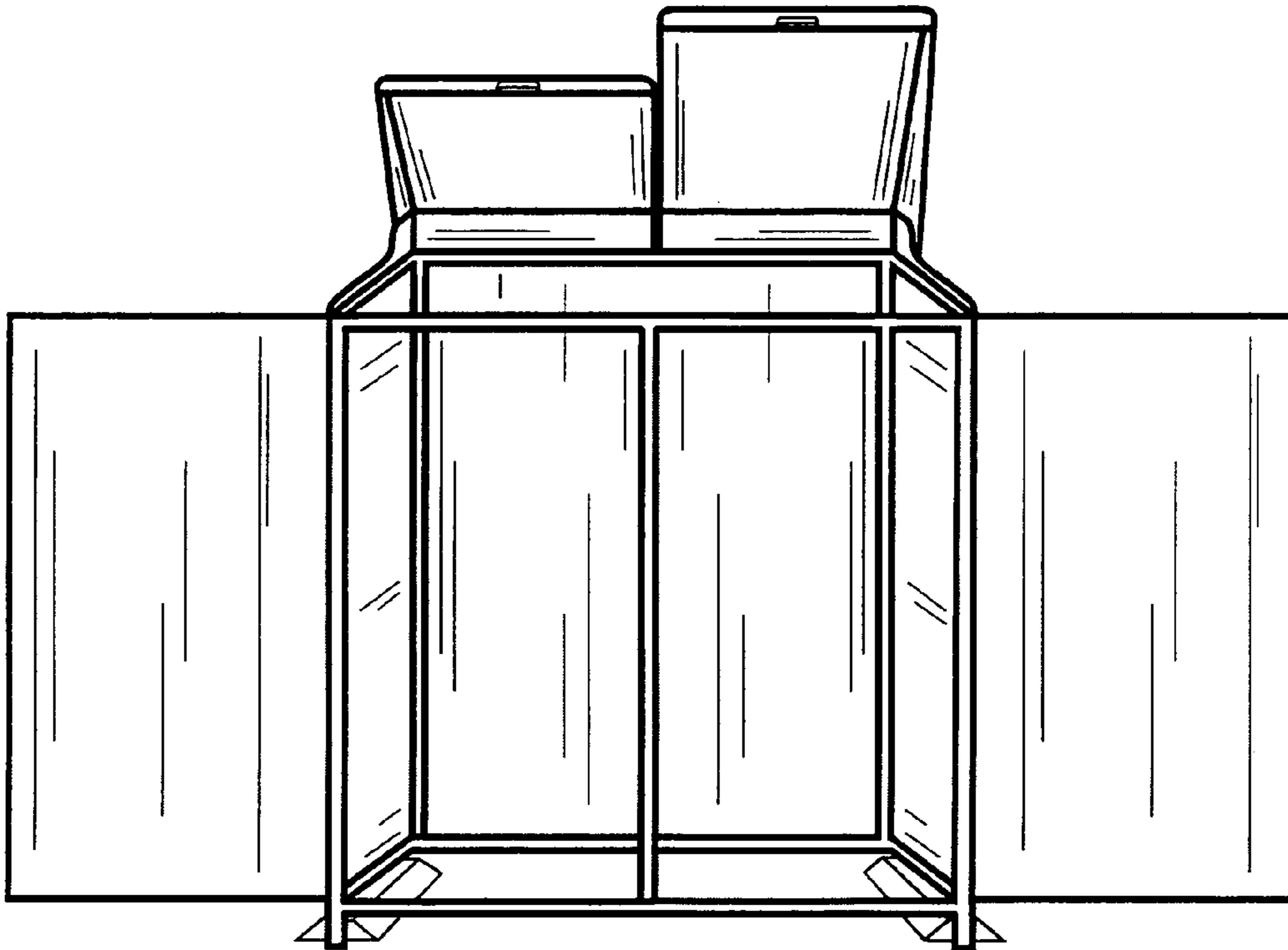

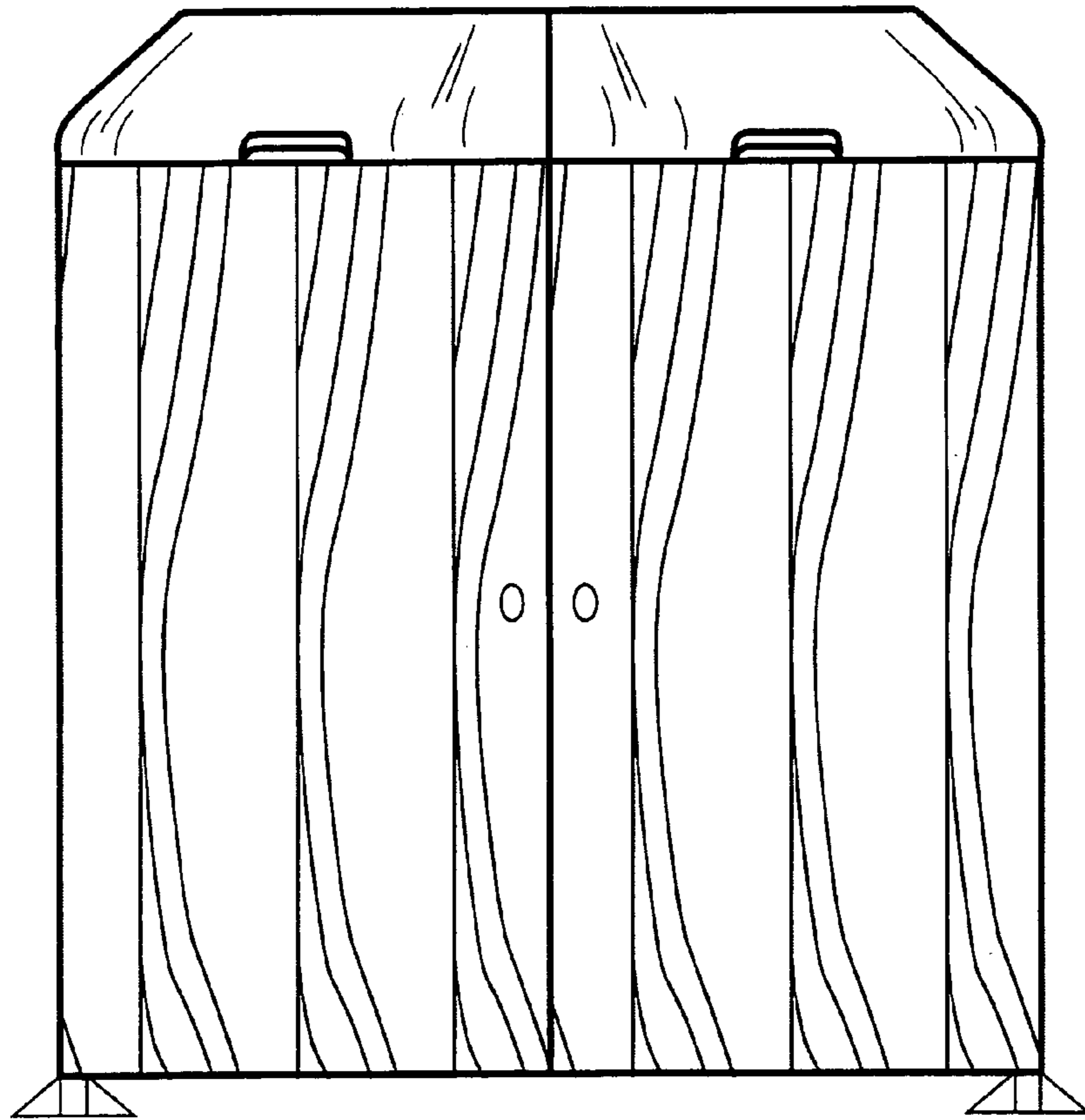

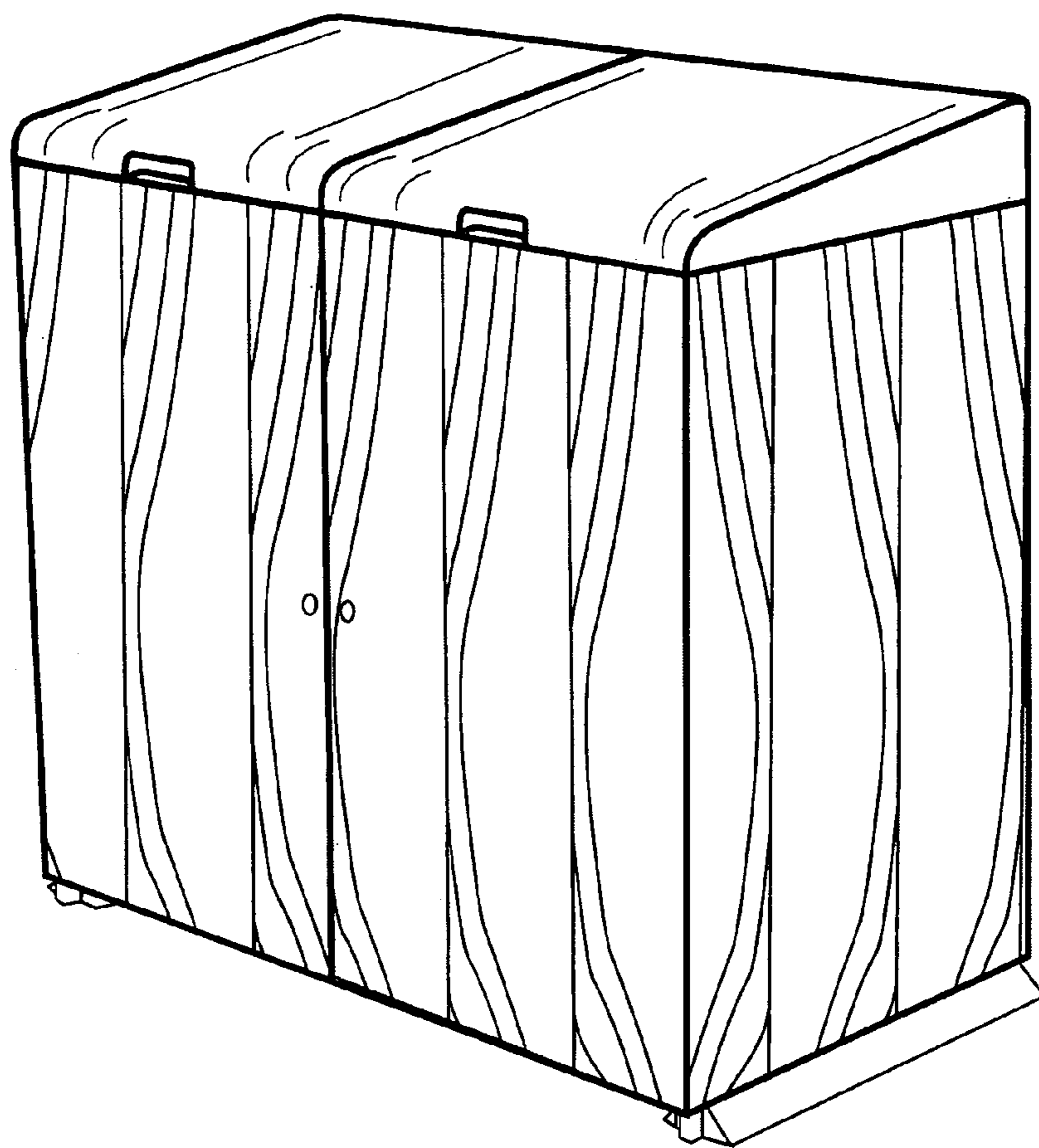

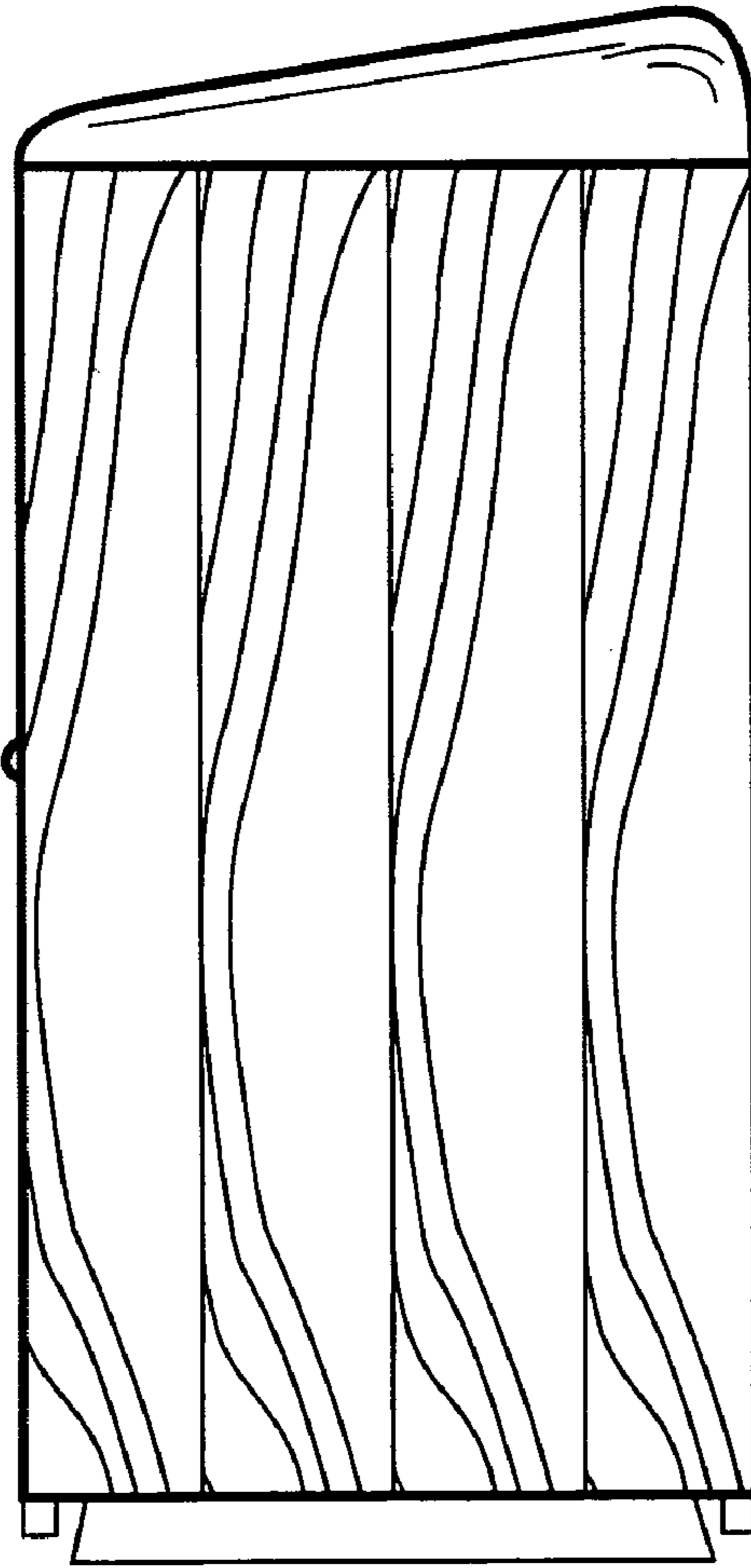

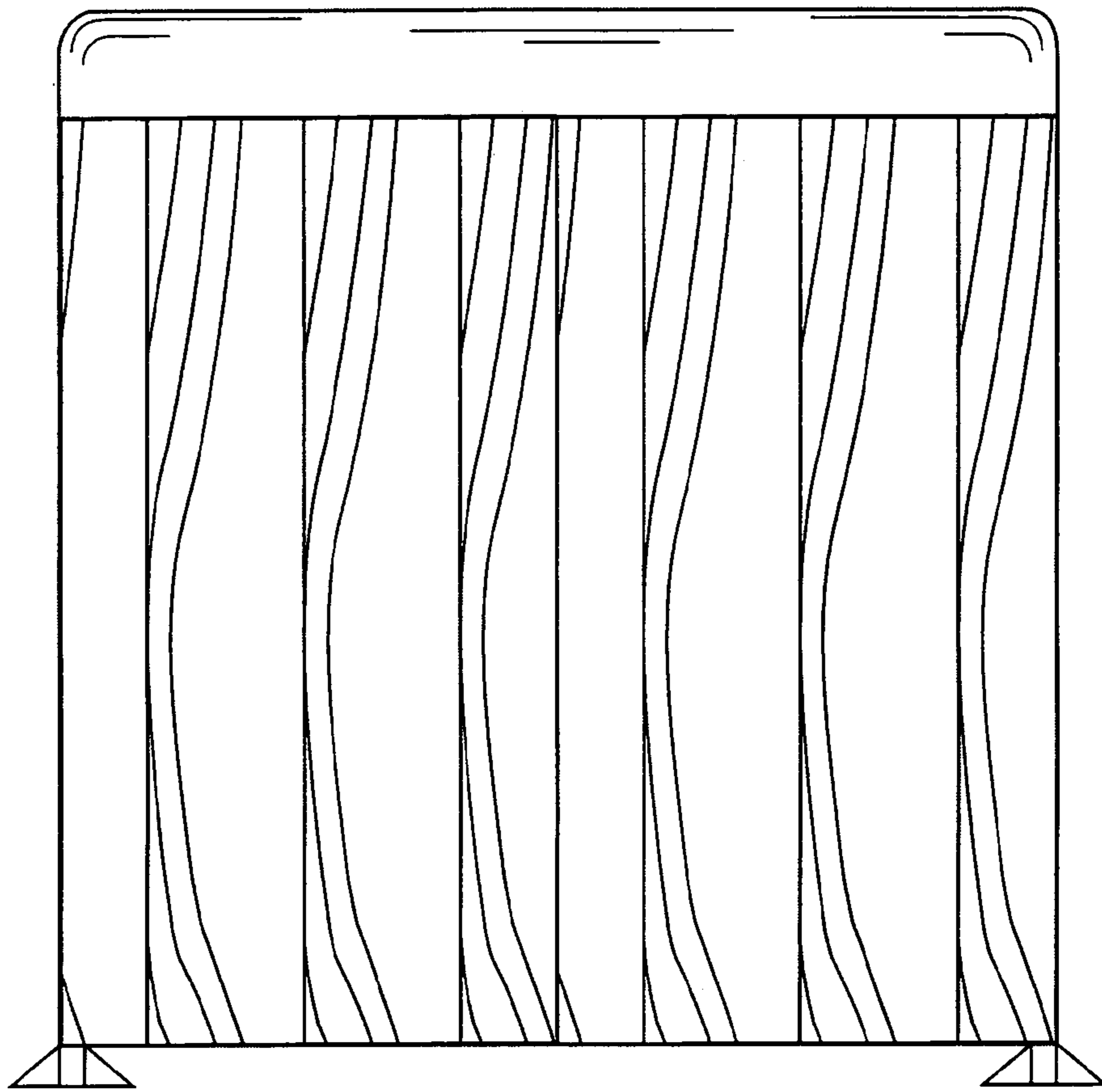

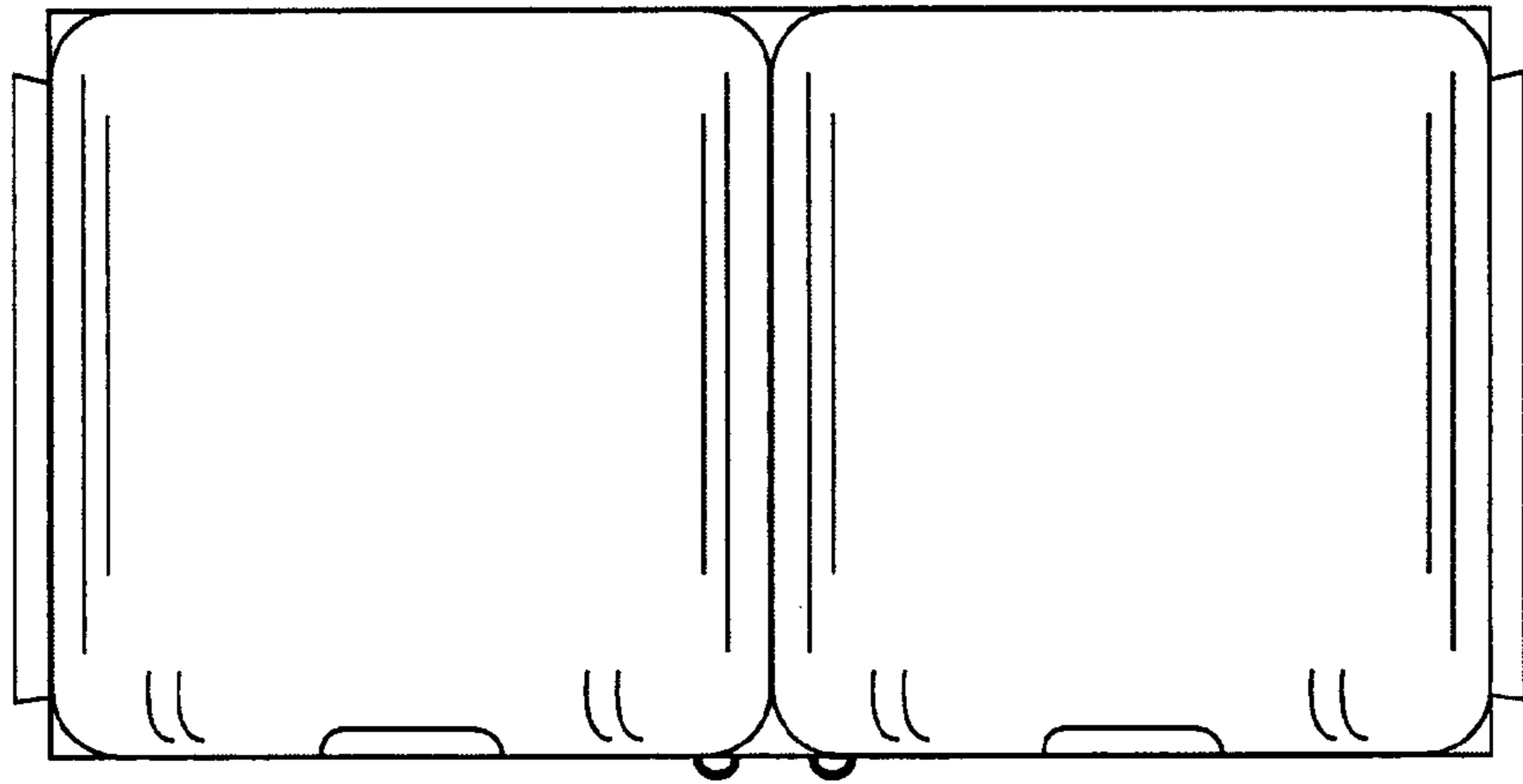
