The ornamental design for pantyhose and tights, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view according to the present invention shown unworn and laying flat;

FIG. 2 is a perspective view according to the present invention shown unworn and slightly opened for the purposes of fully depicting the present invention;

FIG. 3 is a front view according to the present invention shown unworn, the slightly opened portions not visible from this view;

FIG. 4 is a rear view according to the present invention shown unworn, the slightly opened portions not visible from this view;

FIG. 5 is a right side view according to the present invention shown unworn and slightly opened for the purposes of fully depicting the present invention;

FIG. 6 is a left side view according to the present invention shown unworn and slightly opened for the purposes of fully depicting the present invention;

FIG. 7 is a top view according to the present invention shown unworn and slightly opened for the purposes of fully depicting the present invention;

FIG. 8 is a bottom view according to the present invention shown unworn and slightly opened for the purposes of fully depicting the present invention;

FIG. 9 is a rear view according to the present invention shown as worn, the broken lines forming no part of the claimed design;

FIG. 10 is a front view according to the present invention shown as worn, the broken lines forming no part of the claimed design;

FIG. 11 is a top view according to the present invention shown as worn;

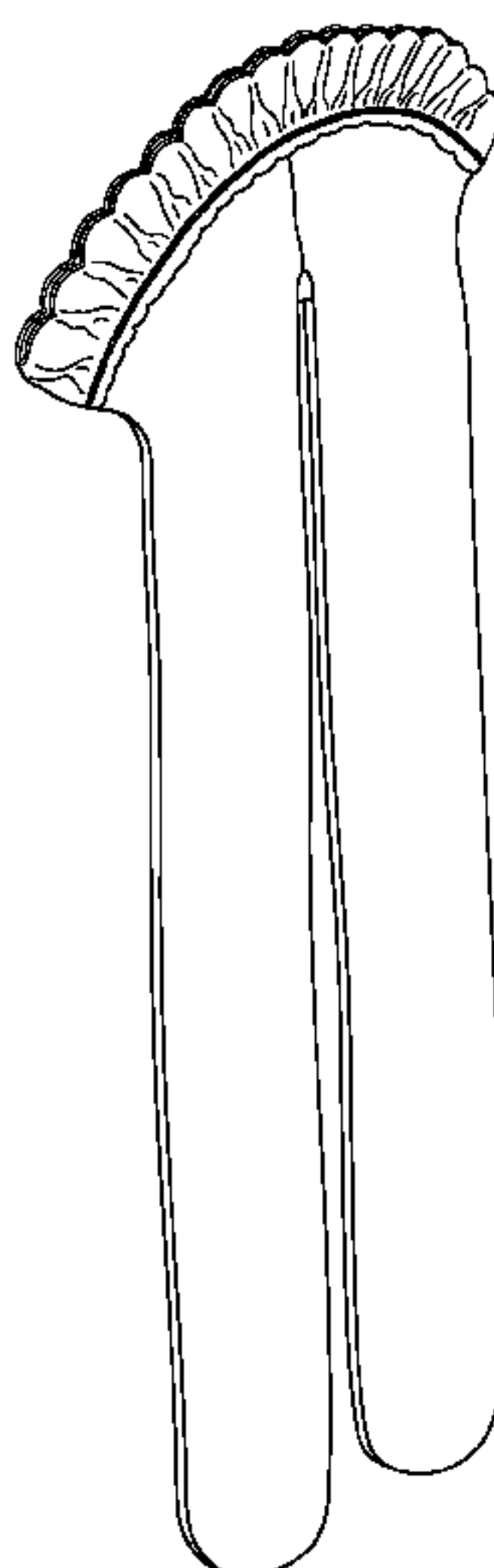
FIG. 12 is a bottom view according to the present invention shown as worn;

FIG. 13 is a right side view according the present invention shown as worn, the left side view is not shown but would be the mirror image of this view; and,

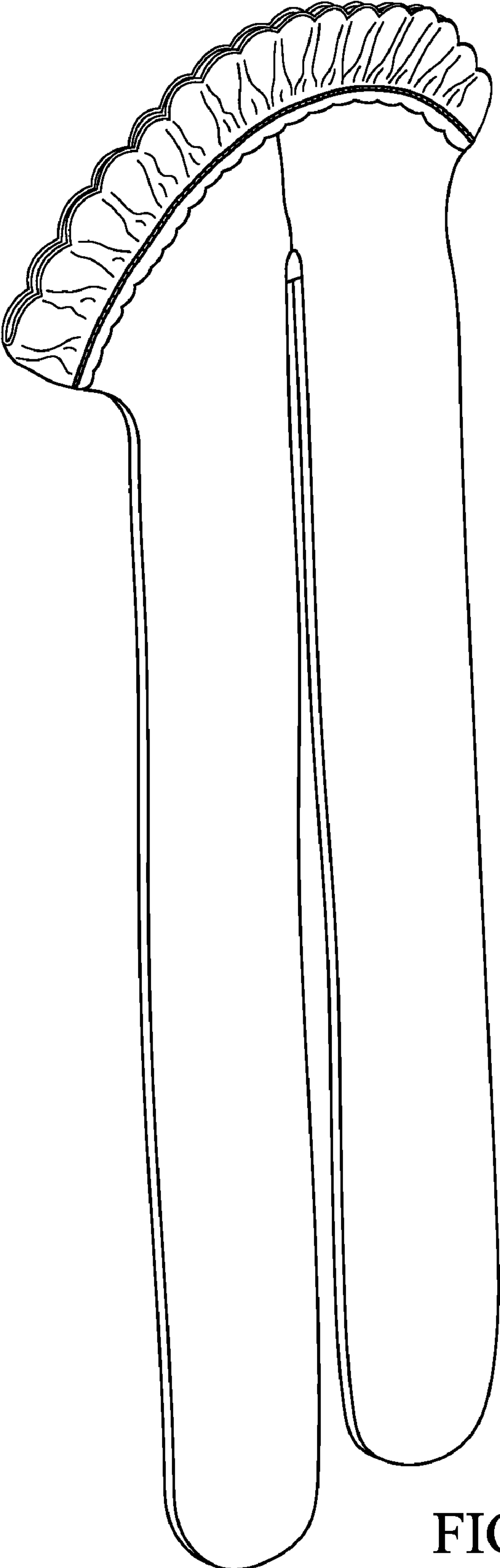

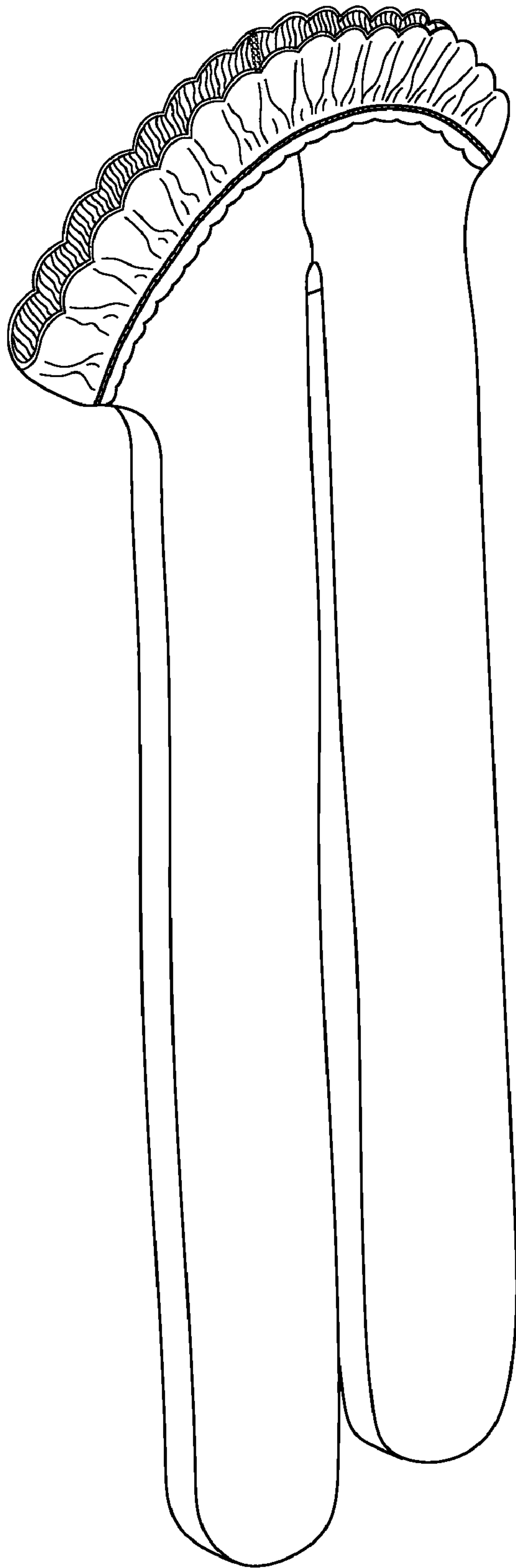

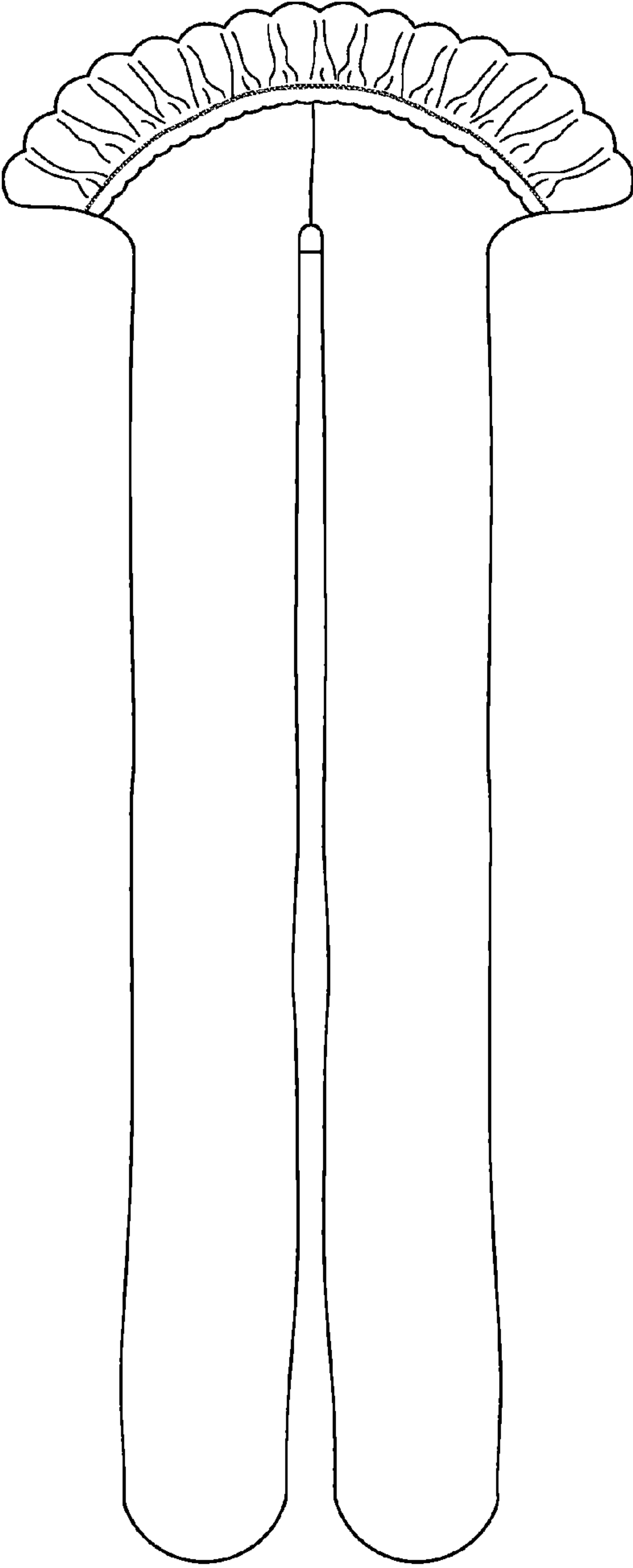

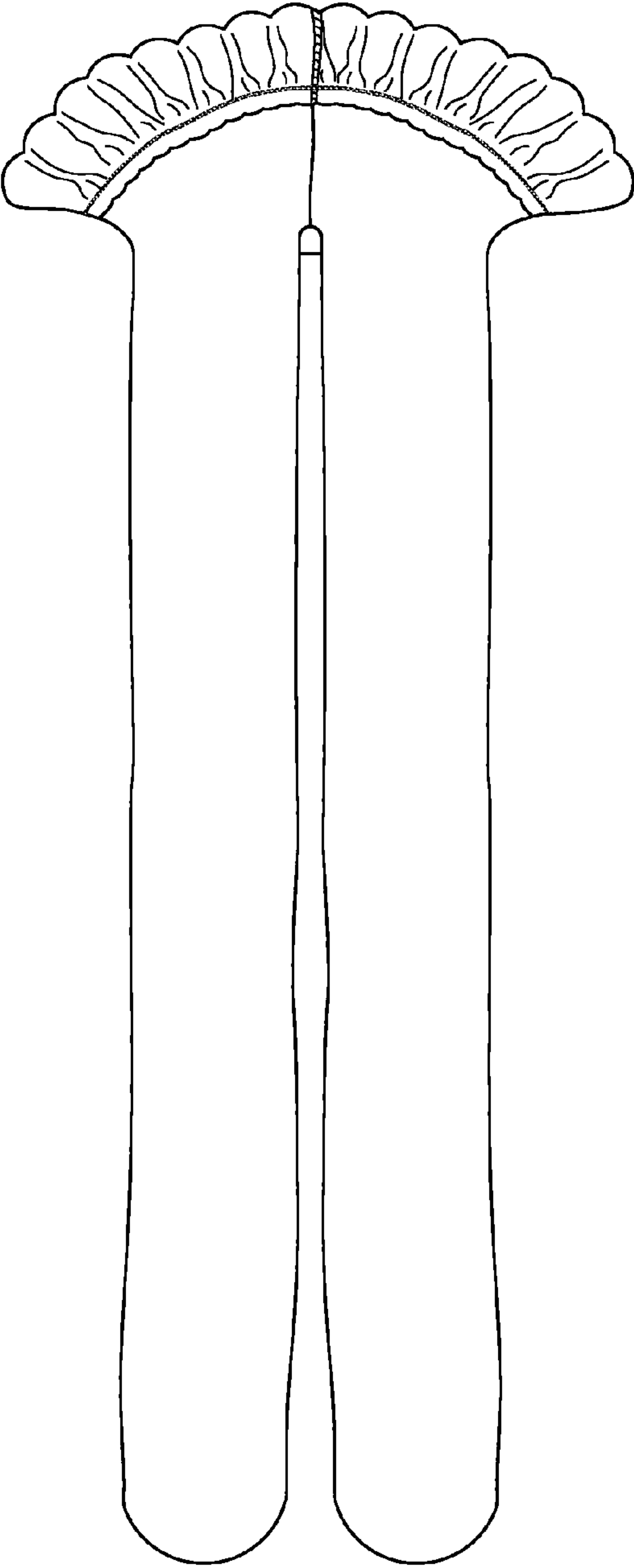

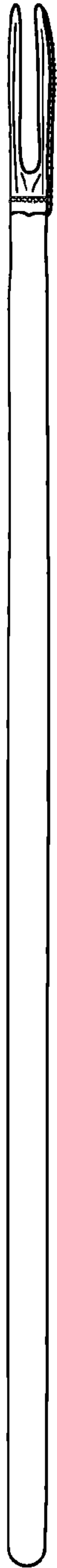

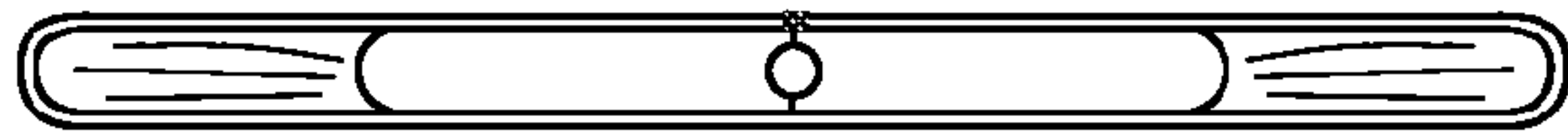

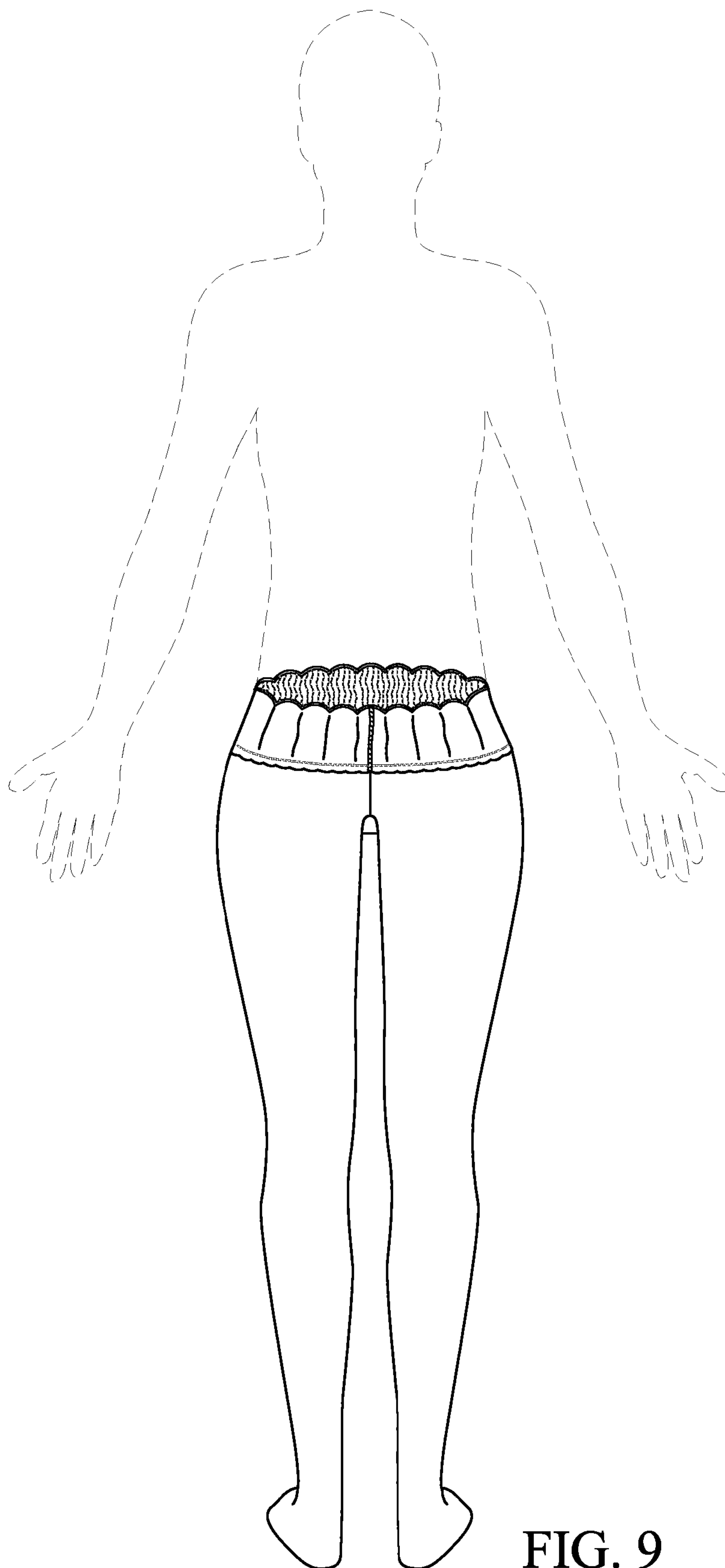

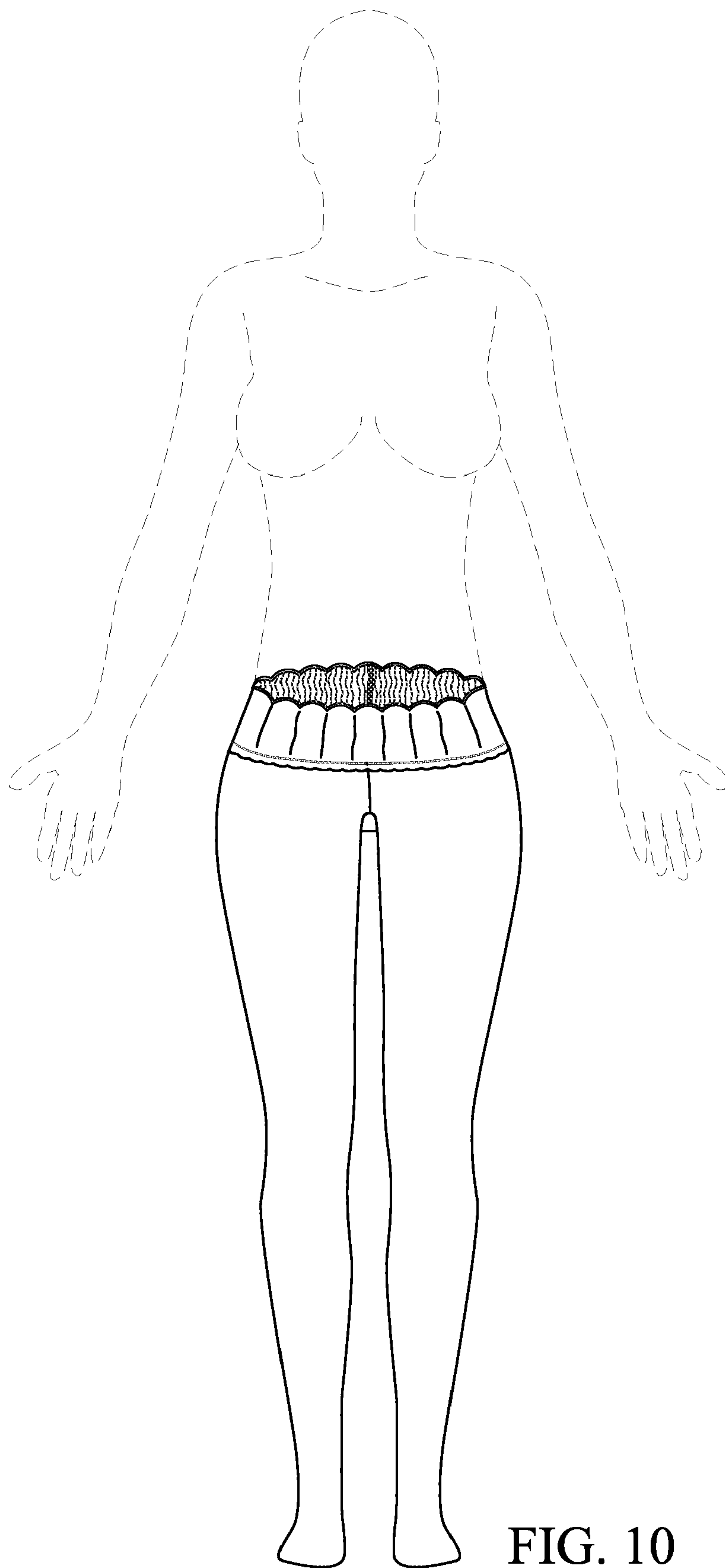

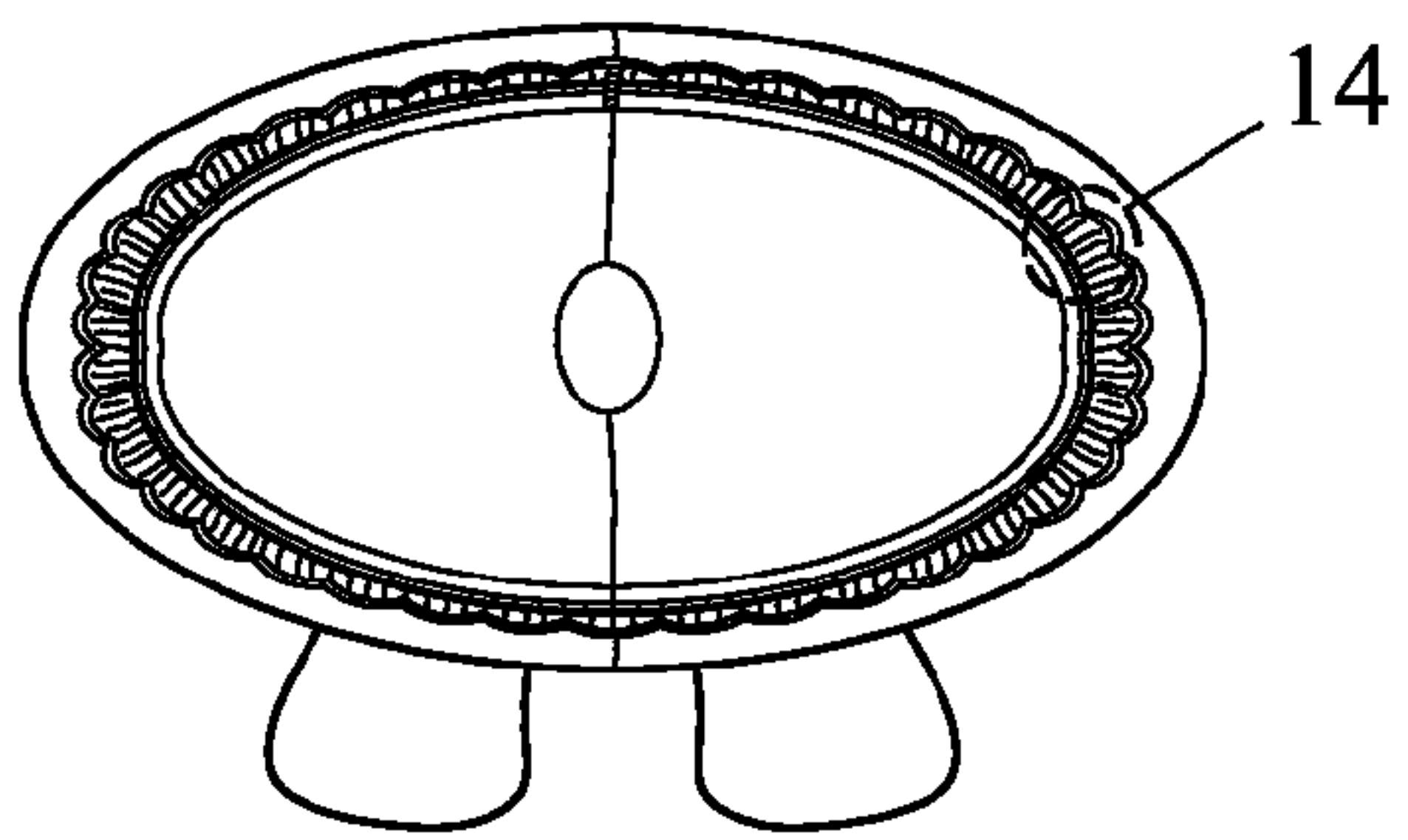

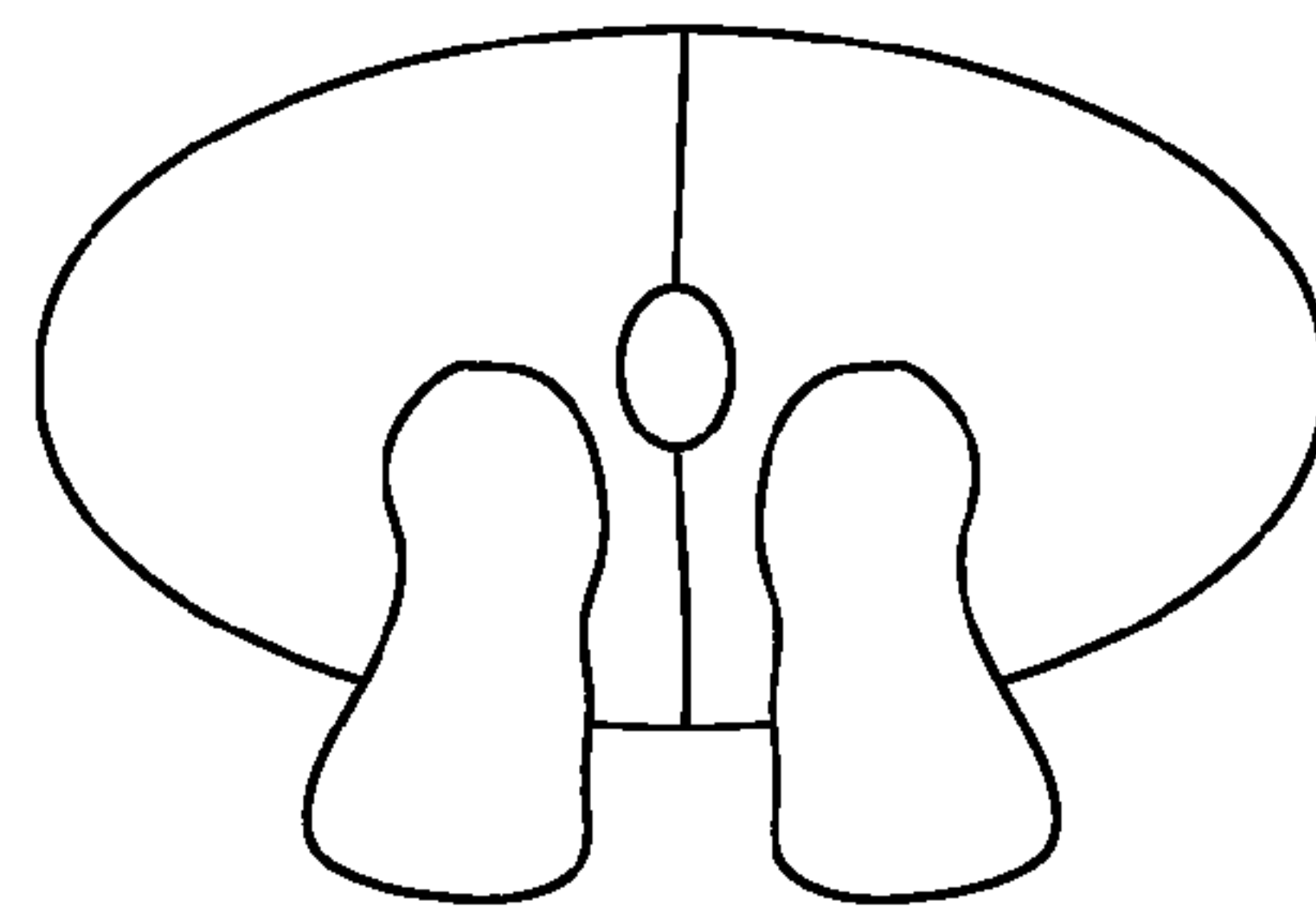

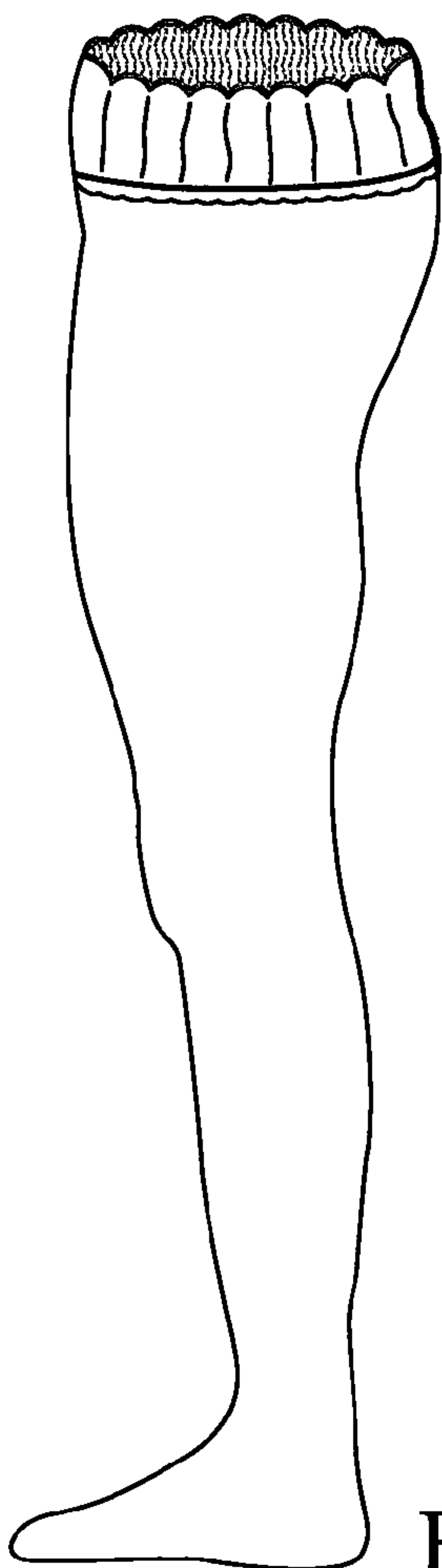

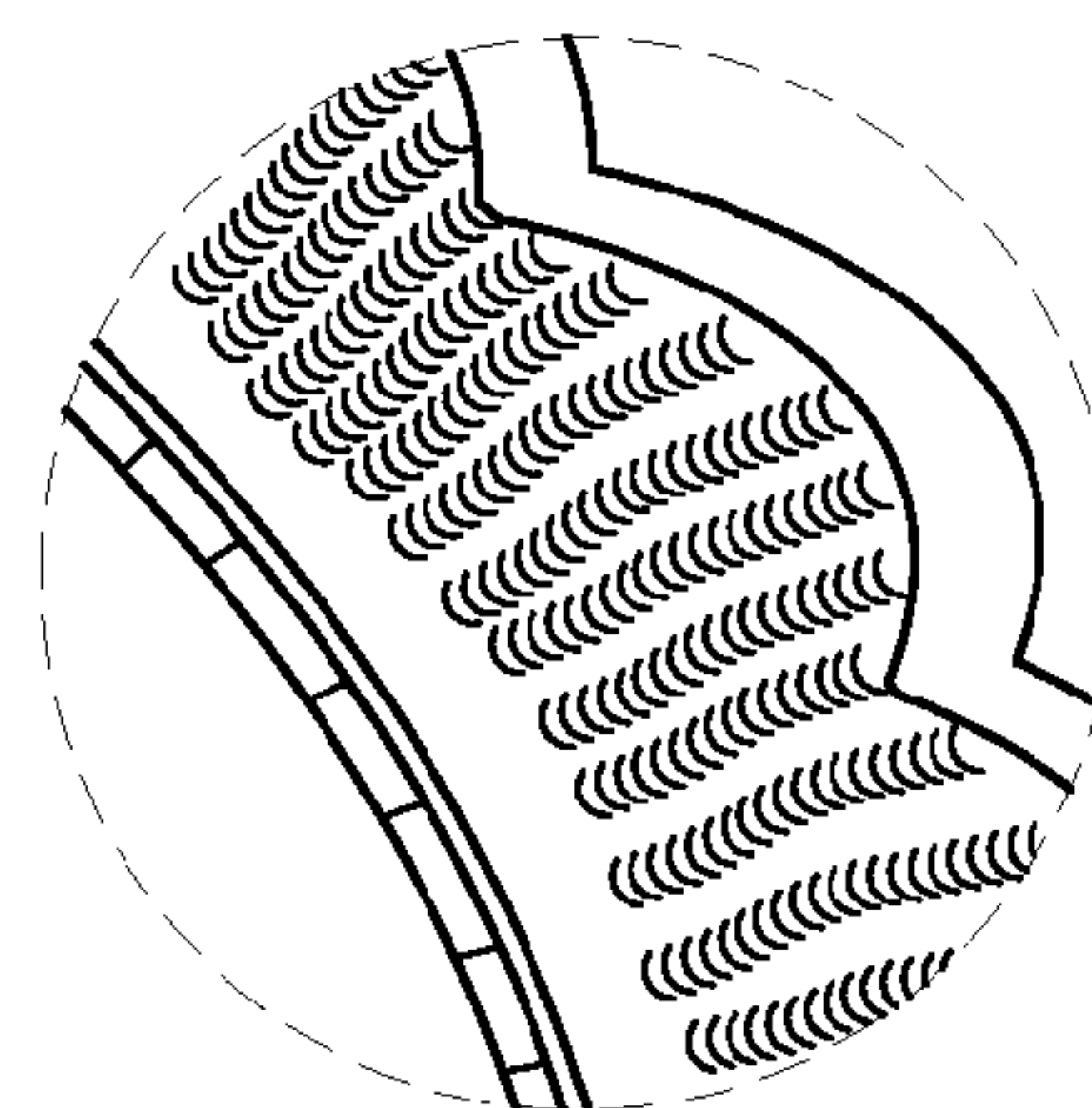
