The design for a cover for wheeled carrier with pull handle, as shown.

DESCRIPTION

FIG. 1: is a front folded view of a cover for a wheeled carrier with pull handle showing my new design.

FIG. 2: is a side folded view of a cover for wheeled carrier with pull handle showing my new design.

FIG. 3: is a front unfolded view of a cover for wheeled carrier with pull handle showing my new design.

FIG. 4: is a top deployed view of a cover for wheeled carrier with pull handle showing my new design.

FIG. 5: is a rear deployed view, with side handle access flap open, of a cover for wheeled carrier with pull handle showing my new design.

FIG. 6: is a left side view of a cover for wheeled carrier with pull handle showing my new design.

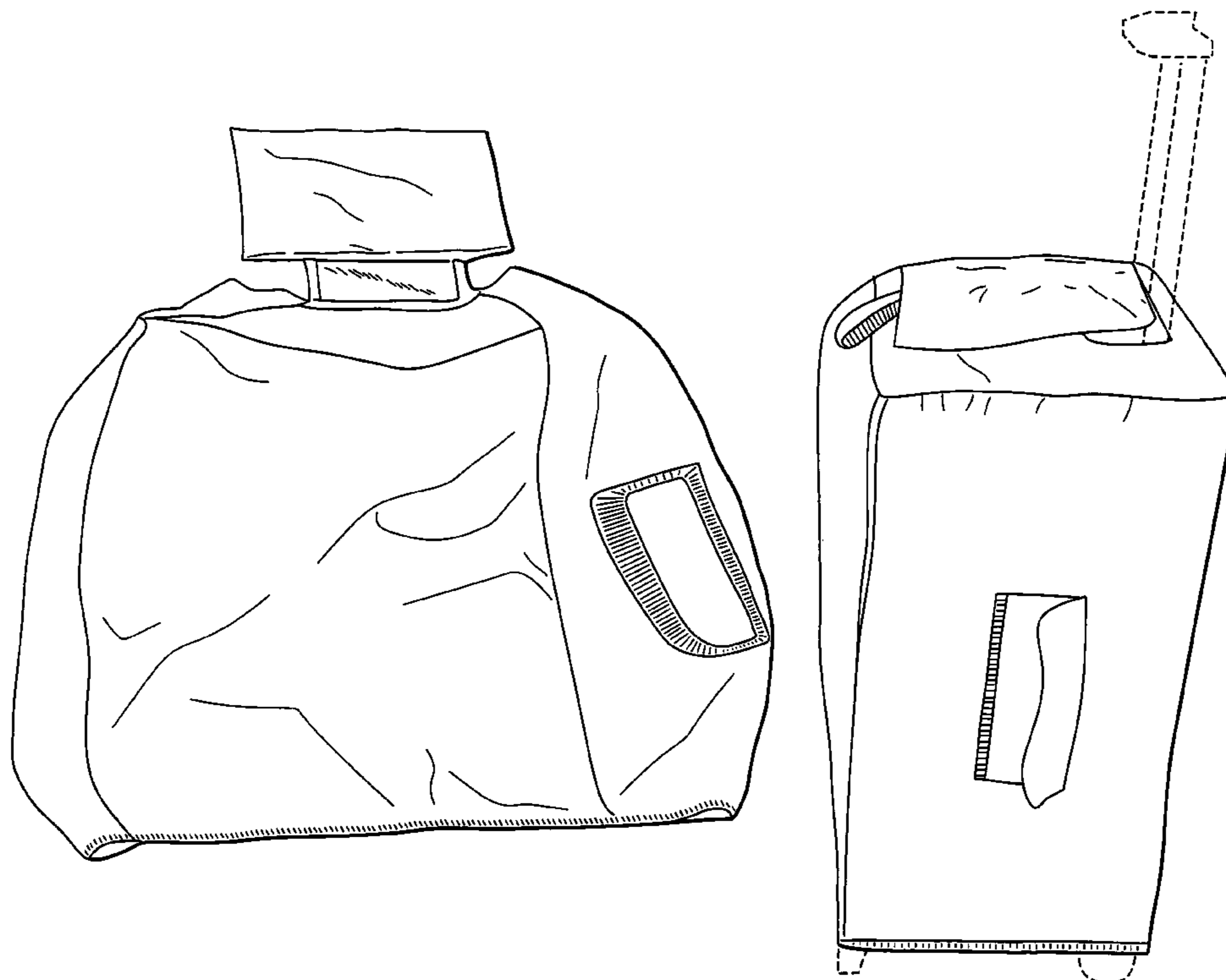
FIG. 7: is a right side view, with side handle access flap open, of a cover for wheeled carrier with pull handle showing my new design.

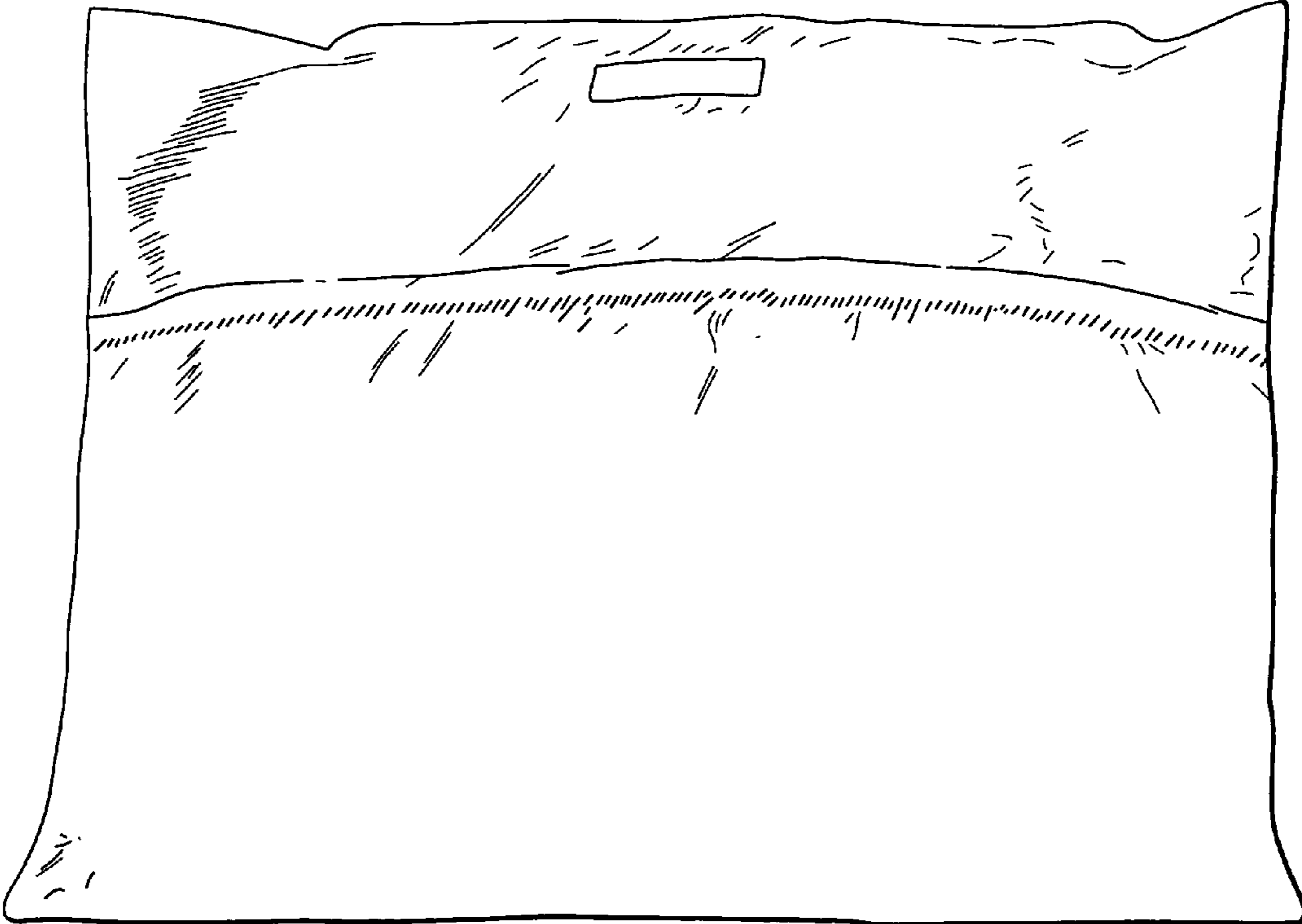

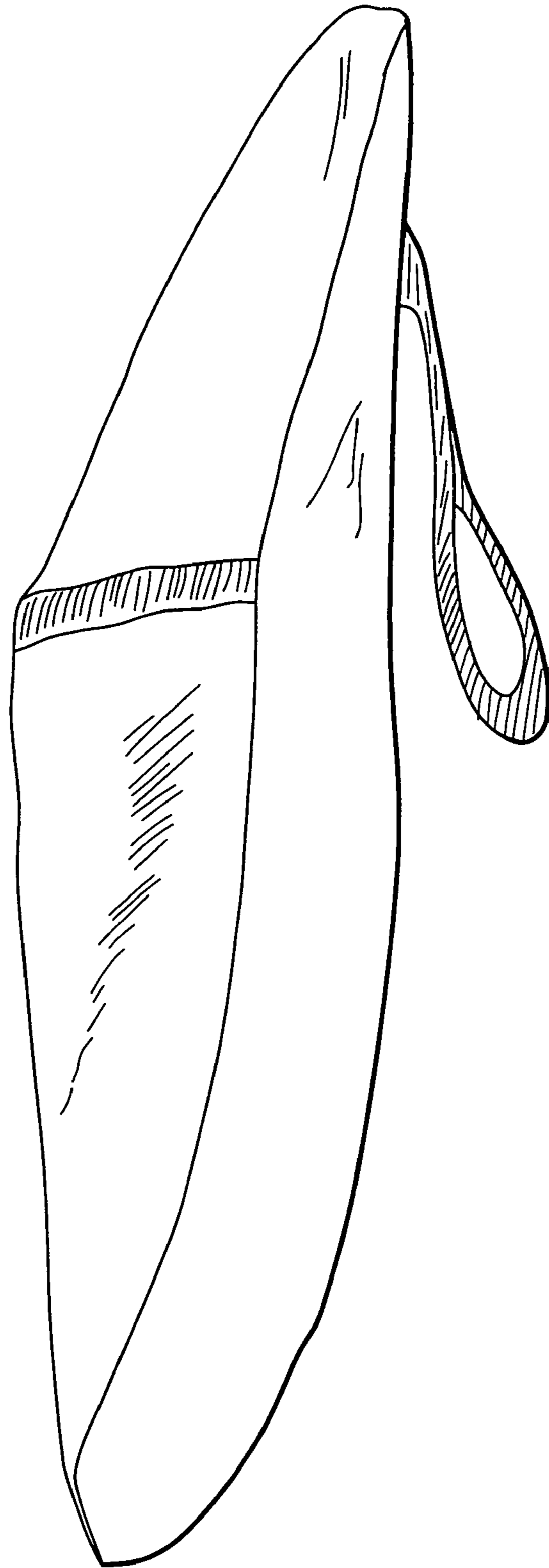

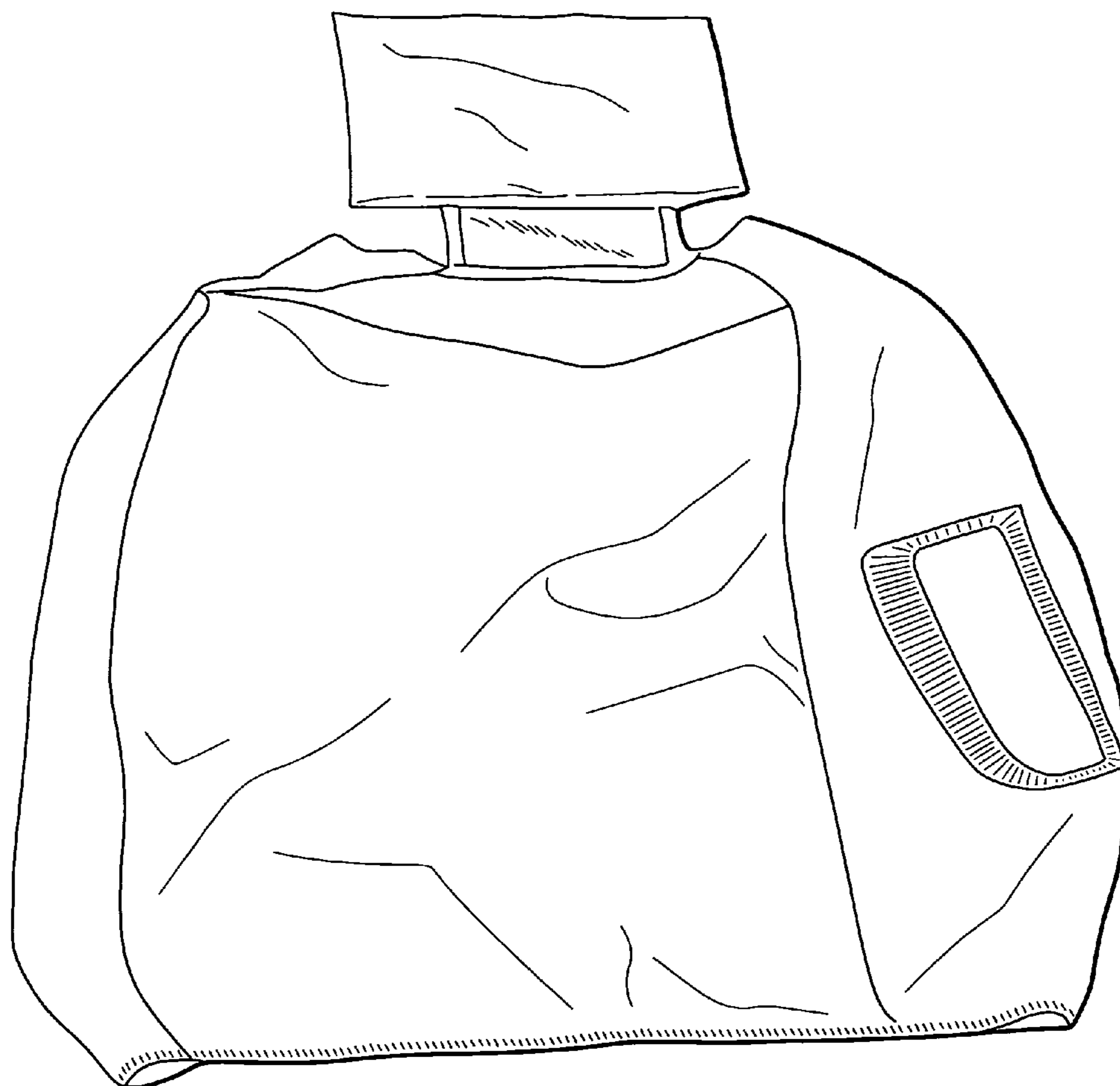

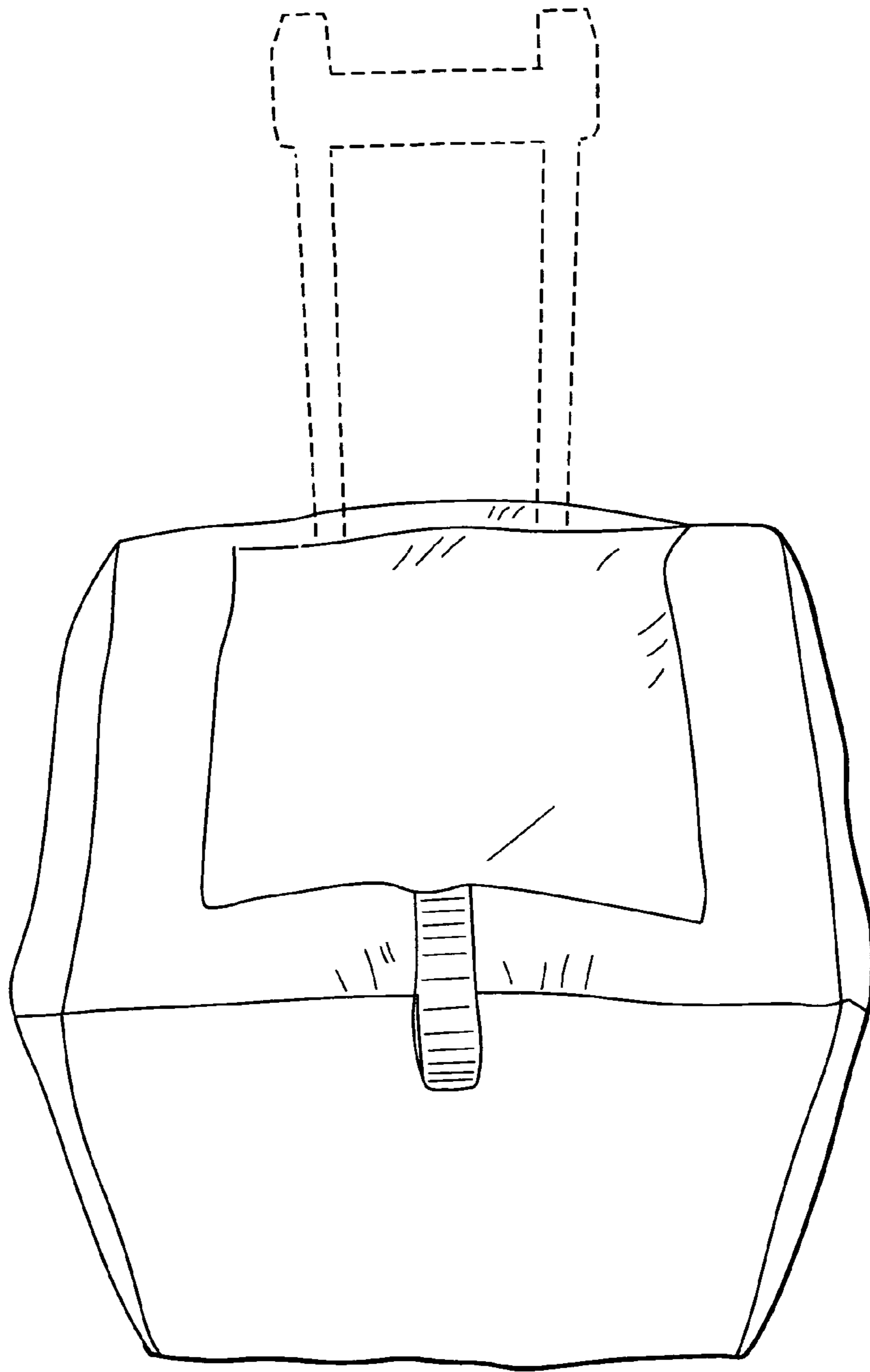

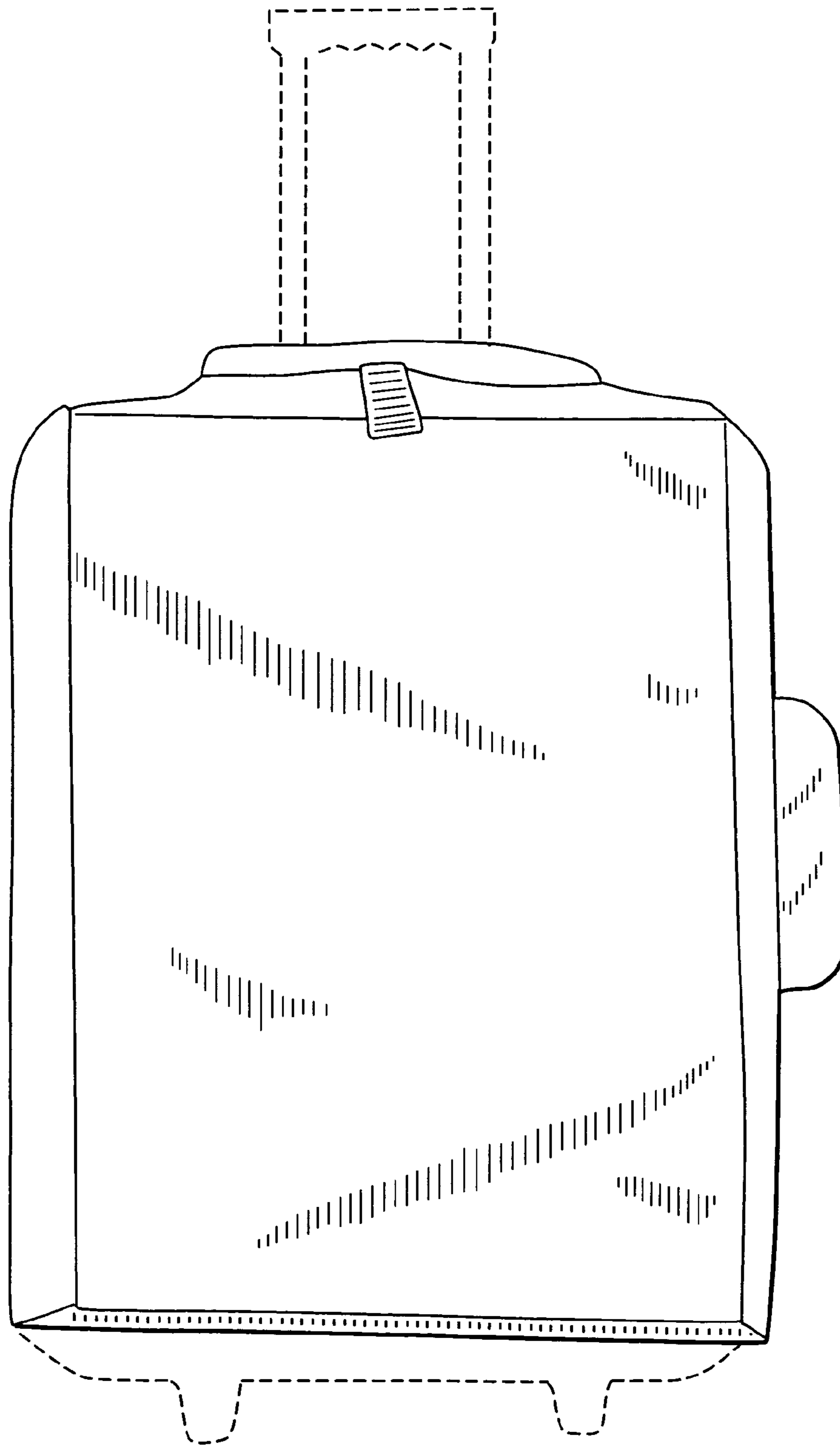

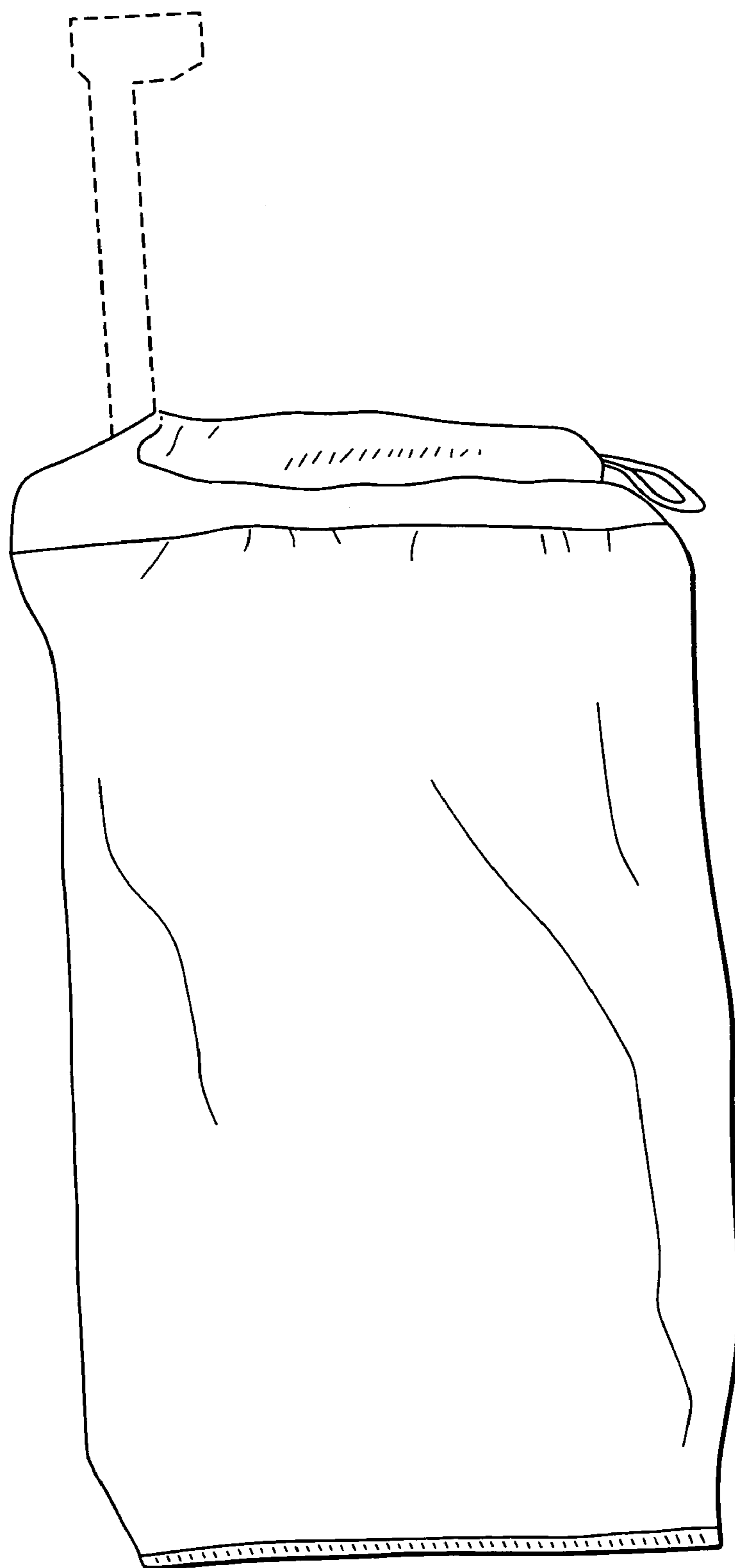

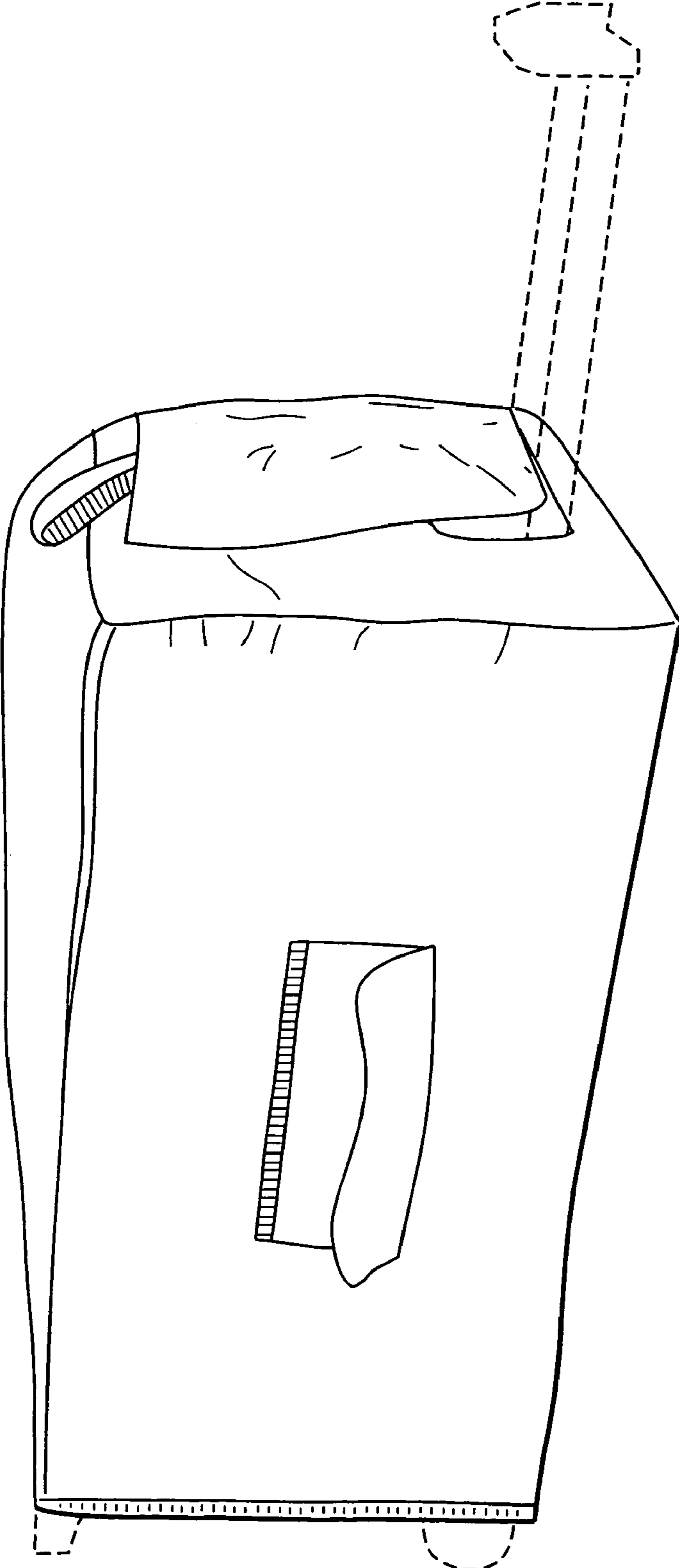

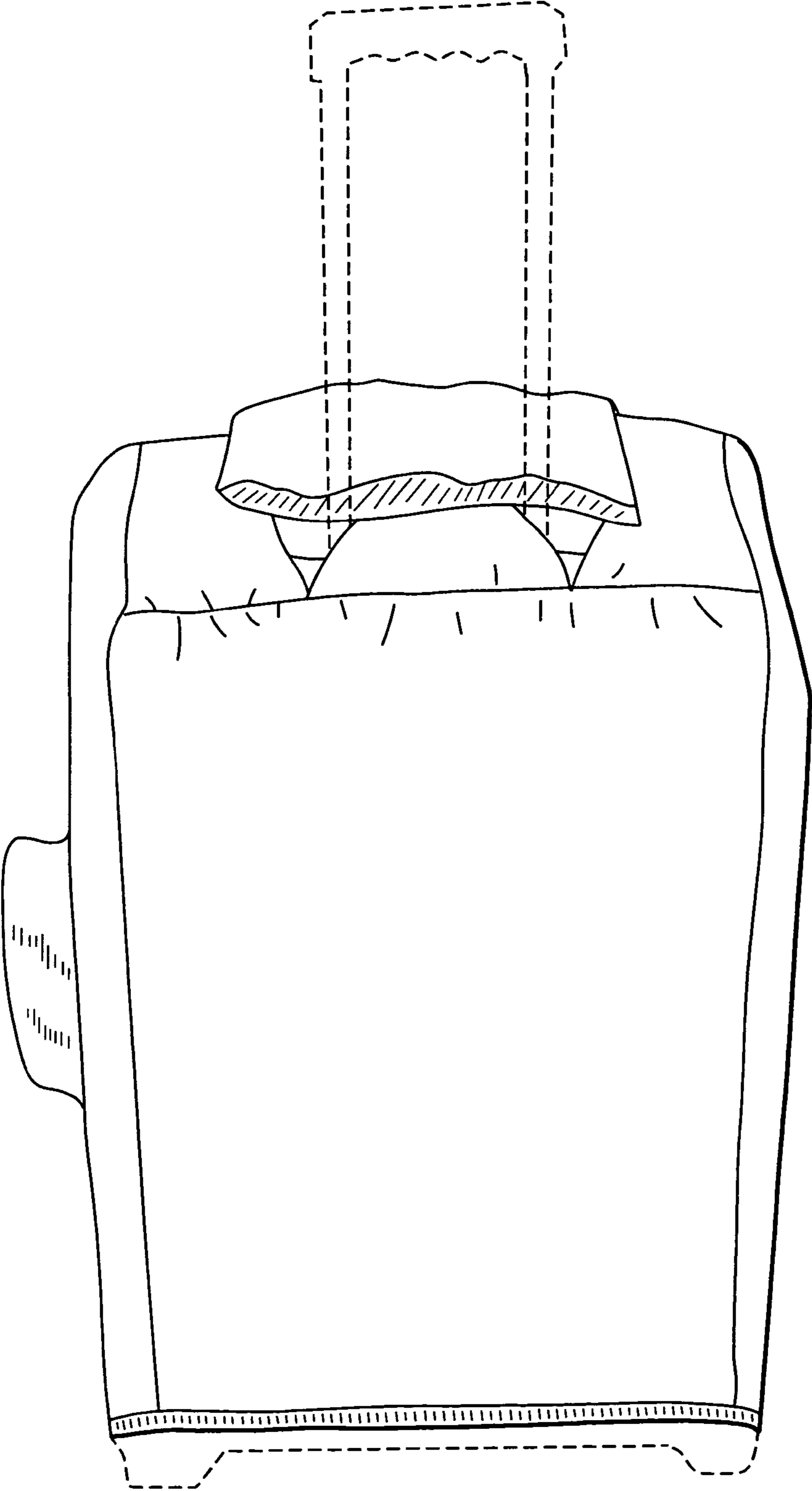

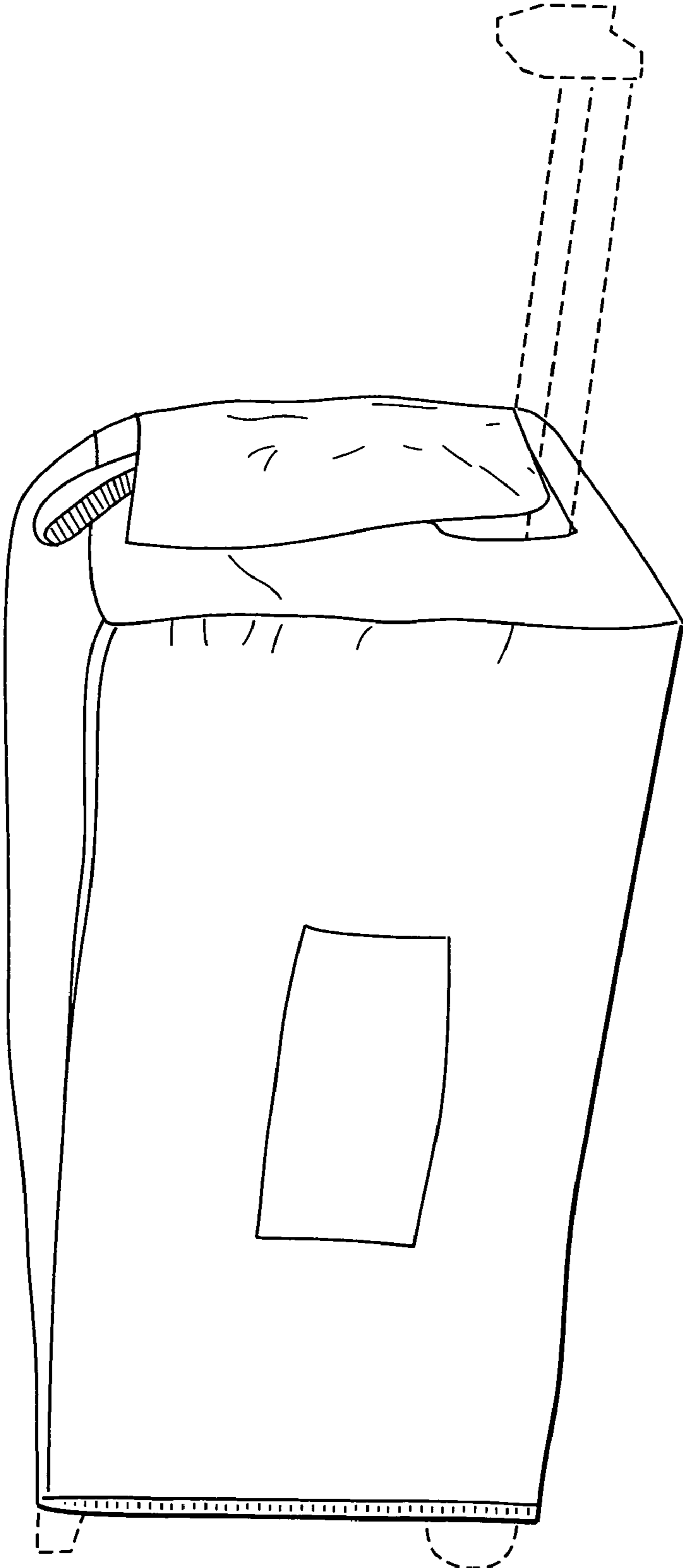
