(57) **CLAIM**

We claim the ornamental design for a toothbrush, as shown and described.

**DESCRIPTION**

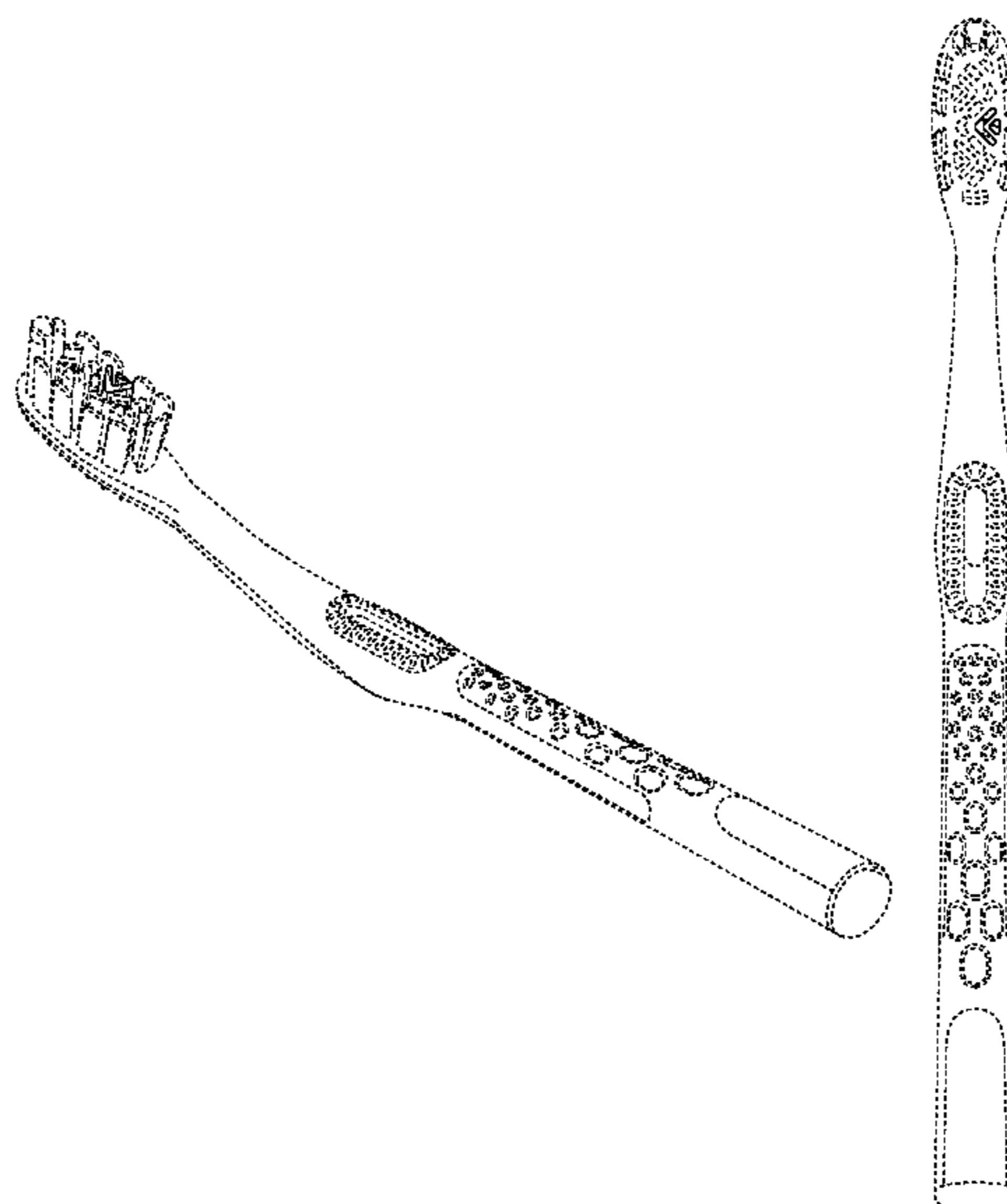
FIG. 1 is a front, right side, bottom perspective view of a toothbrush showing our new design;

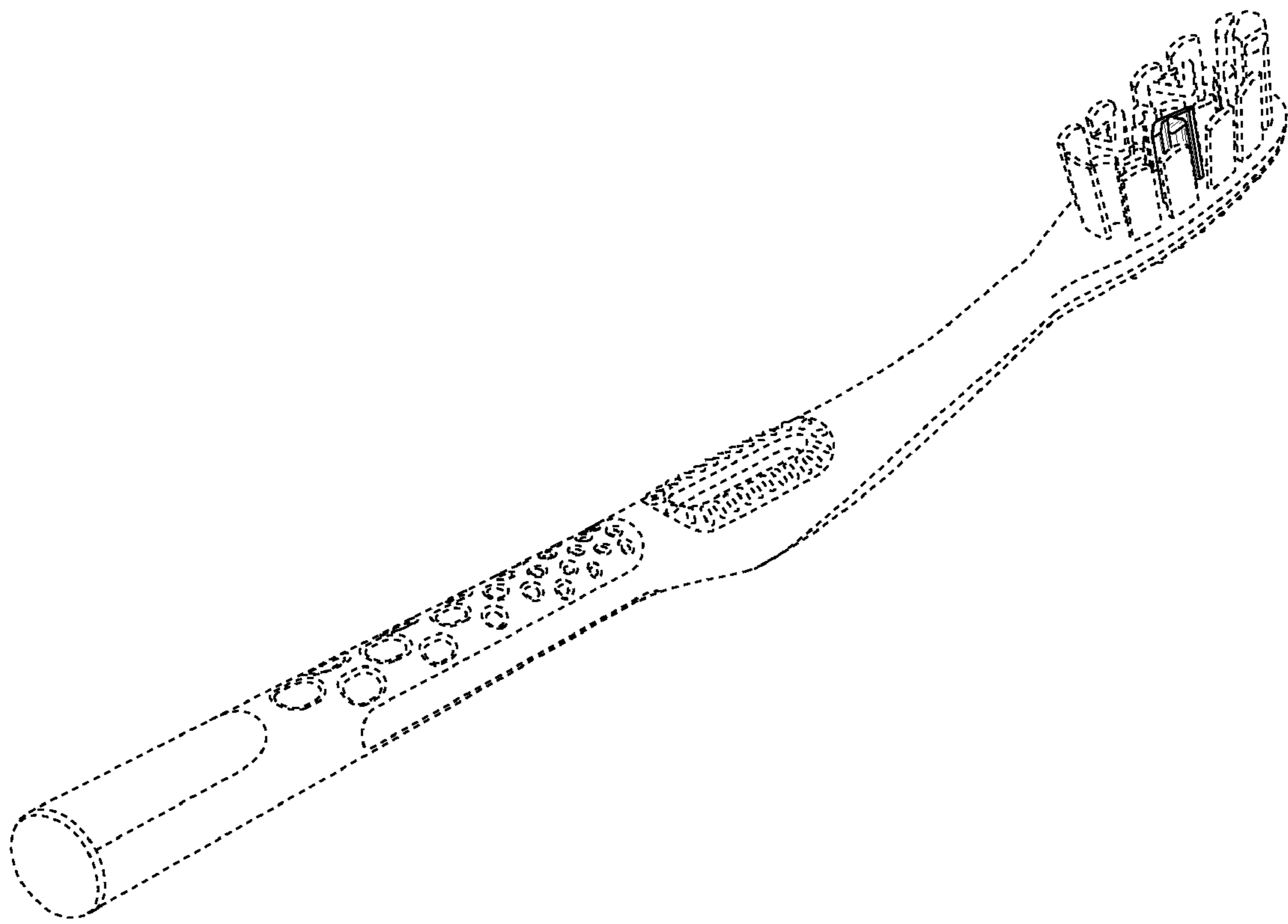

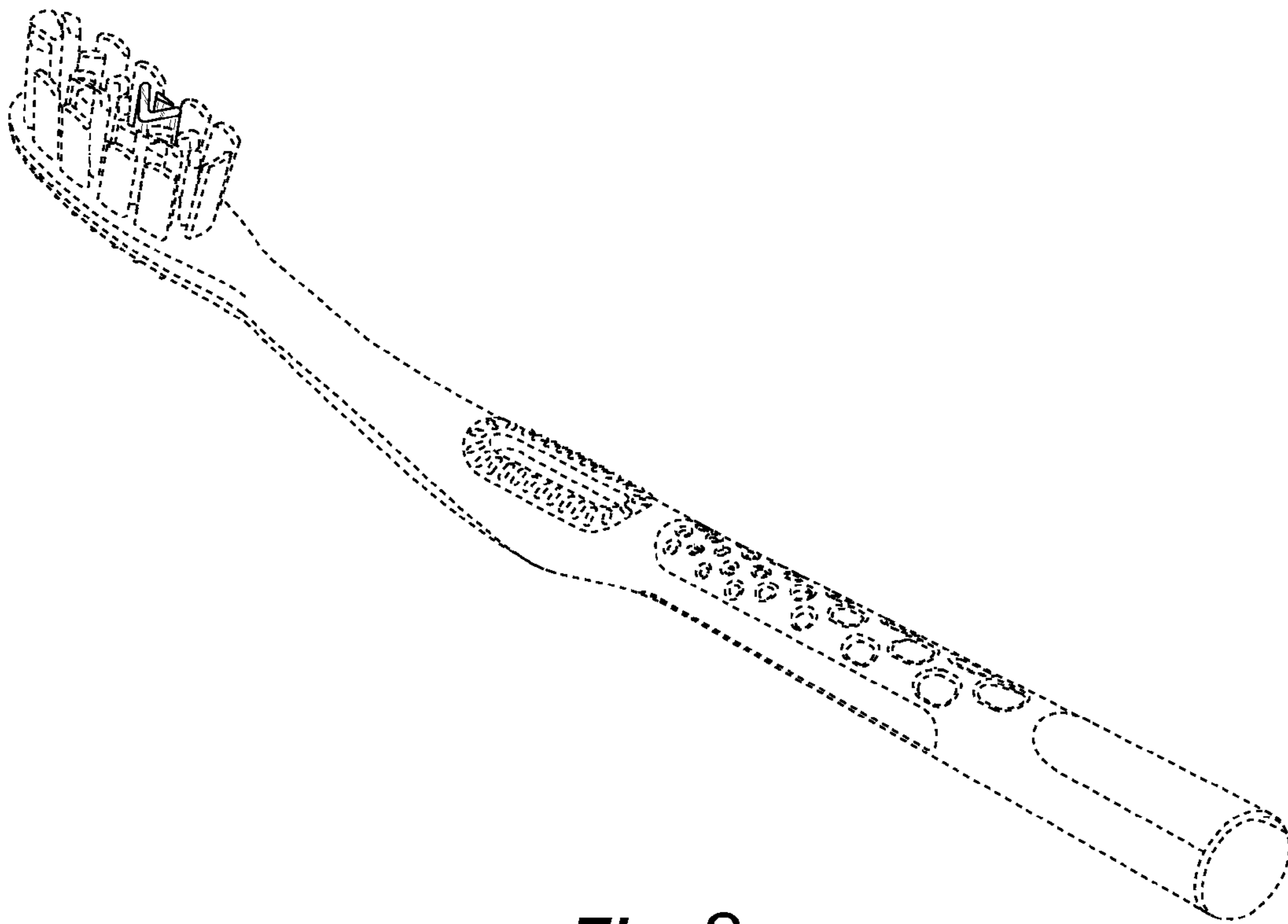

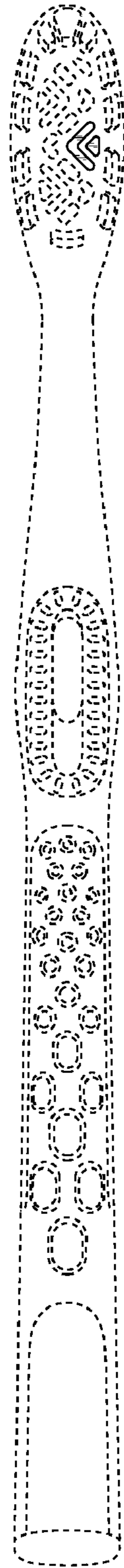
