(57) **CLAIM**

The ornamental design for a toothbrush with tongue scraper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a toothbrush with tongue scraper showing our new design;

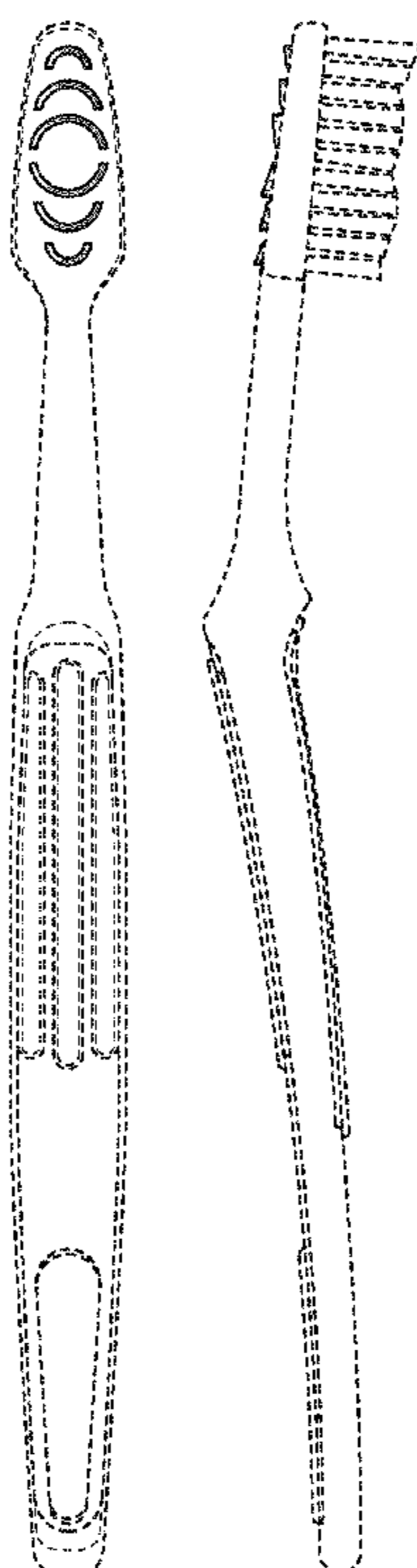
FIG. 2 is rear elevation view thereof;

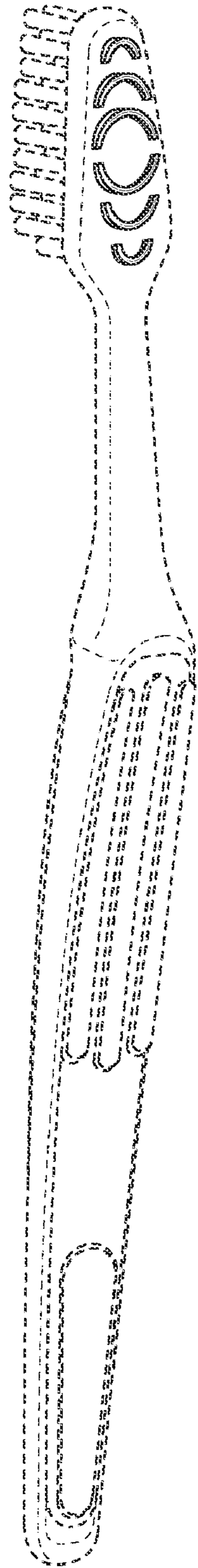

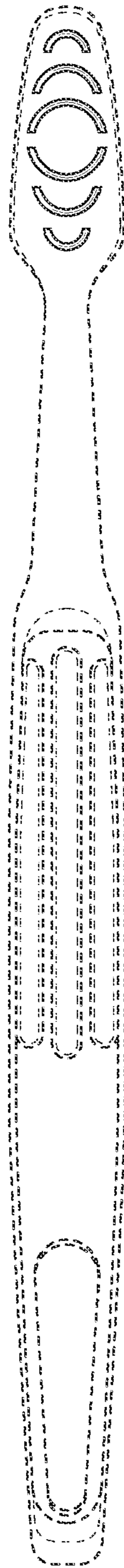

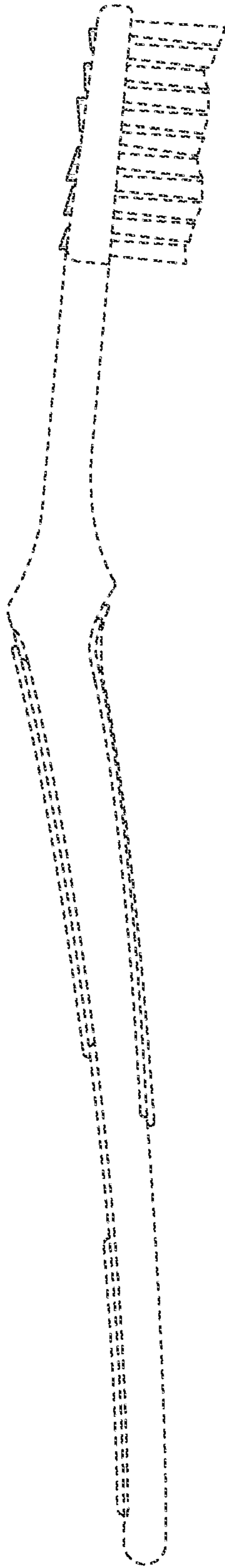

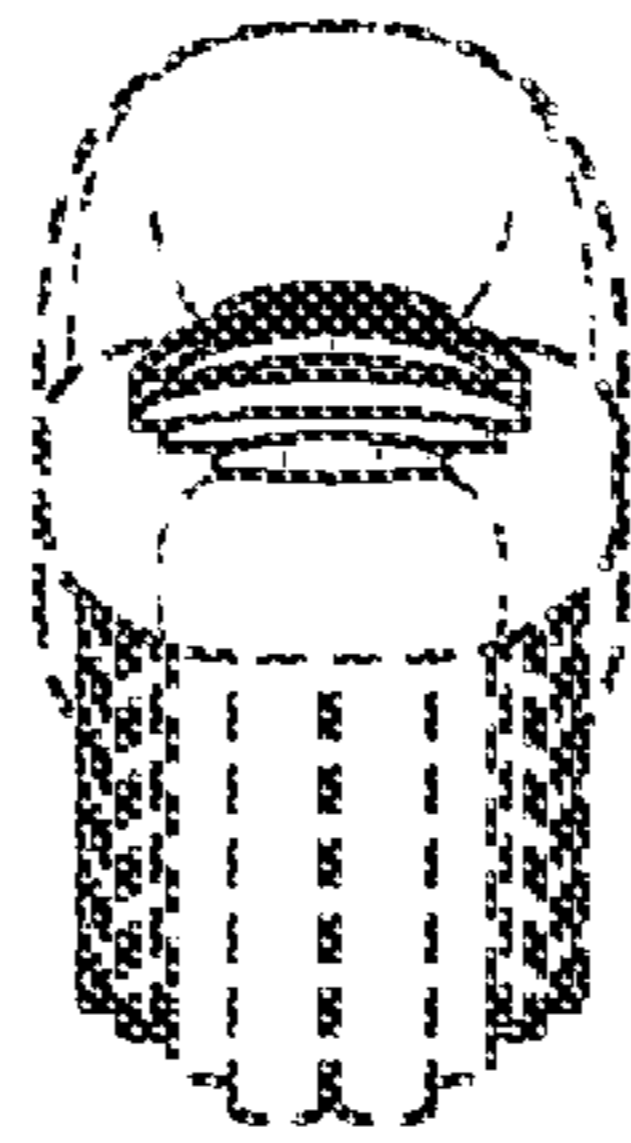
