FIG. 2 is a top plan view of a second embodiment of the fabric.

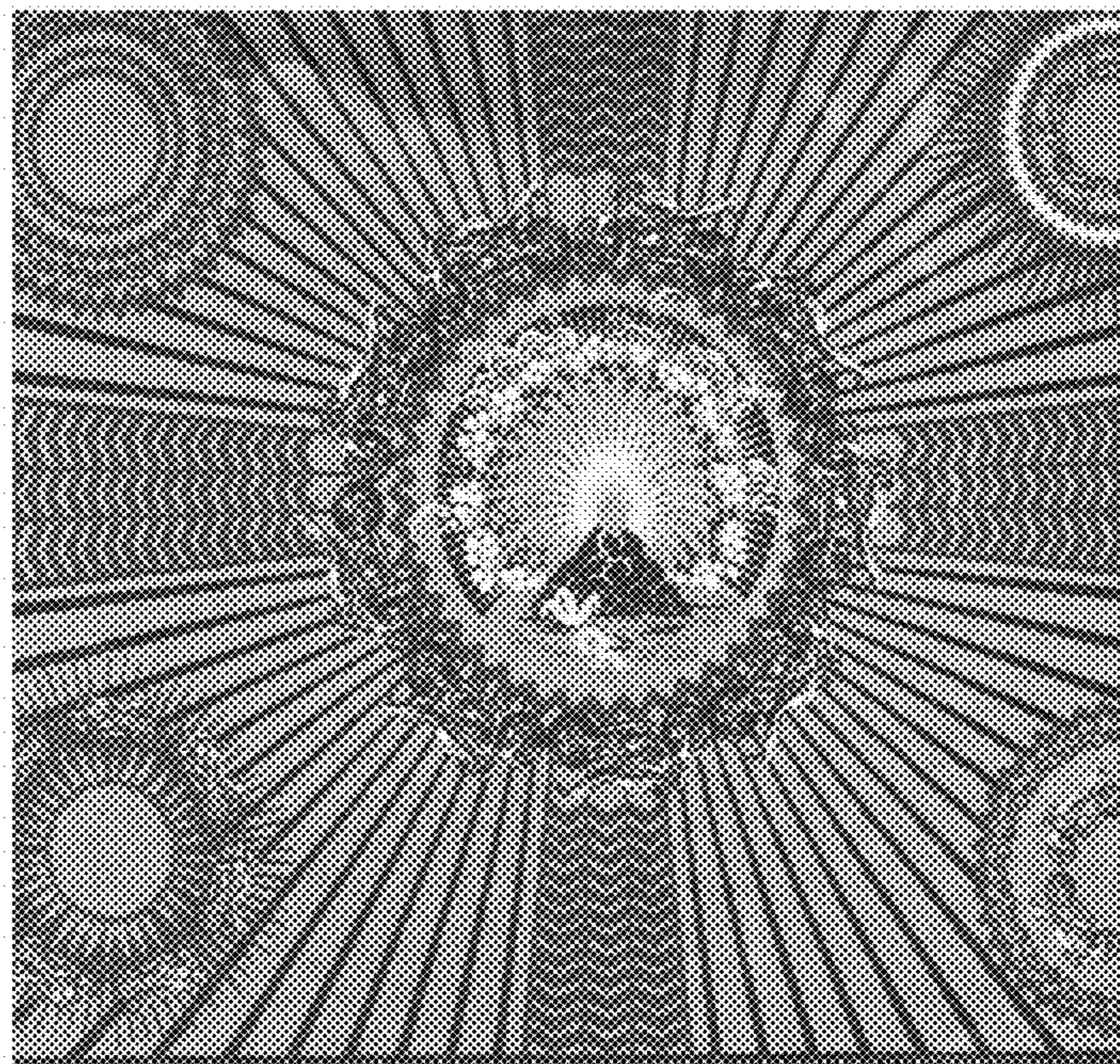
In FIG. 1, the shading gradations represent color contrast. The colors shown in FIG. 2 are preferred colors which form an integral part of the second embodiment of the design.

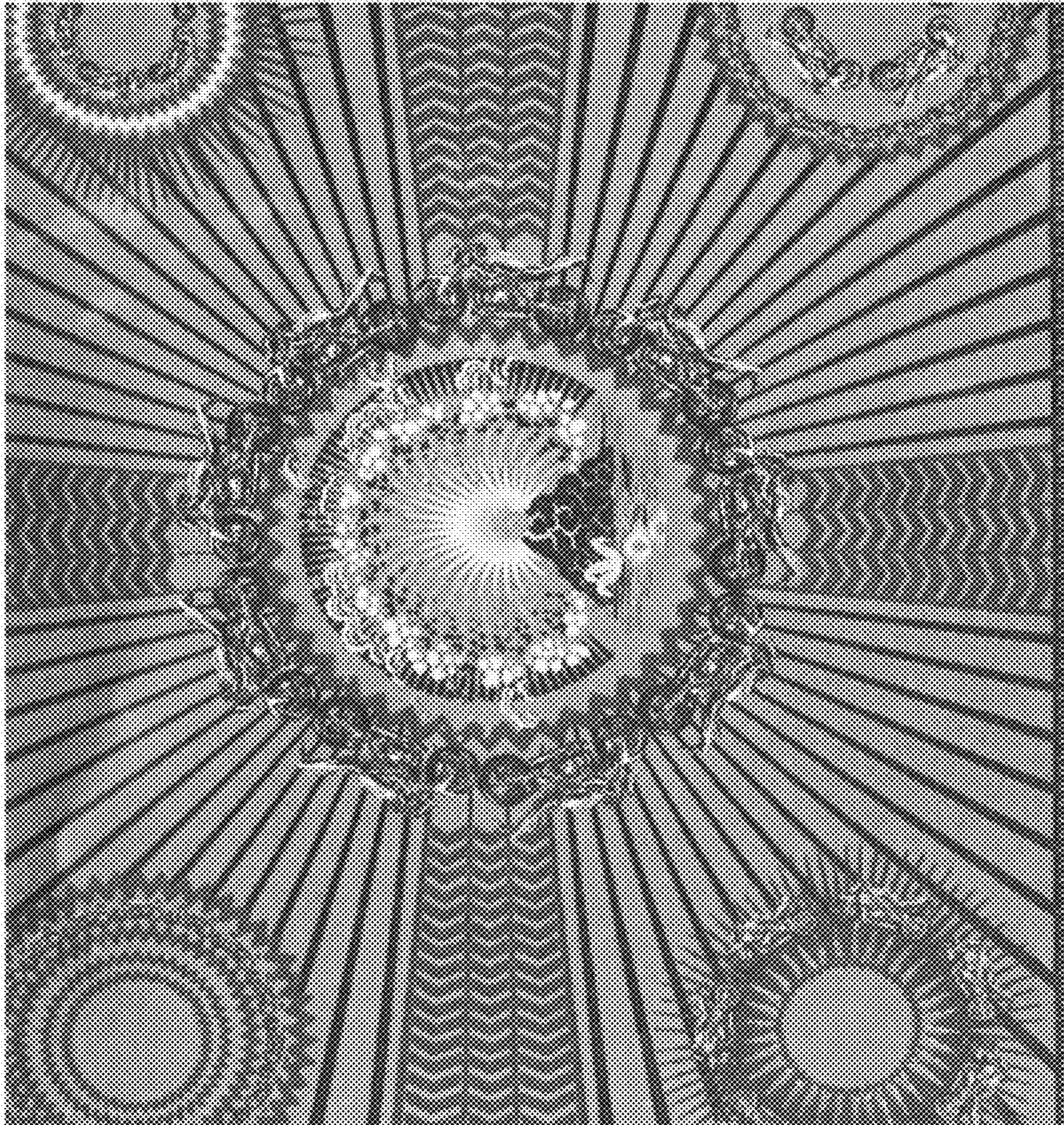

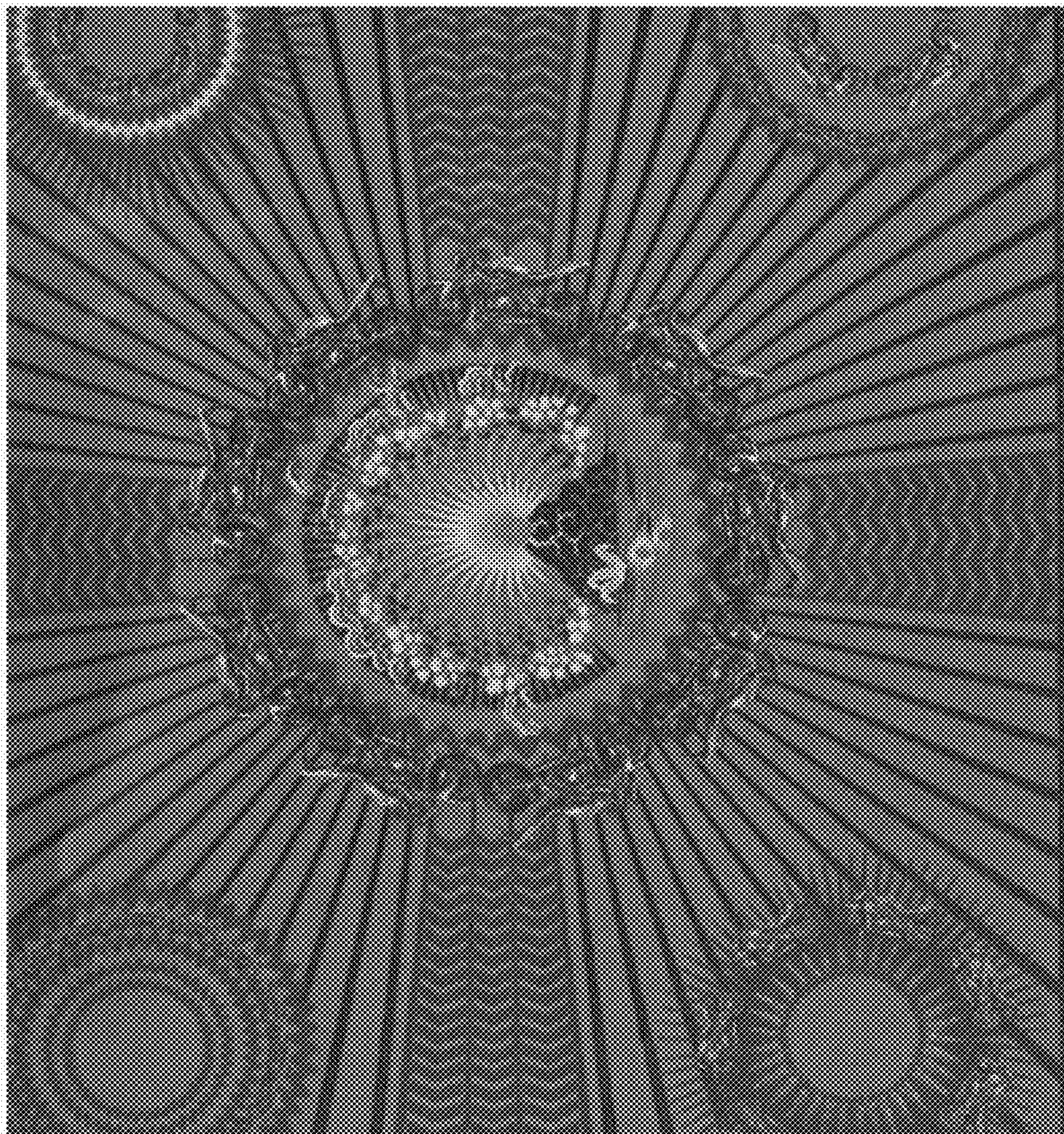

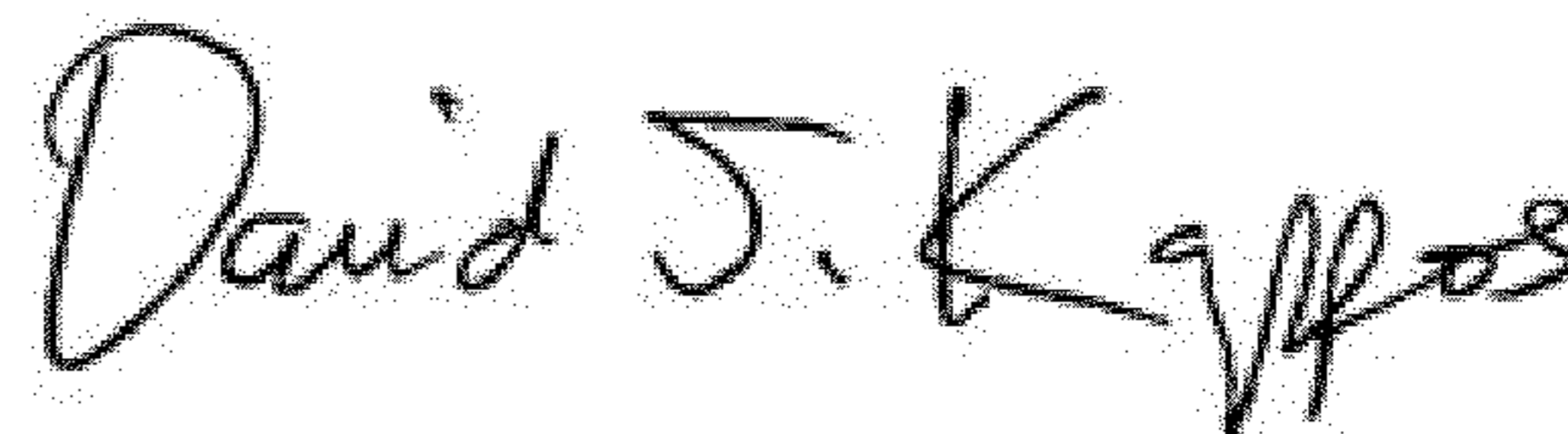
