The ornamental design for a component for modular office furniture, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the component for modular office furniture of the present invention; FIG. 2 is a right side view of the embodiment of FIG. 1; FIG. 3 is a left side view of the embodiment of FIG. 1; FIG. 4 is a top side view of the embodiment of FIG. 1; FIG. 5 is a bottom side view of the embodiment of FIG. 1; FIG. 6 is a front side view of the embodiment of FIG. 1; and, FIG. 7 is a back side view of the embodiment of FIG. 1. The broken lines in the drawings represent environmental structure only and form no part of the claimed design.

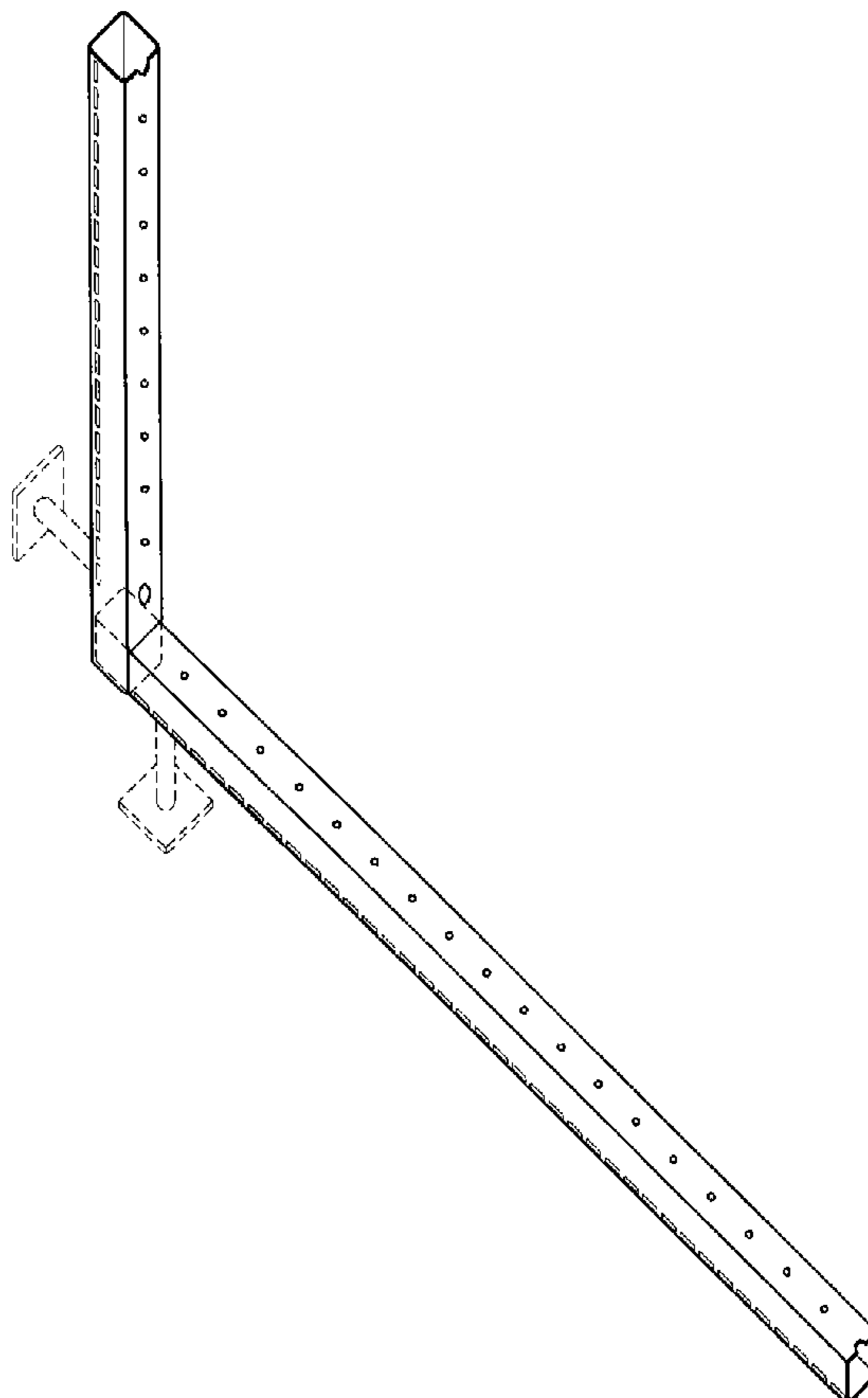

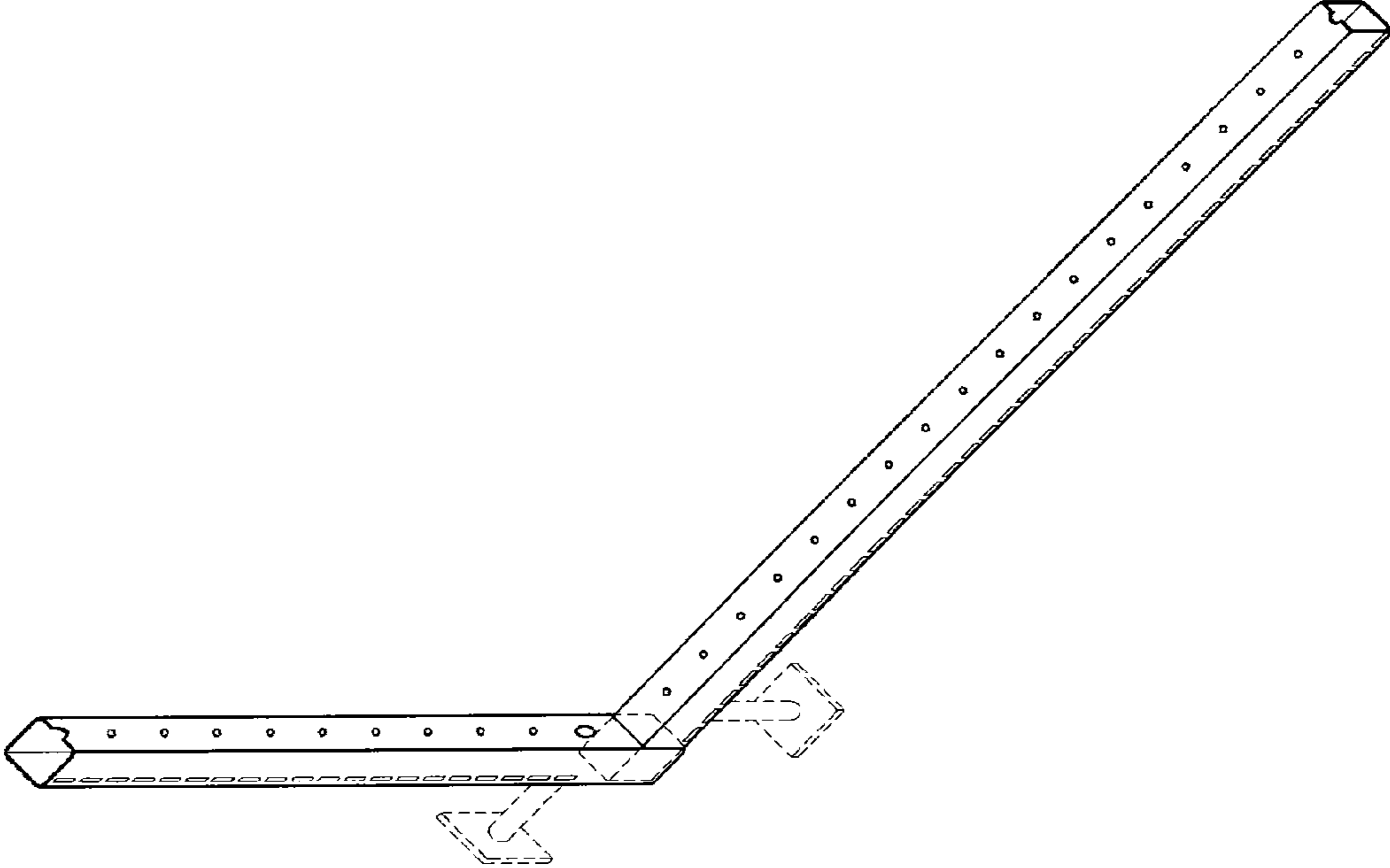
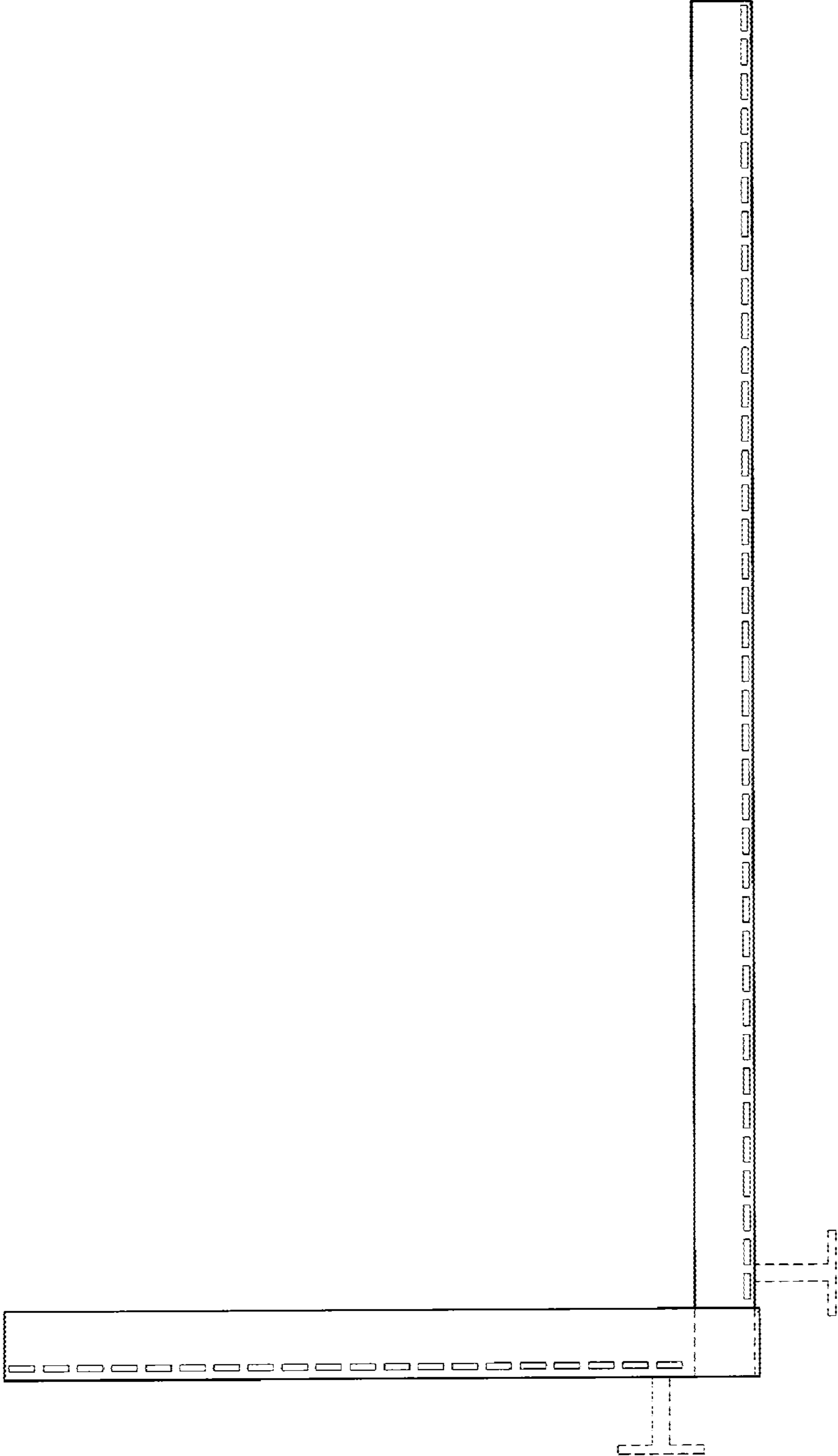

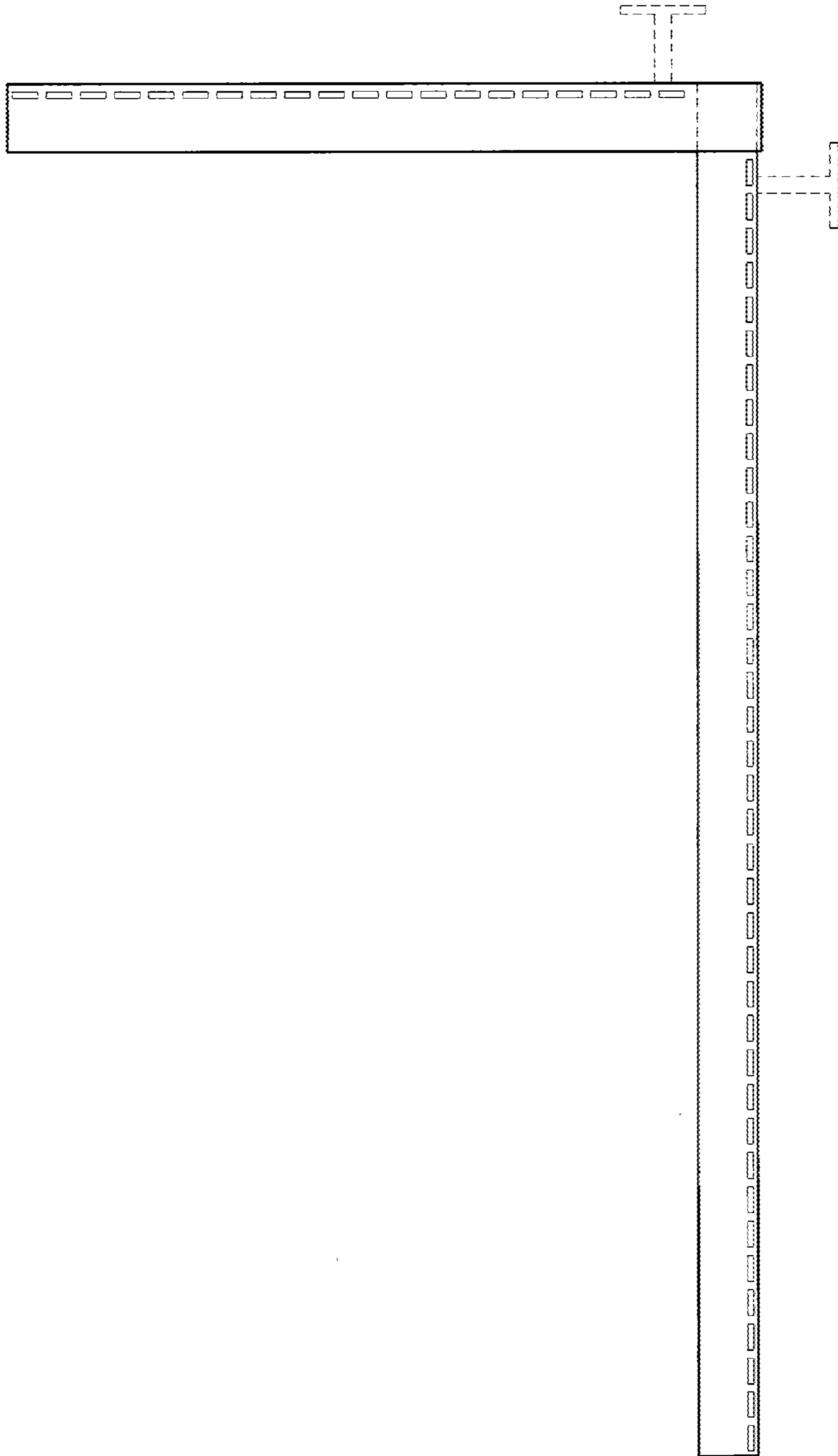

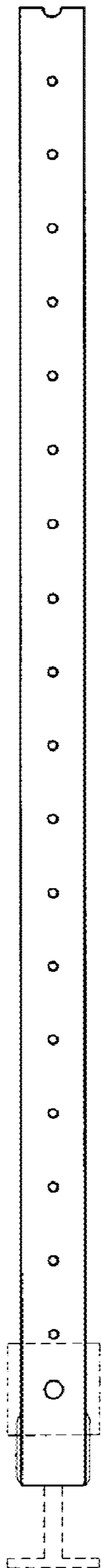
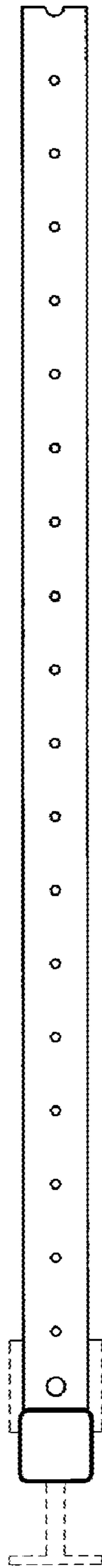

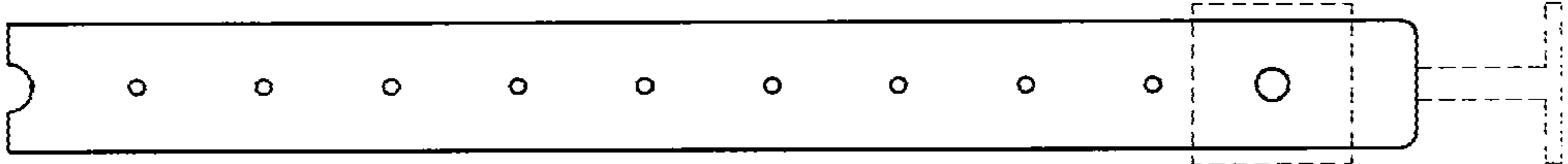

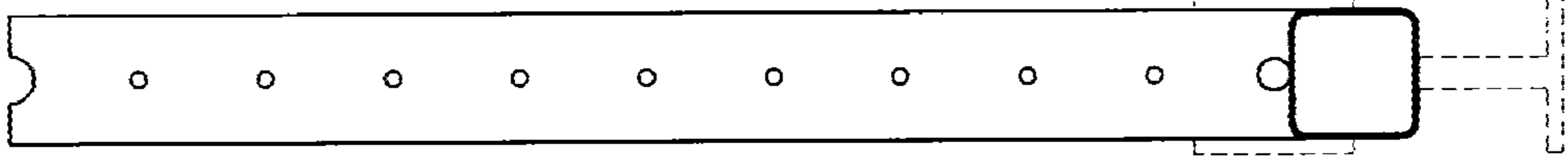
