DESCRIPTION

FIG. 1 is a front perspective view of a dispensing device of the present invention;
FIG. 2 is a front view of the dispensing device of FIG. 1;

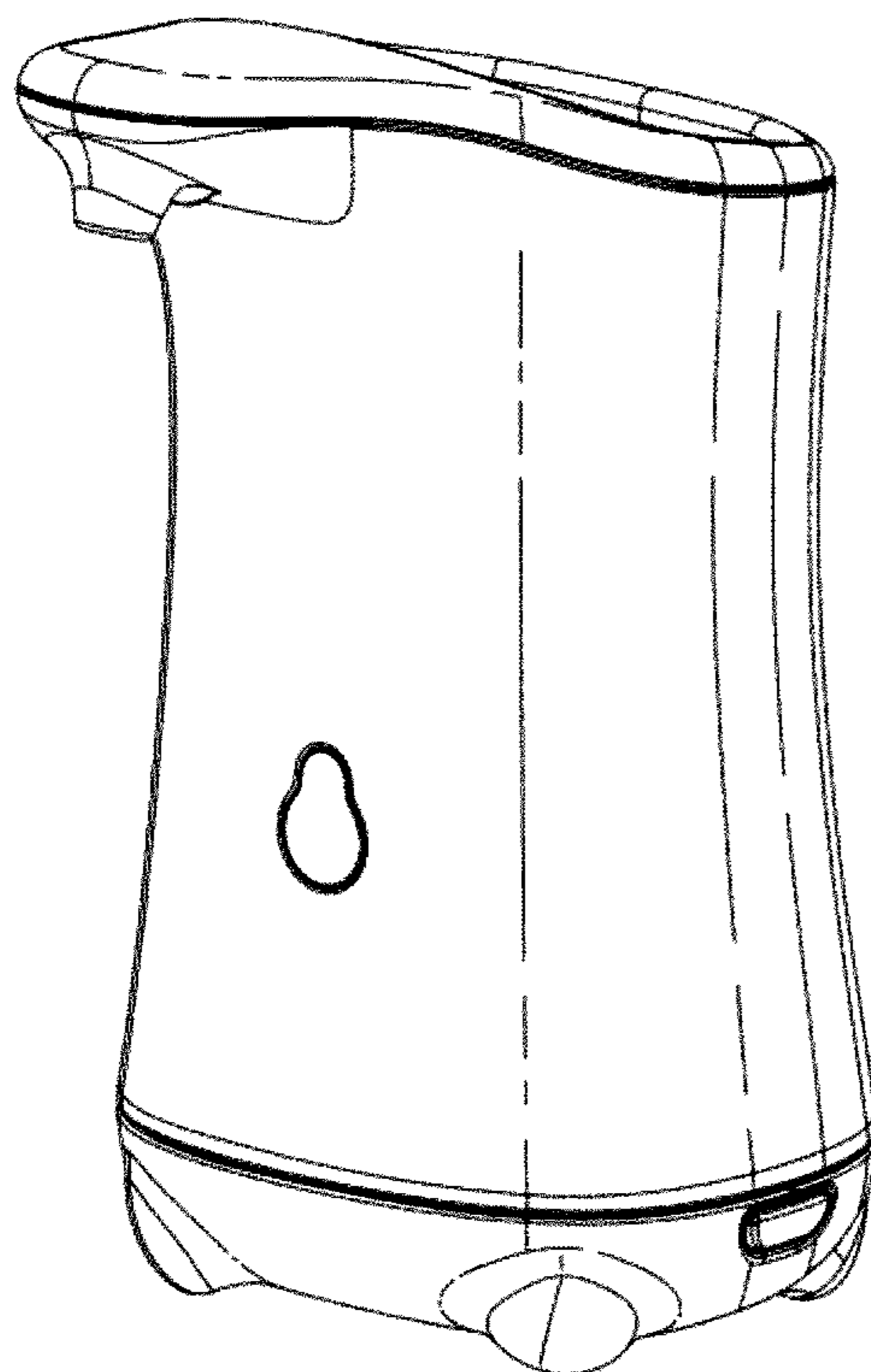

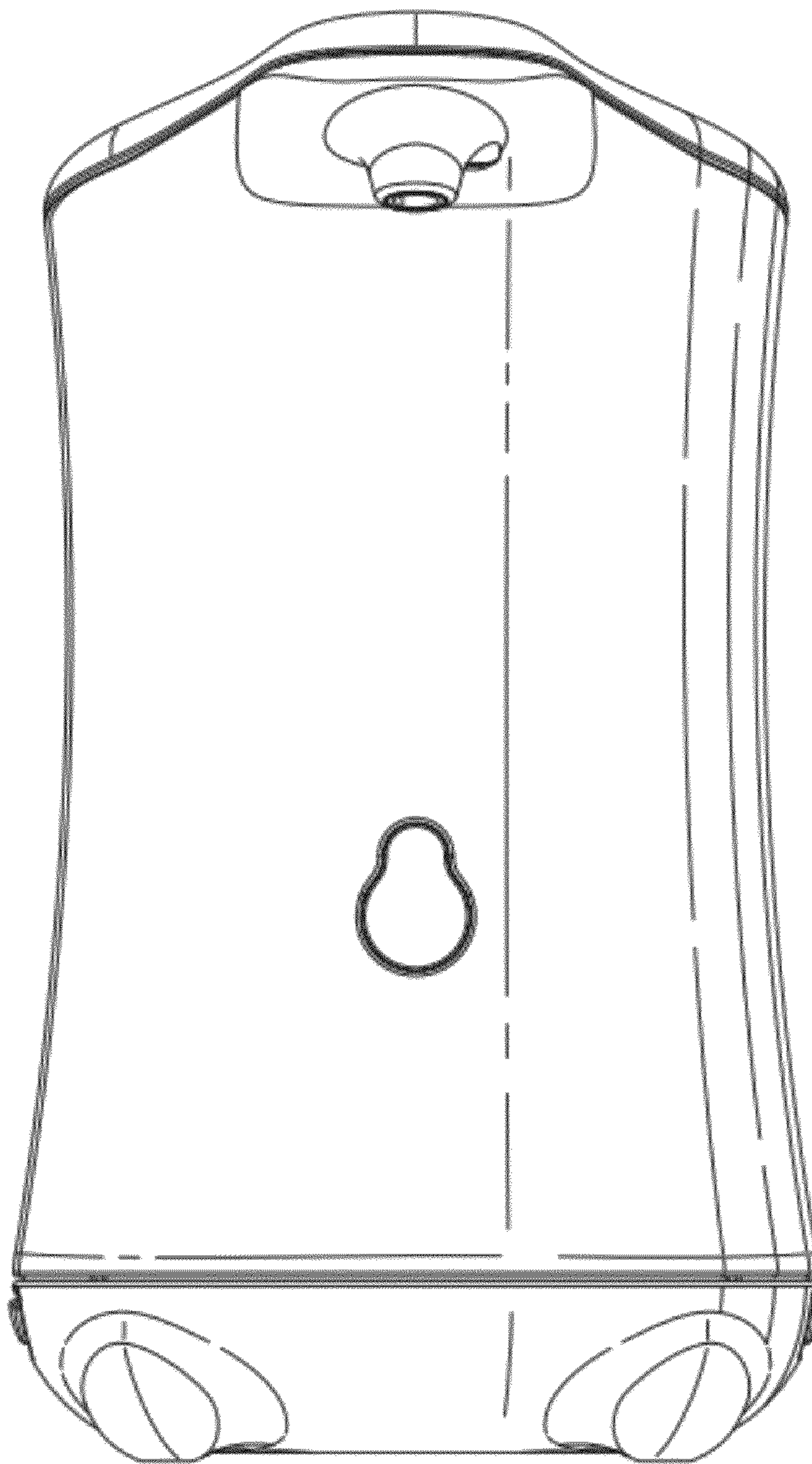

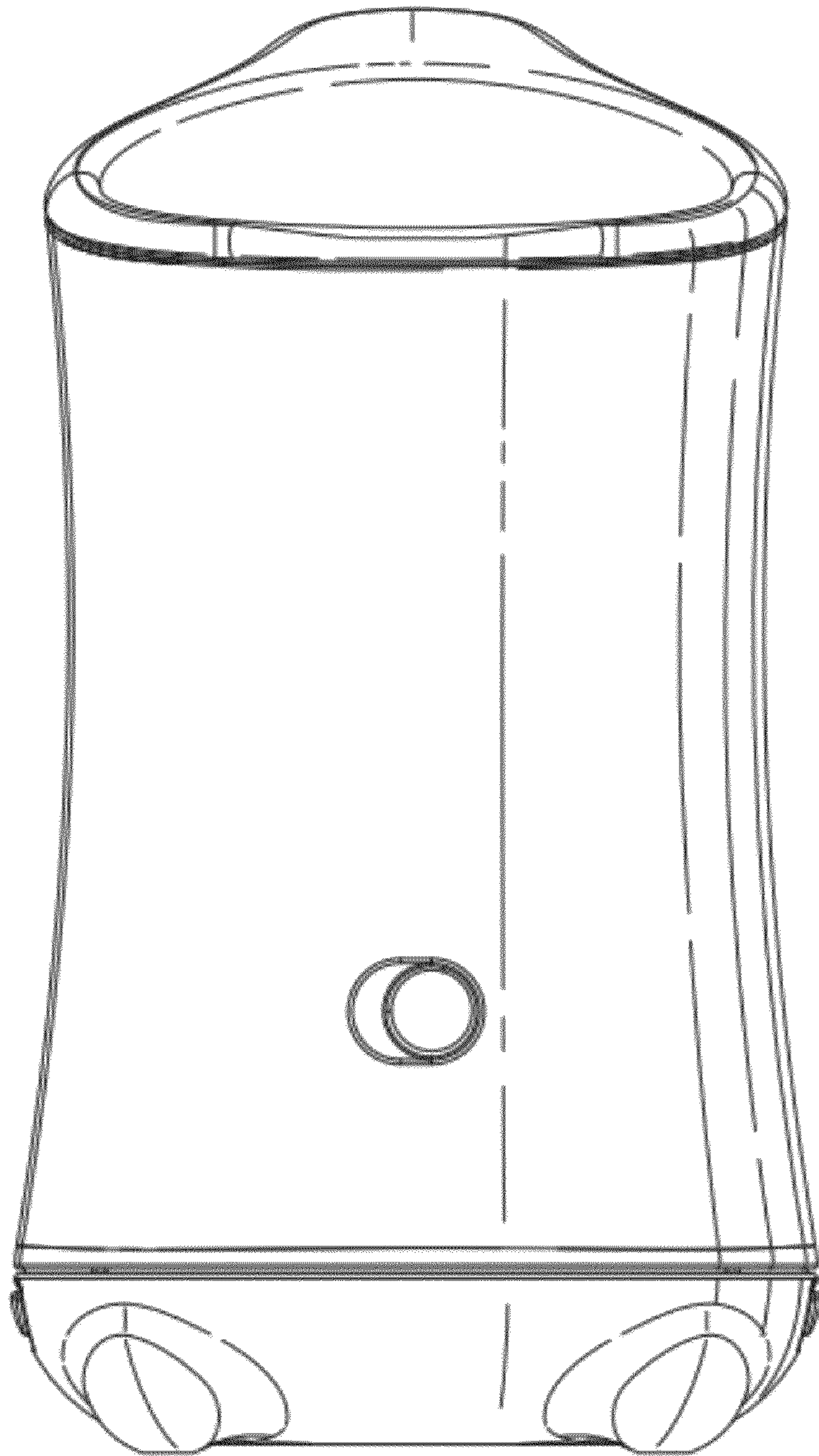

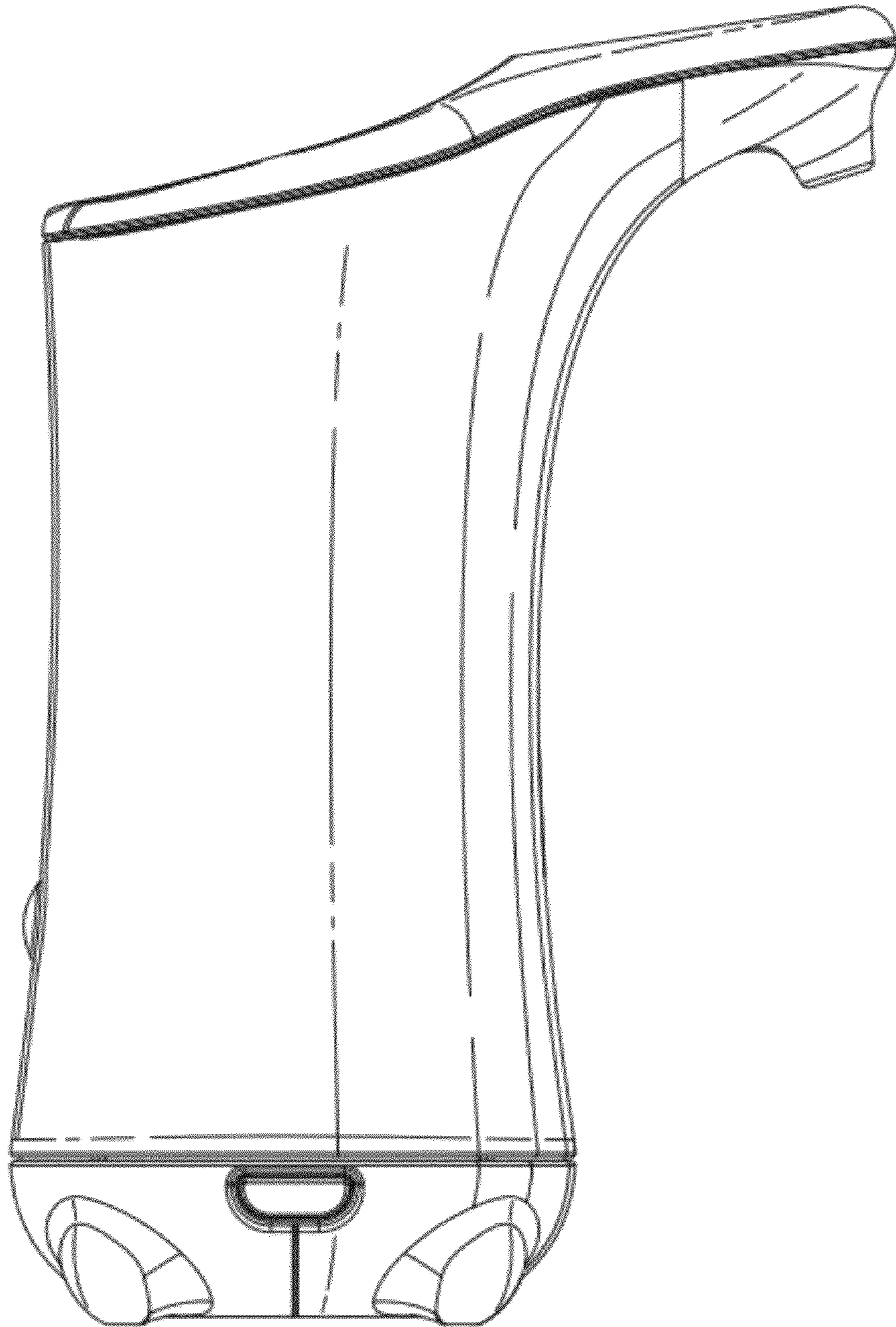

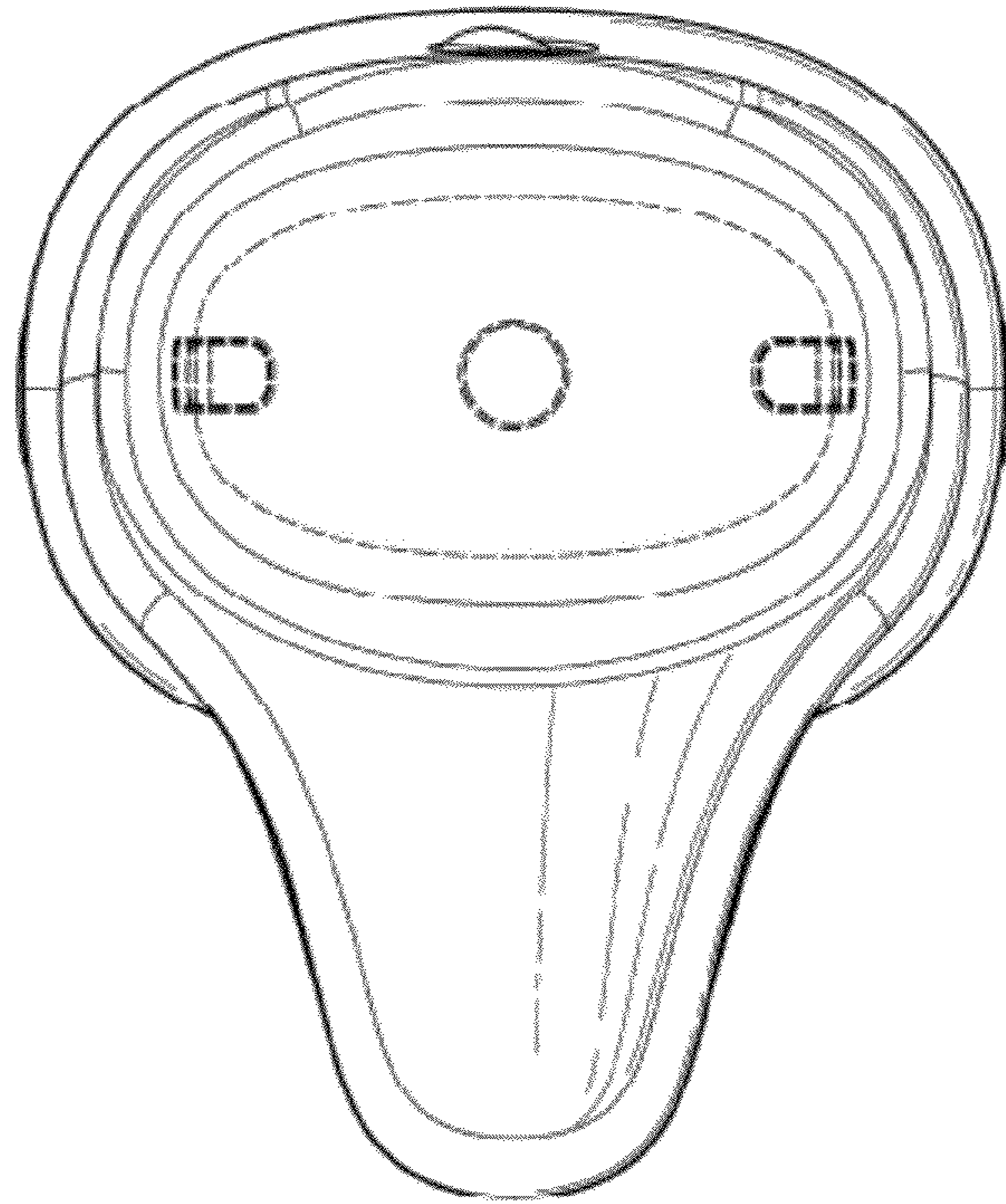

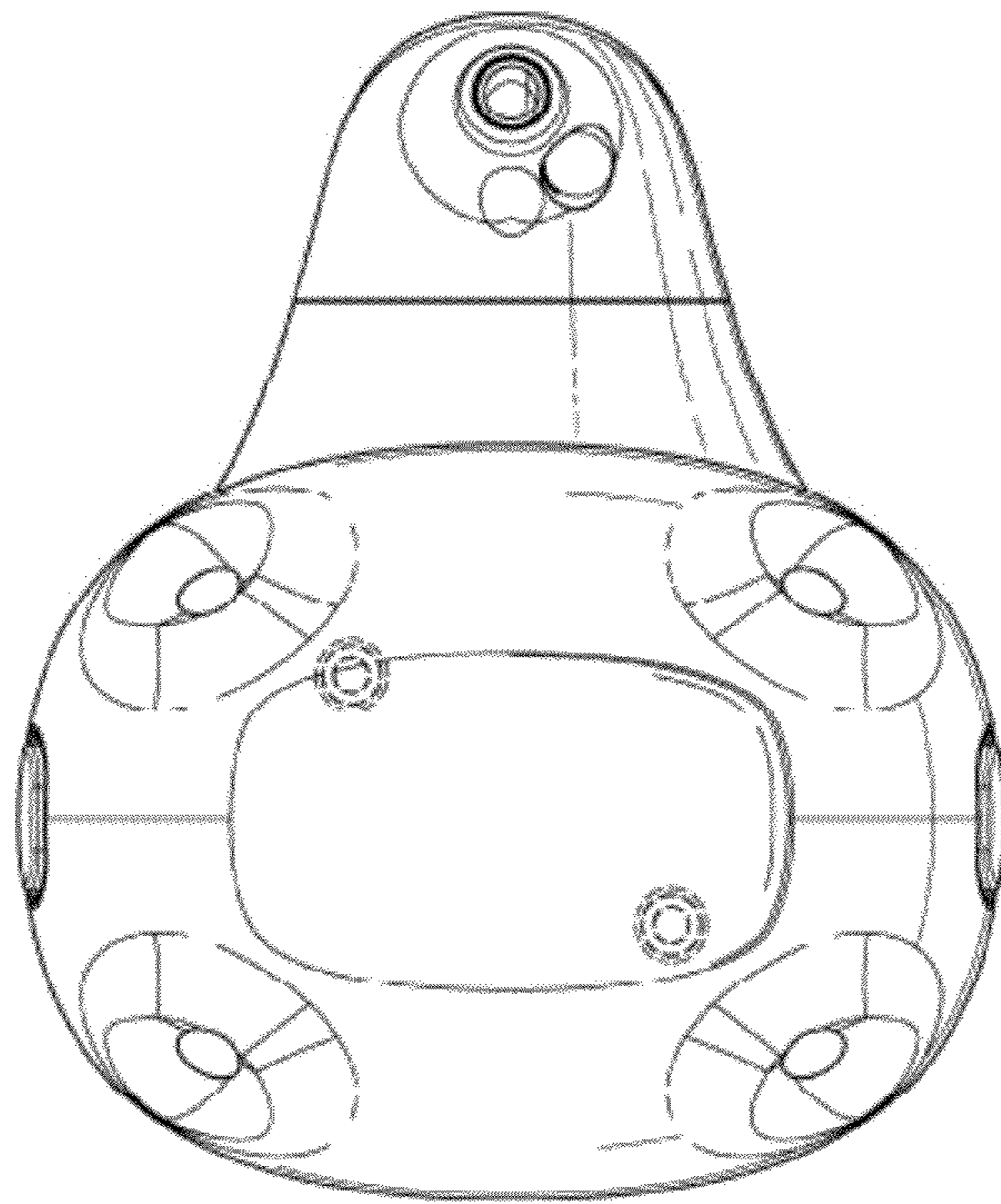
