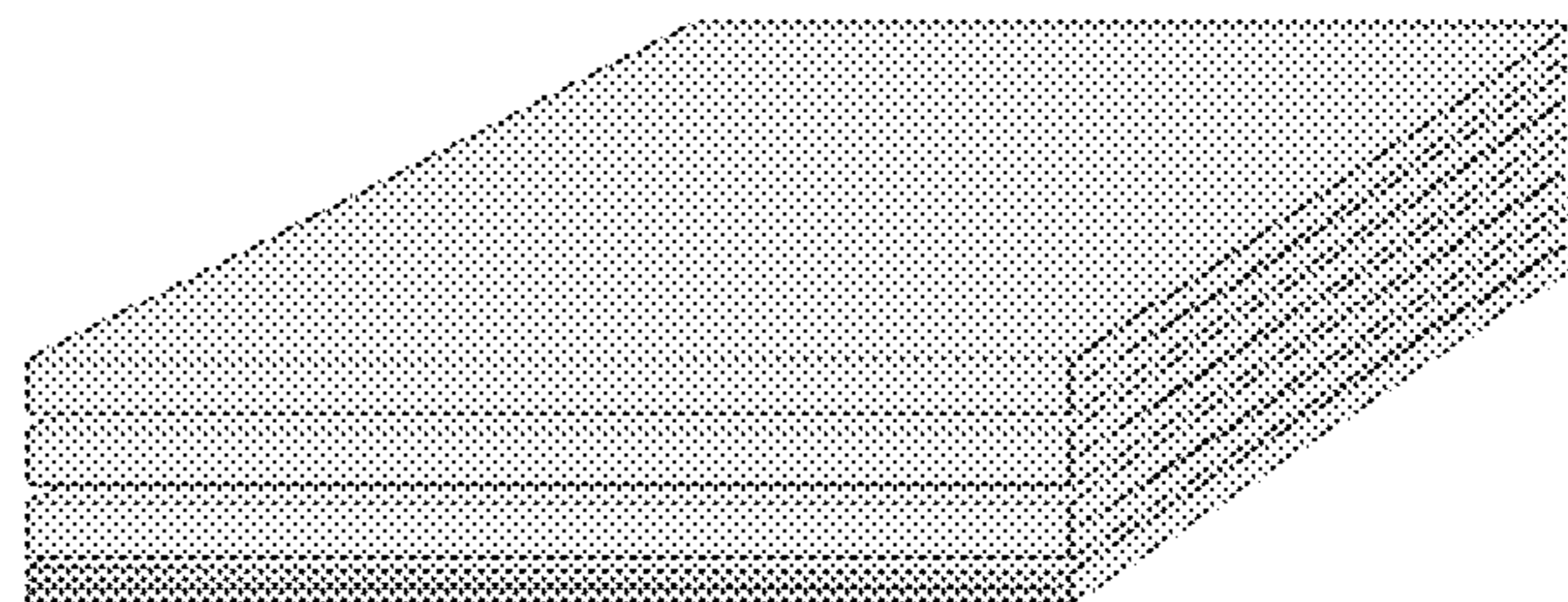
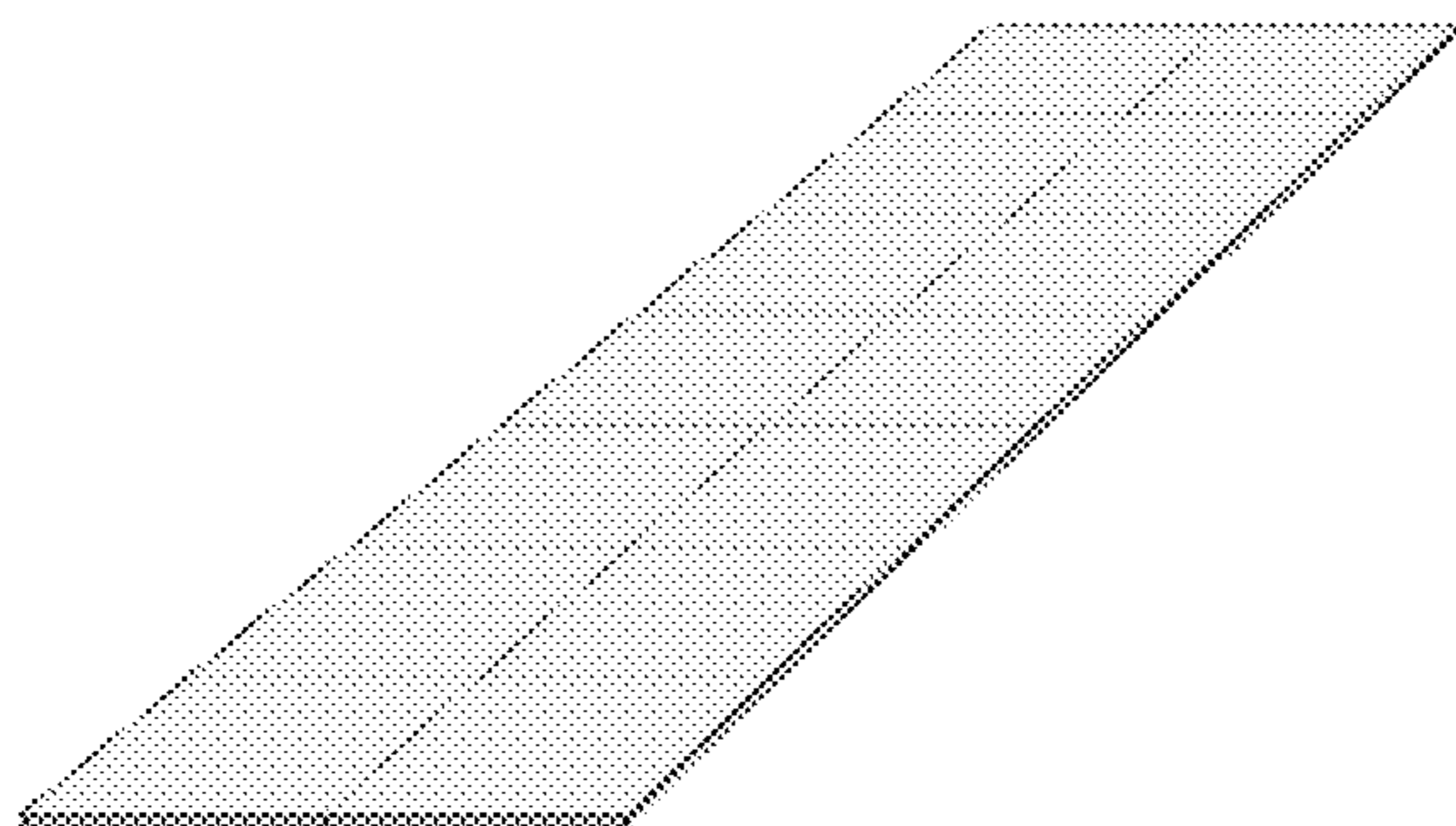
(57) **CLAIM**

The ornamental design for a portable, foldable yoga mat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front, top, and side of a portable, foldable yoga mat, showing my new design;
 FIG. 2 is an elevational view of the top side of the design of FIG. 1, shown in a flat configuration, the bottom elevational view being a minor image thereof;
 FIG. 3 is an elevational view of the left-side of the design of FIG. 1, shown in a flat configuration, the right-side elevational view being a minor image thereof;
 FIG. 4 is an elevational view of the front side of the design of FIG. 1, shown in a flat configuration, the rear elevational view being a mirror image thereof;
 FIG. 5 is a perspective view of the design of FIG. 1, shown in a folded configuration; and,
 FIG. 6 is a perspective view of the design of FIG. 1 shown in a position of use. The broken lines in the drawing form no part of the claim.

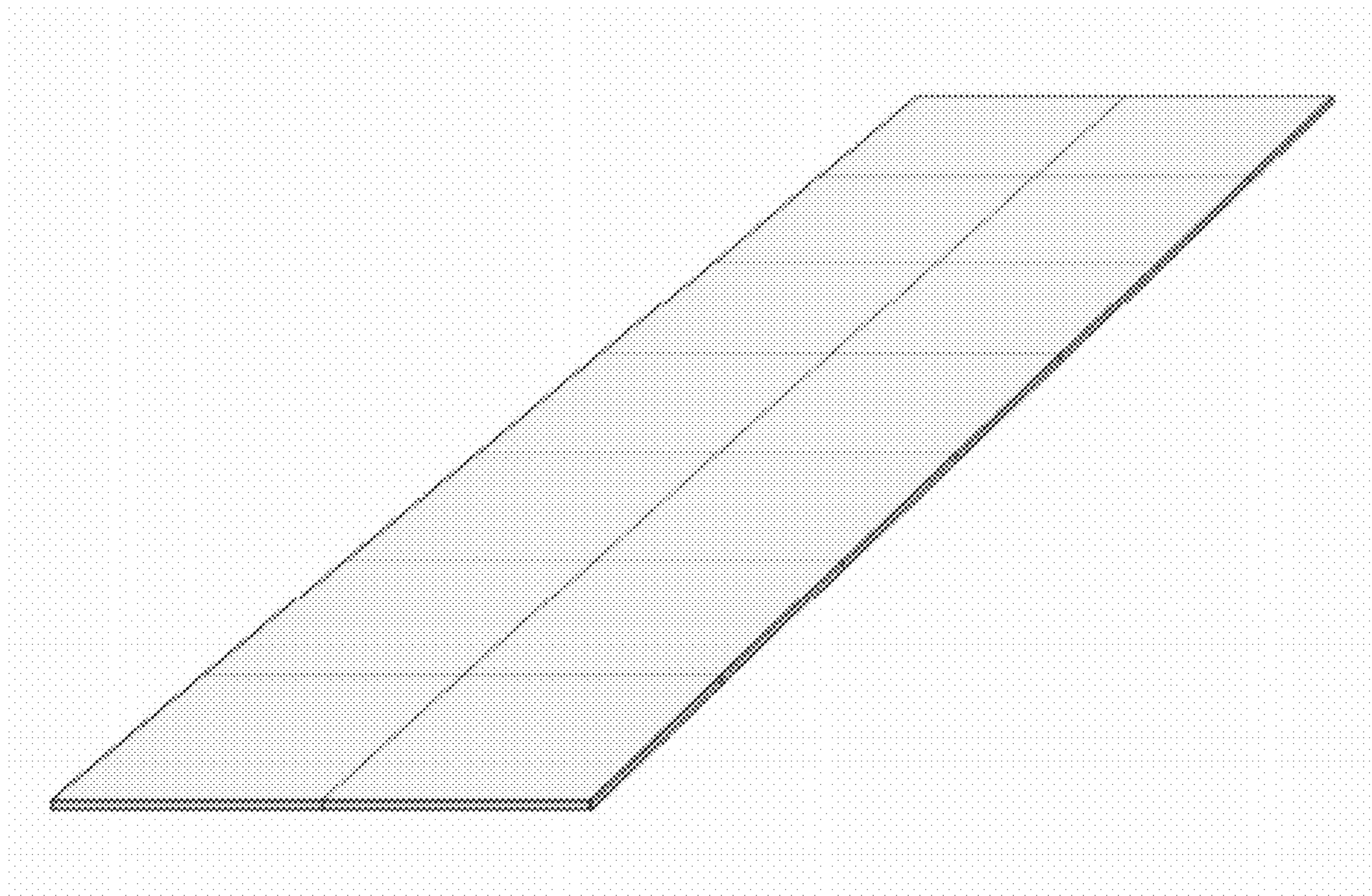

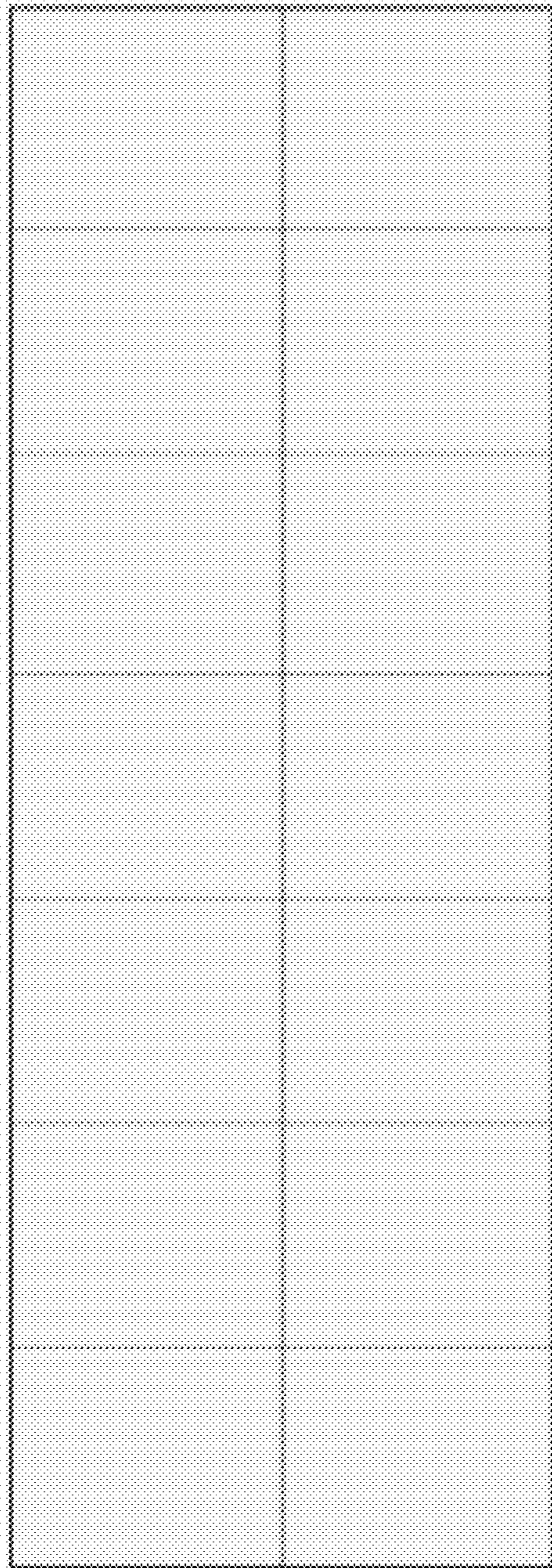

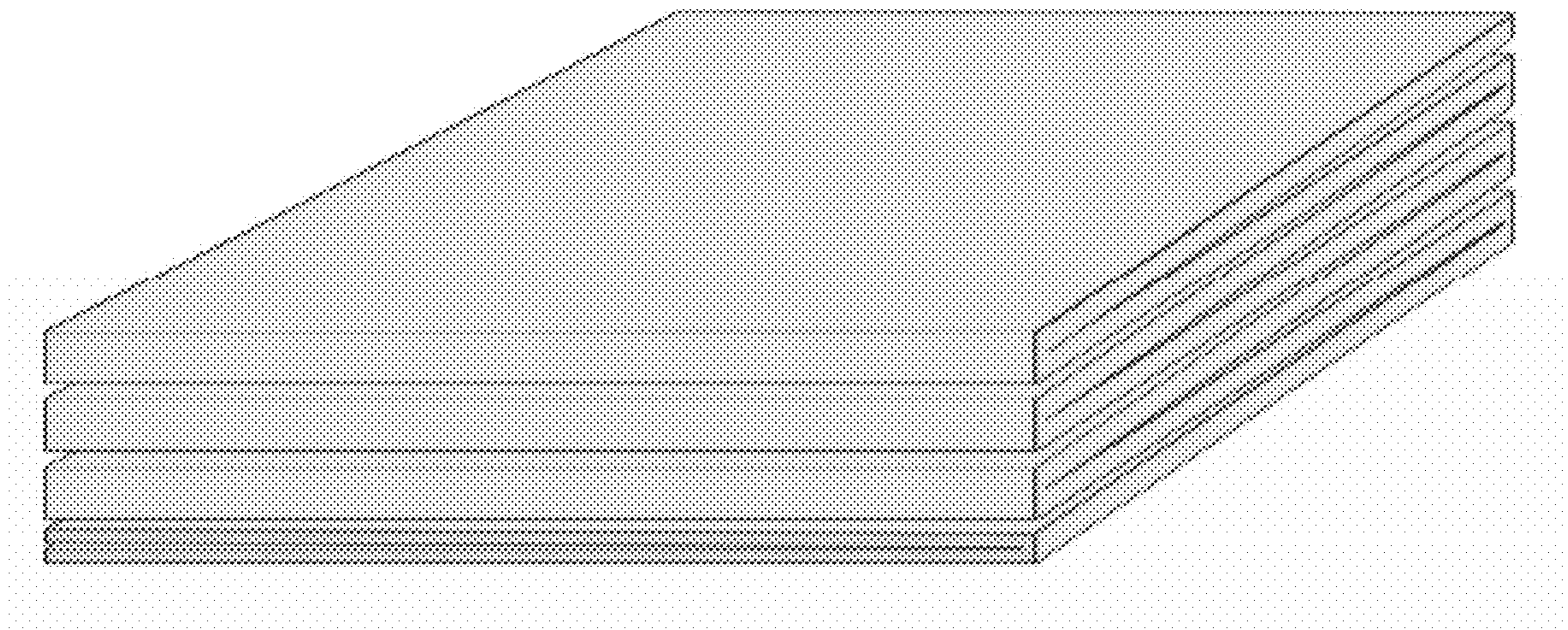

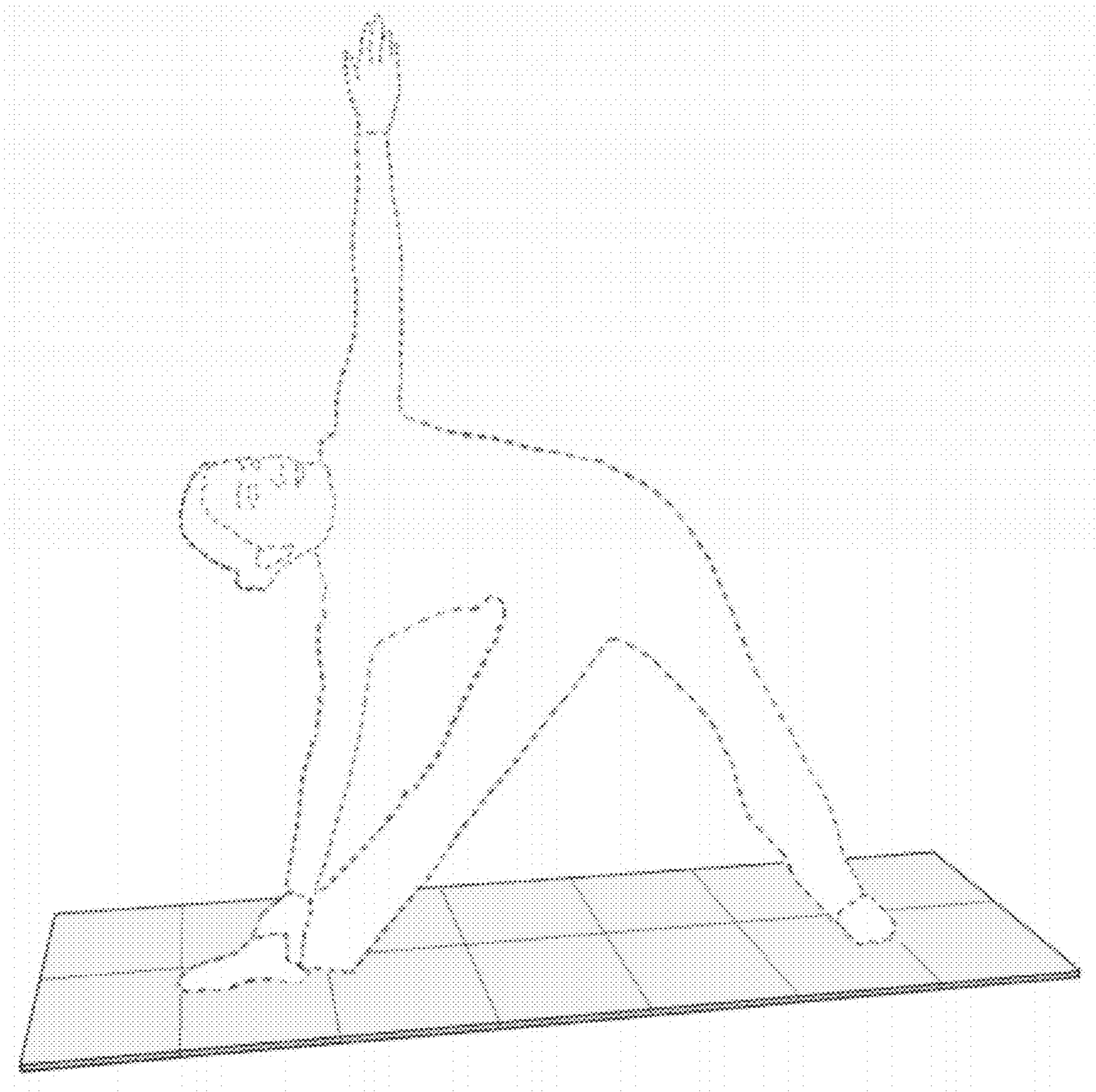
