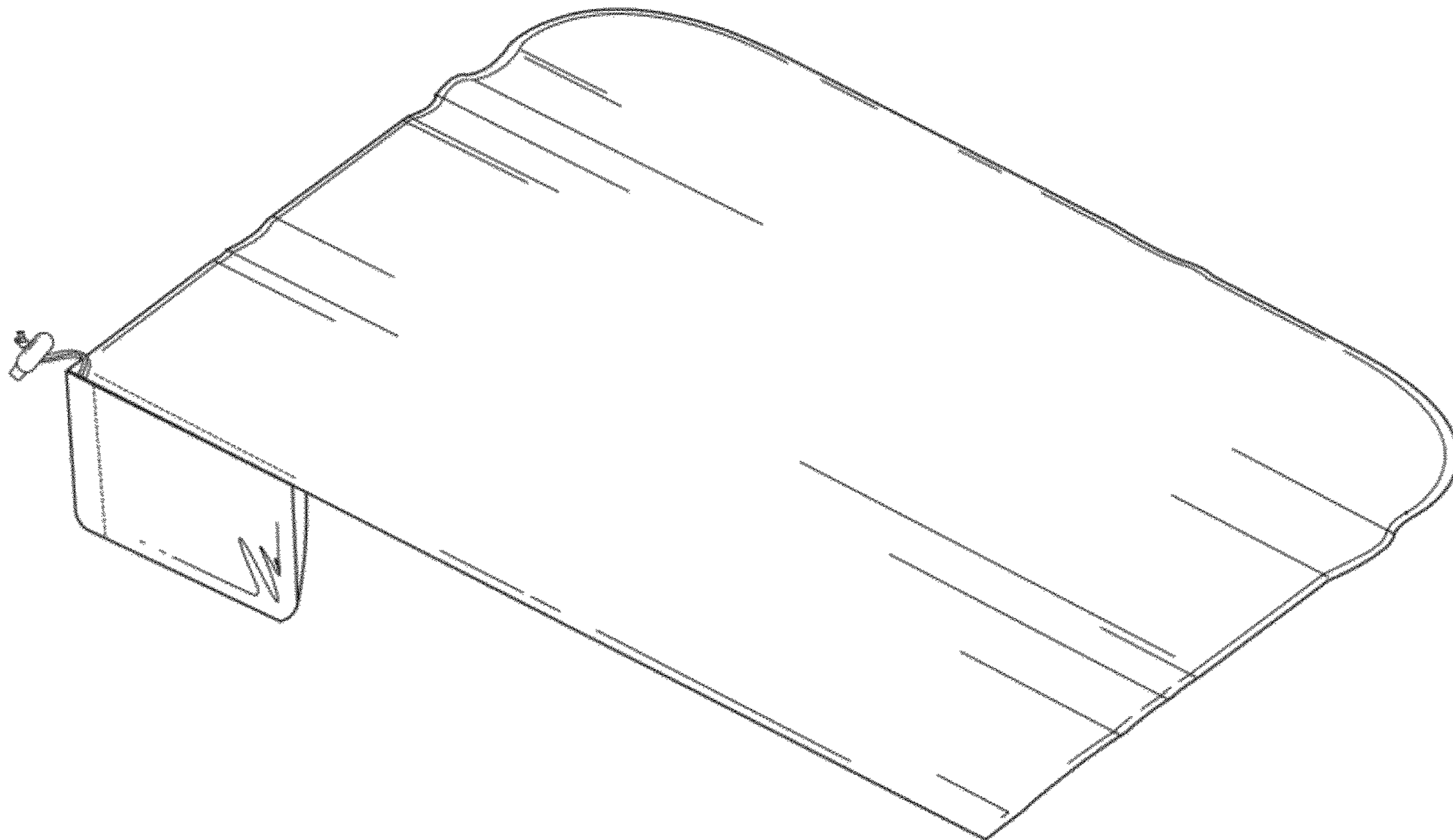

I claim the ornamental design for a portable seat cover, as shown and described.

DESCRIPTION

FIG. 1 is front view thereof;
FIG. 2 is back view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a 3/4 perspective view of the portable seat cover from the front, bottom, and left side showing my new design.
The broken lines in FIGS. 1, 2 and 7 show portions of a portable seat cover that form no part of the claim.

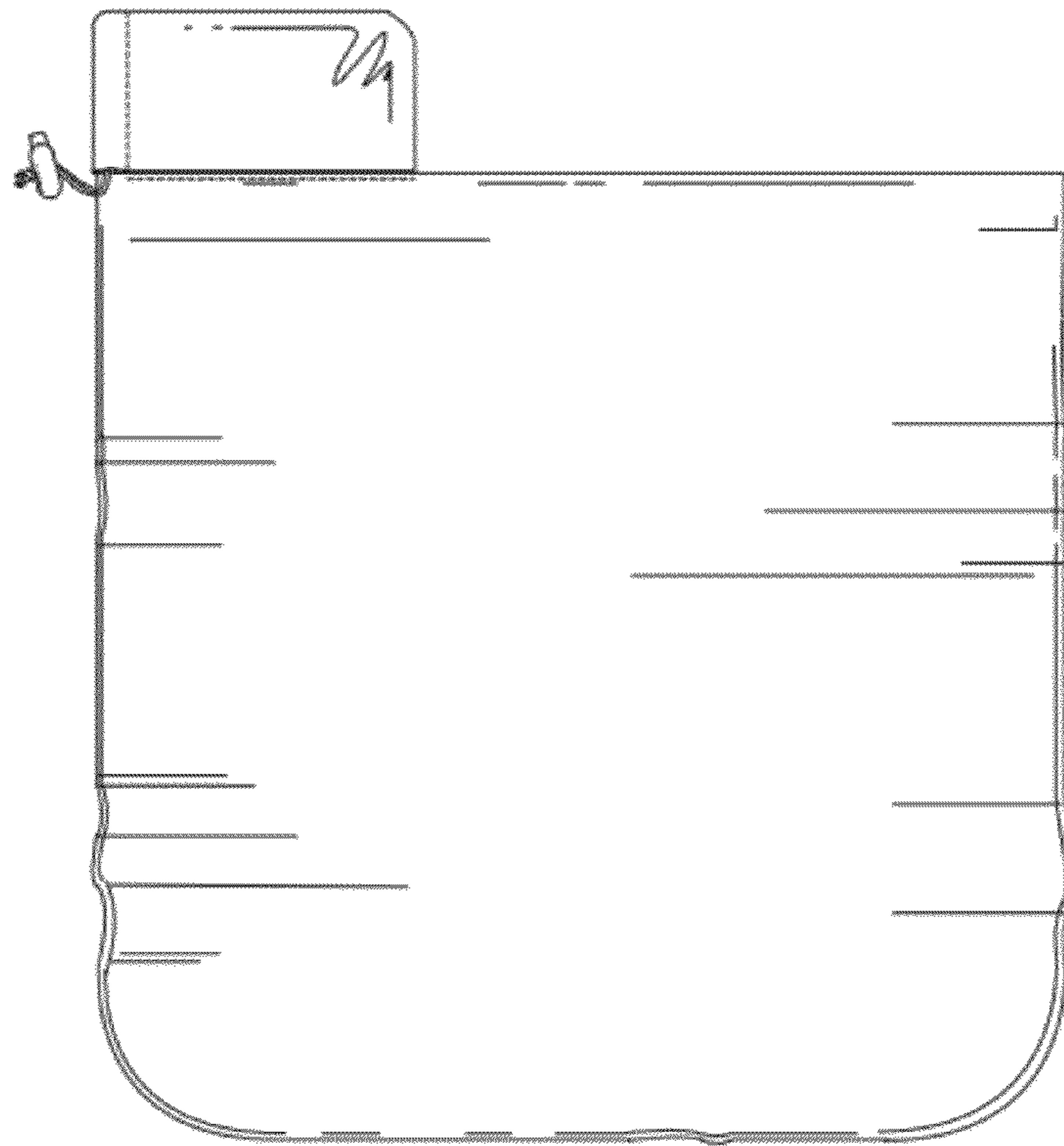

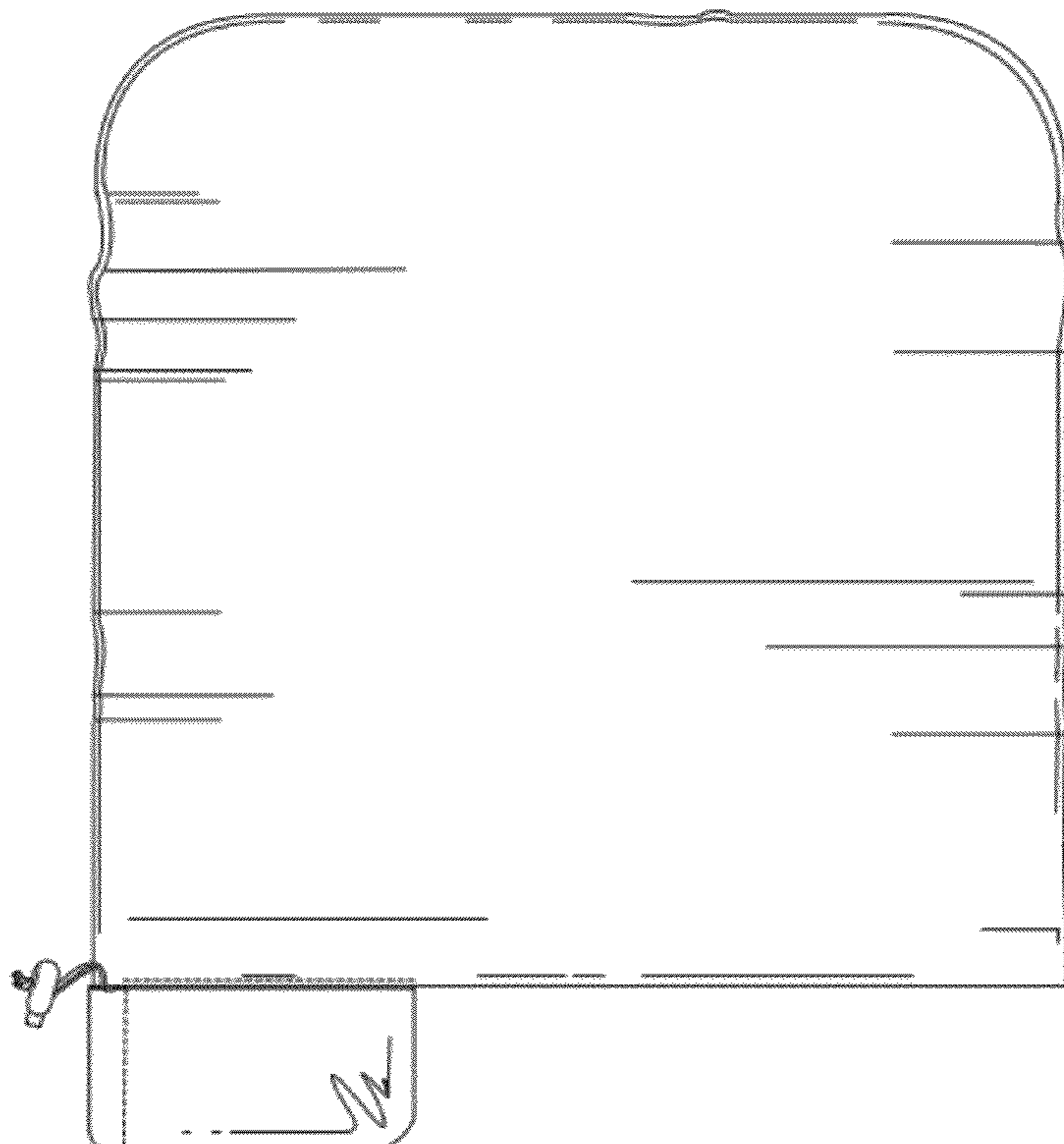

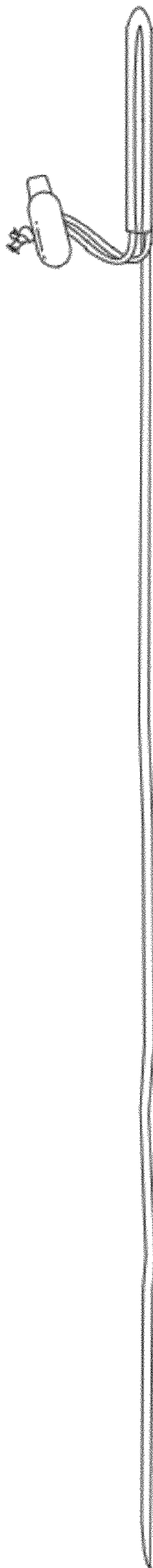

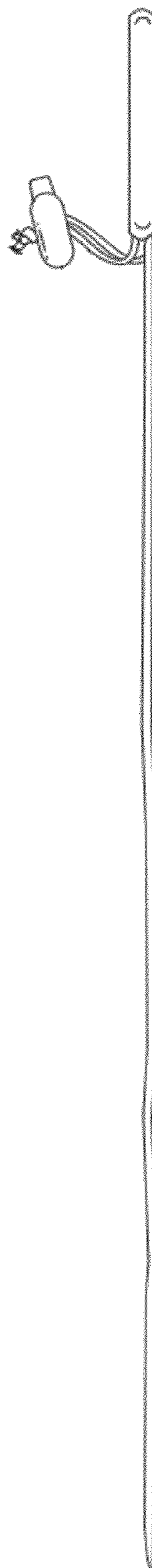

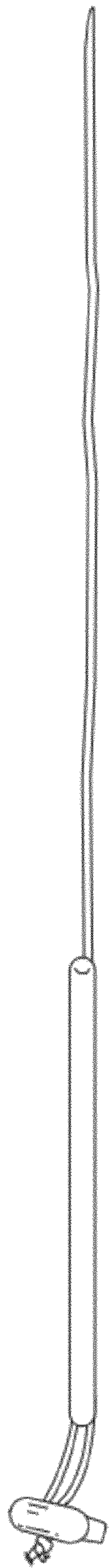

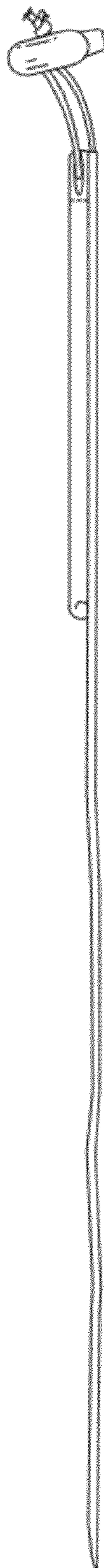

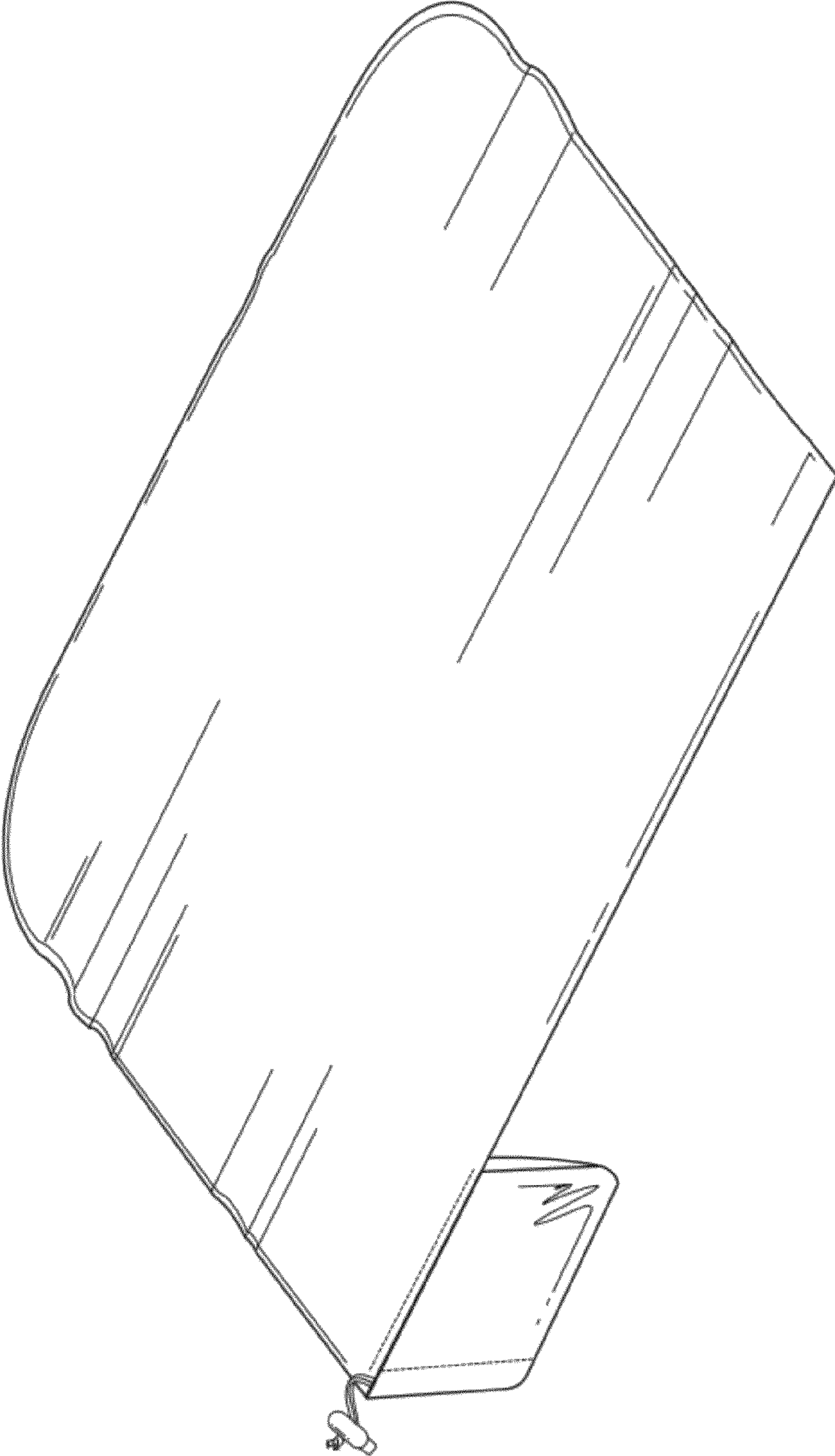
