The ornamental design for a knife handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a knife handle, showing the new design;

FIG. 2 is a front elevational view thereof, wherein the rear elevational view is a mirror image of the front elevational view;

FIG. 3 is an enlarged elevational view thereof;

FIG. 4 is an enlarged right elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

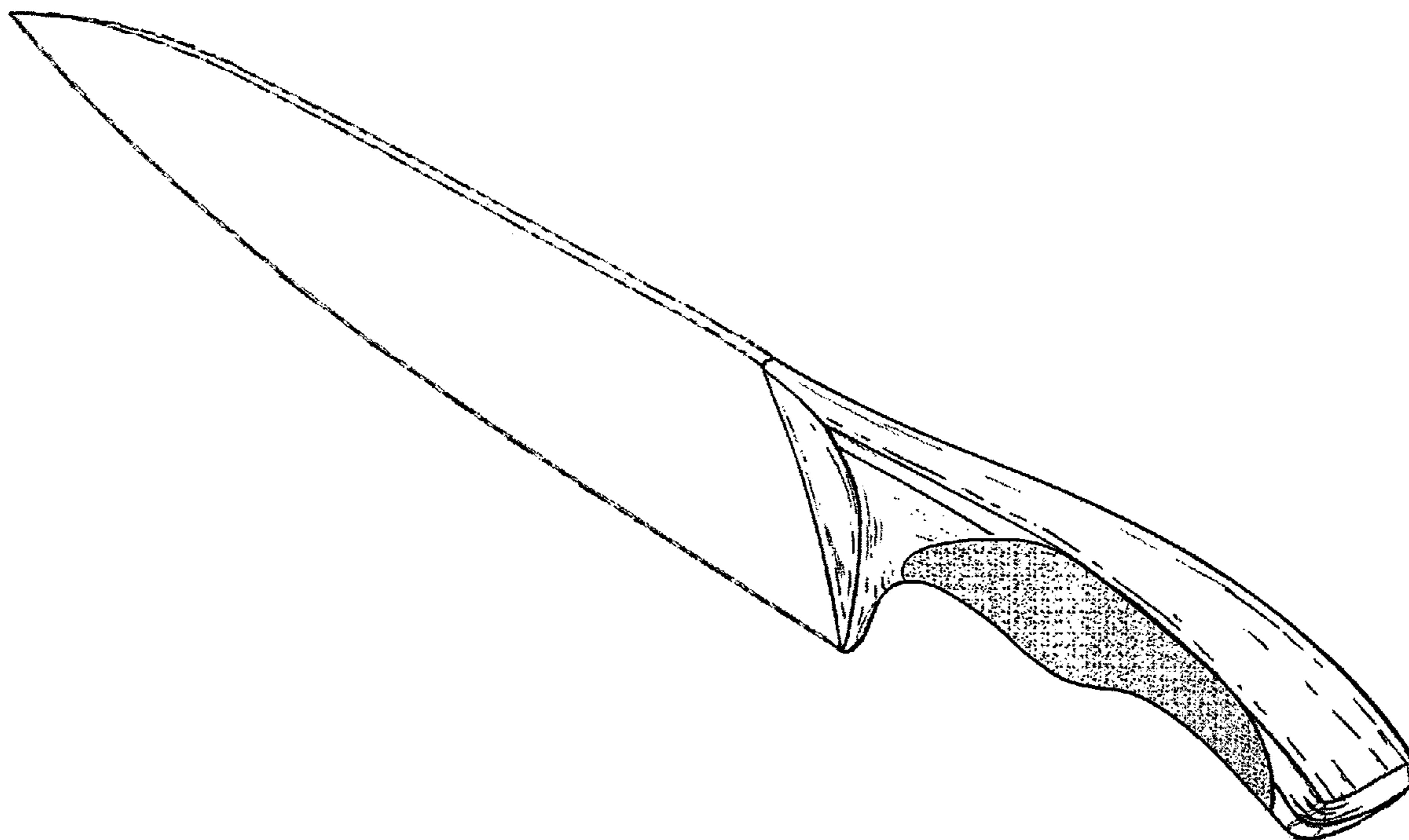
FIG. 7 is an inverted perspective view thereof;

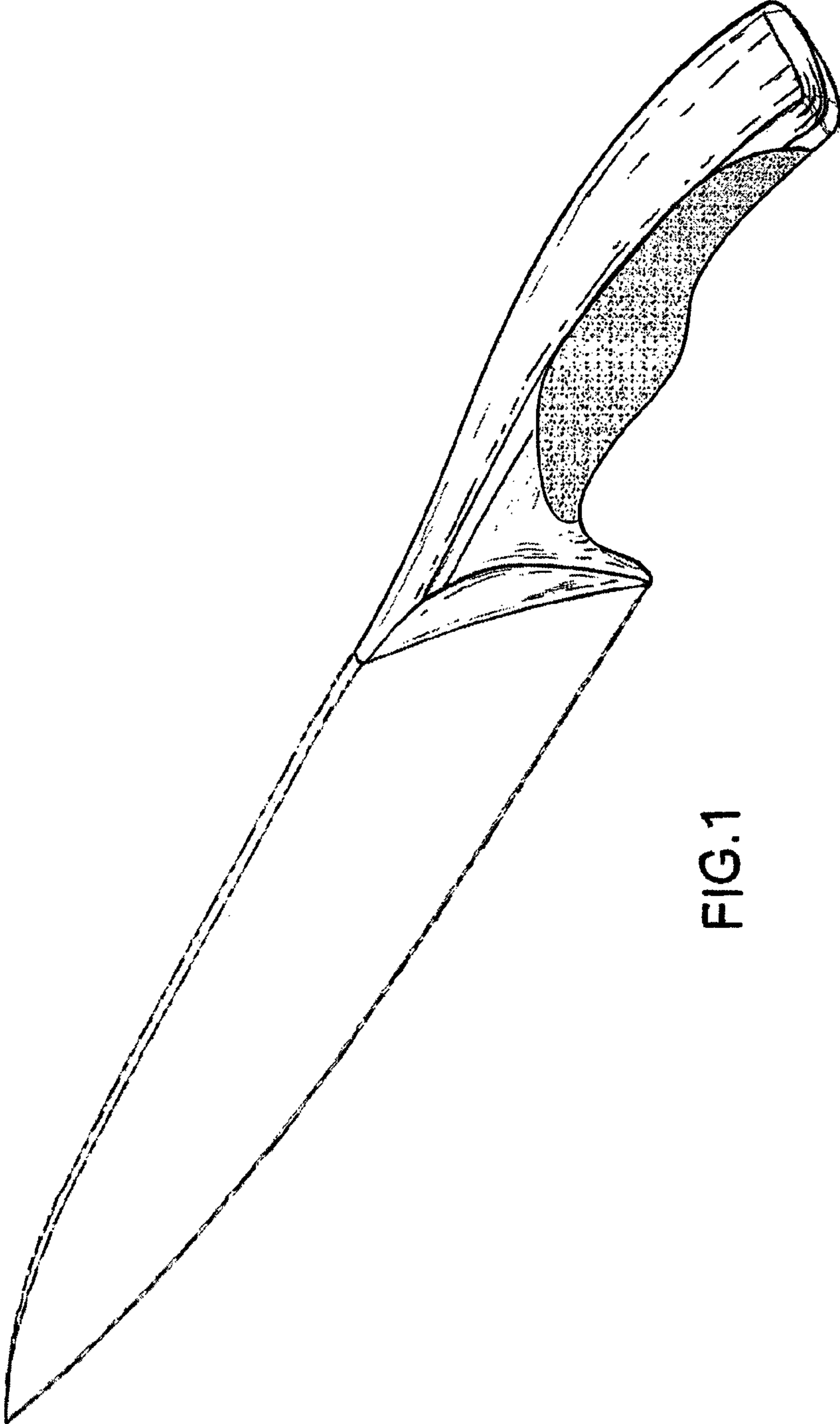

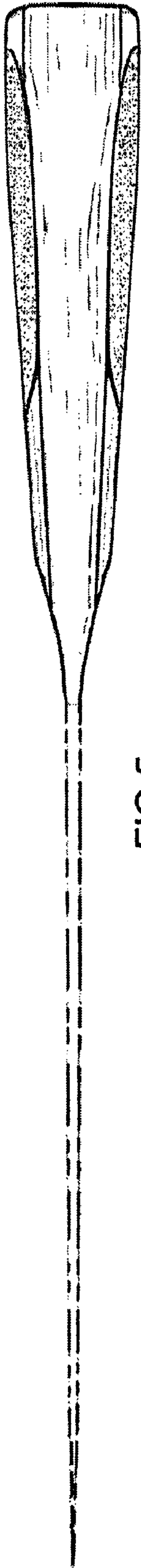

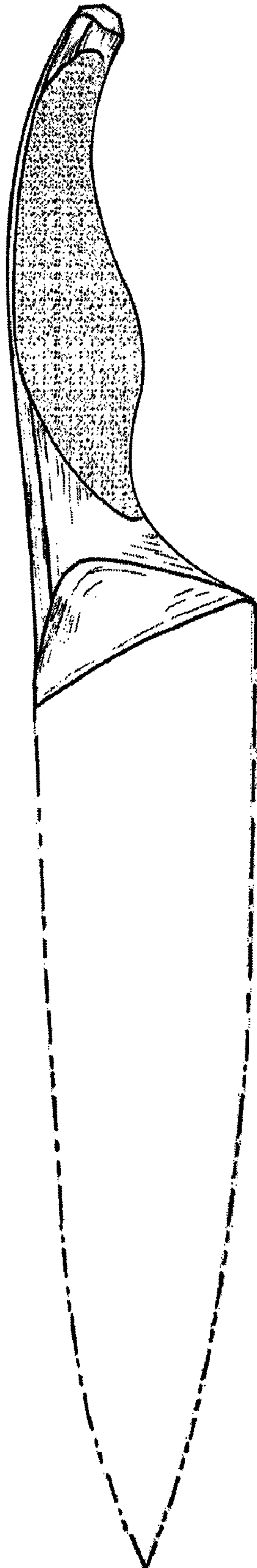

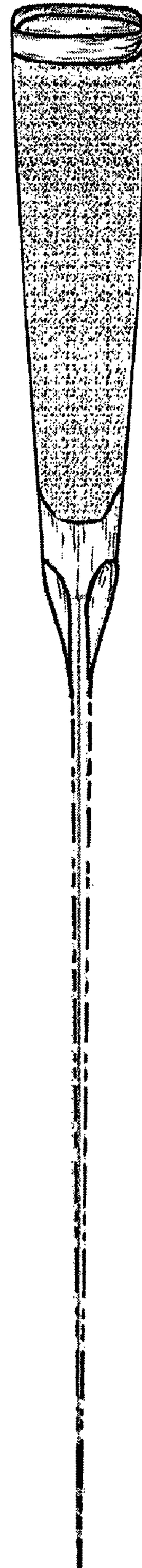

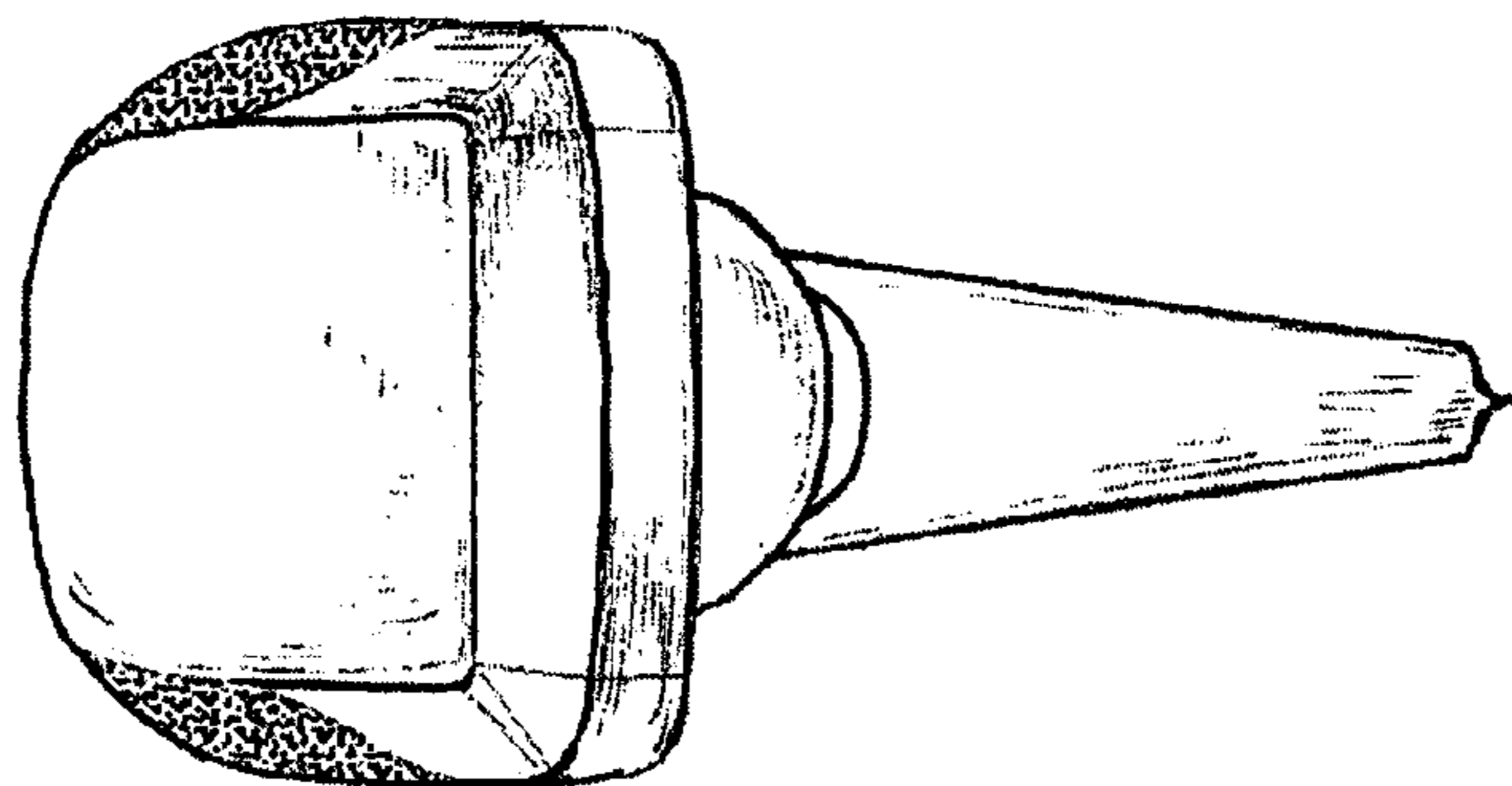

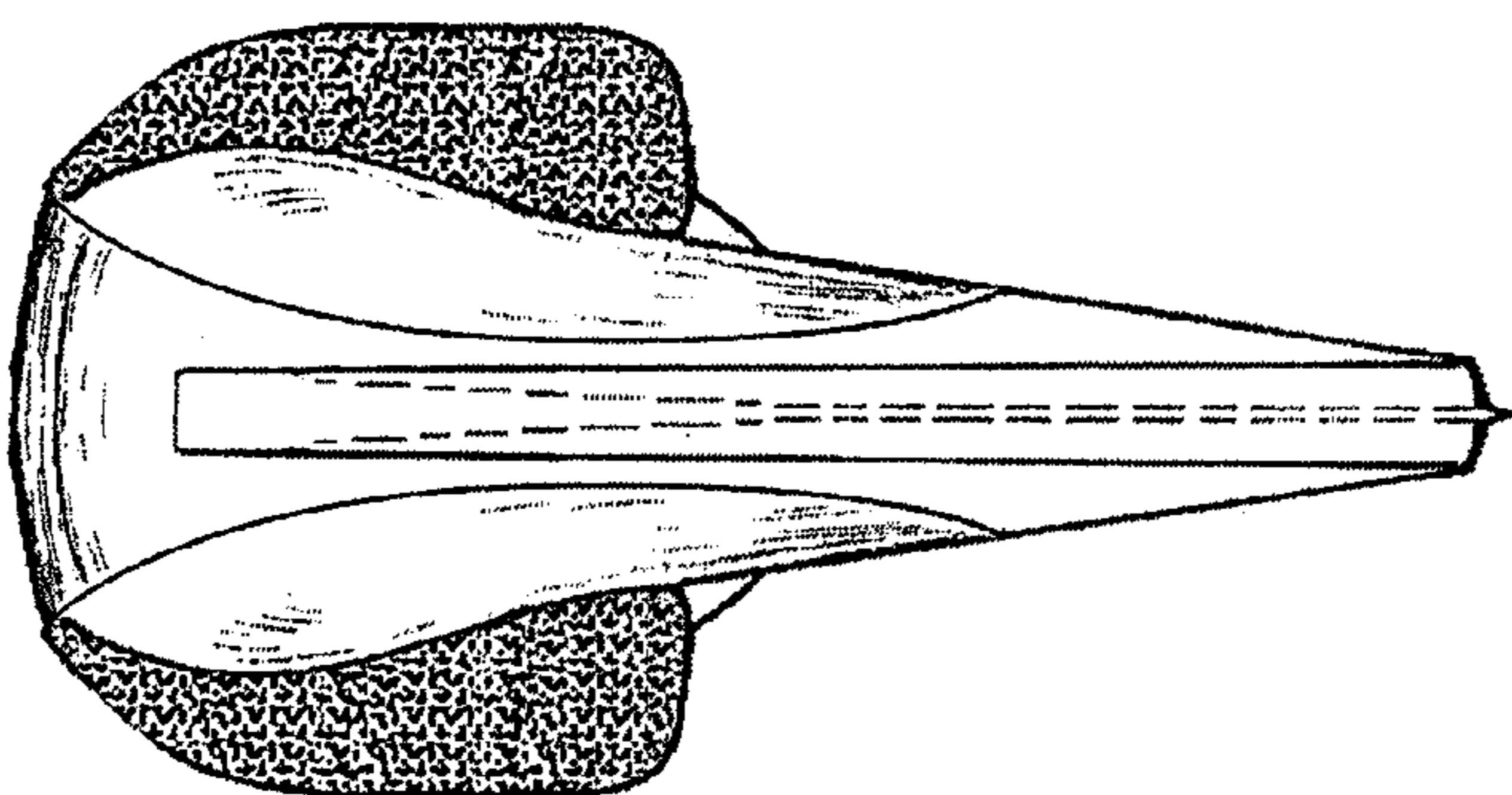

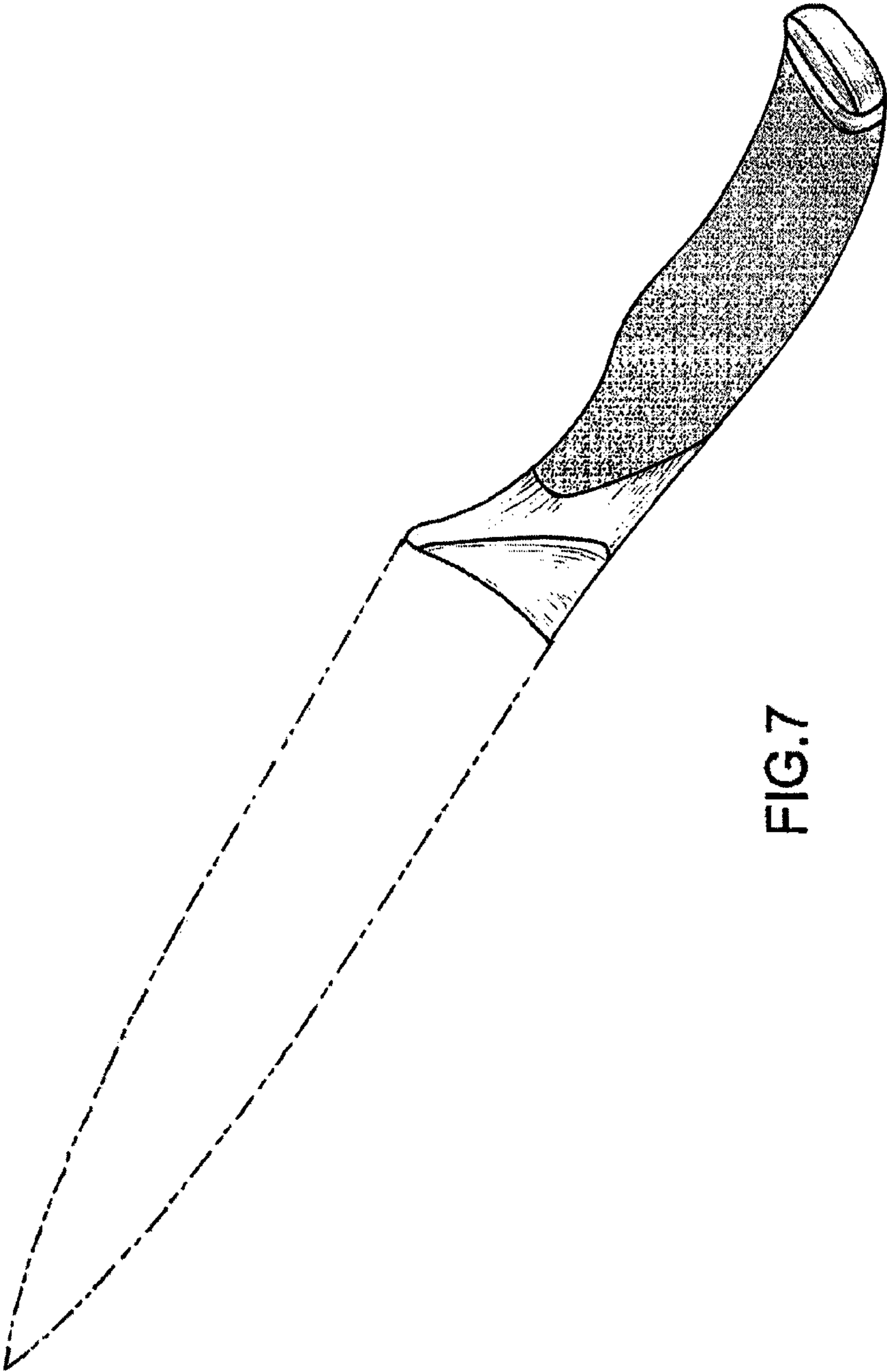

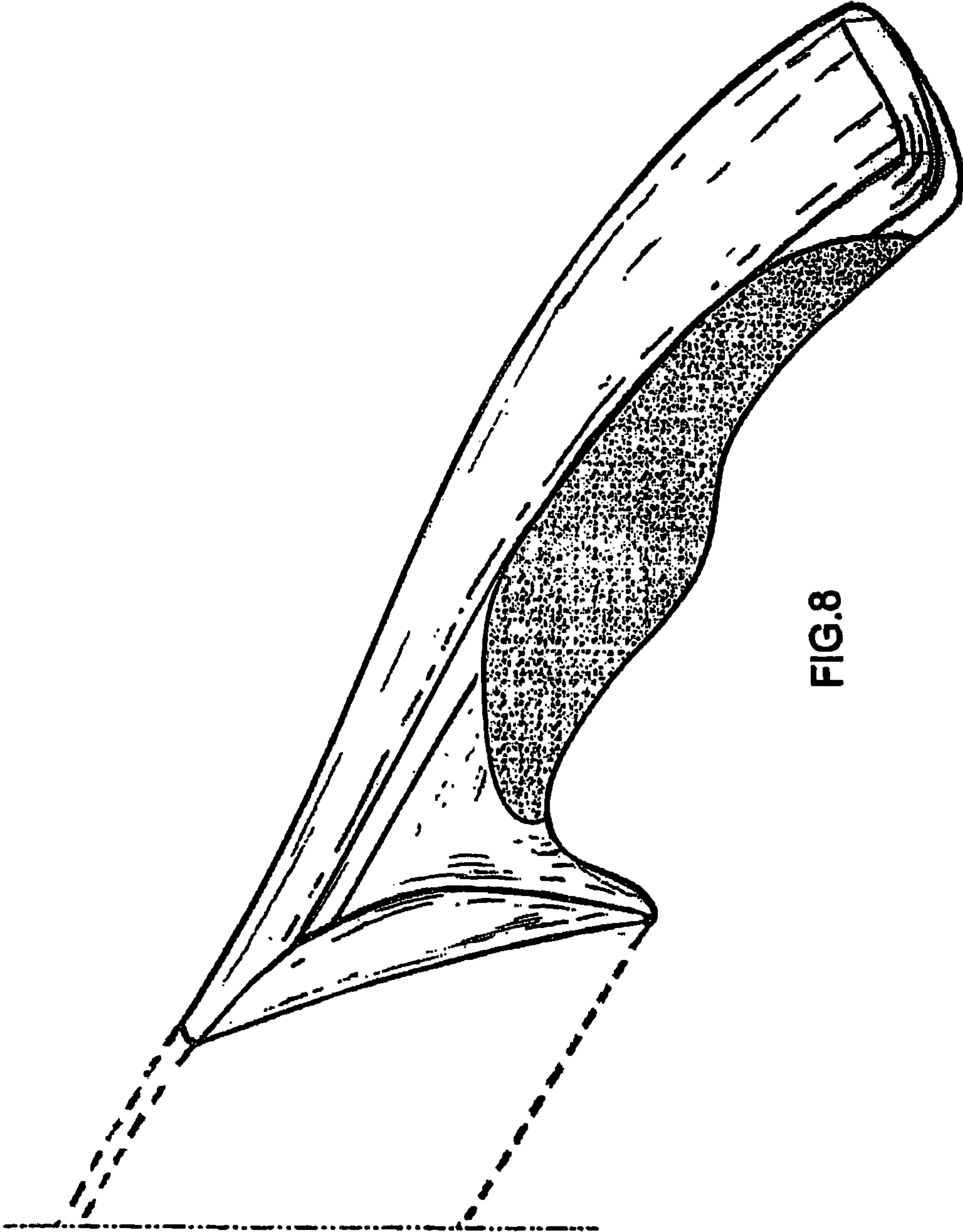

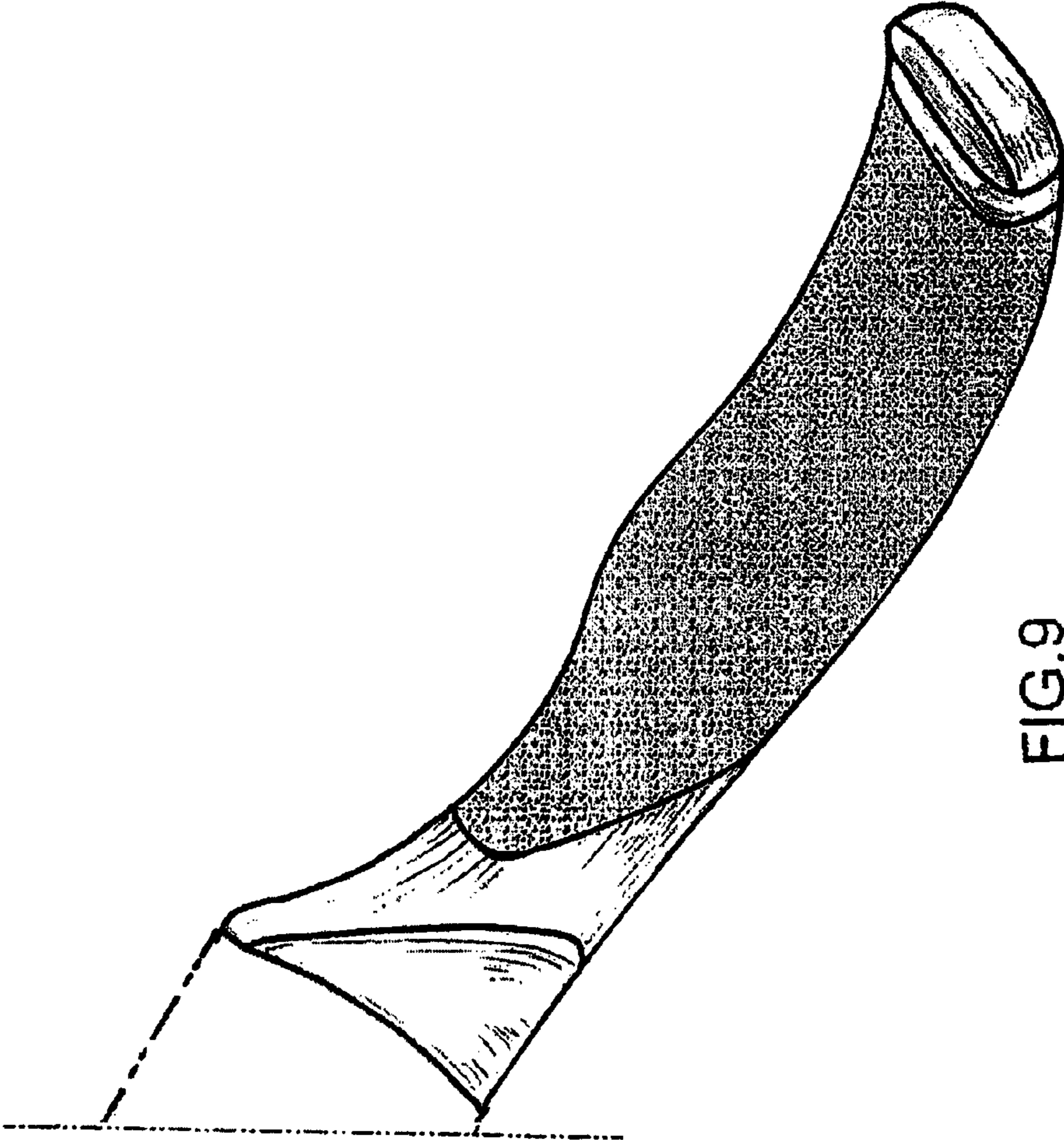
