The ornamental design for a perfume bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, left side, perspective view of a perfume bottle showing my new design;

FIG. 2 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;

FIG. 3 is a front elevational view thereof;

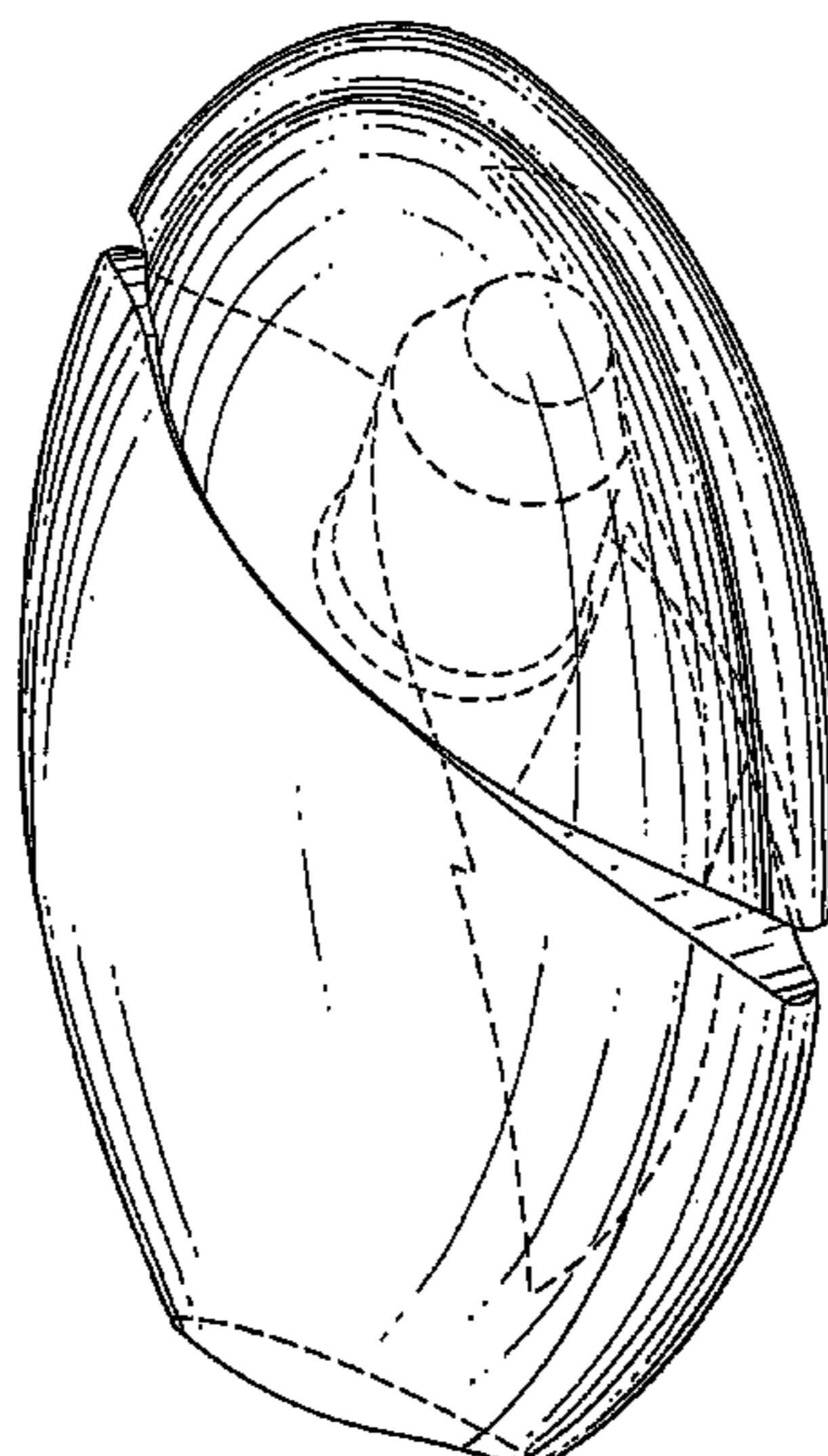
FIG. 4 is a top plan view thereof; and,

FIG. 5 is a left side elevational view of the perfume bottle lid removed from the base, the right side being a mirror image thereof.

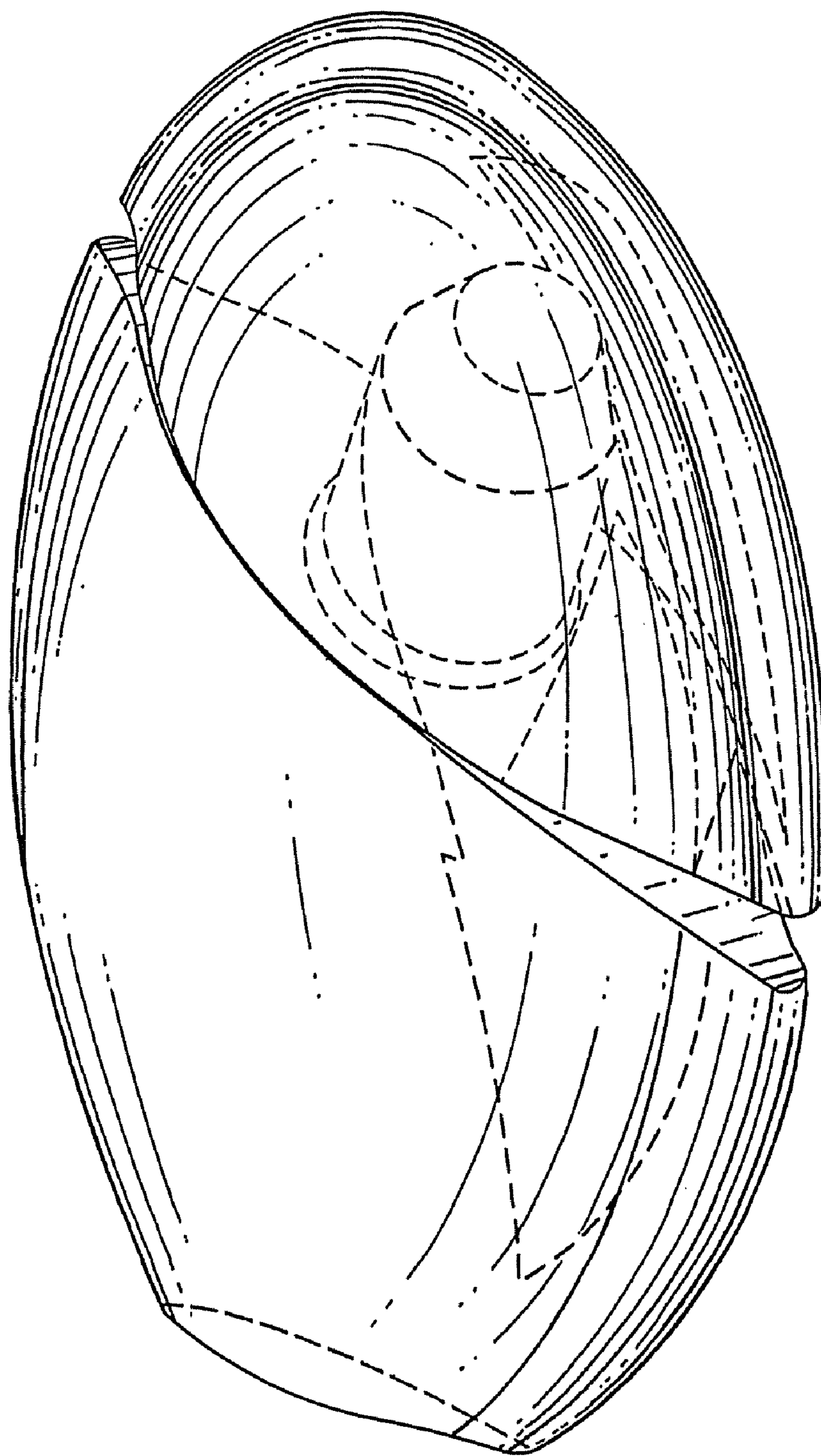

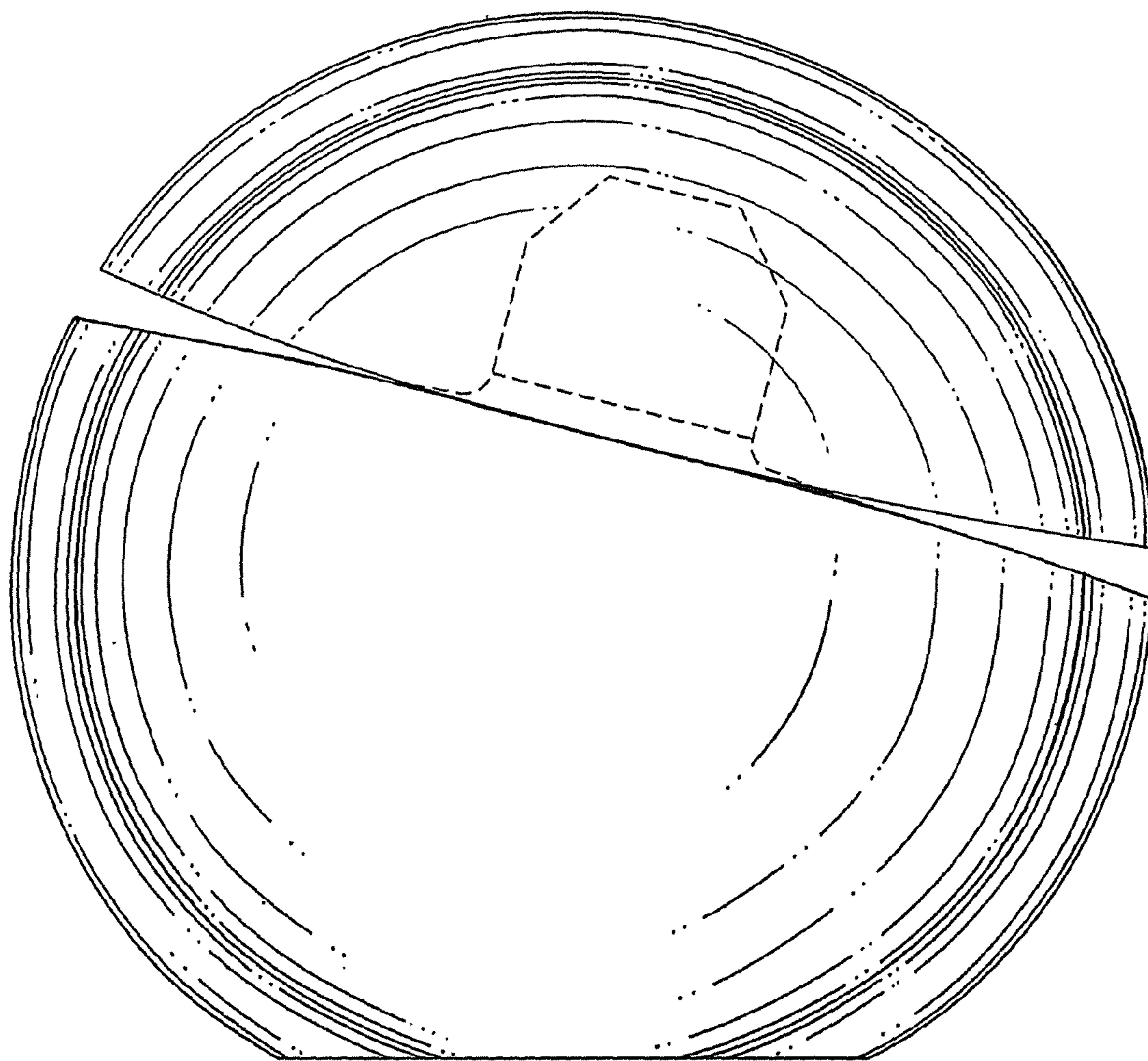

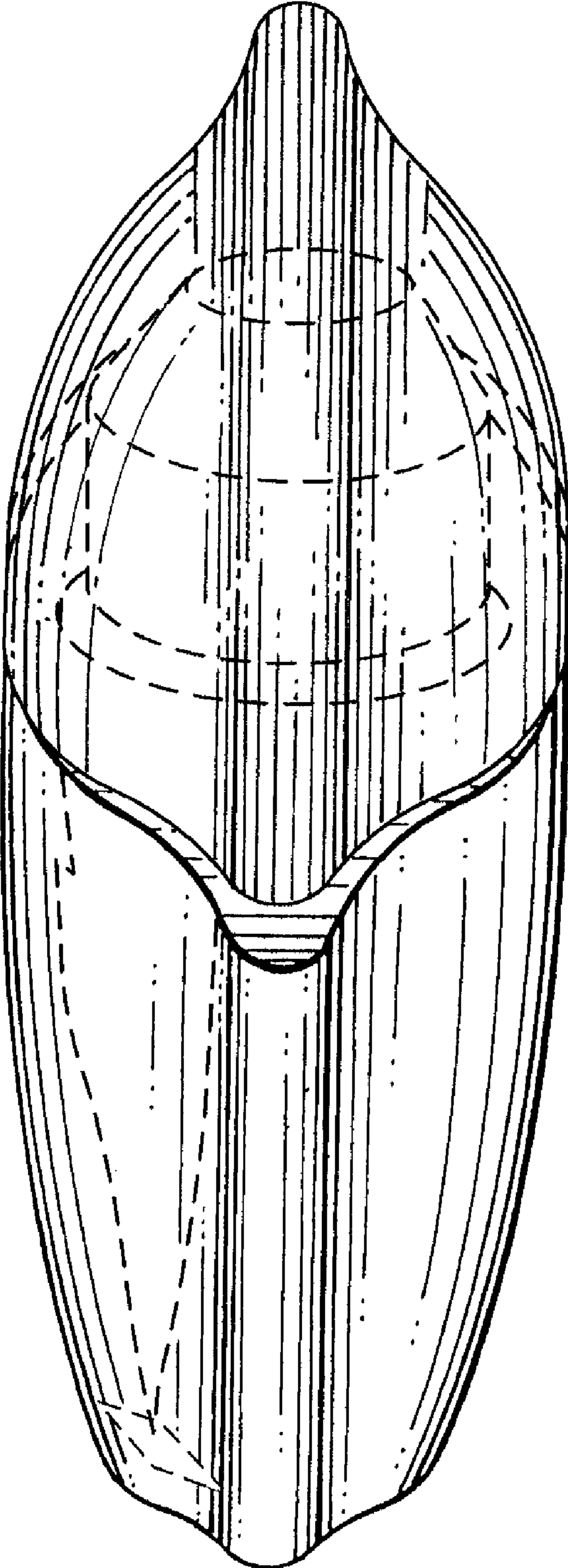

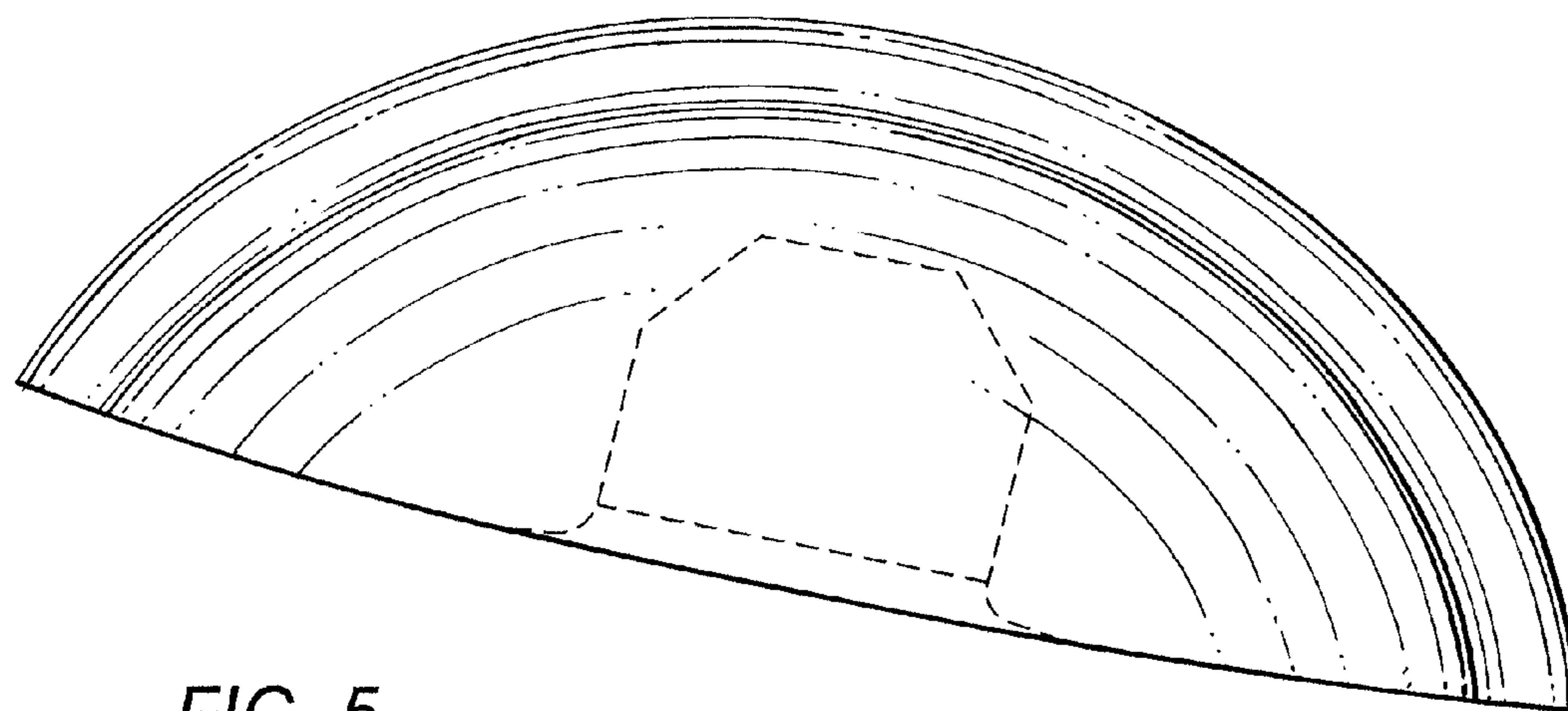
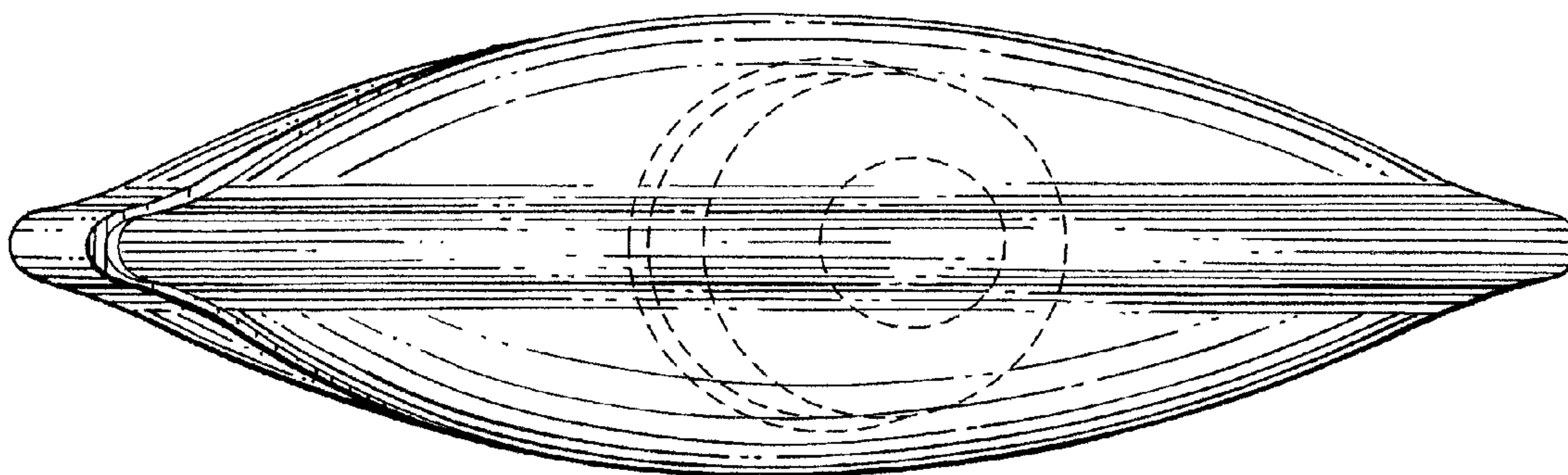
