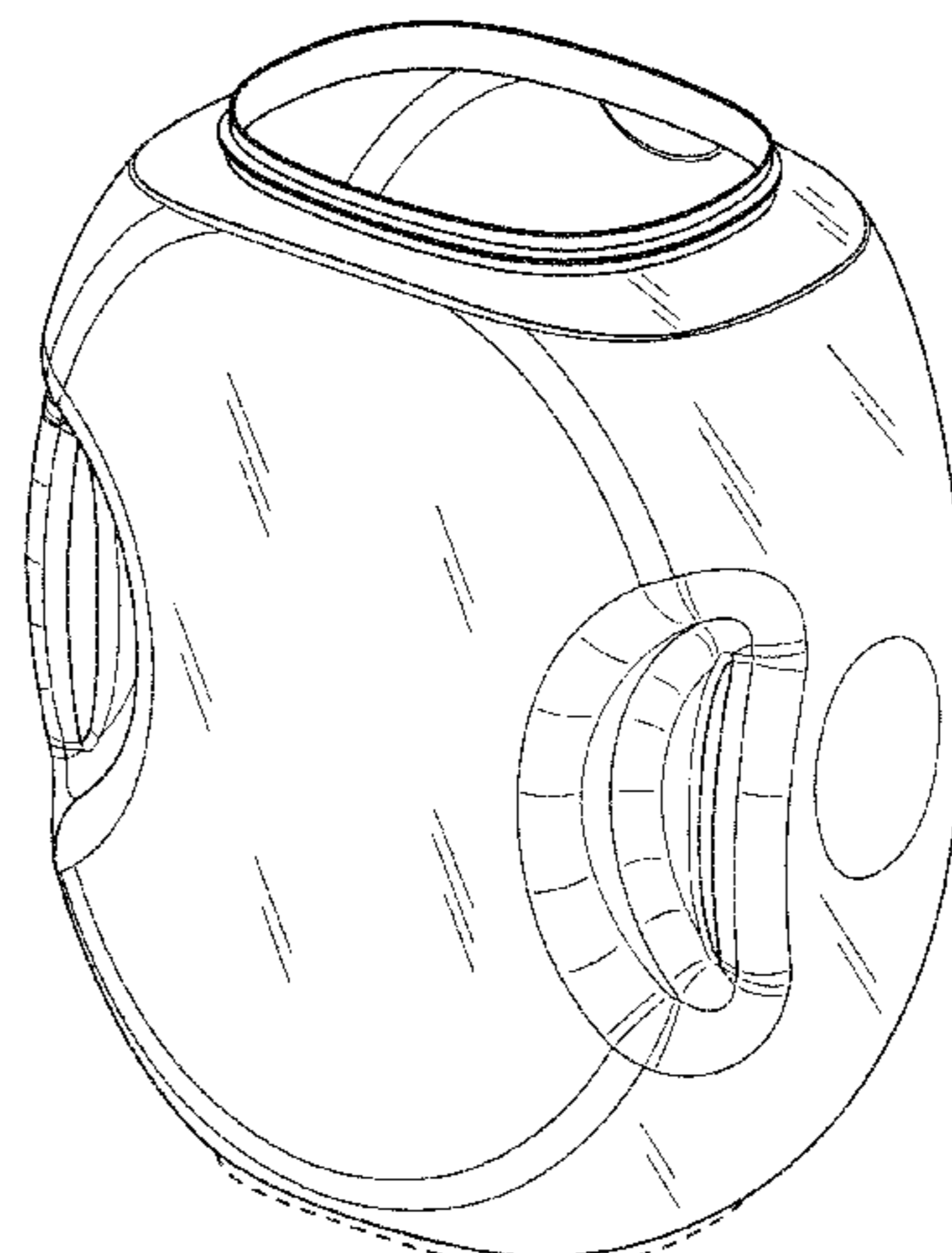
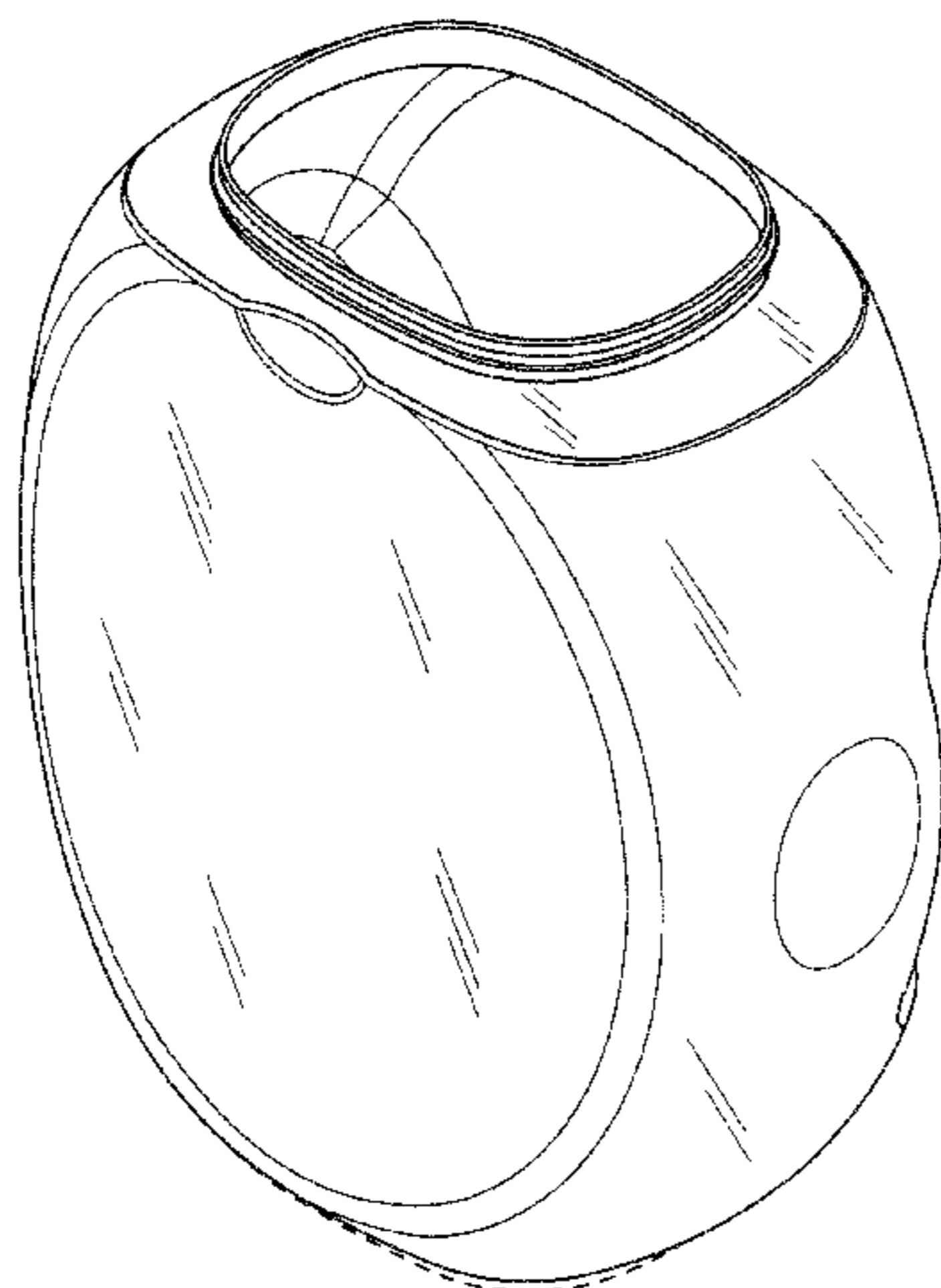
The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of a container embodying our new design; FIG. 2 is a top, back, and left side perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a back elevational view thereof; FIG. 5 is a left side elevational view thereof, the right side elevational view being a mirror image, FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The broken lines shown in the drawings of the bottom surface are included for the purpose of illustrating environmental structure and form no part of the claimed design.

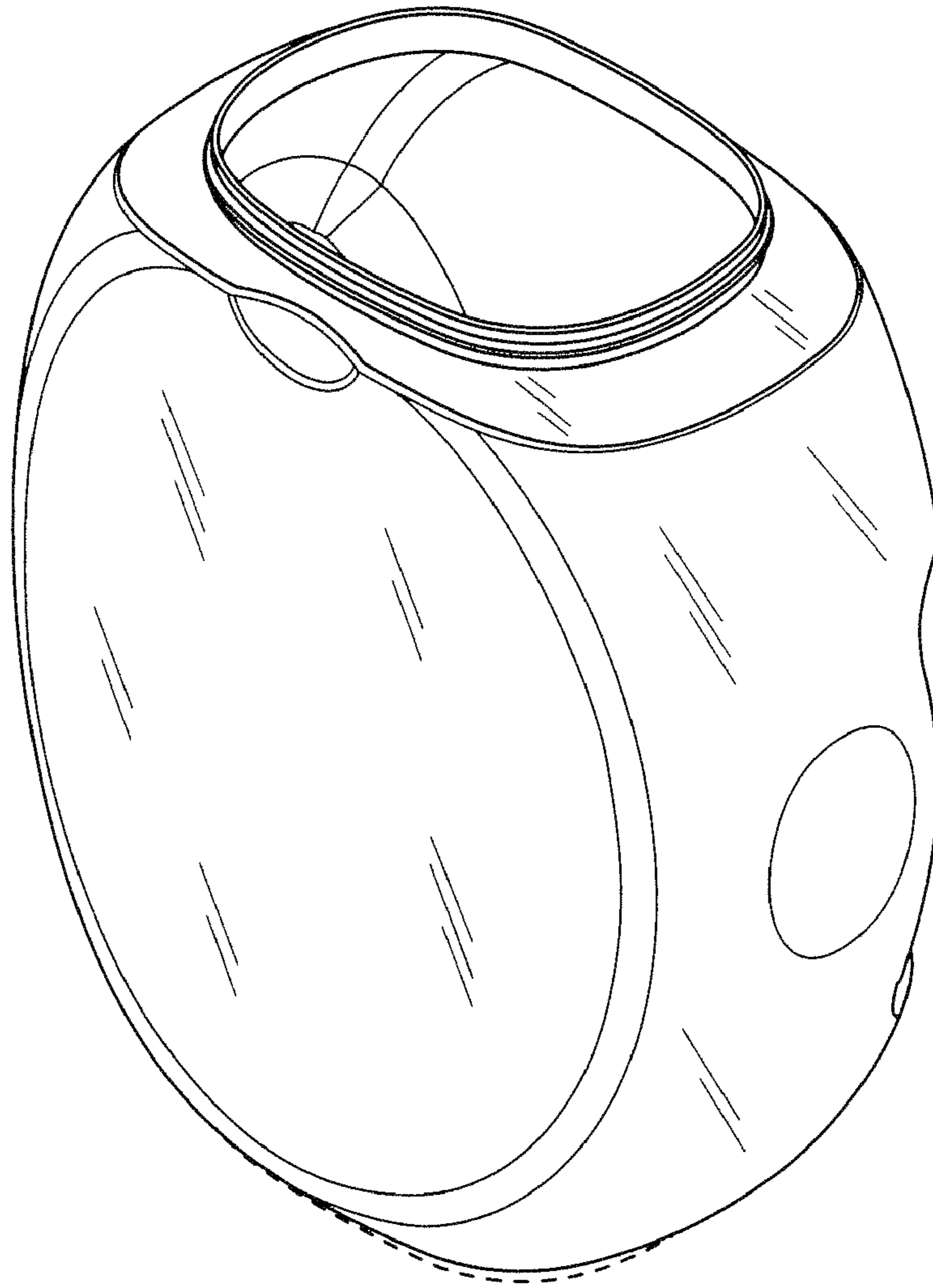

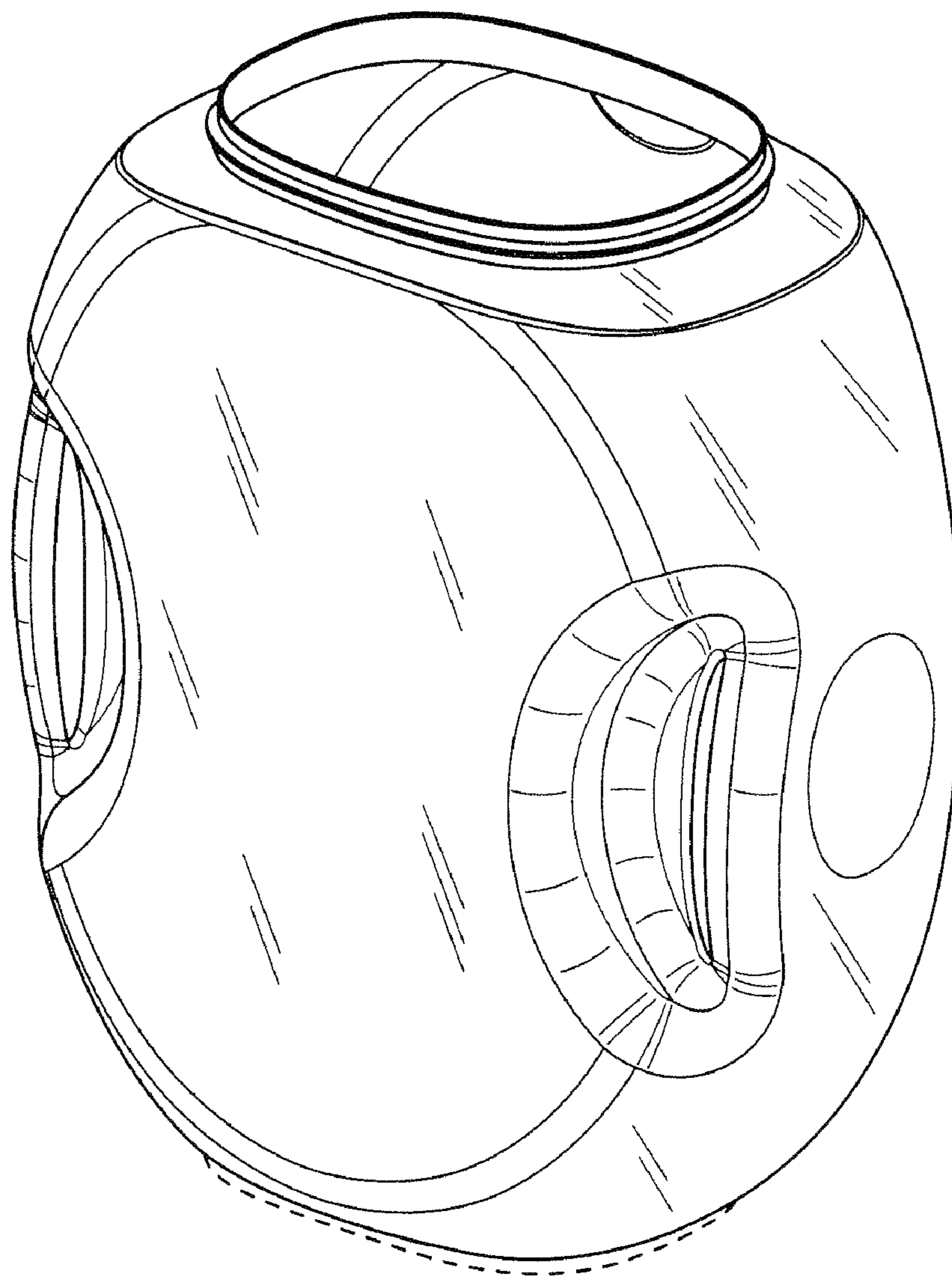

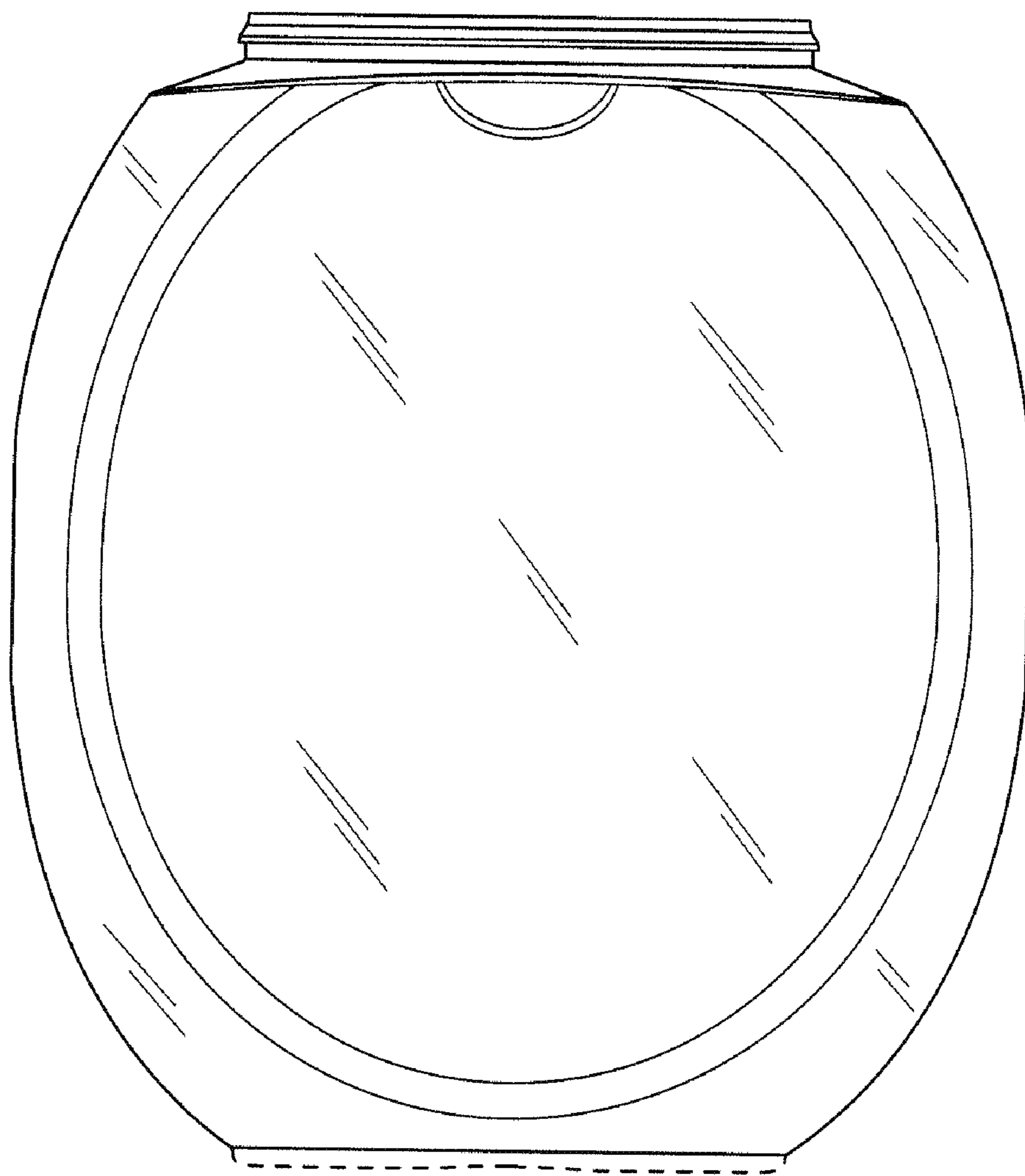

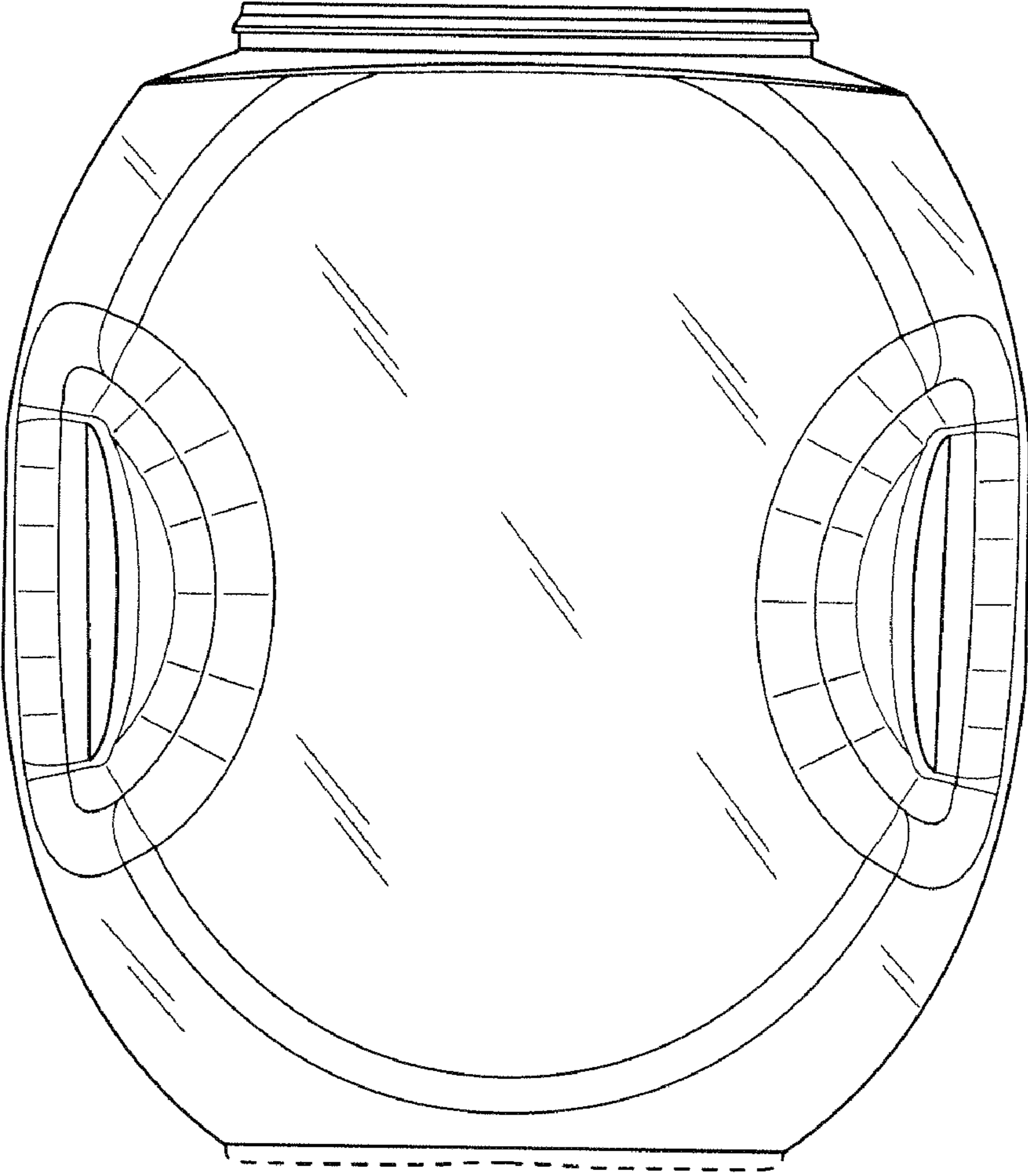

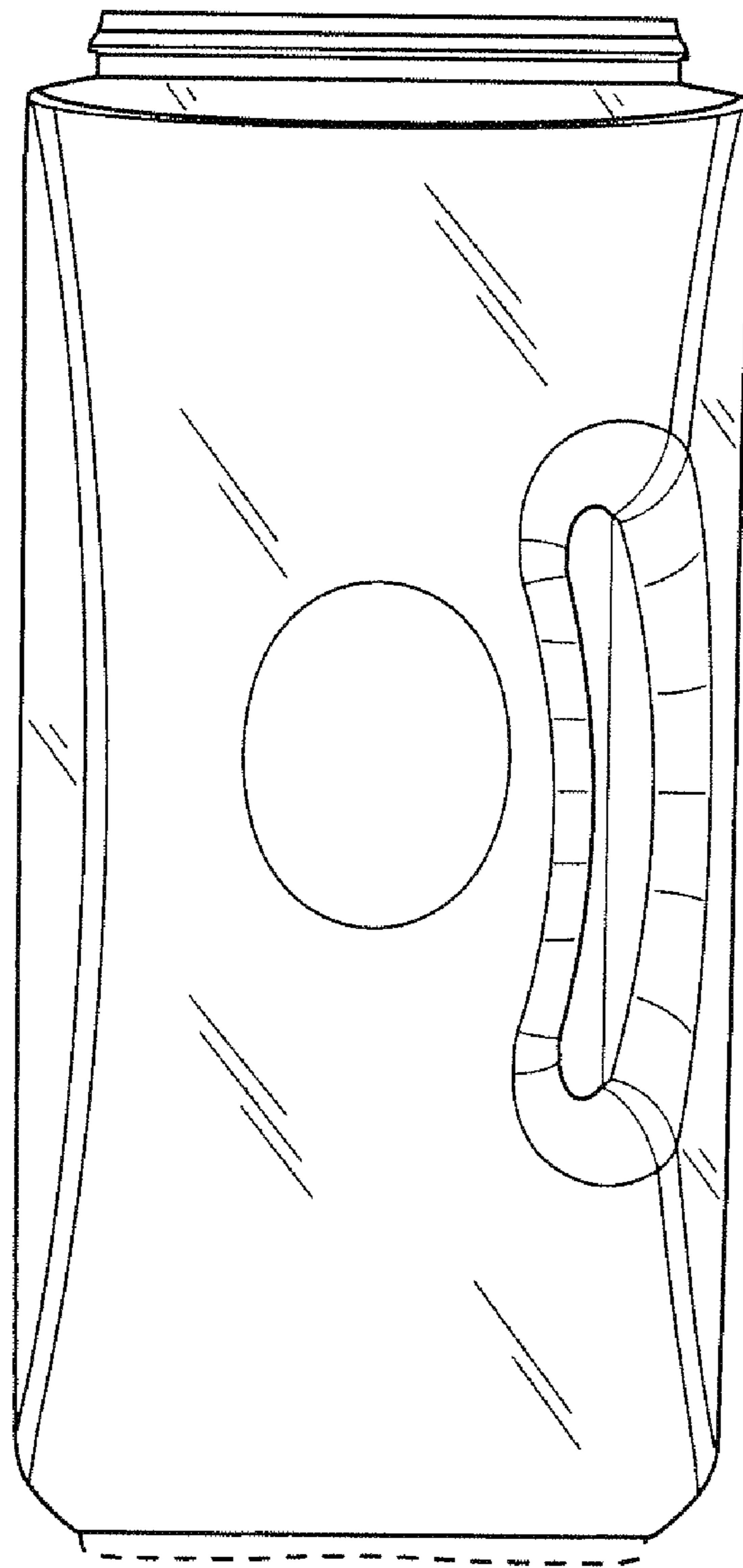

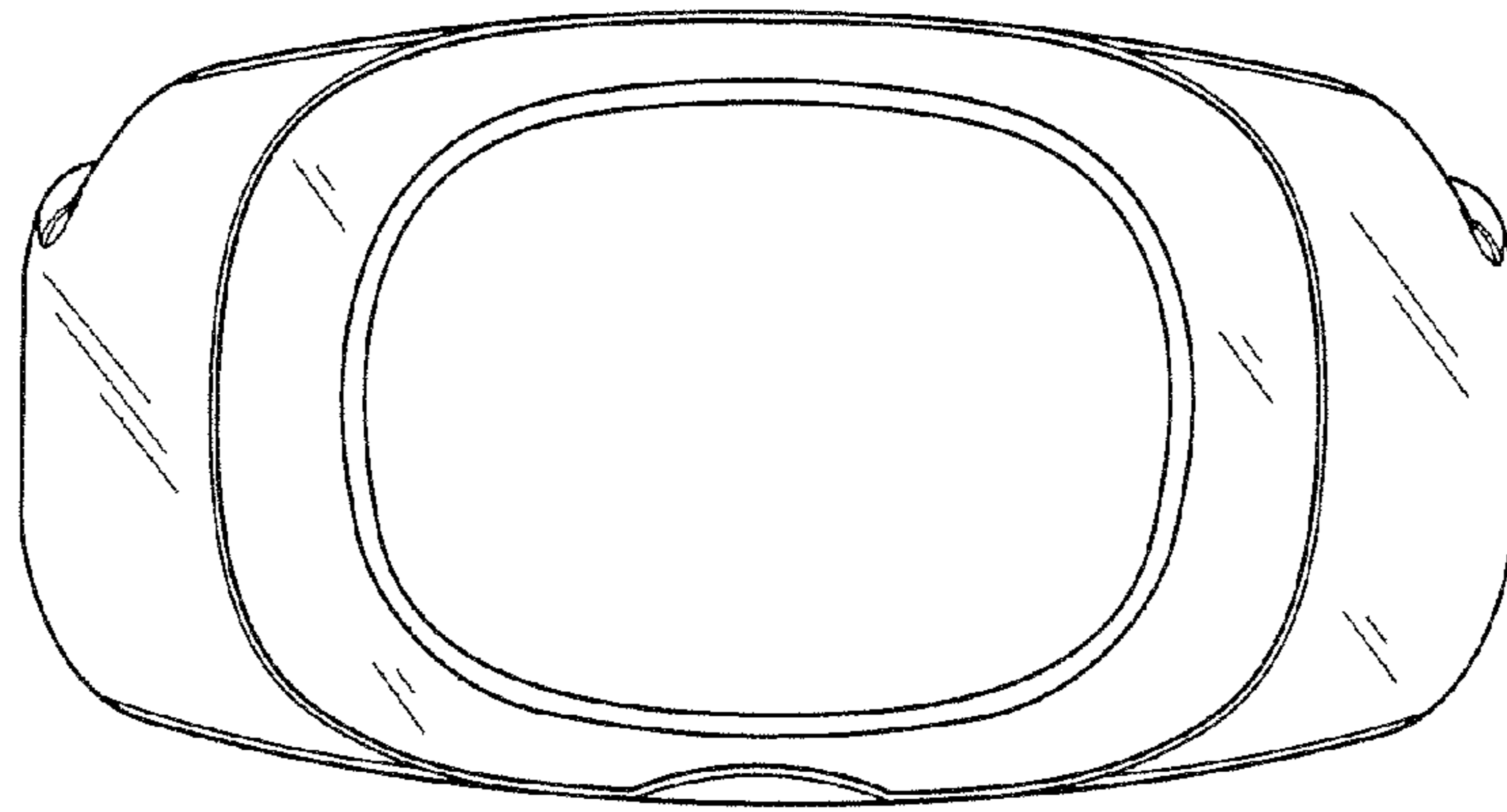

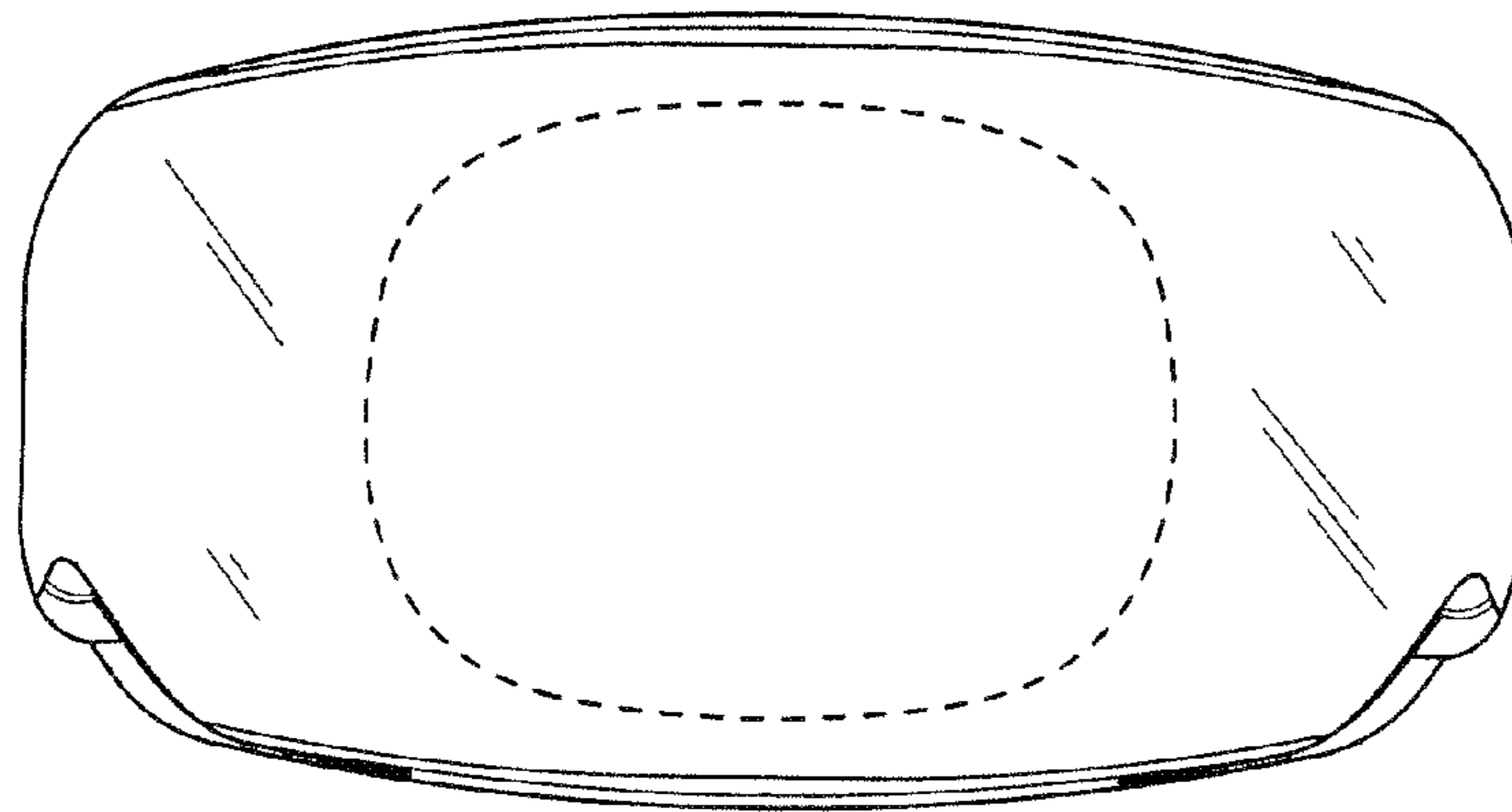
