The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a front left side perspective view of a container showing our new design;

FIG. 2 is a side view of the container of FIG. 1;

FIG. 3 is another side view of the container of FIG. 1, opposite the side view shown in FIG. 2;

FIG. 4 is a front elevational view of the container of FIG. 1;

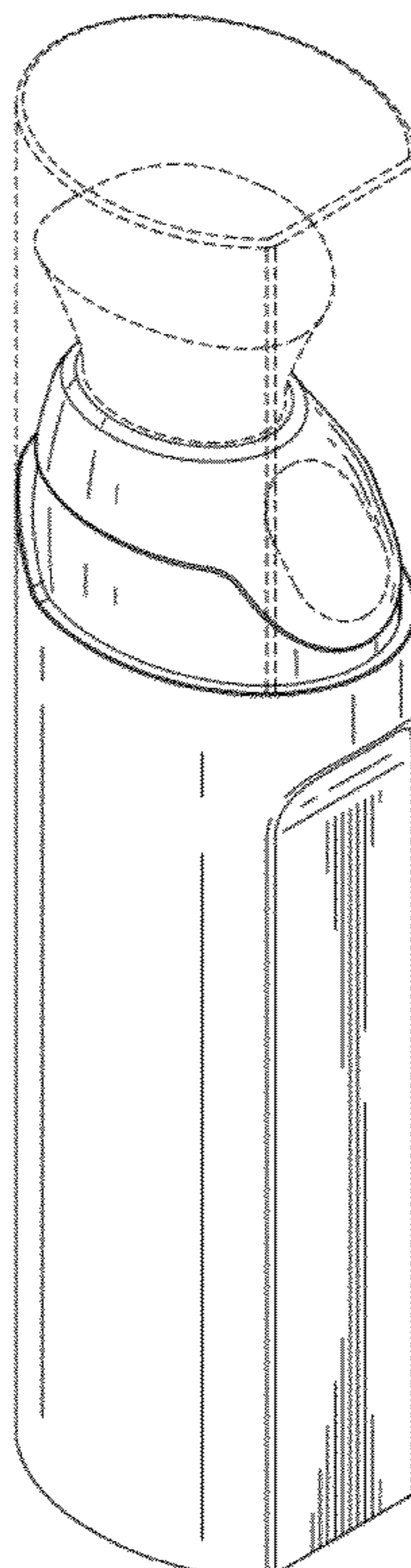
FIG. 5 is a rear elevational view of the container of FIG. 1;

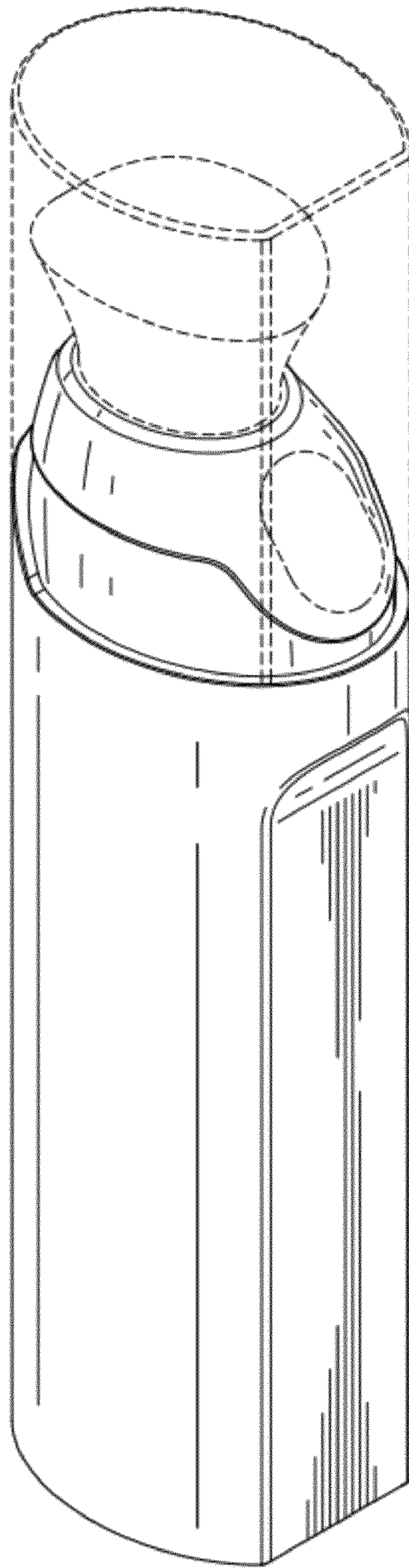

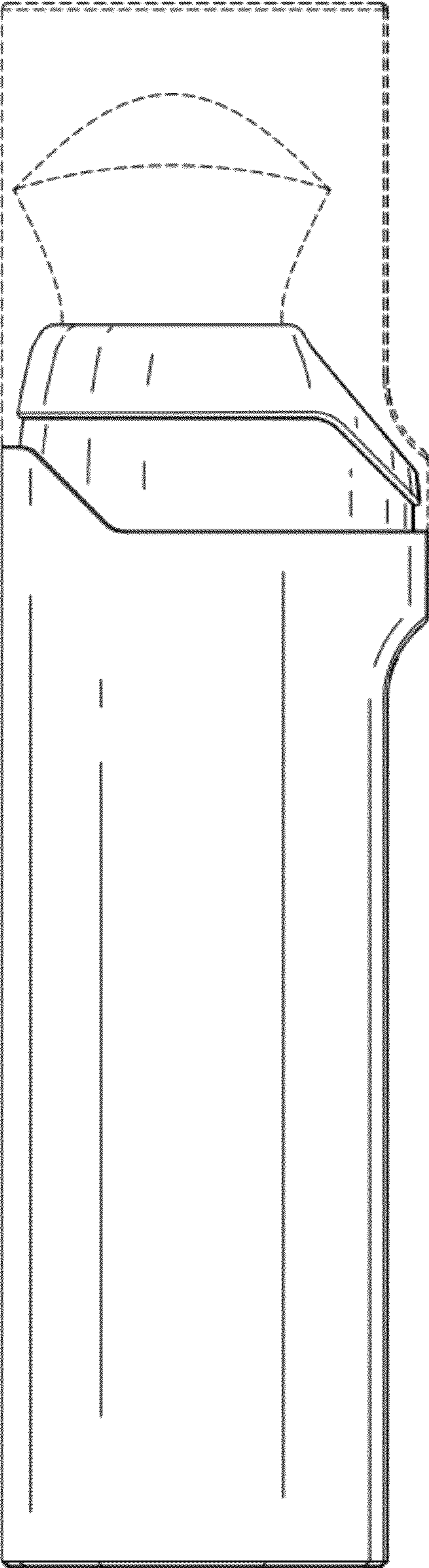

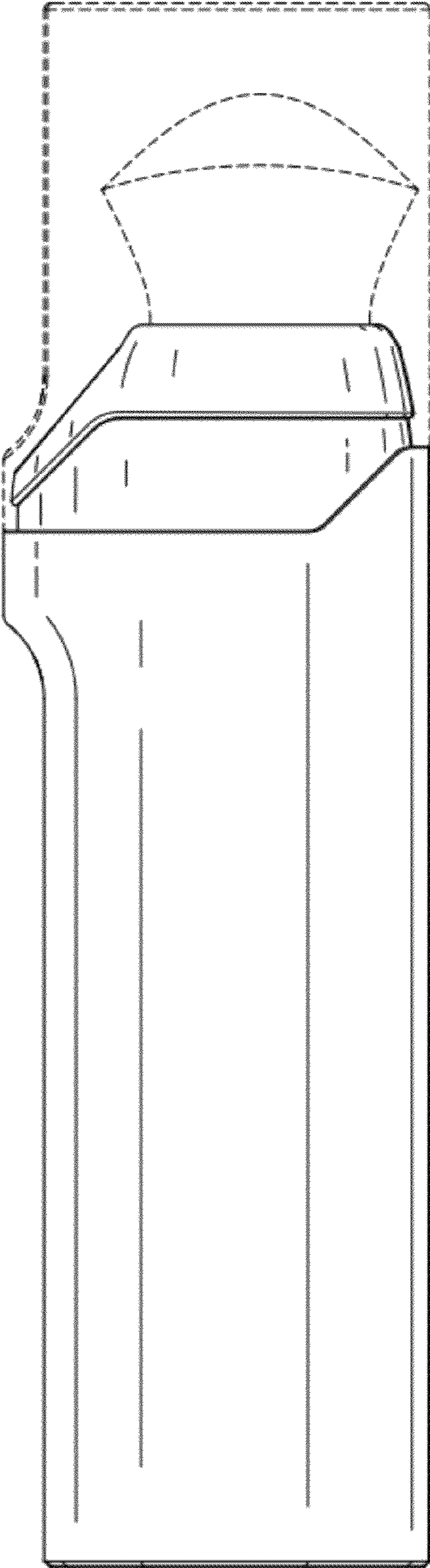

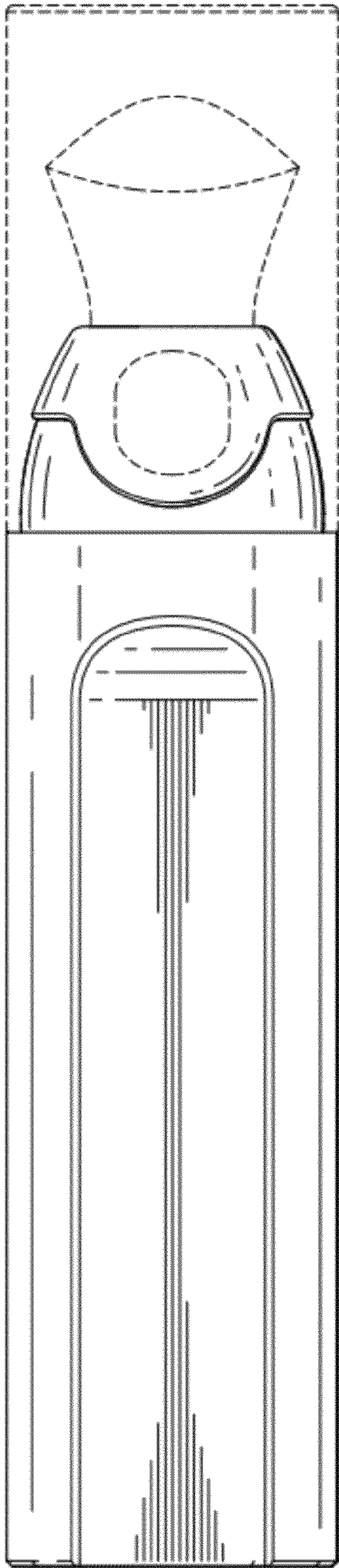

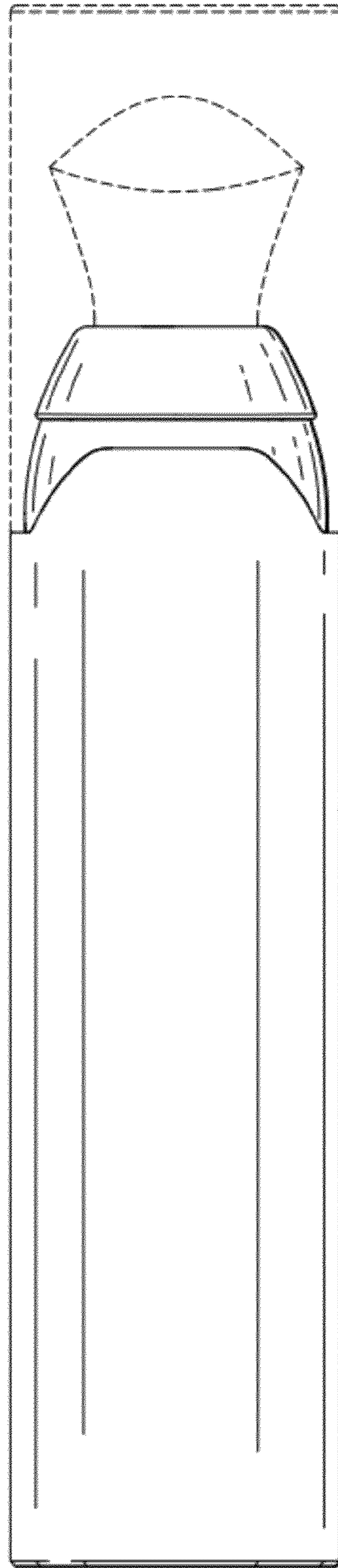

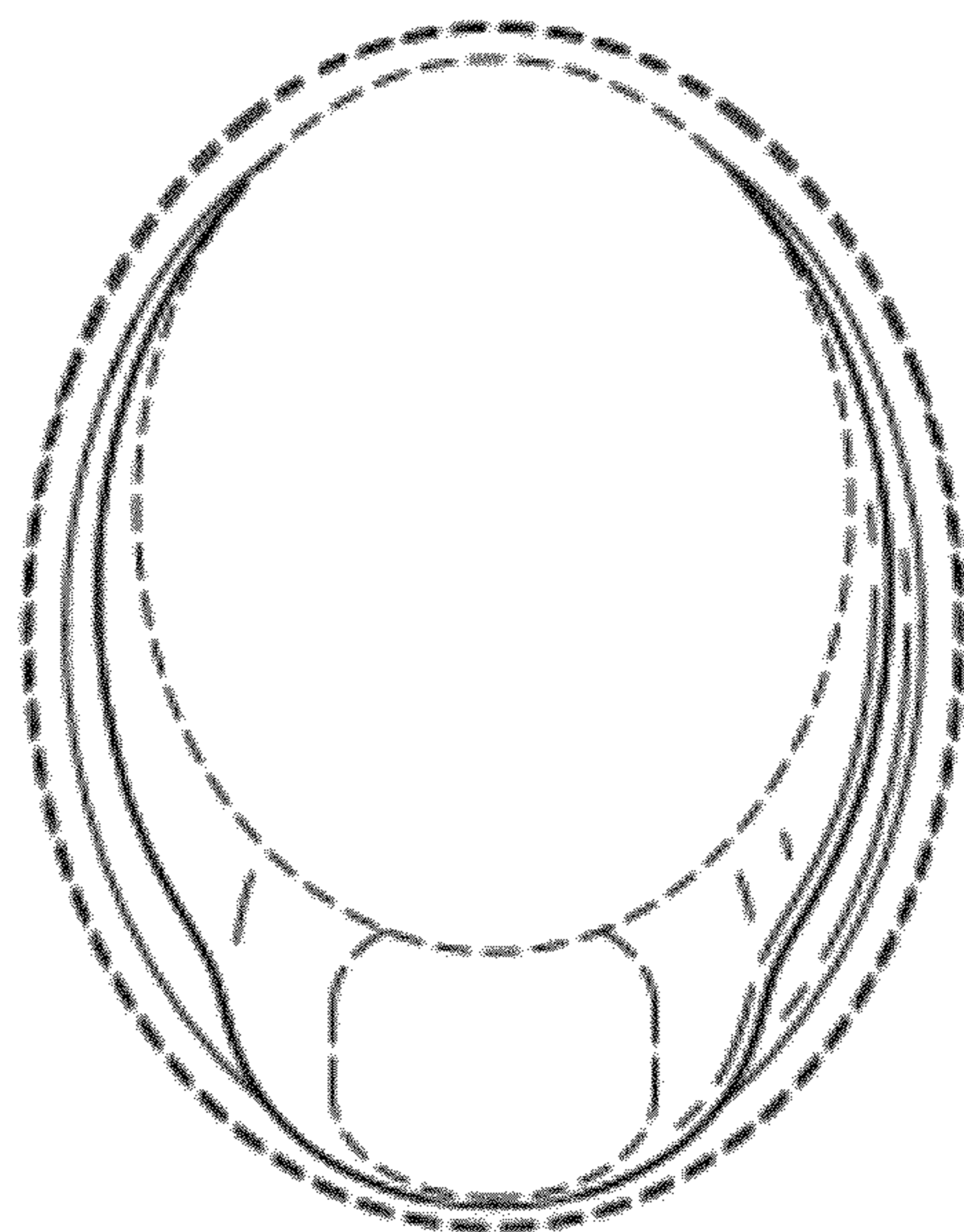

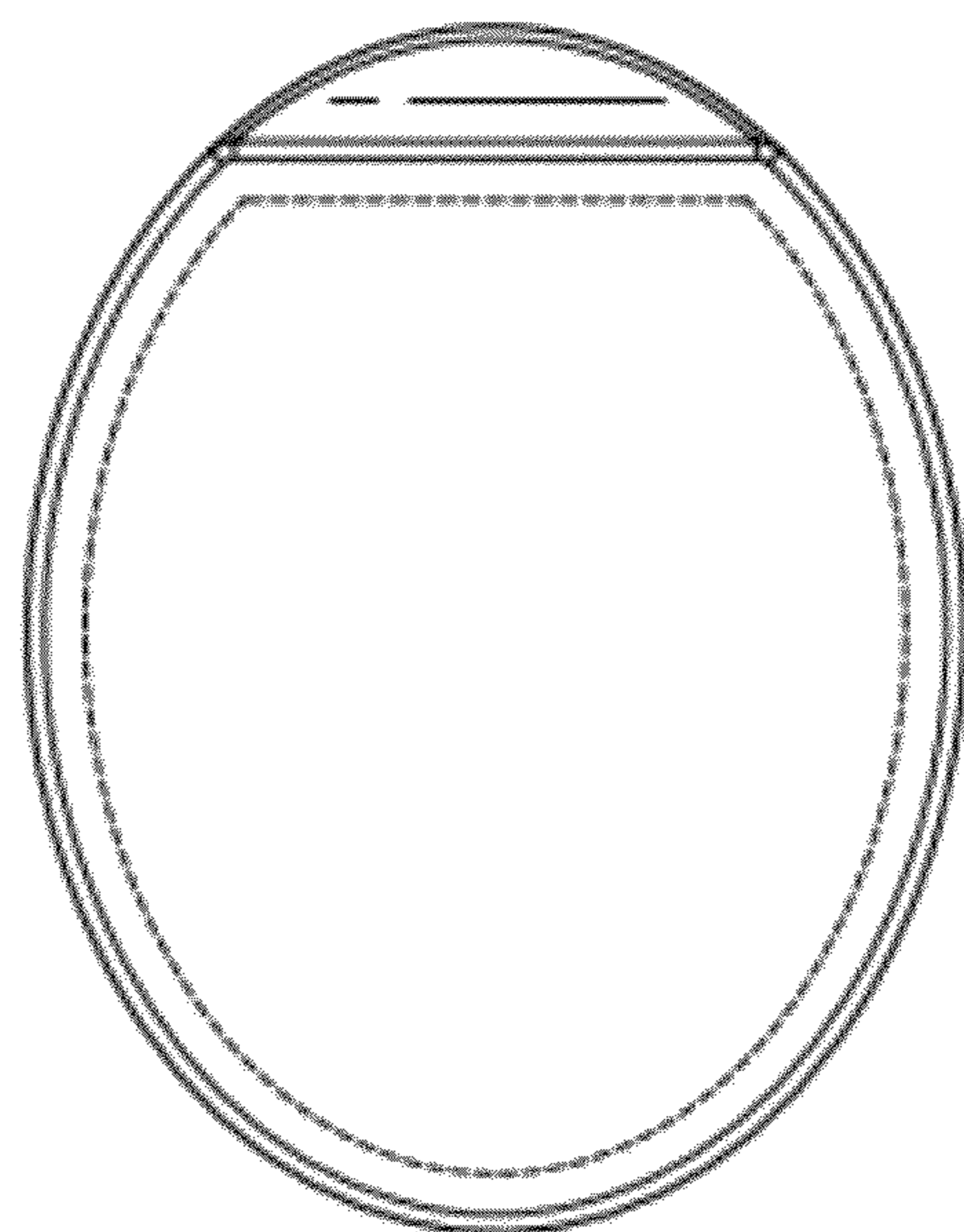
