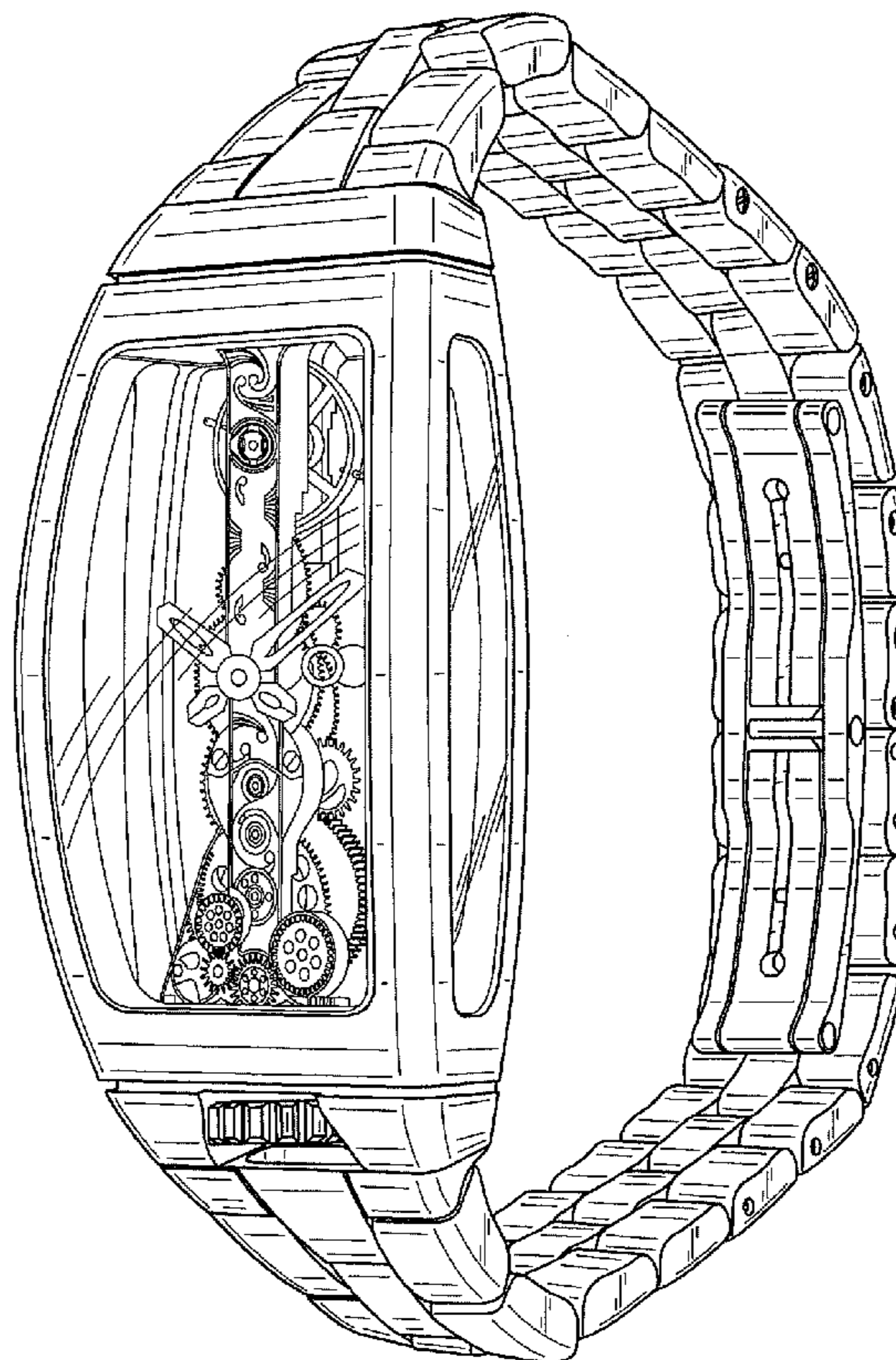
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of the front and right side of a wristwatch that comprises my invention;  
FIG. 2 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof;

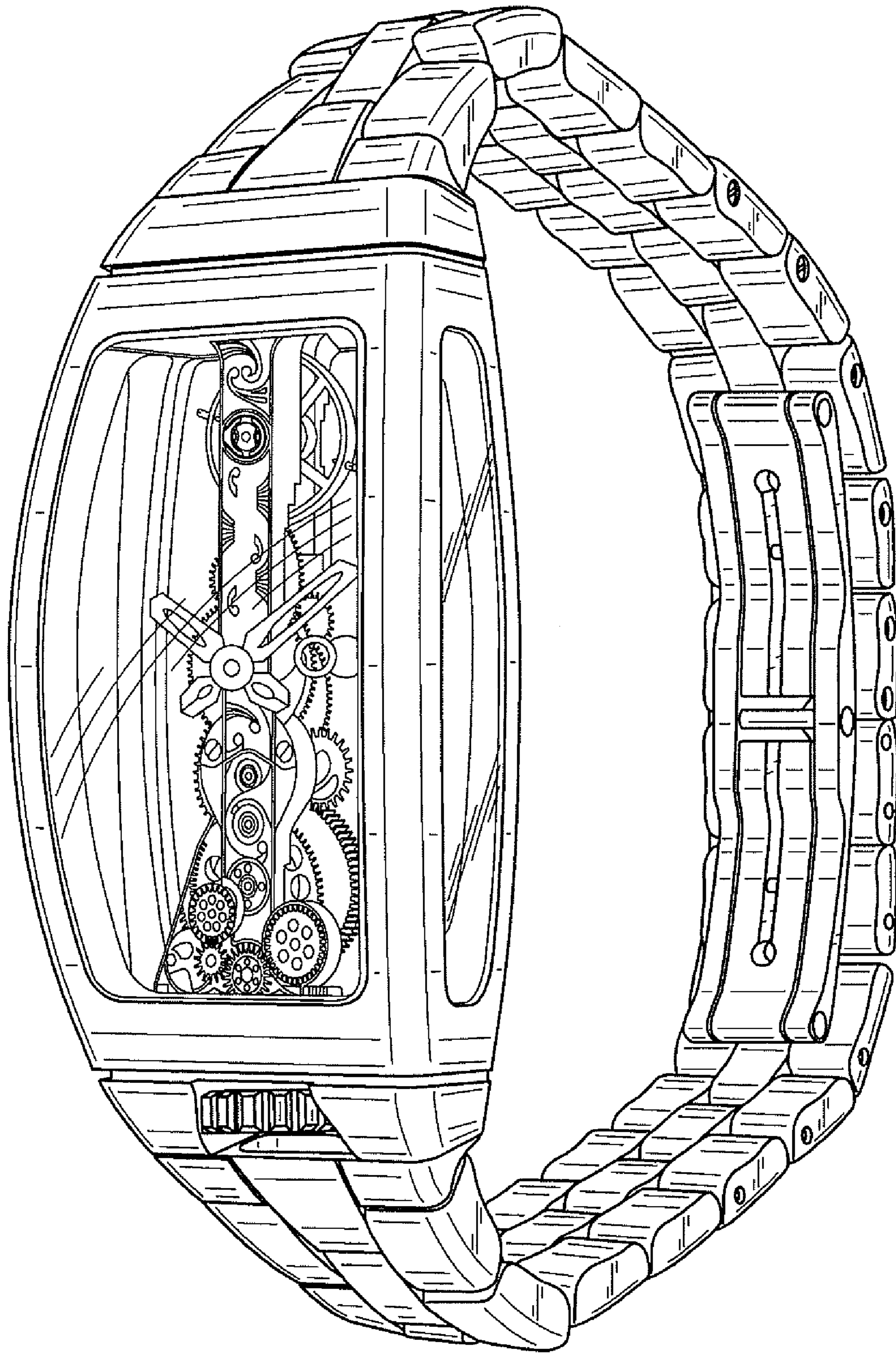

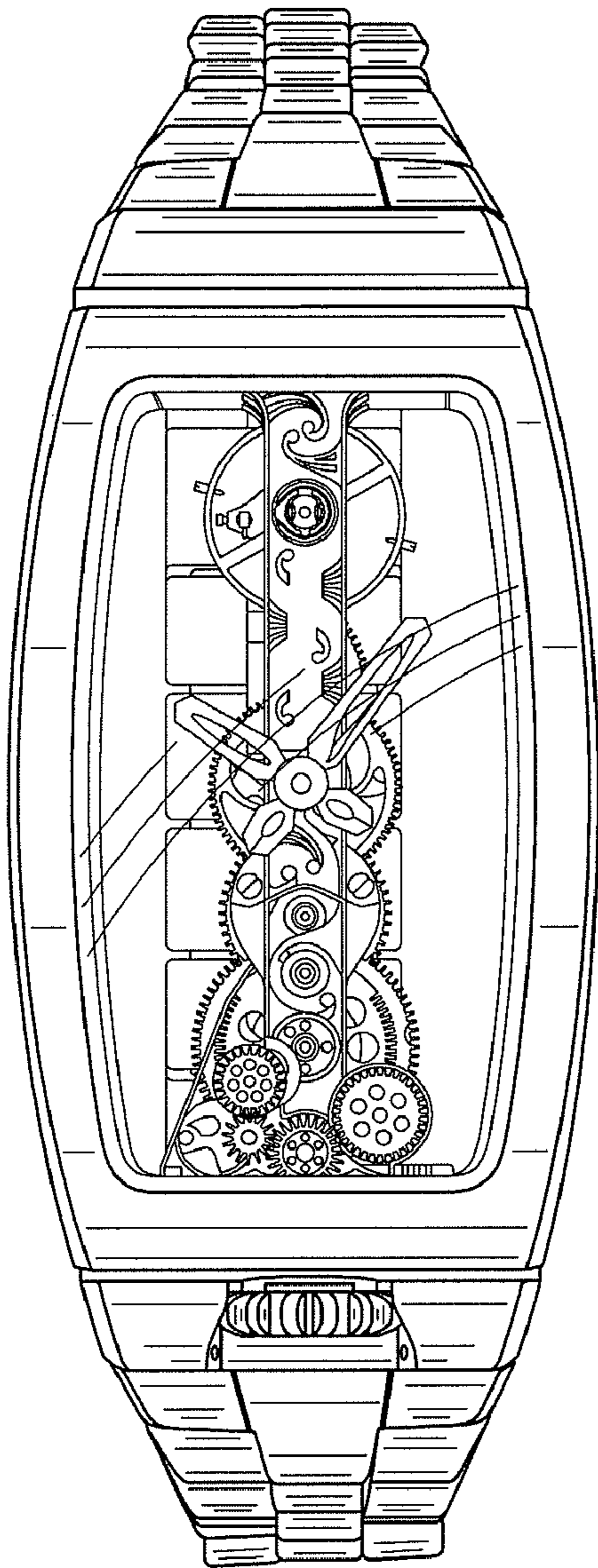

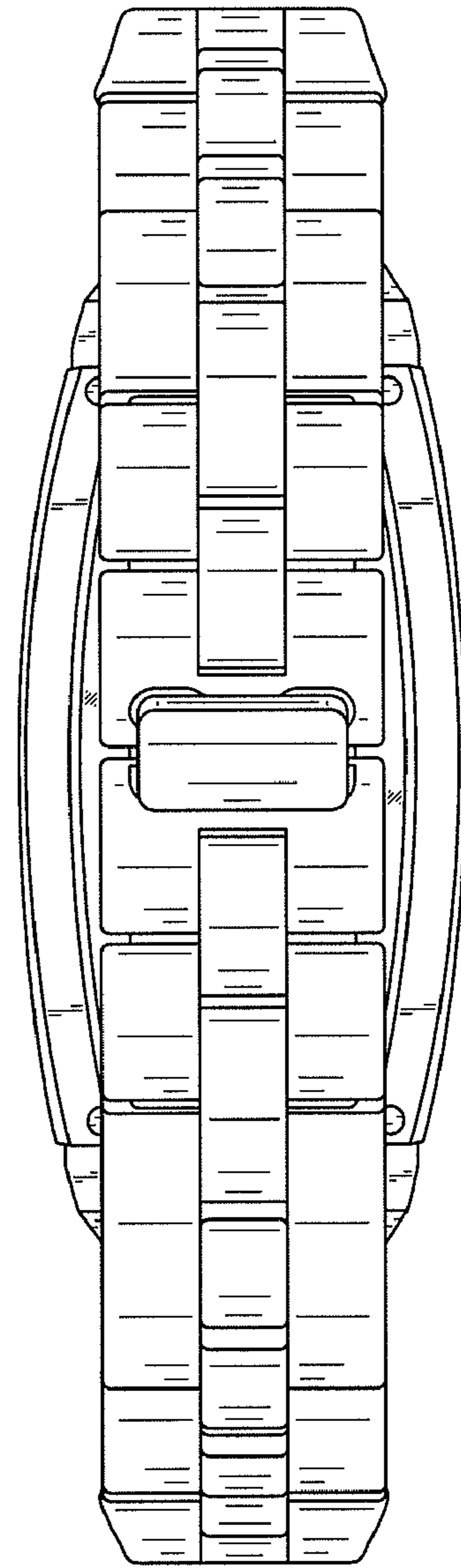

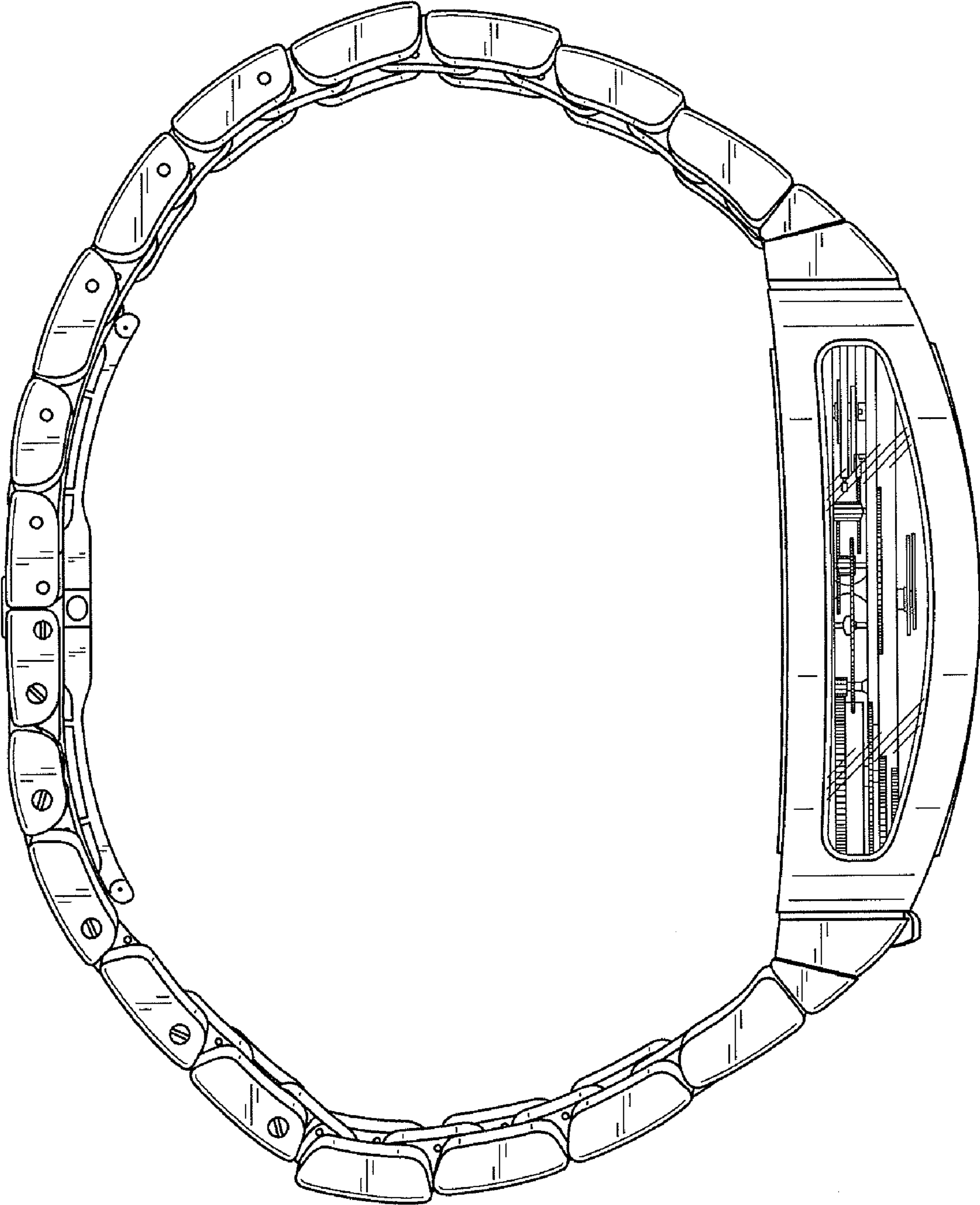

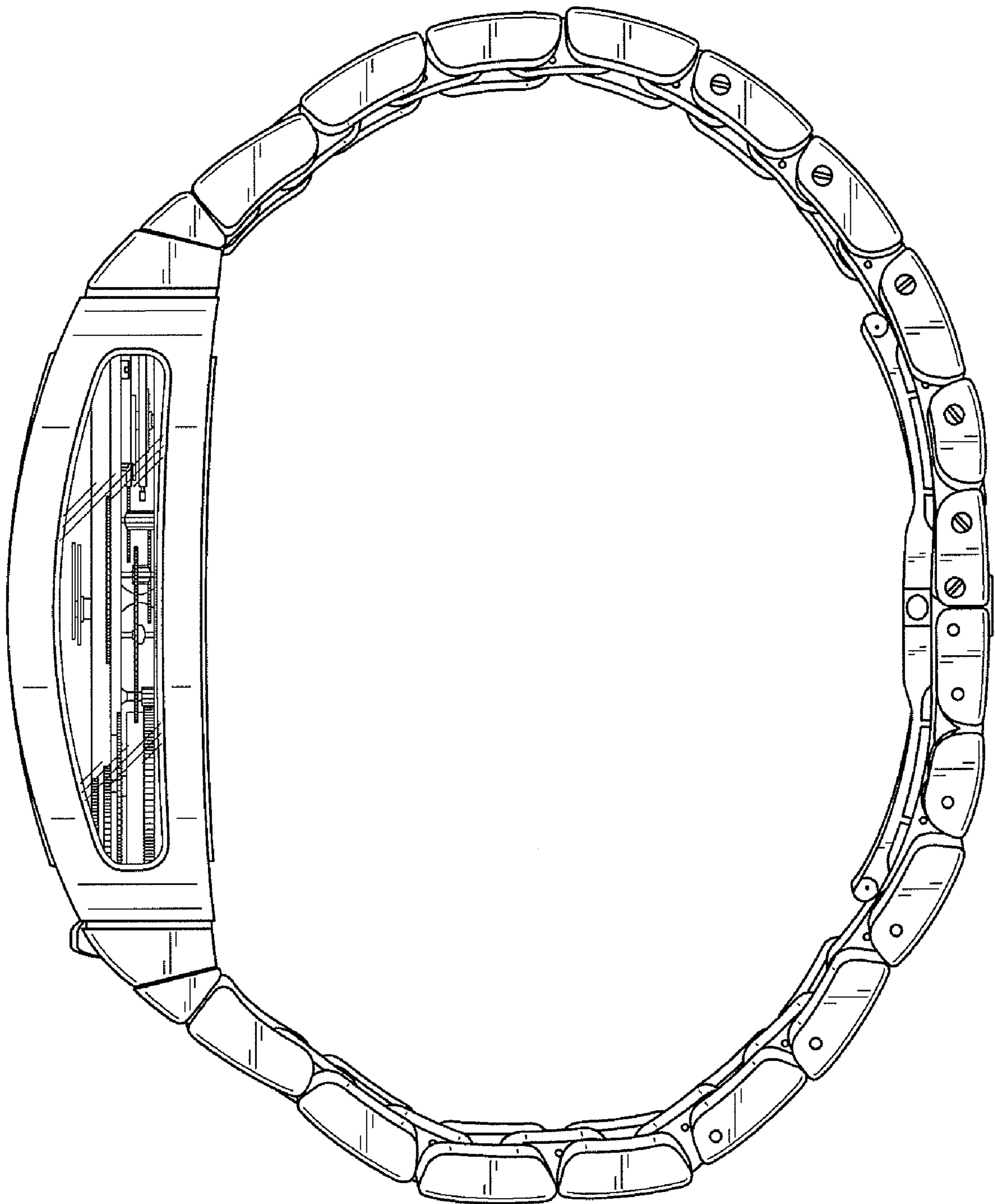

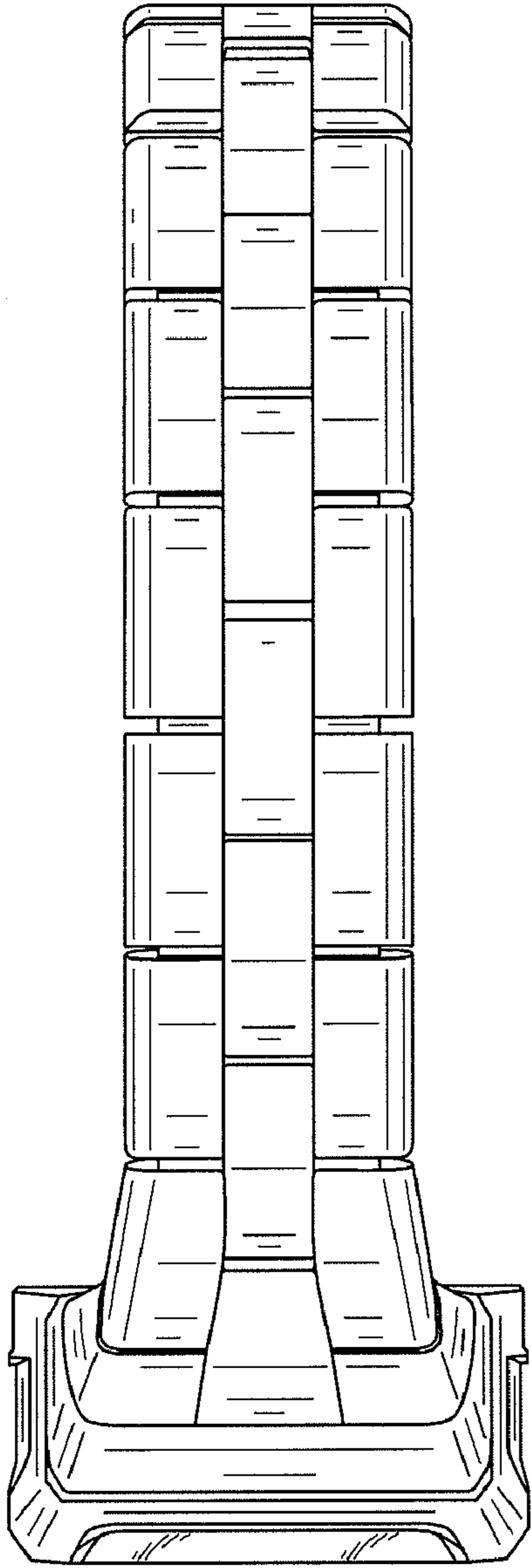

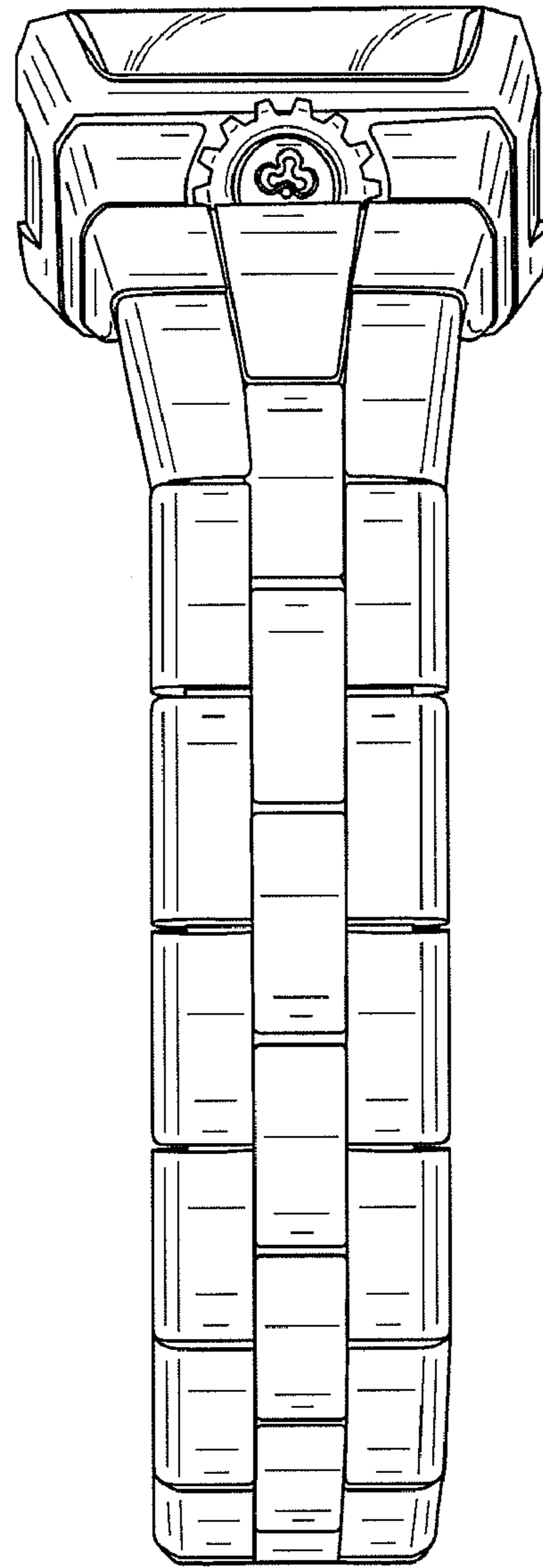

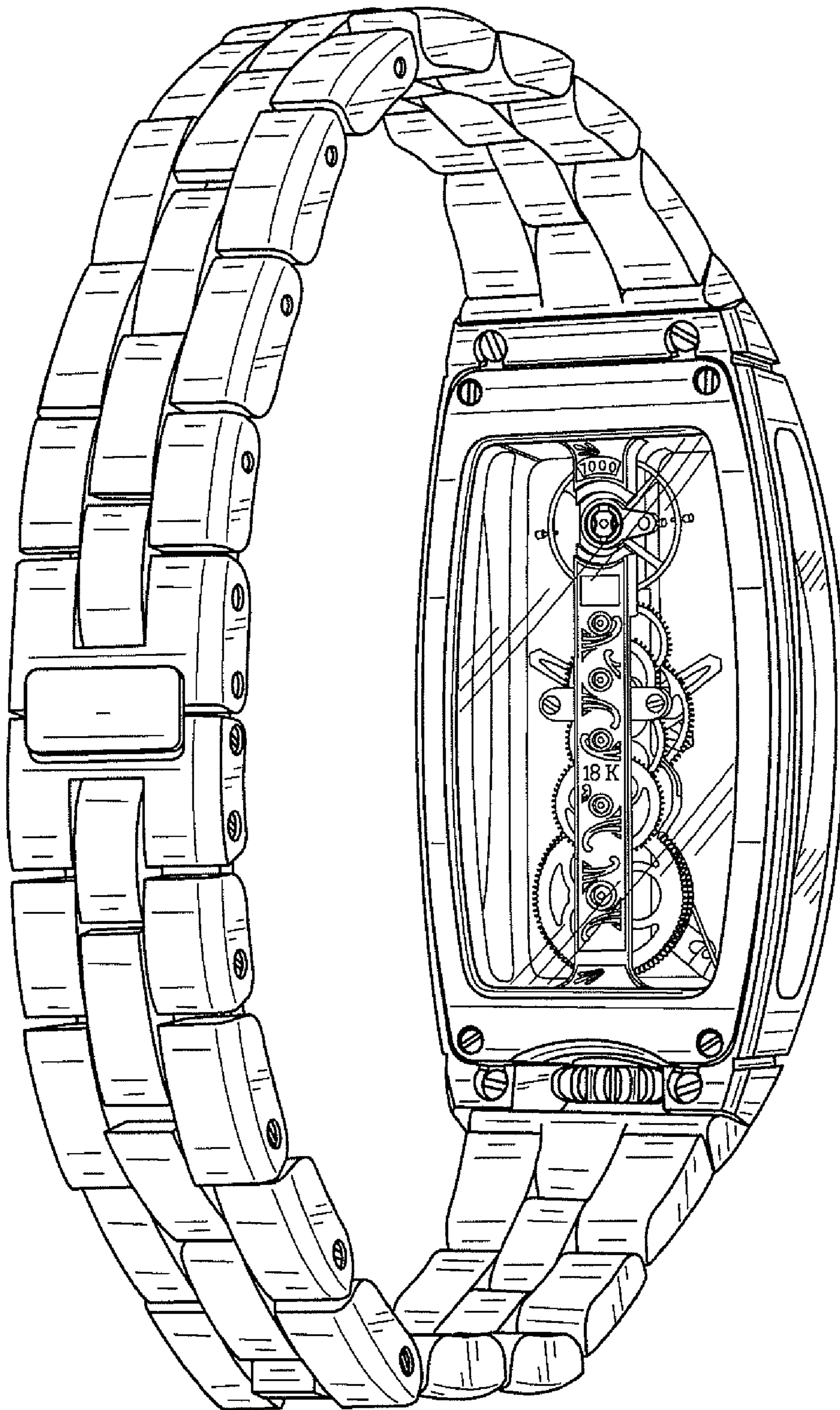
