(57) **CLAIM**

I claim the ornamental design for a silicone watch, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of the silicone watch showing my new design;  
 FIG. 2 is a rear elevation view thereof;  
 FIG. 3 is a left side view thereof;  
 FIG. 4 is a right side view thereof;  
 FIG. 5 is a top view thereof;  
 FIG. 6 is a bottom view thereof;  
 FIG. 7 is a perspective view thereof  
 FIG. 8 is a cross section taken along lines 8-8 of FIG. 3; and,  
 FIG. 9 is a cross section taken along lines 9-9 of FIG. 4.  
 The broken lines depicting part of a silicone watch in FIGS. 8 and 9 are keys for retaining a watch movement and are for illustrative purposes only and form no part of the claimed design.

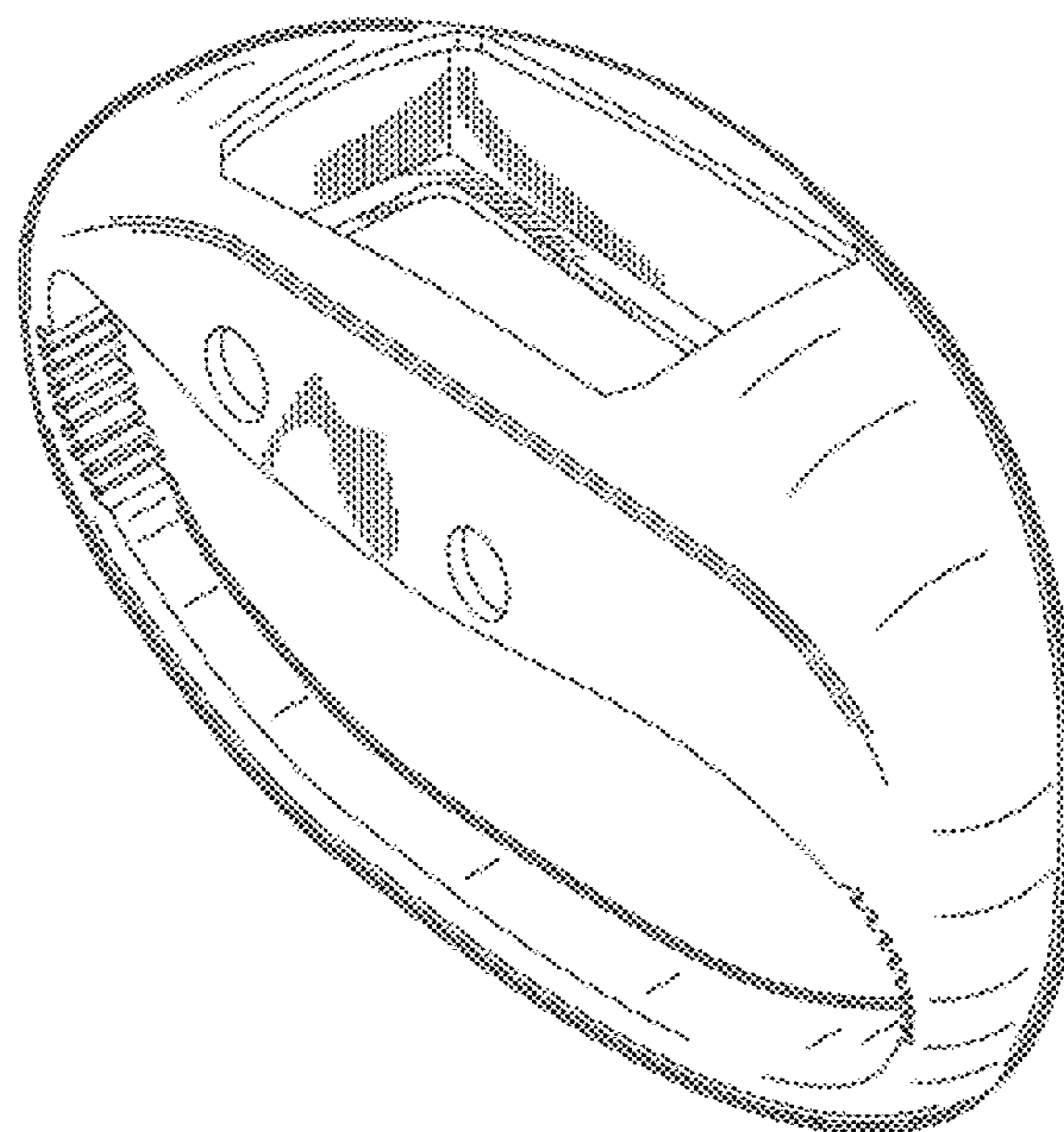

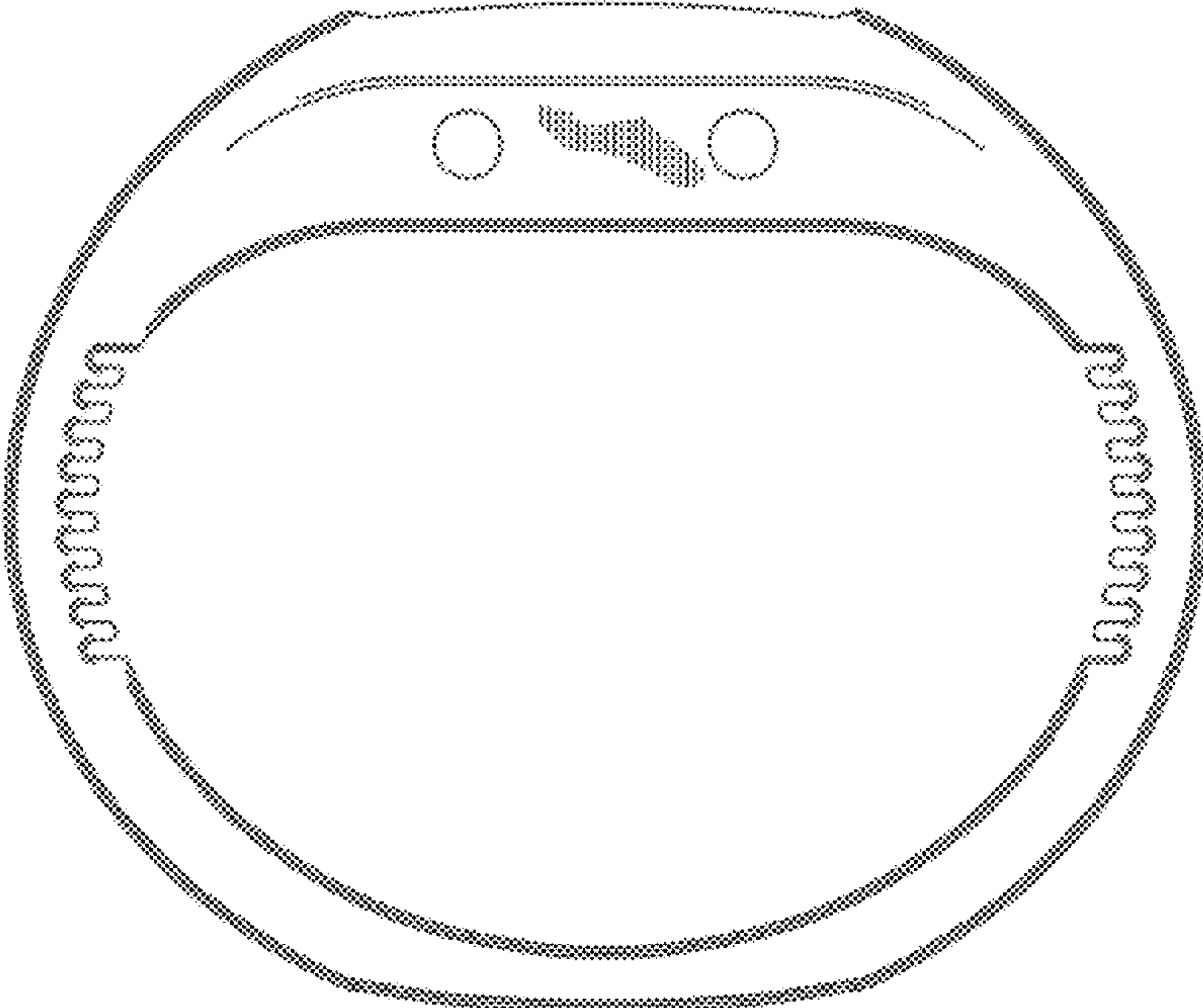

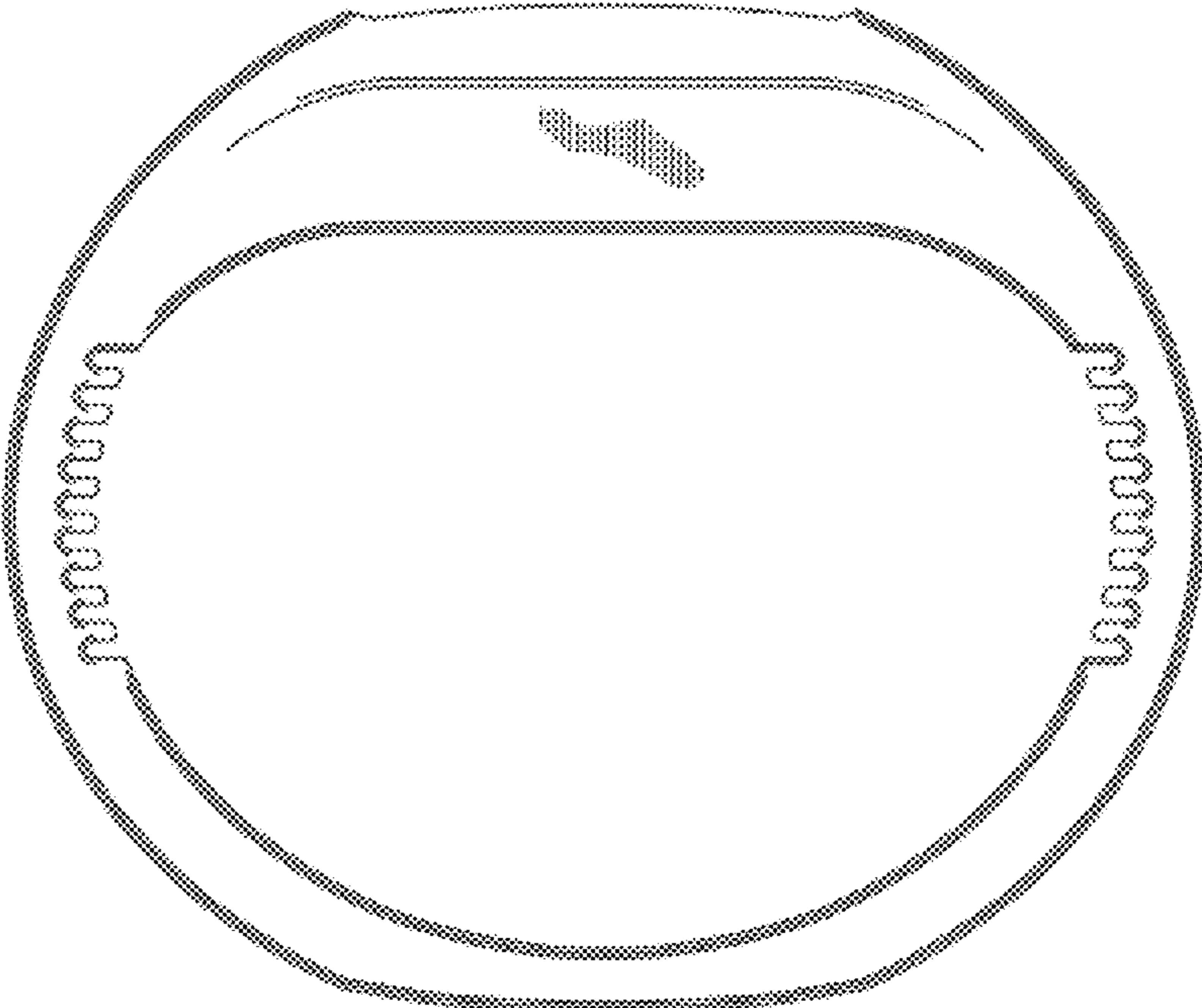

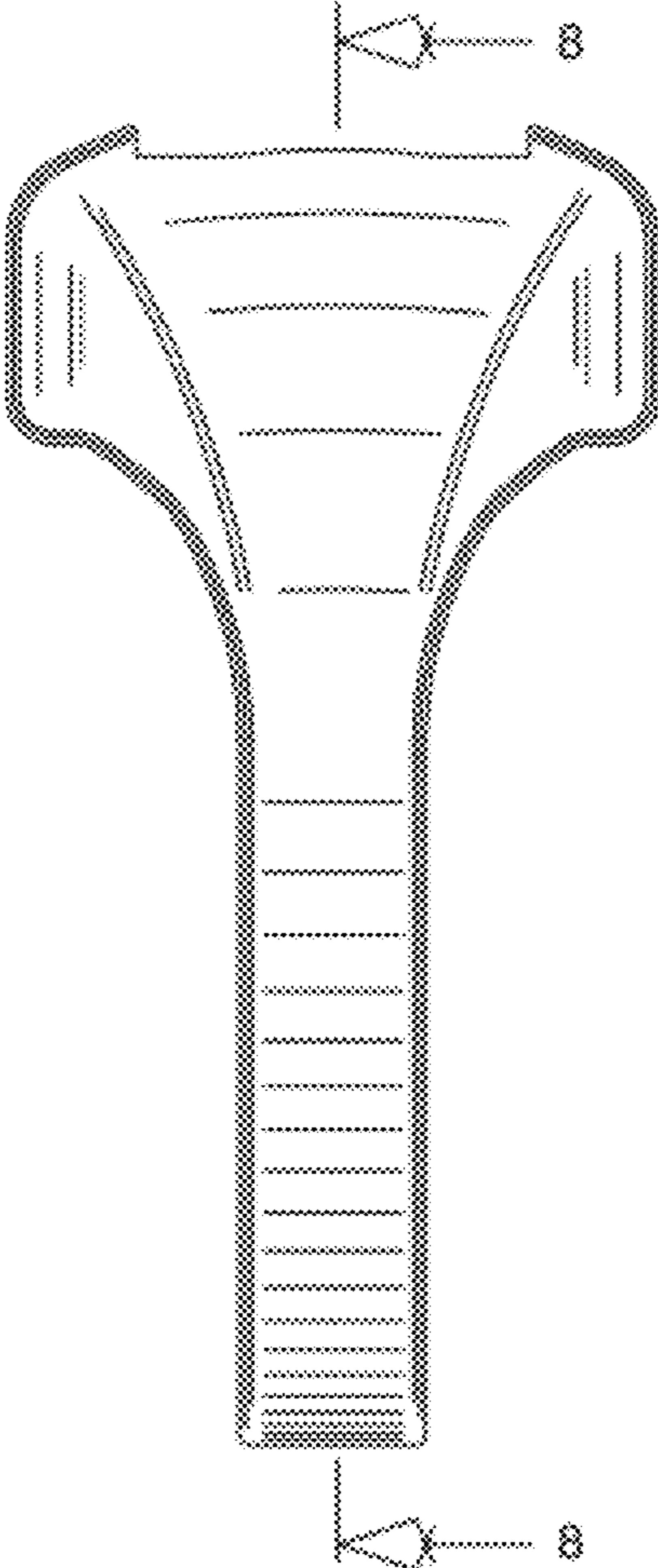

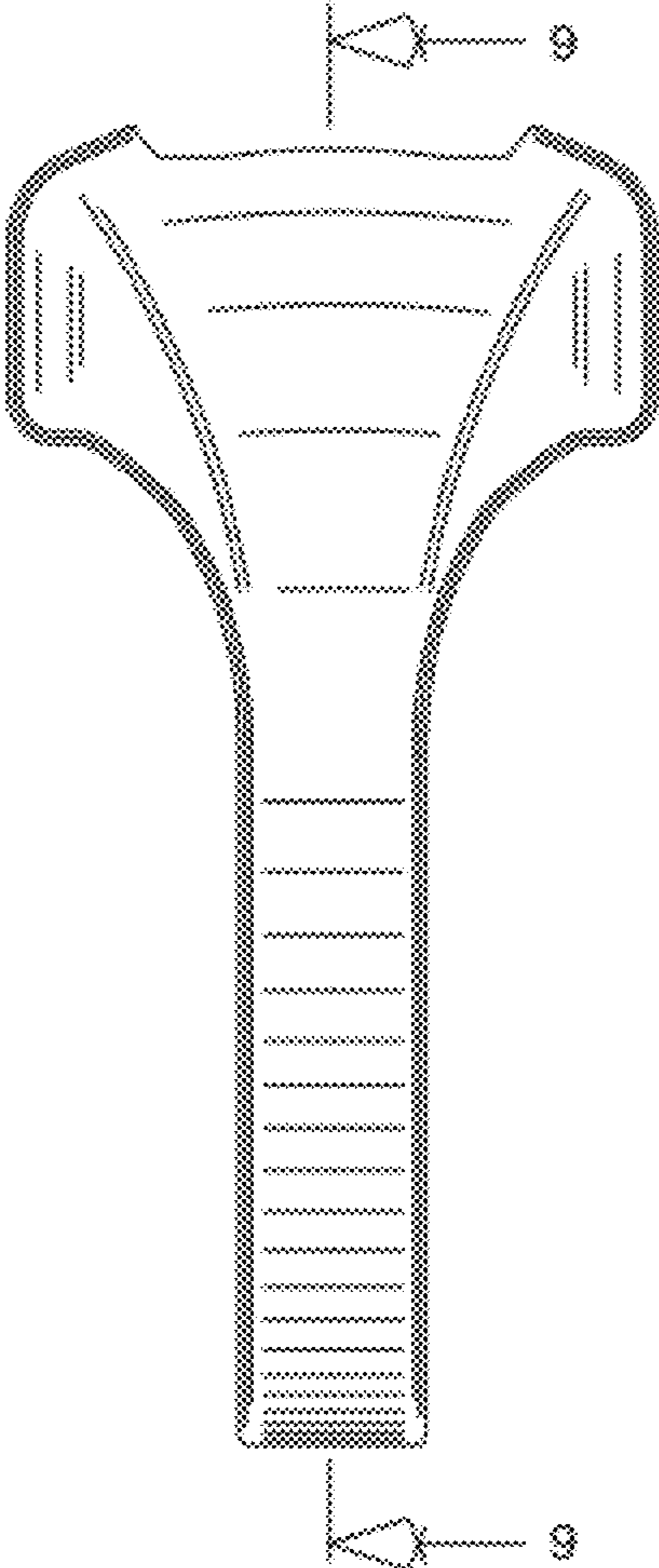

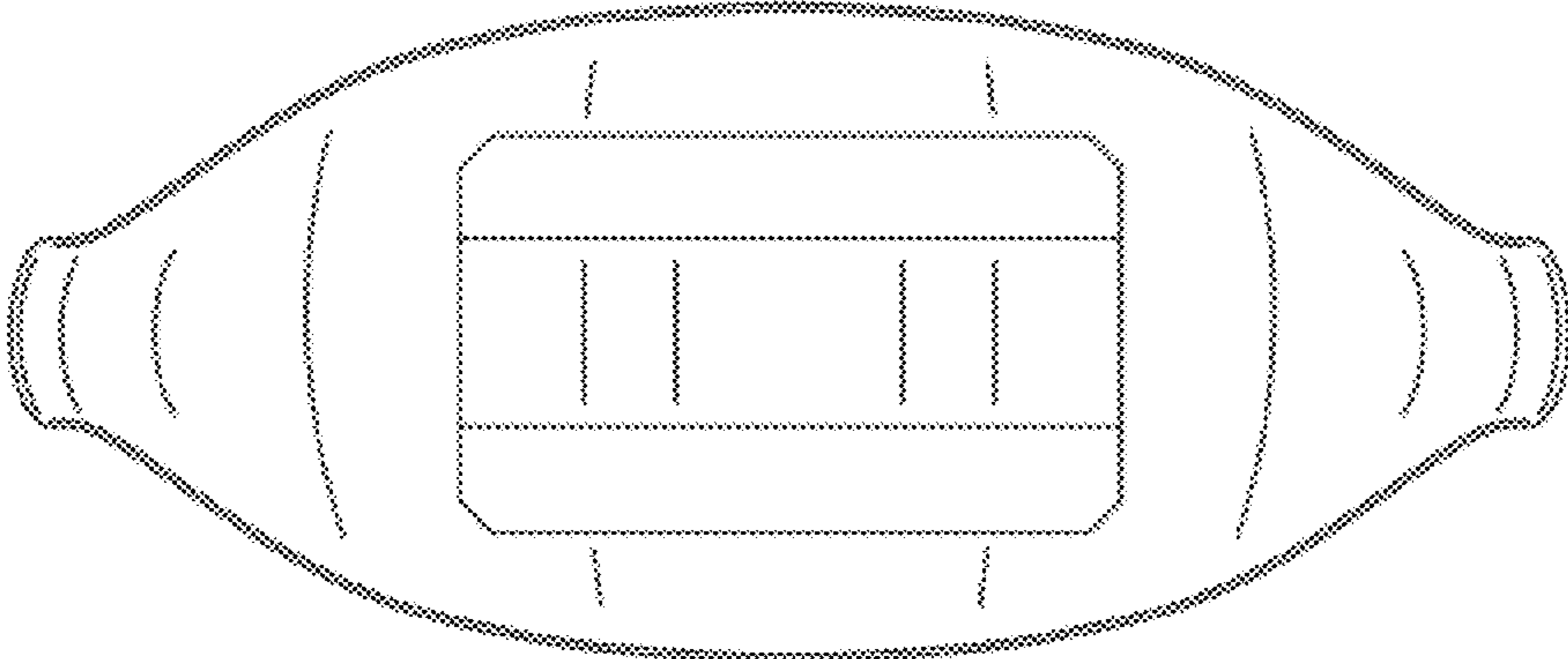

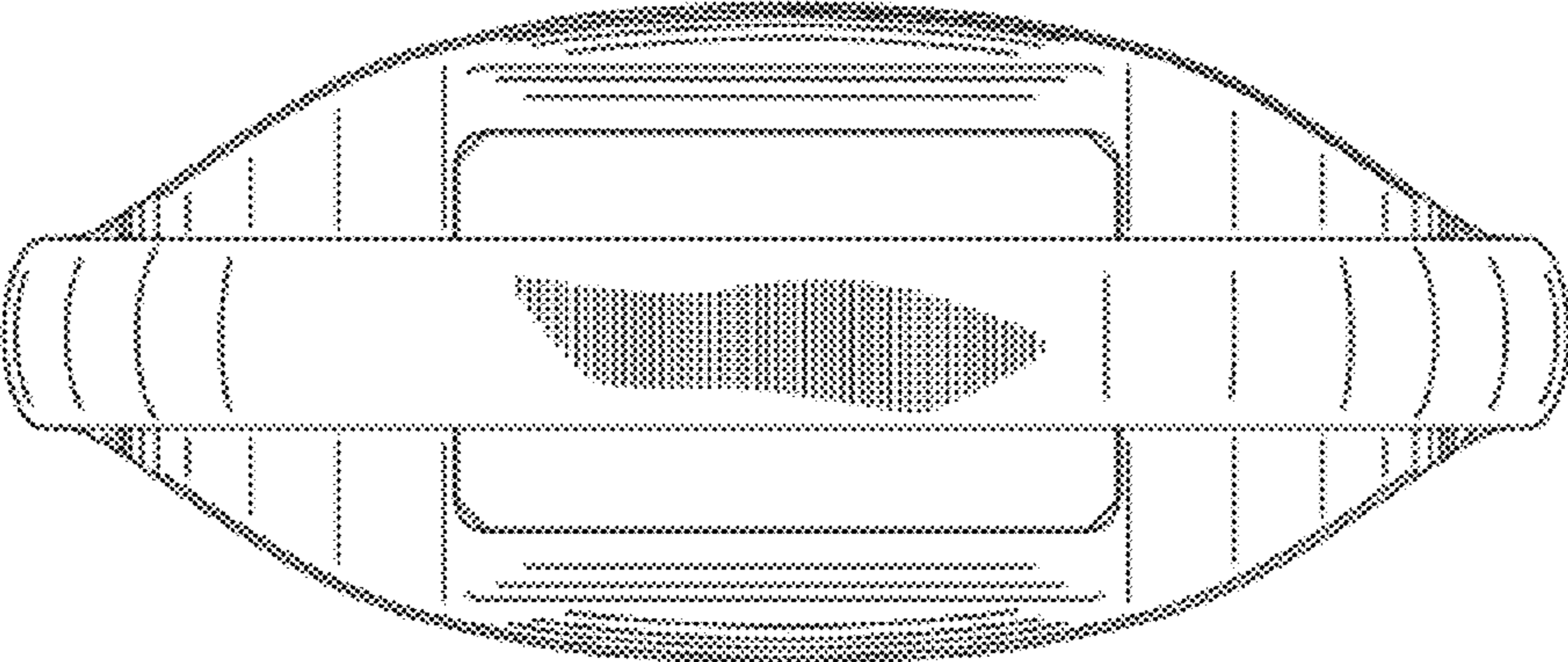

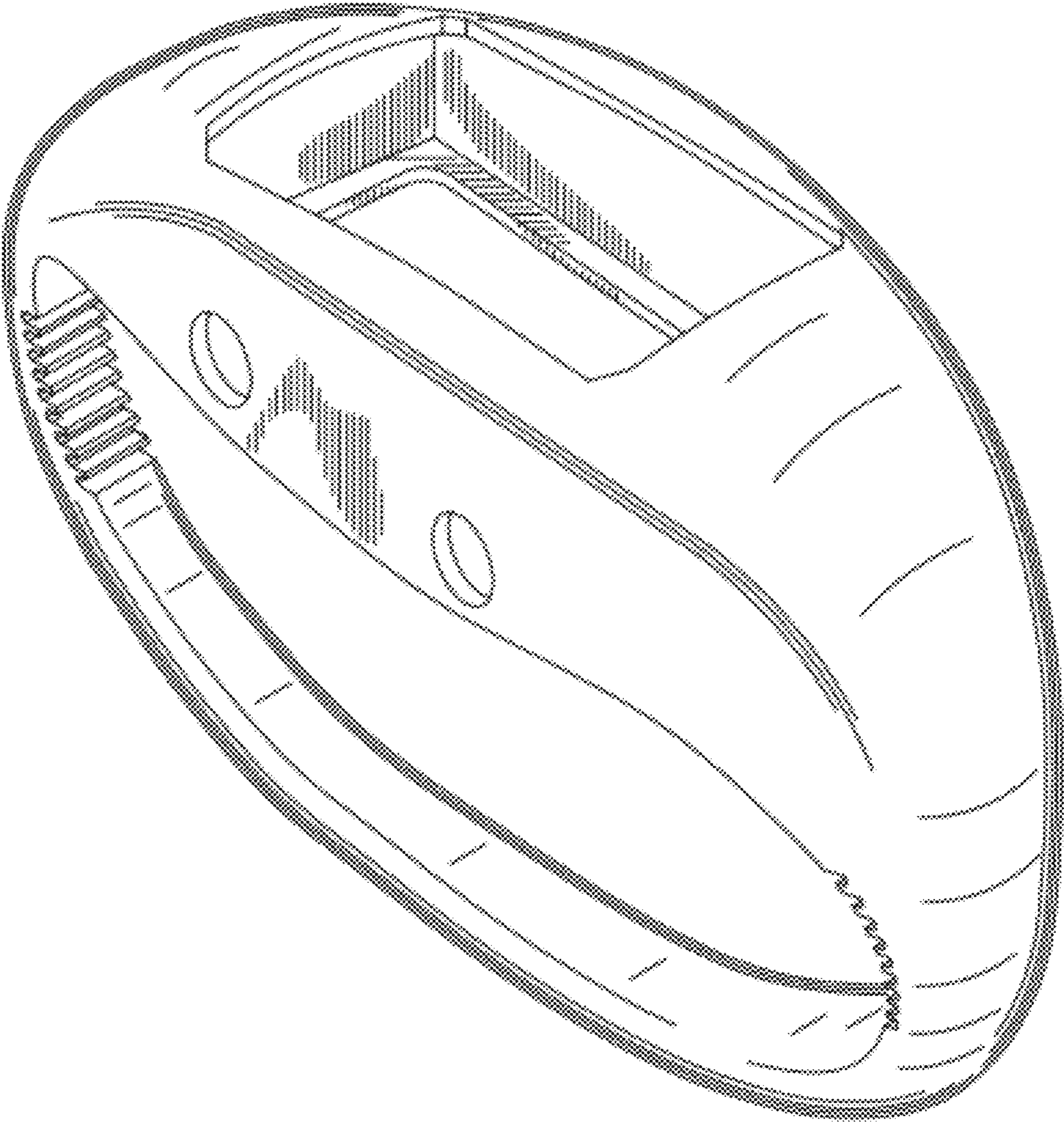

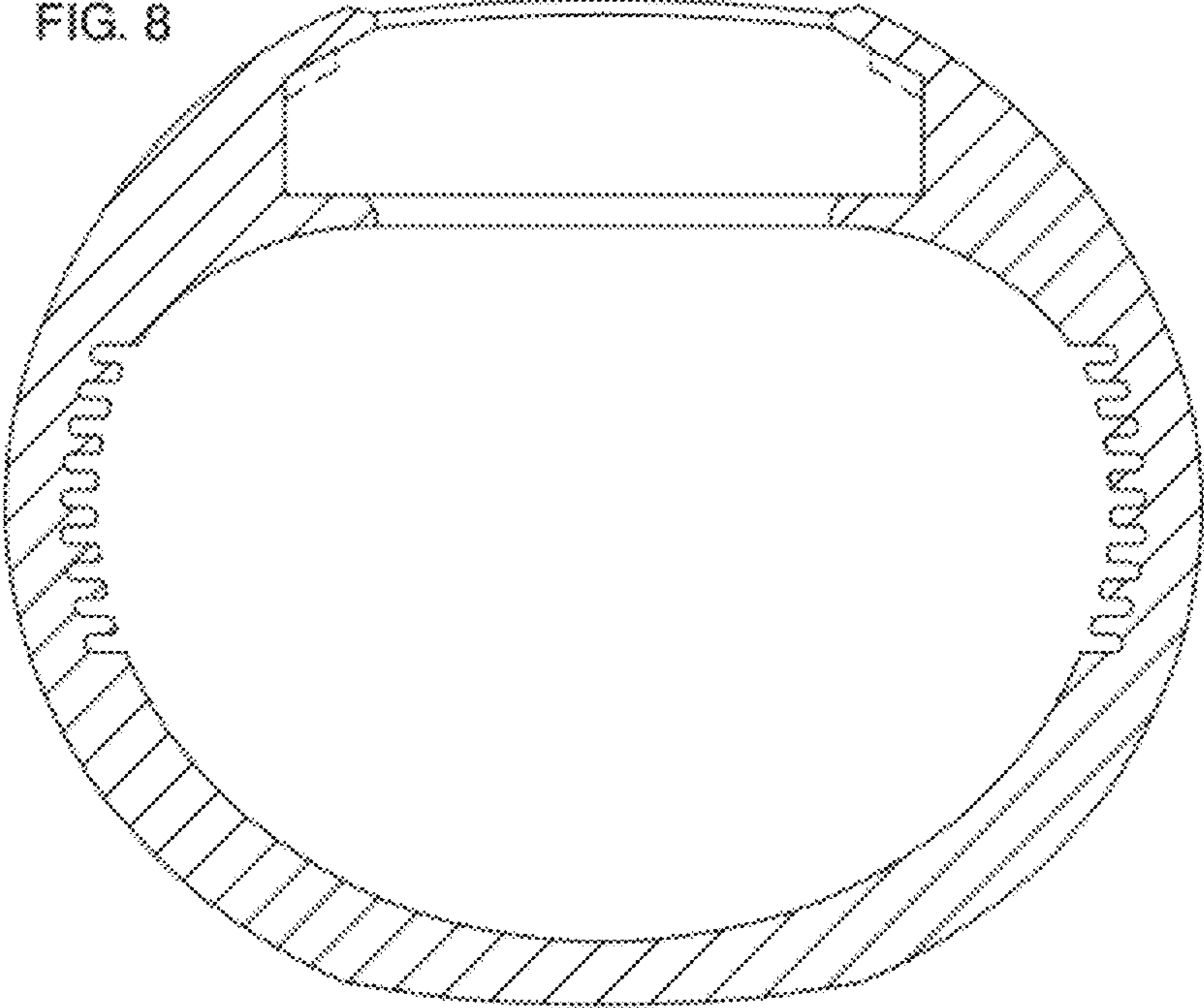
