(57) **CLAIM**

The ornamental design for a motorcycle body, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevation view our motorcycle body shown mounted on a motorcycle frame, the motorcycle wheels and frame in broken lines, showing our new design; FIG. 2 is a left side elevation view of the motorcycle body of FIG. 1;

FIG. 3 is a front elevation view of the motorcycle body of FIG. 1;

FIG. 4 is a rear elevation view of the motorcycle body of FIG. 1;

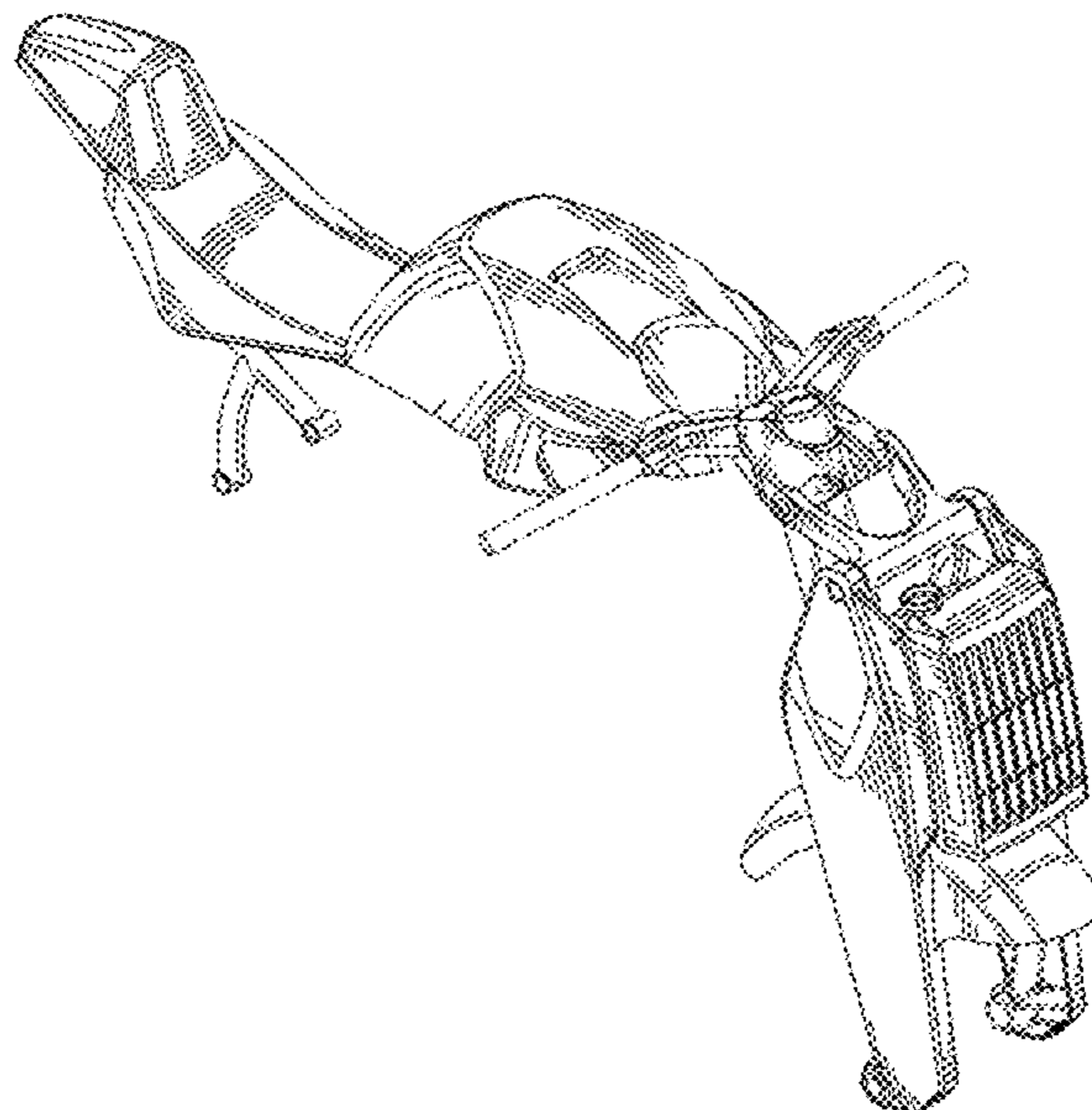
FIG. 5 is a top plan view of the motorcycle body of FIG. 1;

FIG. 6 is a bottom plan view of the motorcycle body of FIG. 1; and,

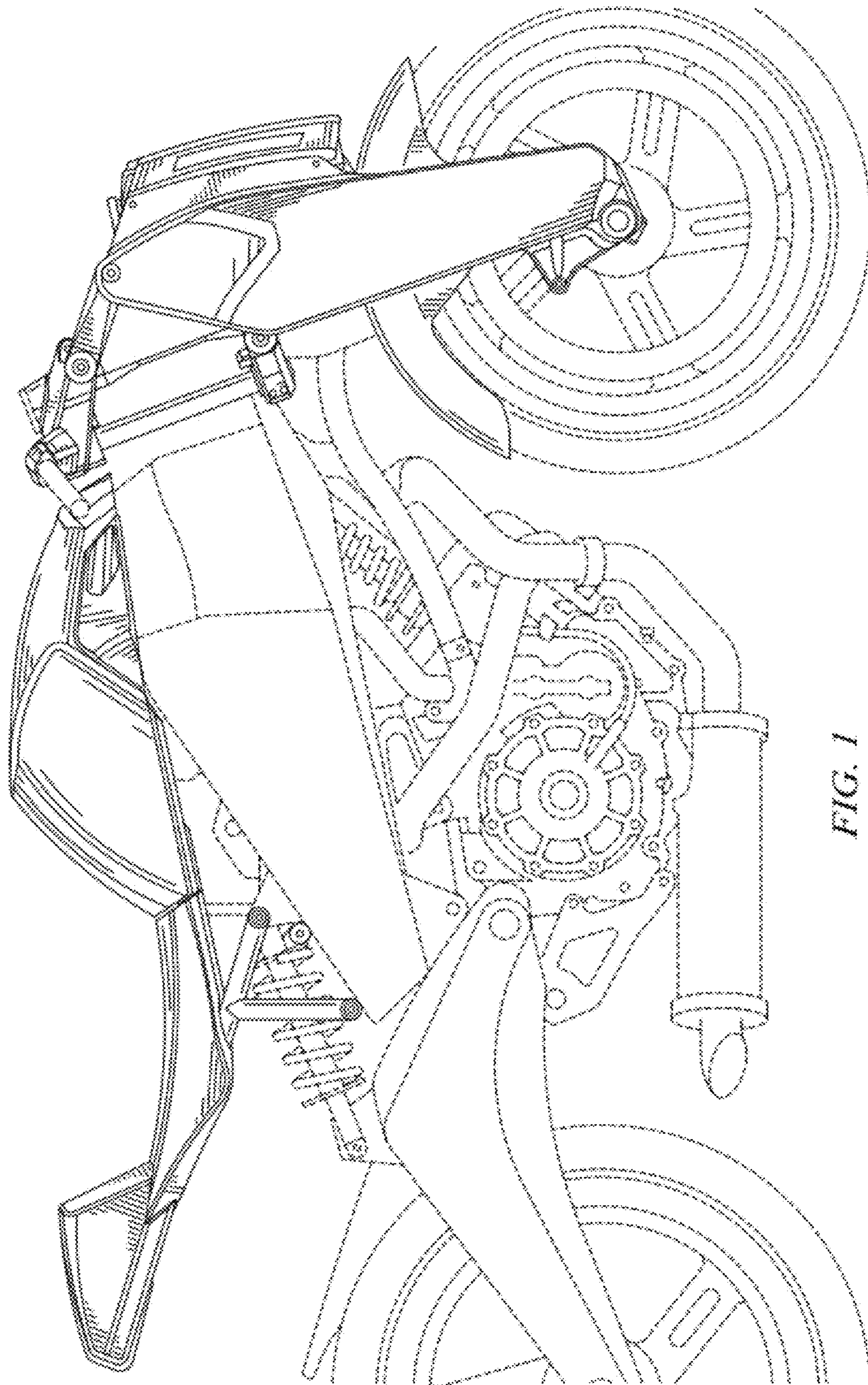

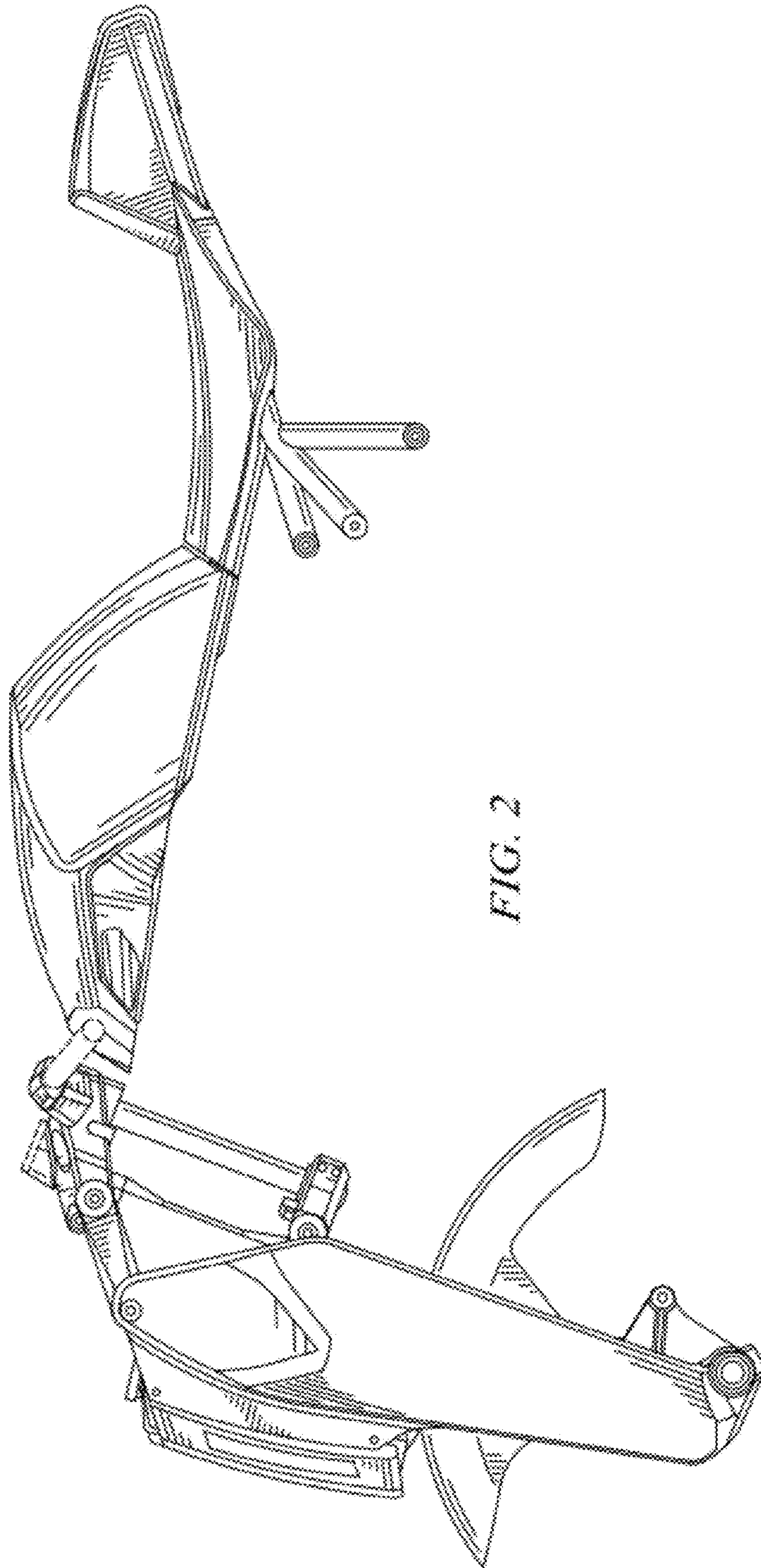

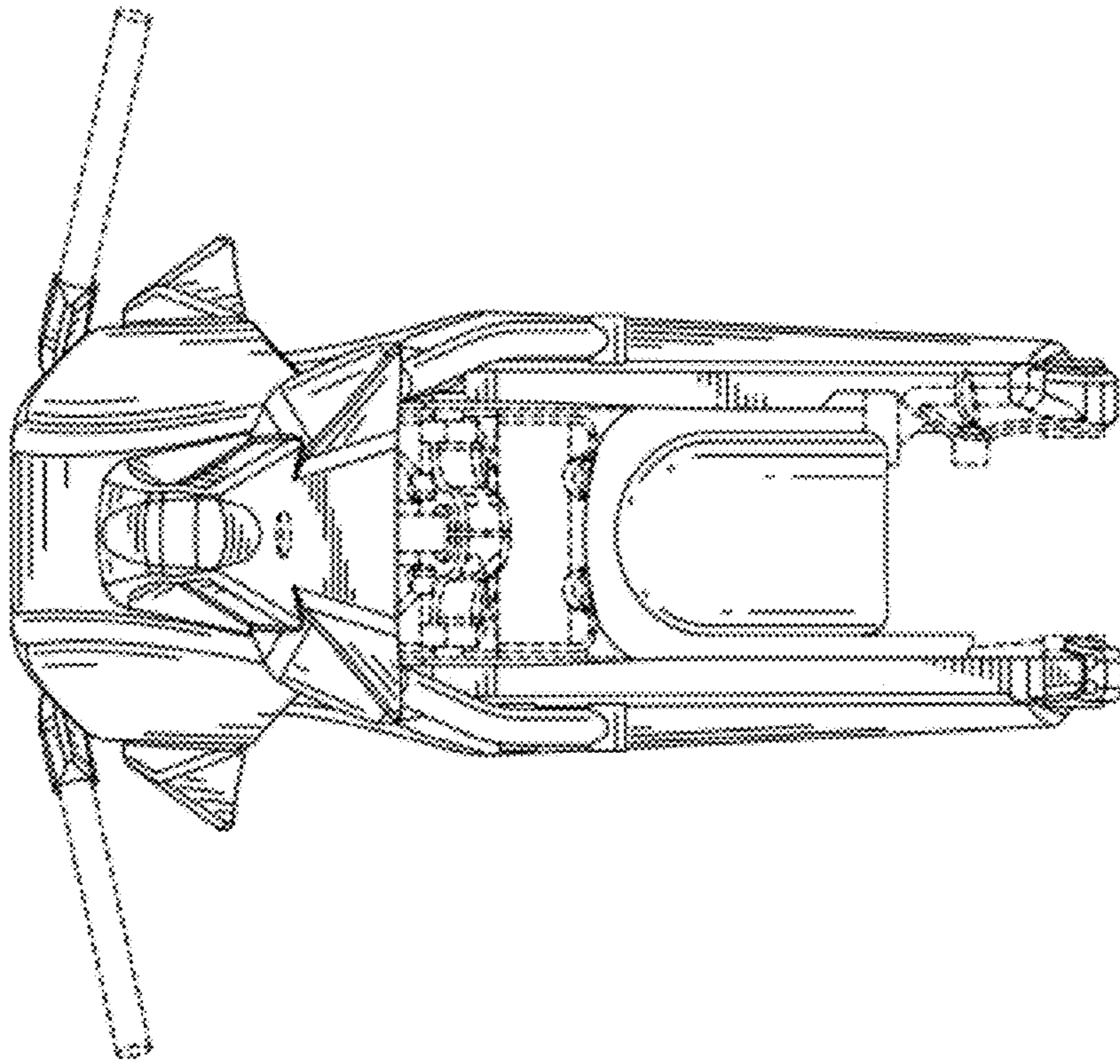

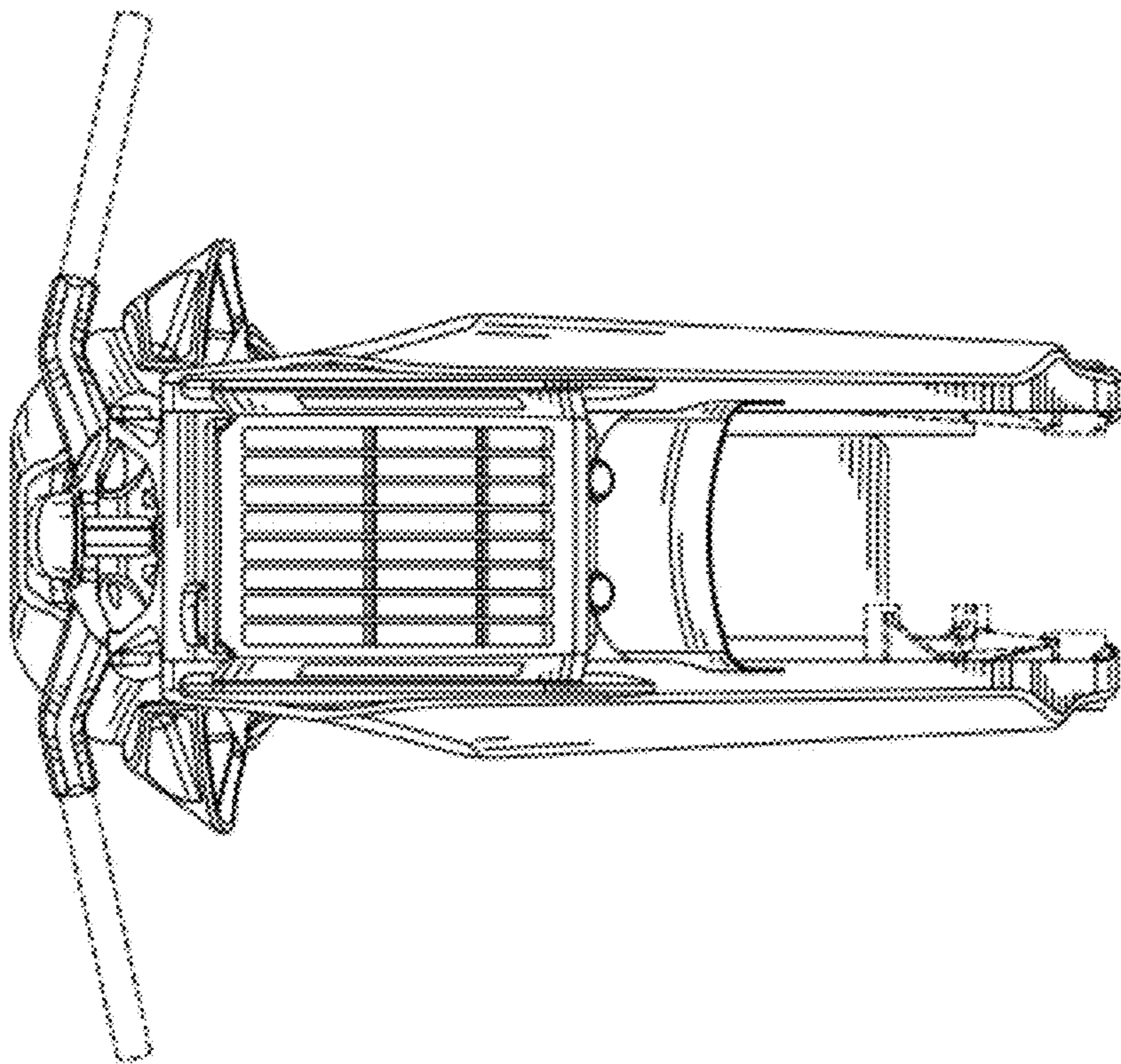

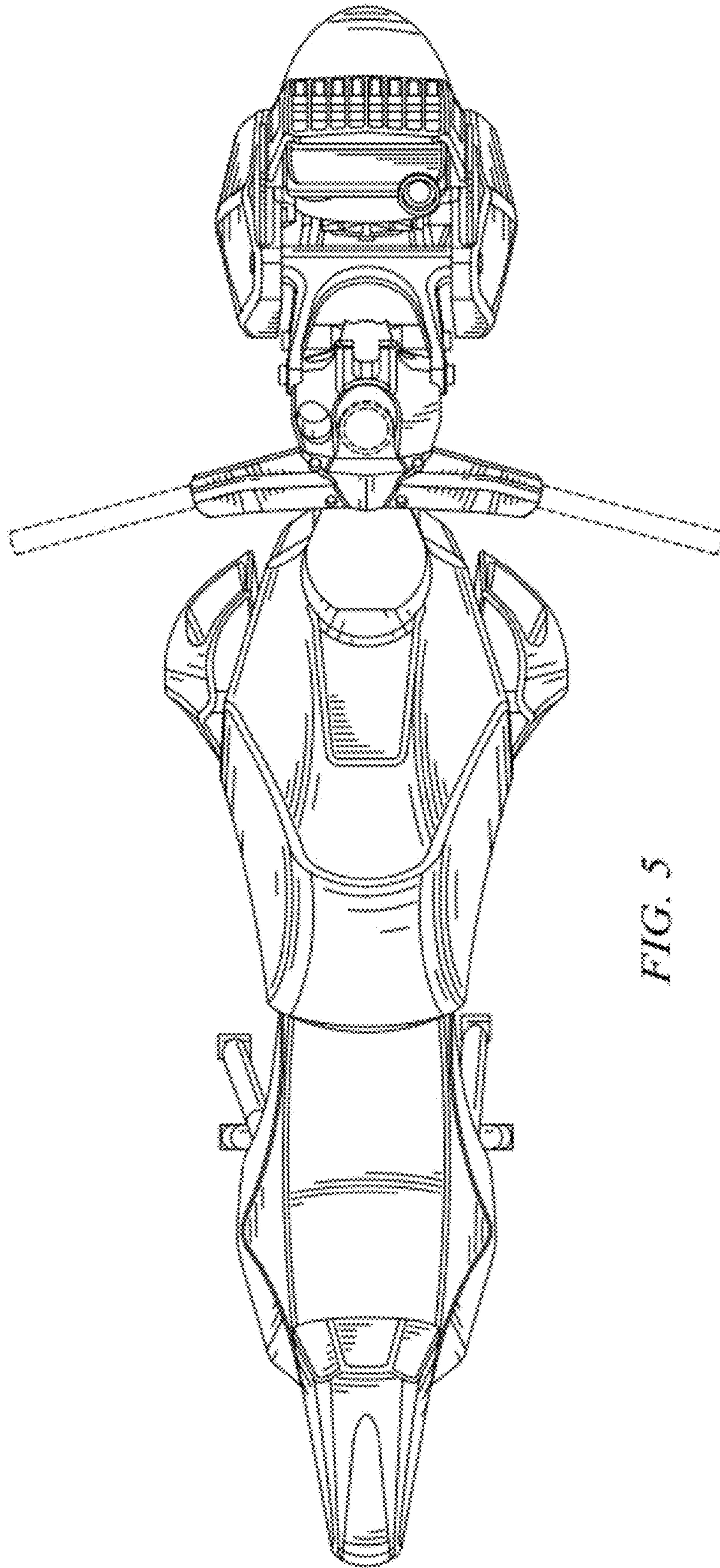

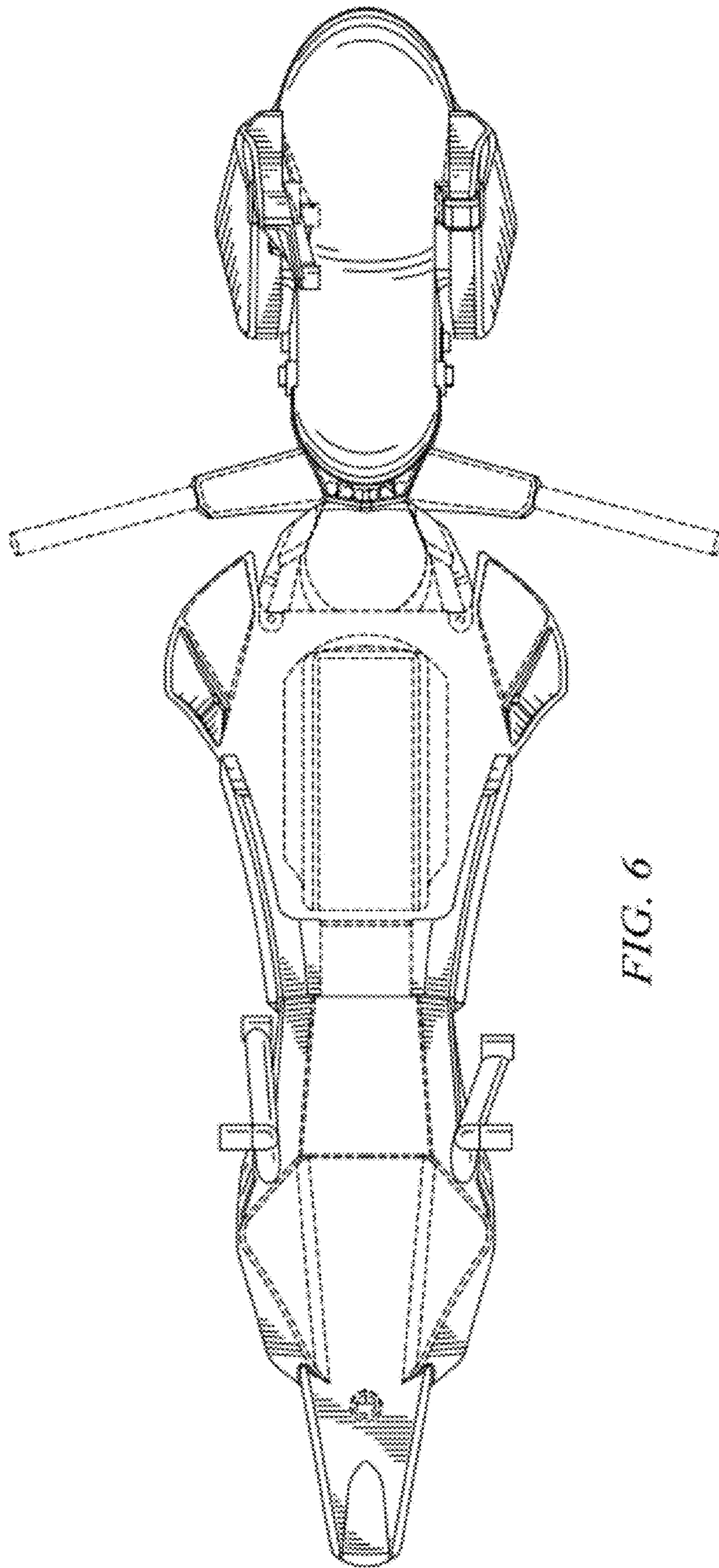

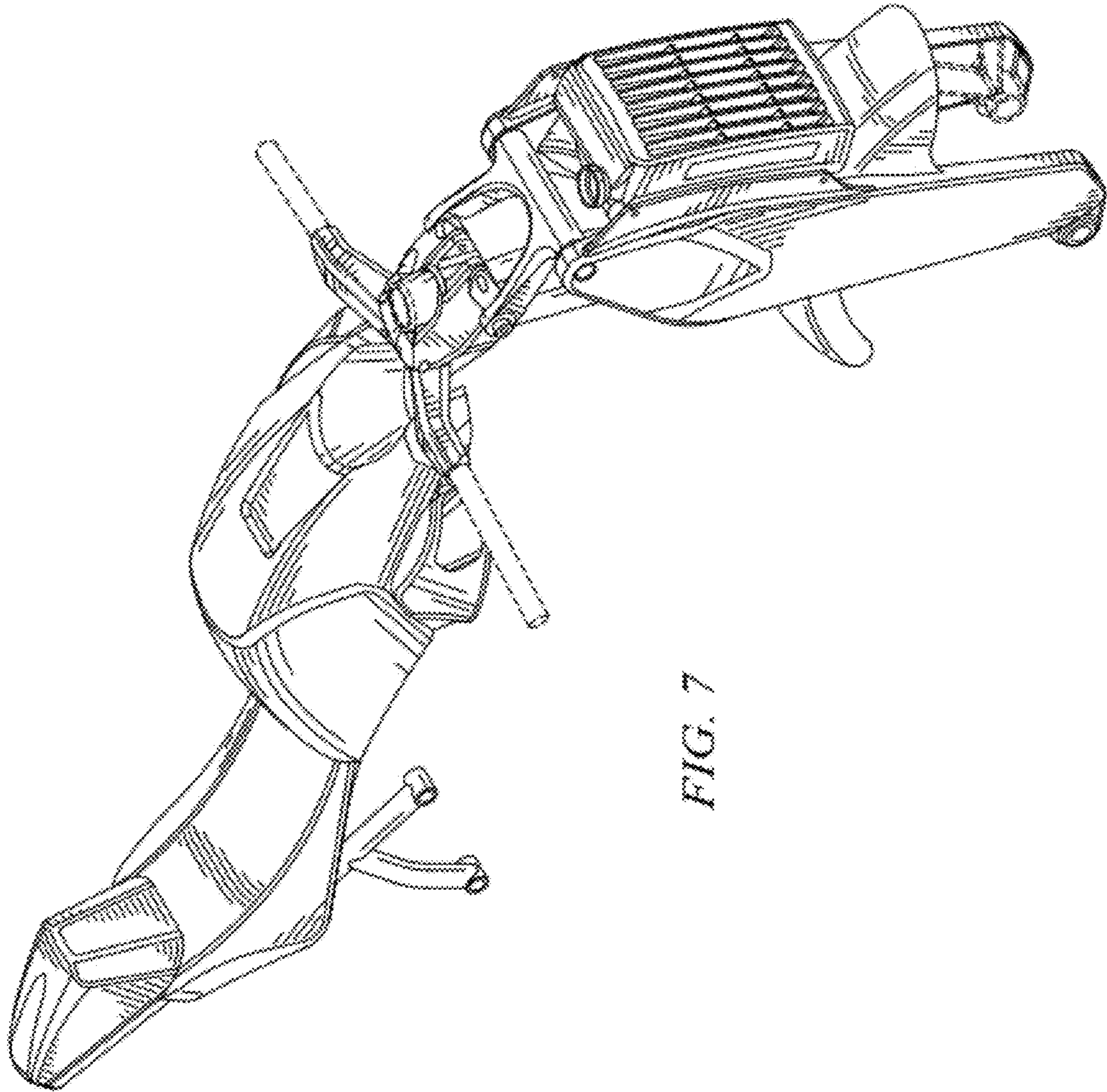
