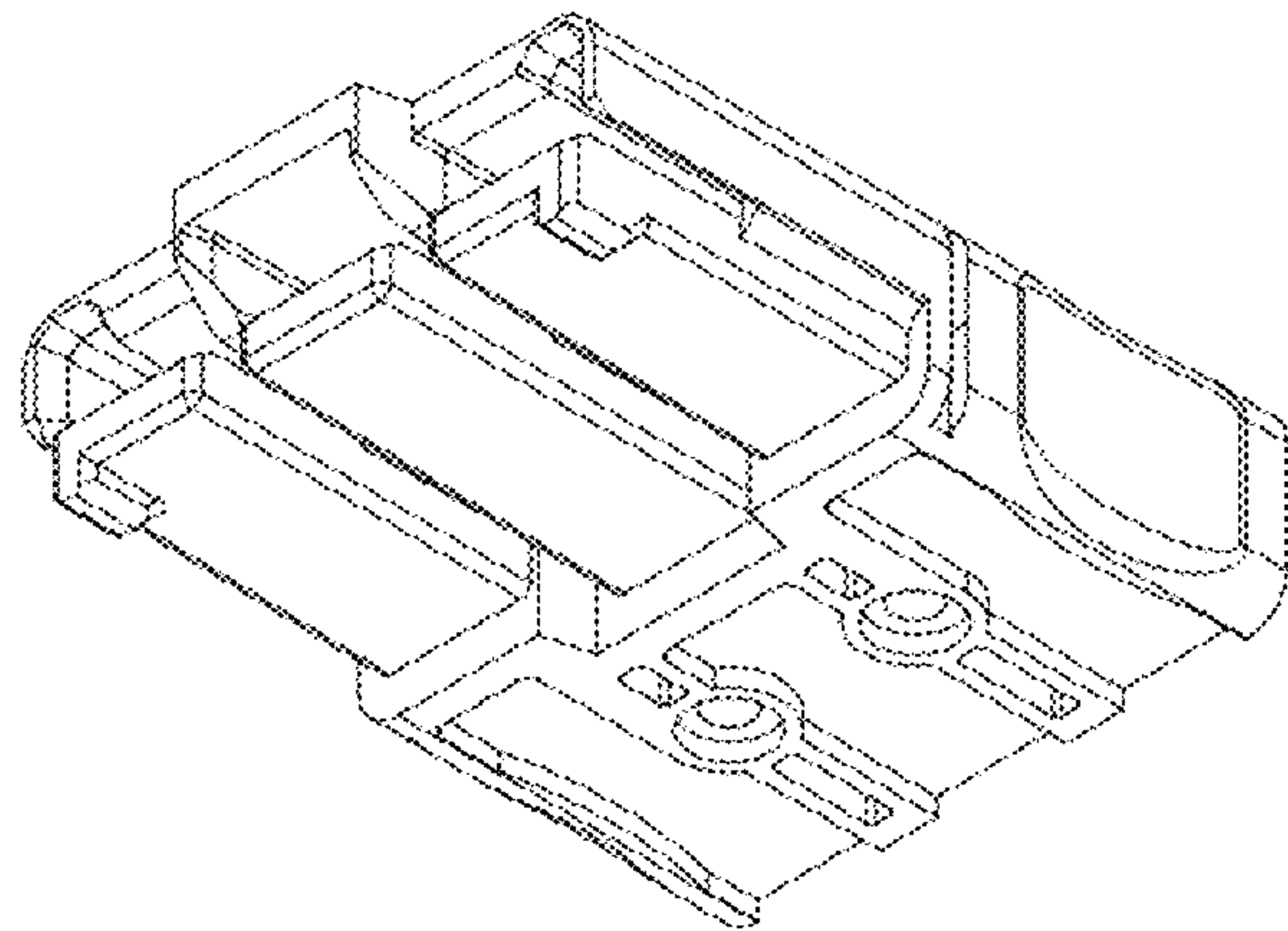
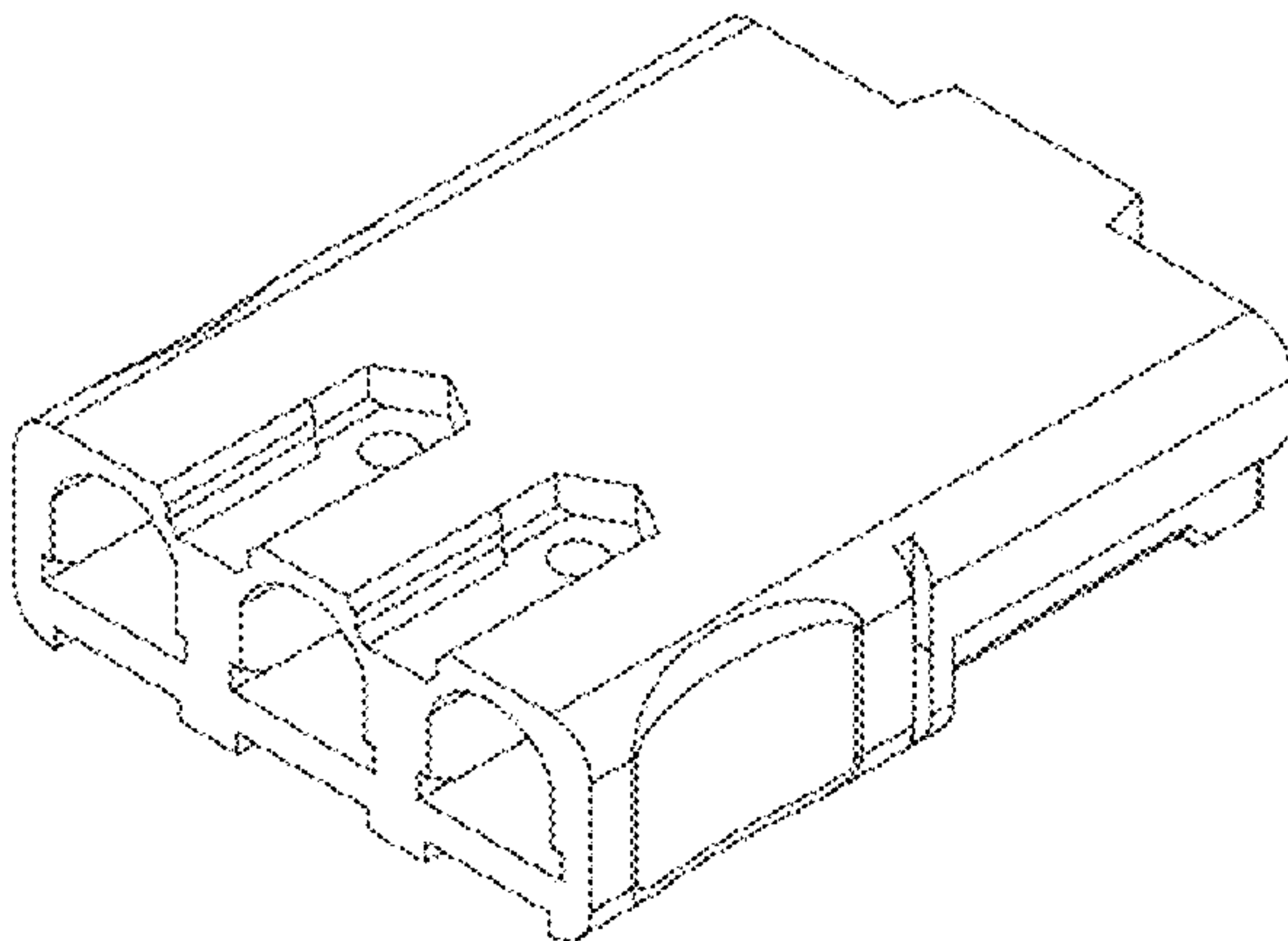
The ornamental design for a polarized 3 pole electrical connector with protective ground, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a polarized 3 pole electrical connector with protective ground showing my new design; FIG. 2 is a back elevation view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a left side elevation view thereof; FIG. 7 is a back, top and left side perspective view thereof; and, FIG. 8 is a front, bottom and right side perspective view thereof.

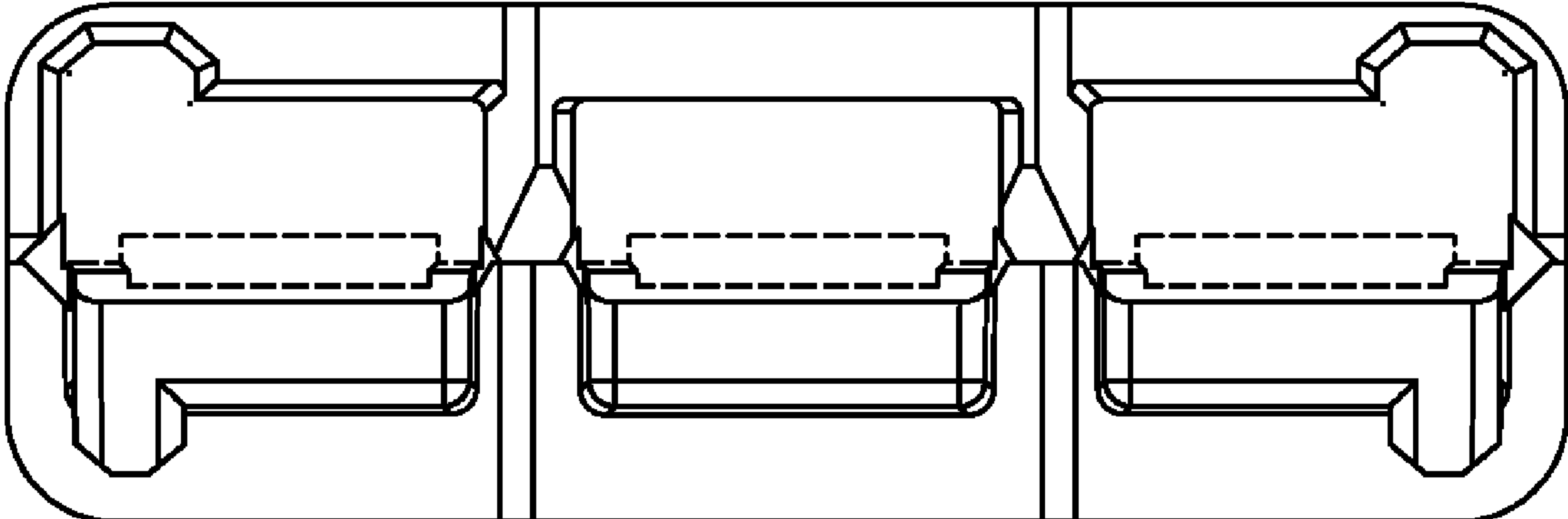

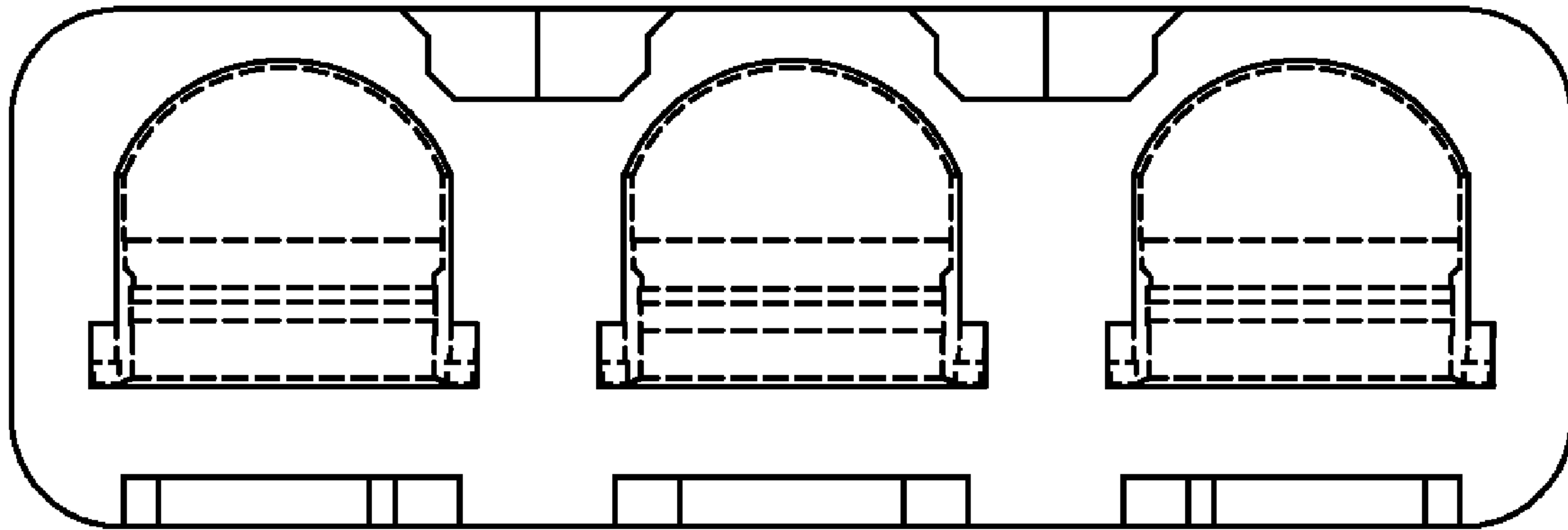

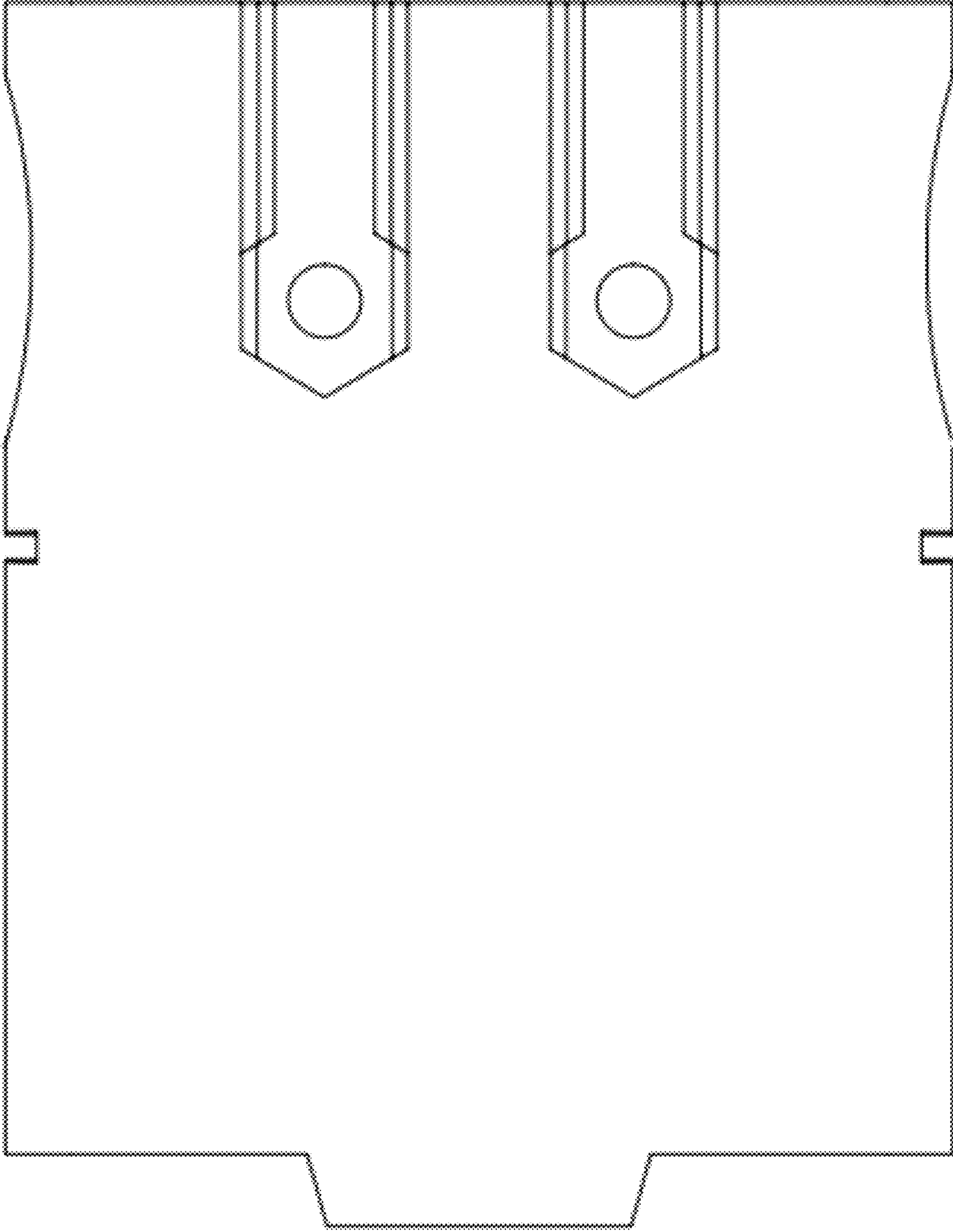

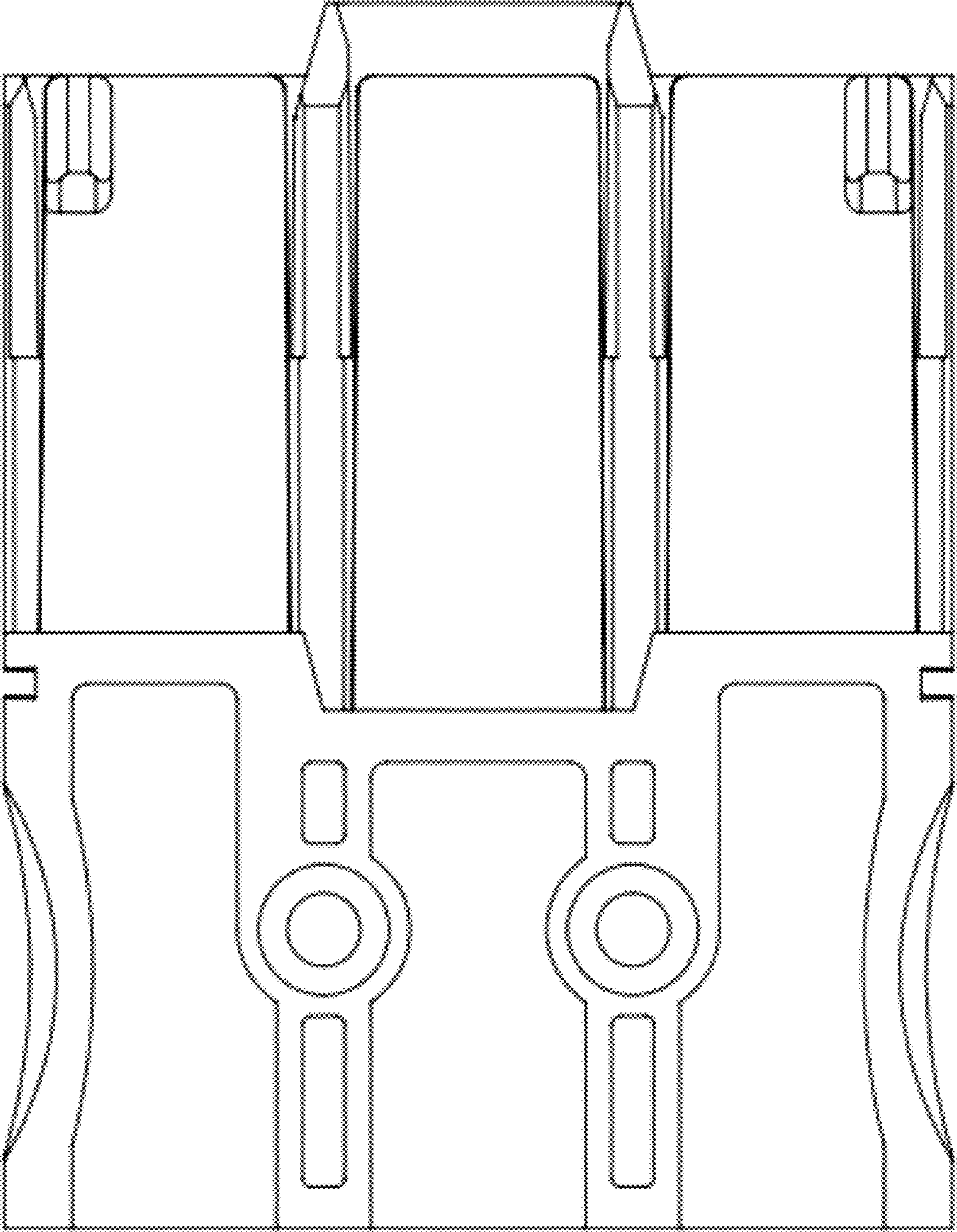

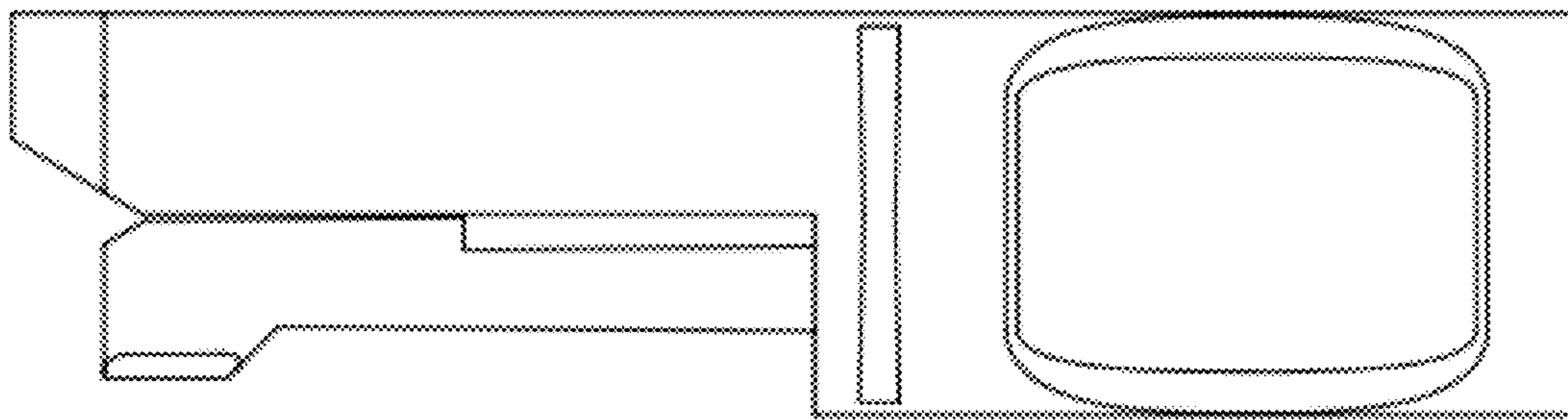

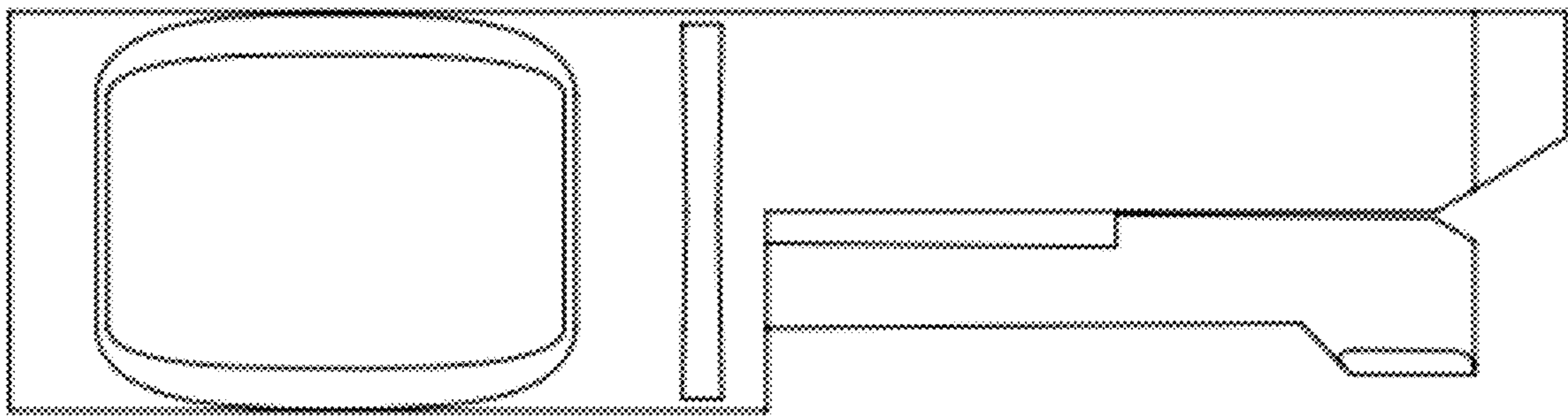

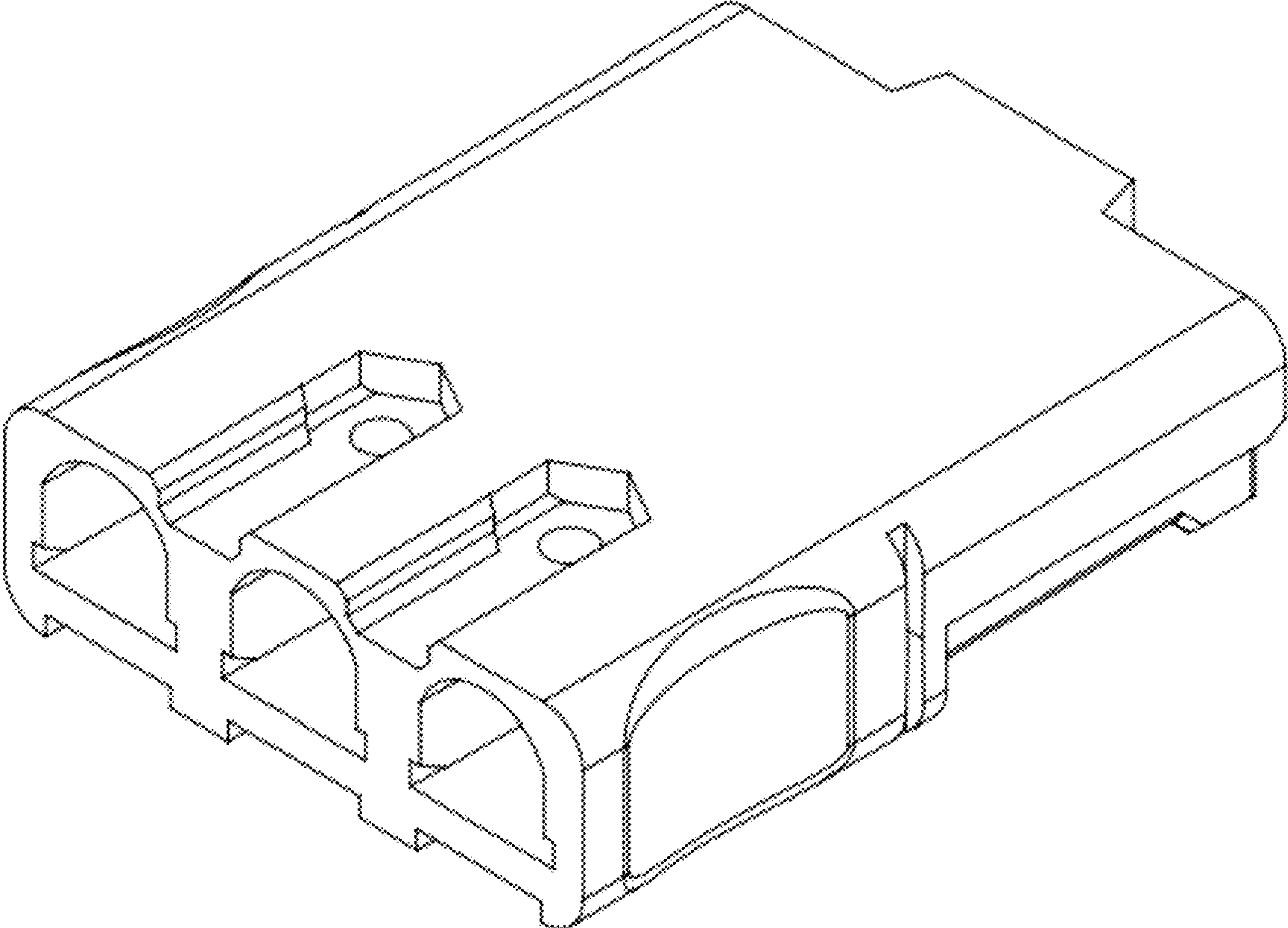

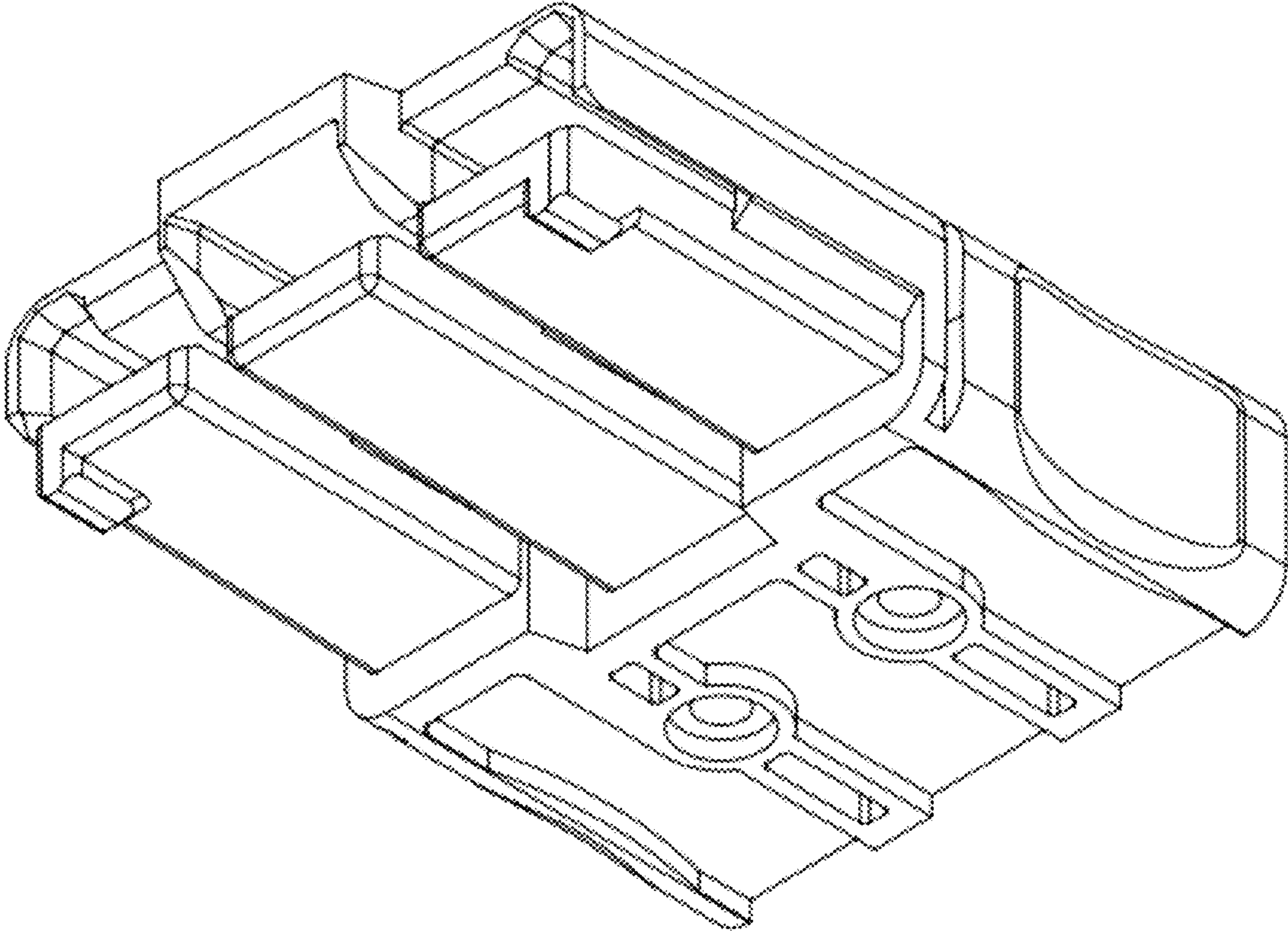
