FIG. 21 is a right side elevational view of FIG. 17;

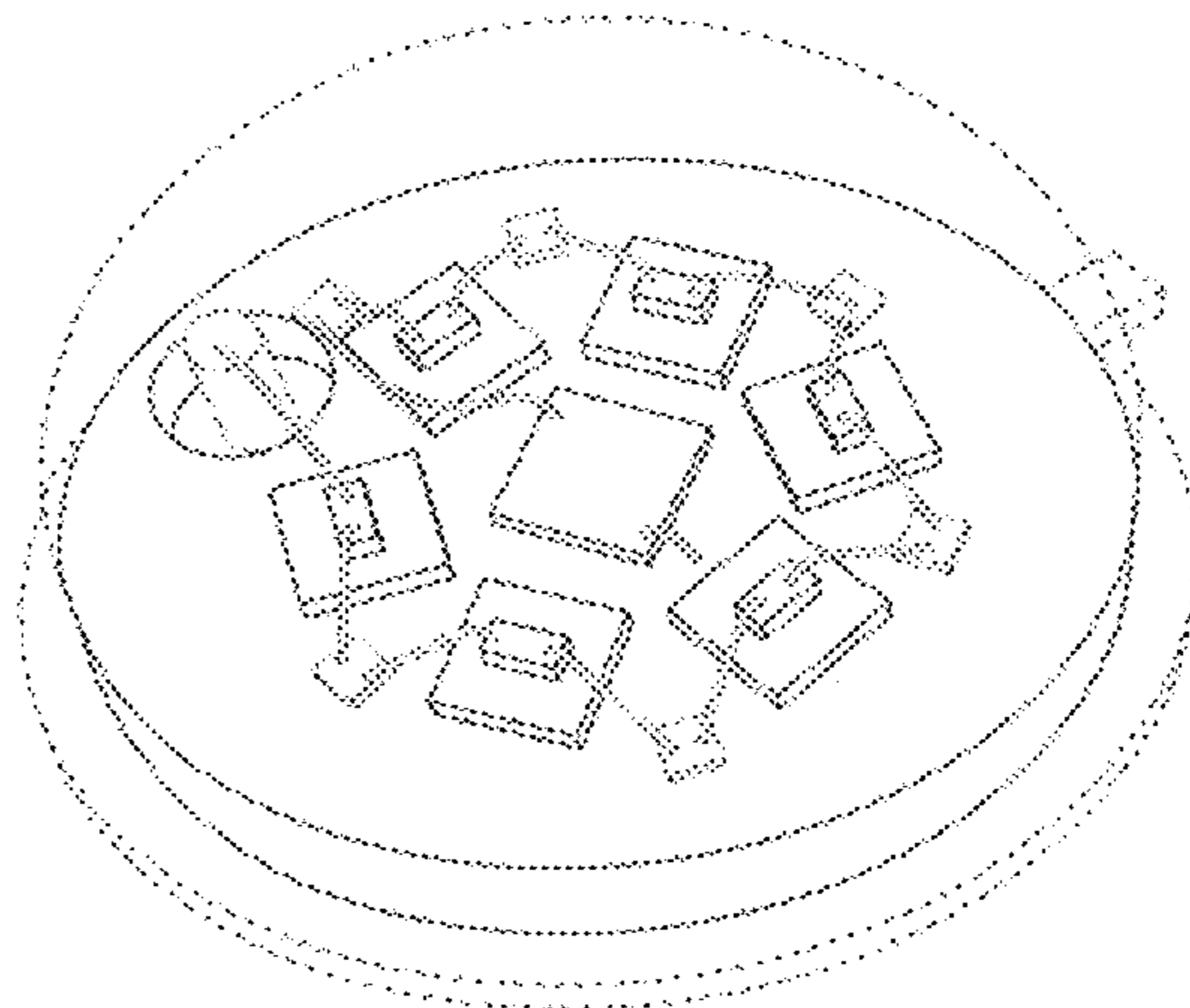
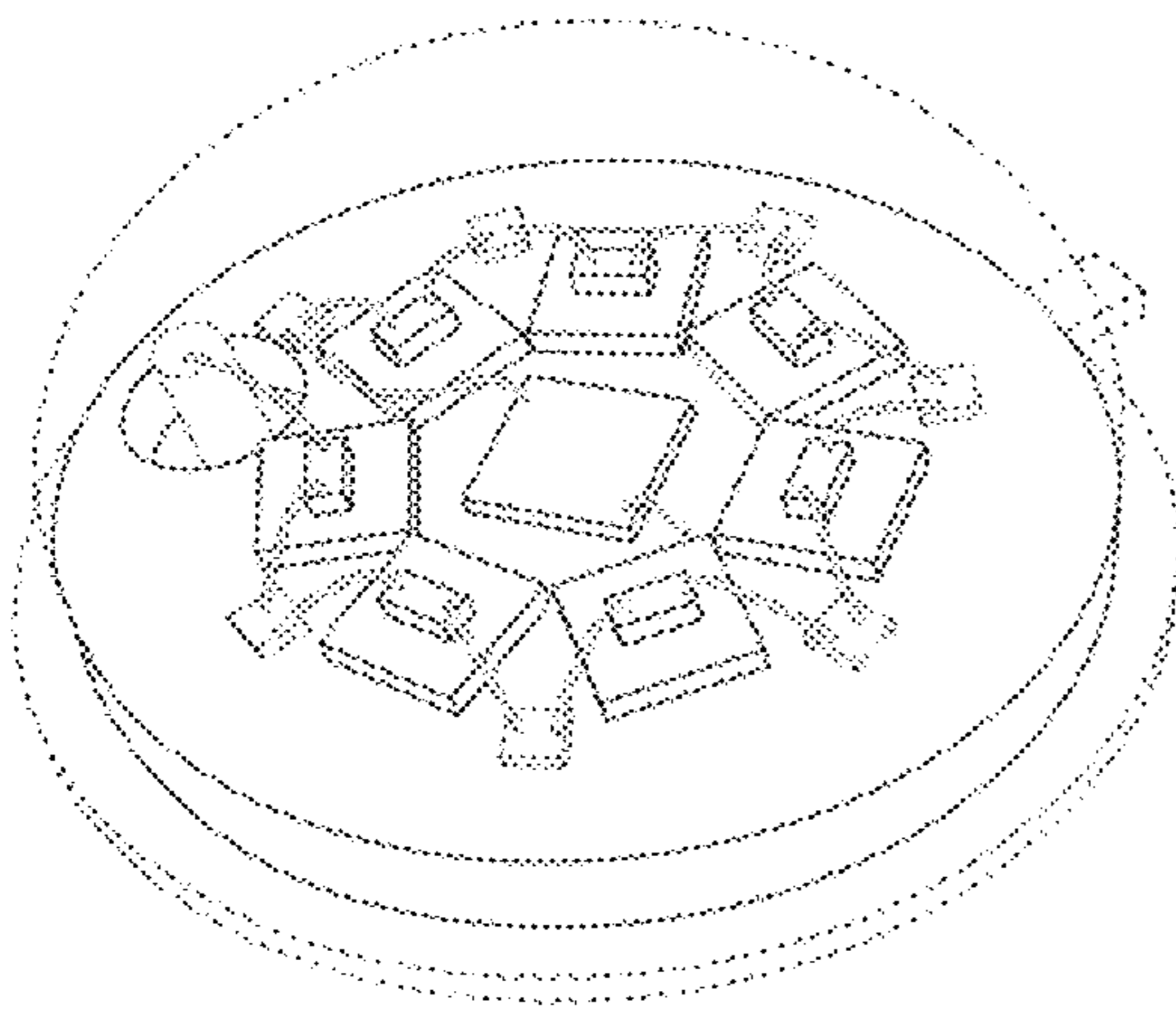
FIG. 22 is a top plan view of FIG. 17;

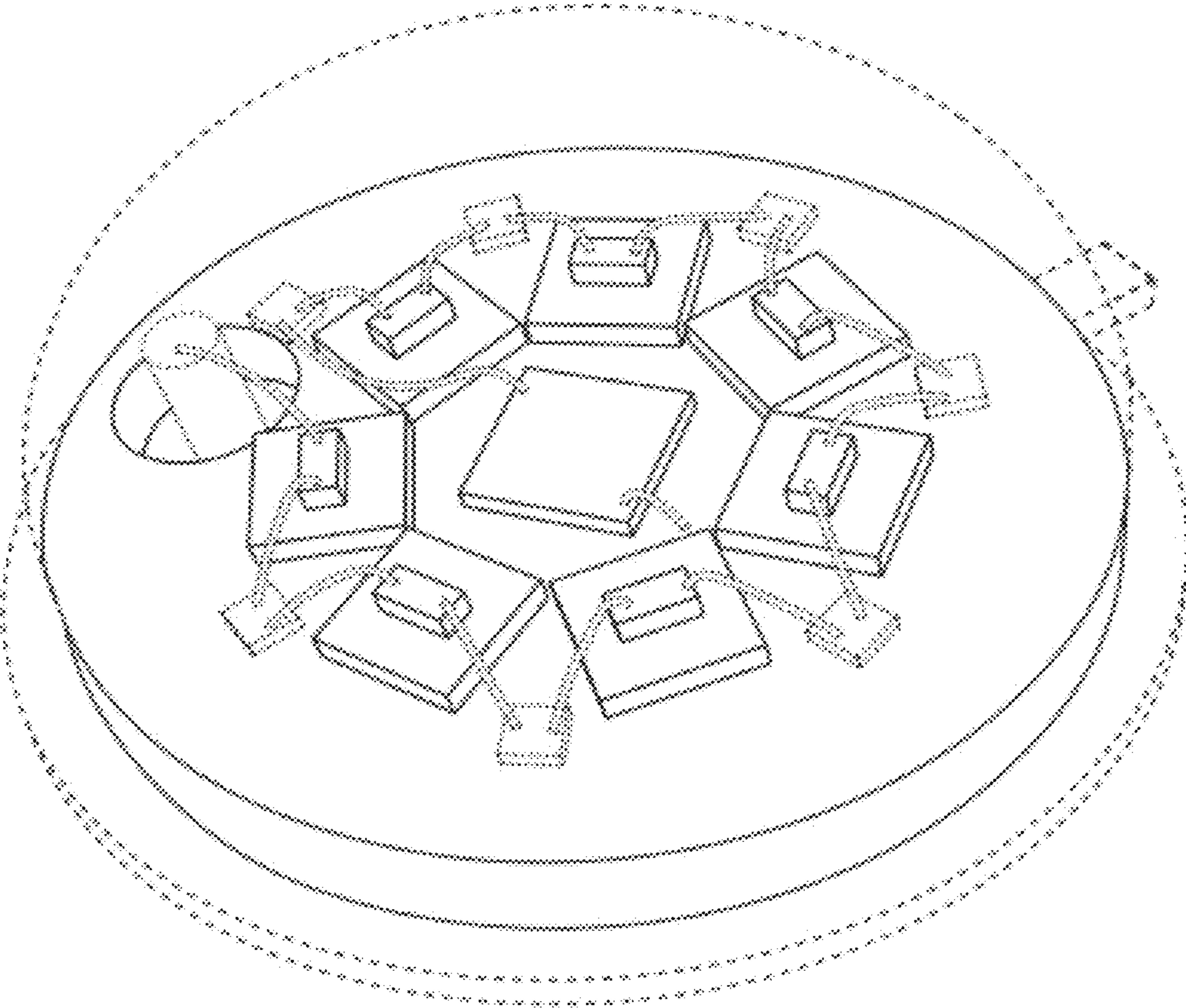

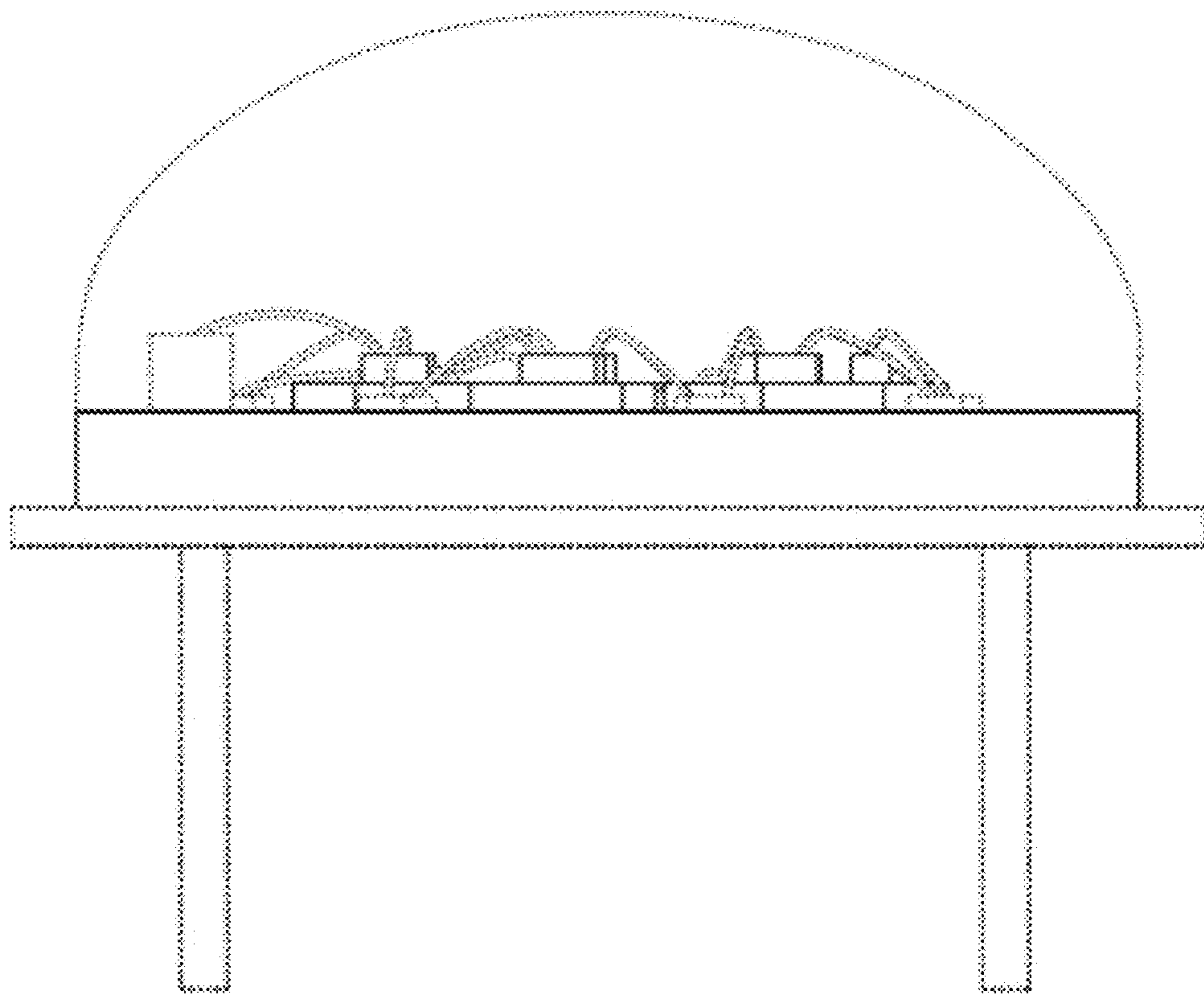

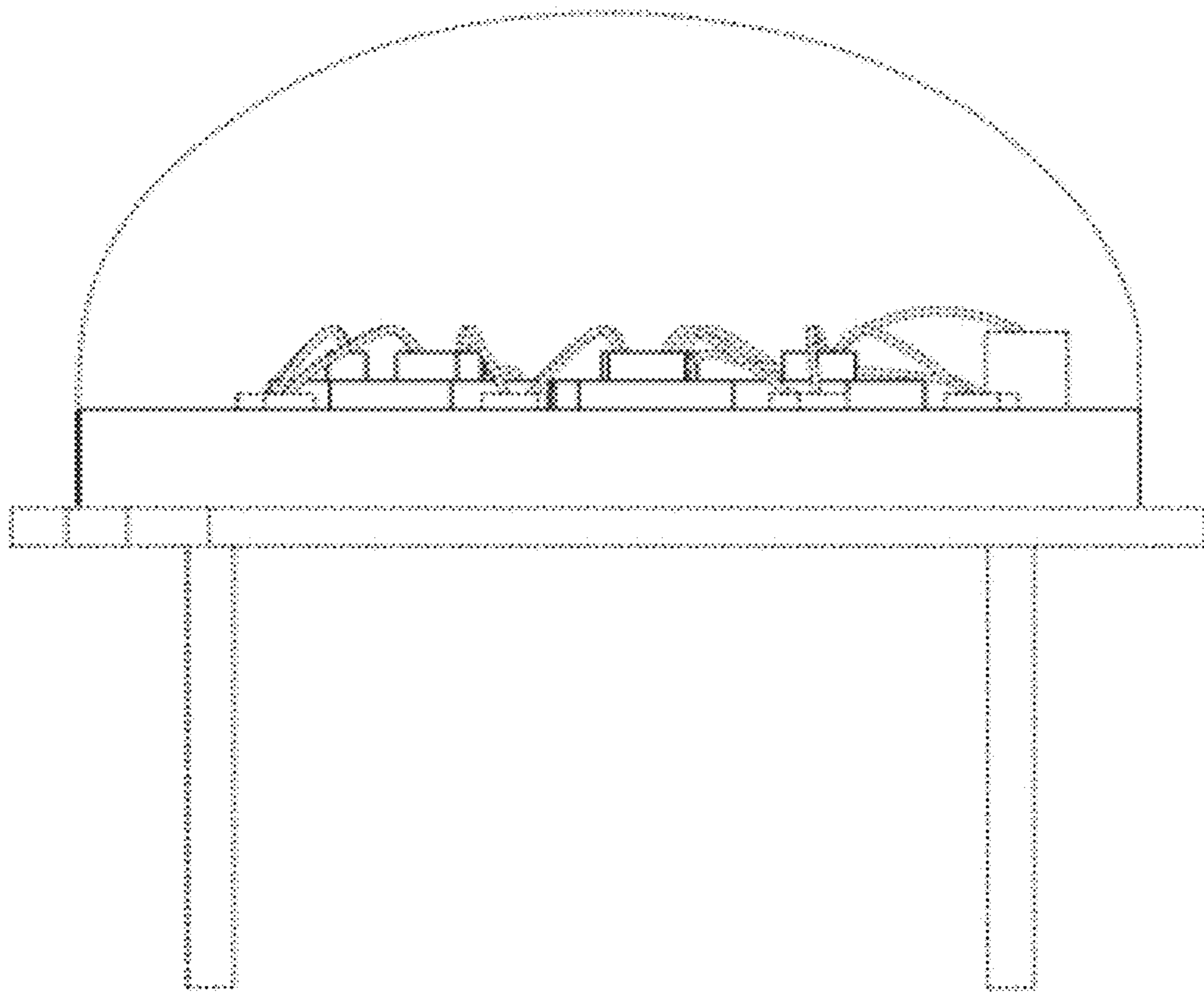

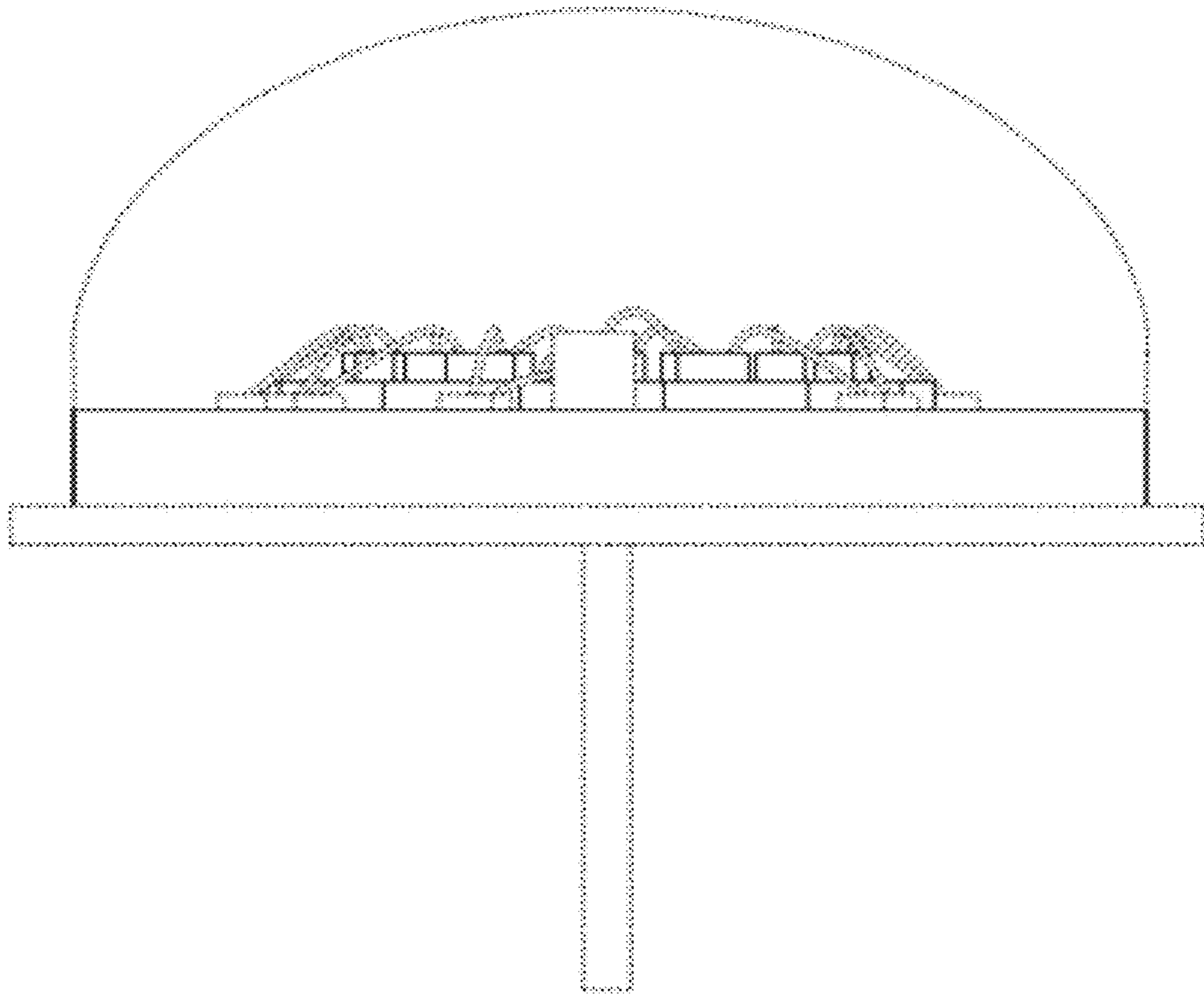

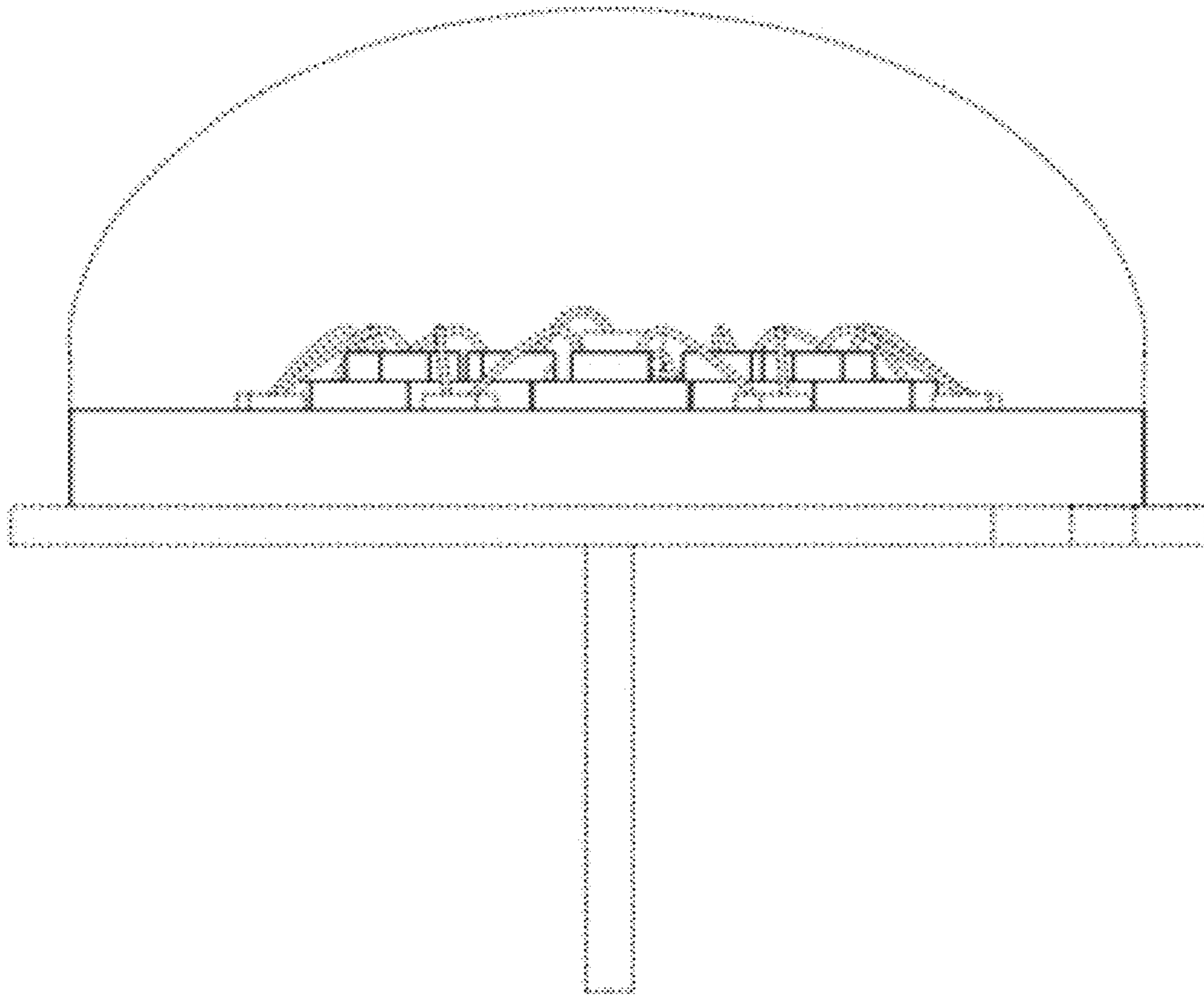

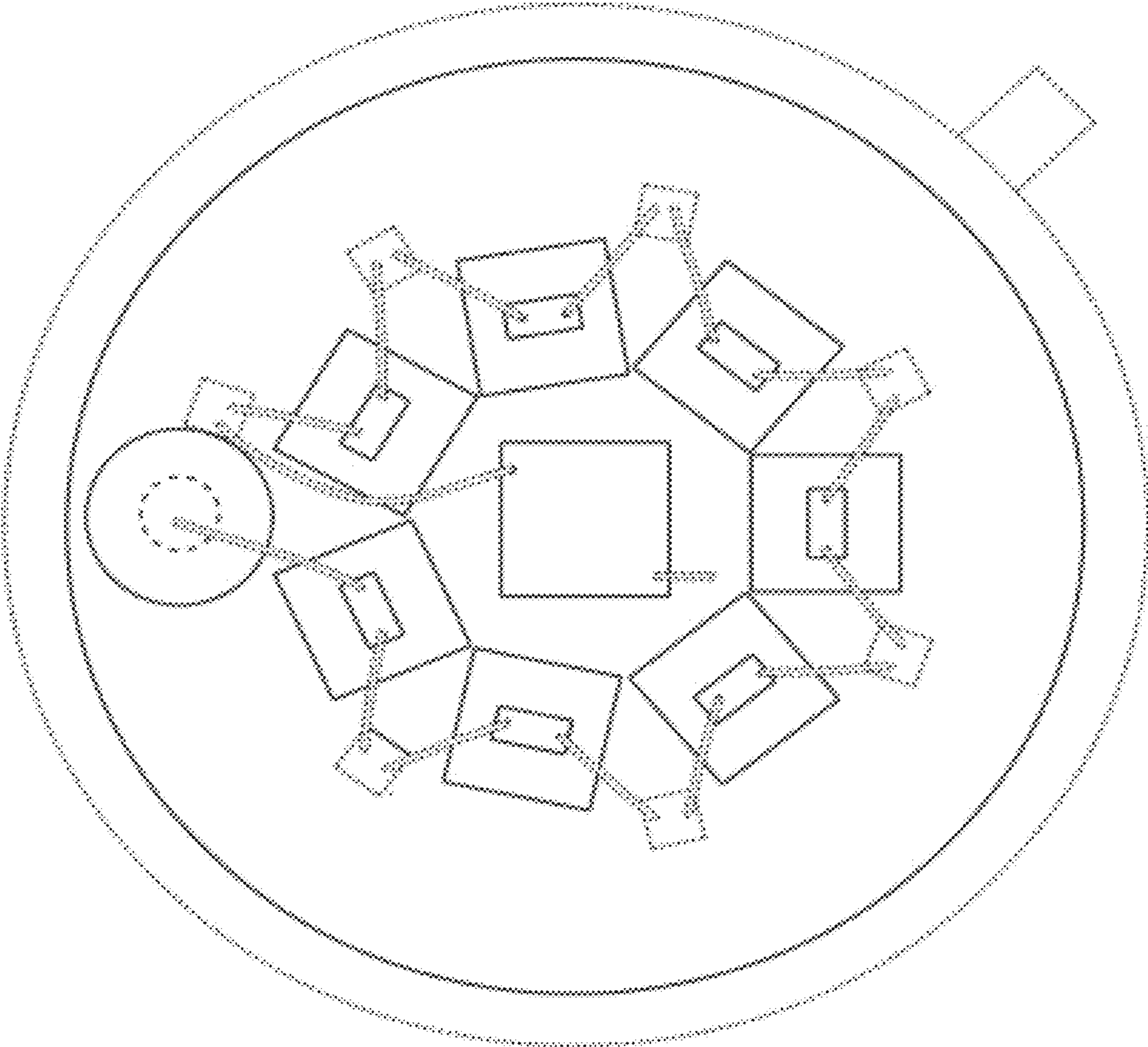

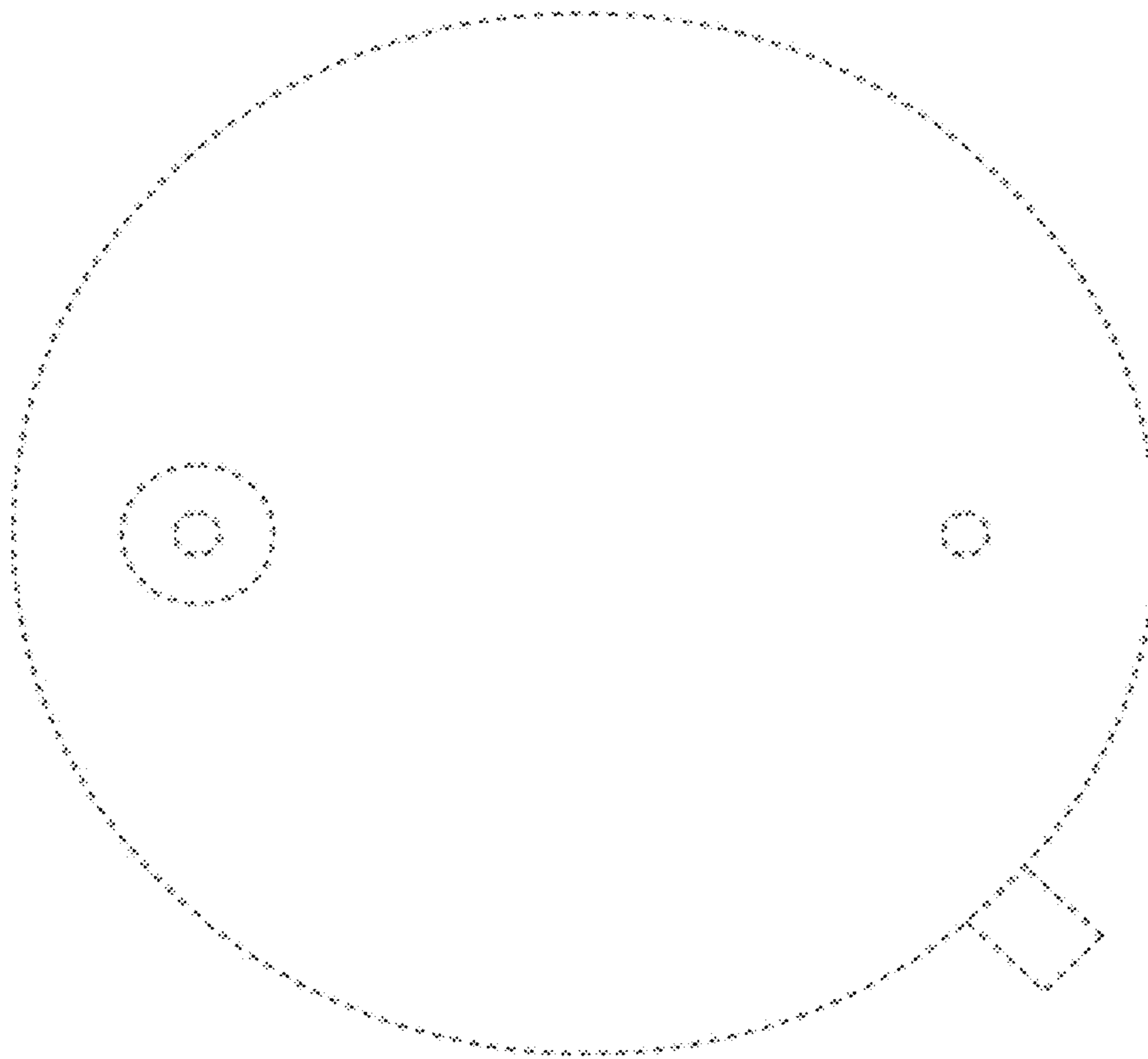

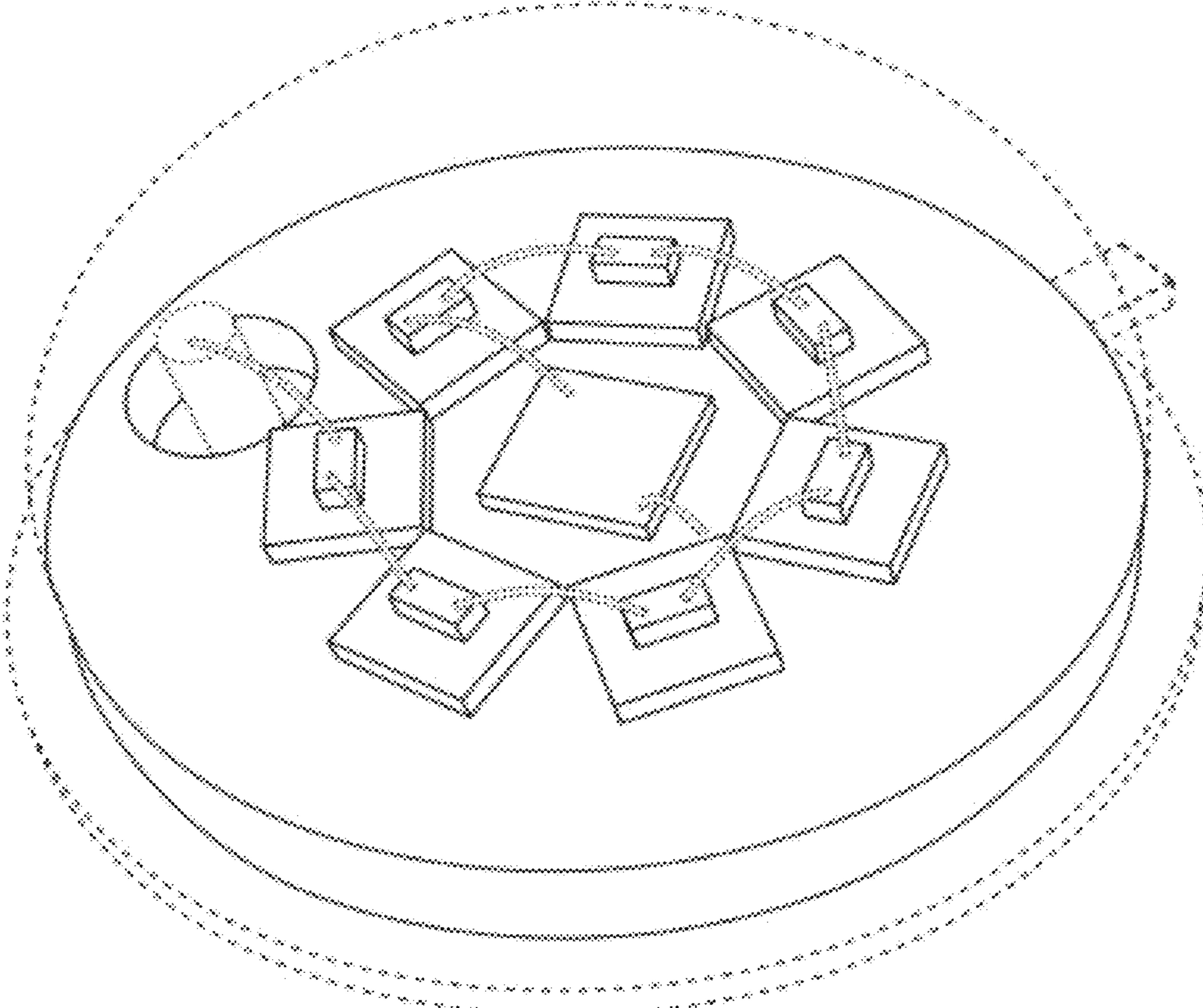

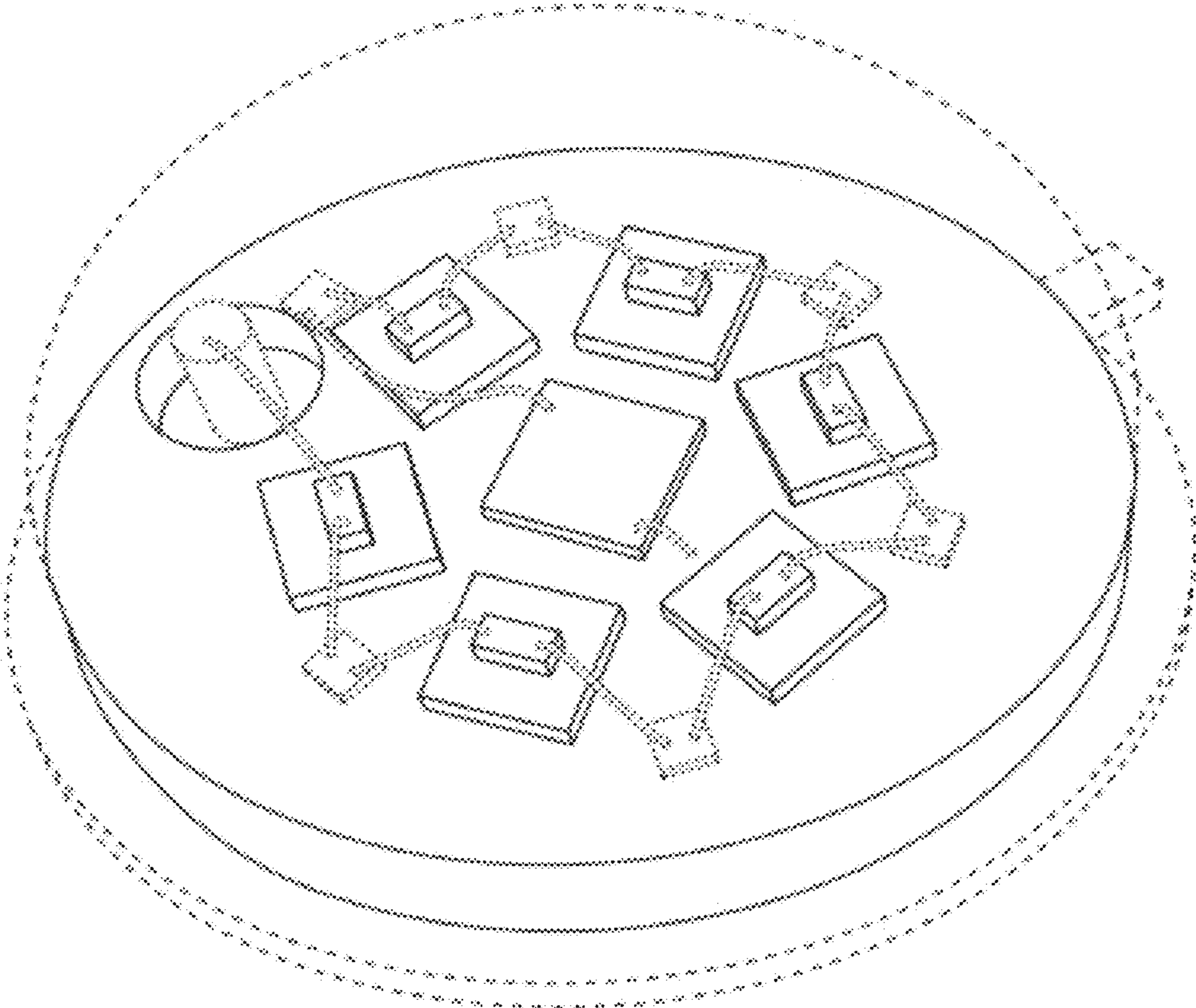

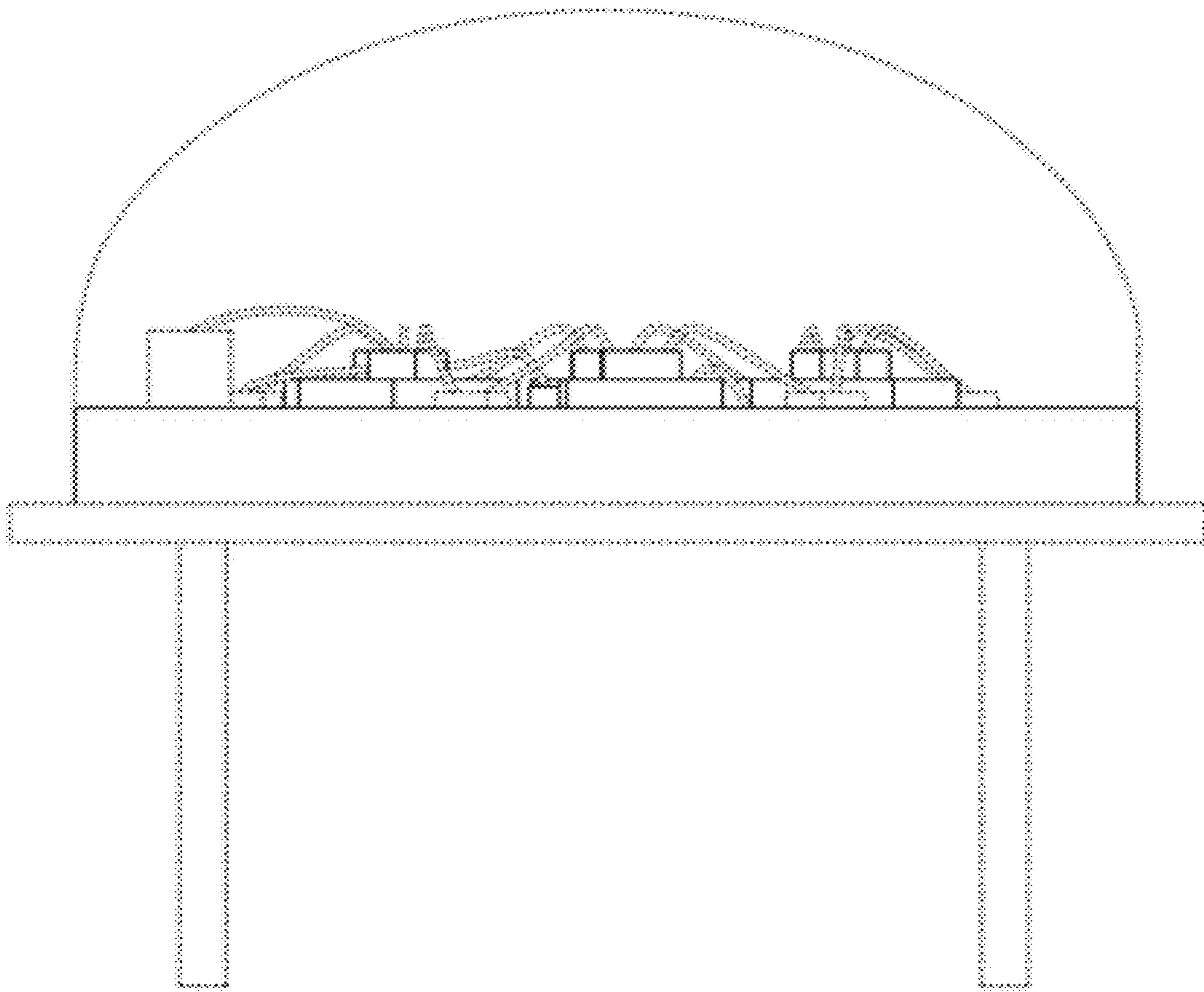

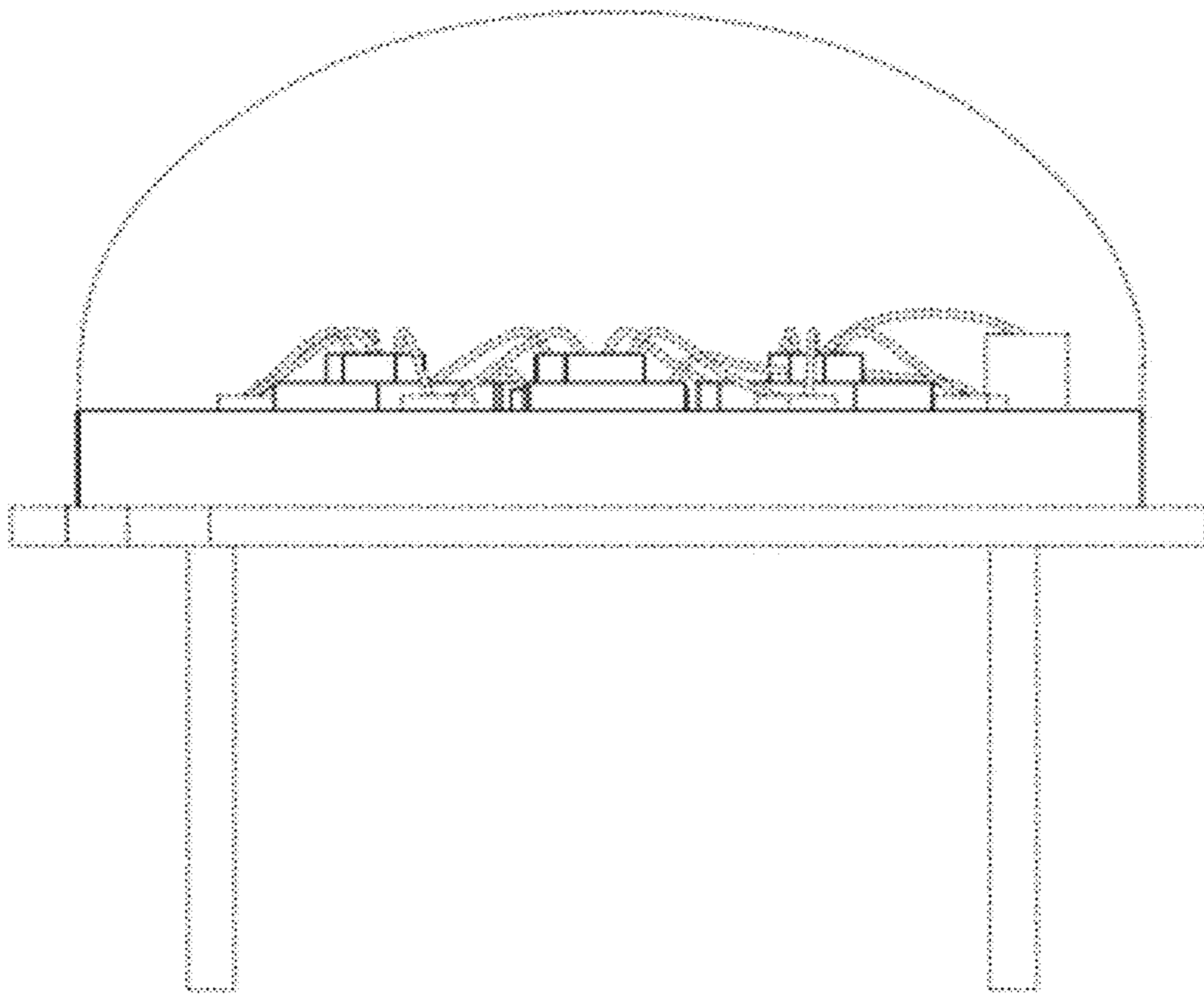

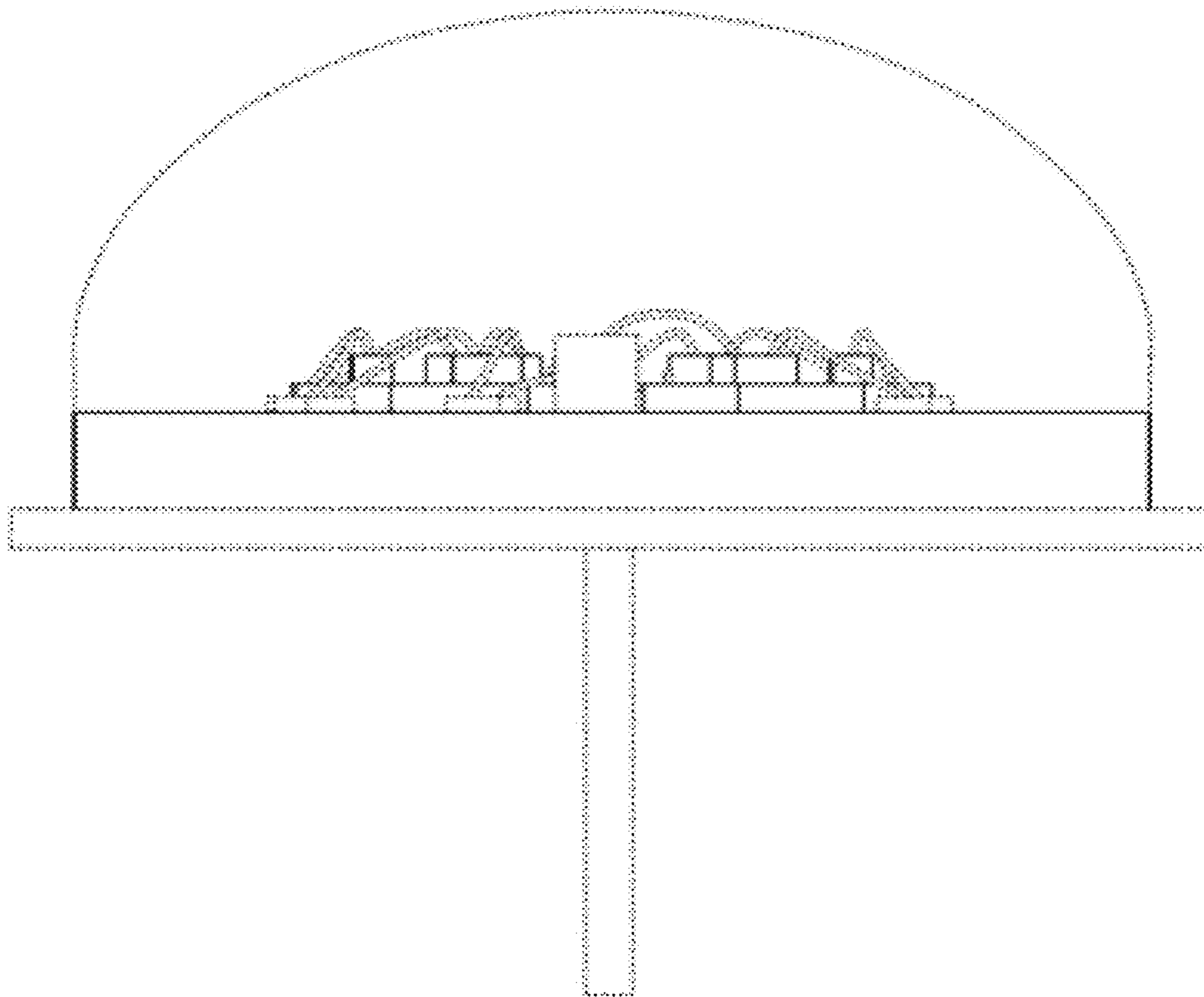

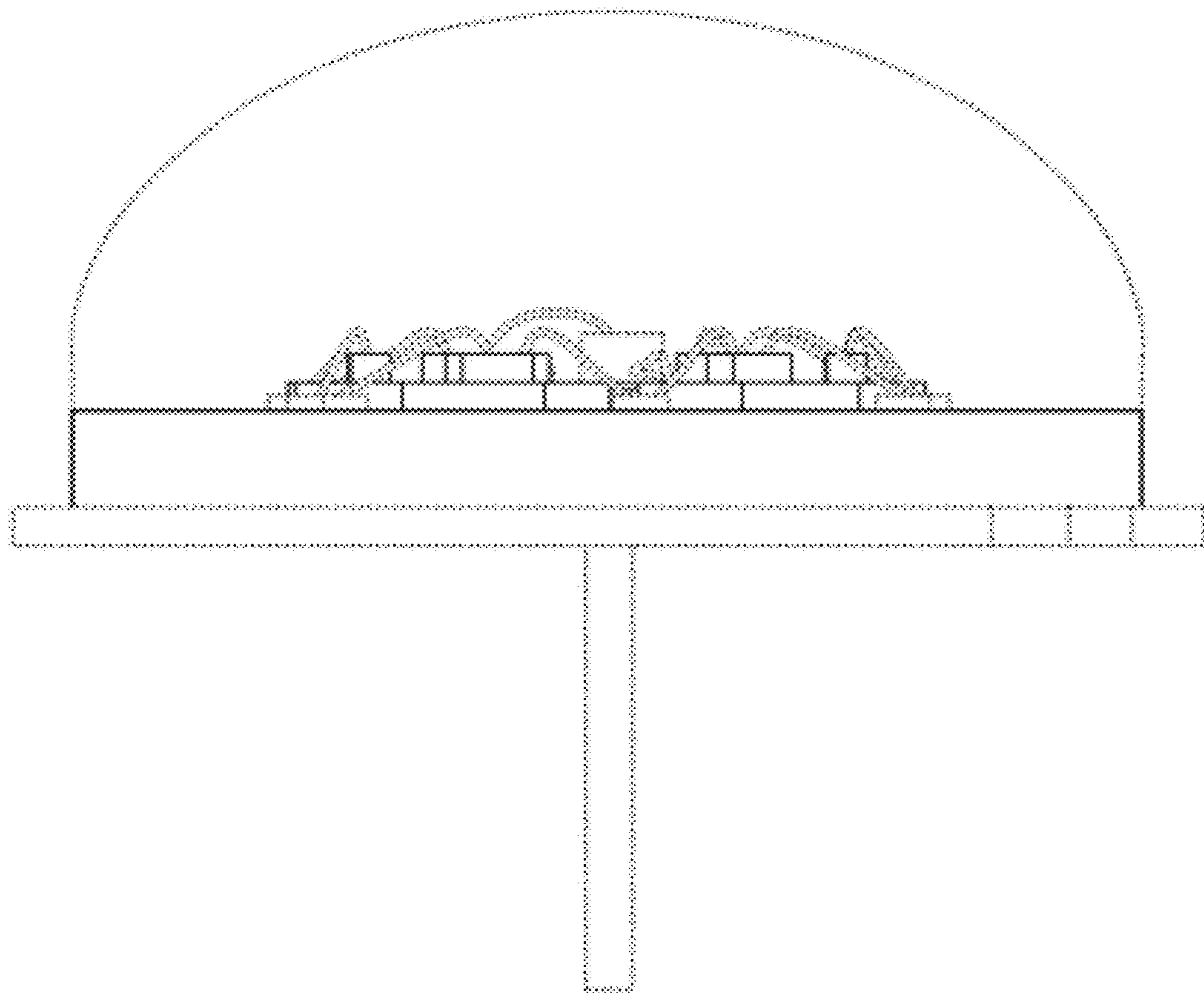

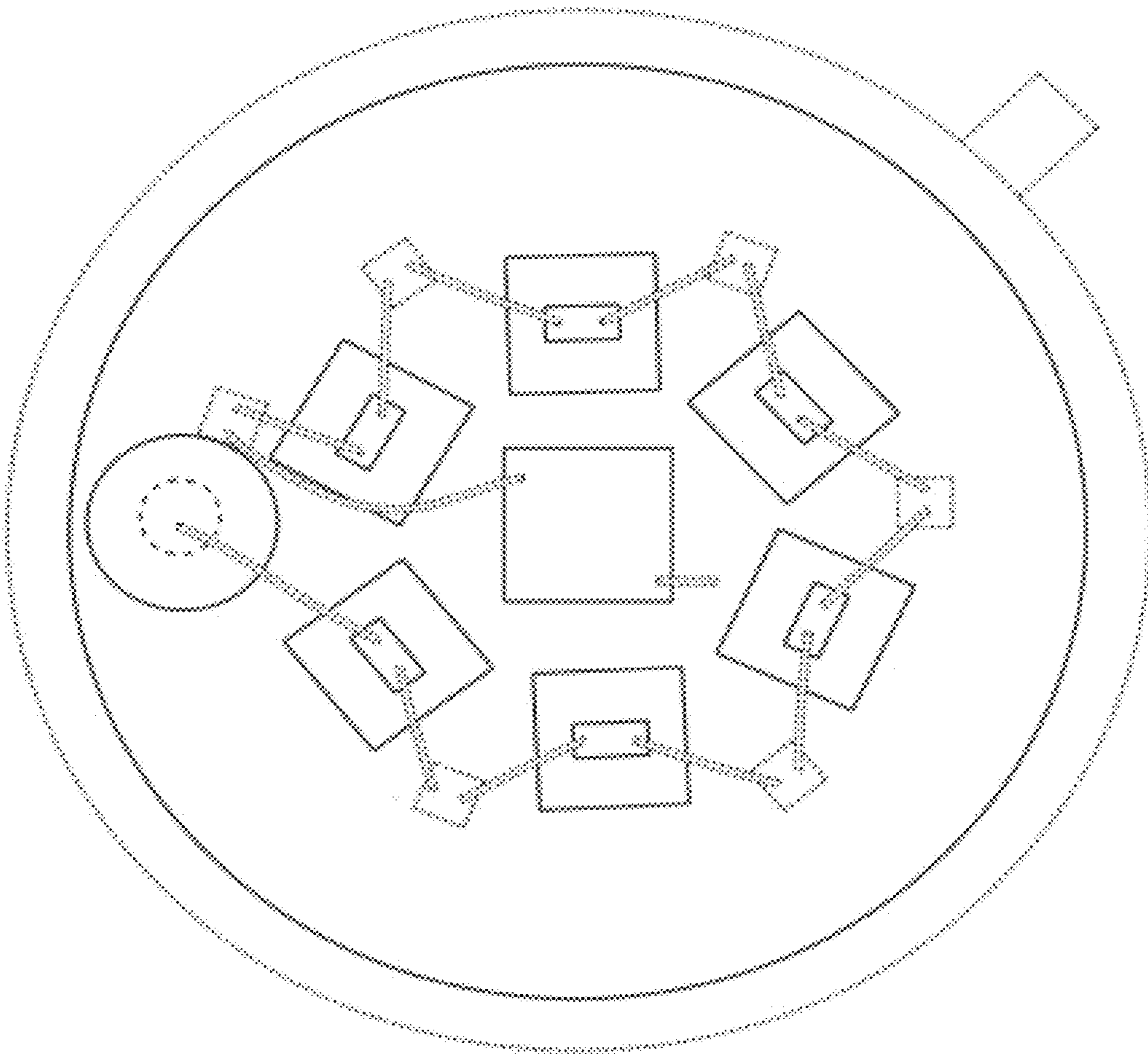

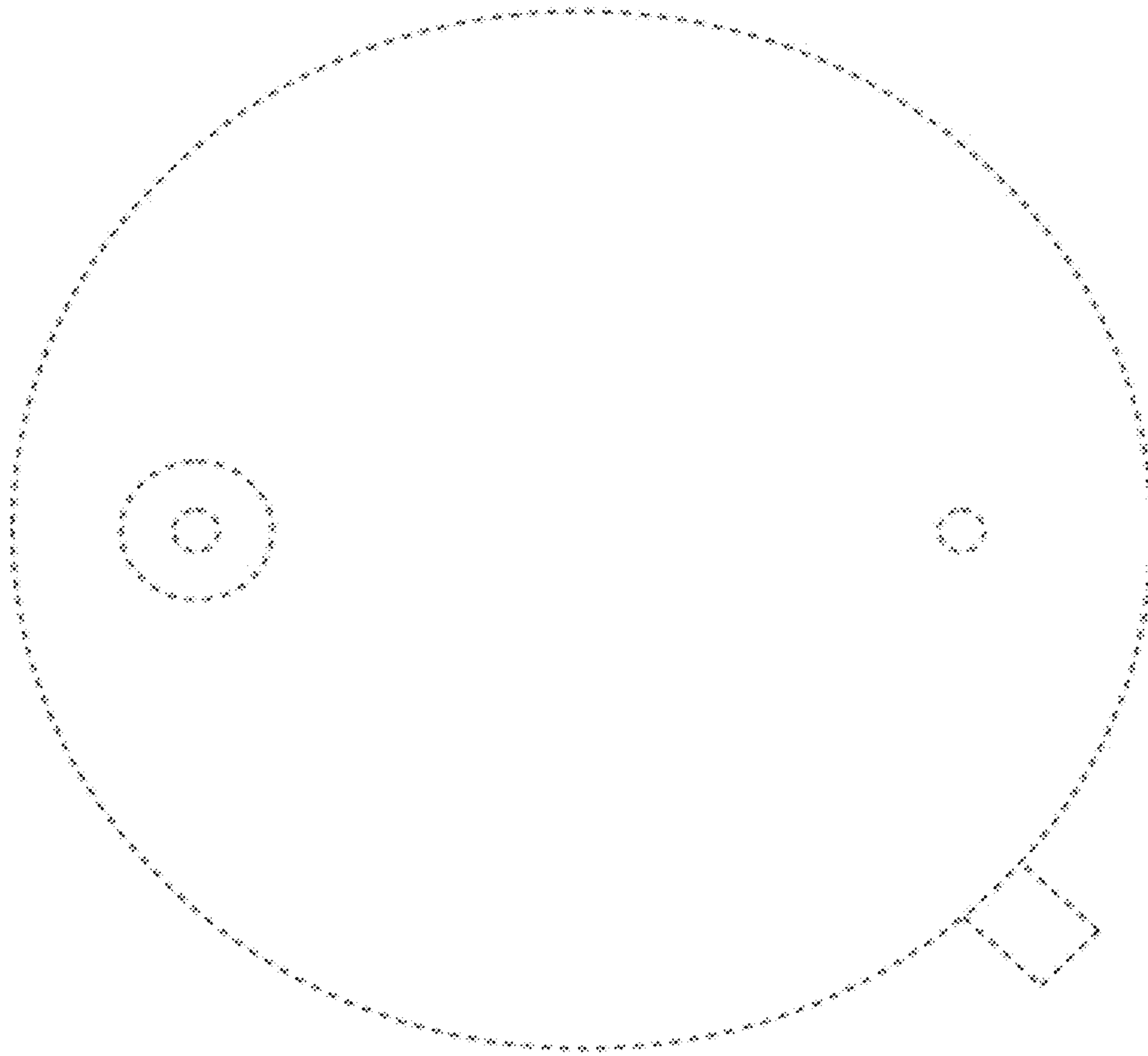

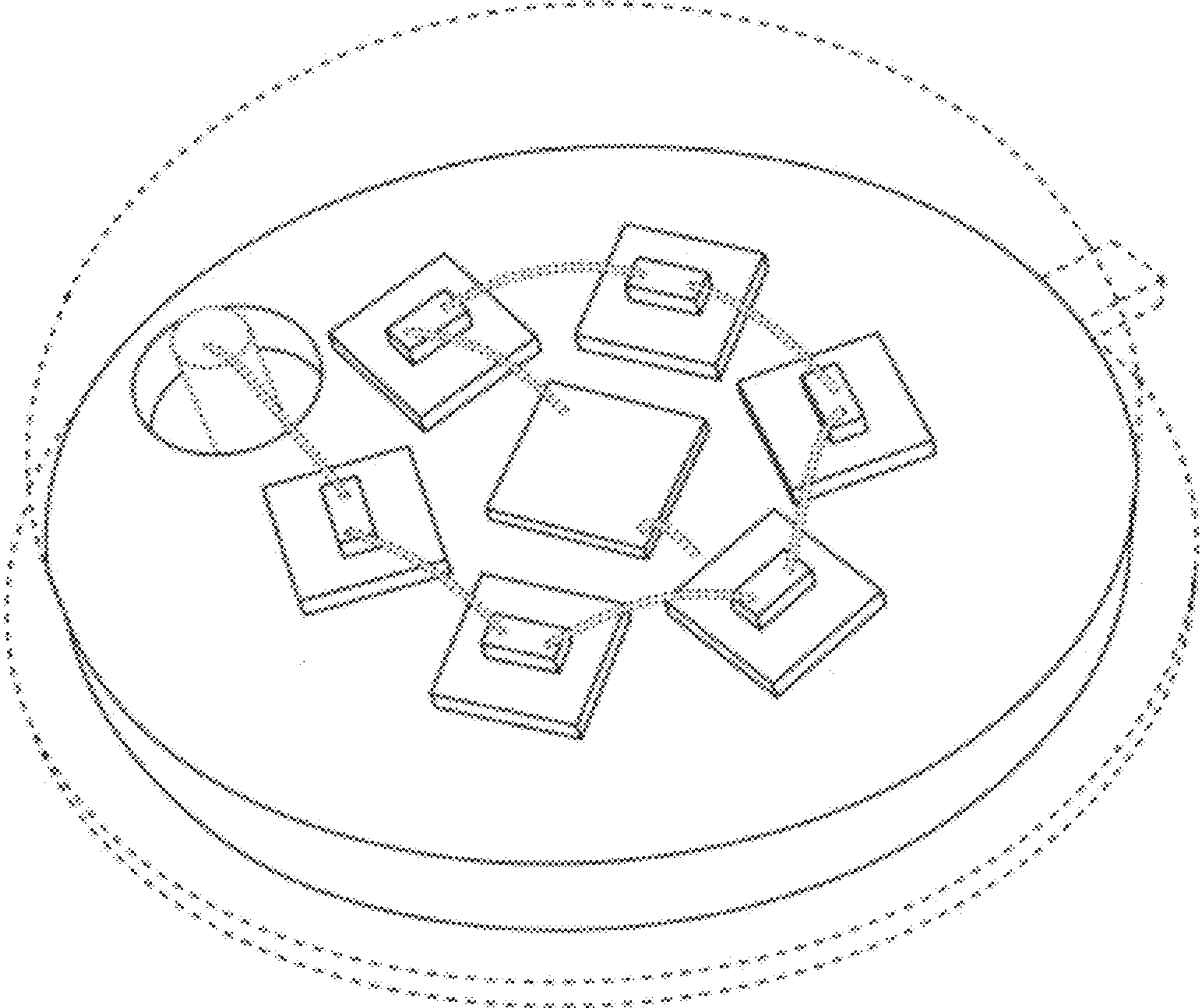

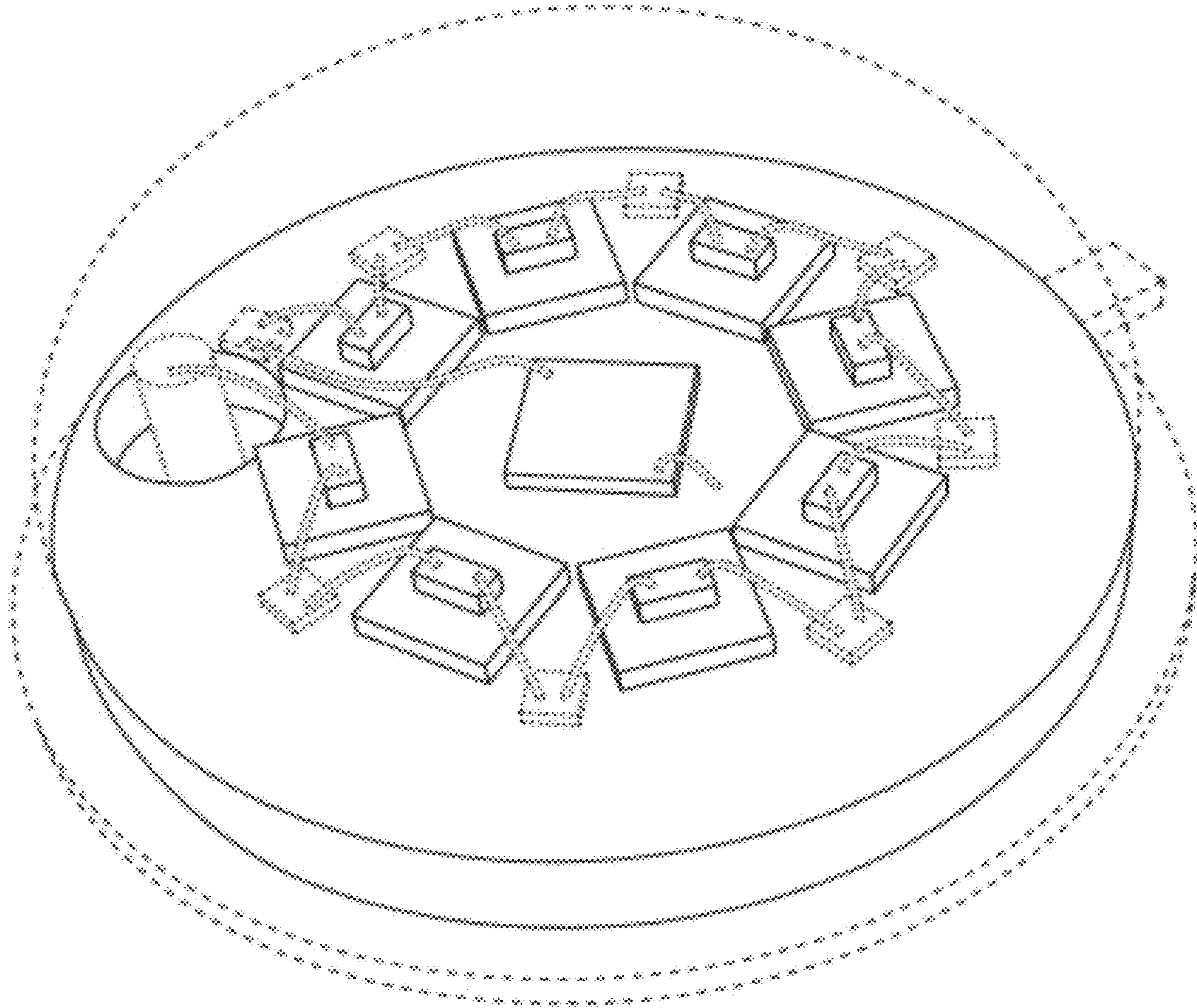

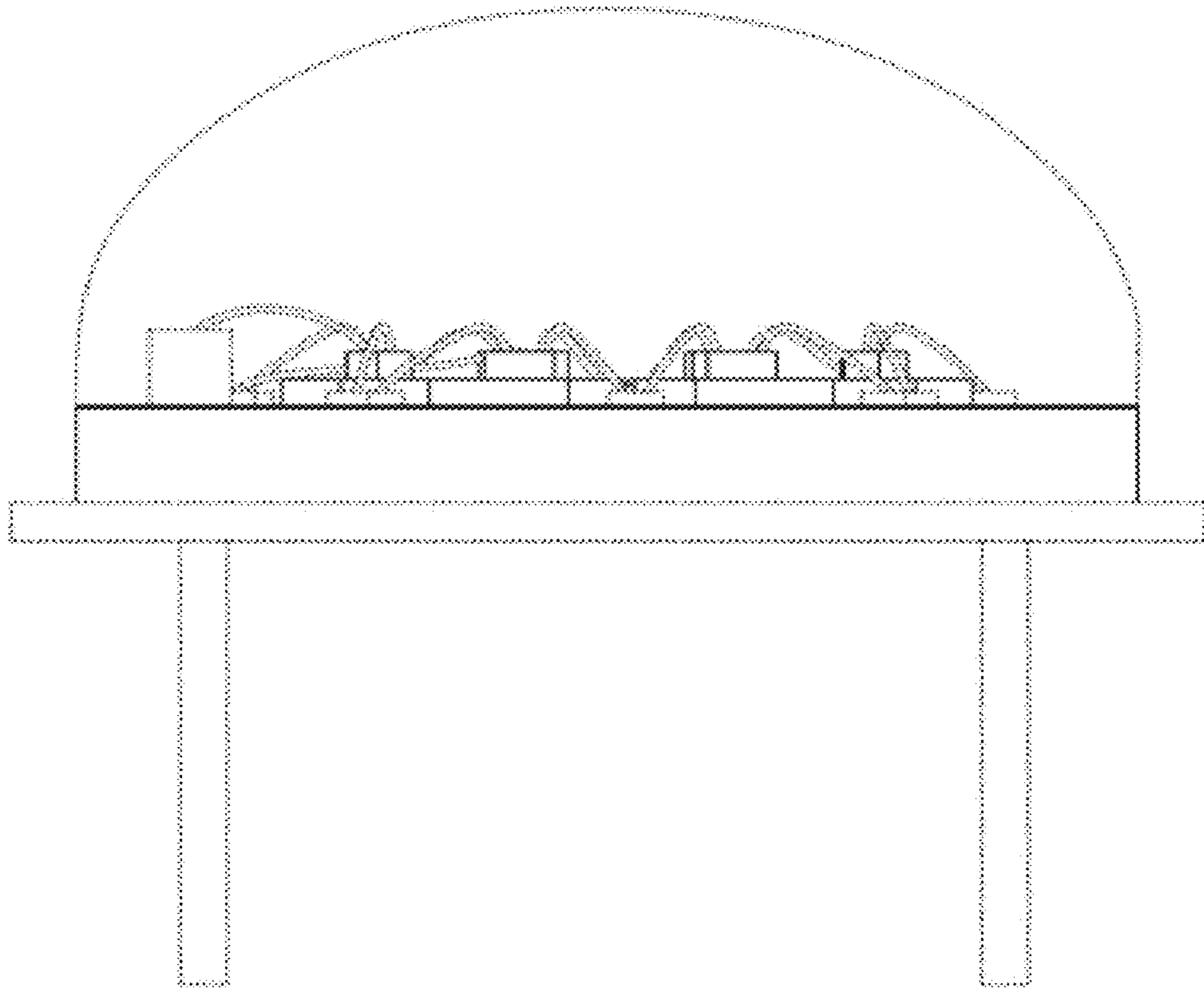

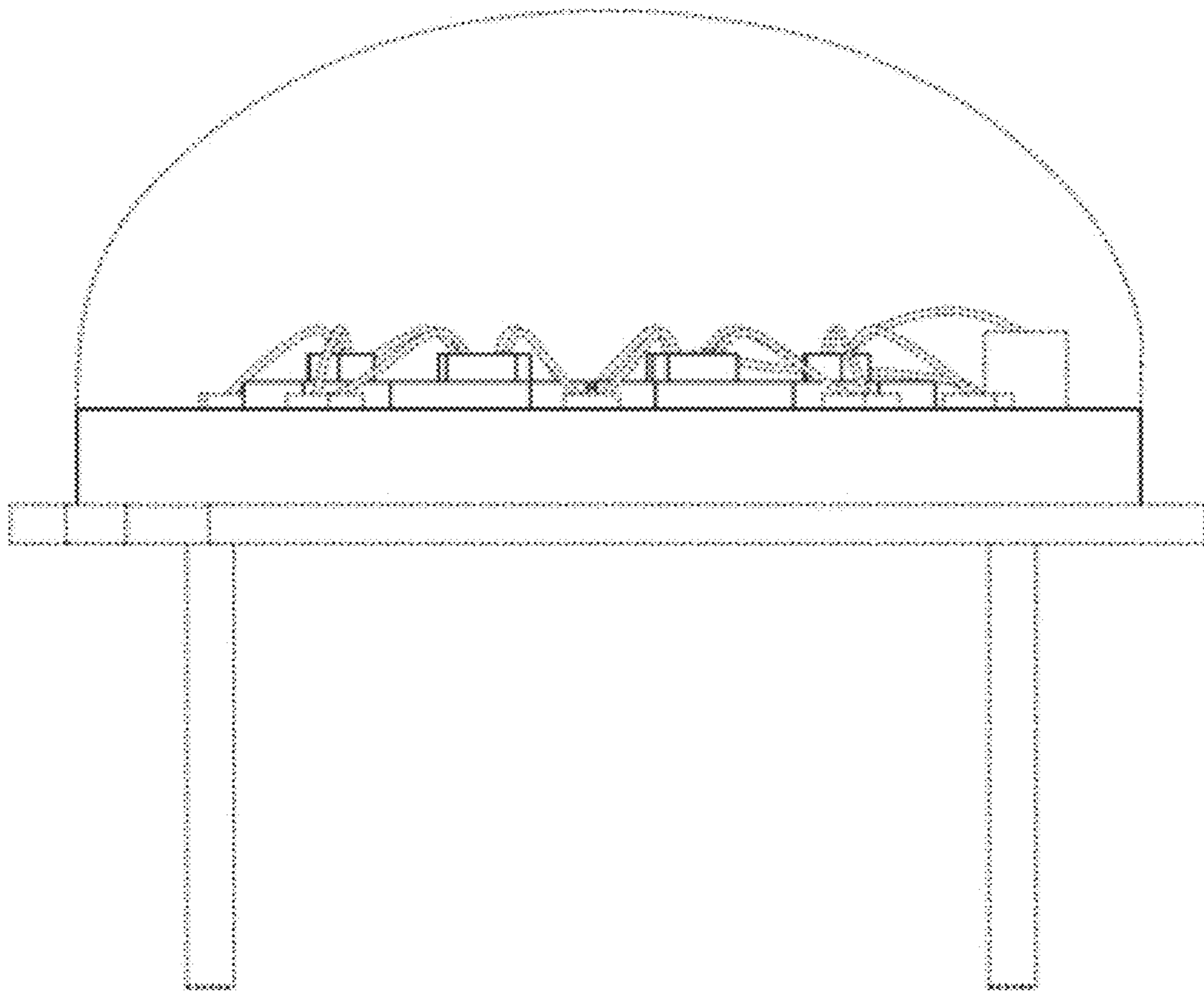

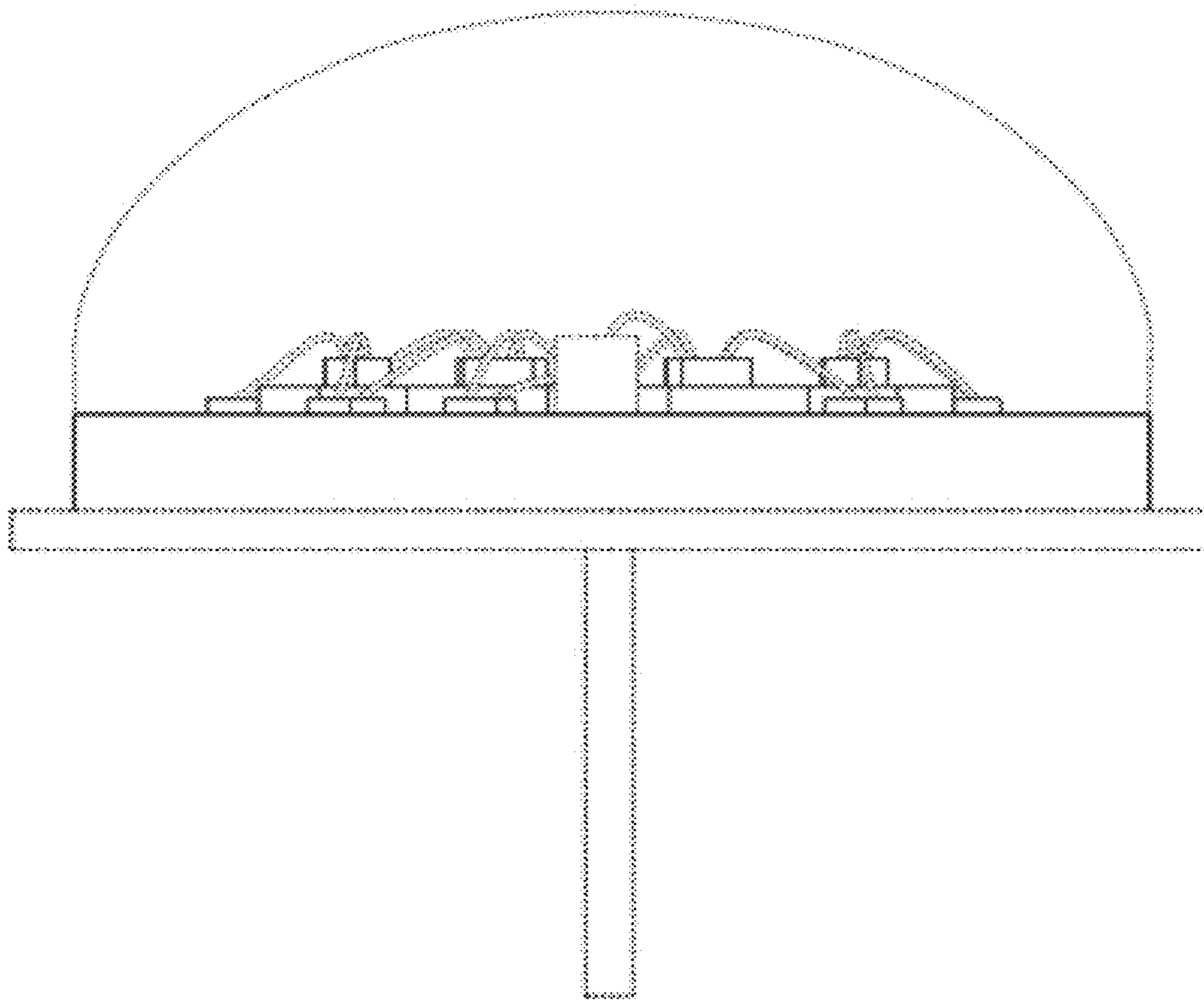

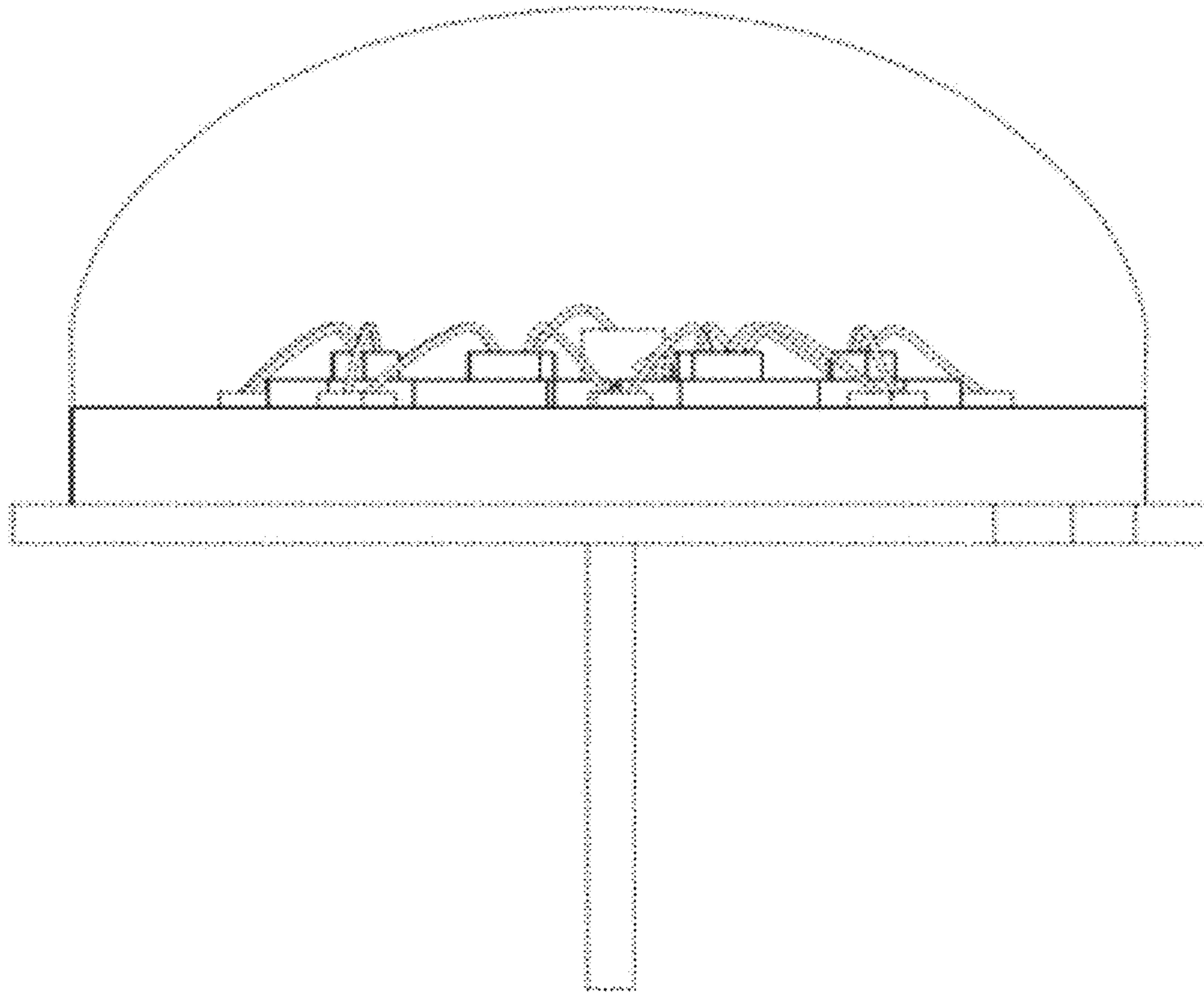

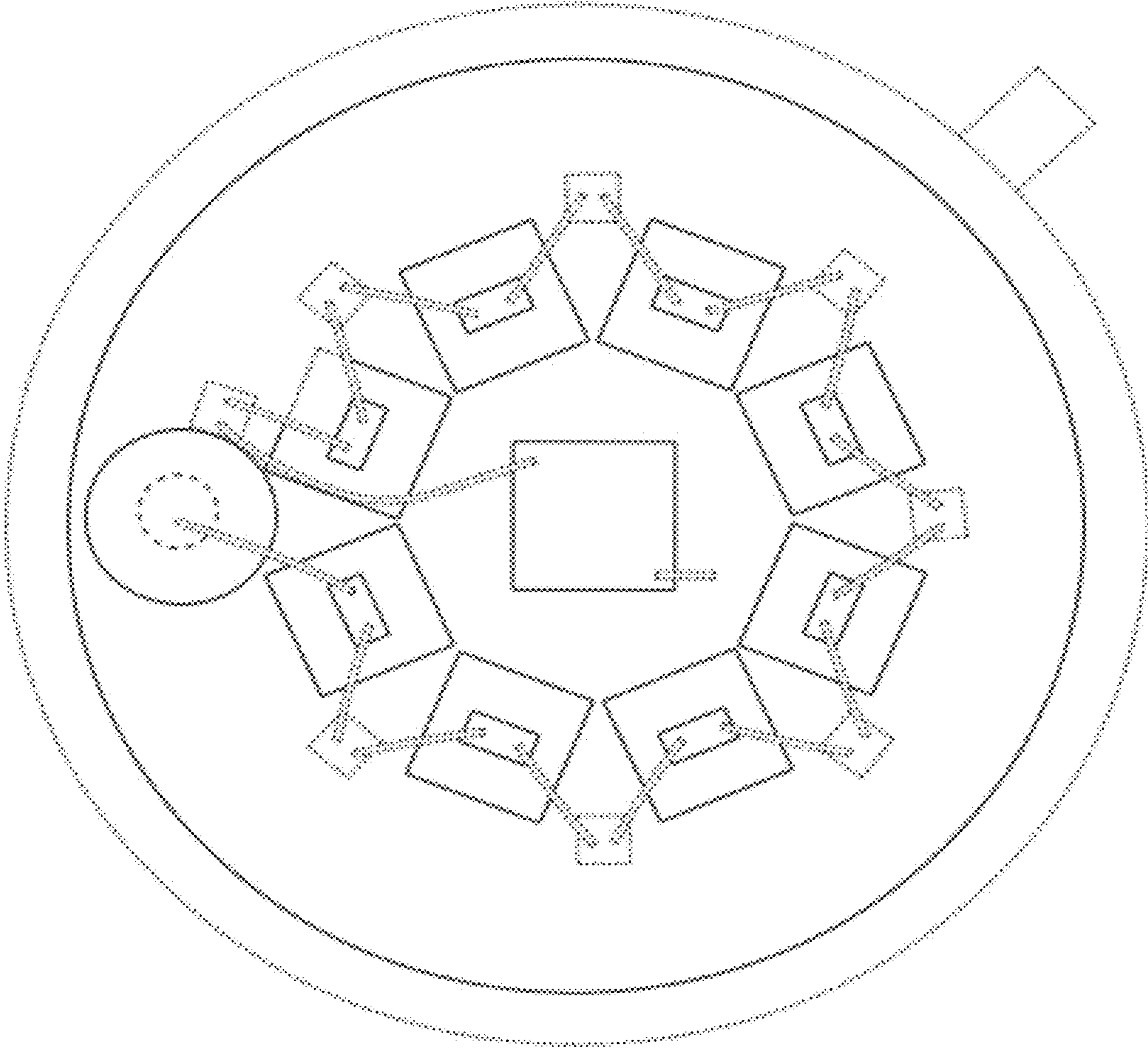

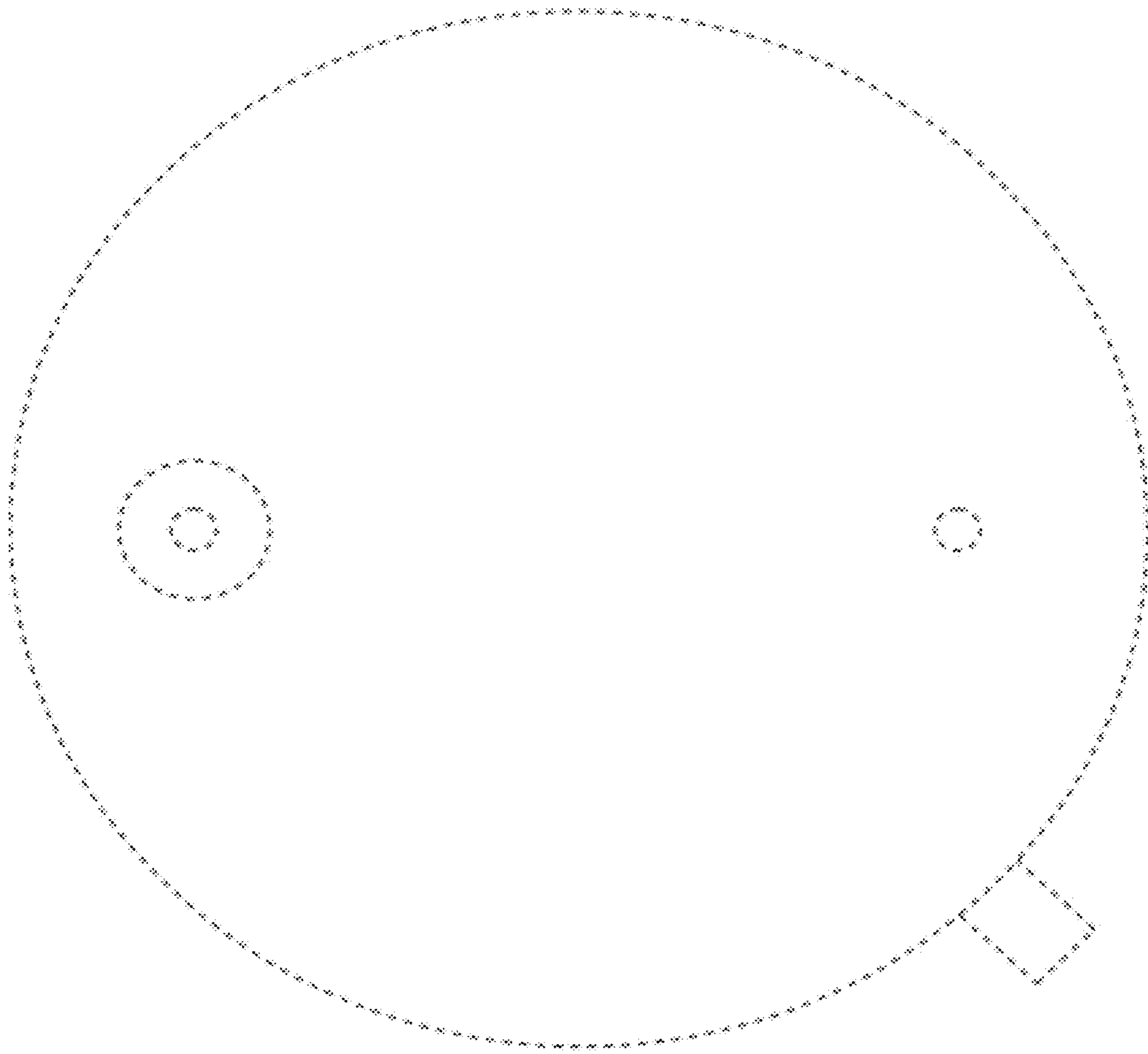

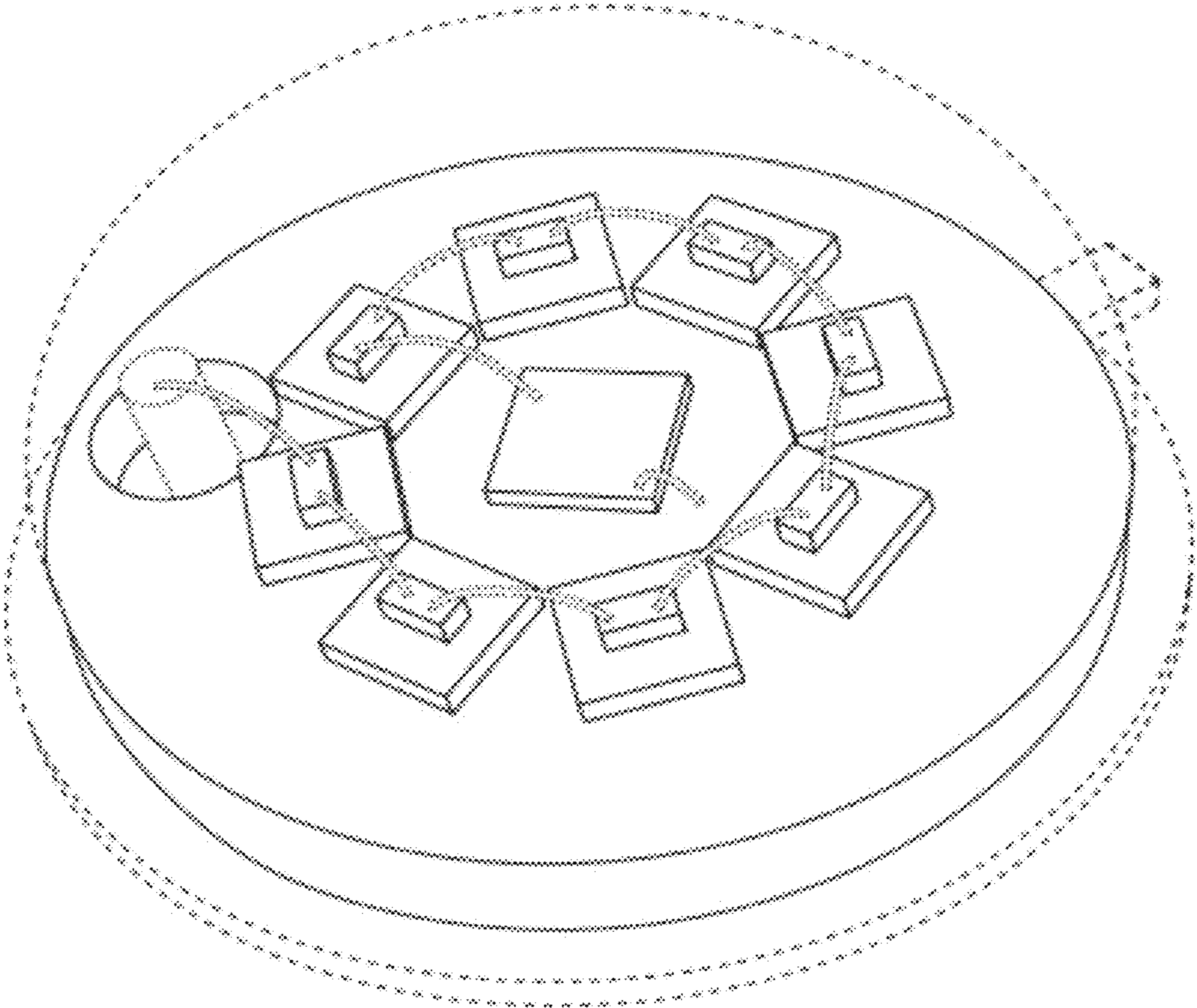
