(57) **CLAIM**

We claim the ornamental design for a handheld electronic device, as shown and described.

**DESCRIPTION**

FIG. 5 is a right elevation view thereof;

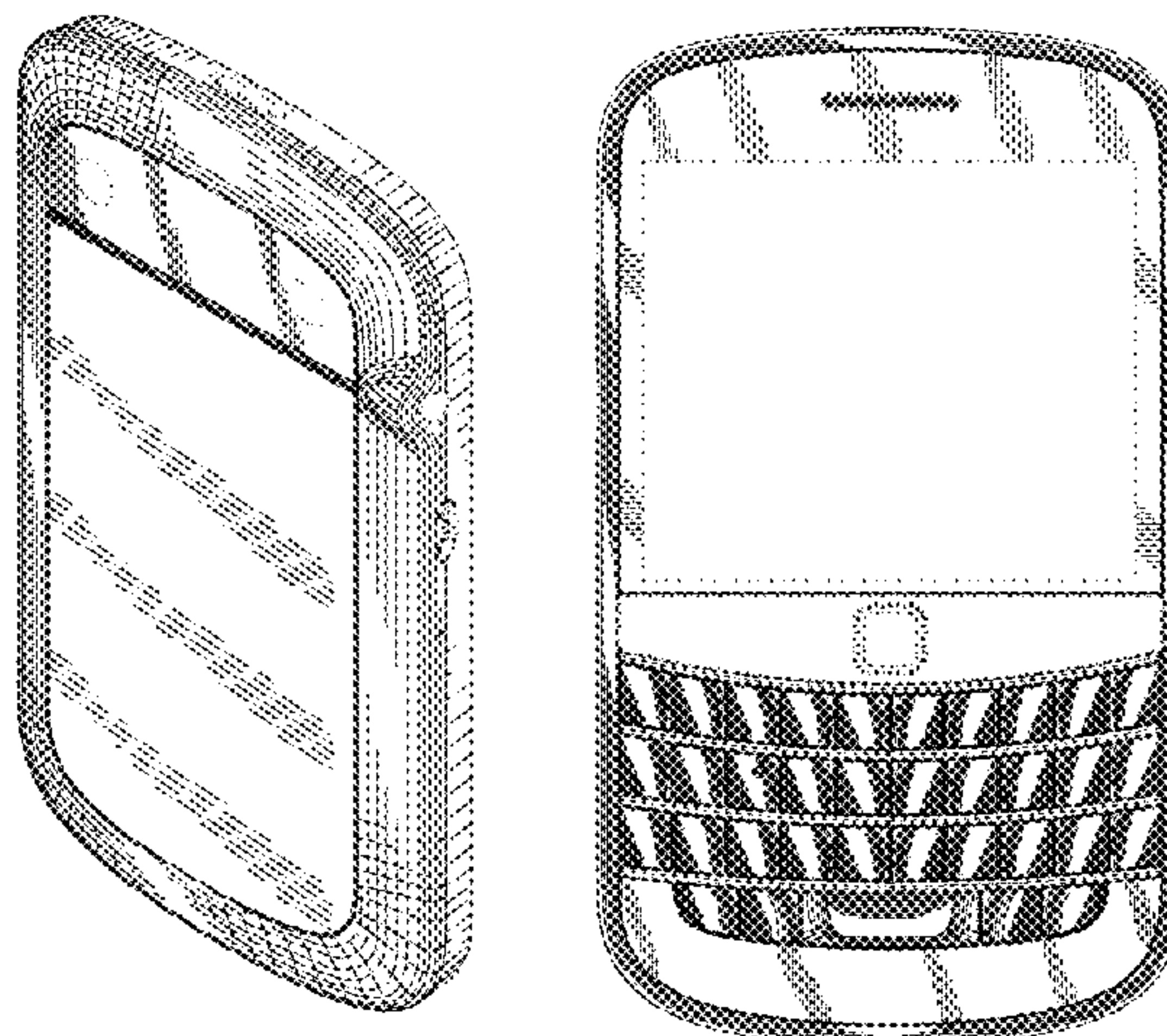
FIG. 6 is a left elevation view thereof;

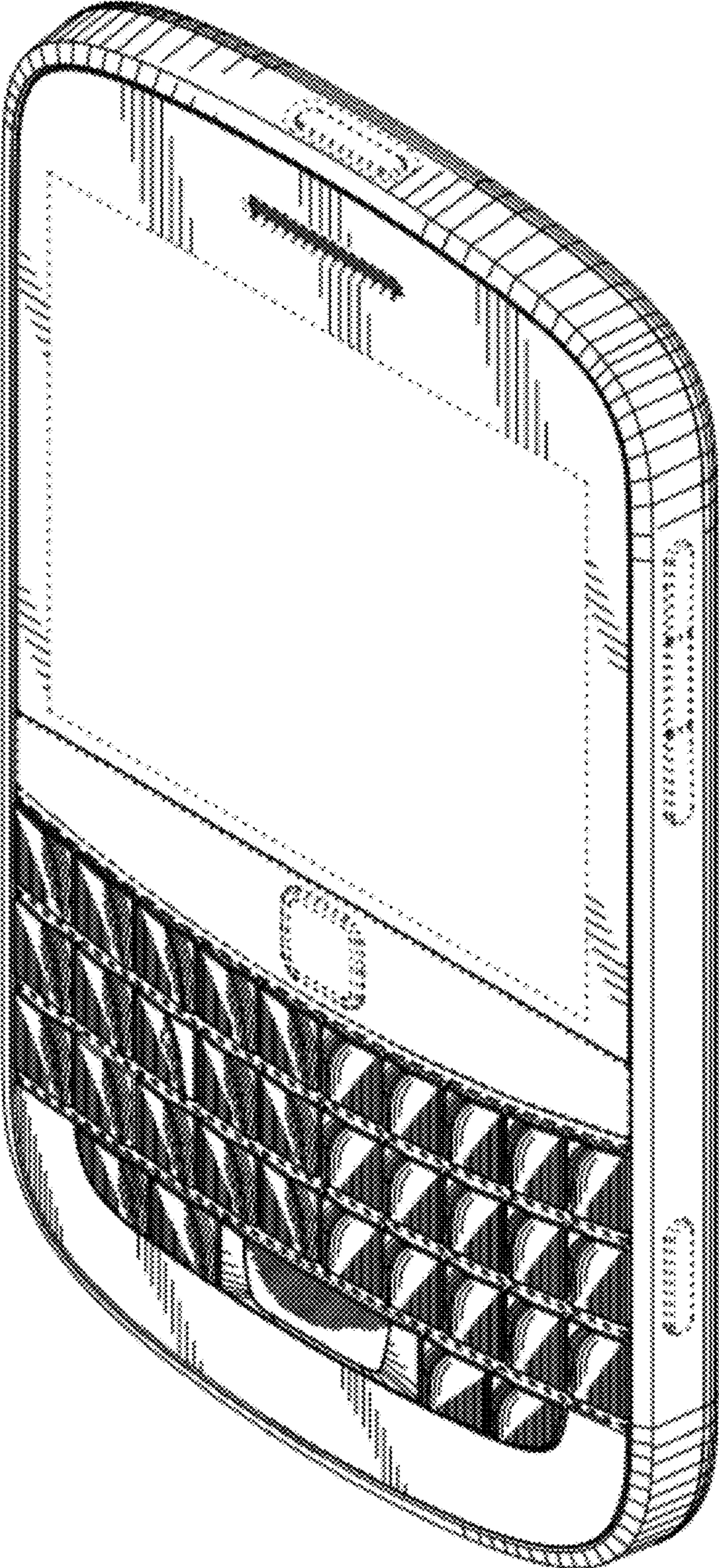

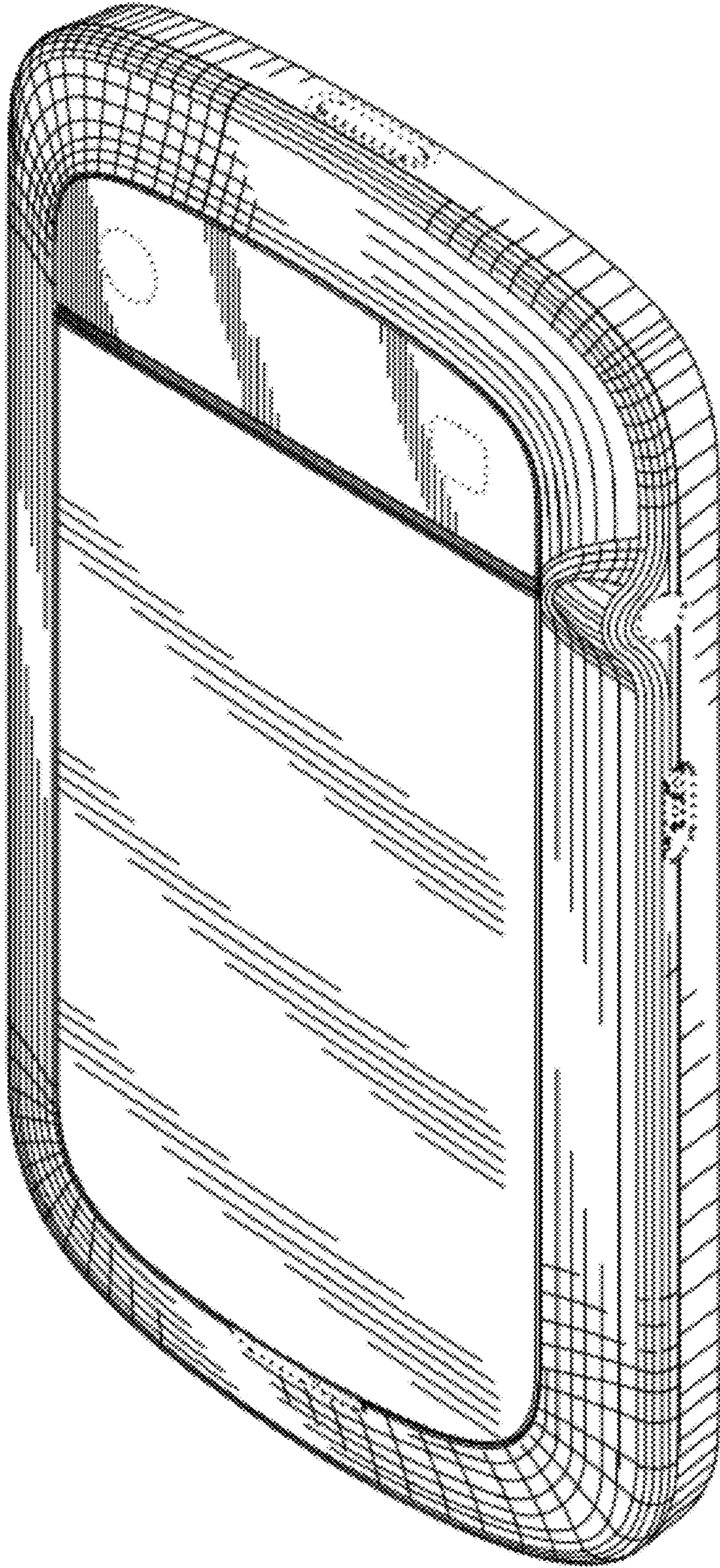

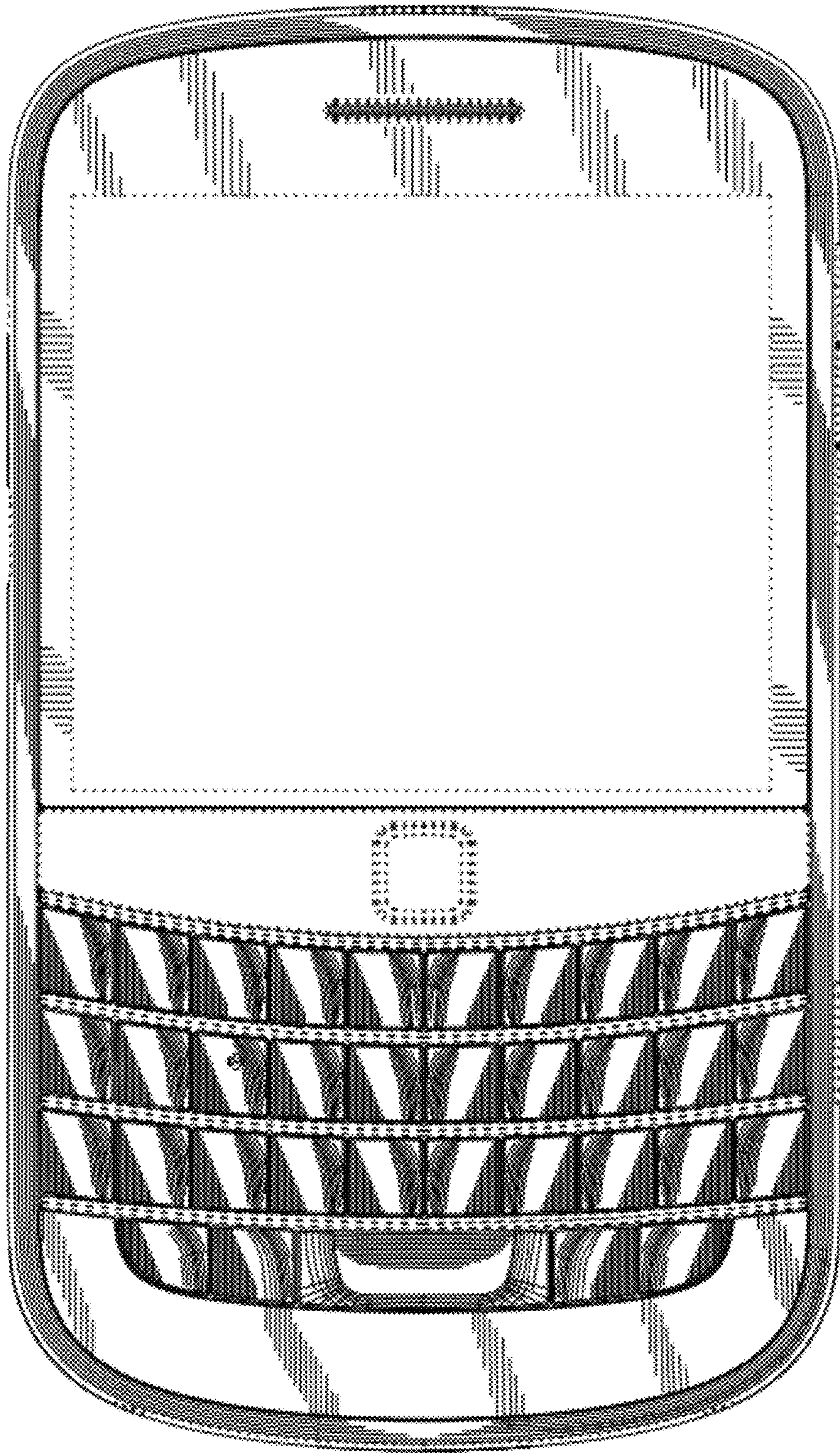

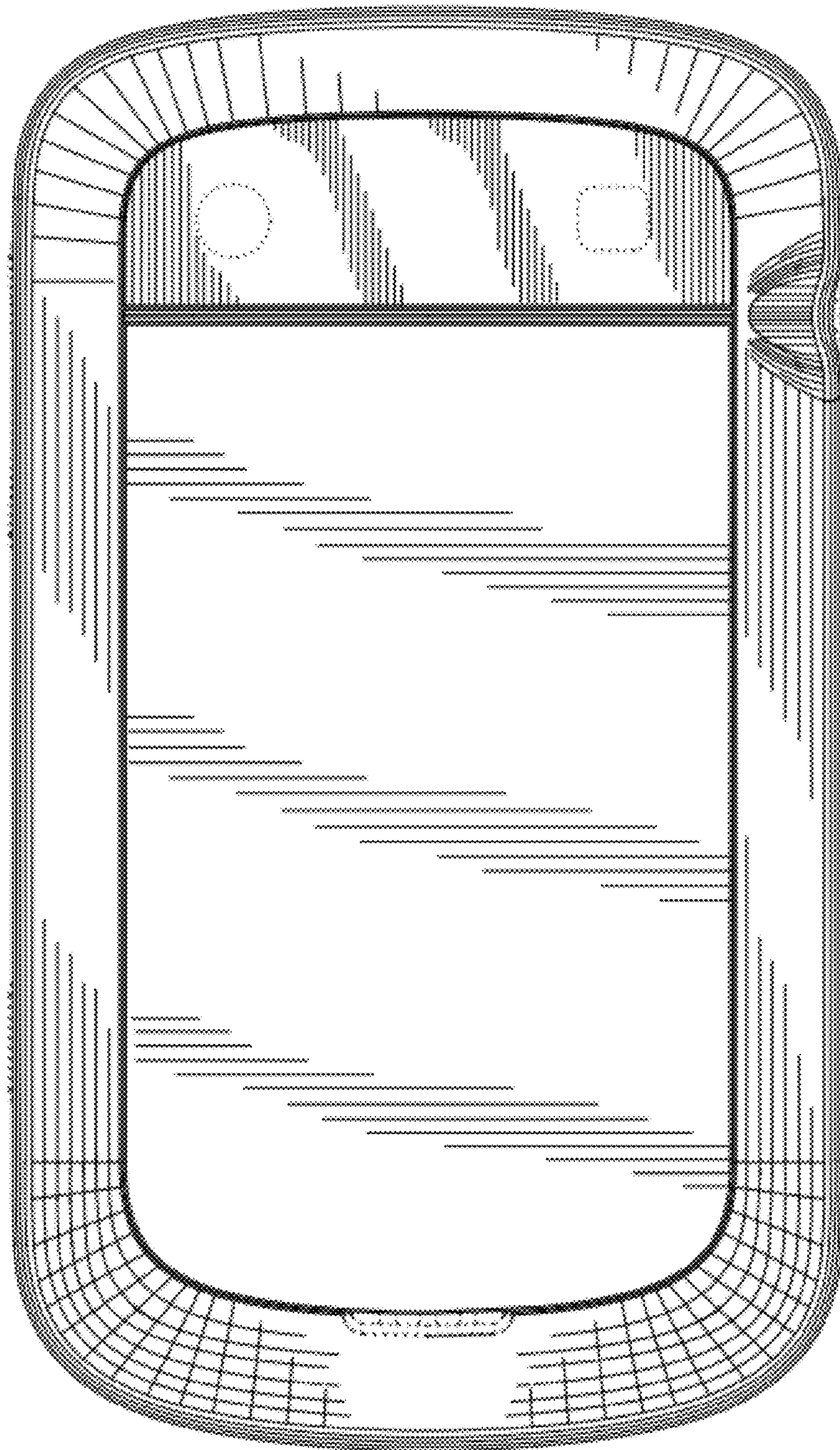

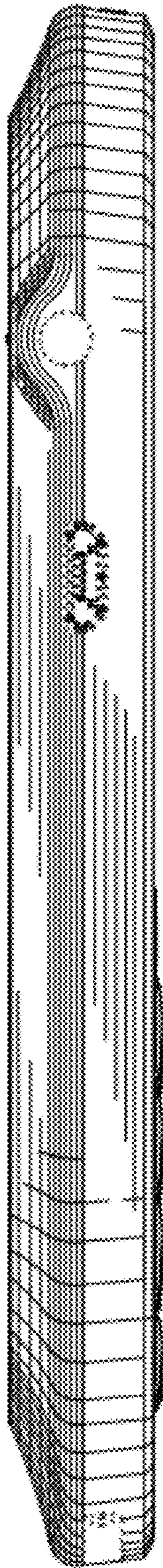

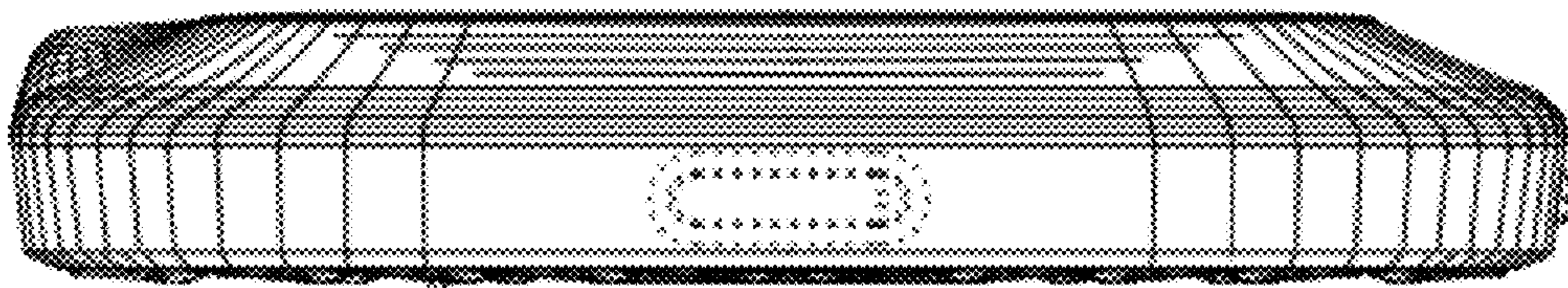

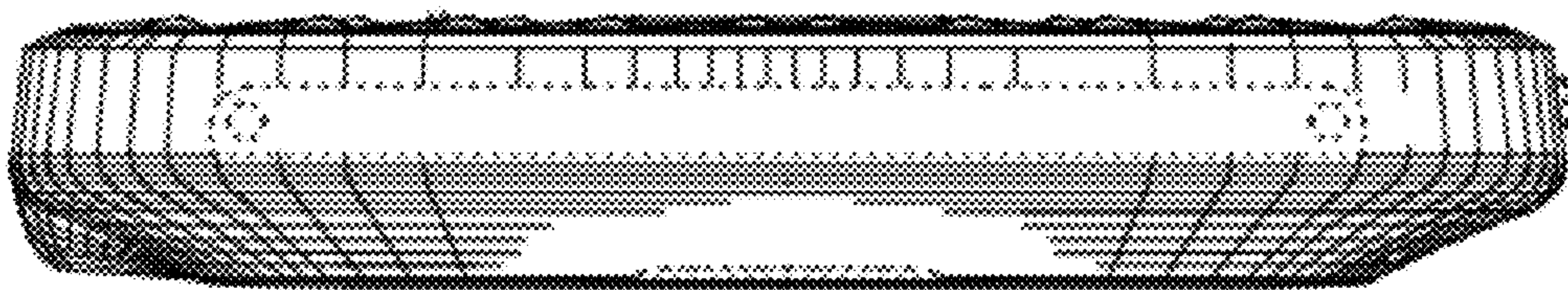
